Transportation Deficit Costs Californians \$40 Billion a Year

Transportation California Says New and Reliable Funding Sources Could Provide Relief to Motorists

(BUSINESS WIRE)--А in December report issued by Washington-based а think transportation tank demonstrates that California's decades of neglect of its transportation infrastructure amount to an annual burden of \$40 billion a year for the motoring public. TRIP, a national transportation research organization, estimates that roadways that lack desirable safety features, travel capacity and/or pavement in good condition cost the state's drivers \$40 approximately billion annually in traffic crashes, higher vehicle operating costs and congestion-related delays. "Even with the efforts of the governor and the legislature over the past several years, we still have a huge gap – which this report clearly shows – and it's hitting the public where it hurts,' said Transportation California Executive Director Mark Watts. Despite the short-term boost from the federal stimulus program, California's funding to improve and rehabilitate bridges and major roadways stands at \$1.5 billion a year. Current needs average \$5.5 billion a year. Transit needs are now \$8.6 billion annually, but funding is \$1.7 billion a year. "We are short nearly \$11 billion annually to meet our transportation needs," Watts

said. "This report shows that our failure to close this transportation investment deficit is costing us nearly four times that much." Safety, congestion and road conditions are an issue in every part of the state. In "Future Mobility in California," TRIP documents that 68 percent of California's urban highways are congested, and vehicle travel is expected to increase by another 20percentby2025.Thestatewide cost of congestion, according to TRIP, is \$18.7 billion annually. TRIP also reports that California has the second highest share of roads in poor condition in the nation – 35 percent. (New Jersey is No. 1.) The extra vehicle operating costs created by these poor roads total \$13.5 billion annually in California. In addition, 29 percent of the state's bridges and overpasses need significant rehabilitation. repair or The traffic fatality rate on the state's non-Interstate rural roads is more than three times higher than the fatality rate on all other roads and highways in the state. Roadway characteristics - such as lane width, lighting, signage, guardrails, paved shoulders, rumble strips and other features - can reduce the number of serious traffic crashes. According to TRIP, the cost of serious traffic crashes in which roadway characteristics

were a contributing factor \$7.6 was approximately billion in California in 2008. Watts pointed out that voters in counties up and down the state have voted to approve local sales tax measures to support transportation. "The evidence is there that voters want to see transportation improvements and are willing to pay for them. Those local expenditures, coupled with state programs and the federal stimulus program, are producing some positive results, but they amount to far less than we need to right the system," he said. The rising cost of construction materials has eroded the buying power of the gasoline tax, which is the primary source of funding for California's safety and rehabilitation programs. The price of key materials used in highway construction increased by 33 percent between October 2004 and October 2009. "A robust federal transportation package and a new and reliable state revenue source are essential to provide relief to the motoring public," Watts said. Employers are seeking customer service, sales, manufacturing and shipping experience in early 2010.

Sacramento County - At this time last year employers were using attrition, hiring freezes and massive layoffs to cut workers while some businesses closed their doors forever. After one of the worst years in decades, the Sacramento regional employment market is regaining traction. Usually a slow period for hiring in the Sacramento area Pacific Staffing has learned that forty-six percent (46%) of 100 top area companies surveyed plan to hire in the first quarter, Q1 of 2010. In Q1 of 2009 more than half of Sacramento regional employers surveyed weren't hiring anyone, another twenty percent (20%) planning staff cutbacks and three local companies closed and laidoff everyone. In contrast to those conditions, in Q1 2010, just seven percent (7%) of company's surveyed plan to reduce workforces in January, February or March. This year lay-offs or reductionsin-force are attributed to seasonal change and a merger, not to a failing recessionary economy.

Twenty-five percent (25%) of companies reported hiring for growth needs in the last quarter, Q4 2009. Historically the slowest hiring period of the year across the area, another positive sign for Sacramento regional jobs recovery in the first quarter of 2010 is indicated as twenty percent (20%) of employers polled say they will be motivated to hire for growth and add staff in Q1. Contacted directly by telephone between November 18 and December 18, 2009, six percent (6%) of hiring is motivated by seasonal demands in Q1. Sacramento employers are looking for technical skills first of all. Demand for technical experience was double any other in first quarter with a focus on computer

networkingandproprietary industryspecific software operations. Employers also seek customer service, sales, manufacturing and shipping experience in the first three months of 2010.

Among all companies the cost of benefits was noted as the greatest challenge in the New Year. Morale was a significant issue noted by contacts at companies currently not hiring. For the first time in nearly a year, two companies say finding qualified candidates for jobs is becoming an issue. What's Our Real Federal Income Tax Rate?

Americans who work for a living, pay their taxes, and keep their personal and family budgets in check must find the irresponsibility of Congress unbearable. If they do not, it could well be because they choose to ignore the gross mismanagement of their elected representatives and senators.

The Congressional Budget Office (CBO) tells us that average American taxpayers pay 22 percent of their income in federal income taxes. What the CBO data do not tell us is what rate would be needed if income taxes were set at a rate to ensure that collections fund federal spending each year.

The Office of Management and Budget (OMB), however, provides the data to determine what our tax bill would be if the federal government's budget were required -- as our family budgets are -- to be balanced. This chart shows the individual income tax rate required to maintain a balanced budget for each of the following years, as well as the Social Security and FICA amounts taken from our paycheck by the federal government (see box below).

This rate is what would be required to stop increasing the federal debt, which is now almost \$13 trillion. The reality is that the federal government is playing games with our earning power and prosperity as well as those of our children and grandchildren.

The OMB projects that, by 2019, the federal debt will reach more than \$23 trillion. Actually, this is not likely to happen because foreign countries have already begun to pull back and stop buying our debt. The amount of total federal income used to fund the federal debt annually is projected to be \$829 billion by 2019, almost the total individual income tax collections in 2009! The OMB projections also assume that debt growth, tax increases, and

entitlements will not have a negative impact on productivity. Yet history tells us that this type of irresponsible fiscal management by government has only one outcome -- the demise and eventual collapse of an economy. A family budget may, from time

to time, incur expenses beyond its income, but the family knows the deficit cannot be sustained. Accordingly, the family reduces spending and works harder. The federal government, which fails to acknowledge the inescapable consequences of indefinite borrowing and spending, refuses to cut spending. The consequences of this irresponsibility are beginning to be evident. The value of the dollar compared to other currencies is sagging and soon will break. Sooner rather than later there will be fewer lenders, and taxpayers will have little left that the government can take.

Those of us who actually work and add to the prosperity of our economy are the only ones that government can tax to fund its irresponsibility. At some point, each of us will have to ask why we should continue. When too much is confiscated,

the incentive to produce ends. Producing is simply is not worth the effort. The "golden goose" is being butchered at the altar of government irresponsibility and greed. On October 30, 2009, U.S.

Secretary of State Clinton blasted the Pakistani government for not imposing higher taxes on its citizens. She said, "The percentage of taxes on GDP in Pakistan is among the lowest in the world. We in the United States tax everything that moves and doesn't move, and that's not what we see in Pakistan." This speaks volumes for what those we have elected to govern our nation think of those of us who have created our nation's prosperity.

An elite "governing class" -- which squanders our precious earnings and the future work effort of our children -- needs to be removed. The sooner the better. Robert L. The Theory of Moral Sentiments: Adam Smith's Timely and Timeless Classic

2009 marks the 250th anniversary of the publication of Adam Smith's masterful treatise on ethics, The Theory of Moral Sentiments. Smith, primarily known today for his hugely influential 1776 work on political economy, The Wealth of Nations, was a professor of moral philosophy. The Theory of Moral Sentiments is stunningly relevant today.

Whereas The Wealth of Nations featured the "invisible hand," the metaphor that dominates Moral Sentiments is "the impartial spectator." The "spectator" represents one's conscience—one's ability to perceive the divinely ordained objective standard of right and wrong.

In Smith's view, conscience is both a divine spark in mankind and also the product of reason. Indeed, Moral Sentiments (like western civilization itself) is a synthesis of Greek Stoic philosophy and Christian thought.

The genius of Moral Sentiments lies in its clear, thorough explanation of the necessary preconditions for social harmony. Smith cites three cardinal social virtues: prudence, justice, and beneficence. Indeed, as we survey our discordant, divided society today, we can see that many of our problems stem from confusion about these three virtues. Smith, in spite of writing his book so long ago, provides the solutions to today's most vexing social problems.

By "prudence," Smith means the practical steps that a person takes to provide for his own needs and wants. For able-bodied adults to shun this basic responsibility is self-destructive and antisocial.

Smith's second social virtue, justice, is "the main pillar that upholds the whole edifice" of society. As essential as it is, though, justice "is entitled to very little gratitude" because "it does no real positive good" and "is ... but a negative virtue" that "only hinders us from hurting our neighbour." Smith is right. We don't feel gratitude to others for not killing or robbing us, because they are simply refraining from what they ought never to do. Yet when people do not refrain from infringing our basic rights, society disintegrates. Thus, the irony that just behavior is at once the virtue that is least deserving of praise, but most indispensable for society's wealth.

Smith's third social virtue, beneficence, deserves the highest approbation, for it represents the greatest good that one can do beyond the call of duty. Beneficence, though, is never a duty. More specifically, it may be one's duty to God as a practicing Christian, but it can never be made a legally compulsory duty to one's fellow man. Here Smith illuminates the essential difference between law and gospel that still confuses and divides Christians today.

In Smith's words, "Beneficence is always free, it cannot be extorted by force, the mere want of it exposes to no punishment; because the mere want of beneficence tends to do no real positive evil." "Beneficence ... is less essential to the existence of society than justice. Society may subsist, though not in the most comfortable state, without beneficence; but the prevalence of injustice must utterly destroy it." Beneficence "is the ornament which embellishes, not the foundation which supports [society]."

Government force may only be used to enforce justice (i.e., to restrain or punish those who would infringe the rights of others) but not to enforce prudence or beneficence. A government that would presume to compel citizens to work (or threatens to lock up citizens who prefer not to purchase health insurance) violates the very rights it is supposed to protect. So does a government that compels the redistribution of property from some citizens to others, because such deeds would violate the necessary and fundamental principle of justice.

Meddlesome do-gooding-the pseudo-charity whereby A and B use governmental force to bestow unearned

benefits upon C that are paid for by D—is unraveling the fabric of society today. When one looks to Washington, one sees that Smith has captured with uncanny accuracy the mentality and spirit of present-day social engineers, central planners, and redistributors of property: "The man of system ... is apt to be very wise in his own conceit, and is often so enamoured with the supposed beauty of his own ideal plan of government, that he cannot suffer the smallest deviation from any part of it. ... he seems to imagine that he can arrange the different members of a great society with as much ease as the hand arranges the different pieces upon a chess-board."

The political reformer manifests "the highest degree of arrogance." He seeks "to erect his own judgment into the supreme standard of right and wrong." He "fanc[ies] himself the only wise and worthy man in the commonwealth, and [believes] that his fellow-citizens should accommodate themselves to him."

This attitude leads to "the madness of fanaticism" among the political leaders of radical reform, while the mass of followers are "intoxicated with the imaginary beauty of the ideal system, of which they have no experience, but which has been represented to them in all the most dazzling colours in which the eloquence of their leaders could paint it. Those leaders themselves, though they originally may have meant nothing but their own aggrandizement, become, many of them, in time the dupes of their own sophistry."

Indeed, I don't believe it is possible for any current book analyzing contemporary America to surpass Adam Smith's classic Theory of Moral Sentiments in terms of lucid insight and timely (and timeless) wisdom.



Rancho Cordova - Ken Cooley, a member of the Rancho Cordova City Council since the City incorporated in 2003, was sworn in as Mayor at the Rancho Cordova City Council meeting on December 21st. Robert McGarvey, also a Council Member from the City's beginning,

was sworn in as Vice Mayor. California State Assembly Member Alyson Huber performed the swearing-in ceremony for the new Mayor and Pastor Mike Mitchum from the Rancho Cordova Neighborhood Church swore in the Vice Mayor. Those responsible for this act apparently spent time poring through files and other things with little street value.

CRI is not too worried that our opponents may have gained a glimpse of our strategy; we are pretty up front about what we do and why we do it. But we take this as another sad reminder of the

Over the years CRI has noticed something else. Opponents of our family friendly agenda have not limited their opposition to conventional education or activism. Our web site has been hacked, our signs and literature destroyed, and our staff has received threats of violence.

It is a tribute to the determination of the staff and supporters of CRI, and the importance of this work, that CRI has not backed down. Each attack has been met with a renewed commitment to push on. And at times we have directly pushed back: see the YouTube video, Louder than Silence, we produced in response to the numerous threats we received over our opposition to The Day of Silence.

And this incident will be the same. The authorities will pursue those who committed this crime. The computer equipment and other valuables will be replaced. And even more security measures will be put in place. Backing away from the battle because of this attack will not even be discussed as an option. Similar choices need to be made by everybody who is reading this. The days of merely observing the culture war are rapidly coming to an end. You may not be the victim of vandalism or threats but you will be asked to take a stand on important but emotionally charged issues. It may come when a neighbor

asks how you are going to vote on a ballot measure, or when you consider opting your child out of unacceptable curriculum at school. It may be when you wrestle with putting a sign in your yard or a bumper sticker on your car that clearly identifies your views.

In 2010 and forward, CRI needs a small army of individuals who have decided that they will take a stand and will commit to a partnership with us. Yes, immediately we need partners who will understand the huge financial burden that comes from a break-in like we suffered last weekend. Please let us know if you can send a special donation to help us replace our losses and increase our security.

But we also need the long term partners who will take the resources CRI provides and will become activists. Attend a Lobby Day. Send a student to City on the Hill. Join us at a school board meeting-

RT Implements Park-Pay-and-Ride Program Beginning January 2010

Effective Sacramento Friday, January 1, 2010, the Sacramento Regional Transit District (RT) implemented a parking fee at three light rail station park-and-ride lots. RT will charge a \$1 daily parking fee at the following "park-pay-and-ride" lots on the Blue Line: Watt/I-80 (243 spaces), Watt/I-80 West (248 spaces) and Roseville (1,087)Road spaces). Passengers can pay the daily parking fee by cash (exact change is required), credit card or debit card at the parking payment kiosk located at the station platform. Passengers can also pay the daily parking

fee by mobile phone by calling 1-888-450-PARK (7275). There is a 35-cent service charge to pay by phone. For convenience and added monthly parking value, passes are available for \$15. Monthly parking passes can be purchased online at www.sacrt. com; RT's Customer Service and Sales Center at 1225 R Street (adjacent to the 13th Street light rail station); Bel Air markets at 1039 Sunrise Avenue (Roseville) and 7901 Walerga Road (Antelope); or by calling RT at 916-321-2849. Independent-thinking Residents Needed to Help Draw Political Boundaries

Sacramento – The State looking for Auditor is volunteers to serve on a votercommission approved to redraw the lines for California legislative and Board of Equalization districts. The 60day online application period begins on December 15, 2009 and ends on February 12, 2010.

"Redrawing district boundaries is an important job," said State Senator Dave Cox. "Those serving on the Citizens Redistricting Commission are responsible for the geographic boundaries of 80 Assembly districts, 40 Senate districts, and four State Board of Equalization districts which will stand for the next 10 years."" Cox added, "This process takes redistricting out of elected officials' hands and gives that power to citizens." Passed in November 2008, Proposition 11 requires the State Auditor to initiate an application process to fill a 14-member commission. According to the State Auditor, the process for

determining the districts and coming to a final agreement must occur in an 8 1/2 month period that starts January 1, 2011, and ends September 15, 2011, with the presentation of the final maps to the Secretary ofStateforcertification. During those 8 $\frac{1}{2}$ months, the duties of the commissioners will be complex and time-consuming.

Duties of commissioners include but are not limited to: holding public hearings throughout the state, review and discuss demographic data, hire and direct commission's staff and vote for the approval of the final district maps.

Applicants must be a registered California voter, who has voted in at least two of the last three statewide general elections. Interested voters can go online at www. wedrawthelines.ca.gov to fill out an application. For those without access to the internet, please call (866) 356-5217.

Assemblyman Niello Weighs In on CARB's Proposed Diesel Regulations

Sacramento – (December 11) Assemblyman Roger Niello (R-Fair Oaks) today testified at the California Air Resource Board hearing to consider the implementation of the truck and bus regulations relative to diesel emissions.

Lastyear, the Board approved strict regulations to reduce emissions of diesel particulate matter, oxides of nitrogen, and greenhouse gases from in-use diesel trucks and buses that operate in California. This regulation establishes requirements for in-state and out-of-state motor carriers, California-based brokers, vehicle owner operators, and any California resident who

hires or dispatches vehicles subject to the regulation. In September, Assemblyman Niello led an effort of nearly half of the members of the Legislature to send CARB a formal request to temporarily suspend the regulations given the weak economy and the unavailability of bond funds for retrofits of diesel engines.

"Ironically, the economy is so bad that the conditions accused of producing the public health threat provoking the new rules are lessening," commented Niello. "This regulation will take a struggling economy and impose additional burdens on small and medium sized trucking companies.

I would only urge that the implementation timeline be seriously considered in order to allow businesses the time needed to recover."

CARB staff has recently releaseddataregardingtheimpact the downturn in the economy has had on emission levels in California. With the decrease in fuel usage, total tonnage of particulate matter has also naturally been reduced.

Following Assemblyman Niello's testimony, the air board acknowledged that the economy had naturally reduced particulate matter and ordered that new rules be drawn up for consideration in April.

When California voters barely approved a \$9.95 billion bond measure for High Speed Rail in 2008, they had no idea how soon they would learn the true meaning of the phrase "being railroaded." As more about this project is revealed, the backlash from the public and political leadership is sure to grow. For purposes of full disclosure, Howard Jarvis Taxpayers Association ran the unsuccessful campaign against Prop 1A (not to be confused with 2009's Prop 1A, an attempt to raise \$16 billion in new taxes). Our most potent weapon was a devastating study by the Reason Foundation which revealed that the proponents' representations regarding costs, fare price and profitability were pure fantasy. (Link: http://reason.org/news/show/ the-california-high-speed-rail). But, from the start, we had an uphill battle convincing voters how poorly thought out this measure was. The California Legislature had already stacked the deck by providing such a biased title and summary for the measure that the issue of that deception is still the subject of litigation today. The deceptive ballot material, in addition to the campaign contributions from those who would profit from the project,

train from San Francisco to Los Angeles is now estimated to cost about \$105, or 83 percent of comparable airfare. Last year, the state said prices would be set at 50 percent of comparable airfare and predicted a ticket from San Francisco to Los Angeles would cost \$55." This near doubling of the projected fare price will have a major impact on ridership: "As a result of the higher fares, state officials now think the service will attract 41 million annual riders by 2035, down from last year's prediction of 55 million passengers by 2030."

Although this revised plan calls into question the entire viability of the project, the news is bound to get a lot worse. In short, even these revised figures by the Authority were born in dreamland.

Another fantasy: "The cost of the project — recently pegged at \$33.6 billion in 2008 dollars — is now estimated at \$42.6 billion in time-of-construction dollars." Sure, that's a projected increase of about \$10 billion, which is jaw-dropping by itself. But the Reason study suggests the final costs will be more than twice the revised projection. Many who analyze the trend lines of these megaprojects think that, if it is ever built, the cost will far exceed \$100 billion.

In a bit of poetic justice, another recent revelation will cause some hardcore backers of the project environmentalists and urban activists - to suffer a case of buyers' remorse. True, some environmentalists who took the time to actually analyze the project concluded that it would do more harm than good. But groups like the Sierra Club jumped on board without critical analysis. Like so many others, they applied a simple mindset: Cars, bad. Trains, good. But it turns out that, from an environmental perspective, this is not so simple. Recent studies by the University of California regarding the environment life-cycle assessment of various passenger transportation systems cast specific doubt on California's high speed rail project. In

reporting on those studies, the Institute for Transportation Studies noted that "if high-speed rail draws only half the ridership it says it will attract, its environmental performance will be twice as bad per passenger mile traveled. And, if compared to typical aircraft travel in situations where 70 percent of rail passenger seats are filled, high-speed rail performs worse (the crossover occurs when high-speed rail achieves 65 percent of estimated ridership compared against current aircraft utilization rates at 70 percent)."

If building California's High Speed Rail project results in millions of metric tons of carbon going into the atmosphere, and its ridership is substantially less than needed to make the project viable – which is the current trend line – a legitimate question is whether HSR will inflict more damage to the environment than if it were never built.

The only good news is that it is still not too late to pull the plug on the entire HSR scheme. Legal authority exists to simply refuse to issue any more bonds or provide appropriations. Better yet, if the Legislature had the courage to do so, it would put the issue back before the voters and, instead of telling them a story of sugar plum fairies, tell the truth about costs and environmental impact.

But the chances the California Legislature will do the right thing here are zero. There are too many moneyed interests, too many cows to be milked to give up on this lucrative project to expect that rational thought will win the day. Between the p.r. firms, the contractors and bond brokers, they will push this horrible project as aggressively as possible before the real truth is realized. By then, they hope it will be too late for California to reverse itself.

State Announces 2010 as the Year of the Checkpoint

More than 2500 Checkpoints Planned Throughout the Year

holiday travel season, state traffic safety officials continued to tighten their firm grip on drunk drivers by and declaring 2010 as "The Year of the Checkpoint" and announcing a record \$8 million in grant funding to 148 law enforcement agencies for DUI checkpoints - up from \$5 million in 2009. The California Office of Traffic Safety (OTS) will fund more than 2,500 sobriety checkpoints in 2010, a 47 percent increase over the 1,700 conducted in 2009. More than 250 took place between December 18 and January 3 as part of the December DUI Crackdown enforcement campaign, Report

Drunk Drivers. Call 911. "To my knowledge, California conducts more checkpoints than any other state," said OTS Director Christopher J. Murphy. "DUI checkpoints are timetested and proven as the most effective DUI countermeasure and I'm gratified that we're seeing the life-saving results."

Since OTS and law enforcement began placing increased emphasis and funding toward sobriety checkpoints in 2006, alcoholrelated deaths have declined in California. According to the National Highway Traffic Safety Administration's (NHTSA) Fatality Analysis Reporting System, DUI deaths declined in California by 9.1 percent between 2007 and 2008, marking a total decrease of nearly 21 percent from the most recent high point

OTS will fund checkpoint operationsbytheCHPandregional 'Avoid' DUI task force programs covering 42 counties and over 400 local police departments. Increased checkpoints will target California's "Top 50 DUI Cities" with even more sobriety checkpoints in 2010. The number of OTS-funded DUI checkpoints in these 'Top 50 DUI Cities' topped out at 605 in FFY 2009. With increased funding, that number is expected to hit 975 in 2010, an increase of over 60 percent. In addition to the checkpoints,



Attempted Bank Robbery in Citrus Heights

Citrus Heights - On 1/4/2010, at approximately 1340 hours, a female Hispanic or Arabic subject, approximately 5'4"-5'6", heavy, wearing a black sweater and dark pants, approached a teller window inside the bank, and slid a plastic bag underneath the security window. Intersection Collision Turns Fatal

Sacramento - On December 16, 2009, at approximately 12:39 a.m., Monica Colton a 36 year old from Sacramento was driving a blue 1997 Chevrolet Cavalier on westbound Madison Avenue at Auburn Boulevard in the #3 lane at an unknown speed. Kym Goodman, a 49 year old from Sacramento was driving a silver 2004 Kia Spectra on eastbound Madison Avenue making a left turn onto northbound Auburn Boulevard at an unknown speed. As Goodman was making the left turn, the Cavalier was also entering into the intersection and the front of the Cavalier struck the front of the Spectra. The Spectra spun out of control and came to rest facing in a southerly direction. The Cavalier spun out of control and came

to rest partially on the west sidewalk of southbound Auburn Boulevard. The Spectra caught fire and citizens came to the aid of Goodman and pulled her from the vehicle. The citizens left the scene before Officers arrived. Goodman was transported to Mercy San Juan Medical Hospital with complaint of pain to her chest and leg. Colton sustained fatal injuries as a result of this collision. Both parties were wearing seatbelts at the time of the collision.



For several months I have had the privilege to read as the Klein Family shared their journey to adopt their second child, Emma Nichole Asnakech Klein from far off Africa on their Facebook Pages. This young couple, Aaron and Cacey, adopted their first child, Spencer, from South Korea. As I looked through their profile and took a glimpse into this young family's life, the problem of orphaned children around the world became more of a reality. I came across staggering statistics about worldwide orphans during the 2 year celebration of Spencer's Adoption Day. Aaron posted "There are 134 million orphaned children around the world. 130,000 waiting forever for families in the U.S. foster care system. Every 18 seconds another child becomes an orphan. Every 15 seconds a child loses a parent to AIDS. And my favorite statistic: it only takes ONE person to make a difference

in the life of a child. You!" Almost a year after adopting Spencer, the Kleins decided to start the process of adopting another child in October of 2008.

She is currently at the Holt International Care Center in Durame, and we expect to travel to Addis Ababa in two to four months to bring her home, depending on the legal process and visas, etc."

On December 20, Cacey and Aaron began their 11 day journey to Africa to bring their new daughter to America! Spencer stayed back with grandparents who also helped the growing family finalize the purchase of their new home. The Facebook posts were frequent and exciting. The 32 hour plane rides, countries they had to travel through and obstacles they hurdled were shared including the much awaited first sight of their "beautiful little princess."

As the adoption process was being finalized on December 29th, Aaron posted "Stuck in Africa. Need a few Congressional

She will have opportunities and freedoms in life that she would never have had in Africa thanks to a loving couple that traveled around the world to receiver her, a remarkable elected leader and a social network. I am thankful that I was able to be part of one of the happiest and special days of their lives all thanks to a Facebook "Friend Request."

Renegades Are 2009 World Champs





With it's first-ever World Championship safely tucked away, the Nor-Cal Renegades now have its sight set on yet a bigger stage – the Tournament of Champions at Lakeland, FL, Feb. 12-14, 2010. The TOC features winners of 18 national and world tournaments of senior softball.

The Renegades posted a perfect 8-0 record at Phoenix in capturing Senior Softball USA World Championship in the 70 AAA division. All players must be at least 70 years of age to compete. Second baseman John Teves led the attack with a .842 batting average which included 10 runs batted in, two doubles, two triples and a home run. Teves was voted Most Valuable Player for the tourney by his peers as well as selected to the All-World tournament team.

Other Renegades voted to the team included pitcher Don Holt; catcher Larry Heise; shortstop Ken Byrnes; and outfielder Herb Epple. Byrnes knocked in 19 runs during the four-day annual event and slugged six triples while collecting 19 hits.

Each player receives specially designed championship rings for their effort. The World Championship title followed a similar feat by the Renegades when it walked away with The Renegades then had to face undefeated Lighthouse Loans from Westlake Village, CA. In the first meeting, the Renegades romped to a 15-3 victory forcing an "if" game between the two 1-loss teams.

In the championship battle, the Renegades jumped out to a 11-0 lead midway through the third inning and never looked back in coasting to 22-8 decision over their Southern California rivals. Al Fereria, who batted .824, was named the MVP and chosen to the All-World team along with Holt, Teves, Dick Bach and Norm Gilbert. Bach hit .750 for the three-day tourney, drove in 20 runs, with 18 hits including a home run and four triples.

seeding round undefeated, the Renegades began doubleelimination play with a 16-6 win over Lincoln Hills that setup a meeting with Lighthouse. Lighthouse prevailed, 9-8, putting the Renegades into the loser's bracket. An 18-2 win over the California Gold Rush led to a rematch with Lighthouse.

The Renegades trailed throughout the seven-inning contest and were down 14-6 after five innings. In the sixth, the Renegades pecked away and got within three but Lighthouse added a run in the top of the seventh. At 15-11 things were not looking good for Nor-Cal. The Renegades picked up a run and then loaded the bases with two outs. Merv Mill hit a drive to center field for a grand slam home run and the Renegades escaped with a 16-15 come from behind win leading to a showdown between the two once-beaten team.


