Ten years after Princess Diana's death, a "Memory of a Rose" exhibit will be a cultural draw card at the California State Fair (Aug 17 to Sept 3, Cal Expo). The rare, poignant display will showcase vintage royal memorabilia, including Diana dolls and many royal wedding souvenirs.

The fair will also offer patrons a Diana tribute presentation on August 31 (the actual anniversary of Diana's passing). Author Susan Maxwell Skinner, a veteran of eight years on the Buckingham Palace press corps, will share her memories of the Princess. Also a professional singer, Skinner will I dedicate several songs to Diana's memory. The John Skinner Band will back this multi-media tribute event.

If a bustling state fair seems far removed from the somber events of 1997, Skinner supports marking the anniversary here. "Many thousands of Californians signed condolences and cried Diana's funeral," through

after the ceremony. Diana's was a life to be celebrated. Her sons recently staged a remembrance concert that was enjoyed all over the world. Their mum's impact remains relevant in many people's hearts. This anniversary is perfect time to honor one of the most effective women in contemporary history. I'll tell stories, I'll sing. We'll light a candle for Diana.'

As for the State Fair context, Skinner approves: "Diana was a people's icon. To commemorate a woman who loved pop concerts and theme parks, a rock arena or a state fair is every bit as appropriate as Westminster Abby...

Eight years of following the People's Princess during the 1980s yielded mixed memories. "Diana was nice to me and appreciated an informal, professional relationship with her," recalled the former royal reporter. "She has reshaped the British monarchy forever, mainly for the better. But she could be difficult and she certainly made some poor decisions. Her bad taste in men was legend! A rotten marriage and Royal Family politics didn't help.

"When you consider the stress

effectively. Every time we see a celebrity doing good works these days, we should remember Diana blazed that trail over 20 years ago. As a professional speaker, I frequently encounter people - of all ages and both sexes -- from all over the United States, who consider Diana their personal Princess. She was no saint. But despite ten years of (mostly unfounded) gossip, she's still a light in the lives of millions.

"I see any sins Diana committed as common to most of us. That's what makes her even more relevant; her achievements teach us you don't have to be perfect to make the world a better place! Look at the figures seen as role models these days -- well, you could do worse that a woman who stood against arms dealers, championed HIV sufferers and taught her kids to do the same."

Skinner is loaning the vintage princess memorabilia that will provide a daily magnet for royalty fans at the fair. "I attended THE wedding in 1981," she said. "Over following years, I amassed scores of collector's items. My 1981 Diana bride doll's tiara and earrings have real diamonds. I don't collect anything manufactured after her death; my "Dianabilia" is kitsch but it recalls the happiest days of her life. The wedding; the birth of her sons; those first royal tours I joined Diana on.

"I also show some rare souvenirs of royal weddings from the 1920s onward. It's not the world's biggest collection, but it's pretty and it makes history come alive. Little girls adore it!"

The author/singer has written three books on Princess Diana. She will host the memorabilia collection and sign her books from 3 - 6pm, every day at the fair. Continuing Diana's efforts for charity, a portion of book sales will be donated to the State Fair's educational scholarships. Skinner will donate several items of "Dianabilia" to a Friends of the Fair fundraising raffle.

The August 31 Diana Memory of a Rose tribute show begins at 1pm on the Cal Expo's Center Stage.

The Bourne Ultimatum (Rated PG-13)

Though the action is nowhere near Asia this time, "The Bourne Ultimatum" seems to be channeling the spirit of Hong Kong Cinema, where a film auteur like John Woo cranked out highoctane action thrillers in which fists and bullets would fly fast and furious. This third film in the "Bourne" trilogy could reasonably be described as a mixture of martial arts fury, James Bond coolness and "Die Hard" mayhem. It's a spectacular achievement of immeasurably thrilling non-stop action in which a well-trained secret operative with amnesia and a hair-trigger temperament goes on a globetrotting journey of selfdiscovery with frequent stops in foreign lands. With a minimal amount of understanding of basic plot points, "The Bourne Ultimatum" stands on its own for delivering excitement. though greater appreciation of the film is gained by familiarity with both "The Bourne Identity" and "The Bourne Supremacy." Jason Bourne, Matt Damon gives an even tougher portrait of a spy than Daniel Craig could bring to the last James Bond film. That's insignificant achievement. no One would suspect that a trained assassin has an impenetrable toughness, but Bourne's rough edge may come from not knowing with any clarity how to distinguish between friends and foes. The "Bourne" trilogy revels in its hero's murky past, made all the more mystifying by his amnesia. Much of Bourne's

hardened, brutal behavior comes from his distress at not knowing his own true identity and his unquenchable thirst for revenge for the death of his girlfriend. When the film begins, Bourne is getting chased once again by agents in Moscow, and as usual he makes a narrow escape, only to end up in London. His desire to disappear without a trace is rudely upended when a front-page story in a London newspaper speculates about his existence as an operative in a covert program named Blackbriar. Arranging a meeting with British newsman Simon Ross (Paddy Considine) turns into a deadly affair at the busy London Waterloo train station. It becomes quickly clear that Bourne, once trained as a super-assassin by top secret CIA black-ops program, has some Agency types gunning for his termination with prejudice. Shadowy conspiracies are ginned up from the defunct Treadstone operation, and Bourne is caught in the middle of a turf battle that soon rages between the deceitful blackops chief Noah Vosen (David Straithairn) and CIA internal investigator Pamela Lundy (Joan Allen). Vosen and his crew are only interested in killing Bourne as a final solution to covering up the errant Treadstone program,

while Lundy is more intent on getting Bourne to come in from the shadows, where he may cast a bright light on corrupt Agency behavior.

Bourne's instinct for survival is well-honed by his past training, and as a result he is stronger and smarter than his pursuers, which happen to be secret operatives, federal agents and the local police in every city he visits in a desperate quest to find answers to questions that still haunt him. While even the CIA director Ezra Kramer (Scott Glenn) conspires against him, Bourne picks up a few friends in the field, including conflicted CIA agent Nicky Parsons (Julia Stiles), who once before endangered her career to help him. Her assistance is invaluable in Madrid, where Bourne engages two agents in deadly hand-to-hand combat. Then they slip off to Tangier, hot on the trail of the Madrid CIA chief who's transporting secret documents.

The chase sequence in Tangier is particularly spectacular, involving a motorcycle chase up and down narrow streets as well as steep sidewalk steps. But the action is most impressively stunning as

ROSEVILLE, CA - The Sacramento Capitals defeated the New York Buzz, 24-20 in overtime to win a record sixth World TeamTennis Championship in Roseville, California. The Caps last won the WTT title in 2002. This was New York's third appearance in the WTT Championship match, only to lose to Sacramento each time.

After opening the 2007 season with two losses, the Caps won 11 of their final 12 matches to advance

Vic Vicari of Sacramento, and Vicki Ammon of Carmichael, were the overall "Ironman" and "Ironwoman" winners of the 34th annual "Eppie's Great Race," which took place on Saturday, July 21, 2007. Elk Grove's youth athlete David Stagg (16 years) was the overall winner of the second annual "Eppie's Great Race Kaiser Permanente Kids Duathlon," with Maggie Lloyd (17 years) of Sacramento finishing first of the youth females.

In addition to Stone and Vicari, 1,958 people competed in this year's Eppie's Great Race triathlon, which requires competitors to run, cycle and paddle along the American River Parkway through Rancho Cordova and Sacramento, California. This year's competitor 2007 Eppie's Great Race featured more participants than the event has fielded in 21 years. In fact, the 2007 Eppie's Great Race set a new entry record for the annual event -627 entrants competed as "Iron" persons (one entrant completing all three legs of the triathlon) this year – the most "Iron" persons in Eppie's 34-year-history! 

Plastic Is a Dangerous Delicacy to Cats

Q: A year ago today, I bought our calico cat, "Gina," from the local SPCA. She is now about 2 1/2 years old. At the shelter, she contracted a respiratory infection, but we nursed her back to good health. Gina is a lovely cat, but we find it odd that she wants to eat plastic bags or anything plastic she comes across. We have to hide them. Any ideas why this is happening or what she finds so yummy about plastic? -- From

her confused owner, Rena M., before dinner. via e-mail

A: Gina's attraction to plastic is not as unusual as you might think. Many cats take a strange liking to different types of plastic, often attempting to gnaw or eat bags, plastic containers, cups and the like. Some curl up and sleep on them; others eliminate on them.

The reason for the attraction is unknown, or at least, indefinite. I once had a cat that was thrilled by anything that made a crinkly sound, especially crumpled paper (upon which he would pounce the instant he heard the sound, making the act of throwing away junk mail a real adventure), plastic sandwich bags and bubble wrap. There's some unnamed joy being associated with plastic -- maybe because it sounds similar to a cat food bag being opened just

At any rate, plastic bags (and any grade of plastic, really) are definitely not healthy for Gina, as they can cause blockages and other damage to the digestive tract. Keep hiding the bags. If some plastic objects can't be hidden, spray them with a repellent such as bitter apple (available at pet-food stores) and, if you catch Gina trying to gnaw them anyway, hiss and clap your hands to startle her. Encouraging a negative association with plastic items may reduce her fondness for them.

Poisons In Your Home - From Metro Fire Dept.

Making your home safe for your family

Poisonings are very common, occurring in about 2 million people a year and about half of those cases occur in children under the age of 5!

Children are naturally inquisitive and love to crawl or toddle around the house, putting everything that they can get their hands on into their mouths. And there are many items in your home that you might not realize can be toxic if swallowed by young children. Many cleaning product are potentially hazardous if ingested, particularly by children. In addition to cleaning products, plants, cosmetics, pesticides, paints and solvents account for 60 % of the poisonings of children. Medications account for the other 40%.

Another interesting fact is that the majority of poisonings in young children occur between 4 and 10 p.m. Dinnertime is such a busy time of day for a lot of families, that many times parents do not supervise their children as closely as usual. Poisonings during this time period are so common, that poison control

centers refer to that time block as the 'arsenic hour'.

Think about what your young child could find just by going into your purse! Make-up and medications are very common items found in purses, and they can be deadly for children. And don't trust the 'child protector' tops on medicines. Many young children are perfectly capable of opening a child protector top very quickly.

Another household poison that you might not have considered, is vitamins. Multi-vitamins, whether for adults or children, can be poisonous if an overdose is taken. Children's vitamins are made to look and taste like candy. This makes them very attractive to young children and when taken in large amounts, they can have serious consequences. The most serious risk from vitamins comes from the iron and the calcium.

If a poisoning should occur, call the Poison Control center before taking any action. Do not induce vomiting or give anything else by mouth without instructions from the Poison Control Center. A Poison Control Center is

usually a better resource than your own doctor if you suspect that your child has been poisoned. The Poison Control Center is immediately available in an emergency situation. It is staffed by medical experts with access to specific information on different types of poisons and other substances that may harm children. But remember, if your child has collapsed or is not breathing, call 9-1-1 instead.

The nationwide number for Poison Control is - 1-800-222-1222.

When calling Poison Control, it is helpful to have the name of the product or medicine that you suspect was taken, how they were exposed (did they swallow it, inhale it, etc) and the current symptoms that the child is experiencing. You will be asked your child's age and weight, whether or not he has any medical problems and a call back number, so it is a good idea to have this information handy at all times.

Remember, take the time to secure or lock up medications, cleaners and other household products out of the reach of children – for safety's sake.

Public Hearing On RT Bus Service Changes

The Sacramento Regional Transit District (RT) will hold a public hearing on Monday, August 13, 2007, to receive comments regarding proposed bus service changes. These changes may include possible discontinuation or realignment of the following underperforming routes: 6, 9, 10, 13, 14, 18, 28, 34, 36, 50E, 61, 62, 63, 64, 65, 74, 75, 76, 83, 91, 105, 140 and 143

The State budget expected to be approved calls for a \$1.3 billion loss to public transportation, which will result in a \$14 million annual loss to RT and a \$1.6 million reduction of bus

service. In anticipation of this budget shortfall, RT has implemented cost saving measures and internal cuts to offset further reductions in service.

"With the price of gasoline continuing to increase, RT should be in a position to encourage people to use transit, not reduce the service offered," stated Michael R. Wiley, Deputy General Manager.

The public hearing will be held at 6 p.m. in the RT Auditorium at 1400 29th Street (at N Street). This location is served by Routes 36, 38, 50E, 67 and 68, and light rail at the 29th Street light rail station.

The proposed service changes and environmental documents are available for review by calling the RT Planning Department at (916) 321-2862. Comments may be submitted in writing to the Planning Department (P.O. Box 2110, Sacramento, CA 95812-2110) and must be received by 5 p.m. on Wednesday, August 8, 2007.

The January 2008 service changes are scheduled for adoption by the RT Board

of Directors on August 27, 2007, and implementation on January 6, 2008


