Fair Oaks, CA -- Hope spreads faster than cancer – that was the lesson ten-year-old Konnor Davis taught the corporate world after his big sister was diagnosed with cancer at the age of 28.

Kelli Davis, a Field Marketing Manager for Round Table Pizza, was enjoying a successful career in the vibrancy of her youth. One evening while on a business trip, she felt a pain in her arm. A few hours later, she sat in stunned silence as the doctor said, "you have cancer." Kelli was diagnosed with a rare form of Non-Hodgkins Lymphoma, a cancer of the lymphoid tissue. "At 28 you don't expect to get sick," says Kelli. "I had played soccer just a few days earlier." And at 10, her little brother, Konnor, didn't expect to face the harsh reality of an ailing sibling. "We didn't hide anything from him," explains Kelli. "I had to move back home and he had to share his room with me. He was there when the chemo made me sick in the middle of the night. The cancer took over his life." Though the cancer had invaded his sister's body, his bedroom, and his life, Konnor didn't allow it to invade his spirit: "Konnor had a sense of humor through it all. We were able to see a serious disease through innocent eyes," says an admiring big sis.

on and off for seven months. But as her health ebbed and flowed with the cycles of treatment, she insisted on going to work whenever possible. "Working gave me a sense of normalcy, something to focus on other than my cancer," recalls Kelli. "My family wanted to do something to thank my bosses Rob [McCourt] and Cindy [Kirk] for all their support and for accommodating my illness." But what do you get a corporate president and a marketing director to say thanks? Konnor had a plan..."We came up with the idea to sell balloons," explains Konnor, shying away from the credit. Each year, Round Table Pizza holds a balloon fundraiser to support Children's Miracle Network, an alliance of children's hospitals throughout the United States. Paper balloons are sold at participating Round Table restaurants for \$1 during the month of April. "We knew participating in the Round Table Pizza fundraiser and raising money for the Children's Miracle Network would mean more to Rob and Cindy than any gift we could have bought," proclaims the duo. Konnor didn't just talk big, he walked even bigger. He hit the pavement, knocking on doors and working the neighborhood for donations. He sent cards to friends and family, rolled coins, took the money to the bank and wrote thank you letters to everyone who

donated. "This was his project and he did all the work," says Kelli. "He had incredible motivation for a ten-year-old. He was able to go up to people and ask for a dollar because he knew why he was doing it."

After a month of hard work, Konnor presented Round Table Pizza President Rob McCourt and Field Marketing Director Cindy Kirk with a paper balloon he bought for \$2,129. "It was truly uplifting to see what a fifth grader was able to accomplish and the love his family has for each other," says McCourt. "I could clearly see that Konnor did this because he wanted to make a difference and support his sister."

"We were floored," says Kirk, who worked closely with Kelli during her illness. "We could not believe that a ten-year-old could do something like that. He was very unassuming." Kelli completed a successful treatment the Monday after Konnor presented his gift.

"Because of my sister, I know how important it is to help people," explains Konnor. He says he hopes he can inspire people to give more money to cancer research, so that doctors will be able to study rare cancers


CITRUS HEIGHTS President of the Citrus Heights Lions, Jerry Still, will be completing his term as club president at the end of June. He would like to thank all those

From the Middle of The River

My seventy-two year old sea legs made me feel tipsy attempting to brace myself on a floating dock on the river. Each time a wave rolled beneath the pier I threw my arms in the air and flapped them around like bird as I tried to catch my balance. Finally, I shuffled myself over to a concrete pylon to embrace

We had no day plans that warm Sunday morning when my wife's sister, Tonja, called and said they had dusted off their 1988 Bayliner and asked us to join them on a cruise up the Sacramento River. With a pot of coffee and an egg sandwich in our tummies, we were picked up at 9 a.m. for the excursion.



IN CONGRESS, JULY 4, 1776 The unanimous Declaration of the thirteen united States of America

hen in the Course of human events it becomes necessary for one people to dissolve the political bands which have connected them with another and to assume among the powers of the earth, the separate and equal station to which the Laws of Nature and of Nature's God entitle them, a decent respect to the opinions of mankind requires that they should declare the causes which impel them to the separation.

We hold these truths to be self-evident, that all men are created equal, that they are endowed by their Creator with certain unalienable Rights, that among these are Life, Liberty and the pursuit of Happiness. — That to secure these rights, Governments are instituted among Men, deriving their just powers from the consent of the governed, — That whenever any Form of Government becomes destructive of these ends, it is the Right of the People to alter or to abolish it, and to institute new Government, laying its foundation on such principles and organizing its powers in such form, as to them shall seem most likely to effect their Safety and Happiness. Prudence, indeed, will dictate that Governments long established should not be changed for light and transient causes; and accordingly all experience hath shewn that mankind are more disposed to suffer, while evils are sufferable than to right themselves by abolishing the forms to which they are accustomed. But when a long train of abuses and usurpations, pursuing invariably the same Object evinces a design to reduce them under absolute Despotism, it is their right, it is their duty, to throw off such Government, and to provide new Guards for their future security. — Such has been the patient sufferance of these Colonies; and such is now the necessity which constrains them to alter their former Systems of Government. The history of the present King of Great Britain is a history of repeated injuries and usurpations, all having in direct object the establishment of an absolute Tyranny over these States. To prove this, let Facts be submitted to a candid world. He has refused his Assent to Laws, the most wholesome and necessary for the public good. He has forbidden his Governors to pass Laws of immediate and pressing importance, unless suspended in their operation till his Assent should be obtained; and when so suspended, he has utterly neglected to attend to them. He has refused to pass other

large districts of people, unless those people would relinquish the right of Representation in the Legislature, a right inestimable to them and formidable to tyrants only. He has called together legislative bodies at places unusual, uncomfortable, and distant from the depository of their Public Records, for the sole purpose of fatiguing them into compliance with his measures. He has dissolved Representative Houses repeatedly, for opposing with manly firmness his invasions on the rights of the people.

He has refused for a long time, after such dissolutions, to cause others to be elected, whereby the Legislative Powers, incapable of Annihilation, have returned to the People at large for their exercise; the State remaining in the mean time exposed to all the dangers of invasion from without, and convulsions within. He has endeavoured to prevent the population of these States; for that purpose obstructing the Laws for Naturalization of Foreigners; refusing to pass others to encourage their migrations hither, and raising the conditions of new Appropriations of Lands. He has obstructed the Administration of Justice by refusing his Assent to Laws for establishing Judiciary Powers. He has made Judges dependent on his Will alone for the tenure of their offices, and the amount and payment of their salaries.

He has erected a multitude of New Offices, and sent hither swarms of Officers to

enlarging its Boundaries so as to render it at once an example and fit instrument for introducing the same absolute rule into these Colonies

For taking away our Charters, abolishing our most valuable Laws and altering fundamentally the Forms of our Governments: For suspending our own Legislatures, and declaring themselves invested with power to legislate for us in all cases whatsoever.

He has abdicated Government here, by declaring us out of his Protection and waging War against us. He has plundered our seas, ravaged our coasts, burnt our towns, and destroyed the lives of our people. He is at this time transporting large Armies of foreign Mercenaries to compleat the works of death, desolation, and tyranny, already begun with circumstances of Cruelty & Perfidy scarcely paralleled in the most barbarous ages, and totally unworthy the Head of a civilized nation.

He has constrained our fellow Citizens taken Captive on the high Seas to bear Arms against their Country, to become the executioners of their friends and Brethren, or to fall themselves by their Hands. He has excited domestic insurrections amongst us, and has endeavoured to bring on the inhabitants of our frontiers, the merciless Indian Savages whose known rule of warfare, is an undistinguished destruction of all ages, sexes and conditions.

In every stage of these Oppressions We have Petitioned

Friends.

We, therefore, the Representatives of the united States of America, in General Congress, Assembled, appealing to the Supreme Judge of the world for the rectitude of our intentions, do, in the Name, and by Authority of the good People of these Colonies, solemnly publish and declare, That these united Colonies are, and of Right ought to be Free and Independent States, that they are Absolved from all Allegiance to the British Crown, and that all political connection between them and the State of Great Britain, is and ought to be totally dissolved; and that as Free and Independent States, they have full Power to levy War, conclude Peace contract Alliances, establish Commerce, and to do all other Acts and Things which Independent States may of right do. — And for the support of this Declaration, with a firm reliance on the protection of Divine Providence, we mutually pledge to each other our Lives, our Fortunes and our sacred Honor.

harass our people and eat out their substance. He has kept among us, in times of peace, Standing Armies without the Consent of our legislatures. He has affected to render the Military independent of and superior to the Civil Power. He has combined with others to subject us to a jurisdiction foreign to our constitution, and unacknowledged by our laws; giving his Assent to their Acts of pretended Legislation:

For quartering large bodies of armed troops among us: For protecting them, by a mock Trial from punishment for any Murders which they should commit on the Inhabitants of these States: For cutting off our Trade with all parts of the world: For imposing Taxes on us without our Consent: For depriving us in many cases, of the benefit of Trial by Jury: For transporting us beyond Seas to be tried for pretended offences: For abolishing the free System of English Laws in a neighbouring Province, establishing therein for Redress in the most humble terms: Our repeated Petitions have been answered only by repeated injury. A Prince, whose character is thus marked by every act which may define a Tyrant, is unfit to be the ruler of a free people.

Nor have We been wanting in attentions to our British brethren. We have warned them from time to time of attempts by their legislature to extend an unwarrantable jurisdiction over us. We have reminded them of the circumstances of our emigration and settlement here. We have appealed to their native justice and magnanimity. and we have conjured them by the ties of our common kindred to disavow these usurpations, which would inevitably interrupt our connections and correspondence. They too have been deaf to the voice of justice and of consanguinity. We must, therefore, acquiesce in the necessity, which denounces our Separation, and hold them, as we hold the rest of mankind, Laws for the accommodation of an Arbitrary government, and Enemies in War, in Peace

Do You Qualify for VA Health Care?

I've been hearing from veterans who are unsure about whether they qualify for free VA health care.

There are a number of factors that go into the equation: Level of service-connected disability, your income and the Geographic Means Test, dates of combat, status of discharge, length of service and other VA resources available.

You qualify if you were discharged within the past two years and served in a hostile area. Your care will be free. When the two years are up, your status will be reassessed regarding your level of disability and income.

health care, you might need to make co-payments.

You don't qualify for free care if your disability isn't related to your service and your income is too high.

When you apply you'll be put into one of eight priority groups, all with different eligibility requirements, ranging from military-related disability and low income, to non-military related and high income. Since 2003 Priority Group 8 (non-service related and income too high) enrollment has been suspended, and you can't sign up.

Group 7, however, is for those qualified veterans who agree to a co-pay and whose income is above the threshold level. but below the geographic level. The determination is King Features Synd., Inc.

If you do qualify for continued made via the Geographic Means Test. This means the cost of living in your area will

be taken into consideration. If you have other health insurance, do not cancel it. Sometimes the VA takes the insurance payment and calls it even.

How to get started: You need VA Form 10-10EZ to apply. You can get it at a VA health facility, or by calling 877-222-8387, or online at www. va.gov. Apply even if you're not sure you qualify. It tells Congress just how many of us there are out here.

moved to Fair Oaks from the Bay Area. Shortly thereafter, we discovered the American River Parkway and locked our anchor into the community.

During the early eighties, I read about an organization named Save the American River Association, and their ongoing battle with the East Bay Municipal Utility District – to keep the Lower American River from becoming a creek. I immediately sent a check to SARA and became a member.

Against unbelievable relatively this odds, tiny band of determined volunteers, affectionately known as SARA, won the court case, and kept water flowing to the confluence with the Sacramento River.

In December, 2003, I attended my first SARA Annual Meeting. I was thrilled as I finally met some of the selfless individuals who have defended the river and Parkway since 1961. In 2004, I was asked to join the SARA Board and became Vice President in 2005.

incoming the As President, I want to share SARA's vision of our role as we face 21st Century challenges to the American River and Parkway. SARA is not only proud to be the organization responsible for the founding of the Parkway, but also the body the community continues to look to - to lead the effort to preserve and protect the water, land, flora and fauna that is the Parkway.

SARA's 50th As

In 1981, our family need is adequate longterm funding. The current County Parks leadership is listed as Interim despite the significant credentials. The County supervisors, current elected stewards of the Parkway, are in discussion with the cities of Sacramento Rancho Cordova and regarding a possible Joint Powers Authority approach to Parkway management. The Lower American

River still lacks a necessary flow standard, and sewage spills by Sierra communities, lacking adequate treatment capacity, threaten the health and safety of the Lower American users.

The American River Parkway Plan Update - the first since 1985 - was approved by both the City of Sacramento and the County of Sacramento, yet still needs to go through the EIR process before being sent to the State Legislature - with adoption expected in 2008. Security and stability are needed.

address these То challenges, SARA is taking several steps:

Advisory Council: At our December, 2006 Annual Meeting, SARA introduced the first 12 members of our new Advisory Council. These individuals, from diverse backgrounds, including environmental, water, legal, fund raising, promotion, management and political, will serve as a brain trust to advise the SARA Board on issues within the scope of SARA's mission.

Networking: is inviting to each of our students and often their

At times, SARA board members appear at still other civic organizations in an effort to educate the public at large

After all, our youth will be the future stewards of the American River & Parkway. In 2006, SARA welcomed our first student intern, Chelsea McDaniel, from C.K. McClatchy Senior High School. Her impact has been so positive that we intend to continue and likely expand the student intern program.

Over the last several years SARA has also had a close working relationship with Guy Galante, a 6th grade teacher at the Gold River Discovery Center in Gold River who not only uses the River and Parkway as a living, outdoor classroom, SARA but also involves his

Inaddition, we are aligning with other water watchdog stakeholders to monitor and address inappropriate sewage releases into the Upper American River by dozens of smaller Sierra communities. Alan Wade, our immediate past president, has taken on the responsibility of monitoring and reporting on Central Valley Region Water Quality Control Board sessionswhere such issues should be

addressed. Membership and Funding: These go hand in hand. SARA realizes we must strengthen our base by increasing our membership, not only to maintain our viability but also to fund our Parkway outreach, education and advocacy efforts via membership donations. Our goal is to increase our membership by the end of 2007 by 350 members. SARA has been guilty of not sending timely renewal reminders and worse yet, not actively seeking new members.

501(c)(3) Tax Status: We are currently awaiting an IRS decision to change from our 501(c)(4) status which is not tax deductible to a 501(c)(3), in which case all donations would be tax deductible. We have reason to believe that should this come about, SARA contributors would increase River and Parkway require

In closing, I ask that each reader imagine what would happen to our greater community should the American River & Parkway not have adequate river flows to support the dependent habitat, or, due to lack of funding, not have necessary maintenance and ranger protection. The American River and Parkway belongs in the center of our community as it is our sole refuge and binds so many of us to this area.

Climate Change Hits the Campaign Trail by Bill McKibben

Next month more than a billion people are who now come expected to watch the huge global warming concerts that Al Gore is staging on every continent. But my guess is that the few dozen young people who recently gathered on a town green in Lebanon, New Hampshire may sway the future at least as much.

Those college kids were the advance guard of "Climate Summer," an effort to make global warming a central issue in the next presidential campaign. They will be trailing candidates, canvassing voters, and in early August marching across the state with thousands of local residents. And in the process they'll be trying to upend conventional political wisdom, which is that the environment is always a second-tier issue, trailing jobs and health care and foreign policy. It's a tough sell -- but there are real signs that this year may be different on the campaign trail.

For one thing, the science of global warming seems finally to have sunk in with Americans. Every week another story shows just how far down a dangerous road we've gone: the latest jolt was the news that the Arctic might be ice-free in summer by 2020. By now, every new tropical storm trips the warning bell in people's minds.

And people are even realizing they need to do something about the problem -- one recent poll found that 44 percent of Americans thought cars that got less than 30 miles per gallon should be banned (which means, if you pay attention to mileage statistics, that about half of them were willing to outlaw their own vehicle).

Faced with those kinds of numbers, leading candidates at least on the Democratic side of the race have staked out strong positions on global warming. Barack Obama, Hillary Clinton, and John Edwards have already all endorsed the Climate Summer goal of 80 percent cuts in emissions by 2050. The fight now is to get them talking about it, over and over again, so that they've honed their pitch to the point that they can convince Congress should they win office in 2008.

And the only way to do that is to keep asking the candidates, keep pressing them. Six years ago, a much smaller group of students did something similar in New Hampshire. They didn't manage, alas, to affect George W. Bush, but their constant questioning did move John McCain. As soon as he got back to the capitol, in fact, he convened a hearing on the issue.

"One of the great things about the requirements of the electoral process is extensive interaction with the citizenry," McCain told his fellow senators. "There is a group of Americans

to political rallies with signs that say, 'What is your [climate change] plan?' I am sorry to say that I do not have a plan because I do not have, nor do the American people have, sufficient information and knowledge. But

do intend, beginning with this hearing, to become informed, to reach some conclusions, and make some recommendations." The result, the McCain-Lieberman climate bill, was fairly modest, but it's the closest Washington ever came to doing anything.

This year's Climate Summer campaign is much bigger -- there are students from dozens of schools, cramming into rented houses, dividing the state up into territories, connecting with campaigns. And they have many new allies locally -- in the small town of Amherst, for instance, where 400 residents turned out in April for a climate change demonstration, and where this year's big 4th of July parade will be a celebration of "the red, white, and green."

As the name implies, the campaign is bolder too. The students are paying a kind of homage to Freedom Summer, now four decades in the past, when 800 northern college kids went south to Mississippi and helped turn America around.

Those students faced unimaginably greater perils, of course-indeed three of them were murdered within days of their arrival. But their faith in the American democratic system endures to this new generation of college students. It's amazing to talk with them as they arrive in the Granite State and find very little cynicism, and a very deep faith that they can make a difference. "There's nothing I can imagine doing with my summer as important as this," said Sierra Murdoch, an organizer from Middlebury College. "There's nothing I can imagine doing with life as important as this."

It would be nice indeed if they left New Hampshire as hopeful as they have come.

One of the numbers I had to determine prior to completing the equation was how much my time and energy is worth on investment with the Fair Oaks per hour. Let's discuss the required information you will need in order to do the calculation. 1. Cost of Marketing (Including but not limited to cost to join an association, monthly costs associated with luncheons/mixers/events) 2. What your time is worth (calculate this by determining how much time you think you will spend on the project and what that value is to you) 3. Anticipated Sales. Once you have the information you can do a simple calculation, first add together the cost of marketing with what your time is worth and then divide that by Anticipated Sales.

you can believe it they find time to For instance; some advertising might cost me \$400 and may take about \$100 of my time. I expect to make about \$1000. So, add \$400 to 100 = 500 then 500/1000 $= \frac{1}{2}$ or a 1-2 ratio. What we learn is that we expect a \$1 return for every \$1 we invest.

I can tell you that the return Chamber is, for me, better than the aboveratio. I attribute my increased return due to volunteering, getting to know my peers and working diligently to earn their business. Remember, we are here to help you achieve your goals and some of the best training you can get is through volunteer work!


Gold River's Sergeant Honored



Doolittle Offers to Amendment **Provide Funding for Rural Schools**

WASHINGTON, D.C. -- from House Appropriations authorization from the federal Representative John T. Doolittle (R-Roseville) proposed an amendment today to the Interior andEnvironmentAppropriations bill that would have fully funded the Secure Rural Schools program for Fiscal Year 2008. This funding is issued to counties to compensate for the land the federal government took when creating the National Forest System, and is used to fund schools, roads, and other public services. Unfortunately, the amendment was defeated on a procedural motion, which prevented an up or down vote from occurring.

"I am disappointed that House Democrats used procedural tactics to prevent a vote on my amendment to provide desperately needed funds to rural counties in a timely manner," Doolittle stated. "The appropriations bill spends billions of taxpayer dollars without fulfilling a promise our government made to provide essential services to many of its citizens.'

While the amendment did not reach a vote, Doolittle was able to secure a commitment for another year. With no

Committee Chairman David Obey (D-WI) and Ranking Member Jerry Lewis (R-CA) to contact the appropriate authorizing committees and urge them to provide a longterm reauthorization of the Secure Rural Schools program, which would ensure payments to counties would continue for several years. The Secure Rural Schools and Community Self-Determination Act, the legislation which authorized these payments, expired in Doolittle September 2006. was successful in securing a one-year extension provided for 2007 in an emergency appropriations bill passed by Congress in May. However, debate over whether to provide funding for our troops in Iraq caused these funds to arrive well in to the current fiscal year, in

had been issued to teachers and

government, county budgets are currently unable to assume this source of revenue, which has already had a negative impact on our schools. Furthermore, this amendment would have allowed these funds to be distributed in a fiscally responsible manner, which would have benefited taxpayers. I will continue to seize every opportunity until rural counties can be secure in relying on this source of revenue promised to them by the federal government," Doolittle concluded.

U.S. Rep. John T. Doolittle has served in the House of Representatives since 1991. The 4th Congressional District stretches from the eastern Sacramento Region to Lake Tahoe on the south and runs up the Sierra Nevada range to the high desert of Modoc County on the Oregon border in the north. It encompasses the entire counties of El Dorado, Lassen, Modoc, Nevada, Placer, Plumas, and Sierra. Additionally, it includes the community of Orangevale in Sacramento County and the Oroville area in Butte County.

This technique also can help you hold down commissions and give your stocks a chance to appreciate. Another tax-advantaged move that could benefit you - particularly if you're in one of the higher tax brackets - is to invest in municipal bonds. Your interest payments will be free from federal taxes; if the municipality that issues the bond is in your state, your interest payments also may be exempt from state and local taxes. (However, some municipal bonds are subject to the alternative minimum tax, so do your research before you invest.)

By making the right moves, you can someday reach your own personal Financial Independence Day. So put it on your calendar of the future - and then do what it takes to reach that happy date.

Californians and Their Government: Time To Get Tough With Trade **The Space Between Us** Enforcement by Stephen Koplan

A recent statewide Public Policy Institute of California (PPIC) "Californians survey entitled and Their Government" reveals a healthy distance between the former and the latter. As the survey observed, a significant 64 percent of Californians claim to know "very little" or "nothing" about how bonds are financed in California, yet we just approved the largest bond package in California history (\$37 billion) last fall. As PPIC president and CEO Mark Baldassare artfully put it, "We don't know how deep the lack of understanding runs---many voters may be thinking about bonds as free money, and not as debt that has to be repaid with interest".

The seeming lack of knowledge about bonding yet the willingness to continue to approve new bonds is just one contradiction the survey revealed. In terms of budget spending, a majority of Californians favor increased funding for K-12, health and human services higher education, and roads, yet only 32% are aware that K-12 education is the largest area of state spending and that personal income tax is the largest source of state revenues. The public continues to urge the government to spend more money in nearly all areas, yet is typically

distrustful of how their government spends money and seeks greater accountability measures to make sure the money is being spent wisely. We look to voters to make informed choices about bonding, yet according to the PPIC conclusions, an overwhelming majority of those surveyed have no idea about how bonds are financed or the nature of the state's current spending obligations. In light of this reality, how do we do a better job of informing the public about the fiscal state-of-the-State?

Such a high level of voter disengagement can seem alarming when looked at in the isolated context of a survey. However, when we consider other factors, these results are somewhat less concerning. For instance, the fact that we have a representative form of government informs the survey results to the extent that people have elected representatives to worry about the day-to-day functions of the government. People are busier and busier these days, and while they demand that their representatives get along and work cooperatively on the issues of the day, they aren't terribly concerned with the "minutiae".

This is understandable. Most people do not want to micromanage the everyday operations of their government anymore than they want to micromanage the everyday operations of others they hire to perform various functions (gardener, dry cleaner, health care provider, etc.). However, people rightly call for accountability and they would prefer that this accountability be delivered in digestible, relevant portions containing information pertinent to their daily existence. They would like to have the tools to monitor the progress of their government, even if they aren't intimately concerned with the details.

To provide such a resource, those of us in government must do a better job of contextualizing the budget for California taxpayers. One of the reasons Californians are disengaged in issues surrounding the budget and bonding is that these things are not tangible items to the average person. While most Californians are not directly affected by the budget as a whole, they are impacted by key parts of the budget, such as investment in roads, streets, and schools. To communicate the nuts and bolts of such items effectively, we must do so in a form that is relevant and accessible to the everyday person. We can't expect people to be watching the "California Channel" twenty-four hours a day, but we ought to provide straightforward information to the voters to ensure a level of fiscal accountability.

On this point, the voters agree: 83% percent declared support for greater accountability through a public information system that would update them on how the bond funds are being spent. In this vein, the Department of Finance will soon be unveiling a website to assist the public in following the progress of the bonds that they approved last fall. My office is also developing a web site designed to inform and educate on these issues - stay tuned. Once this information is made broadly available, the public will enjoy the benefit of real-time access to how the bonds are impacting Californians at the local level.

This type of service strikes at the heartofthegapbetweenCalifornians and their Government. Truly, the real issue to most people is how the budget affects their everyday lives, in their communities. It is our task to present these issues in a relevant way that brings the process "home".

(NAPSA)-Since the year 2000, the United States has lost 3 million manufacturing jobs. Last year, the U.S. trade deficit set a new record at \$764 billion and this has been happening year after year. China alone accounts for nearly 30 percent of that deficit.

With the size of our trade deficit, it's hard to argue with a straight face that products have trouble getting into our market. For example, in the steel sector, lost profits and income between 1996 and 1998 amounted to \$2.66 billion. In the shrimp industry, the authors of the study computed that the negative impact

to give foreign products greater was \$210 million between 2000 access to our markets. They argue and 2003. And in furniture, the impact was \$333 million between 2001 and 2003. Other sectors of our economy, from agriculture to high technology, faced similar results.

Enforcing U.S. trade laws to prohibit unfair practices such as dumping and subsidies shouldn't be a question for our nation's leaders, it should be virtually automatic. People who work hard and play by the rules deserve to know that the government will stand by them and stand up for their interests when foreign countries try to cheat in the world trading system.

The message from this study is clear: Without vigorous enforcement of our U.S. trade laws, our domestic industries will suffer crippling losses and workers' jobs will be irretrievably lost.

Declarer sometimes runs into a totally unexpected distribution of the missing cards. There is nothing he can do about rearranging the adverse cards, but if he keeps his cool, he can occasionally overcome unfortunate distribution and demonstrate that bad luck is not always fatal. Consider this deal where South got

to four spades and West led the club jack. Declarer won with the queen, and the only question seemed to be

whether he'd make four spades or five

But when he led a trump to dummy's king at trick two, West went up with the ace, and East surprisingly showed out. It now appeared that West would score four natural trump tricks to defeat the contract, but South thought the matter over carefully and found a way to salvage his game.

He took West's ten-of-clubs return at trick three with the ace, cashed the Q-J of hearts, then played dummy's ace of hearts and trumped it! Now, pursuing his aim to reduce his trump length to equal West's, declarer cashed the A-K of diamonds and ruffed a diamond.

By this time nine tricks had been played and declarer was down to the 9-8-6 of trumps while West had the Q-10-7-3. South had already won eight tricks -- two hearts, two diamonds, two clubs and two ruffs and West had taken only one.

Declarer now led the spade nine, and whether West won with the ten or not, there was no way he could prevent South from scoring two trump tricks to make the contract. The two ruffs declarer had carefully maneuvered while reducing himself to the same number of trumps as West turned out to be the ideal medicine to overcome the 5-0 trump division. Never give up!

Editorial - Healthy Pets Bill? Not!

AB 1634, is named The Healthy Pet Bill and this may be the cruelest part of this Bill. It has nothing to do with improving any pet's health. It is designed to eliminate all dogs and cats in California. In the first unamended version, consideration was not given to some very important animals in our lives such as K-9 dogs, Service Animals such as dogs trained to help the blind or disabled, Search and Rescue Dogs and dogs used in the vast California farming industry. Another aspect of this bill was the severe restriction on all breeders of purebred dogs and pedigreed cats in the name of reducing the euthanasia of shelter animals.

The facts and figures have been distorted by the proposers of the bill to justify its passage. Similar bills have not worked, many have been enacted and met with failure No extra revenue has materialized for the communities.

Actually, often the opposite occurs as more animal are surrendered to the shelters. Fewer animals are

licensed. Most of the animals in the shelters are feral cats, unweaned kittens and puppies. Even the unfortunate euthanasia count is often misrepresented by counting even unborn kittens and puppies. A new shelter is being built in Sacramento costing over 27,000,000 dollars. Much of that will be spent on administration costs. Their concern is euthanasia, not save and re-home. Shelter numbers have been

dropping for years. One homeless dog or cat is one too many. The spay and neuter policy of all legitimate animal associations such as AKC, CFA and TICA have produced wonderful results.

There is now a shortage of adoptable pets in many shelters. Dogs and cats are being smuggled into the US from Mexico, as seen on a recent TV special

These mandatory bills have failed to produce the desired results. For example: LA County in 2000-Licensing compliance declined. Animal Control Budget increased

269%. In San Mateo, CA 1991, Dog deaths increased 126%, cat deaths increased 86%, license declined 35%

The bottom line for many of the hobby breeders, for people who love their animals and the associated events, is that this Draconian measure being proposed will impinge on every aspect of their lives. It is not the business of government to determine what an individual will pursue in

their private live.

This bill will not produce 'Healthy Pets', it will not produce extra revenue. It may jeopardize public safety by the loss of K-9 and service dogs.

And very many of us will have our lives saddened without the animals and friends who are part of our lives and happiness.



Falling home sales, rising gasoline costs and regional wages continue 2007

staff reductions surveyed this June attributes slow business as the reason for cutting workers in July, August and September. In polling 72 of 100 top regional companies Pacific Staffing discovered eleven percent (11%) of them plan to layoff workers in O3. (PRWEB) -- More than half of the nation's housing markets are appreciating or have at least stabilized, according to a Special report by Housing Predictor, an information driven web site, which forecasts housing markets in all 50 U.S. states.

Some 56% of the nation's markets are appreciating or have stabilized. Improving markets are

are experiencing similar results.

The sub-prime loan problem has led to the nation's second all-time high level of foreclosures behind the U.S. Savings and Loan Crisis in the late 1980's. But eager investors are beginning to make a dent in the foreclosure market buying many properties for lower prices. Housing Predictor expects foreclosures to continue to increase throughout the remainder of the year, and level off toward the end of 2007 as more investors purchase properties.

The sub-prime problem has quietly already spread into the conventional lending market, which lowered mortgage borrowers qualifying standards with a variety of aggressive exotic loan programs. However, economic forecasts indicate the damage in the conventional lending markets should be limited. Raw undeveloped land, however, and newly developed subdivision lots in many areas of the country are Wages, Home Sales and Gasoline Costs: When asked if wages were too low compared to Sacramento regional home prices, forty-seven percent (47%) of the HR contacts polled said yes. Fifty percent (50%) said no, and three percent (3%) didn't know or didn't answer. When asked if falling homes sales affected their business thirty-one percent (31%) said yes while sixty-six percent (66%) of companies polled said no. Three percent (3%) didn't know or didn't answer. When asked if rising gasoline costs affected their company sixty-four percent (64%) said yes while thirty-three percent (33%) said no. Three percent (3%) didn't know or didn't answer.

Heat, Air Pollution Take Toll on Pets

O: I read your column about the person who was concerned about the bird that lived in a home with a smoker. While I don't smoke, my 11-year-old golden retriever, "Blaze," has occasional breathing trouble, especially on very hot days when there is a lot of smog. Her vet prescribed a nebulizer, which helps greatly. Can you let readers know that pets are affected by unhealthy air just as we are, and to make sure they don't have to struggle to

breathe? Thanks. -- Jeri G., setting up pee pads or a litter Atlanta

A: Will do, Jeri! According to Jamie Wolf of Healthy Dogs USA (www.healthydogsusa.com), when humans feel discomfort from heat and poor air quality outside, dogs are affected 10 times more. So, during the height of summer heat, watch the weather forecasts daily, note the predicted air quality and gauge you and your dog's activities accordingly.

Take pets for walks earlier in the mornings, when air quality is better and the heat is not so intense. Monitor them closely, particularly senior dogs and small dogs, who are most affected by poor conditions. Make sure pets have plenty of water throughout the day. Small dogs should not go outside on particularly bad

days. You might even consider

pan during prolonged periods of poor air quality. Set up some indoor exercise for them, such as climbing up and down the stairs or other creative ways to help them work off excess energy.

If a pet is having trouble breathing -- excessively panting, drooling, heaving or wheezing -- take it to the vet immediately. Sometimes, it is simply a result of poor air quality, but breathing difficulties can also signal more serious conditions.

A vet can recommend supportive treatments for affected dogs, such as a nebulizer treatment after a walk, or homeopathic therapy with herbs like slippery elm (check with the vet or a pet naturopath for safe dosage).


• Bring your pet's regular food to avoid stomach upsets.

SMUD Awards \$25,000 to Area **Students with Solar Power Dreams**

Grants help local educators learn and teach renewable energy

Four local high schools will share \$25,000 to develop solar projects as part of the Sacramento Municipal Utility District's (SMUD) Energize Minds for Solar Design grant program. The electric utility provides the annual grants to help educate the next generation of energy consumers and to spur students' interest in solar and other sciences.

For the 2007-2008 school year, Laguna Creek High School earned a \$10,000 grant for a classroom project that involves a

shade structure with solar panels built over one of the school's large rooftop air-conditioning units. The energy collected from the solar panels will power one or more banks of classroom lights. The students will test if a shaded air conditioner operates more focus with grant money being efficiently in hotter weather. The classroom lighting will be replaced with energy-efficient LED lighting and powered by the solar panels.

Three schools earned the remaining \$15,000 for various projects:

 Rancho Cordova High School will design and develop a solar electric vehicle, which will be raced in the Portland Electrathon America Races next year.

• Bella Vista High School will establish a school-wide solar club to help educate students and install solar panels to power some school facilities like fountains.

• San Juan High School will purchase solar panels to power fans and lighting in a campus greenhouse. The funding will also support a newsletter reporting on the school's renewable energy and energy efficiency activities. In 2006, the first year of the grant program, SMUD awarded \$30,000 to three schools: Sheldon

High School, American River College and Will Rogers Middle School. Sheldon High School students designed solar-powered, super energy-efficient model homes with one "test house" being built with removable walls and other features. At American River College, students designed

and built various solar-powered projects such as pumps for fountains, luminescent maps that can be read in darkness, a portable food cooler and water purifier. At Will Rogers Middle School, communication was the used to build a solar-powered broadcasting studio for English as a Second Language students.

SMUD works with the National Energy Education Development Project (NEED) on the grant program. A panel of SMUD renewable energy experts, a member of the California Energy Commission, and advisors from NEED review all the applications and award the grants.

SMUD has been a pioneer in energy efficiency and renewable energy for over 25 years. In the 1970s, SMUD started Peak Corps, a program designed to lower peak demand, along with an aggressive energy efficiency program. In the 1980s, SMUD built one of the world's first solar plants and in the 1990s popular established solar programs for residential and commercial customers. SMUD was one of the first utilities to establish renewable energy goals and plans to have 20 percent of its energy portfolio renewable by 2011. For more information about SMUD, visit www.smud. org.

likely to invest in China now.


