## **Proactive Steps Taken to Reduce** Cat and Dog Overpopulation

By Pam Runquist, Director AVAR SACRAMENTO - At a hearing on April 17th, the Board of Supervisors, by a vote of 4-1, gave initial approval to an Animal Overpopulation Ordinance that promotes spaying and neutering of cats and dogs and restricts out-ofcontrol breeding. The focus of the ordinance is higher licensing fees for unaltered cats and dogs (\$150) versus a much lower license fee for animals who are spayed or neutered (\$15). There is a reduced unaltered fee (\$45) for animals who are registered with breed groups and meet certain criteria.

The county's Department of Animal Care and Regulation will use these licensing fees and accompanying fines as a financial incentive to crack

down on problem breeding situations. Any citations issued under the ordinance will be "fix-it tickets" with fines and higher fees waived if animals are sterilized. Fines collected under the ordinance will help fund spay-neuter programs for low-income families. The Board of Supervisors is scheduled for a final vote on the ordinance on

'By indicating its approval for this measure, the Sacramento County Board of Supervisors has demonstrated its proactive position regarding the welfare of animals in our community and our collective commitment to reduce overpopulation and the euthanasia in our shelters," said Pat Claerbout, director of the Department of Animal Care and Regulation.

"We applaud the four supervisors who approved this ordinance and have taken a strong stand against outof-control breeding in the Sacramento region," said Pam Runquist, a representative of the Coalition to Stop Animal Overpopulation. "Now animal control has a tool to deal with problem breeding situations and a strong incentive to encourage people to spay or neuter their companion animals."

The lone "no" vote was Supervisor Roberta MacGlashan, who said she didn't think the ordinance would work despite testimony that similar ordinances have successfully reduced animal intake at shelters in other communities.

#### Democrats Have it Wrong in Iraq

When President Bush announced a surge of troops into Baghdad in January, Democrats pounded him for the folly of putting U.S. troops in the "middle of a civil war." Three months later, the question is, "What happens to a civil war if only one side shows up to fight it?"

The Shia militias that had become the main driver of violence in Baghdad are ducking and covering. Militia leader Moqtada al-Sadr is in hiding, perhaps in Iran. His fighters aren't resisting U.S. troops who have begun conducting patrols in his stronghold of Sadr City. According to Gen. David Petraeus, 700 members of Sadr's Mahdi Army have been detained in recent months.

This hardly means that peace and harmony reign in Baghdad, but it has reduced the killing significantly. If at the beginning of the year anyone had predicted such progress from the addition of just two U.S. combat brigades in Baghdad (six brigades eventually will be part of the surge), he would have been derided as a delusional optimist.

This progress might be transitory, but it illustrates the falsity of a key assumption of Democrats. They prefer to talk of Iraq in terms of a civil war because it suggests that nothing can be done about the violence, that it is running its own hermetic course. Well, it clearly isn't. What the U.S. does matters. If we hadn't surged, Baghdad already might have descended into the genocidal fury toward which it was headed earlier in the year.

The other side of the control Baghdad. Iraqi civil war -- the carbombing Sunni terrorists -- hasn't stood down, of course. But these are the people that Democrats express a notional interest in fighting. In a January letter to President Bush, House Speaker Nancy Pelosi said "counterterror" should be one of the "principal" missions of U.S. troops. Sen. Carl Levin wants to restrict U.S. troops to "an antiterrorist mission to go after al-Qaida in Iraq."

According to a U.S. intelligence report quoted Iraq -- weakening the force by The New York Times, captured materials from al-Qaida in Iraq say that the group sees "the sectarian war for Baghdad as the necessary main focus of its operations." So the Democrats profess to want to fight terrorists in Iraq, and al-Qaida in Iraq is making Baghdad its focus. It would stand to reason, then, that the Democrats wouldn't want National Review. Nonetheless, Democrats in the House and Senate are attempting to force our troops from Baghdad, exactly as al-Qaida in Iraq wants. In reporting on al-Qaida in Iraq's strategy, The New York Times notes, "American forces, instead of withdrawing from the capital as the Sunni insurgents had hoped, prepared plans to reinforce their troops there." ## How California Lost Its Sovereignty an Article V convention if the convention is called concentrated in the federal

The State of California is supposed to be sovereign under the Constitution of the United States. There is no higher government authority above California. The Constitution provides for parallel sovereignty for the federal and state governments, each with its own realm of authority. The federal government is not supposed to have a superior status. The 10th Amendment emphasizes that powers not specifically allocated to the federal government by the Constitution are held by the states or the people.

The Constitution endows the states with ultimate sovereignty because they can change the Constitution. Article of the Constitution states that "on the Application of the Legislatures of two thirds of the several States, [Congress] shall call a Convention for proposing Amendments" subject to ratification by three-fourths of the states.

The states have in fact submitted over 500 requests for such a convention to Congress, with the required two-thirds of the states asking for such conventions. The state applications for

Congressional Record. But Congress has violated the Constitution by ignoring these requests. In so doing, Congress has destroyed one of the checks on federal power that the founders had implemented.

The states have thus lost their sovereign ability to change the Constitution. This loss was in part the fault of the states themselves when they adopted the 17th Amendment to have a direct election of senators by the citizens rather than the original constitutional provision of having the state legislatures elect their senators. This situation could be reversed by the repeal of the amendment if two-thirds of the states call for it. But Congress refuses to comply.

Some people fear that a constitutional convention might propose amendments that will limit our liberty. However, any amendment would have to be ratified by three-fourths of the states. Few of the many past proposed amendments were ratified. The convention could also propose amendments that would enhance liberty, particularly

are registered in the by the state legislatures to limit the power of the federal government. Indeed, many of the state calls for a convention have sought to limit federal taxation. This may be the reason Congress refuses to comply.

Many legal scholars think that the federal government has abused its constitutional authority over interstate commerce by interpreting all economic activity as being subject to federal authority. The federal government has gone around the 10th Amendment with revenue sharing that has strings attached, conditions that in fact enable the federal government dictate policy to the states. Moreover, the Supreme Court has in effect amended the Constitution for the worse when it has interpreted the commerce and other clauses in favor of federal power.

Regardless of whether one fears or welcomes a constitutional convention, the Constitution authorizes it, and if we are to have a rule of law under the Constitution, Congress must follow the provisions of Article V. Liberty is better served with divided powers than with power government. Two lawsuits, Walker v.

United States and Walker v. Members of Congress, have been initiated in federal courts to make Congress obey Article V (see http:// www.article5.org/). refusal of Congress to comply with Article V has received little public attention. Those of use living in California should be aware that our individual sovereignty as citizens is also cut short when our state representatives have lost their constitutional authority. We no longer have a real Constitution and rule of law when Congress arrogantly asserts

## GI Bill Boost

The GI Bill gave World War II veterans a leg up: education benefits that allowed them to get a great start in life and bring a new wave of prosperity to the U.S. But that program was for peacetime. And too many veterans weren't told about all their benefits.

Here's one to keep an eye on: Jim Webb, a senator from Virginia, introduced the "Post-9/11 Veterans Educational Assistance Act of 2007" (S.22) in January. As of now it's sitting in the Committee on Veterans' Affairs.

The bill would alter the Montgomery GI Bill as follows: If you were on

active duty on or after Sept. 11, 2001, you could receive full coverage of tuition, room and board, and a stipend of \$1,000 a month, up from \$800.

You'd have 15 years to apply for those benefits (up from 10 years), and you wouldn't have to pay the enrollment fee of \$1,200 in your first year of service.

If you need a tutor, you could be eligible for \$100 a month for 12 months, to a maximum of \$1,200.

Then you would be eligible for up to \$2,000 for one licensing or certification test fee.

You'd need to complete secondary school (or get a GED) first, and the program would have to be approved (The VA Web

site has a list of approved programs.)

In some cases you can pursue your education while on active duty: Half-time, apprentice, correspondence school, flight training, tutoring help and licensing and certification tests.

Let's hope this isn't another case of a good bill being stuck in committee or watered down with a companion bill. It's worth keeping an eye on -- and deserves you making a phone call or two to prod those on the committee.

Thursday the SMUD Board of Directors will consider holding public workshops and community meetings to discuss the need for a general rate increase in 2008. SMUD General Manager Jan Schori is recommending an average 7 percent rate increase to take effect January 1. The revenues would:

• Cover rising power neighboring PG&E. costs.

Replace equipment aging and facilities to maintain reliable

electric service. Help meet SMUD board and state goals for solar power, efficiency energy increased and renewable energy.



Similar legislation has passed in 14 states including Maryland, Massachusetts Minnesota, Arizona, Florida and New Jersey. It is estimated that approximately 3,000 stillbirths occur in the state of California each year. Stillbirth affects roughly 1/100 pregnancies and takes the lives of more infants than all other causes of infant death combined.

"This is a bi-partisan bill," Sunita Param from the MISSing Angels and the mother of a stillborn daughter said. "It is neither pro-choice nor pro-life but rather it is pro-child, pro-family and most of all pro-women. This optional Certificate of Birth Resulting in Stillbirth will be a piece of tangible and healing evidence that my daughter was born."

## Victory in the Partial-Birth **Abortion Case at Supreme Court**

I am happy to report that we just got the decision from the Supreme Court of the United States in the partialbirth abortion cases. Our analysis prevailed, and the Court ruled 5-4 in our favor. In an opinion by Justice Kennedy, the Court upheld the ban on partial-birth abortion. Former Attorney General John Ashcroft, who was the Attorney General during the litigation, will be our guest on the radio broadcast today.

We had the privilege of representing members of the House and Senate who actually drafted the legislation. This is a significant victory! One of the main thrusts of the arguments we made in the trial courts, in the courts of appeals, and ultimately, to the Supreme Court, was that the government has a compelling interest in protecting the life of the unborn. Justice Kennedy, in his opinion, specifically

The Court recognized that "Congress determined that such abortions [partialbirth abortions] are similar to the killing of a newborn infant." Justice Kennedy also wrote: "The Act's stated purposes are protecting

## **Regional Transit Service Lacking**

What impact does the Regional Transit system have on business, you ask? A lot! Fair Oaks and Orangevale have not received their fair share of this public service. The Fair Oaks Chamber of Commerce Legislative Committee sees the relevance and is acting to help alleviate the problem. A

meeting was set up with County Supervisor MacGlashan and her Chief of Staff Ted Wolter, Regional Transit Deputy General Manager Michael Wiley, Regional Transit Director of Planning Taiwo Jaiyeoba, and Ralph Carhart and Don Troutman. Carhart and Troutman wanted to bring the problem to the attention of the people who can initiate a change. Although there will not be immediate changes, Fair Oaks and Orangevale are on the Board. Their reception to hearing the problem, and the long discussion that followed has brought this issue to the forefront. Congratulations especially go to Ralph Carhart, who has used public transportation for 25-plus years and lived the problem noted above. Ralph has spent even more years working for Cal Trans and interacting with Regional Transit. His suggestions were sensible and solid, which contributed greatly to the discussion.

Ralph Carhart and Don Troutman have committed to carry this through. It is their goal to improve transportation, which will benefit businesses and the community on the whole.



#### I was in a car accident, what now?

Schools also will receive curriculum packets, prepared by the California Department of Education, to facilitate successful program implementation in the classroom and in the garden.

OSH selected Golden Valley Charter based on the strength of its school garden curriculum, its school-wide

commitment to develop and use the garden, its plan to sustain the garden as a valuable educational tool and the broad involvement of students and staff in the program. These selection criteria were established by OSH in partnership with the California Department of Education.

Promoted by the California Departments of Education and Food & Agriculture as a valuable learning tool, school gardens can be used to teach children lessons in life sciences, reading, history, math and spatial skills. They can also help foster good health as children learn the links between plants, gardening, food and health.

"When we reviewed grant applications," we put a strong emphasis on identifying schools with a plan to create a rich curriculum around the garden- both during its initial development, and in the years to come," said OSH President and CEO Rob Lynch. "Every school we selected for the program demonstrated a commitment to establish a successful and sustainable school garden."

#### **Contract Bridge**

YOU CAN WIN, BUT YOU CAN'T LOSE



The bidding: North West East South

Opening lead ace of hearts. In bridge, the participants see only 26 cards when the play starts and not the 52 cards seen in the diagram. Naturally, seeing only 26 cards, they

might not play their cards as perfectly as if they saw all four hands. Being human, they might err. The declarer, and the defenders likewise, frequently trade upon this deficiency. They sometimes make plays they would not make if all 52 cards were in plain view, and they do this

because they might induce a mistake

Consider this deal where South stole the contract by making an unnatural play. West led the ace and another trump. Declarer, after sizing up his chances, won the second trump in dummy, cashed the ace of spades and returned a low spade toward his hand.

East assumed from this line of play that declarer had a singleton spade and therefore played low instead of going up with the king. South won with the jack and eventually established dummy's fifth spade as a trick to finish with 11 tricks in all.

Now let's suppose declarer had won the heart in his hand at trick two and led the jack of spades for a finesse, as East would have taken the king and returned a club to put South down

The beauty of South's play is that it gives him a chance to make the contract regardless of where the king of spades is located. If West has it, the hand is sure to make because dummy's queen becomes established for a vital club discard

If East has the king, then it is just as well not to attempt the losing finesse. In fact, it is much better to cash the ace and lead toward the jack because East has a chance to go wrong.

It is true that South might cost himself 30 points if it turns out that West has the king of spades, but who wouldn't pay a 30-point premium to ensure a game?



In this con, someone calls pretending to be a court official who threateningly says a warrant has been issued for your arrest because you didn't show up for jury duty.

The caller claims to be a jury coordinator. If you protest that you never received a summons for jury duty, the scammer asks you for your name, Social Security number, and date of birth so he or she can verify the information and cancel the arrest warrant. Give out any of this information

and bingo! Your identity just got stolen.

The scam has been reported so far in 12 states, including Missouri, Michigan, Ohio, Texas, Arizona, Illinois, New York, Pennsylvania, Minnesota, Oregon Washington State.
