LDS Church Opens Feather River Temple for Tours

YUBA CITY, CA (MPG) - Area members of the Church of Jesus Christ of Latter-day Saints (LDS) have been patiently awaiting the completion of one of their faith's most sacred buildings since plans for it were announced by Church President Russell M. Nelson in 2018.

On Tuesday, August 15th, members of the media, local and state dignitaries were invited to join

Church Officials and volunteers for an open house and exclusive first tours of the Feather River Temple.

The Feather River Temple sits on a 9-acre site originally sold to the church by Mehar Tumber, a devout Sikh man. Years prior, the church had difficulties in finding suitable grounds to build a Stake Center chapel and although Tumber's peach acreage was not up for sale, he agreed to allow the sale. His daughter Raji told the Church her father

felt it was "a blessing to have a religious organization...as an anchor to our property."

Those grounds are now gorgeously landscaped with local flora and fauna, preserved oaks, and transplanted trees, including 100-year-old olive trees brought in from Corning and planted at the four corners surrounding the 38,000 sq. ft. holy LDS temple.

GRIDLEY, CA (MPG) - Pastor David Henry serves as pastor of the First Baptist Church of Gridley, serving international missions along the way. In turn, he is sharing the experience of mission service with his 13-year-old son, Lucas. Together, they spent a week in Chone, Ecuador, strengthening the discipleship of Christian believers and sharing the gospel of Jesus Christ with others.

Pastor Henry has experienced several short-term missionary trips, most of them to developing nations. In 2018, Greg Ernsburger, a college friend and career missionary, asked him to travel to Sigchos, Ecuador and serve a church founded there. Sigchos sits at 9300 feet in elevation in the mountainous region of Ecuador.

What Henry saw in

Gridley Country Ford is a car dealership once again. Starting somewhere in 2018, when Covid impacted the supply chain, it was odd to see a car dealership on the freeway with no cars to sell or just one or two cars that were out front, with most of the other vehicles being used cars of other brands. So it's one more step toward feeling as if life is back to normal (other than hurricanes and earthquakes) when there are cool cars that you can stare at while you're stopped at the intersection, wishing that you could have one of them instead of the car you're sitting in. The best salesman at Gridley Country Ford has always been Highway 99 and the stoplight on Spruce Street.

The Church of Jesus Christ of Latter-day Saints have opened up the new 44,000-square-foot

Temple for everyone to go through it in Yuba City. The temple, which is called the Feather River Temple (if you call it Yuba City Temple, the people from Marysville and Woodland might not come, so they named it after a random geographic feature), will host tens of thousands of people in the coming weeks. The tours are open to anyone between nine and nine every day but Sunday and will go until September 9. I went in and had the opportunity to meet some of the craftsmen who installed the stained glass, which is a scarce skill set nowadays. We don't have as many stained glass jobs because there are fewer and fewer churches being built. There is also world-class (literally best in the world) stonemasonry, carpentry, and electrical work. Almost all of those require union labor as its union apprenticeship programs have had to take the place of job training in the last 30 years as the public school system walked away from vocational education in favor of preparing everybody to go to college. Former State Building and Construction Trades Council President Andrew Meredith and his Northstate agent Mark

Mulliner ensured that skilled workers were available to meet the project's needs. So no matter your religious variation, the building is truly a masterpiece.

Trust in Government survey is out again. Switzerland is the winner, with 83% of the people responding that they have "trust" in their government. Mexico came in at 52%, Turkey at 42%, Brazil at 39%, Spain at 37%, Ireland at 62%, and the United States rolled in at 31%. This is a trend that needs to be adjusted. It is not good to have our major institutions of social stability being doubted by more than 50% of the people. America is such a better place than what it is getting credit for. We should always be vigilant about government overreach. Still, I think the people who doubt our government to that extent need to travel overseas more often and consider how many people who say they trust their government - are lined up trying to get into the U.S. Odd phenomenon.

GRIDLEY, CA (MPG) - A few Wild Things visited Gridley recently, and no, not Gabe Kerschner and his assistant Piper from the non-profit organization of the same name.

The Wild Things wildlife program is based out of Colfax and acts as conservation ambassadors for wildlife that are either in need of rescue or have been confiscated due to being illegal to own as pets. The group is home to 60 displaced species, and in the spirit of education, Wild Things visits local schools, libraries and more to share their knowledge and animal friends with the youth.

This year, Kerschner, director of the program, brought a few animals from the preserve to introduce to a large number of youth that turned out for the Friends of the Library event. For each furry, feathered, or scaled animal, the Wild Things director shared information on their habitats, lifestyle, quirky little tidbits about each animal and how they came to be a part of the Wild Things family.

First up was an adorable 31-year-old brown lemur named Samantha. Kerschner demonstrated how Samantha would greet her family in the wild, the lemur kissing and cleaning his nose. For grapes, Samantha demonstrated her amazing jumping ability and generated laughs from the crowd as she pulled Kerschner back towards him via her leash for more treats.

Next a volunteer was chosen from the crowd to help introduce Boo, a fully grown, yet small, western screech owl. Kids got a kick out of Boo's fixed eyes that made it appear that his head swiveled in nearly a 360 degree turn and his waving goodbye with one wing. As the program continued,

Kerschner introduced Clover, a two-and-a-half-year-old red Kangaroo that had been with Wild Things since birth, Harley, a baby skunk whose mother had been hit by a car, Dewie Hopper an African pixie frog, and Noah the red-tailed Boa.

The interactive and educational program delighted those in attendance, including adults.

The program was such a hit last year at the Gridley Branch of the Butte County Library that it was moved to Expo Hall at the Butte County Fairgrounds so that more of the public could participate. Wild Things returned to Gridley thanks to Chico Children's Endowment Funds that sponsored the full cost of interactive and educational program. ★

said that before its construction, teams performed a precedent study to understand the area and get a feel for it, which then translated into the temple's overall design, including its landscaping, architecture, and décor aesthetic.

At the entrance to the temple, guests are met with the inscriptions, "Holiness to the Lord" and "House of the Lord," carved in stone and written in gold above the great doors to the building. Elder Mark Bragg, president of the North American West Area for the LDS Church said that the words were "both a declaration as to what it (temple) is but also a reminder that all things within the house of the Lord point us to him."

During the press conference, Elder Bragg said that the church likes to think of its temples as "an intersection between life here and eternity." He continued, "I've heard it described sometimes as the knot that ties Heaven and Earth together. That's what we hope you will feel."

Upon entering the building, one observes a quiet calm and peace about the space. An image of Jesus Christ welcomes those into the reception area which is beautifully adorned with colorful custom artwork and textiles, representing native plants and landscapes, such as the California poppy and golden rolling hills adorned with oaks. The colors orange, gold, blue, and white permeate the décor, both on the lower and upper floors. Intricate stained-glass windows throughout the temple reflect almond blossoms seen in our area during spring, and rich gold leaf and mahogany add warmth to the serene interiors.

Guests are ushered through the lower floors that serve as office spaces for the temple presidency and their wives, other functional spaces such as laundry areas, and the main feature, the baptistry.

A large baptismal font rests on the back of 12 life-sized oxen, representing the 12 Tribes of Israel. The upper floor of the temple features instruction rooms, the elegant Celestial Room, and Sealing Room where sacred ceremonies are conducted, including marriages. A moment is provided in the Celestial Room for guests to sit and contemplate surrounded by light, glistening chandeliers, and large mirrors that reflect each other, giving the impression of visitors images continuing into eternity.


The building is indeed exquisite and a testament to the belief that it is truly the house of God on earth. Senator and church member Rosilicie Ochoa Bogh said that "the temple is a physical representation of our faith, but it is here as a testament to the strength of our commitment to the teachings of Jesus Christ." After taking a tour, Chairman of the Sutter County Board of Supervisors, Karm Bains said it "is a world class structure that will welcome thousands of visitors to our community."

The temple will predominantly serve members from the Yuba-Sutter area, Gridley, Biggs, Chico, Oroville, Redding, Ukiah and Placer County. It is one of 12 temples in California, the first to be constructed since the Sacramento Temple opened in 2006.

During all the excitement of the Feather River Temple's grand opening, committees and crews of hundreds of local volunteers worked to promote and welcome the public to share the temple experience – and not just members of the LDS church.

Area Manager of Communications for the LDS Church Kim Farah described the work of the volunteers and members of the public who made the open house possible. "This community overall, is extraordinary. This community loves each other. The interfaith and nonprofit groups work together," she said, to make events like the temple grand opening and tours possible.

Exclusive tours were held until the temple opened to the general public on Saturday, August 19th. The open house tours will continue until Saturday, September 9th, 2023, with the exception of Sundays, August 20th, 27th, and September 3rd. Tours run from 9:00 a.m. to 9:00 p.m. The temple will be formally dedicated Sunday, October 8th, wherein it will only be accessible to members of the church.

Delayed Planting For Processing Tomatoes Leads To Harvest Backlog

As California growers harvest this season's processing tomato crop, there is concern that canneries could struggle to keep up with a backlog of fruit deliveries. Heavy rains left tomato fields wet and muddy through spring, disrupting planting of processing tomato transplants, which continued through May. With much of the crop now being harvested at once, growers are worried about risks to fruit that can't be processed right away. Bruce Rominger of the California Tomato Growers Association said some growers may be encouraged to harvest early when tomatoes are a little green.

Klamath Farmers Hope To Finish Harvest Before Water Supplies Run Out

Farmers relying on water supplies from the federal Klamath Water Project say they are trying to finish harvest before their water supply is cut off in the coming weeks. Scott Seus of Tulelake-based Seus Farms, which grows horseradish, onions, mint and grain, said the growers face water shortages again this season, despite a plentiful water year. That's because the Klamath Water Users Association had expected a water delivery of 285,000 acre-feet this year. Instead, irrigators got an initial allocation of 215,000. Still, that is vastly improved over last year's 50,000 acre-feet supply

Napa Valley winegrape grower testifies before House panel on wildfire dangers

As the 2017 Tubbs Fire was bearing down on his vineyards, sixth-generation Napa Valley winegrape grower Johnnie White battled the blaze with the St. Helena Fire Department. White testified last week before the House Committee on Natural Resources about the consequences of the fires on rural communities, urging proactive steps including increasing removal of wildfire fuels. He told lawmakers that "our industry continues to witness damage and destruction to our livestock, commodities, farms, ranches, wineries, farm homes, employee housing and equipment."

Almond Board announces new members after elections

The Almond Board of California has announced the election of five voting members for the panel that directs global market development for the almond sector. New member Kelli Evans is a co-op grower from Evans Farming in Live Oak. Members re-elected were: Paul Ewing, an independent grower from Los Banos, Alexi Rodriguez, an independent handler with Campos Brothers in Caruthers, Alicia Rockwell, a co-op handler with Blue Diamond Growers in Sacramento, and Darren Rigg, an independent handler from Minturn Nut Co. Inc. in Le Grand. ★


The plants are working hard to reserve water. Leaves are curling, some are withering for the good of others. Herbaceous plants have little openings called stomas or stomata. These are microscopic openings or pores in the underside "skin" of leaves.

The stomas are like little sets of itty-bity lips that open and close. The stomas have two

rounded sausage-like parts that open and close the tiny opening. A stoma opens and closes in response to the internal pressure created in the little "lips." Also called "guard cells." The inner wall of a guard cell is thicker than the outer wall. When the guard cell fills with water it becomes full. The outer wall balloons outward, drawing the inner wall with it and causing the stoma to enlarge. The guard cells work to control excessive water loss. On a hot, dry, or windy day they close. Then open when conditions are more favorable. Most plants, the dawn triggers stomatal opening. This reaches a maximum near noon, which is followed by a decline because of water loss. Sometimes you can see moisture dripping

on leaves, sometimes it is in gas form. A fancy word for this process is evapotranspiration. This process stops as darkness approaches. Some plants such as Bromeliads and Crassulaceae (Jade Plants) have an alternative form of photosynthesis, their stomata open at night to reduce water loss.

When the heat is over 100, this stresses most plants and their little lippy cooling system. When this system is attacked by excessive heat the leaves crinkle and dry up. All of this behavior is a part of photosynthesis. All this gas exchange can be tiring when it is 100 and plants really like it to be no more than 85. This is one reason it is easier on plants to water them early in the morning. ★

of other people there think you do.

But there's really nothing magical about 25%. The purpose behind it is, I don't want you to be house poor. If you find yourself still able to save and invest because you keep other financial aspects of your lifestyle so low, then you're okay. The problem with most people starts when they've got a high cost of housing, and those payments put a real squeeze on their budgets. It doesn't leave them enough room to save up to buy the next car, so that car becomes debt. The same thing happens with Christmas and vacations and everything else. They don't have enough extra money to save for things because a huge chunk of their income is flying out the door every month wrapped up in rent or a house payment.

Now, you're telling me your situation works for you because you've made room in your budget and live a very frugal lifestyle by choice. That's cool. I'm not mad at you about that. But here's the thing: Whatever you spend on rent disappears. And the more money you burn, the less you've got on hand for other things.

I'm not exactly sure how you adjust that in your situation. Maybe you move outside the city and commute, or perhaps you add a roommate into the equation. Or, maybe you're fine with how things are and that's the way you want to live. That's okay too. But my reasoning behind the 25% figure—which is actually more of a guideline than a rule—is so you don't become house poor. I want you to be able to save, invest and give generously. Plus, I want you to own your own home one day.

And you won't be able to do that if everything you make is going toward big payments!

Dear Dave,

Is there any flexibility in your rule about not spending more than 25% of your take-home pay on rent or monthly mortgage payments? I live downtown in Washington, D.C., and I'm finding it's pretty hard to do here. I make about \$90,000 a year, but I'm spending a little over \$2,000 a month in rent. Rent is my largest expense by far, and I don't spend a lot of other money, so I'm still able to save a little and do other things. Can you give me your opinion about this approach?

Dear Tanner,

True, I advise people to spend no more than 25% of their take-home pay on housing. Math still works in every city and state in the country. You don't get a pass on math just because you live in Washington, D.C., even though Congress and a lot

Oakland Man Found Dead in U-Haul Truck Killed in Butte County

BUTTE COUNTY, CA (MPG) - On August 4, 2023, an individual contacted the San Francisco Police Department and indicated he had a deceased person inside a U-Haul. San Francisco Police Department personnel located a deceased male inside the U-Haul. The deceased male was later identified as Alexander Licona-Romero, age 21, of Oakland. San Francisco Police Department personnel located evidence indicating the death occurred in the Berry Creek area of Butte County. The San Francisco Police Department contacted the Butte County Sheriff's Office (BCSO).

During an investigation, BCSO located evidence that Licona-Romero and at least two other individuals traveled from the Bay Area to Berry Creek. Upon arrival in Berry Creek, the individuals committed an armed robbery at an illegal marijuana grow. During the armed robbery, Licona-Romero was shot. After Licona-Romero was shot, at least two individuals transported Licona-Romero to the Bay Area. One of the individuals later reported the incident to the San Francisco Police Department.

- Do not run into the street; always look both ways before crossing..

Tuesday afternoon, a Butte County Judge issued a warrant for the arrest of the subject, Russell Ellison, age 40.

The officers returned to Riverbend Park with the warrant found Mr. Ellison, and placed him under arrest. He was transferred to the Butte County Jail and charged with three crimes:

Penal Code 451(c), arson to wildland (felony)

Penal Code 422 (a), making criminal threats (felony)

Health and Safety Code 11364 (a), possession of narcotics paraphernalia (misdemeanor)

Ellison's bail was set at \$125,000. ★

missionaries to organize a church in Chone, in the Ecuadorian lowlands, nearer the coast. Henry described Inez as a "person of peace," like Lydia in the New Testament (Acts 16:13-15).

The Chone church now serves over 200 congregants. During his recent mission trip, Henry preached to the members. Henry focuses on two things. First is, "The relationship that you really can have with God. That's a real thing." Secondly, "You need to honor the Lord in a church that believes what the Bible says." Henry describes Southern Baptists as "people of the book."

Henry and Lucas also taught in the barrios of Chone, sitting in chairs under street lights and in community centers. They taught members how to share their faith and also made pastoral visits to their homes. Henry started street discussions by asking, "Are you a good person?" He then taught about how Jesus Christ saves them from sin.

The people of Chone are very poor, because there is little work. Those who work are taxi drivers or work in shops and restaurants. Henry said they are looking for hope and are open to the gospel,

like Jesus, who "Came to the least of these, the widow, the orphan, the prisoner, the sick. They were listening to him."

The Henrys have nine children, and all of them have accompanied Pastor Henry or Keisha Henry, his wife, on missions. Lucas served by telling his own faith story, sharing Bible stories, and participating with young people in activities such as soccer and crafts. Traveling down to Chone, a nearly two-day trip, involves flights to Los Angeles, then Miami, then Quito, with a four-hour bus ride to Chone.

The Henrys fund their own mission trip

expenses, with the help of generous members of the First Baptist Church in Gridley. The Church belongs to the Southern Baptist Convention, a national organization of churches heavily focused on international missionary work.

In this work, Henry shares the message of the Garden of Eden, and the choice of Adam and Eve that brought sin into the world, Henry said, "God made this perfect world, and it all went haywire. He didn't blow it up and start over again, he sent himself, Jesus, into the world, to give us grace. The blood of Jesus pays for all of our sin." ★

Detectives on the Trail of Crossbow Shooter

Sutter County Sheriff's Dept. News Release

SUTTER COUNTY, CA (MPG) - On May 24, 2023, at approximately 12:24 pm, the Sutter County Sheriff's Office was dispatched to the area of Lincoln Road and Clements Road in Yuba City, reference a calf being shot by a crossbow bolt. An additional calf was located at the scene which was fatally shot by a crossbow bolt. Both crossbow bolts were recovered for evidence.

On July 25, 2023, at approximately 1:30 pm, the Sutter County Sheriff's Office received a call regarding a deceased mare (female horse) that was located on a property on South Butte

Road in Sutter. Deputies and Animal Control responded to the scene and contacted the property owner. During the investigation, it was discovered the mare had been shot in the head by what we believe to have been a crossbow, immediately killing the mare. No crossbow bolt was located as we believe the suspect(s) had removed the crossbow bolt prior to fleeing the scene.

If anyone has information regarding these cases, the Sutter County Sheriff's Office urges them to call Detective Evans at (530) 822-2210. Your assistance can play a crucial role in helping to apprehend those responsible and preventing future incidents. ★







Notorious Hate Crime Revisited

COLUSA, CA (MPG) - A convicted killer was sentenced last week to 120 days in Colusa County jail for violating the terms of his parole - again.

Prior to his release from prison, Marvin Dean Noor, 61, of Colusa, spent decades in maximum security for one of the most notorious racially motivated murders in Northern California.

"Marvin Dean Noor was released on parole on April 17, 2018, after having served 38 years on a first-degree murder conviction for the intentional and senseless killing of Jimmy Lee Campbell," said Special Prosecutor Matthew Beauchamp, of the Colusa County District Attorney's Office. "Campbell, a young black man, was shot in the back simply for being African American."

Noor, who reportedly led a criminal life since he was 13, along with long-time friend James Thomas McCarter, and Noor's girlfriend Dani Shope, were convicted of killing Campbell on the evening of Jan. 14, 1979, as he walked along Park Avenue in Chico after leaving the roller rink.

Campbell, who was deaf, would not have heard Noor's car pull slowly up behind him as McCarter leveled a 30-30 rifle at his back and pulled the trigger; nor would Campbell hear the gunshot as the bullet tore through his left shoulder, broke a rib, and traveled into his heart, slicing his aorta.

Noor would later confess to police that he saw Campbell jerk, clutch his shoulder, and stumble a few steps, but that he sped the car away before Campbell fell, hitting his forehead on the railroad tracks and sprawling face up in death, as he would be discovered a short time later by a passing motorist.

According to news reports, the case would likely have gone unsolved but for the drunken and exuberant boasting of two of the culprits, who, using racial slurs, bragged about killing black people in Chico and Oroville.

Noor, who was 19 at the time, Shope, 24,

and McCarter, 20, all of Oroville, had reportedly spent the day drinking and smoking pot, after getting the rifle from Noor's mother's home in Oroville to poach deer in the hills.

They had spent the afternoon shopping in Marysville and, by the time they decided to go hunting, it was late in the evening. Failing to shoot a deer, they looked for a cow to shoot, but failed to spot any in the darkness and steady rain.

It was Noor's suggestion, at the urging of Shope to kill something, to hunt black people.


Later reports would say that Noor had a deep hatred for blacks from the many run-ins he had while locked up in the California Youth Authority as a juvenile. Noor, who had just been released from Preston a few months earlier, had a history of violence and was on probation for assault with a deadly weapon.

McCarter reportedly had black friends and had never been arrested but had been expelled from high school twice for offenses committed with Noor, who had the dominant personality.

Both McCarter and Noor would drop out of high school before graduating, leading lives they admitted revolved around drugs and alcohol. Shope had left her husband and children to live a carefree and wild lifestyle, reports said. Already on his second bottle of rum after McCarter shot Campbell, Noor narrowly avoided a head-on collision on the road back to Oroville and crashed his Pontiac through a fence and into a field.

After passersby helped push the car out of the mud and back onto the road, the trio traveled into South Oroville, which had a large African American population. They soon spotted three young black men at a park.

This time, it was Noor's turn to shoot, but he fumbled with the trigger. The men, who watched the Pontiac slowly approach and saw the long barrel of the gun pointed at them through the window, dropped to the ground. Frustrated that he

couldn't fire, Noor sped off.

After midnight, three blocks from the park, Noor pulled slowly upon Michelle Knight, who was walking on Roseben Avenue with her purse in one hand and holding an umbrella with the other.

Noor called out to her, and she looked up. He fired. Knight screamed and crumpled to the ground as Noor sped away. Noor's bullet missed but had reportedly passed so close to Knight's cheek it left powder burns.

After dropping McCarter off a few blocks away, Noor and Shope drove around, shot out a few streetlights and at power poles, until deciding to go to Noor's brother David's home to tell him what they had done.

Noor's brother was asleep, but his girlfriend let them in and heard the confession and the drunken couple's exhilaration at what had transpired that night.

According to reports, Shope eagerly indicated that it would be "her turn next" to shoot.

The following morning, Noor and Shope returned the gun to his mother's home and went on about their day.

Within 24 hours of Campbell's murder, Noor, McCarter, and Shope had been arrested and were being integrated by police. David Noor's girlfriend, Linda Hammersley, had

Gridley District Court Judge Steven McNelis, who authorized the search warrants for Marvin Noor's house, where he and Shope were arrested, and Noor's mother's home, where the gun was found, had also joined the police as an observer when the warrants were executed.

McCarter was arrested at his home late that same night without an arrest warrant, only after Noor and Shope implicated him for Campbell's murder during questioning.

Under a gag order, the case progressed secretly through the courts, until one year after Campbell's death, when Noor and McCarter pleaded guilty to first degree murder in a deal that dropped the special circumstance charge and the attempted murder of Knight.

The plea deal came with a 25-year-to-life sentence, if Noor and McCarter forfeited appeals, and an opportunity for parole. Shope had already pleaded guilty to second degree murder in exchange for testimony against the others and had been sentenced to only 15 years in prison.

The arrangement outraged Campbell's family, who only learned about it from news reports after Noor and McCarter entered their pleas. With the gag order lifted, the ghastly details of the murder spread quickly in news outlets across the country. The deal for all three killers angered the NAACP, which questioned a dual system of justice. Would the deal have been reached if the races of the victim and perpetrators were reversed?

California Attorney General George Deukmejian also questioned the DA dropping the special circumstance charge and was asked by Assembly Speaker Leo McCarthy to investigate.

A year later, McCarter did appeal his conviction, hoping to get the hearsay and search warrant evidence thrown out, but the court upheld their validity and the manner of the searches, and affirmed there was sufficient probable cause for his arrest, based on creditable informants.

"Officers knew a racially motivated murder had occurred in Chico the night before and that another murder could have occurred in Oroville," court records state. "Because of Shope's statement indicating 'her turn' was next, officers could reasonably have believed that the senseless shooting would continue."

Eventually, the murder and attempted murder of black people in Butte County would slip from peoples' memory, and all three involved in the crime would eventually be released.

Noor, who violated his parole and served a short stint in Sutter County Jail, in 2022, was arrested again by CDCR parole officers on July 14, at his residence in Colusa, for using and possessing alcohol, which is prohibited by terms of his prison release.

His parole officer, Agent M. Taylor, said the state frequently checks on Noor, but he would not say why he is living in Colusa rather than his home county, where the crime occurred, and where there are better resources to help parolees successfully reenter society.

Noor's release from prison and his presence in Colusa bothers Beauchamp.

"The State of California's decision to release Noor is hard to reconcile with the depravity and cruelty of the underlying crime," Beauchamp said. "Since being released from prison, Noor has violated his parole multiple times, including weapons violations."

Beauchamp said the killer's release is just another example of California's failed public safety policies and agreed with Noor's parole officer that Noor's past criminal history and behavior while on parole places the community at risk.

"Colusa should not be a dumping ground," Beauchamp said. "Noor, who is not from Colusa County, has no business being on parole in the city of Colusa."

Oroville Man Sentenced to 15 years to Life in Prison for Molesting Daughter

BUTTE COUNTY, CA (MPG) - August 16, 2023 an Oroville man was sentenced to 15 years to life in prison for molesting his adopted daughter from the ages of nine to twelve years old.

The life sentence for Ralph Bogue, 60, was handed down August 16, by Superior Court Judge Jesus Rodriguez after Bogue admitted to years of abuse suffered by his adopted daughter while she was living with him and his wife. Bogue's wife is the victim's biological aunt, who adopted the victim several years ago. The victim lived in the home with Bogue, his wife, and their biological children, at a home in Oroville.

Butte County District Attorney Mike Ramsey said the case against Bogue began when the then 12-year-old victim disclosed to a family member in late 2022 about the ongoing sexual abuse. Investigators from the District Attorney's Office interviewed the victim, who disclosed the abuse at the hands of Bogue. The victim stated the abuse eventually progressed to explicit sexual abuse over the course of several years. The victim described Bogue forcefully dragging her to his room and throwing her down during the assaults. The victim also described Bogue waking her up in the middle of the night by dumping ice-cold water

on her, so that he could sexually abuse her under cover of darkness.

The victim stated that she had previously disclosed the abuse to other family members but was not believed and the abuse continued. After the investigation began in late 2022, Bogue was confronted by another family member about the abuse and admitted to inappropriately touching the victim. He was arrested and charged in February of 2023 and remained in custody at the Butte County Jail through sentencing.

At the sentencing hearing on August 16, the prosecutor handling the case read a statement from the now 13-year-old petite victim, who described the damage that 6-foot, 345-pound Bogue caused, and will continue to cause in her life. The victim stated he ruined her life, and her relationships with her family, but that she was glad he could no longer hurt her. The prosecutor noted that Bogue took advantage of a troubled young woman, who looked up to him as a father and violated her trust for his own perverse pleasure. The prosecutor commended the victim for being brave enough to come forward, despite previously having not been believed by her family, and for having the strength to follow through with the case to ensure there will be no future victims. ★

16-Year-old Oroville Minor Admits Involuntary Manslaughter

BUTTE COUNTY, CA (MPG) - The 16-year-old Oroville youth who accidentally shot and killed his 13-year-old friend while both were in a stolen car was in juvenile court on August 9, 2023, and admitted guilt to a charge of involuntary manslaughter with the personal use of a firearm.

Butte County District Attorney Mike Ramsey said the teenager and three other boys, ages 13, 14, and 16, were joyriding in a stolen car with a handgun during the early morning hours of July 18, 2023. All had been playing with the firearm and, during the course of the evening, one of them had loaded the gun with ammunition. The handgun was being handled by the shooter in the back-passenger seat of the stolen vehicle when the weapon discharged. The 13-year-old victim, Amadeus Miller-Ramos, who was in the front passenger seat, was struck once in the back by a bullet. Ramos died as a result of the gunshot wound. The shooter claimed he did not know the weapon was loaded at the time it discharged.

After the shooting, the victim's body was placed in a field in Thermalito

near the intersection of 18th Street and Tehama Avenue where he was eventually found. The teenagers in the vehicle all gave differing stories as to who participated in the disposal of the victim's body. The Butte County Sheriff's Office is continuing to investigate the other surviving boys concerning their culpability for other crimes committed in the early morning hours just before the 13-year-old's death.

Ramsey noted the 9 mm semi-automatic pistol believed used in this tragedy was stolen from a separate vehicle in the Oroville area the night before the shooting. The gun was later turned into the sheriff's office through a confidential source after the shooting.

Ramsey said, "This case is a sad reminder to us all that firearms are dangerous and should always be handled with care. Gun owners should make sure their weapons are stored safely to ensure that minors do not have easy access to them."

The teenage shooter will next appear at the Butte County Juvenile Court on September 13, 2023, at 8:30 a.m. for sentencing. He continues to remain in custody at Butte County Juvenile Hall pending this next hearing. ★
