GRIDLEY, CA (MPG) - The Ms. Agriculture America Pageant was born from the marriage of over 125 years of farming and 30 years of pageantry experience, but the program is relatively new to the Gridley area.

Eight months ago, Isabella Bastiani was crowned Miss Agriculture America Butte County Teen Queen, but on May 28th, 2023, the 15-year-old relinquished her Butte County title to compete at a higher level.

## Gridley Council Considers Live Oak Policing Request

GRIDLEY, CA (MPG) - In the June 5 Gridley City Council meeting, Gridley Police Chief Rodney Harr discussed a request from the City of Live Oak to provide policing services. Live Oak historically had its own police department but began contracting with the Sutter County Sheriff's Office decades ago. Live Oak requested Gridley assign seven officers, a lieutenant, and a sergeant to police Live Oak, offering to pay salaries and benefits.

Harr said that Live Oak makes the request every five years or so. When Councilmember Angel Calderon asked why they continue to request services, Harr answered, "In the past ... to check to see if they're being charged appropriately by the sheriff's office."

Several challenges to policing Live Oak were discussed: the different radio systems used by the two cities, the need for additional equipment such as a repeater, the current difficulty with hiring additional officers, the need to process arrests in Sutter County, the obligation to attend court in Sutter County, the need for additional records staff, and the possible conflict of an officer summoned to appear simultaneously in two county courthouses.

Councilmember Jim Roberts said, "Back in the mid to late 90s, this came really close to actually happening. ... It was just a logistical nightmare dealing with two different counties and different dispatch systems, and it died at the council."

Harr discussed the \$1.7 million contract Live Oak currently has with the Sutter County Sheriff's Office, calling it a "smokin' deal," and added that it isn't economically feasible for the City of Gridley to essentially create a second police department to patrol Live Oak.

Mayor Mike Farr said, "I think Gridley PD should be patrolling and policing Gridley, not Live Oak or anybody else. ... I strongly said no."

Developers used the community forum period to remind the council of their concerns in working with the City Planner and City Engineer.

Justin Kern, GUSD Superintendent, added to the comments by reporting they are in the process of certifying the district property on Randolph Avenue, "to build a

## Gas Leak Forces Evacuations

GRIDLEY, CA (MPG) - Evacuation orders went out on the morning of Friday, June 16th due to a large gas leak that occurred along the Hwy 99 corridor.

Reports say that a backhoe accidentally struck a PG&E gas line roughly around 10:00 am at 1460 Hwy 99, just south of the Dollar General store and north of Archer Avenue in Gridley.

CALFIRE responded to the scene, along with PG&E crews, Butte County Sheriff's Office and Gridley Police Department. It is believed that PG&E crews were already on-site at the time of the incident.

CALFIRE/Butte County/Battalion 7 Chief Mike Conaty said that upon their arrival, a very loud whistling was issuing from the struck pipe, inferring a

high-pressure leak. Due to the potential danger it imposed on neighboring residents and businesses, an evacuation order was issued to homes on Archer Avenue down to Bonnell

Avenue. The AmeriGas facility, located on the south corner of Archer and Hwy 99 immediately shut down operations and was of concern to responders. Conaty also requested

a shutdown of Hwy 99 until the gas leak had been contained.

When Herald reporters arrived, the smell of gas in the area was heavy despite

# The New Pi-Line CAL FIRE to Suspend Burn Permits

The recent spate of people being hit by the train has brought to light the issue of Railroad legal jurisdiction. Gridley Police Chief Rodney Harr has to work with the Railroad Police to have enforcement jurisdiction on the tracks. A majority of railroad operations are regulated at the federal level, which can sometimes limit the authority of local and state governments. In American history, as the trains started going west,

they wanted speed in their development, so having one set of rules made sense at the time, as the railroad wanted to avoid dealing with new rules at every state line. The Interstate Commerce Clause of the United States Constitution grants Congress the power to regulate interstate commerce. Railroads are considered a part of interstate commerce because they transport goods and passengers across state lines. As a result, the federal government has the authority to regulate various aspects of railroad operations, including safety standards, rates, and specific environmental regulations. The regulation of railroads has evolved, but only a little since the 1800s, and there have been ongoing conflicts about the balance of power between the federal government and local

and state governments. In recent years, there have been efforts to devolve (push down) more regulatory authority to the states, counties, and cities, allowing them to have greater control over certain aspects of railroad operations while ensuring compliance with federal safety and operational standards. The City cannot tell the train how many times or for how long to blow its whistle; unlike cars and trucks, the City has no authority to regulate their speed. So don't call City Hall. Call your Congressman to make changes to the railroad in Biggs/Gridley/Live Oak, all of which are towns that were started by the railroad and have tracks running through them.

## CAL FIRE/Butte County News Release

**BUTTE COUNTY, CA (MPG)** - Following a period of critically dry conditions, California experienced a very wet winter that filled reservoirs and put an end to years of drought. The plentiful precipitation also caused significant vegetation growth in Butte County. No matter how much rain the area receives throughout the winter and spring, however, the abundant grass crop dries out as the temperature rises and humidity drops.

While wildfires are a natural part of California's landscape, the increasing fire danger posed by dead grass and hotter, drier conditions in the region are prompting CAL FIRE to suspend all burn permits for outdoor residential burning within the State Responsibility Area of Butte County. This suspension goes into effect Monday, June 26, 2023 and bans all residential outdoor burning of landscape debris such as branches and leaves.

"We encourage residents to use the last two weekends in June to finish any debris burning that may help you achieve your defensible space goals," says Garrett Sjolund, CAL FIRE/Butte County Fire Department Fire Chief. "But we urge caution as the risk of an escaped control burn is

rising with the temperature."

As of June 12, CAL FIRE and firefighters across the state have responded to 1,639 wildfires that have burned more than 4,000 acres this year.

After outdoor burning of landscape debris by homeowners is no longer allowed, CAL FIRE is asking residents to continue preparing your home for wildfire by creating defensible space and hardening your home.

Here are some tips to help prepare homes and property:

Clear all dead and dying vegetation 100 feet from your around all structures; Landscape with fire resistant plants and non-flammable ground cover; Find alternative ways to dispose of landscape debris like chipping or hauling it to a biomass energy or green waste facility.

The department may issue restrictive temporary burning permits if there is an essential reason due to public health and safety. Agriculture, land management, fire training, and other industrial-type burning may proceed if a CAL FIRE official inspects the burn site and issues a special permit.

The burn permit suspension applies to all areas of Butte County except within the city limits of Gridley and Biggs. For up-to-date burning regulations, visit the Burning page at [ButteCounty.net/Fire](http://ButteCounty.net/Fire). ★

school on that site down the road." He also noted that TK, Transitional Kindergarten, is expanding in the state, and the district will soon be required to serve all four-year-olds. Because McKinley School is almost maxed out, they are planning for the future. He said that City Planner Donna Decker had reached out to him on the matter in April but hadn't replied to his response. He requested the city "stay in communication, stay in the loop, it's been spotty."

Eric Waterbury, GUSD Board President, also spoke during the community forum, saying, "We're hearing things like we're not willing to give up

an easement for Laurel Street to be extended, and we are. ... Those talks have fallen flat since April." He added that residential development could be "too much" for current school facilities, saying, "If we don't have a plan to build schools out in the future, and how we're going to build those schools out ... we're going to have kids stacked in classrooms." He noted a future school on Randolph could cost \$50-\$60 million, funds the district wouldn't have with the impact fees they are allowed to levy, and they would like to work with the city on other avenues for raising the needed funds.

Ashley Ayala, Parks and

Recreation Director, was happy to report that the Kids Free Fishing Day saw 871 participants and 750 free meals, with the biggest fish weighing in at 7.16 lbs. The Outdoor Equity Grant helped pay for the expenses of the fishing event. The grant will also fund the Kids Healthy Outdoor Day on July 8. Catalina Sanchez, councilmember, suggested Ayala consider tri-city events organized in partnership with the cities of Biggs and Live Oak.

Calderon reported that the county library system is in crisis and needs a minimum of \$3 million dollars. The Butte County Library Ad Hoc Committee is recommending to the Board of

Supervisors a ballot measure that would create a tax district or other funding.

City Manager Cliff Wagner reported that there is an interested buyer for the Stapleton's plant on the north side of town. City staff will be meeting with the potential buyer, a company that makes natural cookies, "... a very clean, healthy operation."

After Electric Utility Director Jake Carter reported on several Electric Department activities, Wagner noted that the DMV registration renewal of one of the electric department trucks became problematic, with the DMV charging a \$30,000 renewal fee. Calling it a "double tax," Carter said, "I got to talk to

every tax division in the State of California ... It took a few days and a lot of documentation ... I was finally able to walk out with plates and registration."

Christian Garcia, Waste Management Recycling Education Rep, spoke during the community forum period, reporting on their participation in the Red Suspenders bed races, vendor booths, and parade, where they had a vintage collection truck and the newest collection truck in California. Garcia added, "The Gridley Transfer Station is open Saturdays and Sundays 8:30-4:00pm, closed 30 minutes for lunch at 11:30am. You're welcome to bring in all your mattresses for free." ★

National Agriculture North America Teen Queen, one of the program's top three highest teen titles. She was also honored with the "outstanding service queen" award.

Of her new title, Bastiani says that it felt "amazing" to earn the crown and that she is very excited for the opportunities the title opens up for her and her platform as an advocate for ag, or ag-vocate.

Her new role as Miss National Agriculture America Teen Queen affords Bastiani the ability to share her passion for agriculture and animals, which manifested at the young age of 6. Her mother, Hilary Bastiani shares that her daughter learned from her pet rabbit how animal fertilizer or compost supported garden growth, and how the produce yield from the garden fed both animal and farmer. Her interest in ag spread from there and by age 7, Bastiani had decided that she wanted to be a farm vet. Her conviction has not changed since.

Bastiani says that being Ms. National Agriculture American Teen Queen was such a draw to her because "I felt like I could spread more information," with a national title. "When I had my previous title, I could only really travel in my

county, maybe to a county nearby, but now I can basically travel anywhere in the United States."

Bastiani says her dream is to "spread more information about agriculture as a whole" to the nation as an ag-vocate. The queen says that while still prominent in our culture, agriculture is taking a back seat to industries such as technology. Her goal would be to shift that focus and help educate others on the importance of agriculture and how any economic level can easily become involved in the realms of agriculture.

The teen has multiple ways to share her message including participating in parades, and fairs, being a spokesperson at events, doing PSA's, educational posts on social media, and community service. Since being crowned Ms. Ag American National Teen Queen, Bastiani has been visiting royalty at the Sutter Parade, Colusa County Fair, and will be participating in many upcoming local events this summer.

As far as the Ms. Agriculture American program, Bastiani says that it feels like "family" and that her fellow queens lift and support each other. She considers herself an introvert and says that "I feel like more people need to know about this program," she continues, "because it's not all about ag. It's about putting in the work and showing that you care about your community, and you care about the country's agriculture and people in general."

a strong breeze. Gridley PD had blocked off the far right northbound lane and Archer Avenue in order to give PG&E crews and responders room to work on the leak, but traffic had not been halted at that time. CALFIRE had set up an incident command center in the Dollar General parking lot and worked with PG&E crews to maintain public safety and facilitate the shutoff efforts. Customers continued to enter the Dollar General parking lot and shopping center across the street, seemingly unaware of danger.

The leaking pipe

appeared to be in a rather shallow excavation site off the shoulder of the highway, with PG&E crews able to reach down and manually work to repair the leak.

The pressure of the leak was reportedly reduced by 10:35 a.m. and the line issuing gas was reportedly capped around 10:40 a.m. No further incident occurred. ★

## Imperial Valley Farmers Await Water Deal, Weigh Planting Decisions

California, Arizona and Nevada reached a long-sought consensus last month on how to conserve water and prevent the Colorado River from running dry. Farmers in the Imperial Valley, who are expected to shoulder much of the burden, had been readying to fallow some acreage to save water as early as this year. But many will plant as normal this year and look to reduce acreage next year. That's because a \$1.2 billion federal compensation plan is yet to be worked out for those curbing water use, including details on how much each water user will be paid to leave water in the river.

## California Ranchers Have Ample Pastures, but High Costs for Rebuilding Herds

Short supplies of cattle nationwide have sent prices soaring at a time when California ranchers have less to sell after years of drought forced them to shrink their herds. With more rain and an explosion of feed on pastures this year, ranchers are eager to rebuild their numbers while the market is hot. But buying cattle at current prices may not be palatable for some. In its May forecast, the U.S. Department of Agriculture said it anticipates beef production in 2024 to decline 8%, resulting in the lowest per capita beef available domestically since records began in 1970.

## Storms improved outlook for California farming, agricultural summit is told

The outlook for California's agricultural economy shows some signs of improvement after several years of supply-chain constraints, high input costs and a multi-year drought that forced farmers to fallow acres and remove orchards. Drenching storms that hit the state early this year turned the tide, contributing to a more positive outlook for agriculture this year, economic analyst David Magaña of Rabobank told attendees during a food and agriculture issues summit in Sacramento. The event featured discussions on topics including water, labor and farm policy.

## Officials Hail Farm Grant Program to Safeguard Food Protection

The U.S. Department of Agriculture is partnering with states to offer a grant program to build resilience across the food-supply system, responding to lessons learned from supply-chain disruptions and food shortages that occurred during the COVID-19 pandemic. The USDA Resilient Food System Infrastructure Program is meant to create new revenue streams for producers and to strengthen local and regional food systems. The program was discussed during a recent California State Board of Food and Agriculture session on safeguards to protect America's food supply. ★






his out of straw walls. Along came the big blow hard wolf and over went the pig's house. They ran to the third little pig's house for safety.

# Undercutting Accelerated Approval Could Doom Biden's "Cancer Moonshot"

Thirty years ago, AIDS patients faced increasing symptoms and the risk of death while awaiting life-saving drugs that had shown enormous promise in clinical trials -- but that were hung up in the FDA's traditional approval process. In response, Congress sanctioned a new FDA "accelerated approval" pathway that gave patients earlier access to medicines. Lives were spared and our healthcare system finally had solutions to manage a disease that was ravaging our nation.

That same accelerated approval pathway has saved countless lives over the past three decades. Cancer treatments have been developed and delivered to patients more readily. Rare diseases once considered untreatable now have new standards of care that were previously completely unthinkable.

Despite this, the pathway is back in the news -- and for all the wrong reasons. Congress recently passed legislation that changed the accelerated approval pathway in significant ways. The latest reforms could substantially weaken the pathway and its potential to bring future treatments down the pike. It's puzzling that some elected officials are championing the Cancer Moonshot while at the same time undermining the pathway that's facilitated earlier access to breakthrough cancer drugs.

Accelerated approval is reserved for treatments that address serious or life-threatening conditions for which there are currently no adequate therapies.

Under traditional FDA approval, new drugs don't get a green light until tests demonstrate they produce a clinical benefit in patients -- for example, better cancer survival rates. Under the accelerated approval pathway, however, medications are conditionally approved if they can demonstrate success at a "surrogate endpoint" -- that is, a predetermined and measurable step that predicts a future clinical benefit. For example, if tests show a new cancer drug shrinks tumors, there's good reason to think it will

extend lives. Crucially, if further required testing determines the medication has failed to deliver on its initial promise, its accelerated approval can be revoked. But in the overwhelming majority of cases -- some 76.5% of accelerated approvals between 1992 and 2016 -- confirmatory testing has led to what's called conversion to traditional approval.

Compromising the accelerated approval pathway would lead to fewer new treatments, period.

Emerging biotech companies are responsible for about 80% of all experimental medicines in the drug-development pipeline. Yet these firms often lack the funds to see a drug all the way from creation to confirmatory testing. With accelerated approval, they can begin selling their medication sooner, thereby enabling them to financially sustain the final rounds of testing themselves.

Unfortunately, that might not be a workable business model much longer. The FDA's top oncology regulator said he intends to begin withholding accelerated approval of new cancer drugs until confirmatory trials are already underway. As a result, two companies have already seen promising cancer treatments delayed because of this new policy.

Further concerns lie in the inconsistencies around access to drugs approved under the accelerated approval pathway. The Centers for Medicaid & Medicare Services (CMS), for example, has disclosed plans to pay less for accelerated approval drugs that haven't completed confirmatory studies.

Equally worrying, CMS has issued a "national coverage determination," that will prevent most Medicare beneficiaries from accessing an entire class of groundbreaking new Alzheimer's treatments simply because they received accelerated approval.

All told, these misguided coverage restrictions will only delay access to FDA-approved treatments that could change the course of some of the nation's most costly chronic conditions. ★

**MARYSVILLE, CA (MPG)** - Thursday afternoon at approximately 5:26 fires broke out in the foothills near Loma Rica and Browns Valley, according to CALFIRE.

CALFIRE reports that what started as two spot fires near Fargo Way and Dusty Trail, merged into one larger fire that the agency named the Scott Fire.

The Yuba County Sheriff's Office in cooperation with CALFIRE Nevada-Yuba-Placer Units put out evacuation warnings and orders that extended throughout the area. The fire forced road closures to portions of Loma Rica Rd., Los Verjeles Rd., Scott Grant Rd., and the public was urged to avoid Marysville Rd. as firefighters worked to contain the blaze.

Although crews immediately began containment efforts, the wildfire was not reported as 100% extinguished until Monday, June 19th.

CALFIRE incident reports say that 475 structures were threatened by the blaze that ultimately consumed 115 acres of grassland and oak woodland. ★

# Two Out of Three Defendants in 2020 Double Homicide Plead Guilty

**BUTTE COUNTY, CA (MPG)** - Guilty pleas were entered on June 13, 2023, in Butte County Superior Court by two defendants in an October 2020 double homicide involving a marijuana deal gone bad.

Michael Griff and Austin Hogan, both 24, were part of a trio of Oroville men who lured two brothers from Florida to buy marijuana here. Griff today pleaded guilty to two counts of first-degree murder and Hogan pleaded guilty to two counts of second-degree murder in the deaths of brothers Jerry and Randy Bonds, 39 and 33 respectively. The remaining defendant still pending trial is Kyle Smith, 27.

Butte County District Attorney Mike Ramsey said the case began when the Florida brothers' family called the Butte County Sheriff's Office on October 21, 2020 and reported the brothers missing. The family told sheriff's detectives the brothers had flown to the Los Angeles Airport two days before and rented a car. The family had tracked one of the brother's cell phone to the Forbestown area in Butte County but then lost contact. Sheriff's detectives developed evidence

linking the Oroville trio to a meeting with the Bonds at Ponderosa Way and Lower Forbestown Road in rural eastern Butte County. The alleged purpose of the meeting was for the Bonds to purchase marijuana from the defendants. The evidence showed the Bonds brothers were then fatally shot by Griff and Hogan using a handgun and a shotgun. All three defendants then concealed the brothers' bodies under vegetation in the area.

Smith then drove the victims' rental car away followed by Griff and Hogan in a separate car to a Reno, Nevada casino. Local and Nevada surveillance linked the defendants to the involved vehicles and eventually to the homicide scene where the brothers' bodies were recovered.

As a result of the pleas, Griff faces a prison sentence of 50 years to life when he is sentenced on August 8, 2023.

Hogan faces a prison sentence of 30 years to life when he is sentenced, but his sentencing will be delayed until Smith's case goes to trial. Hogan is expected to be a witness against Smith during that trial. Smith's trial proceedings were continued to June 21, 2023, to set a date for his jury trial. ★

# Paving Work Scheduled for State Highway 162 East of Oroville

**BUTTE COUNTY, CA (MPG)** - Caltrans is alerting motorists about around-the-clock one-way traffic control next week on State Highway 162 east of Oroville for paving work.

Starting Monday, June 19, construction crews will be working during the daytime and nighttime hours through Saturday, June 24 from Saddle Drive to the Middle Fork Feather River Bridge. Around-the-clock one-way traffic control is scheduled to continue Monday and Tuesday, June 26 and 27. Flaggers at each end of the construction zone will be utilized along with a pilot car.

Motorists can expect intermittent one-way traffic control at various locations along the 4-mile stretch of roadway from 7 a.m. to 5 p.m. Monday through Friday from June 28 through August 31.

Motorists are reminded that pilot vehicles are to be followed at all times within the project zone for the safety of construction crews and travelers. Failure to follow pilot vehicles may result in a \$220 citation with traffic fees doubled in construction zones.

The schedule is subject to change due to weather, equipment or material availability or other unexpected events. Knife River Construction of Chico is the contractor for this \$2.4 million paving project. Roadwork is expected to be completed by the end of August.
