This Fourth of July, remember to celebrate responsibly. Protect your community by preventing fires and injuries caused by fireworks. Before you think about buying fireworks for your celebration, make sure they are permitted where you live. Fireworks purchased out-of-state are illegal in California without a license. Why not let the experts handle the fireworks show? You can easily grab a blanket, head to local fireworks show, and find the perfect patch of lawn to kick back

"With fireworks causing over \$25 million dollars in property loss in 2022, preventing fires and injuries caused by fireworks begins with you" said Chief Daniel Berlant, Acting California State Fire Marshal. "Don't be the reason your Fourth of July holiday goes up in smoke".

If Safe and Sane fireworks are legal in your area and you choose to use them, it's important that you follow these safety tips:

Never use illegal fireworks; Make sure the firework has the State Fire Marshal "Safe and Sane" seal on it; Make sure the "Safe and Sane" firework is purchased from a licensed fireworks booth; Never allow young children to use or handle fireworks; Never use fireworks while impaired by drugs or alcohol; Never hold a lit firework in your hands; Never light fireworks indoors; Only use them away from people, houses, and flammable materials; Never point or throw fireworks at another person or animal; Do not try to re-light or handle malfunctioning fireworks; Soak both spent and unused fireworks in water Continued on page 4

GRIDLEY, CA (MPG) - On Friday, June 23rd, Ed White, Director of Maintenance, Operations & Transportation for GUSD, Superintendent Justin Kern, fellow GUSD bus drivers, and members of the California Highway Patrol joined together to honor retiring bus driver Marie Popejoy at the Guardian Building in Gridley.

CHP Commander Marc Stokes, along with CHP School Bus Officer Jeremy Andres, and CHP's Chad Stewart stood before Popejoy's colleagues and took a moment to thank the long-time employee of GUSD for her years of dedication. Stokes would say, "In my time I've never, ever presented a school bus driver an award." He continued, "That goes to demonstrate how great this is, and just the fact that it is well deserved – how special it is."

Popejoy began her career driving school buses for Gridley Unified School District (GUSD) in 2001 and, for the last 22 years, has been the dedicated driver for students with special needs. In his presentation, Commander Stokes said that she drives about 100 miles a day, equating "to 378,000 safely driven miles

(a year), which is pretty incredible."

She was nominated for the award by CHP's Motor Carrier Specialist Frank Hall, who inspects both buses and drivers, evaluating bus and driver safety, bus maintenance records, and driving records of transporters. Popejoy was selected for the award due to her outstanding performance in all aspects of her job and responsibilities.

Officer Andres, who worked with Popejoy throughout her career, shared with Commander Stokes that her character and consideration stood out along with her exceptional driving record. When out sick, Popejoy would call in to check on her route and the children she transported daily to make sure that everything went well.

Andres presented Popejoy with a safe driving award certificate for her 22 years of service and excellent track record. An emotional Popejoy said that "It's been an honor to do this. I love what I did. I love my kids, my coworkers." She continued, "Thank you God for taking me through it without letting anybody get hurt on my watch - it's been a huge blessing." She retired to a round of applause as her colleagues expressed they were sad to see her go.



I've kept a small bowl with pebbles and water for the bees. I can stop because they are sipping water from the old carpet that covers the turtle's island sunning spot. When I first saw them I thought, "What are they doing?" Then I realized they were drinking water. No more accidently tipping over

pebbles everywhere.

The bublets I took off of the tiger lilies last fall, have grown little plants. A few of these plants sent up stalks. The other day I noticed that some of the stalks had started bublets of their own, no flower but determined to produce something. Now to find out if they are viable or not. I'm hoping all these little plants are forming bulbs that I can help get bigger and then have more tiger lilies.

The peach trees are doing well and the early peaches are starting to ripen. Many people have told me they have terrible leaf curl this year. So happy not to be a part of that, so far, no curl and OK production. Of course, my trees are kept small at about 5-5.5 ft tall and not too wide. Enough fruit to eat without canning.

I am adding extra irrigation to the fruit trees and the Japanese maple trees. Trying to make them nice and strong for the onslaught of hot, hot, hot that is coming our way eventually. Since we are officially in Summer, I have no doubt we will heat up.

The Praying Mantis egg-cases I found are now empty. I'm watching for babies but haven't seen them so far. I'm sure they are there but camouflaged. Once they are bigger, I will be coming eye ball to eye ball with them in the garden. The ladybugs have arrived. I haven't notice aphids but I'm sure they are there.



Family Business? Keep it Professional

My father isn't involved with our family-owned business anymore, but he's still a one-third owner and insists on taking a salary. This situation has begun to cause problems for other I was wondering what your take is.

Dear Tracy,

If I understand correctly, three owners form the board, and you three direct the management and leadership of the company. That means if your dad gets outvoted on something, he must accept it because he's a minority owner. As an owner who is no longer actively involved in the company, he should be getting a distribution of the profits—not a salary.

Dave Ramsey Says

Specifically, one-third when the profits are distributed.

Let me give you a visual. Draw three concentric circles so that they all overlap in the center. It should look a bit like the Olympic symbol—a Venn diagram. In each circle, write "owner," "management and leadership" and "family." This is a standard family-business diagram. Most problems in family businesses come when someone forgets which circle they're in. You could be a member of the family but not members of the family, and have any ownership or be in leadership. You could be in leadership but not be part of the family or be an owner. You could also be a member of the family and be an owner but not work at the company. That would be your father.

I think you guys need to reset things in your business. It's time for the working owners to sit down with your father and have an adult conversation. The discussion should be professional and gentle and go something like: "Dad, we all set this up in the beginning. But we've

made some mistakes. We shouldn't be paying a salary to people who don't work in the business. You've been repaid for your venture money, and from now on, you'll be getting a distribution of profits instead of a salary. We think this is fair and reasonable, but if you don't agree, we can discuss buying you out of your third of the company."

It sounds like things are already strained, but you've got to have a professional setup within the business. Do your best to be respectful and reasonable with your father. But you need to get this sorted out and agreed on before it causes any more hard feelings.





Alleged Child Molester Held to **Answer After Preliminary Hearing**

Butte County DA News Release

BUTTE COUNTY, CA (MPG) - A 31-year-old Chico man appeared in the Butte County Superior Court on June 27, 2023, for a preliminary hearing on charges alleging he supplied drugs to his 15-year-old "girlfriend"; beat her; assaulted her with a firearm; and had sexual relations with her causing her to become pregnant and undergo an abortion. After the preliminary hearing, he was held to answer for his crimes that spanned from June 2021 through September 2022.

Silvano Angel Maldonado, Jr., 31, of Chico, appeared in court June 27, and heard the evidence supporting the judge's ultimate decision to uphold 24 counts of child molest, domestic violence, child abuse, furnishing drugs to a minor, criminal threats, and assault with a firearm against a 15-year-old victim over the course of a year. A special enhancement of great bodily injury was also upheld as a result of the victim's abortion.

Butte County District Attorney Mike Ramsey said the evidence presented showed that in June 2021, Maldonado

held a gun to the victim's head and threatened to kill her. The evidence also showed Maldonado was molesting the victim for the entirety of their contact from June 2021 through September 2022. The victim was 15 years old when Maldonado began to prey on her when he was 29 years old.

Ramsev said the evidence also showed the victim became pregnant by Maldonado and he promised to pay for the teenager's abortion but later reneged.

Ramsey said the Chico Police Detective Sophia Parsons was alerted to the conduct by the victim's mother last year. Parsons conducted an extensive investigation resulting in Maldonado's arrest in October 2022. Maldonado has remained in the Butte County Jail since his arrest.

After the hearing, Butte County Superior Court Judge Kristen Lucena found there was sufficient evidence to proceed to trial on all the counts brought by the prosecution. Judge Lucena scheduled Maldonado's case for arraignment and jury trial setting on July 13, 2023. Maldonado is being held without bail and he remains in custody. He faces over 30 years in state prison.

Magalia Man Arraigned on Child Molest Charges

BUTTE COUNTY, CA (MPG) - A 48-year-old Magalia man was arraigned on multiple child molest charges on June 20, 2023, in Butte County Superior Court. His arraignment was continued to Thursday morning for entry of a plea and appearance of counsel.

Eric Leon Rein, 48, of Magalia, was arrested last Thursday, June 15, 2023, by investigators from the Butte County District Attorney's Office. District Attorney Mike Ramsey said the arrest of Rein was the culmination of a nearly oneand-a-half-month investigation, which alleged Rein molested two young girls, now adults, over the course of several years, beginning when the girls were eight

Ramsey said his investigators were initially alerted to the situation when the Butte County Sheriff's Office referred the case to his investigators in April 2023. One girl disclosed multiple instances of molest, spanning the course of several years. The other girl is living with a disability and is non-verbal. Ramsey said investigators conducted a thorough investigation that included backtracking through time to establish where the girls were living to properly prepare charges for arrest. Once the investigation was complete, Rein was arrested and interviewed.

Ramsey said Rein is facing multiple counts of felony child molest and faces up to 20 years in state prison. He is being held in Butte County Jail on \$400,000 bail. ★







Shelly Diaz, GUSD Director of Child Nutrition, said they were looking at installing vending machines at Sycamore Middle School that would offer reimbursable meals, such as a cold deli sandwich or salad. The machines would be connected to the meal payment system, giving students the option to access meals outside the cafeteria.

The Fire Fighters from Gridley Fire Department/CAL FIRE would like to offer these tips for the safe and responsible use of fireworks:



- Remember, most fireworks injuries occur to children always have an adult present.
- Most fireworks caused injuries are to hands and eyes and can be very serious - resulting in the loss of one of more fingers, a hand, or your eyesight. Light one at a time and keep a safe distance away.
- NEVER point fireworks at another person.
- NEVER use near dry grass or other flammable
- NEVER attempt to re-light or modify fireworks.
- · Have a bucket of water, sand or garden hose available at firing sites.

BUTTE COUNTY, CA (MPG) - CAL FIRE/ Butte County Fire Department is reminding residents that fireworks regulations will be strictly enforced this 4th of July holiday. The possession or lighting of fireworks is illegal everywhere in Butte County except within the city limits of Gridley and Oroville.

"Our fire prevention officers will be on patrol on and around the 4th of July," says CAL FIRE Butte Unit Chief Garrett Sjolund. "Anyone found to be responsible for causing a fire while using fireworks anywhere in Butte County is subject to financial penalties and criminal prosecution."

Fireworks have gone on sale as of Wednesday, June 28 in Oroville and Gridley, as well as other communities just outside Butte County. Again, those fireworks can only be used in the cities in which they were purchased, they can't be transported outside Oroville or Gridley, nor can they be brought across the county line and used in Butte County.

The 4th of July weekend is traditionally one of the busiest weekends in Butte County for many outdoor activities. We encourage everyone to celebrate the holiday safely.



GRIDLEY, CA (MPG) - Three Gridley baseball players were selected to be on the All-Northern Section baseball team as it was announced on June 17.

According to the Chico Enterprise-Record, the selectees were voted on the team by a compilation of local media outlets that included the Chico ER, Appeal Democrat, Paradise Post, Redding Record Searchlight and MaxPreps.

Class of 2026 pitcher/utility Tanner Abbott was selected to the first team while 2024 catcher Bryar McWilliams and 2023 alumnus Michael Ryan were selected to the second team. The three selectees were key components into helping Gridley accomplish multiple milestones

throughout the season.

Abbott led the Bulldogs in wins (9) with a 9-2 record, innings pitched (47), strikeouts (76), and threw the only no-hitter for the Gridley pitching staff in a 10-0 win over Los Molinos on April 20.

On top of his dominant pitching numbers, Abbott contributed greatly at the plate offensively for the Bulldogs. His .355 batting average and 22 hits on the year

were second best for Gridley.

McWilliams locked down the plate this season as the catcher and Solis told the Herald that he is excited for another season with McWilliams behind the plate.

As a staple at the top of the Gridley lineup throughout the season, McWilliams led the Bulldogs in hits (26). His .351 batting average and team leading 85 plate appearances gave opposing pitchers issues as he was in the top three of the teams on base percentage for the year.

Solis told the Herald that McWilliams did a great job in the preparation for games behind the plate whether it was preparing his pitchers before a game getting them in the right mindset or remembering the deficiencies and tendencies of opposing hitters to take advantage.

Ryan was a four-year player on the Gridley roster and capped off his senior season with a bang that included a Northern Section Division III title along with leading the Bulldogs to the CIF Division IV NorCal final.

Ryan led Gridley with a .370 batting average and 13 extrabase hits. He led the Bulldogs in hit by pitches and walks at the plate along with being noted as the best leader/captain that Solis had ever had as a coach.

His leadership qualities included always picking a teammate up on the field, and he played multiple positions before ending his season in the outfield at his natural position.

Although Solis wasn't awarded the baseball coach of the year for the NS, he deserves the recognition as being the head coach of the only NS team that reached any of the CIF NorCal finals.

In his first year at the helm of the program of his alma mater, Solis set the bar to a new level. After the loss to Sutter on June 3, Solis expressed to the Herald that now that they have made it to the final game of the season, their goal is to win the final game of the season.

Solis has a young pitching staff returning with Abbott and 2025 Garrett Francis leading the way and although some graduated this past season, the Bulldogs will be back in contention next season for another postseason crown. *
