City Planner and Engineer **Respond to Developers' Complaints**

GRIDLEY, CA (MPG) - The May 15 city council meeting was the city's opportunity to answer the complaints previously raised by developers concerning the city's planning process.

Using flow diagrams, current project timelines, cost drivers, and comparisons with other cities on expected timelines, required initial deposit percentages, and hourly rates, City Planner Donna Decker and City Engineer Dave Harden explained the City's planning process. Adding a detailed timeline of both Steffen Estates and the Village at Eagle Meadows, Harden said that Steffen had four resubmittals and Eagle Meadows had nine.

"You've heard complaints from the developers against the Department of Public Works, the Electric Department, Engineering, and Planning," Decker said, adding that there is back-and-forth communication between several City departments before projects go before the Planning Commission and then to the council. It was also noted that city consultants and staff must work with agencies which "bisect" the city: with Reclamation District 2056 and RD 833, Butte Water District, and Biggs-West Gridley Water District; with Butte County on projects on the edges of city limits; with Caltrans on projects along Highway 99; with the City of Biggs on developments on the northwest; and with the railroad and schools. The City contracts with Butte County for plan and building inspection. Harden said the county is involved in "Every project that we have that has new building going on." "We barely benefit from a subdivision, yes, we need houses, but the city itself doesn't benefit financially. That doesn't bring us income, it brings houses," Harden said. Vice Mayor Bruce Johnson commented, "There's a lot of commerce that comes *Continued on page 2*


BIGGS, CA (MPG) - Biggs High School kept it brief Friday, June 2nd, when

Wolverines Walk!

The following is from the Original Bill Burleson Gridley Herald Pi-Line of April 14, 1993: Thursday Circle observes its 82nd birthday this week, fathering in the home of Freda Smith on Sheldon Ave. Joan Hancock is president. Edith Stohlman joined the club in 1921 and is the senior member, soon to celebrate her 100th Birthday. In February of 1911, six Manzanita/East Gridley neighbors got together. They represented the Clayton, MacKenzie, Stowe, Pingres, Metzler, and Waterbury families. They planned a club for the purpose of bringing newcomers together, for most of them had come from the East and were

strangers in a strange land. The area had just been colonized, and East Gridley was in Colony 1. In those days, there were no paved roads and no drainage. The ladies walked to the meeting bringing their children. Children are always welcome in the club. The first meeting was in Mrs. MacKenzie's home, but the first public meeting was at the Metzler-Waterbury

"shack." The club was christened "The Thursday Circle, " and meetings were to be held on the first and third Thursdays of the month. Membership was limited to 25. The minutes reflect that they were living in little shacks and tank houses with a few houses scattered here and there, and the fields were dotted with lots of oak trees. The club erected the flagpole with the flag in Vierra Park. In 1929 they planted an evergreen at Memorial Hall. They have also taken part in many activities within the Gridley community: showers, weddings, farewell parties, house warmings,

and relief in times of disaster. Congratulations to the ladies of Thursday Circle. ***

Another new business in downtown Gridley, Tim Glines Floor Design, corner of Hazel and Vermont Streets. Tim and wife Denise are the owners. They will hold a grand opening celebration starting today and running through Saturday.

with it. ... We need to get to 10,000 people, so we can get more grants. ... We're under pressure from the state to build a bunch of houses here, too, so we're being crushed both ways."

Harden replied, "They also bring traffic to your streets, which is wear and tear, they make impacts on your utilities. ... If you don't collect impact fees ... you don't have the money to make those improvements and expand your systems ... and provide those reliable services that people count on." Harden said an impact fee study would provide needed information on impact fee rates and the balancing of commercial and residential development.

In his response to developers, City Administrator Cliff Wagner discussed the request to discount developer impact fees.

"I believe that what we're being asked is for the city to indemnify developers against risks in the free market," said City Administrator Cliff Wagner, citing the reality of recent economic forces which have affected housing development. " ... To imply that the city has a duty to ensure the profitability of developers by subsidizing them with other taxpayers' funds in the community is, in a word, absurd."

Several possible improvements to the planning process were offered. Council member Catalina Sanchez suggested the City publish an expected timeline and that council members receive a monthly project pipeline, showing the stages of each current development.

"That's why, I think, all of us ran for council, to have these conversations, even though they're uncomfortable. ... The administrator is going to hold us accountable, our staff is going to hold us accountable, but we're also going to hold them accountable," Sanchez added. She also suggested more planning process information be available on the City's website, suggesting website updates could be a part of budget discussions.

Stating that he had also received a number of calls on the issue, Council member Angel Calderon said, "I direct them to call our administrator. ... Mr. Wagner is a very open and amiable individual. All you have to do is make an appointment and talk to him."

City Administrator Wagner said that there had been an internal discussion about processes that could be implemented, such as a developers packet, including a master fee schedule that developers can sign as received and understood.

"It boils down to communication," said Mayor Mike Farr. When things take time, Farr said, "These contractors ... need to know what their timeline is." Councilmember Jim Roberts added, "I agree with staff. If somebody thinks something is taking too long, instead of just complaining, call up and try to ask, 'why is this taking so long,' instead of waiting months and months. ... take some responsibility for checking on your projects.'

The developers were given time to respond to the city planning, engineering, and administrative presentations. Mike Visinoni, with Steffen Estates on Little Avenue, reiterated many of his initial concerns, saying that being the "squeaky wheel," or contacting the City to investigate delays, was overwhelming.

Steve Stapley, with the Eagle Meadows development, requested the City conduct an impact fee study, noting that Colusa had discounted their fees by 50%. Jared Brown, engineer with Eagle Meadows, said the City may not be responsible for the profitability of developments, but the City needs to see it as their duty to help make developments successful.

Brooke Leone and Steve Stark, Orchard Hospital, were on hand to help recognize May as Mental Health Awareness Month. "... It is the role of the city council ... to improve the life quality of our residents, and I thank Orchard Hospital for actually doing that," Calderon said.

Wagner reported that a delegation from the city of Comala, Colima, Mexico, a city of about 20,000 residents, made a visit to city offices. They were in the area to pick up a donated ambulance from the City of Davis. The delegates reported that there are Gridley residents whose ancestors hail from Comala. They hope to work with Gridley city officials to create sister-city status. "We have a significant number of people who came from this particular town," Calderon added.



CORNER Electrical Safety Around Swimming Pools, Hot Tubs, and Spas

For many of us, water activities equals' fun. But it's important to be aware of electrical hazards while enjoying the water. Know how to be safe around swimming pools, hot tubs, and spas.

- If you are putting in a new pool, hot tub, or spa be sure the wiring is performed by an electrician experienced in the special safety requirements for these types of installations.
- Outdoor receptacles must have covers that keep them dry even when appliances are plugged into them.
- Ground-fault circuit interrupters (GFCIs) are special devices designed to protect against electric shock and electrocution. They are required for most pool, spa or hot tub equipment. They may be in the form of an outlet or a circuit breaker. Test the GFCIs monthly according to the manufacturer's instructions.
- Electrical appliances, equipment, and cords should be kept at least 6 feet away from the water. When possible, use battery operated appliances and equipment, such as televisions, radios, and stereos.
- Avoid handling electrical devices when you are wet.
- Make sure that any overhead lines maintain the proper distance over a pool and other structures, such as a diving board. If unsure, contact a qualified electrician or your local utility company to make sure power lines are a safe distance away.
- Do not swim during a thunderstorm.
- Have a qualified electrician periodically inspect and – where necessary – replace or upgrade the electrical devices or equipment that keep your pool, spa, or hot tub electrically safe.
- Have a qualified electrician show you how to turn off all power in case of an emergency

Farm Bureau President Urges **Congress to Address Fire Risks**

California Farm Bureau President Jamie Johansson is calling for increasing the pace and scale of forest management, including employing livestock grazing and prescribed burns to reduce dangerous fuels and protect communities and the environment. On May 23, Johansson testified in Washington, D.C., before a federal lands subcommittee of the House Committee on Natural Resources. He told the panel, "Given the extensive number of wildfire related impacts in California, California Farm Bureau has a vested interest in quality and quantity of forest management activities."

Winter Storms May Have Increased **Risks of Tree Pathogens**

Atmospheric rivers that swept across the state this year have created conditions for plant pathogens that haven't been seen for decades in California. Florent Trouillas, a plant pathologist at the University of California, Davis, said he is getting more calls from growers and farm advisors concerned about potential crop damage. Recent tests in an orchard showed the presence of Phytophthora syringae, a pathogen that can affect almond crops but is rarely seen in California. Researchers are working to diagnose fruit and nut crop ailments that could be enhanced by wet weather.

Farm Bureau: Small Farmer Need Help After Storms

The California Farm Bureau is calling on the state to improve mechanisms for disbursing disaster relief payments for damages suffered in devastating 2023 storms. Testifying before a joint informational hearing of the California Assembly Agriculture Committee and the Assembly Emergency Management Committee, Farm Bureau Administrator Jim Houston said the storm impacts have been especially hard on small farmers, including many that may lack insurance. "There is no good mechanism for people to recover their losses," Houston said at the May 23 hearing.

Researchers: Lab-Grown Meat May Be Worse For Environment Than Retail Beef

Researchers at the University of California, Davis, have found that lab-grown or "cultivated" meat's environmental impact is likely to be significantly higher than retail beef. Researchers conducted a life-cycle assessment of energy needed and greenhouse gases emitted in all stages of production compared with beef. Based on current and near-term production methods, they concluded that lab-grown meat will be worse for the environment and more expensive than conventional beef production ★




stop trying to produce things myself, and to STOP!



Bulldogs Drop Last Game in Division IV NorCal Final

SUTTER, CA (MPG) - The Sutter Huskies and Gridley Bulldogs baseball teams made it to the final game of the season as the two former Butte View League rivals squared off in the California Interscholastic Federation Division IV NorCal Championship on Saturday, June 3.

The scene last Saturday at Arata field in Sutter looked like a fair as fans of both teams were lined up on the edge of the fence from each foul pole to leave no standing room to watch the game as the Huskies won the game 10-1.

For the second consecutive time in a little over a week and a half, Sutter junior shortstop/ pitcher Logan Yacavace had his longest outing of the season with a complete game, four hit and six strikeout performance.

Yacavace last pitched in the Huskies CIF Sac-Joaquin Section Division V Championship on May 23 in a 4-3 thriller that lasted 13 innings and Yacavace pitched 6.2 innings in relief to pick up the win.

Sutter (26-5-1) head coach Stewart Peterson told Messenger Publishing Group that they have always been confident with Yacavace on the mound, but he's also valuable defensively as well.

"We've used him in the closers role with one or two innings here or there, but when we called on him for the Bradshaw Christian game along with today, he was ready," Peterson said.

The unselfish Yacavace expressed to MPG the team effort throughout the entire season and added it was a perfect way for the seniors class to go out as most of the roster has played with one another for years.

Gridley (17-6) head coach Javier Solis told MPG that every game in the state playoffs was a bonus as their original goal was to win a Northern Section title as they did on May 20, in a controlled

level credited multiple people throughout his years as a Bulldog.

Ryan's main message to the returners next season was to show up ready to play everyday.

"With our young pitching staff, they have a chance to win every game," Ryan said.

Being mentioned as the best leader in Solis's 12-year coaching career, Ryan exemplified that as being a leader in the classroom and on the field giving it 100 % all the time.

Abbott went 2-for-2 at the plate with an RBI. On the single, Abbott rolled his ankle and it didn't translate well as he went to pitch in the bottom of the third.

No excuses were made as the Huskies slammed four straight singles as Wickum had his second single and third RBI of the day.

In previous conversations with Wickum, he expressed he has been up and down at the plate throughout the season.

"I worked on being patient," Wickum said. Wickum went 2-for-4 with three RBIs in the game.

Seven of the Huskies starters had a hit during the game along with four of them having two or more RBIs in the game.

Sutter added four more runs in the third to take a 6-1 lead. Yacavace sewed up the Gridley lineup for the rest of the game as he only gave up the triple to Ryan in the fifth.

The Huskies tacked on three more in the bottom of the fifth before junior designated hitter Rylan Giovannoni capped off the scoring with a solo home run in the sixth over the left field fence.

This was the first trip to the NorCal finals for the Huskies and Bulldogs as the format began in 2021 by the CIF.

As the season ends, turnover on both rosters begin as they both lose key pieces but Sutter and Gridley have a lot coming back next season.

While the Huskies lose four starters and the Bulldogs lose three, both squads have their primary pitching coming back.

Solis added that as much talk
