BIGGS, CA (MPG) - After being hired on as Interim City Administrator, Josh Cook was officially sworn in as Biggs new City Administrator at the City Council meeting held March 14th, 2023.

Mayor Brian Bassett says the City hired a recruiting agency to find a good fit for the City Administrator's position, but after one round didn't deliver the candidates they had hoped, the process started again. When Mayor Bassett and his council saw Cook's application in the second round, Bassett said the decision to hire him was unanimous. "We found our city administrator right under our nose."

council for 18 years and 16 years spent serving as Gridley's mayor. "My growing up years in Gridley, I was always taught that you should be involved – if there is a community meeting you go to it, and if there's something that needs to be done, you sign up and go do it."

At 24, Cook began his own career in politics working for Congressman Wally Herger. He has worked in the California legislature for roughly 18 years with few breaks in service, the last 11 years spent working for Senator Dahle (former assemblyman Dahle). Throughout his years of service, Cook has worked with seven state senators. He has also served in the California State Guard for 8 years. Of his transition from State to local government, Cook mentioned multiple factors, but most importantly he felt that "local government makes a bigger difference in people's

lives." After years in the legislature, Cook says that "if you want to make a difference in people's lives, you get to the government that's closest to the people." It is also a boon that this area is "home" to Cook, and he can be closer to family.

Cook believes that his role working for elected officials in the past, will assist him in implementing what the City Council would like to see happen for the City of Biggs. Mayor Basset echoes those sentiments and adds that his relationship with Gridley's City Administrator, Cliff Wagner, will hopefully foster a positive relationship between the two cities moving forward. Cook has already held meetings with former Biggs City Administrator Mark Sorensen, Butte County Sheriff Kory Honea, who provides law enforcement for the town, and public works Continued on page 3

Child Molester Sentenced to 32 Years

BUTTE COUNTY, CA (MPG) -David Kenneth Hamilton, 26, of Chico, was sentenced Wednesday, March 22, 2023, in Butte Superior Court for sexually abusing two different boys under the age of 10 years old. He received the maximum sentence of 32 years in prison.

Hamilton's acts of molestation were discovered through an extensive investigation by the Chico Police Department into ongoing sexual abuse by multiple offenders with whom Hamilton was associated. Each of those other offenders was also charged and previously pled to their role in the molestation of victims.

Butte County District Attorney Mike Ramsey said search warrants executed in the case revealed significant evidence of ongoing predatory conduct by Hamilton and his girlfriend. In one text exchange with his girlfriend, Chelsea Klein (who previously pled and was sentenced to state prison for her role in the case), the two discussed scouting for young boys in a public bathroom. Klein texted Hamilton about a young boy entering the restroom, and Hamilton responded angrily that he wasn't able to take a picture of the boy, because: "Some guy came in" the bathroom. Further evidence collected at Hamilton's home included eyeglasses that contained a hidden camera, child pornography, and other evidence of pedophilia. Ramsey said that Hamilton's character and history made it abundantly clear he will forever pose an extraordinary danger to all children. Because of the charges of which he was convicted, Ramsey said Hamilton will be psychologically evaluated by state doctors to determine if he is a Sexually Violent Predator before being eligible for parole from prison. If he is found to be a Sexually Violent Predator (SVP), he could be transferred to and spend the rest of his life in a locked state hospital.

GRIDLEY, CA (MPG) - For the past 75 years the Gridley Lions Club has pursued helping the community of Gridley in a wide variety of ways. One dedicated area of service is helping those who have vision impairment. Not only does the local Lions Club have Vision as a major mission, but so does Lions Clubs International (LCI). Almost 100 years ago Helen Keller challenged the Lions Clubs in the US to become, "knights for the blind...". Lions' clubs took up this challenge and have been involved in helping the blind and vision impaired since that time.

Thirty-three years ago, LCI increased this mission for sight by starting SightFirst. This international foundation has taken up the fight to help with preventable blindness. President Jimmy Carter, a proud Lion, has been deeply

involved in the project to eliminate Onchoceriasis, better known as "river blindness." Caused by a worm that gets into the eye it can be halted by the use of Mectizan[©]. SightFirst is

instrumental in partnering with health care providers and local governments to get this treatment to the affected populations. Another preventable eye condition that leads to

blindness is Trachoma, a highly contagious bacterial infection of the eye that leads to blindness. It too can be prevented and Lions through SightFirst work steadily to get Zithroma[©] to those suffering from this infection.

Locally the Gridley Lions have collected glasses over many years. There is a renewed effort and the boxes for collecting unused glasses are now placed at Orchard Hospital, CVS, Rite Aid and Safeway Pharmacy. Look for these donation boxes and bring your unused prescription and readers to give to those who need help with sight. Once the glasses are collected, the Gridley Lions donate them to a collection warehouse in Vallejo, Lions In Sight of California and Nevada. GRIDLEY, CA (MPG) - Since the resurrection of Jesus, Christians have celebrated Easter to commemorate his triumph over death and promise of eternal life. Local churches are planning a variety of Easter services and invite the public to attend.

The Gridley Christian Church plans a special worship service the morning of Easter Sunday, April 9 at 10:30am. Refreshments will be served before the service, at 9:30am. Their church is located at 580 Washington St. on the corner of Hazel St.

Calvary Chapel of Gridley will feature special speaker Rich Robinson, of Jews for Jesus. He will speak at 10:00am at the church at 210 Park St. Robinson's presentation, titled "Christ in the Passover," will explain the connection between the ancient Jewish feast of Passover and the Last Supper Jesus shared with his disciples.

First Baptist Church will begin their Easter celebrations on Good Friday,

April 7 at 6:00pm with a night of worship with the gospel music group The Kramers. They will begin Easter Sunday with a sunrise service outside the church at 6:15am, followed by breakfast. Their usual 10:45 am service will also be held. They are located at 100 Vermont St.

Local congregations of The Church of Jesus Christ of Latter-day Saints are planning special Easter Sunday services commemorating the atonement and resurrection of Jesus Christ. Services will be held at the Liberty meetinghouse at 1259 French Ave. and at the Stake Center at 400 Spruce Street, both at 9:00am. The Spanish-speaking congregation plan a service at the Stake Center at 12:30pm.

The Sacred Heart Catholic Church plans several commemoration events. On Good Friday, April 7, an outdoor "Stations of the Cross" or "Via Crucis" will take place at noon at the parish property behind the Safeway shopping center on Bonnell Ave. in Gridley. On Saturday,

California Invests Another \$1.1 Billion on Its Transportation Infrastructure

Caltrans News Release

SACRAMENTO, CA (MPG) - The California Transportation Commission (CTC) recently allocated more than \$1.1 billion for projects to repair and improve transportation infrastructure throughout the state. The allocation includes more than \$533 million in funding from the federal Infrastructure Investment and Jobs Act of 2021 (IIJA) and more than \$190 million in funding from Senate Bill (SB) 1, the Road Repair and Accountability Act of 2017.

"California and our federal partners are taking action now to create a safer, more resilient, and more equitable transportation future for all Californians," said Caltrans Director Tony Tavares. "These visionary infrastructure investments are giving Caltrans the tools it needs to rebuild California."

Projects the CTC approved in the Sacramento Valley and Sierra regions include:

City of Chico: \$6.2 million in federal IIJA funding for the Esplanade Corridor Safety and Accessibility Improvement

federal IIJA funding, to install lighting, widen shoulders, upgrade approaches to bridges and rehabilitate culverts from Gianella Road to Muir Avenue.

State Route 99: \$2.8 million to plan and develop a safety improvement project at the intersection SR-99 and Oswald Road south of Yuba City in Sutter County.

State Route 162 in Oroville: \$3.4 million in federal IIJA funding to implement a comprehensive set of active transportation infrastructure connectivity and safety improvements that will close all sidewalk, bike lane, street lighting and multi-use trail gaps along the route in the city.

Interstate 5 in Sacramento County: \$33.6 million, which includes \$30.8 million in federal IIJA funding, to construct acceleration and deceleration merge lanes and Intelligent Transportation System (ITS) infrastructure from the Arena Blvd interchange to 0.4 mile south of Yolo County line.

The IIJA, also known as the "Bipartisan Infrastructure Law," is a once-in-a-generation investment in our nation's infrastructure to improve the sustainabil-

The project calls for installing a multi-use pathway, 12,400 feet of Class III bike lanes, 3,200 feet of new sidewalk, new bike boxes, lighting at intersections, Americans with Disabilities Act (ADA) ramp improvements, countdown pedestrian crossing signals, refuge islands, a new traffic signal and lighting.

State Route 32 west of Chico: \$3.4 million in federal IIJA funding to install a traffic signal at Meridian Road. The Butte County Association of Governments is contributing \$500,000 in IIJA funding.

SB 1 provides \$5 billion in transportation funding annually that is shared equally between the state and local agencies. Road projects progress through construction phases more quickly based on the availability of SB 1 funds, including projects that are partially funded by SB 1.

YUBA COUNTY, CA (MPG) -Every year at "Pioneer Day" on the last Saturday in April in the tiny northern California town of Smartsville we celebrate the town's settlers. This year another event has been introduced to honor one of the area's foremost citizens, Fr. Andrew Twomey. He was the Catholic priest who tragically died on March 8, 1902, at the age of 36. He drowned in the flood waters of Dry Creek on his way from Smartsville to minister to the residents of Rackerby on Sunday morning.

Fr. Twomey was loved by the local residents and is remembered every year at Pioneer Day, coming up again April 29. On that day he will be portrayed by Leroy Prindle, president of Friends for the Preservation of Yuba County History.

was also remembered on the anniversary of his death, March 8, thanks to the inspiration and organization of local resident Luis Vazquez. This first annual gathering took place at two locations, the former Church of the Immaculate Conception in Smartsville and the Smartsville Catholic Cemetery.

Visitors at the church were impressed and moved by Fr. Twomey's story and by the historic church, now under the care of Smartsville Church Restoration Fund, Inc. (SCRFI). Afterwards they attended a memorial service and mass at his

gravesite at the cemetery. SCRFI will again have the church open for viewing on the 14th annual Pioneer Day, when Leroy returns to tell visitors about the life of Fr. Twomey. The day will be filled with fun for the entire family. There is



Storms Wreak Havoc for Agriculture in Multiple California Counties

Widespread flooding from continuing atmospheric storms have caused extensive damage for California agriculture, with more storms expected this month. Water from recent storms flooded dairies and carried silt and debris into citrus groves in Tulare County, flooded fields of leafy greens and berries in Monterey County and impacted livestock and feed crops in Humboldt County. Executive Director Norm Groot of the Monterey County Farm Bureau said this month's damages there could top January's estimated \$336 million in agricultural storm losses.

EPA Updates Risk Assessments for Pesticides for Tree Crops, Vegetables and Cotton

The U.S. Environmental Protection Agency has released updated risk assessments for spray drift from four organophosphate pesticides. The materials-diazinon, ethoprop, tribufos and phosmet-are used in agriculture for fruit and nut trees, vegetables and cotton, and for a variety of purposes in nonagricultural settings. The EPA is undertaking a lengthy registration review process for them.

Huge Snowpack and Rising Reservoirs **Boost California Water Hopes**

California's water supply is benefitting from continued storms and flooding. Heavy snow in the Sierra Nevada brought snowpack levels to 222% of normal as of March 16. Meanwhile, Gov. Gavin Newsom signed an executive order that lifted restrictions to allow floodwaters to be diverted to farms for groundwater recharge. The State Water Project will conserve 237,0000 acre-feet of water to help restore depleted aquifers. The U.S. Bureau of Reclamation is diverting another 600,000 acre-feet to boost groundwater supplies and wildlife refuges.

Imperial Valley Region Stands by its Alfalfa Production

As Colorado River water supplies shrank dramatically over the past three years of drought, critics increasingly took aim at alfalfa growers in California's Imperial Valley. But the region's farmers and a leading agricultural researcher are defending alfalfa production in the desert region. They say alfalfa plays a major role in the globalized food system and is a key contributor to the Imperial Valley economy. The crop particularly thrives in the region. "We probably have the highest yield and highest quality alfalfa in the world," says farmer Larry Cox.



LaMalfa and Peters Reintroduce Bill to Tackle Damage Caused by Pesticides



From the Office of Congressman Doug LaMalfa

WASHINGTON, D.C. (MPG) - On March 8, 2023, Congressman Doug LaMalfa (CA-01) and Congressman Scott Peters (CA-50) reintroduced the Targeting and Offsetting Existing Illegal Contaminants (TOXIC)

other states contend with the emergence of illegal cannabis cultivation sites on public lands, investigations show that growers frequently use dangerous banned pesticides to protect their crops. For buyers, consuming even small amounts of cannabis exposed to these banned pesticides could be potentially deadly. The problem also poses a severe health risk for the U.S. Forest Service agents who encounter the illegal crops and are tasked with removing them. The TOXIC Act will remedy the environmental damage caused by banned pesticides to our public lands and ensures those who illegally grow cannabis on federal property using

Act. As California and

banned pesticides are subject to stricter criminal penalties.

"Across the west, cartels are illegally growing marijuana in the most environmentally devastating ways, and at a scale that should concern any group or governor that claims to be pro-environment," Rep. LaMalfa said. "The key to this environmental degradation is the use of illegal pesticides, pesticides that are not allowed near any legal farming operation, which seep into the soil and watershed, poisoning wildlife and endangering residents who inadvertently consume it. Everyone; outdoor enthusiasts, nearby residents on their own land, wildlife, Forest Service, and law enforcement personnel are all at risk. The TOXIC Act penalties for their use on is necessary to criminalize those who harm our public land with banned chemicals and helps remedy the environmental impacts." "Our wildlife, habitat, and public health pay the price for the actions of illegal cannabis growers who often work with the cartels," said Rep. Peters. "These extremely dangerous and illegal pesticides can harm endangered species like pacific fishers and spotted owls, as well as Forest Service agents and consumers who can be severely sickened by these toxins. It is essential that the federal government use all available resources to fix the harm caused by banned pesticides smuggled across our southern border and increase


federal lands."

This bill will: Authorize \$250 million over five years for the Forest Service to use Superfund toxic waste remediation authorities to address environmental damages caused by the release of banned pesticides on federal lands for cannabis cultivation; and raise the criminal penalties for using banned pesticides in illegal cannabis cultivation to a maximum of 20 years in prison and \$250,000 in criminal fines to establish parity with the criminal penalties for smuggling banned pesticides into the U.S. The U.S. Sentencing Commission would then be required to review and update its sentencing

guidelines for these crimes. The idea for the bill came from a series of investigative stories by San Diego journalist J.W. August published in the Times of San Diego.

In 2019, the San Diegobased Border Pesticide Initiative was formed with members of the Department of Justice, **Environmental Protection** Agency, Department of Homeland Security, California Department of Toxic Substances Control, and the City Attorney's Office. In 2021, the group announced it had prosecuted over 50 defendants and seized over 1,000 containers of illegal pesticides.

Reps. LaMalfa and Peters first introduced this bill in October 2022

COLUSA, CA (MPG) - Come to the 80th Annual Stonyford Rodeo, a Professional Rodeo Cowboys Association (PRCA) event on Friday and Saturday, May 5 and 6, and a local amateur event on Sunday, May 7. With its 2020 census population of 127 (700 to 800 more in outlying ranches and communities), Stonyford is likely the smallest venue in the United States to host a PRCA rodeo. While the community is too small to support a motel, it has great camping locations.

The nearby East Park Reservoir provides lakeside camping sites on it at Lodoga and Stonyford ends. The Lodoga end is eight miles from the arena and the Stonyford end is two miles away. The campsites are managed by Colusa County and there is a fee for camping there. Information is available at www.countyofcolusa. org/629/Parks-Recreation.

For convenience to rodeo and other local activities, the best place to camp is in the large area behind (east) of the rodeo arena. This area is managed by the Stony Creek Horsemen's Association in the persons of Germaine Burrows and her crew of dedicated volunteers. This area has plenty of trees and easy access to the arena, restrooms, and local businesses. Camping charge is \$30/vehicle and

is on a first-come, firstserve basis. Due to safety requirements, NO guns, fireworks, motorcycles, ATVs, or similar-type vehicles are allowed on the property. This camping site regularly draws several hundred people each year. They begin arriving the weekend before the rodeo and often remain several days past. On rodeo weekend, parties abound at the end of the day and may include rodeo contestants and staff.

Tickets are available at www. stonycreekhorsemen.

org and at the following locations: Stonyford General Store, Stonyford; Carl's Feed, Willows; Boot Barn, Chico & Yuba City; Bucke's Feed & Grain, Orland; Marie's Lakeshore Feed, Clearlake; Rainbow Ag, Lakeport; and Ace Hardware, Arbuckle. Prerodeo ticket prices are \$15 for adults and \$7 for children, ages 7-12. General admission at the Gate on Friday and Saturday: \$20 for adults and \$10 for children (7-12). Gates open at 3 p.m. on Friday, 11a.m., on Saturday, and 10 a.m., on Sunday. At the Gate on Sunday: Persons aged 13 & older: \$5; age 12 & younger are free. All tickets are general admission (except VIP top row and Box Seats tickets). General Admission seating is first-come, first-serve. So, you will need to get to the area early for choice of seat.

SLE Owner Sentenced for Possession of Narcotics for Sale while Armed

Butte County DA News Release

BUTTE COUNTY, CA (MPG) - An Oroville man, who owned and operated several sober living environment (SLE) homes in Oroville, was sentenced on March 22, 2023, in Butte County Superior Court on two charges of transporting narcotics for sales and one charge of possessing narcotics while armed with a firearm. He received probation from a local judge over the objection of the District Attorney and the recommendation of the Probation Department for a term of six years in prison.

Butte County District Attorney Mike Ramsey said that Michael Mirton Anderson, 60, of Oroville, was sentenced after previously entering pleas of no-contest to the charges in January 2023. Anderson, a long-time criminal in the 80s and 90s, had managed to turn his life around and received a Certificate of Rehabilitation in 2016 from the Butte County Superior Court. Anderson also became the owner, operator, and president of the Northern California Treatment Services, providing SLE homes for addicts attempting to change their lives.

Unfortunately, Anderson returned to a life of crime and was ultimately arrested in

April of 2022 when the Butte Interagency Narcotics Task Force (BINTF) stopped Anderson driving his vehicle with two known narcotics offenders.

A search of his vehicle revealed a loaded handgun hidden between the driver's seat and the center console. BINTF agents also located a backpack belonging to Anderson containing two additional handguns, 67.61 grams of fentanyl, 1.62 grams of heroin, and approximately half a pound of methamphetamine. An additional 293 pills stamped as "M-30" were located in the backpack as well. Although the pills were marked as oxycodone, testing revealed that the pills were counterfeit pills laced with fentanyl.

Anderson's cell phone was also seized and a search of the phone located months of sales text messages.

Before sentencing, Anderson's attorney filed arguments with the court stating that Anderson committed these crimes due to Anderson's drug addiction and to provide for his family. Anderson requested a chance on probation to participate in drug rehabilitation (somewhere other than his own SLE) so that he could address his addiction and go back to helping be a drug and alcohol counselor. \star


