# Not Left Hanging

CALFIRE/Butte County Rescues Worker Dangling in Silo

BIGGS, CA (MPG) - At approximately 1:37 pm on Monday March 6th, an emergency call from Sun West Milling in Biggs requested immediate aid in rescuing one of their employees stuck inside one of their large silo's.

Captain Lane Costa of CALFIRE/Butte County Rescue Station 44 in south Chico said the employee of Sun West Milling was believed to be conducting routine maintenance within the silo when it appeared that equipment used to lift and lower crew members may have malfunctioned. The worker was left

danglingly 100 feet in the air in the empty shaft on his own harness.

Rescue Station 44 out of Chico received the call and immediately sent their Truck 44 to join Biggs Truck 73, which was first on scene, Truck 74 of Gridley and engine 72 out of Palermo. Captain Costa reports that a standard dispatch to an emergency of this type is going to include five technical rescuers with one team lead.

# Woman Pleads to Hit and Run Which Injured 5-Year-Old

Butte County District Attorney Press Release

OROVILLE, CA (MPG) - Banessa Santana, 34, of Oroville, appeared in Butte County Superior Court on March 7, 2023, and plead no contest to all charges relating to a series of incidents wherein Santana fled from law enforcement and ran her car into the back of another car, seriously injuring a five-year-old boy.

Butte County District Attorney Mike Ramsey said the case stemmed from March 12, 2022, when Santana was spotted driving in Oroville by an Oroville Police officer, who was aware of outstanding warrants for Santana's arrest on a previous probation violation and for cutting off her ankle monitor.

The officer turned on his red lights and siren, but instead of stopping, Santana took the officer on a high-speed chase through a residential area of Thermalito, running stop signs and traveling in excess of 50-60mph. The officer had started to slow down after three miles, as the chase had become too dangerous, and Santana had gone over a hill approximately a quarter mile away.

Ramsey said Santana then collided into the rear of another vehicle being driven by a father and his two children, ages eight and five. The father and children were taken to the hospital for treatment. The five-year-old child however suffered major injuries and spent several weeks in the hospital because of the collision. The child is slowly recovering but will have permanent injuries.

Ramsey said Santana fled from her damaged vehicle on foot and remained at large until April 21, 2022, when she was spotted as a passenger in a vehicle by Gridley Police Department. When the car was pulled over by Gridley police, Santana jumped out of the passenger seat of the vehicle and led officers on a foot chase but was quickly chased down and arrested.

Santana plead as charged to all of the criminal conduct alleged in all her cases after an attempt to gain mental health diversion was rejected by a local judge.

Santana will next appear in court on March 30, 2023, where she could potentially be sentenced to 11 years and 8 months in prison. Santana is currently in custody in the Butte County Jail. She has been denied bail.

# Danger Near Cherry Street

GRIDLEY, CA (MPG) - The crossing on Highway 99 and Cherry Str. in Gridley has been the location of many car versus pedestrian accidents. On the evening of March 2nd, another pedestrian was hit.

A 2000 model Toyota Camry was headed northbound on Hwy 99 when the sedan hit the juvenile pedestrian. Gridley Police Department received the emergency call at 8:30 pm, responding along with CALFIRE/Butte Unit/Gridley Fire Department and Butte County EMS personnel.

Images from the scene show the vehicle with a shattered window, caused by the full-impact of the woman's body rolling up the hood and into it. The night obscures whether the vehicle was silver or gold in color and was

allegedly driven by a hispanic male. The woman involved claims she was in the crosswalk, her body thrown up the highway. The vehicle came to rest further north on the roadway near the Huckleberry's Restaurant.

After Gridley Media Group posted pictures of the accident, the woman involved identified herself to the public, but since she is a juvenile, her name is being withheld in this publication. The self-proclaimed victim says that she was crossing in the crosswalk with the safety lights flashing when the vehicle struck her.

The report says that she received moderate injuries and was transported to Enloe Hospital for treatment.

# The New Pi-Line

and got a teaching creden-

tial, fast-tracking himself

This is the 233rd Pi-Line I have written. What does Pi-Line mean? Someone asks me why this column is called the Pi-Line about every other week. I once knew - because Mr. Burleson himself told me after a Planning Commission meeting. The problem is - I forgot what he told me. I asked retired long-time Editor Scotty Williams when he last visited town, and he did not remember either. I have been asking around covertly, and no one seems to know. Then out of the blue, my favorite motherin-law Judy brought me the Friday, October 29, 2010, issue of the Herald, which had a biographical sketch of Bill Burleson. The halfpage treatise describes how Bill got out of the Navy in 1946, went to Chico

State, majored in English,

toward being a High School teacher. Instead of entering academia, he came home to Gridley in 1950 and joined the family business, which was the Gridley Herald. The family did not start him out as Editor, however. He was tasked as the front desk guy, print operator, warehouseman, photographer, bill collector, and delivery guy. The most challenging job he had was as a hand typesetter. He did hot metal typesetting (mechanical typesetting, hot lead typesetting, and hot type). Bill would melt lead to create letters and then assemble lines of type one character at a time to make a metal sheet that went into the printer. Handsetting like this was tedious and time-consuming work. The invention of the Linotype machine made the process a little easier as it melted the letters and lined them up for you. The last edition of the New York Times printed with melted metal type was in 1978; since then, the type has been computer generated and computer printed. The word Pi is a verb. To "Pi" or "Pi up" is to drop a tray or sheet of perfectly lined up letters and cause

all of the letters to be jumbled up. "Pi" is defined as jumbling, mixing up, or randomizing. In 1957 he wrote the first ever Pi-Line. He wanted the column to be light-hearted, upbeat, and supportive of community endeavors. Most of all, he wanted it to be "mixed up" and open to whatever was on his mind - and he wanted it on the front page, which is where it was for more than 45 years.

This background also sheds some light on why the Gridley Herald was the first newspaper in America to go all Apple Macintosh computers for production. Macintosh was the first graphical interface that utilized scalable fonts in a usable way. Knowing what Bill went through setting type with hot lead, one can understand why he would be so enamored with the Mac. He switched from a typewriter to the Macintosh in 1984 and never stopped using a Macintosh until his death at age 78. This column is written on MacBook to

**GRIDLEY, CA (MPG)** - Talented young actors will bring a welcome Night of Comedy to our winter-weary community. Following a Covid break, the GHS One Act Plays return with four short plays for an evening of light-hearted fun.

"The Seussification of Romeo and Juliet" will bring rhyme, humor, and the nuances of Dr.Seuss to the characters and plot of Shakespeare's classic "Romeo and Juliet." Thing One and Thing Two narrate this whimsical reinvention, while the Capitulate and Monotone families act it out. If only Shakespeare and Dr. Seuss had collaborated, this may have been the

Continued from page 1 from the tight entrance. He conveys that rescues in confined spaces are "something special." Procedure dictates that before entering, CALFIRE rescuers monitor the air within the space, checking that is breathable and for any contaminates that could injure them or the patient. If it is not deemed safe, the area would require ventilation. In cases such as this, Captain Costa says their biggest hazard is dust and the organic gases coming off of any decaying materials.

Using a rope system, the patient was retrieved quickly. From the time of the call until the time the patient exited the hole, only 39 minutes had elapsed. Thankfully, no injuries were reported.

Caption Costa wanted to express that Sun West Milling did everything correctly to facilitate the successful and safe rescue of their employee. This included appropriate operating procedures before the incident took place, and safety measures during and after the rescue - specifically keeping the fans on to maintain fresh air flow and any large equipment turned off.

Station 44 is CALFIRE/ Butte County's home base for Technical Rescue. While Gridley's Station 74 responds to many of the water calls as it is the hub of the Swift Water Rescue Team, Station 44 handles rope rescues, confined space rescues and urban search and rescue. "The general public just assumes we fight fire and that's it. But as far as disciplines, we run EMS


calls, technical rescue calls, flooding emergencies – we're an all-risk fire department" says Captain Costa.

Incidentally, Station 44 is currently training this week with Captain Costa teaching a 40-hour rope rescue operation course. Our CALFIRE/Butte County units are constantly honing their skills in order to protect and serve our communities.

# **Local "Storm Chaser" Gets Arrested in Kentucky**

FREEMONT, KY (MPG) - Troopers with Kentucky State Police (KSP), Post 1 responded to the area of Freemont in McCracken County to assist local law enforcement, emergency management, and fire/rescue departments with reports of severe weather damage. KSP Post 1 and McCracken Central Dispatch had received numerous reports of damage to residences and downed trees and power lines blocking roadways.

A command post was established at the Dollar General near the intersection of KY-994 and KY-348. Law enforcement was alerted to a disturbance at the command post. Troopers made contact with Justin A. Stohlman, 41 years old of Gridley, CA, who advised he went around two road closed barricades into the closed disaster area to film for his social media account. It was reported to troopers that Stohlman got into an argument with another person on scene and indicated that he had a firearm. Troopers located a handgun concealed on Stohlman's person. Due to past convictions and federal law (18 U.S.C. 922(g)(9)), Stohlman is prohibited from carrying a concealed deadly weapon.

Stohlman was arrested and charged by KSP with Disorderly Conduct, 2nd degree; Criminal Trespassing, 3rd degree; Disregard Traffic Regulation, 1st offense; and Carrying a Concealed Deadly Weapon. He was transported to and lodged at the McCracken County Jail. The investigation is ongoing by Trooper Propes. ★





# California Farm Bureau Reacts to Groundwater Decisions

California Farm Bureau Press Release

SACRAMENTO, CA (MPG) - California Farm Bureau President Jamie Johansson responded to the California Department of Water Resources announcement on sustainability plans for the state's groundwater basins.

The agency recommended approval of plans for six California groundwater subbasins. It declared six other plans to be "inadequate," which will result in a review by the State Water Resources Control Board.

"This action will trigger a process before the water board that will afford local agencies additional opportunities to address identified problems, regain control of their basins and, hopefully, avoid formal probationary status or the imposition of eventual state interim plans," Johansson said.

"Passage of the Sustainable Groundwater Management Act in the 2014 drought year was a seismic shift in California water," he said. "It was never going to be easy to transition on a timeline of just 20 years to eliminate an estimated 2.5 million acre-feet of overdraft a year in our most impacted areas of the state. Historic droughts in recent years have also shown us that we can't simply continue as we have been, and that California must also invest in a more resilient, 21st-century water system."

Johansson added, "California Farm Bureau will work with state and local agencies, our county Farm Bureaus and our agricultural groundwater users on workable solutions to sustain healthy aquifers. Our groundwater supplies are critical for California farmers, including vegetable, fruit, nut, and dairy producers who account for much of America's food supply. It is important that California carefully consider solutions that protect both our aquifers and our food production."

The California Farm Bureau works to protect family farms and ranches on behalf of nearly 29,000 members statewide and as part of a nationwide network of 5.3 million Farm Bureau members.



Dunn and Rogan both said Spring Training for the Drakes will be May 15th or 16th and fans are welcome to attend.

Dunn expressed that season tickets are \$200 for the reserved seats during the 30 home games Marysville will host throughout the inaugural season.

Dunn added they are trying to apply some sort of reserved parking with the purchase of season tickets. The Drakes will host two exhibition games on May 21-22 against the San Rafael Pacifics and Santa Rosa Scuba Divers before their first official home game of the season on May 25 versus Santa Rosa.

The Drakes are owned by the Pecos League and Dunn told MPG he wants the Drakes to be a big part of the community.

Rogan mentioned that Dunn believed he would be a good fit because the people of Marysville loved baseball with a lot of history

Rogan added he wants the players on his roster to battle everyday.

"I want to make the city proud," Rogan said. "When guys pull for one another, you're going to have a chance at team success."

Marysville held a local tryout in Sacramento in the middle of December. North Highlands resident Jalen Gordon, 23 tried out for the Drakes and made the squad.

Gordon said that he fit the criteria of the Pecos League by being overlooked throughout his career and still had the dream of playing the game he loves.

"It's big for me because I'm still in the range where my family can still come and watch me play and represent North Highlands," Gordon said.

Gordon added his best attribute in baseball is his speed. He said he is a utility player but prefers to play in the outfield.

Rogan and Gordon met for the first time at last week's meet-and-greet. Plenty of smiles between the two lit up the room as they got acquainted with one another.

Gordon is excited to get the season started and mentioned he has met some of his other teammates so far and they are building chemistry on and off the field.

"Baseball is about friendships. I hope to make long-life friendships with these guys," Gordon told MPG. ★
