GRIDLEY, CA (MPG) - On July 15th between 8 and 9 in the evening, patrons of the North American Old Holy Roman Church Utrecht Succession, Gridley Mission confirm that they witnessed what they believe to be a miracle.

mission's focus for their worship.

According 9 testimonies verbally shared with Herald reporters, the event regarding the depiction of Jesus of the Divine Mercy transpired as follows:

The framed print of Jesus of the Divine Mercy was initially seen moving on the wall by a teenage boy. The room was darkened as customary during the Adoration of the Cross Ceremony which was taking place at the time. The young man brought the movement to the attention of the small congregation and Archbishop Castaneda. Witnesses, fourteen of

# **Drive Sober** or Get Pulled Over this **Holiday Season**

SACRAMENTO REGION, CA (MPG) - This holiday season, the California region of Mothers Against Drunk Driving (MADD) is partnering with the National Highway Traffic Safety Administration (NHTSA), California Office of Traffic Safety (OTS) and local law enforcement to share the message about the dangers of drunk driving.

MADD, NHTSA, OTS and local law enforcement partners want all drivers to remember this lifesaving message: Drive Sober or Get Pulled Over. Drivers will see officers working together December 14, 2022, through January 1, 2023, looking for drivers suspected of being under the influence of alcohol and/or drugs.

The holidays are one of the most dangerous times on our nation's roadways as more people travel to celebrate with friends and family. According to NHTSA, California had the largest increase of any state in the number of lives lost in alcohol-impaired driving crashes in 2020 – an alarming 20% increase in the number of fatalities from 2019 to 2020. During the month of December 2020, 937 people were killed in alcohol-related crashes, accounting for 29% of all traffic deaths. This is why MADD is working with local law enforcement to remind the public that drunk driving is not only illegal, it is a matter of life and death. As you head out to the holiday festivities, remember: Drive Sober or Get Pulled Over.

"We know everyone is rushing around during the weeks leading up to the holidays, preparing for holiday gatherings and getting into the seasonal mood,' said Patricia Rillera, MADD California State Executive Director. "If you plan to head out to festivities, make sure you plan a sober ride home because driving drunk should never be an option. Even one drink is one drink too many if you're the driver." Rillera said.

# **Understand the Risks**

Nationally, it is illegal to drive with a BAC of .08 or higher. If you're caught drinking and driving you could face jail time, lose your driver's license and your vehicle, and pay up to \$22,000 in attorney's fees, fines, higher insurance rates, and lost wages, according to the Automobile Club of Southern California.

# Chief of Police Pleased with Cooperation **During Bomb Threat Investigation**

Press Release from Police Chief Rodney Harr

GRIDLEY, CA (MPG) - On Friday, December 16, 2022, at approximately 11:12 am, the Gridley Police Department was notified of a possible bomb threat at the Gridley High School (GHS) campus, located at 300 East Spruce Street in Gridley. The location houses 9th through 12th grade students as well as additional staff and faculty members.

After the initial evacuation of students, staff and faculty from the immediate campus, Officers with the Gridley Police Department, members of the Butte County Inter-Agency Bomb Squad and GHS Administrative staff conducted an extensive search of the school grounds and classrooms for any suspicious packages or other devices.

No such packages or devices were located.

At approximately 1:13 pm, the campus was declared to be safe allowing students, staff, and faculty to return to campus.

Gridley Police Department Officers, with the assistance of GHS Administrative Staff, conducted a thorough investigation into the reported bomb threat. During the investigation, a 15-year-old juvenile suspect was identified. The suspect was subsequently

detained, arrested and later booked into the Butte County Juvenile Hall for violation of one (1) count of section 148.1(c) of the California Penal Code (reporting a false bomb threat to any person). Based upon the age of the juvenile, the name will not be released.

Incidents such as these are of the highest priority for the Gridley Police Department and will have the appropriate resolution for the protection of not only the Gridley Unified School District students, staff, and faculty members, but for all the members of the Gridley Community. It is with the cooperation of everyone that incidents such as these are resolved in a timely and just manner.

The Gridley Police Department would like to highlight that the relationship with GHS Administration, Staff and Faculty Members was a key component to the quick resolution of this investigation. I would also like to thank members of the Butte County Inter-Agency Bomb Squad for their very rapid response and assistance with this incident.

Continued from page 1 them, report seeing the image moving slowly at first, then faster in a more dramatic pendulum motion. Multiple onlookers saw red sparks appear, glimmering around Christ's head, while his halo began to glow. As the light radiating from the halo intensified, the red and blue-white rays issuing from Jesus's heart in the image also began to illuminate with brightly colored light. A visitor to the congregation reportedly began speaking in tongues, crying softly. As the alleged manifestations continued, those in attendance saw other miraculous events transpire.

Archbishop Ivan Castaneda reported seeing Jesus's eyes opening and closing. Others, such as Mother Fatima Jerez, saw Christ's right hand, raised in the depiction of the image, making the sign of the cross blessing those that had gathered around in awe of the celestial display. Archbishop Castaneda

confirms he also witnessed this. Eventually, the swinging of the portrait slowly ceased, the light faded, and the image returned to its natural state. The occurrence reportedly lasted around 15 minutes, but due to a state of shock, none recorded the exact time of the phenomenon.

Since July, 14 witnesses that range from ages 7 on up, have undergone the process of having their personal statements transcribed, translated from Spanish to English in some cases, and have had them notarized to properly document the incident. A second manifestation has also been recorded via video, which captured the same picture moving and radiating the image of a cross. The video has joined the compilation of evidence to chronicle these holy events.

In recognition of such a significant event, the 14 parishioners in attendance that July evening have signed the back of the image, and a special

mass was held to bless and consecrate the depiction of Jesus the Divine Mercy as Patron of the entire North American Old Holy Roman Church Utrecht Succession. The picture was moved in early November to the Jesus El Buen Pastor Church in San Bruno, California as it is now considered to be a sacred item and Patrimony of the Archdiocese. Four parishioners in San Bruno claim to have seen it illuminate in the same manner as in Gridley, but not swing as it had done while here.

Archbishop Castaneda tells the Herald that "after a lot of praying and debate," the congregation decided to publicize the happening. "We were very hesitant to go public," says Archbishop Castaneda. He sought counsel from an outside pastor, who helped him come to the decision that it should be shared with the world, "because maybe he (Jesus) has a message for his people."

The Church wished to announce the event much earlier but wanted proper documentation in place before doing so. A series of events have prevented the publishing of the account until now.

When confronted with

the issue of doubters, disbelievers and that they may be mocked by their community, the witnesses young and old held firm to their declarations. Not one retracted their statements, and it remains clear that they believe what they saw truly happened. Archbishop Castaneda confirms, "We did not make this up and, so I need to be strong and say, well, this is the truth. This is what happened." He continues, "We're not sure why it happened, but it did happen."

Attempts at recreating the events have been unsuccessful – for those involved, all signs point to the divine.

Archbishop Castaneda shares that he's come to this conclusion about the event and his small parish: They might be a small church, a small congregation, nothing "special" about themselves in their eyes, but that God ultimately decides whom he will speak to, when, and how he will inspire.

# Bill to Prevent FEMA Clawbacks of Disaster Aid to Become Law

WASHINGTON, D.C. (MPG) - The week of December 19, 2022, legislation crafted by Representative Doug LaMalfa (R - Richvale) to prevent the Federal Emergency Management Agency (FEMA) from taking back disaster assistance funds that it considers duplicative with legal settlement claims will be signed into law. H.R. 539, the Preventing Disaster Revictimization Act, was a joint effort between Representative LaMalfa and Transportation and Infrastructure Committee lead Republican Sam Graves (R-MO), who sponsored the bill. Despite the work of Congressmen LaMalfa and Graves to get the legislation unanimously passed out of the U.S. House of Representatives in June 2021, the Senate had not passed the bill until it was included in the National Defense Authorization Act last week.

"There are thousands of victims of wildfires in Northern California and even more across the nation who are reeling after natural disasters," said Rep. LaMalfa.

"They are applying for federal assistance in good faith to help them rebuild

their lives and they shouldn't be punished for FEMA's mistakes. In the aftermath of a wildfire, tornado, flood, earthquake, or other disaster, people's focus is on rebuilding their lives. The federal government should be helping them, not seizing money because of bureaucratic mistakes and revictimizing them all over again."

H.R. 539 also includes a provision crafted by Representative Sam Graves to require that FEMA waives debts related to disaster assistance for recipients when the agency later determines it mistakenly overpaid them. Under current law, FEMA can come back weeks, months, or even years later to seek repayment of funds it awarded victims, even when the agency is at fault for making the error and the funds were appropriately used in the wake of a disaster. The bill also requires FEMA to report to Congress on its efforts to minimize similar errors in the future.

Congressman Doug LaMalfa is a lifelong farmer representing California's First Congressional District, including Butte, Glenn, Lassen, Modoc, Nevada, Placer, Plumas, Shasta, Sierra, Siskiyou and Tehama Counties.

the pictures hanging on Santa's bedroom walls are of Todd's family and grandchildren, a letter to Santa signed by her great grandchild Mason.

The Christmas dollhouse features three stories on one side and two on the other – looking directly at it the left gives viewers a glimpse into Santa's private life, while the other three storied side provides a look at the hustle and bustle of the workshop and mischievous lives of his elves. The tiny details permeate through the whole piece, with bins of toys marked to be delivered to Gridley and Biggs, tufting on the couches, and more.

She began work on the project in January of this year. The Christmas dollhouse evolved from a small idea – "I didn't intend to start making the dollhouse," says Todd, explaining that her mind was focused on rebuilding and refurbishing the wooden display pieces featured at the Biggs Community Park during the holiday season. She mused about incorporating a 3D effect, painting a

scene behind glass or plastic and using the wood to frame it to suggest you were looking inside something multi-dimensional. Instead of displays at the park, her design grew into a fabulous window display for the Colonia, the Christmas Dollhouse.

Todd claims, "I knew nothing about wood," but persevered learning from her "mistakes". Her design wasn't to the scale of other dollhouses, so she had to be innovative, adjusting her Santa to the right height by chopping off their legs and making them longer with wood. Of the Santa reclining, she says, "I thought if he's sitting down in the chair, he needs to be comfortable. So, I cut his boots off his legs and stacked them by the fireplace, so they'd be warmed by the fireplace, then took some old cloth napkins I had and made sock-like-things and stuffed them in the legs (of his suit). Now he's sitting there reading his notes in his socks!"

The elaborate and not-to-miss Christmas Dollhouse is currently on display at the Colonia Hotel, located at 479 B Street Biggs. ★

# Be Wary of Latest Inflation Statistics

Fed Chief Jerome Powell sobered up Wall Street yet again last week during his latest periodic Federal Reserve (FED) speech and news conference. As Wall Street attempted to get some sort of "pivot" sign out the tea leaves of his musings, no such inkling of a softer FED was to be found. Pivot means to stop raising rates and pivot to the other direction, which in this case would be back down.

Instead, stone faced and dead serious as always, Powell once again splashed his monetary bucket of ice water all over those listening, which by the way, is just about everybody these days.

Although recent economic statistics have shown a tiny bit of pullback in certain economic metrics, the real story is inflation is still north of 7%, and that is more than double the 30 year average.

Seven years of an inflation rate that high and you might as well throw half your money in the trash can. Yes, the math works out that badly.

Wall Street has had some giddy rallies here and there, as tiny glimmers of hope in inflation readings every now and then enticed buyers into the markets

The latest Consumer Price Index (CPI) showed a slight drop in the prices it measures and with the bad news bears pretty much taking over the stock market lately, any signs that things may be improving send stocks rallying, albeit if only briefly.

One only has to dig a little deeper into inflation statistics however, to see all is still not well in inflation-land.

CPI measures the prices consumers pay using a select basket of goods over time. Sounds accurate enough but the CPI does not tell the whole picture.

The Producer Price Index (PPI) measures costs further upstream at the producer level which are the people that make the stuff the consumer then buys down the line. It's a peek into the prices consumers will pay (the CPI number) sometime in the future as produced goods trickle down the supply conduits to store shelves.

Like the CPI, the latest PPI report also showed a small drop in year over year inflation. But comparing the PPI to historical norms, food inflation soared to a 12 year high, led by a shocking 38% surge in fresh and dry vegetable costs. The Christmas dinner might be a tad smaller this year for many folks and not by choice but rather by necessity.

Making matters worse, there is a "core" government expected at .4% month over 530-559-1214.

month vs. the .2% expected.

Producer inflation costs eventually get directly passed on to who?

Because Jerome Powell and his minions at the Fed are well aware the inflation at the producer level is a precursor to inflation at your local store, the Fed won't back off anytime soon on its raising rates crusade, and will likely keep rates high much longer than Wall Street expects.

What the Fed also knows is its history. You have to scroll back to the 1970's when the Fed faced inflation of a similar magnitude.

In the early 70's, then Fed Chief Arthur Burns raised rates and smashed their near double digit inflation, only to soon thereafter bow to political pressure and quickly lower rates again.

Inflation returned with a vengeance and then some and reached dizzying new heights by the late 70's.

Whoops.

Newly appointed Fed Chief Paul Volker found out in very short order he had to jack Fed rates to 20% in March of 1980 to get the job done and bring prices back

The current Fed rate is 4.5%.

Can you imagine what would happen if 20% rates were the required medicine

I actually can't imagine, it would be that

In conclusion, Fed Chief Powell knows his history. Although today's Fed actions are smashing the market and will soon smash the consumer right along with it, he knows not raising rates high enough and not keeping there long enough, could spell a disaster of unprecedented levels.


No, Jerome Powell nor his Fed will pivot anytime soon Wall Street. It will likely be a very long time before he even thinks it.

The best fishing was found at the Hat Creek inlet, to the Crystal Lake Hatchery. Burr! It was cold. The intermediate line, 9ft fluorocarbon leader and 3ft tippet all froze in the rods tip-top guide. So we had to stop fishing every half hour to clear the ice particles. Our #14 Pheasant Tail Nymphs worked well, as falling spinners covered the lake surface. The best bait was the lowly Scud.


# **Traveling for the Holidays? Be Prepared**



# Districts are Run Well?

Gov. Gavin Newsom is fond of characterizing his global — model in all things good, from economic clout to fighting climate change.

One conspicuous absence on his list of California's virtues is its public education system, for good reason.

In statewide and nationwide tests of K-12 academic achievement, California lags badly behind. Learning is especially deficient among children from poor famother states.

To the extent that this educational crisis receives any attention in the state Capitol, the discussion is almost always confined to money, on the fanciful notion that spending more will automatically increase academic attainment.

One reason money doesn't solve the problem is that the state provides very little oversight on how the money is spent, including the extra funds that local school systems receive specifically to close the achievement gap. State education officials intervene only when local insolvency.

Some school districts spend their money wisely don't and outcomes largely hinge on the quality of their governance. Those with engaged and committed boards and administrators tend to have better outcomes than those with inconsistent, politics-driven and often chaotic governance.

That's why a massive effort to judge how well California's local school systems are structured and managed is welcome.

Arun Ramanathan, state as a national — or even CEO of Pivot Learning, an Oakland-based non-profit organization that advises school systems on improving instruction, created a series of benchmarks to gauge how well school districts are prepared to embrace reforms. He also created a website that allows the public to view the results for every school district with at least 2,500

"Despite billions in investilies, but even kids from ment and decades of effort, affluent California families new reform efforts rarely tend to lag behind those in have intended impacts at the district, school and classroom level, and sustained improvement is rare," Ramanathan told EdSource, a website of education journalism. "There are rarely insights into why. The District Readiness Index resulted from that questioning."

The ratings cover five "domains" - community relations, finance, leadership, personnel policies and workplace conditions. Users can see how the districts score in each, with overall ratings designated by colors. Blue is the best, yellow is in the middle and orange is the worst.

The grading process systems are flirting with resulted in about half of the 420 districts getting yellow grades and about 40% blue marks with roughly two and effectively and some dozen placed in the orange

category, meaning they have "few foundations" for achieving needed reforms.

Some of the state's largest districts are colored orange, including Los Angeles Unified, whose enrollment approaches 10% of the state's 6 million public school students.

It's not surprising that LA Unified, Oakland Unified, San Francisco Unified and Sacramento Unified received low marks because all have been in constant political turmoil and financial distress of their own making.

Three of the large districts San Diego Unified, Elk Grove Unified and San Juan Unified – escaped the orange designation and are marked as yellow.

A few large districts achieved blue status for being well prepared, including Fresno Unified, Long Beach Unified and San Bernardino Unified. But most of the blue districts tend to be either in affluent suburbs – no surprise there – or in rural areas.

Most interestingly, the blue list includes a number of districts with large numbers of poor students, such as Brawley and Calexico in poverty stricken Imperial County.

The District Readiness Index provides new ammunition for the school reform movement in California, which seeks to elevate students' welfare over the petty politics, particularly in Los Angeles Unified and other large districts, that sabotage their educations.

LIVE OAK, CA (MPG) - The Gridley girls varsity basketball team's stellar defense held off a late second half push from the Live Oak Lions in a 49-32 victory on Wednesday, December 13.

Gridley (6-3) prevented what would've been a three-game losing streak with the wire-to-wire win over Live Oak.

Lady Bulldogs head coach Becca McCray mentioned to The Herald that there was a team meeting after the conclusion of their last tournament at Oroville.

"We turned around and looked like a whole new team," McCray said.

She added that they played great team ball, and their defense was efficient. Whether it was picking up defenders with full-court pressure, slapping the ball off the dribble in the half-court or blocking shots, the Gridley defense made Live Oak struggle.

The Lady Lions struggled on the court in the first half, but also were limited when it came to reserves as only eight players were in the home whites for Live Oak. Lady Lions head coach Sharonda Watson explained to The Herald that everyone on the bench knows their role.

"They're gonna come in and contribute to what is needed for the team," Watson said.

Live Oak (5-2) trailed 26-6 at the end of the first half.

With Gridley and Live Oak being seven miles from each other in driving distance down Highway 99, the game was a big deal Tuesday night. Cota was asked and pulled away a couple of times for team pictures throughout her interview with The Herald in the Live Oak

All eight soccer and basketball teams combined between Gridley and Live Oak played one another on Tuesday. Cota mentioned to The Herald that both soccer teams fell to Live Oak, so it was nice to get a little revenge for their soccer friends. The Gridley boys basketball team also won, which made it an even split on the day for both schools.

The Lady Lions did outscore the Lady Bulldogs in the second half 26-23 and were led by senior forward Annalese Contreras with a team-high 16 points. Live Oak is competing in the Orland tournament this weekend where they picked up another win over Los Molinos on Thursday night.

Watson exclaimed to The Herald that her hope is to focus on rebounding the ball and boxing out this weekend as she added that they can get their high-quality shots on the offensive end.

The Lady Bulldogs are competing in the Sutter tournament this weekend with their first matchup against Placer. McCray told the Herald after the conclusion of the Live Oak game that Placer was going to be a good test for Gridley.
















# Local Middle Schools Boost CHFFA Toy Drive

The toy drive has ended for this year – these helpful little elves having delivered their gifts to the agency – ensured that Santa will be able to surprise hopeful children




