Gridley Titans Search for Information on Attack

GRIDLEY, CA (MPG) - Gridley's Titans organization released a statement on Facebook Monday, November 14th after an incident involving one of the organization's Coaches after the All-Star game held Saturday.

Here is the full statement:

"Good Morning, As many of you know our SYF all star football game was this past Saturday on November 12th at the Sacramento State University stadium.

Unfortunately at the conclusion of the 10U game and the start of the 12U game, one of our coaches was attacked under the visitor's side bleachers near the women's restroom (south end of the bleachers). Coach Tony Luquin was knocked unconscious and left lying on the ground before others found him and came to his aid. Coach Tony was later transported to the UC Davis hospital where he received medical care and was ultimately released from the hospital hours later. He is recovering well after sustaining a concussion and additional injuries. We are asking for anyone who saw anything related to this incident, either moments before, the attack itself, or anything relevant following this incident to please come forward with that information. This event was supposed to be a family event and it's sad we have to send out this message, but those responsible need to be held accountable. If you have any information or have witnessed anything related to this incident, please contact Sacramento State University's Police Officer Ramie Folena at 916-278-6000 or via email at r.folena@csus.edu in reference to case # 22-702. We appreciate your cooperation and thank you in advance doing the right thing."

The Herald reached out to the Sacramento State Police Department for more information and was told that the incident is currently under investigation. They were unable to share any other information at this time. ★

Swimming at the Masters

GRIDLEY, CA (MPG) -After putting away a strong season, Gridley High School Swim Team was invited to participate at the Masters Meet at Shasta College.

Coach Monica Terry says that the Masters Swim Meet invites the "cream of the crop" swimmers from Division 1 and Division 2, pitting the top 16 swimmers against each other in their designated divisions.

After her gentlemen swimmers took 1st place and her ladies 2nd place in the BVL Championship, the team moved on to Div 1 and Div 2 Championships held October 26, 2022 in Durham. The ladies would place 6th out of 12 teams with 132 points. They would swim against 11 teams from 3 separate leagues – the BVL (Gridley), EAL and NAL. The boys would also swim against teams from the leagues, placing 4th out of 18 teams, with an overall

Not every state allows citizens to be the legislature, but California has in the constitution, the referendum, the initiative, and the recall powers. This last election included seven questions for voters - referred to as propositions. Proposition 1, which was placed on the ballot by the legislature, got a 65% yes vote to amend the state constitution. Propositions 26,

27, 28, 29, and 30 were put on the ballot by people or groups who gathered enough voter signatures to get their policy issue up for a vote. Out of those five, the only one passed was dedicating more already existing education funding to arts and music. The Gambling measures and unionizing dialysis treatment failed. Proposition 31 was a measure banning flavored tobacco that was a referendum, meaning the legislature passed the ban, and enough people signed petitions to put the decision of the parliament in front of the people. So the law that was passed was upheld. So it was a big year for direct democracy. A constitutional amendment, a referendum, and some initiatives. We are

all qualified (if you voted) to add legislator to our resumes for the next time we go out into the job market. California is unique in allowing the voters such direct power, and no one can say we have been hoodwinked. Some measures pass, and some fail based on how well they appeal to the people. If the time ever comes where it's - always yes, and they all pass, or it is all no, and they don't, it would be a sign that voters are not really thinking when they play legislator. The results this year made it pretty clear where the majority stands on the issues of 2022

For the ladies' individual events, first time swimmer and sophomore Sid Allard placed 7th in the girls 100-yard breaststroke, with her personal best time of the season, 1:22.39.

Evie LaBuff, a Freshman at GHS, would compete in two individual events, the girls 100-yard butterfly in which she would take 13th place and the girls 500-yard freestyle, in which she would place 16th.

Swimming for the GHS Boys in individual events, sophomore, and 2nd year swimmer, Jace Lewellen took 11th place in the boys 100-yard backstroke.

Billy Routon would swim the boys 100-yard butterfly at a blistering speed of 57:08, earning him 3rd place overall and would again place 3rd for his boys 500-yard freestyle 5:27:38.

The individual swimmers would join their teammates for the relay swim portion of the event.

Swimming the girls 200 medley relay and placing 10th were Brynna, Allard, Evie LaBuff and Annie Woods. For the girls 200 freestyle relay, Allard, Gallagher, Brynna and Ellie Woods would represent GHS. Both relay teams would place 10th. Moving up in the bracket for 8th place for the girls 400 freestyle were LaBuff, Gallagher, Annie Woods and Adams.

Swimming for GHS in the boys 200 medley relay, Lewellen, Routon, Soares, and Solander placed 10th overall. The boys 200 freestyle team comprised of Yahuaca, Rogers, Solander and Lewellen took 11th place. Wrapping up the relays, the boys 400

freestyle was swum by Yahuaca, Soares, Rogers and Routon for an outstanding 8th place.

Overall, the GHS girls swim team placed 10th out of 15 schools. The GHS boys had an outstanding swim at Masters, placing 9th out of 21 schools.

With gifted individual swimmers and a team full of talent, GHS Swim has taken major strides towards greatness. Their efforts were acknowledged at an awards night held after the teams had time to recoup from Masters. Coach Terry praised her entire team, refusing to single any one swimmer out above another, but recognizing that she had some truly amazing athletes on her team.

Aaron Rogers would receive the MVP/Bulldog Award. The Breakout

Swimmer Award, which was bestowed on individual swimmers selected to participate at Masters, went to Sid Allard, Evie LaBuff, Billy Routon and Jace Lewellen. At that time, the boys' teams received their BVL Undeclared Season plaques. Luke Soares received the Star Swimmer Award, Nico Donati the Knowledge Award, Harper Solander the Most Spirited and Nate Yahuaca Most Improved. Ellie Woods received the Star Swimmer Award for the ladies, Phoenix Brynna received Most Spirited, Hope Gallagher and Annie Woods received the Living in the Water award, and Most Improved went to Jasmine Johnson. The Teamwork Award went to: Audrey Beck, Gemma Donati, Earline Adams, and Zoey Williams. ★

A Story of History: Gridley WWII Vet Speaks

GRIDLEY, CA (MPG) - This Veterans Day, the Gridley Museum held a special event with guest of honor, Gridley’s Francis ‘Frank’ Heinrich.

Frank was invited by the Museum to speak about his and his family’s military service during WWII.

As attendees and family circulated through the museum, Frank was found sitting in a ring of chairs, informally sharing intimate conversations with those that came to hear his stories. It was clear that a sharp mind remained behind the 100-year-old veteran’s bright blue eyes and Frank was easily able to recount details to his listeners. While he spoke about his own service, he recounted much of his brothers’ experiences.

The Heinrich family from Live Oak included 11 children. Frank was one of five Heinrich brothers that would serve active duty during WWII: William (Bill), Charles (Charlie), Robert (Bob) and himself. Two of his other brothers would also serve: Brother Richard was drafted into service in WWII and brother Harold, who was found medically unfit for service during that time, would recover and serve in the Korean War.

During WWII, Bill was the first to be drafted into service. His service in the Army kept him stateside, primarily serving in Texas where he worked with Army Hospitals.

Frank’s brothers Charlie and Bob would have much different experiences.

Frank told the Herald that Charlie enlisted in the U.S. Navy and served on the USS Helena. During the Battle of Kula Gulf, March 1943, the USS Helena would fight Japanese destroyers. Reportedly, the enemy hit the ship with three torpedoes, breaking it into three

parts and sinking her. Frank recounts the story of Charlie, who jumped off the ship into waters flooded with oil as the ship went down.

The Navy would write their mother, Katherine, providing her with a copy of what would equate to a press release about the loss of the USS Helena after so many asked for information about its demise. It comfortingly

read, “It is believed that you will find strength and peace in the knowledge that the gallant fight waged by the officers and men of the USS Helena against great odds was in keeping with the finest traditions of the Navy.”

A copy of the letter and press release joined other military memorabilia and family photos as part of a display on the Heinrich Family.

Thankfully, Charlie was not one of those killed in action that day. Although he was lost for about 2 weeks, Charlie would be retrieved by Navy submarine after being harbored by friendly natives on nearby islands. Franks shares that out of a crew of about 1,100 on the USS Helena, Charlie was one of 450 that survived the attack. Charlie was awarded the Purple

Heart for his injuries.

Frank’s brother Bob would also experience heavy combat. He was drafted into the Army and landed on Omaha Beach in Normandy, France 6 days after D-Day. According to the Department of Defense D-Day fact sheet, the landing at Omaha Beach was part of a massive amphibious invasion of a 50-mile stretch of coast in France called Operation Neptune (assault phase of Operation Overlord) that began on D-Day, June 6th of 1944. Out of the multiple beaches stormed during that 24-day operation, Omaha reportedly had the highest casualties. Bob would persevere and spend most of the war in Germany and France. He was eventually awarded the Bronze Star and was discharged from the Army as a Captain.

It seems common for WWII Veterans to be hesitant to share their war stories. Frank agreed that this is a trend among his generation. Of course, Frank remained humble and lightly touched on his position with the Coast Guard (Navy) during WWII. Part of his service involved hauling troops on a Navy troop transport across the seas. He sailed the Pacific, Caribbean, Atlantic and Mediterranean seas, downplaying his role in the war and reflecting his modest nature. When asked, he would delve into more detail and conversations would evolve, guests recalling details of their own family members’ service during WWII and other battles.

Listening to Frank was awe inspiring, fascinating, and yet solemn. For 6 of 7 brothers to serve the nation during war is a statement of their valiant patriotism. The fact that they all returned home alive could be considered a miracle.

Thank you to all our veterans that have served. ★



Motorists Transition to Newly Constructed Roadway on Highway 70

YUBA COUNTY, CA (MPG) - Caltrans is alerting motorists that crews have shifted traffic to a newly constructed segment of roadway on State Highway 70 between Laurellen Road and Woodruff Lane north of Marysville.

Motorists should be alert for equipment and crews working along the roadway as traffic is shifted to allow crews to start roadwork on the opposite side of the highway.

Caltrans reminds motorists the construction zone speed limit has been reduced to 45 mph between Laurellen Road in Yuba County and East Gridley Road in Butte County, where a separate construction project is underway.

The work is part of a \$131 million Yuba County project which will widen and pave the shoulders to 8 feet, provide a

14-foot-wide two-way left turn lane, continuous passing lanes and 6-foot-wide unpaved shoulders for slow-moving farm equipment. The project will also straighten some curves to improve sight distance, improve culverts, repave the roadway and create a 20-foot clear recovery zone for errant drivers to return their vehicle safely to the roadway.

DeSilva Gates Construction of Dublin, Alameda County, is the prime contractor. Completion is targeted for December 2023. The schedule is subject to change due to weather, availability of equipment and/or materials or other construction-related issues.

Chico High Track Attacker Sentenced

BUTTE COUNTY, CA (MPG) - The 14-year-old male juvenile who attacked a 71-year-old woman walking on the Chico High School track in June of 2022 was in Butte County Juvenile Court on November 9, 2022, to be sentenced. The teenager had previously admitted to an attempted first-degree murder charge. He received the maximum sentence of four years, six months in juvenile hall.

The juvenile court judge noted the sentence, the maximum under current California law, was “woefully inadequate” given the vicious and remorseless attack on the elderly woman. The judge additionally found the teenager was on juvenile probation at the time of the attack for convictions of vehicle theft, unlawful 911 calls, vandalism, theft, and receiving stolen property.

The teenager told a court-appointed psychologist that he really didn’t remember the attack because he had ingested marijuana and Xanax and blacked out. The judge during the sentencing stated he did not believe the juvenile’s excuse. The psychologist reported the juvenile displayed no remorse from the time of the attack until his sentencing and offered a diagnosis that the juvenile suffered from an antisocial personality disorder.

Butte County District Attorney Mike Ramsey said the victim, who is disabled from brain and other injuries, is not being identified to protect her privacy. Family members took the woman to live with them in the eastern U.S. to assist with her expected long-term and difficult recovery. The victim’s daughter sent a letter to the court expressing how her parent’s previously active and engaged life was shattered and that she is now a shell of her former self.

Ramsey said the victim was walking on the Chico High School track around 11:00 p.m. after the Chico High School graduation ceremony that took place on June 2, 2022. The victim reportedly regularly exercised on the track.

The teenager snuck up on the lone woman from behind and struck her in the upper body with a fence T-post causing serious injuries and a brain bleed. After the attack, he dragged the victim to a corner of the field where she was strangled and left unconscious. The juvenile then leisurely left the area. His actions were captured on nearby video surveillance.

Ramsey said the victim at some point regained consciousness and dragged herself into a bathroom on the field where she was found by high school custodians at about 6:30 a.m. the next morning.

Ramsey noted recent legislative changes to California law prohibit juveniles under the age of 16 from being tried as adults. In addition to the attempted murder count, Ramsey said the juvenile also admitted an additional allegation of using a weapon (the T-post) and another allegation of causing great bodily injury to an elder. He was sentenced to the maximum term of four years, six months to be served at the new “Commitment to Success Program” at the Butte County Juvenile Hall.

Ramsey explained the juvenile was to be incarcerated locally because there is currently no other option for maximum incarceration for serious crimes committed by juveniles and tried as juveniles in California. The California Youth Authority (CYA) was eliminated by the legislature in 2005 and in its place, the Department of Juvenile Justice (DJJ) was created. However, the closure of the Department of Juvenile Justice was announced on May 19, 2020, and was phased out, not accepting any new commitments from the state’s juvenile courts in June 2021. It will be fully shut down on June 30, 2023, making all serious juvenile offenders the sole responsibility of the local counties.

Ramsey noted: “Despite popular myth, CYA and then DJJ, have not been “Gladiator Schools” for the past two decades. These state institutions had the most cutting-edge and scientifically-validated rehab programs for youth in the nation. A troubled and dangerous youth had the resources of these state institutions as the best chance at rehabilitation during the limited time that a juvenile is subject to the juvenile court’s jurisdiction. Unfortunately, the legislature and the governor closed these state institutions to our most dangerous youths last year.

However, the Butte County Probation Department, which runs the local juvenile hall, has along with local criminal justice partners, begun an effort to turn our local Juvenile Hall into a higher security facility that will attempt to replicate the DJJ rehab programs for extremely dangerous youth locally. It will be a work in progress.” ★

Could the Ocean Slake California’s Thirst?

“Water, water, every where, And all the boards did shrink; Water, water, every where, Nor any drop to drink.”

Poet Samuel Taylor Coleridge penned those words in his 1798 poem, “The Rime of the Ancient Mariner,” to describe the plight of becalmed sailors who could die of thirst while surrounded by limitless expanses of undrinkable seawater.

In a way, it also describes California’s plight. Despite its 3,427 miles of Pacific Ocean coastline, including bays, inlets and tidal marshes, the state has an ever-widening gap between its demand for water and its supply.

Naturally, there has been a decades-long debate over whether the state should tap into that endless supply of seawater to bridge the gap, emulating other arid and semi-arid societies, particularly in Australia and the Mideast.

From a technical standpoint, it’s a no-brainer. Desalination plants, including a few already operating in California, do exactly what they are supposed to do — strip the salt from seawater, converting it into freshwater suitable for drinking or any other purpose. The barriers to

building dozens of desalination plants along the coast are economic, environmental and political.

Such plants require oodles of electrical power to pump in the seawater, push it through filters that remove the salt and then return the uber-salty brine waste either to the sea or into another process.

A massive desal program would place a new burden on a power grid that already struggles to keep up with demand on very hot days as it evolves from natural gas-fired power plants to renewable sources such as wind and solar. Desal’s power demand also contributes heavily to the bottom line costs of producing water, making it more expensive, at least so far, than water from other sources.

Finally, environmental groups have generally opposed desal projects on assertions that pumping seawater into the plants and returning brine to the sea run the risk of damaging delicate marine ecosystems. But the groups have another, unspoken reason for opposition. Restricted water supplies have been used as a tool to oppose new residential development and increasing water supply undercuts that political tool.

In combination, all of those points were cited in the California Coastal Commission’s rejection of a much-debated desal project at Huntington Beach in Orange County earlier this year. The plant would have been a near-clone of a desal facility in Carlsbad, further south along the coast.

At the time, it appeared

to be a death knell for the expansion of desalination in California — something that Gov. Gavin Newsom’s administration envisions in its overall plan for closing the demand/supply gap as climate change and semi-perpetual drought diminish traditional supplies from winter rains and snowfall.

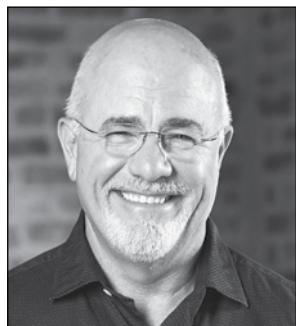
However, last month the Coastal Commission approved another Orange County desal project, one that would use somewhat different technology to pump in seawater and dilute the leftover brine before returning it to the sea.

Environmental groups gave their blessing to the Dana Point project, which made a big difference in the Coastal Commission’s attitude, as is the fact that it’s only one-tenth the size of the Huntington Beach project and would serve purely local customers of the South Coast Water District.

The approval was an indication that desalination could, as the state’s water plan envisions, play a significant role in California’s water future, which will be much different than its abundant past.

That said, desal probably wouldn’t be the silver bullet of limitless supply that some have hoped it would be. It would be more of a reliability factor, something that Californians could depend on working when traditional supplies fall short.

I’ve been in the real estate business since 1978, and I’ve never seen anything like it. Usually, it takes about 90 days to sell a house. You’ll get some offers, and none of them will be at full price, but everyone will have time to think about things. That’s normal, and it’s probably a lot closer to how things will work themselves out for you now in Greenville.

But in any economy, my advice to you would be don’t buy another house until yours has sold. If you end up with two house payments and your old house is sitting empty while you’re having to pay for the mortgage, taxes, utilities and all

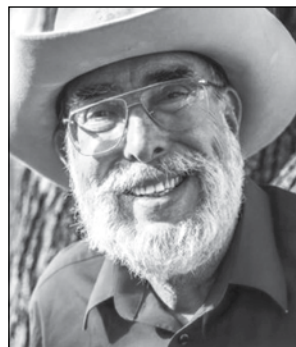
the upkeep to make sure it’s ready to show, you’re going to become what’s known as a motivated seller. I don’t want you to just give it away, but you’ll need to be very careful to make sure the timing on this deal makes sense.

Personally, I wouldn’t buy another house until the first one sells.

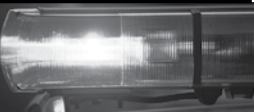

Gridley Resident Arrested for Murder



BCSO News Release

BUTTE COUNTY, CA (MPG) - On July 8, 2022, at approximately 8:09 P.M. the Butte County Sheriff's Office (BCSO) began receiving multiple phone calls about shots being fired in the area of

Esperanza Avenue, Palermo. BCSO deputies immediately responded to the area. Upon arrival, deputies located two individuals who had been shot.

Detectives, deputies, and medical personnel moved the individuals who had been shot to a safe location and immediately began providing medical treatment. Detectives determined multiple individuals fled the area on foot and in vehicles.

During the investigation, detectives determined a male who resides in the 1900 block of Esperanza Avenue, made arrangements to sell multiple pounds of marijuana at

his residence on the evening of July 8. A group of several males showed up at the residence to purchase the marijuana. Detectives determined at least two members of the group purchasing the marijuana reside on the East Coast. Both groups were armed with firearms. Shortly after 8:00 P.M. multiple shots were fired.

During the shooting, the homeowner was grazed by a bullet. The homeowner was transported to a local hospital where he was treated and later released. A male who detectives identified as Russlane Reynolds, age 31, was associated with the group

purchasing the marijuana.

Russlane was transported to a local hospital. Despite the life-savings efforts provided by deputies, EMS, and medical personnel, Russlane died shortly after arriving at the hospital.

The homeowner's residence, two vehicles, and a motorhome were struck by bullets during the shooting. Over the past four months detectives conducted an extensive investigation. During the investigation, detectives located evidence that gave them cause to believe Juan Rodriguez-Gil, age 29, of Gridley murdered Russlane. Detectives obtained an arrest

warrant for Rodriguez-Gil. Detectives located evidence Rodriguez-Gil fled to Mexico after the shooting.

On November 7, 2022, U.S. Custom and Border Protection agents arrested Rodriguez-Gil after he attempted to re-enter California. Detectives responded to the Mexico/California border and transported Rodriguez-Gil to Butte County. Rodriguez-Gil was subsequently booked into the Butte County Jail. The Sheriff's Office is asking anyone with additional information about this investigation to contact detectives at 530-538-7671. ★

BCSO Investigating Stabbing in Durham Area

BUTTE COUNTY, CA (MPG) - On November 11, 2022, around 11:45 P.M. a caller reported a fight to the Butte County Sheriff's Office dispatch center. The caller explained the fight was occurring in the Durham area near the intersection of

Aguas Frias Road and Duncan Road. The caller indicated multiple individuals had been stabbed.

Deputies and medical personnel responded and located a large group of juveniles near a bonfire. Deputies also located a juvenile victim who had been stabbed. The victim was transported to a local hospital where he received

treatment and was subsequently released from the hospital.

Deputies conducted an investigation and determined the following: Multiple juveniles were attending a party in an orchard when a fight occurred. During the fight, a juvenile suspect used a knife to stab at least three individuals. Two of the

individuals who were stabbed left the location prior to law enforcement arriving.

Over the past two days, deputies conducted follow-up and identified the additional victims and the juvenile suspect who stabbed the victims. The two additional victims received non-life-threatening injuries

and are recovering at home. On November 14, detectives worked with the Butte County District Attorney's Office and obtained an arrest warrant for the juvenile suspect. Based on the fact the suspect is a juvenile, BCSO is not releasing further information about the suspect's identity. ★

REDDING, CA (MPG) - The Gridley varsity football team was soundly defeated Thursday night, 64-7, at University Prep in the first round of the 2022 Division III Northern Section CIF Football Playoffs.

The No. 6 seed Bulldogs (4-7) were simply overmatched against the No. 3 ranked Panthers (10-1). University Prep scored 27 points in each of the first two quarters, respectively, and led 54-0 at halftime.

The Panthers were limited to only a field goal in the third period. Then in the final quarter, the two teams exchanged touchdowns, as Gridley avoided the shutout. University Prep will travel to Cottonwood to take on No. 2 seed West Valley (8-3) in the playoff semifinals on Friday night at 7 p.m.

The Panthers recorded 406 total rushing yards on 27 carries, averaging a whopping 15 yards per rush. Senior running back Ryan Dyab was the game's leading rusher with 11 carries for 178 yards and four touchdowns.

Six of the touchdowns came on the ground for University Prep and the other three came through the air. Sophomore quarterback Kaos Martin completed 3-of-4 passing attempts for 139 yards and three scores for the Panthers.

The Bulldogs' statistics were unavailable as of press time. A majority of Gridley's team is in the Class of 2023. Thirteen out of 23 players will be graduating in the spring. One key player that will be returning next season is sophomore quarterback Gus Stogsdill. ★

Wolverines' Run Game Triumphs Over Bulldogs to Advance in Playoffs

LOS MOLINOS, CA (MPG) - The Biggs varsity football team extended its season on Thursday, November 10, with a 30-22 win on the road against Los Molinos in the first round of the 2022 Division V Northern Section CIF Football Playoffs.

This was the first playoff win for the Wolverines (4-7) since the 2017 season and their second appearance in the post-season since 2019. Biggs entered the playoffs as the No. 6 seed, the lowest ranked team in the bracket.

compared to the 147 yards rushed per game through the first seven games of the season.

"We went back to the stuff that I was comfortable with since I've been around and stayed with our bread and butter," Harrison explained.

Harrison added that anytime you change everything in the middle of the year, it could be a disaster, but it worked out well

for the Wolverines. All the scoring in the game happened in the first and fourth quarters of the game.

Biggs jumped out to a 16-0 lead in the first quarter, but Harrison exclaimed that the Wolverines gave Los Molinos some hope after the Bulldogs blocked a punt and had the ball deep in Biggs territory.

The Wolverines had a duo

of running backs that included junior Zach Smith and sophomore Davis Long who combined for 375 yards on the ground and three touchdowns on the night. Although the game went scoreless in the second and third quarters, Harrison told The Herald that his defense was huge the entire game.

"We have kids that fly around, and you know they're going to

be in the right place at the right time when they need to be," Harrison said.

Harrison added that they made a couple defensive adjustments at the half that benefited Biggs in the second half. When the clock hit triple zeroes, the Wolverines were able to celebrate the victory and move on to the second round.

"It feels really good to know that we have one more week to play football," Harrison stated.

Biggs will travel to Portola (9-1) on Friday night for a matchup with the No. 2 seed Tigers. Harrison said Steve Heskett, who is the coach for Portola, has his utmost respect.

"He does what he does, and he never changes it for anybody!" Harrison exclaimed.

Harrison added that the key to the game against the Tigers is to stay mistake free, as the Wolverines have not lost a fumble all season.

"The team who commits the least amount of mistakes in Portola is going to go to the championship," Harrison proclaimed.

Kickoff in Portola on Friday night is set for 6 p.m. ★

Live Oak Suffers Lopsided Loss at Orland, Ending Season

ORLAND, CA (MPG) - The Live Oak varsity football team lost its eighth straight game on Thursday night in the first round of the 2022 Division III Northern Section CIF Football Playoffs, subsequently ending the Lions' season.

Live Oak (3-8) entered the

postseason tournament as the No. 8 seed against top-ranked Orland (11-0). The Lions were on the wrong end of a lopsided loss Thursday, falling to the Trojans 46-8.

and seven touchdowns on 30 carries. The Trojans averaged an impressive 12 yards per carry.

Junior running back Diego Rico recorded a game-high six rushes for 115 yards and four touchdowns. Rico averaged a remarkable 19.2 yards per rush. Junior quarterback Connor Ovard attempted one pass for Orland against Live Oak and it fell incomplete.

Two Trojans recorded tackles in the double digits. Rico, who also plays free safety, and junior outside linebacker Christian Padilla each had 10 tackles and half a sack. The Live Oak statistics were unavailable as of press time.

Nearly half of the Lions will be graduating in the spring. Twenty out of 47 Live Oak players are in the Class of 2023. ★
