Gridley's Response to Butte County Grand Jury Report

In reply to the Final Report of the 2019-2020 Butte County Grand Jury released to the public on June 24, 2022, it falls to me as the City Administrator of the City of Gridley to provide two responses. First, I will be providing a formal response directly to the Butte County Grand Jury addressing their findings. Second, and more importantly, I would like this to serve as a response to the residents and taxpayers of the City of Gridley who deserve a clear and full explanation.

On June 24, 2022, the Gridley Herald published a story entitled: "City of Gridley the Focus of Butte County Grand Jury Report." This story gave a fair and accurate report of the Butte County Grand Jury's findings.

I would like to state up front that I recognize the important role that the Grand Jury process plays in helping to promote transparency and accountability in local government. Those that voluntarily serve in this capacity dedicate a great deal of time and make significant sacrifices to promote the public interest.

However, the Butte County Grand Jury's report and findings suffer from several critical flaws including: a significant lack of context, a fundamental misunderstanding of municipal finance, and the interview process exposed a basic lack of understanding of the function of representative government.

I think the best way of approaching their stated concerns is to address their findings in the order in which they presented them in the Butte County Grand Jury's report.

The BDGJ report lists 6 findings, outlined below:

F1. The City of Gridley has not posted its audited

Some 23 million Californians' bank accounts will get a boost of \$200 to

\$1,050, thanks to a new round of payments approved by state lawmakers.

But the payments, aimed at mitigating higher prices for gas and other goods, will leave out lots of

low-income Californians. Among those passed over are some seniors, many living on disability benefits, and some of the lowest-income adults.

That's because the direct deposits and debit cards – expected to begin arriving in late October and conclude in January 2023 – will be sent out based on tax returns.

About 3 million Californians are in families that earn little enough that they aren't required to file taxes, according to research by Public Policy Institute of California for its 2019 California Poverty Measure. The poverty rate among people who live in families that don't need to file taxes is 60%, the institute estimates. Neither the state Department of Finance nor the Franchise Tax Board, which is responsible for collecting state personal income tax in California, knew exactly how many Californians will be left out of the rebate.

The Legislature wanted to create a program to send payments to people who don't file taxes and aren't enrolled in safety net programs that received a boost in the budget. But after negotiations with the Newsom administration, that proposal didn't make it into the final budget.

H.D. Palmer, spokesperson for the Department of Finance, said that he couldn't offer specifics on why the proposal didn't make it into the final budget, but that proposals from both sides didn't make it into the compromise.

Representatives for Senate President Pro Tem Toni Atkins and Assembly Speaker Anthony Rendon said nobody could figure out how to administer such payments.

"Ultimately, the configuration of the rebate was subject to three-party negotiations as part of the final budget, and there were concerns that there wasn't an efficient and secure way of accomplishing a grant program to non-tax filers," said a statement from the office of Atkins, a San Diego Democrat.

The Legislature "really wanted to get help to these people, but ... we were not able to do it logistically," said a spokesperson for Rendon, a South Gate Democrat.

The payments will go out to Californians who filed 2020 tax returns by October 2021, according to the Franchise Tax Board, which has a tool for calculating how much you are eligible to receive based on how much you earn and other factors.

But in California, people earning less than \$19,310 who don't have a child or someone else depending on them – one of many different gross income thresholds – aren't required to file income taxes. The state also doesn't count Social Security retirement or disability benefits as taxable income, meaning people who receive those benefits aren't required to pay taxes, so long as they have minimal other income.

Lawmakers tried to aid some low-earners who may not file taxes by increasing payments for people receiving CalWorks benefits, a program for needy families. They also increased benefits for people who receive Supplemental Security Income – a state-supplemented version of social security benefits for senior or disabled people who would otherwise not qualify for, or have extremely small social security payments.

The boosts for people in those two programs are good, said Trinh Phan, a senior staff attorney focused on economic security at Justice in Aging, which advocates for low-income older adults. But, she said, the budget package still leaves out some people who are very low-income.

For example, someone getting by just on Social Security Disability Insurance could miss out on this rebate and the boosts to

CalWorks and Supplemental Security Income: They might earn little enough that they don't have to file taxes, but if they don't have kids they likely won't qualify for CalWorks. And, if their disability benefits pay more than \$1060.21 per month, they wouldn't qualify for Supplemental Security Income either, said Phan.

About a quarter of Americans over 65 live in households where 90% of the family income is Social Security, according to the Social Security Administration. The average retired worker benefit in California is about \$1,500 per month, or \$18,000 per year. The average SSDI benefit is about \$1,300 per month, or \$15,600 per year.

Some low-income Californians won't receive the rebate, Department of Finance spokesperson H.D. Palmer said. But he pointed out that many people who aren't required to file taxes still choose to do so, sometimes to receive other benefits distributed through the system. In 2020, an additional 500,000 low-income tax returns were filed in California, Palmer said in a statement, "presumably to qualify for a Golden State Stimulus payment or perhaps even a federal relief payment." Palmer also pointed to other forms of financial assistance in the budget, such as \$1.4 billion in aid for people with unpaid utility bills.

People who don't pay taxes and aren't in a benefits program run by California are hard for the state to reach quickly with aid. Social security benefits are administered by the federal government, and the state doesn't have data on recipients, said Jesse Rothenstein, a professor of public policy and economics at University of California, Berkeley, and faculty director of the California Policy Lab.

"It's obviously not great that we're missing people, and many of them are some of the most vulnerable people in the economy," said Rothenstein. But, he said, "It's not as if there's a mechanism available that reaches everybody." Given a set of imperfect options, using the tax system was the best choice, Rothenstein said.

It's also the choice lawmakers made when distributing two rounds of Golden State Stimulus payments in 2021. After that move, they faced criticism from disability advocates, and seniors who were left out.

"To see that they have done it again this year is just further proof that nobody's paying attention to people who need the most help," said Charis Hill, a disability advocate who lives in Sacramento.

California's government doesn't know much about the people who don't file taxes. The Franchise Tax Board doesn't track the number of residents who aren't required to file taxes, or what share of those people live in poverty, according to statements in response to CalMatters' questions. A spokesperson for the board said that no state agencies appear to track that information.

The difficulty of reaching people with this payment exposes a weakness in the state's system "that needs to be addressed on a longer-term basis," said Chris Hoene, executive director of the California Budget and Policy Center, which advocates for targeting aid to lower-income people. Part of the solution would be better data sharing between the federal government and the states, he said.

But, given the options policymakers were considering – including giving money to car owners, as Gov. Newsom proposed, and cutting the gas tax – he thinks the payments based on income are a good outcome. ★

YUBA CITY, CA (MPG) - Sutter Superior Court is accepting applications for 2022/2023 Grand Jury members.

The function of the Grand Jury, over the course of one year, is to investigate the operations of various officers, departments and agencies of local government including city and county offices, school districts and special districts. As an independent body that operates separate from the entities and officials it investigates, this watchdog agency has broad access to public officials, employees, records and information and promotes government accountability.

Service is voluntary. The Grand Jury is comprised of concerned citizens working

together to make our community better and ensure that our tax dollars are spent appropriately. The term begins upon empanelment after July 1st and ends June 30th with a commitment that may require 4 to 10 hours per week. To be qualified, candidates must have lived in Sutter County for at least one year, be a U.S. citizen, be at least 18 years old and have sufficient fluency in English.

Interested parties may submit a Grand Jury application, which is located on the Sutter Superior Court website at <https://www.sutter.courts.ca.gov/general-information/grand-jury>.

Upon acceptance of the application, interested parties will be summoned for a Grand Jury interview before final approval. ★

financial reports dated 6-30-20 and 6-30-21.

RESPONSE: It is correct that the City of Gridley has not posted its annual audit for FY 2019-2020. We are unable to provide the results of an independent audit that we do not have. The city, like all municipal governments in California, is required to contract out for an independently conducted audit of our financials. The City of Gridley contracts with MUN CPAs of Sacramento. Completion of the audit was anticipated in the Fall of 2021. The city was informed that it was further delayed as a consequence of staff changes, staff departures, and the effects of the COVID-19 pandemic. It might have been possible in that time frame to have canceled the contract with our existing audit provider and retained a new firm. However, that course of action might have served to delay completion even further because it would have effectively reset the entire process back to the beginning. I determined to stay the course. The delay of the financial audit is of no benefit to the city or its staff team. In fact, it frustrates our ability to navigate grant applications and a range of other critical financial processes. The city finance staff has continually and professionally worked to facilitate the successful completion of the audit and anticipates that it will be concluded and publicly available very soon.

F2. A portion of the funds in excess of the Electric Enterprise Operating Expenses are transferred annually into the City of Gridley General Fund.

RESPONSE: The fact that the city transfers revenue from the electric enterprise fund is a matter of public record. The city's annual transfer is the subject of ongoing litigation, and we are confident it will be found to be lawful and in compliance with all applicable statutory and constitutional requirements. We strongly disagree with the grand jury's conclusion, but otherwise we cannot comment on pending litigation.

F3. The City of Gridley audits show an accumulation of cash over the Fiscal Years 2016-2019.

RESPONSE: The City of Gridley has accumulated cash. However, the accumulation of cash is overall citywide not specifically the electrical or any other enterprise fund. The accumulation of cash can be in consequence of

several factors. First, it is an appropriate goal for municipalities to establish a responsible "rainy day reserve." The state of California experiences significant economic fluctuations as a result of sudden policy changes in Sacramento and the national economic environment. We also reserve cash for an array of important capital projects and infrastructure investments. Additionally, the North State and specifically our community have experienced the significant financial impacts of historic civil emergencies such as the mandatory evacuations as a result of the Oroville Dam spillway failure, the Camp Fire that led to the emergency evacuation of thousands of Paradise Fire residents, and the subsequent establishment of the temporary FEMA housing center at Gridley's Industrial Park. Second, there are a number of funding sources that resort in accumulated cash, which must remain separated, segmented, and can only be used in specified ways. For example, as a municipal provider of power, the city receives Green House Gas (GHG) Allowances from the California Air Resources Board, which can be auctioned through the State's Cap and Trade program. This process results in (GHG) funds, which because of strict limitations on usage, accumulated to a balance of \$1.3 million last year. However, it was exactly that planned accumulation that allowed the City Council to approve a one-time "Climate Change Rebate" to every residential electric customer. That rebate totaled over \$475,000 and represented a significant benefit to ratepayers. There are several similar state and federal funding mechanisms like the American Rescue Plan Act funding, which resulted in the city receiving \$1.6 million in federal funding for very specific eligible infrastructure investments. The Act allows jurisdictions up to four years to expend the federal funds because they recognize the limitations that exist currently where contractors and supply chain interruptions have slowed the ability of local governments to implement program investments. It is increasingly difficult to get a contractor and supplies. The result of the limitations outlined above can be what appears to be a significant and inappropriate accumulation of cash.

However, things are rarely what they appear to be.

F4. City officials have not identified the goal number of accumulated cash/investments.

RESPONSE: Again, this was largely addressed in response to finding F3 (above), however, I would add that the City Council has, in fact, set a goal of 20% for the budget reserve by 2024-2025. This is a matter of public record and can be found in the City Budget Summary for the past several years. As far as other state and federal programmatic income sources, in some cases, we have established funding goals to accomplish specific policy objectives and in others, it would not be possible due to the nature of the prescriptions placed on the use of the funds. Again, municipal finance and the regulations that govern it are complex and sometimes defy an easy answer.

F5. The City of Gridley has not provided the method or basis for the computation of the GEU rates.

RESPONSE: The Butte County Grand Jury's report found that the City of Gridley's electric rates are, in fact, comparable to northern California cities. Although the members of the Grand Jury may not have felt that the methodology employed in 2017 to establish the current electric rate structure was adequate, it is the role of the locally elected policy body to determine the efficacy of the methodology. We are currently preparing to engage in a new independent rate study that will ultimately provide a thorough and update analysis of our rate structures for electricity, water, and sewer.

F6: The GEU rates per kWh are comparable to other northern California cities.

RESPONSE: The city concurs.

I hope that the residents and taxpayers find this information helpful. In an era where cynicism and distrust seem to have become the order of the day, I wish to assure the citizens of Gridley that we take our mission seriously. The City of Gridley and its staff remain committed to providing cost-effective, responsive, and professional municipal services to our residents. If any Gridley resident should have questions or concerns about the Grand Jury report or the responses I have provided, or any other matter, please feel free to stop into City Hall so that we can discuss them in person - anytime. ★

Losing Ground in Protecting Our Air Quality

For decades, California has been the nation's leader in reducing tailpipe emissions from cars and trucks and other aggressive work to clean up smog. Southern Californians old enough to remember their eyes stinging from air pollution in the old days know how important that work was.

But now, the state's hard work cleaning up the air is going up in smoke.

California has always had fires, and summer and fall smoke used to be an occasional annoyance. But the mega-fires the state is increasingly seeing send up so much smoke that the air quality gains made over the past years are being lost.

As the L.A. Times recently reported, California's 2020 wildfires sent up so much smoke that we reversed decades of progress in improving air quality. This is no surprise to Californians who spent months under apocalyptic dark skies, but it's a sad confirmation of how much progress has been lost.

And while 2020 was a record-setting wildfire year, 2021 was nearly as intense. It would have set a record if 2020 hadn't come first. This air pollution isn't just unpleasant. It is deadly. Stanford researchers, as the Times reports, estimate up to

3,000 premature deaths from the smoke in our air.

As a member of the state Legislature, I've been fighting for healthier forests for a decade. I've written legislation to get the government's bureaucracy out of the way of fire prevention, launch a major reversal of "no management" management practices, and supported and expanded the Sierra Nevada Conservancy, a champion of healthy forests and watersheds. I wish I could say it was enough.

A large part of the problem is leadership. The current governor says the right things, but real work to keep communities safe and reduce wildfire severity is scarce; there has been no significant reform to California Forest Law in the last 20 years. We still manage our forests under policies that reflect the reality of the 1960s, not today.

This administration is great at issuing press releases but very bad at follow-through, as multiple reports from Capital Public Radio reporters documented over the past year. State and federal policies still put countless barriers in front of the work needed to actively thin overgrown forests (in some places 400% overgrown). We can do better. We can more aggressively waive long reviews under the California Environmental Quality Act for fire-safety projects.

Environmental groups cling to the power to stall and stop projects under these laws in the name of protecting forests. Still, I defy any of them to take a tour of Plumas County, where the Dixie Fire burned a million acres last year and

tell me that it is a healthy environment.

We must consistently support the local governments and nonprofit Fire Safe Councils that plan and organize fuel work. Competitive grants primarily drive the state's current system. CalFire does its best to fund essential projects, but too many communities don't have the organization to ask. Many rely on volunteer groups to handle this critical public-safety work. I have the highest admiration for the people who step forward to help their neighbors, but the critical fire risks we're facing demand a 21st-century response. We have to tap the nearly forgotten wisdom of the ranchers, and the California Native tribes before them, who learned that fire in California is inevitable, but burning on purpose in the right season is safer and better for the environment.

The risks of prescribed fire are serious, but we need to expand our capacity to burn where we can do it safely. And we must work with the federal government, which manages nearly half the land in California, so it does its part to change course. Our national forests are a California treasure, but in recent decades their extreme, barely managed fire risk has made them a bad neighbor. The wildfire crisis is destroying watersheds, leveling whole towns, and blanketing the state in smoke that is literally killing Californians even if they live miles from the fire lines. We must do better.

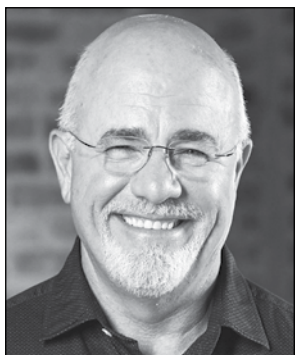
Thinking about decay these days. There are benefits to the earth with the process of decay. Decomposition and decay are essential to the building of soil. They are essential to recycling various nutrients making them available to new organisms. Decomposition is the process in which larger particles that are converted into simpler organic forms. This becomes a food

source for many species at the base of the ecosystem. These species are known as Detritivores. The word detritivore means “feeders on dead and decaying organic matter.” This detritivore community is made up of many organisms, each doing a specific job in the decomposing process. Most do their jobs are done out of sight. When seen this process can be seen as undesirable to humans. Yes, these community members are insects such as beetles and their larvae. Flies and maggots (fly larvae) also, woodlice, fungi, slime molds, bacteria, slugs and snails, millipedes, springtails and earthworms.

The primary decomposers of plant matter are fungi. Once, there is plant litter the hyphae of fungi invade. This is the white stringy stuff you see when

you turn over matted litter. The primary decomposers of animals are other animals and bacteria. Flies, beetles and their larvae are the first to go to work. Once they get started then bacteria enter the scene and putrefaction sets in, this causes a mighty stink. Once this stage is past the flies and beetles continue their feeding along with the long list of other members of the detritivore community such as snails, the little slimmers. Both the decomposition of plants and animals aids new growth throughout the ecosystem. Everything eventually succumbs to the detritivore community.

Speaking of habitat, a rabbit has come to the yard. This could be a problem. Rabbits have much bigger munching mouths than do snails, earwigs and sow bugs. ★

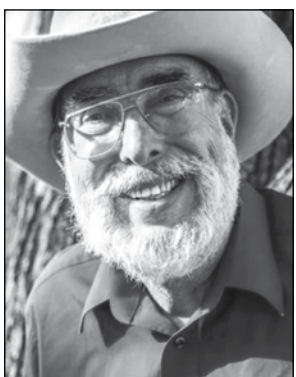

RESOLUTION NUMBER 22-02 RESOLUTION OF THE BOARD OF TRUSTEES OF THE GRIDLEY-BIGGS CEMETERY ASSESSMENT DISTRICT INTENT TO LEVY AND COLLECT ASSESSMENTS FOR FISCAL YEAR 2022-2023

WHEREAS, the Board of Trustees of the Gridley-Biggs Cemetery District, acting as the legislative body of the Gridley-Biggs Cemetery Maintenance Assessment District, has previously ordered through Resolution 94-3 the formation of an assessment district pursuant to the provisions of the Landscaping and Lighting Act of 1972, known as the Gridley-Biggs Cemetery Maintenance Assessment District, for the purpose of financing certain cemetery facility improvements as specified in the District's Master Plan and for the purpose of funding maintenance operations of those facilities; and

WHEREAS, the Board of Trustees, through Resolution 94-3, has ordered that the cemetery improvements specified in the original Engineer's Report dated April 8, 1994, be constructed, and has estimated that the cost of such proposed cemetery improvements is greater than can be raised from a single annual assessment, and has ordered that the estimated costs of these improvements, other than the costs of maintenance and servicing, be raised by an assessment levied and collected in annual installments over a period of 20 years, commencing in fiscal year 1994-95 and ending after fiscal year 2013-14; and

WHEREAS, on Wednesday, February 12, 2014, the Board adopted Resolution 14-01, pursuant to Streets and Highways Code sections 22608 and 22585 et seq., declaring the intention to extend the annual assessment period an additional 20 years, setting a public hearing for June 11, 2014 and requiring that the notice of public hearing and assessment ballots be mailed to all District property owners as shown on the equalized tax rolls; and

WHEREAS, notice of said public hearing was duly published and mailed as required by Resolution 14-01, Streets and Highways Code sections 22585 et seq. and Government Code section 53753 and the assessment ballots were timely mailed to all owners of property within the District as shown on the equalized tax rolls; and

WHEREAS, at 7:00 AM on June 11, 2014, as set forth in Resolution 14-01, the Board held a public hearing and afforded all interested persons an opportunity to be heard, closed the public hearing and directed the Clerk to tabulate the assessment ballots that had been received prior to the close of the public hearing; and

WHEREAS, the ballots were tabulated and there was no majority protest, the Board may proceed with this Resolution of intent to levy and collect assessments for fiscal year 2022-2023; and WHEREAS, Streets and Highways Code Sections 22622, 22623, 22565 and 22661 authorize the preparation of an Engineer's Report on an annual basis which shall describe any proposed new improvements or any substantial changes in existing improvements, set forth an estimate of the costs of any improvements and/or maintenance, specify a diagram for the assessment district, specify the amount to be assessed upon various types of assessable lands within the assessment district, and include in the estimate and the assessment for fiscal year 2022-2023 the total amount of the annual installment assessment ordered in this Resolution; and

WHEREAS, an Engineer's Report for fiscal year 2022-2023, as authorized and ordered by the Board, has been prepared, which Engineer's Report generally describes the general nature, location, and extent of the new improvements or any substantial changes in existing improvements and maintenance, provides an estimate of the costs of any proposed new improvements or substantial changes in existing improvements and refurbishments and maintenance, sets forth a diagram for the assessment district, specifies the amounts to be assessed upon various types of assessable lands within the assessment district, and sets forth the total amount of the annual installment assessment for fiscal year 2022-2023 ordered by this Board of Trustees in this Resolution; and

WHEREAS, this Engineer's Report has been approved by the Board of Trustees of the Gridley-Biggs Cemetery District pursuant to Streets and Highways Code Section 22623, and

WHEREAS, the Board is authorized to act pursuant to Streets and Highways Code sections 22585-22595.

NOW, THEREFORE, BE IT RESOLVED, FOUND DETERMINED AND ORDERED as follows:

- Section 1. Findings. The Board finds:**
- the preceding recitals are correct;
 - compliance has been had with all requirements of the Landscape and Lighting Act of 1972, including, but not limited to sections 22585-22595, and section 53753 of the Government Code;
 - the tally of the assessment ballots timely received was in favor of the assessment as set forth above;
 - the Board may proceed with the levy and collection of assessment as set forth herein; and,
 - Said assessment is a valid property-related fee as defined in Article XIII D, section 6(b) of the California Constitution:
 - Revenues from the fee shall not exceed the funds required to provide the property related service: maintenance and expansion of the cemetery for exclusive use of property owners and families.
 - Revenue derived from the fee is not used for any purpose other than that for which the fee was imposed. The fee provides only for the expansion and maintenance of the cemetery.

The amount of the fee imposed upon any parcel or person as an incident of property ownership does not exceed the proportional cost of the service attributable to the parcel. The fee provides only for the expansion and maintenance of the cemetery.

 - The fee is imposed for a service that is actually used by, or immediately available to, the owner of the property in question. The charge provides for the expansion and maintenance of the cemetery which is available to the persons paying the charge and not available to the general public.
 - The fee is not imposed for general governmental services where the service is available to the public at large in substantially the same manner as it is to property owners. The charge provides for the expansion and maintenance of the cemetery which is available to the persons paying the charge and not available to the general public.

Section 2. Declaration of intent to levy and collect assessments pursuant to Streets and Highways Code Section 22624.

- Said assessments will be levied and collected within the boundaries of the Gridley-Biggs Cemetery Maintenance Assessment District, which comprises all that area lying within the boundaries of the Gridley-Biggs Cemetery District. A full and detailed description of the boundaries of the Assessment District and the parcels of land within the district is contained within the Engineer's Report.
- The Board of Trustees declares its intent to continue to levy and collect assessments for fiscal year 2022-2023 within said District at a rate of \$1.50 per month or \$18.00 per year per single family residential unit, apartment unit and/or condominium, all as set forth in the Engineer's Report. This is the same rate as that of the prior fiscal year. The total number of parcels to be assessed and an estimate of total annual assessment revenue are contained within the Engineer's Report. The estimated cost of the proposed cemetery improvements specified in the Engineer's Report is greater than can be raised from a single annual assessment, and therefore, the estimated cost of these improvements, other than the cost of maintenance and servicing, will be paid for by this assessment, which will be levied and collected in annual installments over a period of 20 years commencing in fiscal year 2014-15 and ending after fiscal year 2033-34.
- Improvements within said assessment district to be funded by said assessments shall include construction of expanded cemetery facilities at Gridley-Biggs Cemetery and ongoing maintenance items as detailed within the Engineer's Report which is incorporated herein by this reference.
- Reference is hereby made to the Engineer's Report which is on file with the Clerk of the Board for a complete description of proposed improvements to be undertaken in fiscal year 2022-2023 and thereafter, the cost thereof, and the proposed assessments upon assessable lots and parcels of land within the proposed assessment district.
- The Board hereby declares that this resolution of intention constitutes a notice of hearing regarding its intent to levy and collect assessments within the assessment district for fiscal year 2022-2023. This hearing shall be held at a meeting of the Board of Trustees on July 20, 2022, at 8:30 AM, at the office of the Gridley-Biggs Cemetery District, 2023 State Highway 99, Gridley, California. The clerk is hereby directed to publish this notice as a notice of hearing in a newspaper of general circulation pursuant to the requirements of Government Code Section 6061.

Bay Fire Forces Evacuations from 2 Areas of Yuba County

YUBA COUNTY, CA (MPG) - Loma Rica residents were forced to evacuate from their homes Friday afternoon, July 8, due to the Bay Fire spreading within their area of Yuba County.

Primarily two areas of Yuba County were evacuated due to what CAL FIRE's Nevada-Yuba-Placer Unit deemed the Bay Fire. According to

CAL FIRE, they ceased forward movement around 3:30 p.m. Friday with the fire contained to about 26 acres.

"Extensive mop up in the area," CAL FIRE wrote in a news release. "Use caution as fire equipment will be entering and exiting the roadways near Marysville Road and Bayberry Lane near Loma Rica in Yuba County. Go to the Yuba County Sheriff's Office website

or social media for evacuation and road closure information."

The Yuba County Sheriff's Department (YCSO) encouraged the public to avoid the area and "follow the directives of law enforcement and fire personnel."

According to the California Highway Patrol (CHP), Bayberry Lane, Big Oak Lane and Pioneer were immediately evacuated. The CHP also stated

that the wildfire spread to multiple acres and that two structures were threatened.

"CAL FIRE Nevada-Yuba-Placer Unit is in unified command with the Yuba County Sheriff's Office for the Bay Fire," CAL FIRE said. "Marysville Road and Bayberry Lane near Loma Rica in Yuba County. Assisted by CHP, Loma Rica Fire, Tahoe National Forest, Dobbins Fire,

Oregon's House Fire, Penn Valley Fire and Foothill Fire."

Evacuees can find shelter at Sycamore Ranch located at 5390 Highway 20 in Browns Valley according to the YCSO. An animal shelter has also been set up in Browns Valley right down the road from the ranch.

"We have the Yuba County Sheriff's Posse Arena open for large animals who have been

displaced located at 5396 Marysville Road in Browns Valley," the YCSO wrote in a news release. "If you need assistance with evacuating animals, please contact Animal Care Services at (530) 701-8997."

Roads affected by the Bay Fire include Scott Grant Road and Peoria Road at Marysville Road; Marysville Road at Fruitland Road; and Dawn Drive at Big Oak Lane. ★

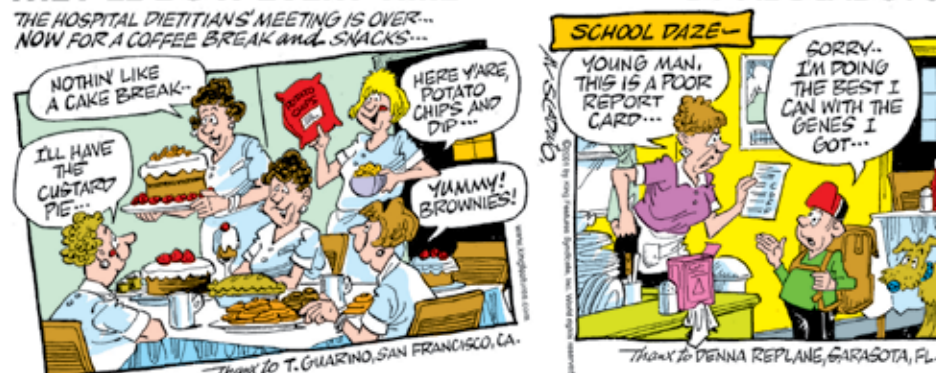

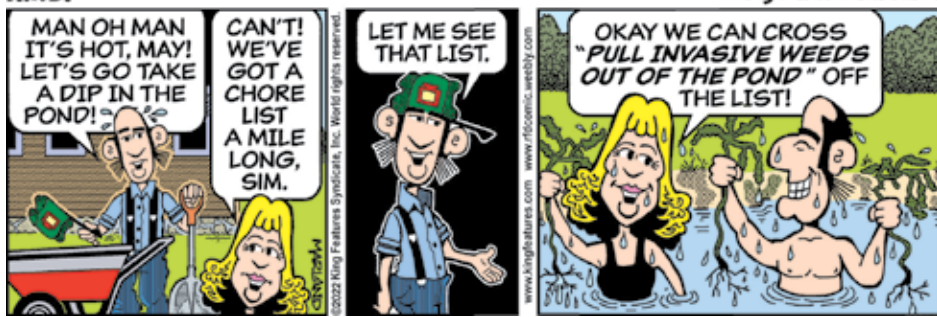

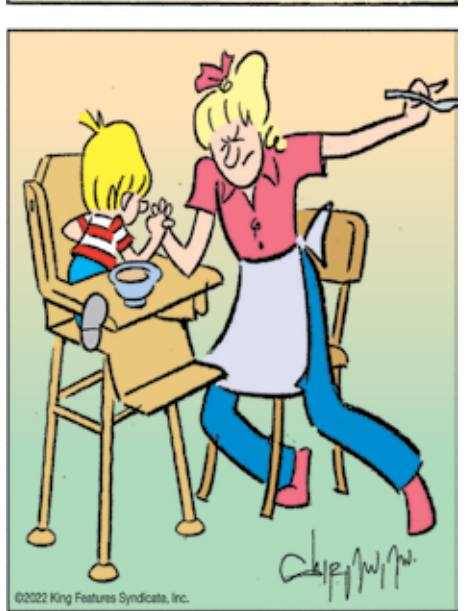

Now You Can Use Your Library Card to Visit State Parks

CA State Library News Release

SACRAMENTO, CA (MPG) - California State Parks and the California State Library today announced an additional opportunity to advance safe and equitable outdoor access to all Californians.

Starting in the first week of April – National Library Week – California State Parks will be distributing the California State Library Parks Pass to public libraries across the state for checkout by library patrons. The new pass will allow free vehicle day use entry at more than 200 participating state park units.

“Spending time in nature is crucial to our mental health and well-being,” said First Partner Jennifer Siebel Newsom. “We’re lucky to have the largest state park system in the nation, and I am thrilled to partner with California State Parks and the California State Library to help make those spaces more accessible to California families. With the California State Library Parks Pass, anyone with a library card will be able to unlock the benefits and beauty of our majestic state parks.”

Research shows that spending time in the outdoors is associated with better mental and physical health, and that many Californians face barriers to accessing their parks. California has a wealth of state parks, and many public libraries are likely within driving distance of one. By reducing barriers to park access and partnering with entities such as public libraries, the state can help more Californians explore the outdoors and generate positive impacts in the area of health, natural resource stewardship, and historical and cultural connections.

“Parks and libraries have the potential to be powerful symbols and agents for California’s open spaces,” said California State Parks Director Armando

Quintero. “It is an honor to work side-by-side with the California State Library, Newsom Administration and partners to advance outdoor access to all Californians via public libraries, inspire stewardship for the state park system and build a healthier California.”

As part of a three-year pilot program starting in April, each library jurisdiction will receive at least three California State Library Parks Pass hangtags per branch for checkout by library patrons, including mobile libraries. Park Passes will enter circulation on a rolling basis throughout April and May for checkout by library patrons; library users can contact their local library for more information. Library-card holders will be able to check out the pass for the allotted number of days allowed by the local library, then return the pass to the library for others to use. The pass is valid for entry of one passenger vehicle with capacity of nine people or less or one highway licensed motorcycle at participating state park units.

“Libraries are trusted community hubs where Californians know they can find what they need to work, play, and thrive,” said California State Librarian Greg Lucas. “This partnership

with State Parks now allows Californians to ‘check out’ California’s great outdoors at their community library.”

Libraries are already an important part of Californians’ lives. There are 1,184 public library buildings in California, and more than 23 million Californians have library cards. In 2019-2020, these libraries circulated over 97 million items free of charge, such as books, technology, Wi-Fi hotspots, videos, music, instruments, tools, telescopes and more. Additionally, the libraries hosted over 300,000 programs in 2019-2020, with almost 7.5 million people attending. The California State Library Parks Pass program is one more way that Californians can get empowered through their libraries. Additionally, the California State Library will be providing grant funding to libraries for outdoor-related items for checkout, programs that teach natural resource stewardship and outdoor skills, or to encourage their library patrons to enjoy the outdoors and make historical and cultural connections to parks.

“All Californians should have the opportunity to be outdoors in nature,” said California Secretary for Natural Resources Wade Crowfoot. “Yet many of

our state’s residents live in communities without adequate parks and open space. This innovative new program will enable more Californians to explore our incredible State Parks system, and in the process create more equitable access to nature and the outdoors.”

The 2021/22 State Budget included initiatives to advance equitable access to state parks and open spaces for all Californians. A \$9.1 million one-time General Fund investment was included in the budget to launch a state parks pilot to expand parks pass distribution, especially for youth in disadvantaged communities. The pilot includes the California State Park Adventure Pass program that provides free day-use passes for fourth graders and their families, the revamped Golden Bear Pass Program and the California State Library Parks Pass.

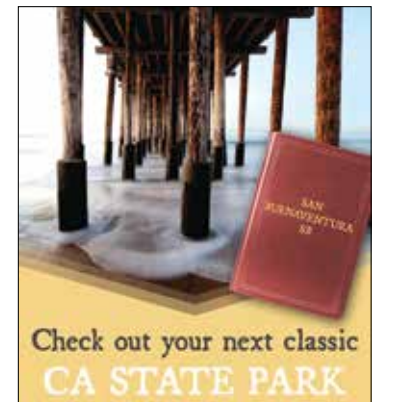
