LIVE OAK, CA (MPG) - As the first of the area high schools to graduate this year, Live Oak once again held a rousingly fun and moving commencement ceremony.

On Thursday, June 2nd, Live Oak High School's Principal, Tony Walton, hyped the grads with a chant, "Let's Go Lions," that could be heard across the field by attendees as the graduates prepared to take center stage. Walton would then lead the grads onto the field and before getting started on his opening remarks,

have the crowd give the LOHS Class of 2022 a standing ovation.

In a moment that would choke Walton up, he said "We are losing a piece of Live Oak tonight and I don't know if he can ever be replaced, which is how it should be." Long-time teacher at Live Oak High School, David Anderson, would be retiring. Anderson was given a large round of applause from the crowd and students, receiving hugs from graduates throughout the ceremony as they received their diplomas.

Moving forward with the proceedings, Walton would say that "This is the

LIVE OAK, CA (MPG) - Noah Curiel has graduated from Live Oak Middle School decorated in gold.

On June 1st, Curiel sat front row alongside his graduating class celebrated by staff, family, and friends for their promotion. His black gown was embellished with a gold sash,

gold cord, and medal. On April 27th Curiel was awarded a gold cord for achieving Honor Roll this school year along with the prestigious Gold Cup. Curiel was one of ten 8th graders who maintained a 4.0 GPA for two consecutive school years, a requirement for qualification of the Gold Cup. However, that was only one of three prominent awards Curiel received this year.

This past March, Curiel was selected as one of six recipients in his class for the Tiger Pride Award. Students were nominated by their teachers who felt these students were emblematic in promoting "character traits of responsibility, compassion, respect, initiative and optimism amongst others."

On May 27th, an 8th grade awards ceremony was held. There, Curiel was awarded the WEB which stands for "where everybody belongs" is a middle school transitional program that serves to welcome incoming 6th graders.

As the ceremony came to an end, the final award was announced. Two students were unanimously selected by 8th grade teachers and school administrators for the California State Assembly Award. Curiel was one of those two students.

In the summer of 2018 Curiel was invited by Senator Jim Nielsen for a private meeting and tour of the Capital in recognition for receiving two consecutive California State Senate Scholastic Achievement Awards. Now, Curiel has added a California State Assembly Award to his academic resumé. Senator Nielsen recently sent a personalized letter congratulating Curiel on his continued success and gave his condolences for the devastating loss of Curiel's father this past February, "while it is difficult to understand and process this loss, I am confident your father would be very proud of your scholastic achievement, and for attaining the coveted Gold Cup."

Of all the awards presented to him this year, Curiel declares his favorite was the Gold Cup. "It took two years to get that one. Two years of 4.0s each year so I had to stay on top of my schoolwork for that whole time. I couldn't give up at any point." Of his accomplishments, Curiel says, "It's unreal. I never thought I would get all these awards."

Curiel certainly faced his fair share of adversity while working towards the goal of the Gold Cup, including a broken leg and the loss of his father. Even so, Curiel stuck with his goal while honoring his father's memory as he persevered.

Curiel credits the support of staff for his many successes at LOMS. Especially, 8th grade Math teacher, Cruz Gutierrez and retired 6th grade teacher, Mrs. Manjit Jhutti. Along with teachers, Curiel also found inspiration through his mom. "She always helped me study, helped me with projects, and even talked to teachers when I needed help with everything I was dealing with. The biggest thing though is she taught me how to set goals and stick to them until I achieved them."

Live Oak Middle School has undoubtedly helped strengthen and prepare Curiel for a bright future. Vice Principal, Erin Walton, compliments Curiel by saying, "Noah exemplifies our Tiger core values - responsibility, respect, and pride. He is a natural leader on the court and in the classroom. Excellence is a habit for Noah; and he's fortunate to have the support of his mother and other family cheering him on every step of his successful journey."

While Curiel prepares to attend Live Oak High School in the fall, he has already begun setting new goals for himself. "I want to continue to get a 4.0 GPA and become the Valedictorian of my class. I want to play football and basketball in high school and get a scholar ship to play basketball at a university." Curiel is also scheduled to begin taking college courses as early as this summer. Clearly, Curiel has a golden state of mind and with his current success, there is no doubt he will only continue building upon his empire of academic excellence. *

California Water Boards News Release

SACRAMENTO, CA (MPG) - In response to

Governor Gavin Newsom's March 28 Executive Order the State Water Resources Control Board adopted an emergency water conservation regulation that will ensure more aggressive conservation by local water agencies across the state.

The new regulation bans irrigating turf at commercial, industrial, and institutional properties, such as grass in front of or next to large industrial or commercial buildings. The ban does not include watering turf that is used for recreation or other community purposes, water used at residences or water to maintain trees. The regulation also requires all urban water suppliers to implement conservation actions under Level 2 of their Water Shortage Contingency Plans.

In March 2022, the state's urban retail water suppliers reported average water use statewide that was nearly 19% greater than in March 2020, lowering the state's cumulative water savings since July 2021 to 3.7%. On May 23, 2022, Governor Newsom convened leaders from the state's largest urban water suppliers imploring them to take more aggressive action to combat drought.

"The severity of this drought requires all Californians to save water in every possible way," said Joaquin Esquivel, chair of the State Water Board. "The regulation compels water systems and local authorities to implement a range of additional critical conservation measures as we enter the hot and dry summer months."

Level 2 water shortage contingency plans are meant to address up to a 20% shortage of water supplies. In addition to implementing Level 2 actions, the regulation requires urban water suppliers to fast-track supply and demand assessments to plan for potential

extended dry conditions.

Level 2 actions often include things such as: Limiting outdoor irrigation to certain days or hours; Increasing patrolling to identify water waste; Enforcing water-use prohibitions; Increasing communication about the

importance of water conservation. Some water suppliers already have imposed strong new restrictions on customers' water use in accordance with their drought management plans. However, about half of the state's 436 water suppliers (both urban water retailers and wholesalers) have not yet activated Level 2, and 36 have not submitted drought plans. The emergency regulation will require suppliers without drought plans to take certain conservation actions, such as conducting outreach to customers about conservation, restricting outdoor irrigation to two days a week and

enforcing against wasteful water practices. The approved regulation will be submitted to the Office of Administrative Law (OAL) for approval, which typically occurs within 10 calendar days. The ban on non-functional turf becomes effective upon OAL approval and the Level 2 requirements for urban water suppliers are proposed to take effect on June 10, 2022.

The regulation will give suppliers new options to reduce water waste if they choose to use them. A violation of the non-functional turf irrigation provision, for example, would be an infraction and subject to a fine of up to \$500.

People who see water waste should report it at savewater.ca.gov.

The State Water Board's mission is to preserve, enhance and restore the quality of California's water resources and drinking water for the protection of the environment, public health and all beneficial uses, and to ensure proper allocation and efficient use for present and future generations.

Mail Theft Arrest

- On Sunday, May 29th, BCSO deputies were dispatched to the area of Lower Wyandotte Road in Oroville on reports of a suspicious vehicle in area.

When deputies arrived, they located a van parked on the side of the road. Deputies contacted a female, who admitted to being the driver of the van. The female initially gave deputies a false name, but was later identified as Nakitta Weaver, age 25 of Oroville. A records check through BCSO dispatch showed Weaver had two warrants for her arrest, one for theft and one for forgery.

Weaver was wearing latex gloves, and deputies located several articles of U.S. mail on the ground next to where Ms. Weaver was sitting, some of which had already been opened. Deputies searched the

vehicle and located additional mail inside, as well as suspected methamphetamine, paraphernalia, and tools often used to commit mail theft. In total, deputies located mail belonging to at least 15 people.

Weaver was arrested for her warrants, felony

identity theft, possession of burglary tools, possession of a controlled substance, and possession of drug paraphernalia. She was booked into the Butte County Jail. Deputies are currently working on returning the mail to the rightful owners.

California Expands Infant Formula **Options for WIC Families**

SACRAMENTO, CA (MPG) - To further support California families while supplies of infant formula remain limited, the California Department of Public Health (CDPH) is adding a new flexibility by expanding purchasing options for the WIC (Women, Infants and Children) program. Effective immediately, families with WIC benefits have eight additional formulas, and a total of 13 options, they can purchase for their infants.

WIC families can find the latest updates at MyFamily.WIC.ca.gov or the California WIC App and should contact their local WIC office with questions on how these options work for infants. General information on the infant formula shortage is available at cdph.ca.gov/ formula.

"We are quickly doing what we can to provide our WIC families with as many infant formula options as possible during this challenging time,' said CDPH Director and State Public Health Officer Dr. Tomás J. Aragón. "In

the coming days we will also add more formulas to this list."

The state's action temporarily expands the existing (WIC) authorized product list to include additional infant formula options. These newer options will be removed once infant formulas are widely available again.

Safety Information for Families in Need of **Formula**

Many California families are feeling the effects of the formula shortage. Safe formula preparation is vital to ensure infant safety.

Non-WIC parents and caregivers who face a

shortage should call their health care providers first to help them navigate infant formula options when supplies are scarce.

Parents and caregivers are advised to NOT dilute formula or use homemade recipes for substitution as this can seriously harm a baby's health.

Babies usually tolerate alternative formula products except in the case of special therapeutic formula, and that's why it's important to consult with your healthcare provider first to get help or to discuss alternatives.

Through BCOE's Back 2 Work Program. participants who have experienced homelessness, re-entered society after incarceration, or encountered barriers to finding employment learn life and job skills and receive temporary paid employment, job placement assistance and social services in counties throughout California.

"The Back 2 Work program has truly impacted my life by allowing me not only to have a career and a second chance - at life and work – but also in introducing me to some great people," said Caltrans Maintenance Worker Robert Kelso, who found a job with the Back 2 Work Program soon after his release from incarceration. "If you have ambition, initiative and drive, the Back 2 Work Program can change your life like it has mine."

Caltrans has partnered

with BCOE since 2013 to offer skills training, employment opportunities and social services, assisting nearly 10,000 people to overcome poverty and improve their lives.

BCOE's Back 2 Work crews support Caltrans in collecting and disposing of litter and debris along the state highway system. Building on the success of this partnership, Caltrans significantly expanded the program in 2021, signing a \$127 million contract with BCOE - funded by Clean California - to hire 82 additional Back 2 Work crews statewide. Each crew has an estimated 50 participants annually, providing more than 4,000 people with the opportunity to reintegrate back into the workforce. Additional Clean California job postings are available on CalCareers.

"Back 2 Work provides people in need with the necessary tools and opportunity to succeed in life," shared Keith Lane. Senior Director of the BCOE Back 2 Work Program. "For those served, being successful can mean so much – reuniting families, breaking systemic cycles, going back to school, and providing for themselves in a way they couldn't before. We are incredibly thankful for the partnership between Back 2 Work and Caltrans, which will benefit every person throughout California in some way."

Litter removal by BCOE's Back 2 Work crews allow Caltrans maintenance crews to concentrate on public safety, maintenance and other critical efforts that keep people and goods moving safely along California's transportation network.

"Clean California is benefiting communities throughout the state - removing litter and beautifying public spaces - and its transformational impact extends beyond our roadsides," said Caltrans Acting Director Steven Keck. "The Back 2 Work Program is helping thousands of Californians overcome poverty, learn important skills and rebuild their lives."

"People need to know that there is hope for all of us. If you are willing to dig deep, try hard and be positive, there are people willing to help you come out of wherever you are," said Rudy Contreras, Caltrans maintenance supervisor and former Back 2 Work participant. "I went from being homeless as child to foster care and now I am a foster parent. The Caltrans and BCOE partnership saved my life."

Since launching Clean California in July, Caltrans has removed nearly 650,000 cubic yards of litter from state highways the equivalent of more than 10,800 tons or enough to fill 197 Olympic-size swimming pools - and hired 708 new team members as part of Clean California, including 546 maintenance workers who collect litter and remove graffiti.







The Feds Response

With inflation and the Feds response to it being the most widely accepted cause of our stock market ills, the question becomes what has caused the inflationary fires to ignite?

Inflation rates, although consistently increasing year over year for decades, have remained within the Feds 2% target rate for most of that time.

In the last year or so however, rates have been spiking. Figures vary on the exact rate of inflation, but we can comfortably say the inflation rate is, well, very uncomfortable.

When looking for reasons, many argue we go no further than 2051 Constitution Ave. in Washington, D.C., the address of the central bank of the United States, the Federal Reserve.

Among its many functions, it is the entity that controls our currency, the U.S. dollar.

The Feds, working in conjunction with Washington policy makers (but reportedly not beholden to them), decide when and by how much to reduce or increase the supply of money in our economy. This increase or decrease in the money supply acts to throttle up or throttle down the flow of currency in the system. The rate of flow, which can be thought of how fast money circulates between all of us, is called "money velocity".

Couple higher money velocity with an increase in the amount of money created by Fed, the higher inflation will go.

In 2008/09, the Feds created trillions in new money, but much of that money went directly into the banking system instead of to the consumer. It is the reason we saw little inflation in the years that followed.

For CoVid-19 relief however, another plethora of trillions was created by the Fed, but this time much of it went directly to consumers. In fact, they have increased the total supply of U.S. dollars in the system by about 41% in just two years. An unimaginable increase without precedent.

Hence the inflation we are now witnessing.

One would think the economic experts working for Washington would enlighten administration officials as to the widely accepted cause and effect that government spending has on inflation.

Whether those discussions are ongoing is unknown, but if they are, it seems 1979, SDSU, and California Insurance the education is falling on deaf ears.

checks to about 6.4 million Canadians to help offset higher prices.

Following their lead, Washington, is discussing a bill to hand out "gas money" stimulus checks to Americans living in areas where gas prices are above \$4 per gallon. The proposed amount is \$100 PER MONTH, at an estimated cost of 168 billion.

The Senate also passed a one trillion dollar infrastructure bill in November of last year. Although final figures are a moving target as the differing political aisles duke it out, it's a foregone conclusion more money is going to continue to gush out of Government coffers. Additional conversations around other assistant programs like food and rent assistance are also on the table. (https://www.whitehouse.gov/ american-rescue-plan/)

One would think spending even more money on assistance checks to address consumer inflation which in part was caused by previous government spending might not be such a good idea. However the disconnect from both political parties on this fact seems palatable.

The question then becomes is why are the Fed and Washington deciding to spend even more money if previous spending got us here?

Won't the additional spending just drive prices even higher, making an already bad situation worse?

One answer could be a November election is looming. If history shows us anything, it shows that during election time, the economy and how people are faring is a hot topic when ballots are

Since the voting constituency knows not of the cause and effect of printing money causing inflation however, politicians don't dare pull the apple cart away right when voters are deciding who stays and who goes.

Unfortunately, that probably means more free money in your mail box, and even nastier inflation to follow.

Finland tops the world in coffee consumption, where they consume 23 pounds of the brew per person each year. In the US, 64% of adult Americans drink java, with the average coffee drinker taking in about 10 pounds of coffee every year (1).
