OAKLAND, CA (MPG) - It all started with iust a tweet.

LIVE OAK, CA (MPG) - Under the shade of the great oak tree that is the town's namesake, dignitaries from the state, the City of Live Oak, Caltrans and those behind the work gathered to celebrate the completion of the Live Oak Streetscape Project.

Master of Ceremonies and Caltrans Project Manager, Johnny Tan, welcomed all in attendance at the celebratory ribbon cutting ceremony saying, "It's been my pleasure to be part of this complete street construction project to see the

amazing transformation of the downtown corridor."

Tan then introduced Caltrans District 3, North Region Director Amarjeet Benipal. Benipal, who has over 30 years' experience working with Caltrans, started off with what a wonderful day it was to be celebrating the accomplishments of those from the federal government, state government, local government, and community. "To be having this momentous occasion, to actually celebrate the investment we are making in our community - The investment which

is bringing pride and joy for us and for future generations" should fill the community with pride.

He would go on to add, "This investment of \$36 million in our community is going to go a long way to actually set the stage for not only bringing the jobs, but also trying to actually bring more businesses, and give people the opportunity to slow down, stop, and actually look at the history of this town."



Continued from page 1 played for the Atlanta Braves, which is Jaden's dad Javier Solis' favorite team.

"Cristian Pache came (to Oakland) from the Atlanta Braves through that Matt Olson trade," Javier said. "I'm a huge Braves fan so Jaden has slowly become a Braves fan as well. So, (when) playing MLB The Show, he enjoys being Cristian Pache. When I had told Jaden that he was on the A's, he was like, 'Oh shoot dad, I really want to meet Cristian Pache.' And I said, 'Well, we know we're going to Little League Day on Sunday, let's reach out to him on Saturday before your baseball game."

Pache grew up nearly 3,400 miles from Jaden in Santo Domingo Centro. Dominican Republic, yet knows the feeling of idolizing a big leaguer all too well.

"A lot of people on Twitter sent me the video of Jaden. I felt a connection with Jaden," Pache told the Herald via an interpreter. "When you notice a kid wants to meet his idol or the person they admire, you want to meet them."

Growing up in the DR, Pache played third base and looked up to players like Alex Rodriguez and Andruw Jones. Eerily like Jaden, Pache admired Jones because he was his dad's favorite player. Pache later met Jones when he was a part of the Braves organization and informed the Herald that he remains in touch with the 10-time Gold Glove winner to this day. The young center fielder is already building his resume, joining his idols with a Gold Glove Award, except his was for his defensive ability in Minor League Baseball (MiLB) last season.

his fellow Little Leaguers on the field before the game. But after his fellow ball players left the diamond, Jaden and the Solis family experienced what would become an irreplaceable memory. Pache emerged from the locker room tunnel to an elated Jaden, his 8-year-old cousin Jay Solis and his 5-year-old brother Maddux Solis, who was named after Braves' Hall of Fame pitcher Greg Maddux.

"I was happy to meet everyone. Seeing Jaden's reaction, I had no idea what he was going to say. He had the happiest look on his face," Pache said Wednesday, April 27, before the A's took on the Giants in San Francisco.

Pache signed Jaden's jersey and gave him A's gear and an autographed bat but was not expecting what came next. In the spirit of giving, Jaden gifted Pache one of HIS autographed Gridley Little League baseball cards.

"I felt like since he was

On Sunday, Jaden joined I felt like I'd give him something back that

> belongs to me," Jaden said. Suddenly Pache found himself lost for words following Jaden's kind gesture.

"When I was his age, I didn't have my own card!" Pache explained. "I have his card in my locker. I have it stored away."

Jaden told the Herald that he currently plays catcher, pitcher and shortstop with a desire to suit up in MLB one day. Solis also wants to start playing center field like Pache. At 10-years-old, Jaden is already competing in the majors as one of six players his age going against 12-year-olds according to his dad.

Meeting one of his favorite baseball players would've been more than enough for Jaden, but that was not all. After the A's defeated the Rangers 2-0 on Sunday, Jaden returned to Twitter where he was bewildered even further.

The fourth grade Solis changed his profile picture to the one his family took

of him, Pache and Maddux. What baffled the Solis family and several members of MLB Twitter was that Pache decided to set the same photo as his profile picture. Pache quoted Jaden's original tweet about the picture with, "We have the same profile pic!" sent out to his over 37,000 followers. Jaden described the moment as "wonderful."

"If you look at the tweet picture, the card that Cristian's holding in his hand is actually an autograph from Jaden to Cristian," Javier said.

Several verified accounts began following the story and interacting with the Solis family on Twitter including television host Montel Williams and former New York Yankees pitcher Phil Hughes. In the days after the game, Jaden went on his first podcast, received Pache cards from generous strangers and was featured in national outlets like Yahoo and The Athletic.

"As a dad, you do your best to give your children the best opportunity you can," Javier said. "The Twitter platform for what I use it as has been a very good experience with the people I've interacted with."

Javier told the Herald that after Jaden's initial video was posted, he shared it with one of his group chats and asked his fellow members to retweet the video. By the time Pache replied, the engagement had soared to over 50

"(My favorite part) was being with my entire family," Javier said. "I know that when we had talked, it was just supposed to be Jaden there. But Cristian was such a good guy that he signed an autograph for my little son Maddux and our nephew Jay.


"He could've just said, 'Hey, I'm only here for Jaden,' but he opened it up to the entire family and said, 'Hey, I'm here for you guys. Let's take a picture, let me sign some autographs.' So, I think that was probably the biggest thing that I took away from that was just how genuinely nice he was and how much he loves the game."


As for the game itself, Jaden said he nearly caught a foul ball and enjoyed seeing A's outfielder Stephen Piscotty launch a two-run homer to left field, which ultimately was the difference in the game.

"Not only (was it) an amazing baseball experience but I think Jaden is now forever going to be Cristian Pache's biggest fan for the rest of his life," Javier said.

Sheriff's Office and District Attorney's Office Investigating in Custody Death

BCSO Press Release

OROVILLE, CA (MPG) - On the morning of April 30, 2022, Butte County Sheriff's Office Correctional Deputies were conducting routine safety checks on inmates housed at the Butte County Jail. Around 11:23 a.m., a Correctional Deputy discovered inmate Cristian Nunez-Paiafox, age 23, of Chico, unresponsive within his cell. Correctional Deputies located evidence Nunez-Paiafox

used a bed sheet to commit suicide. Correctional Deputies and jail medical staff immediately began providing Nunez-Paiafox with emergency medical treatment. Paramedics responded and provided additional emergency medical treatment. Despite the life-savings measures that were administered, jail medical staff and paramedics were not able to revive Nunez-Paiafox.

Butte County District Attorney's Office Investigators and Butte County Sheriff's Office Detectives responded to the jail and began investigating. During the investigation, personnel interviewed Correctional Deputies, medical staff, and inmates housed in cells adjacent to the cell occupied by Nunez-Paiafox. Investigators and detectives located evidence which confirmed Nunez-Paiafox used a bed sheet to

commit suicide. Investigators and detectives determined Nunez-Paiafox was housed in a cell by himself, and other inmates did not have access to Nunez-Paiafox's cell. Investigators and detectives reviewed video surveillance and determined Correctional Deputies had been conducting hourly checks on Nunez-Paiafox. Prior to locating Nunez-Paiafox, Correctional Deputies conducted a check on Nunez-Paiafox at 10:38 a.m. During the 10:38 a.m. check, Nunez-Paiafox was alive, and he did not request any assistance from Correctional Deputies. An autopsy will be conducted by the Sacramento County Coroner's Office to determine Nunez-Paiafox's cause of death.

Investigators and detectives determined Nunez-Paiafox was arrested by the Chico Police Department on April 28, 2022, for misdemeanor counts of battery and resisting arrest. He was subsequently booked into the Butte County Jail. Butte County District Attorney's Office Investigators and Sheriff's Office Detectives are actively investigating this incident.

These days I am traveling a lot for work and eating out once, sometimes twice a day. How do I make healthy food choices?

Dear Chris,

Traveling for business is often hectic and leaves little time for meal planning. The key to success is to plan ahead. Try to stay on your regular eating pattern as much as possible. Use these tips for a healthier experience:

- 1. Eat three meals a day and have healthy snacks available when you need them. Things like fruit, nuts, and popcorn travel well. You can make trail mix with roasted nuts and raisins.
- 2. Restaurants with 20 outlets or more are required to list the calorie amount of food on their menus. Choose a meal with about 500 calories.
- 3. Think twice before ordering appetizers, which are often deepfried and may contain over 1000 calories.
- 4. Choose pasta with red sauce versus white sauce.

- 5. Choose lean, grilled meats: chicken breast, beef or tenderloin, pork tenderloin, or fish. Skip the fancy sauces, as these are often loaded with fat.
- 6. Ask for a to-go box. Many servings in restaurants will last for two meals.
- 7. Ask for salad dressing, butter, and sour cream on the side. These are delicious additives but use them moderately.
- 8. Beware of salad entrees. You may think you are making a healthy choice, but a cobb salad, crispy (fried) chicken salad, and chicken Caesar salad contain over 1,000 calories each. However, ordering a garden salad before your meal is a good idea; it will help fill you up.
- 9. Skip dessert.
- 10. Avoid sugary drinks regular soda pop, lemonade, margaritas, piña coladas, etc. If it has been a long week, and it's time for a libation, have a glass of wine, a light beer, or a vodka tonic.
- 11. Finally, do not skip meals or let yourself get too hungry. That is when we tend to overcompensate and eat anything in sight!

Gridley Tennis Season Ends

ORLAND, CA (MPG) -Fittingly, the final singles match win of the season for the Gridley High School tennis team... came in a tiebreak.

After 19 tiebreaks this season (13 of which resulted in heartbreak), the 20th not only resulted in a win but propelled Gridley's top seed, sophomore Ryan Woolery, to the quarterfinals of the Butte View League Championship.

Using a combination of topspin, side spin and flat serves, some of which he had just learned within the last two days, Woolery was able to take down Oroville's sophomore No. 2 seed, See Xae Yang by a score of 9-8 (after a 7-5 tiebreak). The first serves were crucial to the outcome, as was Woolery's newfound willingness to hit the ball to all areas of the court.

Gridley coach Bob Moffitt praised Woolery for his ability to adapt his game and keep his head during a stressful match.

"Ryan is a true competitor in every sense of the word," Moffitt said. "There is zero quit in the kid. But, in the past, he might have let his emotions get the better of him. Today, he focused on each point and his plan of attack for each point. Yes, he worked on adding physical skills to his repertoire just this week, but I am most happy to see him really put the mental part of the game together with the physical."

In the playoff format, the first two rounds go to eight games, as the winner must win by two. If there is a tie, a first to seven tiebreak is played, again with a requirement to win by two. Yang had previously defeated Woolery 6-0, 6-3 and had squeaked out a win over Gridley junior Spencer Davis 2-6, 6-4, 10-8 in this season's headto-head matchups. But not on April 21.

Davis came back in his match with Corning junior Francisco Hernandez to tie matters at five. But Hernandez won the last three games, with a couple of crucial line calls that could have gone either way, to win 8-5.

An even closer match ended with a deceiving score of 8-3 and a victory for Oroville freshman Aaryan Patel over Gridley junior No. 3 seed Cole Leishman. Leishman also deployed his newfound serving skills to great effect and sent nearly every game to deuce. However, the score was not as lopsided as it would appear. Johnson took his match to 6-7 against Oroville freshman Noushue Yang. Though Johnson was able to use his height to great effect in keeping rallies alive, Yang was finally able to close him out 8-6.

Gridley junior Juan Avelar and freshman Cesar Ortiz never got going and fell 0-8 and 1-8 to Corning sophomore Hayden Carter and junior Francisco Ruiz Jr., respectively. Gridley sophomore No. 5 seed Eric Ramirez was battling a cold but held his own against Orland No. 3 seed, Junior Galvan. Galvan had previously beaten the Bulldogs' Woolery and Davis, but he struggled against the quick-footed Ramirez. Though the final score was 8-0 for Galvan, he had to survive deuce multiple times and Ramirez was able to

prepare for his doubles match feeling somewhat confident.

Ramirez had reason to feel confidence. With playing partner Ortiz, the two bulldozed Oroville's No. 3 seeded doubles team, senior Tien Chao and Patel, with solid net coverage and aggressive swings of the racquet when opportunities arose. Ramirez and Ortiz advanced to the quarterfinals 8-4.

Moffitt praised the duo, who were both linemen on the Bulldogs' football

"They take up a lot of space and they are fast," Moffitt said. "I've played against both and it's pretty intimidating seeing them charge the net and then have to react once they clobber the ball. Their aggressiveness is usually rewarded and it was again today."

The pair would fall to Orland's No. 3 seeded duo of Ethan Orozco and Cheeto Garcia 8-3. Woolery would also fall in his quarterfinal match to Orozco 8-0.

After the matches, Moffitt described the finals and season as a success.

"I told the kids on the first day that winning wasn't important and it's not. Improving and competing to the best of your ability are," Moffitt said. "My few regrets in life come from not giving my all at something or, when I was these kids' age, being afraid to try. In the end, the kids who were competitive today tried."

Iuvenile Arrested at Las Plumas High School

OROVILLE, CA (MPG) - On April 21, 2022, around 7:00 AM, the Butte County Sheriff's Office (BCSO) received a call from a parent of a Las Plumas High School student. The parent indicated she had information a Las Plumas High School student on a school bus had a firearm in his possession. BCSO deputies immediately began looking for the bus, notified Las Plumas High School, and responded to Las Plumas High School.

Deputies arrived at Las Plumas High School

around the same time the bus was arriving. When the bus arrived, school staff members attempted to contact the juvenile and he fled on foot. Deputies worked with school staff and were able to locate and detain the juvenile without incident. Deputies investigated and determined the juvenile had thrown the firearm in a field after he fled from school staff.

Deputies conducted an area check with the assistance of a firearm detection K-9 from the Paradise Police Department. Deputies were able to locate the

firearm the juvenile threw in a field near Las Plumas High School. The juvenile was arrested for a felony charge of possessing a firearm at school and was subsequently booked at the Butte County Juvenile

The firearm deputies located was a "ghost gun." Ghost guns are unserialized and untraceable firearms that can be bought online and assembled at home. This investigation is ongoing. The Sheriff's Office is asking anyone with information about this investigation to contact deputies at 530-538-7671.



CA Tax Waste Report

Howard Jarvis Taxpayers Foundation issued its "Follow the Money 2021" report this week. It is not recommended reading for those prone to depression.

It begins with "This last year California once again ranked worst in the nation to do business, according to an annual report by CEO Magazine, and numerous examples of waste, fraud and abuse totaling billions of taxpayers' dollars down the drain were reported by independent investigations.'

California is now expected to be the leading state in screwing its citizens and businesses. Voters, likely suffering from Stockholm syndrome, reward their molesters with a return to power.

Even Silicon Valley is in decline losing 20% of its venture capital investment. Even after Gov. Newsom's \$95 million advertising blitz tourism never has come close to its pre-2019 levels.

The ongoing loss of jobs, businesses and productive citizens has cost the state a Congressional seat and national influence for the first time in its history.

The state can't even monitor its budget due to failed technology scheduled to come online in 2016. The accounting system is hundreds of millions over budget. Now, here are some specifics on waste, fraud and abuse.

Openthebooks.com reported that 82 - L.A. lifeguards made more than \$200,000 each and 7 made over \$300,000 in 2019. And State Controller Betty Yee cannot even produce a checkbook or summary of monies spent. Yet most large cities and 49 other states can show a record of expenditures.

Five DMV employees at the Torrance and Lincoln Park offices admitted taking tens of thousands of dollars in exchange for issuing licenses to unqualified drivers.

A Sacramento Bee investigation found that Governor Newsom's wife's nonprofit, a firm focused on gender equity in film, received \$800,000 in donations from companies involved in lobbying the state. The following donor companies also contributed to the Governor's political activities.

They include PG&E,

Kaiser Permanente, AT&T, and Comcast. The Governor denies that the donations to his wife's nonprofit had any inappropriate influence on his decisions, stating that "There's no correlation, period, full stop. Absolutely none."

The chief executive of the state's largest union (SEIU) resigned after being charged with numerous crimes including failure to pay her taxes. This union is in favor of higher taxes and gave \$6 million to Newsom for his recall fight.

In 2019-2020, state and county officials labeled thousands of businesses nonessential, bankrupting them. County medical officers forced millions of healthy workers to go home. Assemblyman Kevin Kiley then asked the director of the Employment Development Department why unemployment was so high. She was baffled saying her "research team" would look into it.

While Californians were threatened to "stay home to save lives" politicians maintained their junkets (Pebble Beach, Australia, Scotland, Portland, and Maui) with lobbyists covering many of the costs to buy influence.

State employees bilked \$2.7 million destined to help AIDS patients. The money funded personal travel, cruises, parties, and trips to sporting events. Fake invoices made out to a nonexistent company diverted the money for personal gain.

Democrat Congressman Ted Lieu donated \$50,000 of his campaign funds to Stanford University before his son was accepted to attend. The contributions were first exposed by an anonymous Twitter user. The user's account was then banned by Twitter.

A federal grand jury indicted South L.A. Councilman Mark Ridley-Thomas on charges of funneling millions of dollars of contracts to the University of Southern California in exchange for an admission with a full scholarship and a paid professorship for his son. The son, Sebastian Ridley-Thomas, is familiar with scandal. He was a State Assembly member accused in the "#metoo" scandal before resigning his seat to become a professor, despite lacking a graduate degree.

Ontario Montclair School Superintendent makes more than \$600,000 annually and Sutter-Yuba Behavioral Health psychiatrists are collecting \$400,000-\$600,000

California's Superintendent of Diversity, a new position paying \$180,000 a year, lived in Philadelphia where he ran a private

business. The state job was never even posted as he was buddies with the State Superintendent of Schools.

The Los Angeles County District Attorney charged four men including a former state senator with stealing \$20 million intended for a solar project. One of the individuals is accused of spending over \$8 million of the funds on personal items.

Only 27 percent of Californians who received coronavirus vaccinations used the website "MyTurn" to schedule appointments due in part to multiple tech glitches. The site failed to list many providers and pharmacies where Californians could be vaccinated. The site hindered people by requiring multiple logins. The \$50 million contract to build the site was awarded to Blue Shield of California on a "no bid" basis.

As part of its mad obsession to inject people, the state resorted to bribery using lottery-style payouts and prizes. Ten Californians received \$1.5 million each, 30 got \$50,000 each, and 2 million people were rewarded with \$50 gift cards.

Whistleblowers exposed a COVID-19 test facility for serious problems including lab techs sleeping while processing samples and test swabs found in bathrooms. State officials initially denied the existence of any problem. They finally acknowledged "serious deficiencies" but still renewed a contract worth \$1.7 billion.

A program to build "tiny home villages" in Los Angeles consisting of 64-square-foot (8X8) aluminum and composite sheds. The state paid \$130,000 each for the structures, ten times what other cities spent.

The San Francisco Chronicle reported that 260 tents San Francisco maintains in six "sleeping villages" cost the city \$5,000 per tent per month, or \$60,000 annually. In addition to tents, the villages provide access to showers and 3-meals a day.

Some complained about the cost. At \$5,000 per tent per month, the rent on a luxury apartment would be less, and the rent on an average 1-bedroom apartment in San Francisco would be less than half.

Butte County and the City of Chico Provide Grant Funds to Support Local Small Businesses

BUTTE COUNTY, CA (MPG) - In an effort to offset the impacts of COVID-19 on local businesses, both the County of Butte and the City of Chico have allocated American Rescue funds to support local business stabilization through the implementation of the Butte Business Stabilization Program II ("Grant Program").

The Board of Supervisors allocated \$1,500,000 toward the Grant Program and will provide up to \$10,000 grants to businesses with 20 or fewer full-time employees. Eligible applications will be pooled by the six jurisdictions (Biggs, Chico, Gridley, Paradise, Oroville, and Unincorporated Butte County).

"The effects of the pandemic on Butte County businesses have been ongoing since 2020, with increased costs and decreased sales," said Butte County Board of Supervisors Chair, Bill Connelly. "These businesses are a major part of our economic engine, and we want to protect and preserve them. Allocating these funds for for-profit businesses is one way we will continue to extend that assistance while businesses work to recover from the impacts of COVID-19."

The Chico City Council has extended the pool of available funds for businesses within the city limits of Chico by allocating \$1,000,000 toward the Grant Program and will support businesses with up to 100 full-time employees. These grant funds will be made available to qualifying businesses after County funds have been expended.

'The City of Chico is committed to helping local businesses thrive," said Mayor, Andrew Coolidge. "Recognizing the vital role small businesses play in driving our local economy, this grant program will provide job creators the support they need and assist in the recovery from the pandemic's far-reaching impacts."

Applicants who submit a complete application packet will be chosen by way of a lottery system after a three-week application period. Applications will be accepted beginning May 2, 2022 until 5pm on May 20, 2022.


· Keep anything that can burn, as well as children and pets, at least three feet away from open flames

Preliminary Hearing Concludes for Double Murder Suspect

BUTTE COUNTY, CA (MPG)

- A Gridley man was held to answer following a preliminary hearing for the murder of two Alabama men, whose bodies remain

Butte County Superior Court Judge Kristen Lucena found there was sufficient evidence presented by the prosecution during the

two-day hearing to order of the two men from Ricardo Banuelos, 30, of Gridley, to stand trial for both counts of murder.

Butte County District Attorney Mike Ramsey said Banuelos is charged with two counts of murder. If convicted, Banuelos faces life without the possibility of parole.

Ramsey said the case began with an investigation launched in November of 2021 when family members

Alabama reported the men had come to Gridley but failed to return. The investigation revealed Banuelos had previously been sending commercial amounts of marijuana to the men in Alabama. Evidence showed that the men flew out to California on November 4, 2021 and were met by Banuelos and his brother. Alfredo, at the Sacramento Airport. Cell phone photos and video sent by the Alabama men to family members showed them to be at Banuelos' residence on East Evans Reimer Road in Gridley on November 4, before they vanished.

Friends and family of both John Dubose Jr., 20 of Selma, Alabama, and Ladexter Pelt, 25 of Eutaw, Alabama, told investigators they had no contact with either man since November

Physical evidence, including blood DNA matching back to one of the men, was found in a detached garage at Banuelos' residence.

Ramsey said the bodies of the two missing men have not been located.

After the preliminary hearing, the defense requested Banuelos be released on bail. Judge Lucena denied the request and ordered Banuelos to be held without bail.

Ramsey said investigators are actively searching for

Oroville Woman Pleads Not Guilty to Injury to Child While Evading Police

Butte County DA Press Release

BUTTE COUNTY, CA (MPG)

- An Oroville woman accused of running her car into a car containing a fiveyear-old child while fleeing a police vehicle, was in court Thursday, April 28. The child was seriously injured as a result.

Banessa Santana, 33, of Oroville, appeared this morning in Butte County Superior Court on charges of Fleeing a Pursuing Peace Officer's Vehicle

and Hit and Run Driving, resulting in serious injury. Santana entered a not guilty plea.

Butte County District Attorney Mike Ramsey said the charges relate to a March 12, 2022, incident where an Oroville Police Department officer saw Santana driving a vehicle and recognized her as being wanted on a felony warrant for a charge of Escape. The officer turned on his red lights and siren, but instead of stopping, Santana took the officer on a high-speed

chase through a residential area of Thermalito, running stop signs and traveling in excess of 50-60mph. The officer had started to slow down after three miles as the chase had become too dangerous, and Santana had gone over a hill approxi-

mately a quarter mile away. Ramsey said Santana then collided into the rear of another vehicle being driven by a father and his two children, ages eight and five. The father and children were taken to the hospital for treatment. The five-year-old child however suffered major injuries and spent several weeks in the hospital because of the collision. The child is slowly recovering but will have permanent injuries.

Ramsey said Santana fled from her damaged vehicle on foot and remained at large until April 21, 2022, when she was spotted as a passenger in a vehicle by Gridley Police Department. When the car was pulled over by Gridley police, Santana jumped out of the passenger seat of the vehicle and led officers on a foot chase but was quickly chased down and arrested.

Santana also appeared in court Thursday on the Escape charge. Ramsey said that last year, on May 26, 2021, Santana had been placed on a home incarceration program by the Butte County Jail for a conviction of felony vandalism and a GPS monitor was placed on her ankle. That same day, Santana cut off the ankle monitor and deposited it in the trash

can of a gas station less than a mile from the jail. A warrant was issued for Santana's arrest for Escape and was outstanding on the day she was spotted by the Oroville police.

Santana will next appear in court for a preliminary hearing on all charges on May 19, 2022. She is currently in custody in the Butte County Jail. The judge has denied her request for bail given her history of flight. She faces up to nine years in prison on the charges.


The chair at the table suddenly is empty and all you are left with are pictures and memories.
