## Coming Soon: Nostalgia!

*Back in Time Arcade II Set to Open in Gridley*

**GRIDLEY, CA (MPG)** - Nostalgia is the name of the game for Back in Time Arcade II.

Actually, it is Pac-Man, Mortal Combat, air hockey and more! Back in Time Arcade II, soon to open in Gridley, is one of two family owned and operated retro style arcades brought to the public by Damien Granados and Chris Swanson.

Granados and Swanson met while both were searching for arcade games. Granados was looking for popular games that he could easily

refurbish. Swanson, who has a background in electronics, was looking for the same. "I started seeing this guy named Damien selling games on (Facebook) Marketplace," Swanson said. It piqued his interest, the two met and it relit a fire in Swanson for working on broken games.

Of their working relationship, Granados says, "My thing is the bodywork, new graphics, making them look pretty. And then that is where it's a perfect match because he's the electrical, electronics guy."

Granados opened Back in Time Arcade in Marysville in September of

2021. It was an instant hit. Granados says of his clientele, "It really surprised me that it's everybody, really, from 3-years-old to 80-years-old. It's the smiles on everybody's faces and the shock. Like, 'I haven't seen that game since I was 8-years-old' or whatever. I love all of that and that's really why I do it."

After meeting Granados, Swanson wanted to open his own location.

With Granados' help, Swanson is opening Back in Time Arcade II in Downtown Gridley on Hazel St., next door to Our Town Pizzeria.

## Developments South of Town

**GRIDLEY, CA (MPG)** - On April 19, 2022, a town hall meeting by Caltrans was held for the citizens of Gridley. A portion of the discussion that evening referenced the foot traffic that would come from future planned developments south of Gridley off Hwy. 99—developments that had shaped the preliminary Caltrans design plans.

Many residents of Gridley are not aware that multiple developments are being planned south of Gridley between Archer Avenue and West Liberty Road. In follow-up conversations about the town hall meeting between The Gridley Herald and Planning Commissioner Donna Decker, some items were clarified for the public.

The development Sunrise Village Senior Housing, east of 99, already has the approval to start. They will break ground soon. Caltrans is working with the developer for encroachment permits which will allow access to state right-of-way. Another multiple family housing development, Orchard View, is planned for the west side of the highway, south of Stuke Nursery. This developer is working with the City of Gridley and Caltrans for entry into the site and for shared access for future commercial uses.

A fuel station, mini market and coffee house are being proposed for the northwest corner of W. Liberty Road and Hwy 99. Plans have been submitted and have had some revision. A review of this proposal is scheduled for the May 18, 2022, meeting of the Planning Commission.

Within these future developments is a discussion of annexing areas around W. Liberty Rd. to Gridley. A few property owners are interested in pursuing annexation. Before that happens, a first step of amending the Sphere of Influence through the Local Agency Formation Commission (LAFCO) has to be completed. LAFCO agencies are independent regulatory commissions created by the California Legislature to control boundaries of cities. Donna Decker, who provided this information, states that, "...this is a lengthy process that we are undertaking now."

More information can be gathered at the Planning Commission meetings in person or by Zoom. The Planning Commission meets the third Wednesday of every month at 6:00 PM in the City Council Chambers at 685 Kentucky St., Gridley. ★

## No Gas for You

California's clean-air regulators unveiled a far-reaching proposal requiring a ramp-up in sales of zero-emission cars, culminating in a ban on new gasoline-powered cars by 2035.

The rules to force Californians to end their dependence on conventional cars are a critical component to California's goals to tackle climate change and poor air quality.

If adopted by the California Air Resources Board this summer, the regulations would be the first in the world and could pave the way for nationwide standards. At least 15 other states pledged to follow California's lead on car standards on previous clean-car rules, and the

federal government usually follows.

Carrying out Gov. Gavin Newsom 2020 executive order ordering the board

to end the sale of gas-powered cars in California by 2035, the new proposal sets in motion the public regulatory process.

Public comments will be collected for 45 days, then a hearing will be held on June 9 and the

board is expected to vote in August.

"This is a hugely important inflection point. This rule finally, definitively puts us on the path to 100% zero-emission vehicles," said Daniel Sperling, a member of the Air Resources Board and founding director of the University of California, Davis Institute of Transportation Studies.

An alliance representing nearly all automakers said in a statement Wednesday that they are "committed to electrification and a net-zero carbon transportation future." Many major manufacturers, including General Motors, have already announced goals to ramp up clean-car models on a similar timeframe.

But the automakers added that it's critical for governments to ensure that "everything from (electric car) infrastructure, demand, critical minerals and supply chain are in place." Even then, the companies said the state's proposed rules "will be extremely challenging even in California and may not be achievable" in other states.

If enacted, 35% of new cars, SUVs and small pickups sold in the state must be zero-emission starting with 2026 models, then increasing yearly, reaching 51% of all new car sales in 2028, 68% in 2030 and 100% in 2035. Of those, 20% can be plug-in hybrids.

The rule does not apply to sales of pre-owned cars, and it wouldn't do anything to force the millions of existing gasoline-powered cars off roads. Only about 2% of cars on California's roads were zero emissions in 2020.

Vehicles that run on gasoline or diesel fuel are the state's biggest sources of planet-warming greenhouse gases, smog and dangerous particles. Under the proposed regulation, about 384 million fewer metric tons of greenhouse gases will be emitted between 2026 and 2040, according to air board staff - a little less than the total amount that the state emitted in 2019 across its economy.

California has already enacted standards that will require roughly 8% of new cars sold in the state to be zero emission in 2025, according to air board staff. That goal already has been exceeded: About 12% of California's 2021 new vehicle sales were clean cars, according to state data.

But the pace would have to triple in just five years to reach the new target, which the automakers dubbed "aggressive."

One of the biggest roadblocks could be the lack of charging stations for electric cars. Nearly 1.2 million chargers will be needed for the 8 million zero-emission vehicles expected in California by 2030, according to a state report. Right now, there are only about 70,000 with another 123,000 on the way, falling far short.

Another obstacle is the cost of the vehicles. "The cost to manufacturers will be high per vehicle in the early years, but significantly decrease over time by 2035," the air board's staff report says.

The economic benefits of the mandate are expected to exceed the costs: The costs could run \$289 billion over the lifetime of the rule while the economic benefits could reach at least \$338 billion - a net benefit of \$48

billion, according to air board staff.

Electric cars now cost more to purchase, but price drops plus savings on gas and maintenance would add up, saving consumers an estimated \$3,200 over ten years for a 2026 car and \$7,500 for a 2035 car, the air board calculated.

In an effort to address consumer reluctance, manufacturers would be required to meet minimum performance, durability and warranty requirements for zero-emission vehicles. Cars must be able to drive at least 150 miles on a single charge, up from the current 50-mile mandate, and batteries will need to last longer and carry a manufacturer's warranty.

The goal is to ensure that new and used zero-emission vehicles "can serve as full replacement vehicles for conventional vehicles in every household in California," the air board says.

Environmental advocates had raised concerns about previous drafts, saying they ramped up too slowly, allowing millions of cars powered by fossil fuels to remain on the roads since the average car is driven for 12 years.

Starting at a sales requirement of 35% is "a marked improvement," said Don Anair, research and deputy director of the Union of Concerned Scientists' clean transportation program. Still, he said, "It's kind of the bare minimum. So we really see that as a floor, not a ceiling, to get started."

Environmental groups urged the board to set a more stringent target of 75% zero-emission sales in 2030. They also are seeking mandatory equity provisions that would ensure electric cars are in communities that suffer the most pollution.

Under the proposed rule, car manufacturers would be allowed to meet a small portion of their sales targets through 2031 with credits aimed at helping low-income residents. For instance, they could earn credits for selling less-expensive new zero-emission cars costing less than \$20,000 or ensure that vehicles are offered up for resale in the state.

Last year Newsom approved a \$3.9 zero-emission vehicle budget that included about \$1.2 billion to bolster rebates and other clean-car incentives, particularly for low-income

and disadvantaged communities. Another \$300 million will go toward building charging and fueling infrastructure.

Newsom touted the \$10 billion zero-emission vehicle funding package in his January budget blueprint, which he said would "expand access and affordability for all."

The state auditor has warned the Air Resources Board, however, that it "has generally not determined the effects its incentive programs have on consumers' behavior and thus, has overstated (greenhouse gas) emissions reductions its incentive programs achieve."

While battery-powered cars emit no pollutants, the generation of the power that runs them does. However, air-quality regulators say emissions from electricity generation are far lower than from vehicles. Much of California's electricity comes from natural gas, solar, wind and hydropower.

Other nations are on similar paths toward phasing out fossil fuel-powered vehicles, but no state or nation has adopted a rule that bans them. However, the European Union is considering a large package of climate change laws that would, in effect, prohibit fossil fuel cars by requiring a 100% cut in all carbon dioxide emissions by 2035.

California's proposal comes as gas prices soar to more than \$5 per gallon in the state. Critics say the Newsom administration is sending mixed messages about gasoline-powered cars by proposing rebates for car owners.

The zero-emission vehicle proposal will require approval of the U.S. Environmental Protection Agency for implementation. Since the 1960s, the state has led the country in cleaning up the exhaust that creates California's choking smog. The federal Clean Air Act gave California authority to set its own tailpipe emissions standards.

The Trump administration acted to eliminate that authority but President Joe Biden's EPA overturned the decision in March. Newsom called it "a major victory for the environment, our economy, and the health of families across the country" and said the state "looks forward to partnering with the Biden Administration to make a zero-emission future a reality for all Americans." ★

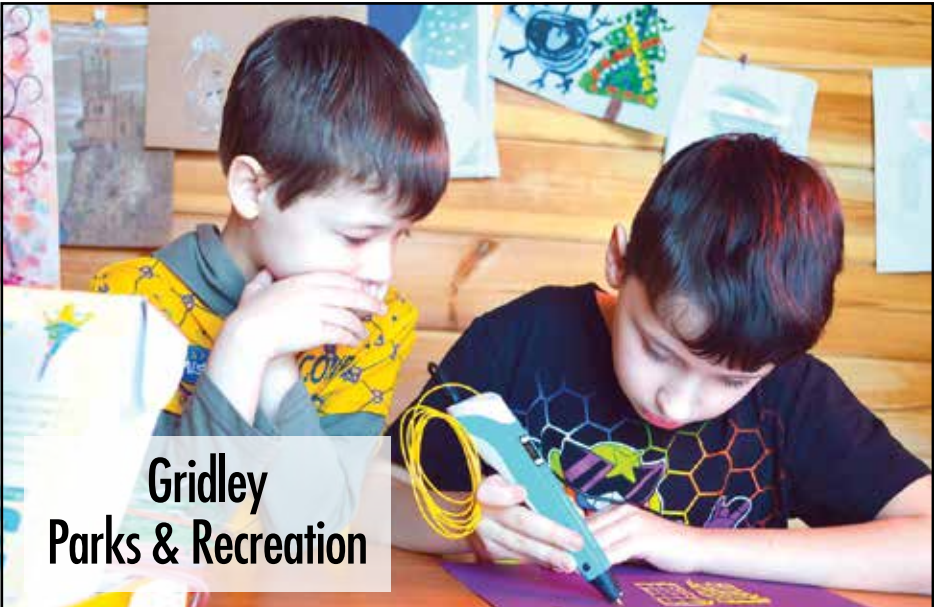

**Deep Freeze Severely Impacts Valley, Foothill Winegrape Growers**

Winegrape growers in the northern San Joaquin Valley and Sierra Nevada foothills are tallying losses from an April frost that devastated crops in many areas. Some growers report the freeze destroyed more than 90% of winegrapes. Two counties—Amador and Calaveras—are preparing disaster declarations based on crop losses averaging 60% or more. Much of the damage occurred during a four-hour freeze spanning night and pre-dawn hours April 11 and 12.

**Port Delays Worsen for Farm Products, as Empty Containers Sent to Asia**

Tree nuts, fresh produce, dairy products and other California farm commodities continue to pile up. That is happening as fewer ships arrive to pick up cargo at the Port of Oakland, where farm products account for 60% of total exports. Agricultural shippers were frustrated as some 67,000 containers left empty during the first two months of 2022, nearly double from last year. Three out of every four containers returning to Asia were reported empty.

**UC Extension Offers Certification Training for Water Diverters**

California law requires water-rights holders, including agricultural interests, to measure and report the water they divert from rivers and streams. It's a complex process, requiring metering equipment and, often, expenses in hiring professionals to do the work. But the state is now allowing water-rights holders to do the measuring themselves—if they complete certification courses offered by University of California Extension. The reporting requirement applies to diversions exceeding 10 acre-feet a year.

**Scientists Target Glassy-Winged Sharpshooter, a Peril to Grapevines**

Scientists at the University of California, Riverside, are researching gene-editing technology that may help neutralize a dangerous agricultural pest. The research is targeting the glassy-winged sharpshooter, a pest whose resistance to insecticides has been growing. The flying insect transmits bacteria that causes Pierce's Disease, which infects vineyards and poses a worrisome challenge for California's \$58 billion wine industry. ★

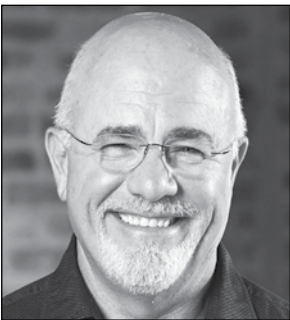

# A Gift from the U.S. Government

With the stock market in free fall, and most bonds (IOU's from businesses and government entities) following suit, investors are looking for alternatives. Cash is safe, but holding cash in an inflationary environment will result in a loss of purchasing power.

But there is an investment that offers both inflation protection and the 100 % safety of U.S. government backing.

A Series I bonds, offered by the U.S. Treasury Department, are currently yielding 9.62%. The interest rate paid on these bonds increases as inflation rises, which is why the yield has skyrocketed.

An I bond earns interest two ways: a fixed rate and a variable rate. The variable rate is adjusted every six months. Note that your rate can also adjust downward or upwards if the underlying interest rates change. The bonds duration is 30 years, but an investor can cash them in at any time after the first 12 months.

In the first six months, you'll get the prevailing interest rate at that time. Then your bond will adjust to whatever new rate is announced in October and adjust every six months thereafter.

If you need cash and turn in the bond before it's at least five years old, you'll pay a penalty of the last three months' worth of interest, but if you do the math, it's only a small portion of the total amount.

Interest on the bonds is also exempt from state and local taxes, but you will still have to pay federal taxes on any gains. There are also special tax considerations if you use the proceeds for higher education purposes.

To buy I bonds, you must be:

- A U.S. citizen, even if you live wabroad
- A U.S. resident
- A civilian employee of the U.S. government, regardless of where you live

Trusts and estates can also purchase I bonds in some cases, but corporations, partnerships and other organizations may not.

You need to set up a Treasury Direct account at [Treasurydirect.gov](http://Treasurydirect.gov)., and have a taxpayer identification number (such as a Social Security number), a U.S. address, a checking or savings account, an email address and a web browser that supports 128-bit encryption.

Although children under age 18 cannot set up a TreasuryDirect account, a parent or other adult custodian may open an account for the minor which is then linked to their own.

Once you have an account, TreasuryDirect will email your account number, which you can then log in to your account. Select "BuyDirect" and then "Series I bonds", then select the bank account to use and the date you'd like to make the purchase.

The limits per calendar year are:

- \$10,000 in electronic I bonds (\$20,000 for married couples)
- \$5,000 in paper I bonds with your federal income tax refund

You can buy more every year and even set it up to automatically repeat the purchase each year.

You can read more about I bonds or open an account at [Treasurydirect.gov](http://Treasurydirect.gov).

At the current yield of 9.62%, and the Feds expected to raise rates at least few times in the coming months to curb inflation, an I bond or two might be just the ticket to help combat today's rising inflation with the added feature of U.S. government backing.

# Fast-Food Menu

Dear Readers:

One day last week, I found myself busy during the lunch hour and didn't stop to eat until around 2 p.m. I went to a fast-food restaurant and ordered a small sandwich, medium fries, and a diet soda. Later I realized the moderate-size meal I had consumed contained nearly 800 calories! The fries were delicious, but were they worth it?

It is estimated that Americans eat one-third of their meals away from home. While fast food is a convenient and relatively inexpensive option, the calories add up. Instead of getting more for our dollar, we get more around the waistline. Increased calories lead to weight gain, and obesity is one of the leading contributors to diabetes, heart disease, high blood pressure, stroke, and possibly some types of cancer.

In last week's column, we mentioned that restaurants with twenty or more stores are required to list calorie counts on their menus. In a study published in the British Medical Journal, more than 242 million food transactions were evaluated over three years. The data was collected in fast-food restaurants in the southern United States. After calorie labeling, a decrease of 60 calories per transaction was observed. However, this was followed by an increase of 0.71 calories per transaction over the next year (1).

Particular subpopulations seem to use the calorie counts more effectively. Women, dieters, and people of higher income levels made healthier choices. The calorie labeling was more effective when a 2000 calorie-a-day recommendation was posted.

At first glance, it seems the effect of

calorie labeling would be easy to measure. People either ordered items with more calories or less, right? However, measuring the impact on society's health is much more complex. For example, after realizing how many calories they were consuming in fast food, some customers may quit going to those restaurants altogether. While this may be a healthy adjustment, measuring its impact on public health is complex.

If you have to eat on the run and fast food is a convenient option, consider these guidelines:

1. "Small-size it" instead of super-sizing it. Americans love to get more for their money, but in the case of high calories, maximizing the value of your dollar just doesn't pay off.
2. Skip the fries. If you must have them, order a small size.
3. Consider ordering the kid's meal for about 500 calories. Enjoy the toy.
4. Drink water, unsweetened tea or coffee, or a diet drink. A 20-ounce sugar-sweetened soft drink costs about 250 calories; a 32-ounce provides 385 calories, and a 40-ounce soda pop brings in a whopping 500 calories!

The implementation of calorie counts on menus may not solve the obesity problem in America, but it's a step in the right direction. Increased awareness and education are vital keys to making healthier choices.

# Rural Conservative CA Shorted COVID Dollars

Due to the unprecedented billions of COVID dollars coming from the Federal government in 2020-21 California State Auditor Elaine Howle cautioned that there could be a high risk of waste, fraud and abuse. She appeared before state officials in January 2021 to present evidence of a lack of fairness and equity in the distribution of funds to rural counties and cities.

Howle argued that smaller cities and counties received less per capita in Covid relief funds than larger jurisdictions in violation of federal guidelines. It is no secret that smaller rural counties are the more conservative people of California and were more resistant to Covid un-Constitutional dictates. They were also less supportive of the governor. Could the governor have used Covid funding to politically punish them during a national crisis?

State Finance maintained that illness rates were higher in the more densely populated urban regions but Howle countered that there is no evidence of that. In fact, she argued that rural communities could have experienced higher Covid impacts.

Governor Newsom pledged to withhold funding from cities and counties that did not follow his public health orders. Howle argued that the state did not consistently monitor that issue. At one point in the ongoing California distribution

of funds 16 large counties received about \$190 per person while the 42 smaller counties got \$102 per person her audit revealed. In addition, the 16 more densely populated counties already had received funds directly from the Federal government according to Howle. (U.S. Treasury paid \$5.8 billion directly to California counties and cities with populations greater than 500,000.)

"It's a pretty common frustration in California," said Assemblyman James Gallagher, a Republican who represents six smaller counties. "The way that funds are distributed tends to favor the (San Francisco) Bay Area and Los Angeles, where the majority of the legislature are from, right? Whereas, the rural areas really feel like they get kind of short shrift."

In some cases less populated counties had higher rates of infections. Imperial County, with a population of just over 188,000 people, averaged 3,215 COVID-19 cases per 100,000 people while Los Angeles County, with more than 10.1 million people, averaged 989 cases per 100,000 people.

The state's strategy, Howle said, contradicted guidance from the U.S. Treasury that urged states to "treat local governments equitably, regardless of their population size." "By not equitably providing counties with funds, there is greater risk that more small counties' COVID-19 related funding needs were unmet," Howle wrote.

The state initially withheld money from two cities – Coalinga (\$212,000) and Atwater (\$387,000) – after they passed resolutions defying un-Constitutional and nonsensical public health orders. But Howle said the Governor's Office

of Emergency Services (OES), which was in charge of monitoring local governments, "could not demonstrate that it had evaluated all cities." (476 cities)

The City of Imperial passed a resolution defying the Governor's orders, encouraged businesses to open and still received their funds. Howle challenged the hit and miss "informal" approach to evaluating compliance. OES eventually funded Coalinga and Atwater in spite of their resolutions as a result of pressure from the Auditor.

The state's Employment Development Department was responsible for distributing a larger sum of unemployment checks than any other state had in modern history. In the rush to get people funds, the department paid billions of dollars (\$31 billion as of Jan 2021) in claims that since have been found to have been fraudulent, Howle said. Many inmates in California prisons received unemployment monies.

California Corona Virus money funded hundreds of millions in contracts (often no-bid) with large corporations that had been very generous underwriting the Governor's political campaigns.

The moral is that the more money and responsibility you give people with no accountability or integrity the bigger the disaster. Covid policies killed more people and damaged more lives than the mild illness ever could.

The Covid Agenda again revealed the moral bottom feeders that pose as our leaders.

# Catalytic Converter Thefts Lead to Search Warrant and Arrest

## Yuba County Sheriff’s Department News Release

**OLIVEHURST, CA (MPG)** - Yuba County Sheriff Detectives and Patrol Deputies served a search warrant on April 21 at approximately 9:00 a.m. and discovered a stolen vehicle and auto parts chop-shop operation at a dilapidated residence in the 1600 block of Broadway Road in south Olivehurst. The owner/occupant of the property, identified as 59-year-old William Morrissey, was located

at the home and placed under arrest for Auto Theft, Possession of Stolen Property, Possession of a Controlled Substance, and Drug Paraphernalia. Yuba County Code Enforcement also responded to the scene and declared the home unsafe to occupy. Today’s search warrant and subsequent arrest was the result of a several-months-long investigation into catalytic converter thefts in the community. Dozens of auto parts were seized from the property, including several catalytics.

Additionally, during the course of the investigation, approximately 30 catalytics were intercepted and seized from shipments allegedly made by Morrissey to mail-in recycler businesses. Locating owners of stolen catalytics can be difficult since the parts do not usually contain any identifying properties to trace back to victims. We encourage vehicle owners to have identifying information, such as your driver’s license number, etched onto these valuable parts. Catalytic converters are commonly targeted for their precious metal content. If you have been a recent victim of a catalytic converter theft and your part had an identifiable mark or number on it, please contact our department to see if we may have recovered your stolen property. A second subject contacted on scene, identified as Roy Crabb age 47, was arrested for several outstanding warrants including a violation of parole. Both Crabb and Morrissey were booked into the Yuba County Jail. ★

**COLUSA COUNTY, CA (MPG)** - On April 21, 2022 at about 7:00 AM, the Colusa County Sheriff’s Office served a search warrant and arrested 5 suspects in connection with a large-scale, illegal indoor marijuana grow operation. The operation was taking place inside an old rice mill located on the 200 block of E. Main Street, Colusa, CA—just outside of the city limits. The illegal operation had been taking place for several months. The large-scale, illegal indoor marijuana grow operation has been connected to

other operations in the San Joaquin County area. The San Joaquin County Task Force assisted in the investigation when they discovered a connection to the Colusa County location. The investigation resulted in the seizure of 4,832 mature plants and the arrest of 5 suspects. The Colusa County Sheriff’s Office Specialized Operations and Response (SOAR) Team assisted in the service of the search warrant. The suspects arrested during the service of the search warrant were booked into the Colusa County Jail and currently face charges for violations of Health & Safety Code; 11358

- Illegal cultivation of marijuana and Penal Code; 182 – Conspiracy to commit a crime. The 5 suspects arrested were as follows: Bo Sen Tan, age 45, from San Leandro, CA; Hong Pin Zhen, age 52, no address listed; Guo Ming Zhang, age 56, no address listed; Xin Shi Yu, age 45, no address listed. Zhui Gou Hiu, age 43, from Brooklyn, NY. The investigation is still ongoing. If anyone has information regarding the illegal marijuana grow operation at the 200 block E. Main St. location, they are asked to contact Sergeant Arnold Navarro at (530) 458-0200. ★

# Oroville Man Sentenced to Life for Molesting His Daughter

**BUTTE COUNTY, CA (MPG)** - A Butte County judge handed down a 15-year-to-life sentence on Wednesday, April 27 for an Oroville man who was convicted of molesting his daughter.

Oroville, was charged in August of 2020 with two counts of sexual abuse, relating to his now 9- and 11-year-old daughters. Smith was tried in front of a jury in August of 2021. Sentencing was delayed when Smith fired his trial attorney and hired a new attorney to bring a motion for a new trial, which was eventually denied by the judge.

During the trial, the victims testified their father had been molesting one of them for years, and the other endured a single incident. The children were between the ages of 5 and 7 when they were molested. Another daughter, 14-years-old when she testified, told the jury that her father attempted to touch her inappropriately on one occasion when she was 12,

but that he was unsuccessful. The girls said the abuse stopped after the defendant was arrested in 2016 for domestic violence against his wife, child endangerment for creating a hostile home environment, and multiple violations of a restraining order. The girls did not disclose the abuse to their mother

for over two years after the 2016 arrest. The children were living with their mother and a grandparent in another city and had not seen their father since the domestic violence incident. During the trial, a golden retriever “victim comfort dog” named Reuben from the Lutheran Church Charities sat with the victims at the witness

stand as they testified. Judge Jesus Rodriguez also set a probation violation hearing Wednesday for June 8, 2022, to determine if the defendant violated his probation from his domestic violence case. If found in violation, Smith could receive an additional 6 years and 8 months in addition to the 15 years before he would be eligible for parole. ★
