GRIDLEY, CA (MPG) - Gridley's Rotary Club had the opportunity to hear from five ladies during its annual speech contest, held Thursday, March 3rd.

The five young women out of Live Oak took on the topic of "Serve to Change Lives". Speeches were required to be at least 5 minutes in length and no longer than 8 minutes, and under penalty of possible disqualification, the students were not allowed to use their names, school names, props, display logos on their clothing or mention their sponsoring Rotary Club prior to or

during their speeches.

Rotary President Lisa Van De Hey said that the club extended the date of the contest in order to generate more participation. With 5 contestants, Gridley Rotary had a strong turnout. Advisor to the contestants, Stephanie Allen, said that her students were excited when the opportunity for the speech contest arose but due to short notice, only had a week to prepare. For some, this was their first speech contest. The audience would not have known it, as each speech was impressive. The students spoke about what "Serve to Change Lives" meant to each of them, and who or what inspired the focus of their speeches.

With no 5th place, Olivia Taylor and Eamen Khan tied for 4th place, Maddie Bole took third place and a scholarship cash prize of \$50. Muskaan Rai took 2nd place with a prize of \$100, and the grand prize of \$200 and first place went to Fatima Corona. Corona and Rai will have the opportunity to move on to the area contest, which encompasses clubs in areas north of Yuba City, with the potential of two Roseville clubs joining in. The area contest is set to be held March 26th with the winner of that contest moving onto the District Level of competition, to be held at the Rotary District Convention, April 30th, 2022.

- As cases and hospitalizations of COVID-19 in Butte County have started to trend downward and the State shifts away from some of the mitigation requirements, Butte County Public Health (BCPH) is rescinding the local Health Officer orders for COVID-19 isolation and quarantine effective on March 5, 2022. These orders were originally issued on October 18, 2021 with an amendment on January 19, 2022. Rescinding the local isolation and quarantine orders means individuals need to follow the California Department of Public Health (CDPH) guidance for isolation and quarantine protocols.

YUBA CITY, CA (MPG) - On Sunday, February 20th youth from the local chapter of the Navy Sea Cadets had the opportunity to participate in aviation activities led by experienced pilots. The crew, many of whom were Navy veterans, flew into Yuba City to meet the local youth and their families. Three of the pilots were women and there is hope to encourage girls to pursue aviation and aeronautics.

The Cadets were shown various small airplanes and helicopters, including a 2-seater plane from the World War 2 era. One highlight of the experience was when each of the 40 cadets were able to take turns being flown over the Sutter Buttes. Some even chose to livestream it on Facebook.

The Sea Cadets is a nationwide youth organization sponsored by the U.S Navy. While not officially part of the military cadets (ages 10-18) they regularly participate in drills and physical training. Younger cadets (10-14) make up the T.S Randy Goodman division while 10- to 14-year-olds belong to the Mathew Axelson Division

In addition to physical training there are classes on various topics from mechanics to resume writing. Some cadets even elect to undertake more advanced military style training. Any teen who completes the program can enlist in the military at an advanced rank should they choose to do so. Cadets come from a variety of different backgrounds. "Everyone is equal when they put on that uniform," says Lt. Sherry Herkal, who leads the Sea Cadet

Herkal makes sure that all potential cadets have the chance to be included. There are some fees for membership and uniforms, but local individuals and groups have made donation or sponsored individual youth. Sea Cadets has paid this forward, and volunteering is another of their values. They have recently been involved with assisting local veterans and military families.

Two Fatalities in Head-on **Collision on Hwy** 70 near Cox Lane

OROVILLE, CA (MPG) - On March 4th, 2022, at approximately 11:18 PM, Chico CHP Communication center began receiving calls of a reckless driver traveling southbound on State Highway 70 in the area of Cox Lane. Shortly after the initial calls, CHP started receiving calls the vehicle collided head on with another vehicle, just south of Cox Lane.

When CHP arrived on scene, they observed a vehicle on fire with the driver still inside the vehicle. Officers immediately began trying to extricate the driver and obtained a fire extinguisher. Officers were able to put the fire out before it reached the cabin of the vehicle. Officers began rendering aid until Fire and EMS personnel arrived on scene.

During the preliminary investigation, it was determined the driver of the black Chevrolet Sonic was traveling southbound on State Highway 70 and for an unknown reason, swerved into the northbound lane colliding with a gray Toyota Camry. As a result of this collision, both drivers suffered fatal injuries, the 32-year-old female passenger in the Camry suffered major injuries, and the 18-monthold passenger in the Camry suffered minor injuries.

The investigation is still being conducted and it is unknown at this time if drugs or alcohol played a factor in this traffic collision.

Green Rivers, Green Beer, Leprechauns, Oh My!

GRIDLEY, CA (MPG) - So, what's with green beer and green rivers on St. Patrick's Day? It seems odd that celebrating a saint's day would be a raucous, carousing time. Especially when that saint was a strict one who made every effort to convert the Irish to Christianity with great success. St Patrick was not Irish. He was originally a slave of Irish raiders. According to the Smithsonian Magazine, it became a drinking holiday in America around 1900. It was during this time that beer was dyed green in celebration. In Ireland it was an important saint's day, all pubs were closed, until it became a drinking holiday in the 1970s.

The complicated history of rebellion and famine brought many Irish people to America starting in the 1600s. The color green became political in Ireland in the 1600s during an uprising to get the British occupiers out of Ireland. The traditional parade in New York City was originally military during

the Revolutionary War. Irish soldiers in the British army showing cultural pride marched past the Old St. Patrick's Cathedral

in New York City on St. Patrick's Day 1762. In 1816 the parade became coordinated by

Irish fraternal organizations. It continues to this day.

While green beer has been guzzled since the 1900s in celebration of St. Patrick's Day the Chicago River being dyed green is a much newer tradition. In the early 60s dye was being used in the Chicago River to trace river pollution. This inspired the celebrants of Chicago to dye the river green for St. Patrick's Day. This is now a yearly ritual. Both the green beer and the green river are strictly American traditions but in the 1980s the green beer started showing up in the pubs of the cities in Ireland on St. Patrick's Day.

West holds a Master's Degree in Geography from CSU, Chico. She is a Butte County native, the place of her childhood home, which was destroyed in the North Complex Fire.

Artificial Sweeteners

Dear Dietitian,

I am on a diet, and I usually drink one or two diet sodas a day. A coworker insists that diet sodas cause weight gain instead of weight loss. Is this true?

Suzanne

Dear Suzanne,

Artificial sweeteners, or nonnutritive sweeteners (NNS), made their debut with saccharin in 1884 in Germany. Saccharin is sold in the US under the brand name Sweet' N Low®. Today there are numerous NNS on the market, some of which are aspartame (NutraSweet® and Equal®), sucralose (Splenda®), and stevia (Truvia® and Stevia In The Raw®).

Studies are mixed when it comes to artificial sweeteners and weight loss. In a randomized trial, 303 overweight participants were instructed to drink 24 ounces of water or artificially- sweetened beverages. Both groups were on a weight loss plan. At the end of three months, those who consumed the artificially-sweetened drinks lost more weight (13 pounds) than those who drank water (9 pounds). The increase in weight loss is attributed to the opportunity to satisfy a sweet tooth with something that has no calories (1). It is important to point out that the American Beverage Association funded this study, which may be a conflict of interest.

There is some concern that NNS lead to weight gain. An eight-year study found a strong link between people who use artificially-sweetened beverages and weight gain. Those who drank the most diet soft drinks gained the most weight. This study was observational, which does not prove cause and effect. Of note, most people who drank diet soda were overweight at the beginning of the study compared to those who didn't use artificial sweeteners. They also identified themselves as dieters, and long-term weight gain is associated with chronic dieting (2).

Professional organizations differ in their opinions of NNS. The US Dietary Guidelines cite "insufficient evidence to recommend the use of low-calorie sweeteners as a strategy for long-term weight loss and weight maintenance" (3). The American Heart Association and the American Diabetes Association have released similar statements. However, the position of the Academy of Nutrition and Dietetics is that "consumers can safely enjoy a range of nutritive sweeteners and nonnutritive sweeteners (NNS) when consumed within an eating plan that is guided by current federal nutrition recommendations, such as the Dietary Guidelines for Americans, as well as individual health goal and personal preference" (4).

Nutrition experts make a strong point in that the risks associated with consuming a high-sugar diet are greater than the risks of consuming nonnutritive sweeteners. In the context of a weight loss plan, the use of NNS will likely help you reach your goal.





California's Green Energy Mania **Threatens Grid Reliability**

California is failing at the government basics. Public safety, homelessness, roads, and water storage are all in shambles. But as long as that shameful list is, it's about to get longer. With summer around the corner, when demand is at its zenith, our energy supply will not be up to the task.

California's headlong rush towards zero-carbon power will cost consumers through wildly expensive electricity rates and lower grid reliability. That's a lose-lose for California families and businesses who want to avoid blackouts and avoid energy poverty.

Golden State politicians and Progressives groups with an almost total overlap - live in dread fear of possible changes in weather decades in the future. Instead of planning for localized mitigations to deal with changing climate, they've decided to remake our entire energy sector, replacing affordable, dependable sources with their opposites.

A case in point is the closing of the Diablo Canyon nuclear power plant, scheduled to stop operations in 2025. Despite disingenuous claims that PG&E is choosing to close this facility, they are being forced into closure by California regulators who can make relicensing extraordinarily time consuming and expensive.

How important is Diablo Canyon? It currently produces about as much power as all the rooftop solar in the entire state. And unlike solar and wind, this power is available on-demand, 24/7. PG&E, the plant's owner, alleges it will replace all the lost power with so-called green, renewable resources, but what if it can't?

The North American Electric Reliability Corporation (NERC), a non-profit dedicated to promoting grid reliability, thinks it won't. NERC notes that California already has insufficient reserve power to meet demand during a heat wave. Closing Diablo Canyon will only contribute to declining reserve margins, according to NERC.

All of that is to say that blackouts are coming when it gets hot in California, as it does every summer. Don't be surprised when your AC won't click on, or you're burning candles for light in this supposedly advanced state. The blackouts are entirely predictable and a direct result of California energy policy making our grid unreliable by replacing on-demand resources with intermittent ones.

And remember, California is pushing people into electric cars through incentives and government decrees. Many people will be charging up those EVs when they get home from work, right after solar energy production peaks. We are creating dreadful imbalances that will lead to energy rationing in one of the wealthiest areas in

Venture capitalist Marc Andreessen recently tweeted about the Ukrainian crisis and its effect on our energy markets and independence, "Build 1,000 new state of the art nuclear power plants in the US and Europe, right now. We won't, but we should." He's right all the way around regarding energy independence and reliance on aggressive rogue states such as Russia for our energy.

But it's the last line that hits closest to home in California. We need to reverse our green energy mania that prices electricity like a luxury good and guarantees blackouts. Dependable, affordable energy is within our grasp if we commit to predictable, on-demand resources such as nuclear and natural gas. We won't, but we should.



Senate Bill 743 (SB 743) was signed into law which changed the environmental emphasis from vehicle level of service (LOS) to vehicle miles travelled (VMT). The State Office of Planning and Research (OPR) has published Guidelines with recommendations on how VMT might be reduced to further a state goal of reducing greenhouse gas emissions and improving air quality by reducing the emissions associated with the length and number of vehicle trips. Most of OPR's recommendations can be applied to urban or built areas where land uses are closer together, mixed use is economically viable, and transit is more accessible OPR recognizes that rural areas should be treated differently based on their land use and transportation context but uses a definition of rural that would exclude Butte County. A recommendation for an interim VMT threshold for the unincorporated area of Butte County, drafted for consideration by the Planning Commission, corrects this oversight and explains why most of Butte County remains rural. Recognizing that there are areas of the County where connectivity to trails and transit can occur, the interim thresholds also establish requirements for development in and around established communities. This threshold is considered interim as modifications will occur over time, and state initiatives may change how the County will need to consider VMT from future development projects.

At this public hearing, the Planning Commission will make its recommendation concerning the interim VMT threshold to the Board of Supervisors who will consider this project at a future public hearing.

The California Environmental Quality Act (CEQA) Guidelines Section 15064.7. states that each public agency is encouraged to develop and publish thresholds of significance that the agency uses in the determination of the significance of environmental effects. Nothing in the CEQA Guidelines states that adopting thresholds is subject to environmental review.
