

Look no further than your favorite restaurant, your kid's school or your local hospital to see the effect of California's latest bout of infections.

Cases have skyrocketed since the holidays, reaching nearly 7 million people infected since the pandemic began. That means so many workers are calling in sick that many businesses and offices are left understaffed and fellow workers are stretched thin.

Health officials are walking a fine line between keeping essential services and the economy afloat and controlling the spread of the virus. But a labor shortage has noticeably influenced national and state COVID-19 policies even temporarily allowing for health care employees to continue working despite a positive test as long as they feel no symptoms and wear an N95 respirator. These guidelines have prompted questions about safety and whether public health is being jeopardized.

Since the start of the pandemic,

California's top officials have been adamant that the state's COVID-19 response is based on science. But these policies also have to be flexible, Gov. Gavin Newsom recently told reporters.

"It's called dealing with reality," the governor said in defense of recent health workplace guidelines during his Jan. 10 budget briefing. "The pragmatism – not what you want, but what you need to do at a time of challenge."

Experts note that the virus and the pandemic environment are fast-changing, and policies in response have to adjust quickly.

But labor needs and politics aside, when it comes to returning safely to work, what are experts and research telling us about omicron? When is it safe for an infected employee to return to work and how dangerous is it to shorten that period? What if you have no symptoms? And what should your employer be doing to keep you and your coworkers safe? Here's what you need to know.

A red flag with omicron is that early research suggests that the incubation

period – the time between when one becomes infected and when one starts to show symptoms – is shorter with this variant – about three days, compared to the four to five days of earlier strains.

Usually, the day before symptoms start and the day symptoms appear are when people are the most infectious, said Sanghyuk Shin, director of UC Irvine's infectious disease science

That means people can become highly infectious faster with omicron than with the previous variants. For example, if person A is infectious and A infects B, person B can then infect person C quicker with omicron than they may have with delta.

"This creates epidemic dynamics that are really hard to get in front of," said Andrew Noymer, epidemiologist and professor of public health at UC Irvine. "Because it's

CTC Allocates \$589 Million for **Transportation Improvements**

SACRAMENTO, CA (MPG) - The California Transportation Commission (CTC) allocated \$589 million for projects to repair and improve transportation infrastructure throughout the state. Senate Bill (SB) 1, the Road Repair and Accountability Act of 2017, accounts for \$302 million – more than half of the funding.

"This investment follows our 'fix-it-first' commitment to repair California's aging infrastructure, while at the same time increasing transit and active transportation options," said Caltrans Director Toks Omishakin. "These projects will make our transportation system safer and more convenient for all users and create thousands of good-paying jobs in the process."

Among those projects approved was one on State Highway 32 in Chico from Muir Avenue to Highway 99 that will rehabilitate pavement, install signals and lighting, upgrade Transportation Management System (TMS) elements, rehabilitate drainage systems, and upgrade facilities to Americans with Disabilities Act (ADA) standards. The project was allocated \$3.51 million.

Caltrans also presented the CTC with the draft 2022 State Highway Operation and Protection Program (SHOPP) at our meeting. Aimed at preserving the condition of the highway system, the draft 2022 SHOPP accounts for \$17.3 billion in funding over a four-year period and includes projects for safety, restoration, road and bridge preservation, and other highway-related facilities.

The CTC will host a public hearing in February to receive comments on the draft SHOPP. All the comments will be considered in the final version that goes before the CTC for adoption at its March meeting. All 2022 SHOPP projects are available on the Caltrans' Ten-Year Project Book website, ProjectBook.dot.ca.gov

SB 1 provides \$5 billion in transportation funding annually split between the state and local agencies. Road projects progress through construction phases more quickly based on the availability of SB 1 funds, including projects that are partially funded by SB 1.

LIVE OAK, CA (MPG) - Drivers may have noticed the lack of signs, cones, and otherwise closed lanes as they make their way through the City of Live Oak on the Highway 99 corridor.

The Live Oak Streetscaping project, which begun in 2020 and is "funded in part by \$2.3 million from Senate Bill (SB) 1, the Road Repair and Accountability Act of 2017, and a \$10 million federal Transportation Investment Generating Economic Recovery (TIGER) grant. The \$36 million project," according to Caltrans, will "improve access for pedestrians and bicyclists" along with traffic flow. The project has seen heavy construction consume the stretch of Highway 99 that begins just north of Ramsdell Drive, continuing south

through Live Oak to just past Ash Street, for well over a year and a half now. As Caltrans has worked its way through town, residents and drivers have experienced shifting lanes,

road closures at vital intersections in the city, loss of easy access to local businesses and more.

Recently, lanes previously closed have opened, along with intersections

and crosswalks. With the finished installation of new light fixtures, construction of ADA compliant sidewalks and crosswalks, new parking spaces along the Continued on page 2

We went from having stores where you would go and buy stuff to the modern-day today in which people buy things on the Internet, and it shows up at their house; this transformation and upward trend happened in about ten years. Do you want to know what the next thing is? Next is,

already have to go to - like a grocery store or gas station. Other countries have already adopted this new model of getting their stuff, according to Katharina Buchholz statista.com. Parcel pick-up stations are gaining popularity as a convenient option to receive packages in some markets. Especially in China - where e-commerce is booming – most respondents said they had used or tried to use parcel pick-up stations in the past 12 months before the survey. Countries with many urban consumers were more likely to favor using these stations. They offer easy round-the-clock pick-up of packages and might be located closer to people's houses than the post office or designated stores that traditionally offer parcel pick-up. In some instances, online vendors like Amazon also offer a discount for the pick-up station compared to standard delivery. In the six-country survey, Swedes were the most avid adopters

a box at a place where you behind the Chinese at 36 percent use in the past year. Besides having items delivered directly to one's home, Swedes favored most traditional post office pick-up. Germany was ranked third at 19 percent parcel station use. In the country, picking up your parcel from neighbors was the most popular besides home delivery. Use of the pickup stations was lower in the U.S. at 13 percent. Those who live in big cities and do not have concierge law enforcement services like Biggs, Gridley, and Live Oak may be more inclined to use a box for picking up stuff just so it does not get stolen. Small-town people may live in small towns because we like human-based reality shopping. highway, landscaping, and the addition of a stoplight at Kola Street, the project appears to be completed. Almost.

Gilbert Mohtes-Chan of Caltrans says that despite looking finished, the project is not yet 100 percent complete. According to Mohtes-Chan, there are still some miscellaneous projects that Caltrans crews will be working on to put the finishing touches on the project, but that they are "on the home

stretch". Weather permitting, Mohtes-Chan says that Caltrans is targeting the end of February for completion of the project, which was hoped to be finished December 2021. It is rumored some sort of ribbon-cutting type event will be held to celebrate the completion of the project.

GRIDLEY, CA (MPG) - The beginning of February is the astronomical midpoint between the Winter Solstice and the Spring Equinox. In ancient Celtic Ireland and Scotland, it was Imbolc, the first indicator of Spring. Bonfires and lamps were lit to bring on the light and to honor the goddess Brigid, goddess of fertility, crafts, poetry and prophecy.

Imbolc was replaced with St Brigid Day, then

In 1887, there was a hunting club called Punxsutawney Groundhog Club. A newspaper editor member declared the groundhog of Punxsutawney, PA to be the true weather predictor of America. Punxsutawney Phil remains the best known of the rodent meteorologists.

There are other lesser-known forecasters. The farthest east groundhog predictor is in Nova Scotis. Sam lives in a hollowed-out log at the Shubencadie Provincial Wildlife Park. He is ushered in with bagpipes and a town crier. Then we have Charles G. Hogg of the Staten Island Zoo who has two honorary doctoral degrees. Not to be outdone is General Beauregard Lee of Atlanta, GA. who inhabits a miniature southern mansion.

This is the short list of groundhog meteorologist around the U.S. No matter how the beginning of Spring is predicted we all know it is on its way in February in California. ★

State-wide Homeless "Point in Time Count"

GRIDLEY, CA (MPG) - Throughout California on January 26, 2022, the biannual count of the Homeless was conducted in towns throughout each county.

This is a project required by the U.S. Department of Housing and Urban Development (HUD). Its purpose is to tally the numbers of homeless in communities, which includes anyone sleeping in a park, on the street, in a vehicle, or those that have no permanent home.

Gridley's count was run out of the Lions Den on Washington Ave. Posters were distributed around town to help notify the un-homed in the Gridley area of the count. The day of the count, two Gridley Lions had their quad-runners and took social workers out to various living

sites to the south and east of Gridley. Each homeless person who agreed to answer the questions received a \$5.00 food card. Although some took advantage of the chance to be heard, not all were cooperative about answering the questionnaire.

A rough estimate of the homeless counted in our area is 28 persons.

The purpose of the "Point in Time" count gives the homeless population a voice about their housing, personal needs, and experiences of living without a home. The "Point in Time Count" is also how the Federal and State governments determine funding that goes into communities to help with housing. It also keeps track of sub-groups of homeless such as families, elderly, youth, veterans, and domestic violence survivors.

Alleged Serial Killer Held to Answer after Preliminary Hearing

BUTTE COUNTY, CA (MPG) - An Oroville man, who has been held in jail on an attempted murder case since June 2020, attended court for a preliminary hearing on charges related to an alleged previous killing spree in Butte and Tehama counties. Ryan Scott Blinston, 38, of Oroville, was held to answer for three separate counts of murder, attempted murder, and arson, which took place in May and June of 2020.

Butte County District Attorney Mike Ramsey and Tehama County District Attorney Matt Rogers said the evidence presented today showed Blinston worked for a tree-trimming service and was part of a work crew at the home of Loreen Severs, 88, and Homer Severs, 91, on May 18, 2020. The Severs lived in Los Molinos and the evidence showed Blinston travelled to Los Molinos from Oroville, on the morning of May 23, 2020, and killed Loreen and attempted to kill Homer after a forced entry into their home. Both had their throats cut. Homer survived the attack, but later died of an unrelated illness in December of 2020.

Ramsey and Rogers said evidence was presented today showing that on June 4, 2020, Blinston again was part of a tree-trimming work crew that serviced the home of Sandra George, 82, in Oroville. The prosecutors said after the work was completed and the crew left, Blinston returned to George's home and killed her. As with the Severs, her throat was slashed inside her home.

Further evidence was presented at the hearing that on June 6, 2020, Vicky Cline, 57, an acquaintance of Blinston, was last seen alive with him in downtown Oroville. An arson fire destroyed Cline's car later that night. Blood and DNA evidence on and in Blinston's car was forensically matched back to Cline. Her body was later discovered by a fisherman in the Feather River near Belden on June 21, 2020. Damage to her throat was consistent with the other victim murders.

Butte County Superior Court Judge Michael Candela ruled after the hearing that there was sufficient evidence to proceed to trial in the murders, attempted murder and arson case against Blinston.

Judge Candela also scheduled the case for arraignment and jury trial setting on January 26, 2022, on the separate attempted murder case that he had already been held to answer on. In that case, Blinston was accused of attempting to murder a 50-year-old man in the man's Brush Creek trailer on June 14, 2020, while a SWAT team was approaching to arrest Blinston for the Cline arson. Blinston was then held in Butte County Jail as investigators put together the other Butte and Tehama murder cases.

Blinston continues to be held without bail as he is facing multiple murder cases and a sentence of life without

Overdose Averted

BIGGS, CA (MPG) - Quick thinking and action by a Butte County Sheriff's Department deputy may have saved a life recently in Biggs.

According to a Facebook post made by the Butte County Sheriff, on January 27th, shortly after 11:00 am, a BCSO deputy patrolling in Biggs, near D and 9th Streets came across a person inside a vehicle, slumped over the

steering wheel. According to the post, the deputy attempted a welfare check on the individual and trying to contact the driver, who was unresponsive. The BCSO deputy's observations led him to believe that the individual was exhibiting signs of an opioid overdose.

"Our deputy administered two doses of Narcan, and the subject regained consciousness and was then transported to a local hospital for further treatment," says the post. It continues, "All BCSO deputies are equipped with Narcan, which is a nasal spray used to block or reverse the effects of an opioid overdose. We would like to thank our deputy for his swift actions, which likely saved a life. If you or someone you know is experiencing a substance abuse issue, help is available. 

Meatless Substitutes

Dear Dietitian,

This past weekend, a friend encouraged me to try a meatless burger. I was pleasantly surprised to find that it was delicious and tasted like meat! Are these meatless substitutes better for you than

Dear Josh.

When it comes to consumer satisfaction, burgers made with meat substitutes taste like meat, look like meat, and have a similar texture. Consumers are switching to plant-based diets for many reasons, including protecting animals, preserving the environment, and general health concerns. Sales of meat alternatives have risen 60% over the last two years, garnering \$922.2 million in 2020 alone (1).

Many of these meat alternatives are made of soy which contains isoflavones, a plant estrogen. At one time, this was a concern for the increased risk of breast cancer in women. However, research has shown there are not enough isoflavones in whole soy products to increase the risk of breast cancer. Caution should be taken, however, when taking soy supplements or consuming processed soy products, which contain larger amounts of isoflavones (2).

One advantage of a plant-based diet is it tends to be higher in fiber. A high fiber rates of obesity, heart disease, type 2 programs, or diet plans.

diabetes, and possibly some types of cancer. One disadvantage of choosing meat substitutes is they are about twice the cost of meat per pound. Consumers can dodge this price hike by choosing whole foods, such as beans, lentils, and soy as their protein sources. Another disadvantage is the lack of vitamin B12 in a diet free of meat and animal products. If you choose to go vegan, consider a B12 supplement, as its function is vital in nerve function.

Are meatless alternatives better for you? My mantra is "Keep it simple." The same rules apply to meat substitutes as they apply to meat when assessing nutritional value. Is it high in fat? What about saturated fat? What is the sodium level? Is it a good source of protein?

When opting for a meat substitute, choose one made from whole foods. Look for items made from tofu, beans, vegetables, and quinoa. Choose a product seasoned with herbs and spices, and beware of fillers, which add calories but little or no nutrition. A rule of thumb is if you can't pronounce it or it contains more than four syllables, it may be a filler. Last but not least, select a product that is low in saturated fat.



Proposition 12 Hog Requirements Could Complicate Junior Livestock Sales

The housing requirements for hogs under California's Proposition 12 don't apply to 4-H programs and exhibitions at fairs or rodeos. And yet the California Agricultural Teachers' Association says administrative costs and burdens imposed by the law on meat processers will impact junior livestock exhibitors who want to sell project pigs into the general food market. That's because those market hogs will need paperwork showing they come from farms certified as Proposition 12-compliant.

Citrus Farmers Face Rising Costs, Smaller Harvests

California citrus growers are facing increasing costs for bringing their crops to market. The California Citrus Mutual trade association says farmers are facing price increases in water, labor, fertilizer, pesticides and transportation. Amid drought and pandemic-related supply-chain challenges, 4% of last season's citrus crop was neither picked nor sold. This year, a down-year growing cycle, the navel crop is expected to drop by 20% and mandarins by as much as 45%.

December Storms Deliver Modest Increase In Water Allocations

California farmers and ranchers may have some modest relief in water allocations this year due to December rains. The California Department of Water Resources is increasing deliveries from the State Water Project to 15% of requested supplies for 2022. That's an improvement from last year when water officials provided just 5% of allocations. That was before the state cut off surface water supplies from the Sacramento-San Joaquin Delta in August due to severe drought.

Output Drops For Processing-Tomato Farmers Amid Challenges

California's anticipated tomato production shrank last year due to water shortages and higher production costs, farmers say. Some processing-tomato growers who once paid \$3,000 per acre on their crop say they're paying more than \$4,000. Last year, state processors intended to contract for 12.1 million tons of tomatoes. By the end of harvest, that figure had dropped by 1.3 million tons, as farmers adjusted production forecasts downward.

PG&E Offering to Remove Debris from Trees Cut Down During 2021 Wildfires

PG&E Press Release

SAN FRANCISCO, CA (MPG) - In response to customer and community feedback, Pacific Gas and Electric Company (PG&E) is offering customers free removal of large-diameter wood from trees that were cut down for safety during the company's 2021 wildfire response.

As PG&E worked to restore power quickly and safely during the 2021 wild-fire season, crews inspected and cut down hazardous trees that posed a potential safety risk to crews and electric equipment. The work was done in coordination with agencies responding to the wildfires.

With this work now largely complete, PG&E is offering landowners the opportunity to have trees that were cut down for safety removed from their property, provided it is safe to do so.

Because the wood is the landowner's property, removal of the wood is optional, and landowners must provide written permission to PG&E to have the wood removed. PG&E is in the process of reaching out to impacted landowners

to offer the removal services and provide permission forms.

Earlier this year, PG&E and contractor crews began removing and disposing of large-diameter wood from 2020 wildfires. PG&E recently expanded the voluntary program to encompass 2021 wildfires.

If approved by the landowner, PG&E will be removing wood debris from trees cut down for safety in response to the following wildfires: Anderson Fire, Cache Fire, Caldor Fire, Dixie Fire, Fawn Fire, Hopkins Fire, KNP Complex Fire, Linda Falls Fire, McFarland Fire, Monument Fire, North Complex Fire, River Fire (Colfax, Oakhurst), Salt Fire, Washington Fire

omicron variant was responsible for about 38% of the cases in the U.S., according to the CDC's variant monitoring system. By the week ending on Jan. 15, omicron made up 99.5% of cases.

In late December, the Centers for Disease Control and Prevention shortened the recommended isolation period for a person who tests positive but no longer has symptoms from 10 days to five. Those who were exposed but haven't tested positive should also quarantine for five days, the agency said.

The CDC said the change was motivated by growing data showing that much of the transmission was occurring earlier "generally in the one to two days prior to onset of symptoms and the two to three days after."

But this move came with quite a bit of pushback and criticism from some in the public health and medical communities who deemed it too lax, especially because the federal rules don't require a negative test to leave isolation. California updated its guidance to align with the CDC's, but the state does ask that people remain isolated until they receive a negative test.

Some research has shown that people can still be contagious after five days of testing positive. A small study from Harvard, for example, took a look at infected NBA players and found that 25% of players infected with omicron were still infectious on day six after their

first positive test and 13% were still contagious on day seven. The study has yet to be peer-reviewed.

"Having people who might still be infectious return to work, could of course lead to more people getting infected and additional workers being forced to isolate," Shin said.

While recommendations about isolation and quarantine can be hard to keep up with, the bottom line is that people should test negative before returning to work and gathering with others, regardless of symptoms, Noymer said.

Asymptomatic transmission does occur and it's a big reason why the pandemic has been so difficult to control

"We can tell everyone who feels sick to stay home, but not everyone feels sick," said Shin.

Experts say the best public health practice is for anyone who tests positive to isolate, regardless of how they feel.

Studies – albeit, many conducted pre-omicron – have shown that a large percentage of COVID-positive people show no symptoms. Research published in December reviewed 95 studies consisting of about 30 million people world-wide. Of those who tested positive, 40% had no symptoms at the time of testing. "The high percentage of asymptomatic infections highlights the potential transmission risk of asymptomatic infections in communities," the research authors concluded.

Meanwhile, separate studies show that the viral loads of asymptomatic patients were comparable to those who had symptoms.

Trying to calculate the odds that you'll contract COVID at work is not really possible because there are so many factors to consider, experts say.

Research has shown that wearing masks indoors can substantially cut transmission, and with omicron, a high-quality mask is more important than ever. N95 masks are the gold standard, especially with a variant as contagious as omicron, Noymer said. Cloth masks are much less effective unless they have multiple layers and a nose wire. And it's essential for masks to fit snugly around the mouth, nose and chin.

"A well-fitting N95 mask should do a pretty good job. But nothing is guaranteed," he said. "Surgical masks do something, but they're not great...and some masks are just pure theater."

N95 masks can filter about 95% of particles in the air, according to the CDC. Experts at UC Davis say it is OK to reuse an N95 mask, but they recommend waiting one to two days between uses so that viral particles can die off.

How crowded a room is also plays a big role. If you're in a busy kitchen or warehouse without many windows, the risk will be greater, Shin said.

A molecular PCR test is the most sensitive and most likely to capture

an infection, but rapid antigen tests are effective tools too, experts say.

Antigen tests are often used for routine screening of people who are not sick. If being used as a precaution for an in-person gathering, for example, Shin says a repeat test could help rule out a false negative — a test the day before and a test the day of an event.

However, given the shortage of rapid tests, this could seem like a luxury. People with symptoms looking to confirm whether they're infected or not, ideally would seek a PCR test, Shin said. But with a backlog in testing, results are sometimes taking more than three days.

Because of the heightened demand for testing, some California counties have come out with new recommendations. Some have urged residents to only get tested if they have symptoms and others have asked people to first seek tests from their health care provider rather than county-ran testing sites because they are overwhelmed.

In an ideal world with no supply shortages, workers who come in contact with large numbers of people, such as those who work in customer service or in grocery stores, would be able to access testing easily and test repeatedly and routinely, experts say.

That said, routine testing of essential workers should go handin-hand with adequate paid sick leave, Shin said. "I've definitely known people who have said they don't want to get tested because they don't know what to do if they test positive. They can't not go to work, they need to pay rent."

California's COVID sick leave expired in September and legislators and labor unions are negotiating how to reinstate it.

Shin said there is room for more education of workers on how the virus spreads. For example, if someone is in an office space alone, they might think it is safe to take their mask off, but if that same space is occupied by others throughout the day, then people should keep their masks on because COVID-19 is airborne and infectious respiratory particles can remain in the air for up to three hours.

Improving ventilation helps,

"Opening windows seems like a no-brainer, but opening windows reduces risk," Shin said.

Workplaces should also consider investing in high grade filtration systems or high efficiency particulate air (HEPA) filters, experts say. According to the Environmental Protection Agency, filters need to be able to remove small air particles in the size range of 0.1 to 1 microns to help remove viruses.



Sequoia National Forest Most Popular for RVs in 2020

SAN DIEGO, CA (MPG) - The COVID-19 pandemic has been challenging for the travel and tourism industry as a whole. Through much of 2020, shutdowns and public health restrictions to limit the spread of the virus led many travelers to cancel or postpone trips. Relaxations on these restrictions, the release of vaccines, and declining cases early in 2021 brought back many travelers, but the emergence of the Delta variant last summer and Omicron this winter again scrambled travelers' plans.

Despite the general difficulties of the travel industry over the last two years, one segment that has fared well throughout the pandemic is outdoor recreation like camping and RVing. Because these activities take place outside and social distancing is easier, the risks of COVID exposure are low, which makes them an appealing alternative to airports, hotels, restaurants, and other locations where risk can be higher. The Outdoor Industry Association estimated that 7.1 million more Americans participated in outdoor recreation in 2020 than in the year prior.

New interest in outdoor recreation has forced related businesses to quickly scale up to meet demand. One example comes from the RV market. In February 2020 just before the pandemic began the RV industry shipped a total of 37,113

units, according to data from the RV Industry Association. That number dropped to just 7,197 amid COVID shutdowns in April 2020, but ever since, demand for RVs has exploded. In October 2021, monthly RV shipments totaled 57,971, an increase of 56% from immediately before the pandemic.

Unlike the segments of the travel industry that have faced low demand. outdoor destinations like those popular with RV drivers are seeing more visitors than ever. Many national parks saw record visitation in the summer of 2021, introducing new systems to manage overcrowding and in some cases turning away visitors. But COVID accelerated a trend of increased visitation to public lands that has been taking place for several years. A recent report from the Center

for Western Priorities found a 39% increase in the occupancy of reservable campsites on public lands during peak seasons between 2014 and 2020.

States in the western U.S. are seeing the boom and its effects most directly. States like Wyoming, Montana, and Idaho are home to some of the U.S.'s most famous national parks and forests. These features make those states top destinations for camping, RVing, and other forms of outdoor recreation, with visitors and residents alike seeking to take advantage of the states' natural attractions.

While western states experience some of the highest levels of visitation, the effects of stronger interest in camping and RVing can be felt in every state with public lands. For example, some of the top national forest destinations for RV travelers are found in locations like

Florida, Minnesota, and North Carolina in addition to western states like California and Colorado.

The data used in this analysis is from Recreation.gov. To identify the most popular national forests for RV campers, researchers at Outdoorsy calculated the total number of RV nights booked in 2020. In the event of a tie, the national forest with the greater number of total RV reservations in 2020 was ranked higher. It's important to note that these statistics only reflect reservations made on campgrounds managed by federal agencies, such as the National Forest Service.

NRA Wins Case Against Los Angeles County

FAIRFAX, VA (MPG) - The Ninth Circuit sided with the National Rifle Association Institute for Legislative Action (NRA-ILA) on Thursday, January 20th, 2022 when it struck down a Los Angeles County order that forced gun stores and shooting ranges to close in 2020 during the COVID-19 pandemic. NRA-ILA originally challenged this order in March of 2020, and filed an appeal a year

"The court today rightfully recognized that Los Angeles County violated Second Amendment rights when it shut down gun stores and ranges in the beginning of the COVID-19 pandemic," said Michael Jean, NRA's director of the Office of Litigation Counsel. "This is an important decision. It ensures that Californiaor any state-cannot use a crisis to trample on the Constitutional rights of citizens."

The decision highlights that these orders, which prevented the exercise of basic constitutional rights like acquiring and practicing with firearms, could have been "perpetually extended if the County so decided."

Given the current state of the world and the periodic resurgence of COVID-19 continuing to affect daily life, this decision ensures that states cannot restrict the fundamental rights of Americans for any reason. In this spirit, the decision concludes by citing Justice Gorsuch's words: "Even in times of crisis - perhaps especially in times of crisis – we have a duty to hold governments to the Constitution."

NRA-ILA also challenged overbearing COVID-19 restrictions in New Mexico and New York. In addition to Los Angeles County, NRA-ILA challenged four additional counties in northern California.

The case is captioned Martinez v. Villanueva. NRA-ILA was joined by local gun stores and ranges, the California Gun Rights Foundation, the Firearms Policy Coalition, and the Second Amendment Foundation in this lawsuit.
