Fidget Blankets for Hovlid Residents

GRIDLEY, CA (MPG) - The residents of Hovlid Community Center will be the recipients of blankets gathered by members of the Gridley Quota Club. The annual project for Hovlid is led by the club president. That president in 2021 is Jan Meyer. Many yards of fleece fabric were hemmed by Pat Scheyer. The gifts for Hovlid vary from year to year depending on the needs of the residents. In the past Quota members donated individual mugs as well as lap blankets. Quota members contributed money and time to the blanket project. This year 24 lap blankets and 24 fidget blankets will go to the Hovlid residents.

Fidget blankets can be made of any material. Various textures and bobbles are then attached to the blanket. These objects stimulate seniors with dementia when handled or fidgeted. They keep the users focused on an activity. This helps reduce emotional escalation that leads to agitation. The fidget

Mandated Masks Again

Starting Wednesday, (December 15, 2021) Californians will once again be required to wear masks indoors in public places regardless of vaccination status, state health officials announced today.

The renewed masking requirement follows a 47% increase in COVID-19 case rates since the Thanksgiving holiday and the arrival of new variant, said Dr. Mark Ghaly, the state's health secretary.

The mask mandate will run through January 15 and is specific to public settings, not private gatherings. Nevertheless, health officials recommend people get tested ahead of holiday gatherings and consider better ventilation by opening windows or convening outdoors when possible.

The mandate will mainly affect about 50% of the state population that lives in counties that currently don't have their own mask mandate, Ghaly said. Los Angeles and several Bay Area counties already have mask mandates for public settings in place.

Along with renewed mask rules, the state will also require that attendees at mega events - those of 1,000 people or more who are unvaccinated show proof of a negative COVID-19 test taken within one day, if an antigen test, or two days for PCR tests. The state is also recommending that travelers get tested before and after trips.

The first statewide mandate was imposed in 2020 and lifted last June.

After the state's June 15 reopening, vaccinated people were allowed to return to grocery stores, retail and other public settings without a mask - at least under state rules. People who were not vaccinated still had to adhere to indoor masking. Telling the difference, however, was tricky: Ghaly acknowledged today that throughout the pandemic enforcement of these rules has been a challenge.

Fly to the Slopes with SMF

SACRAMENTO COUNTY, CA (MPG) - The Sacramento region had its first major rainstorm of 2021 in October, which brought huge amounts of snow to the Sierra. So much in fact, several Tahoe ski resorts opened weeks earlier than planned which could be a sign of an incredible ski season to come! Whether you're heading to Lake Tahoe's spectacular slopes or to the Rocky Mountains and beyond, Sacramento International Airport (SMF) can get you to the snow quickly. SMF offers direct flights and easy

connections to many major ski destinations. Locally, Lake Tahoe is home to 15 ski resorts, 477 miles of slopes, 146 lifts and views you won't find anywhere else in the world. Ski racing began in North Lake Tahoe in the 1860s, when gold miners decided to attach boards to their feet and skim down the slopes, and the first resort was built in 1924. Today, there's a resort for every kind of snow junkie – skiers, snowboarders, beginners and experts. SMF is approximately 100 miles from Tahoe and offers numerous nonstop flights from major U.S. hubs. Making both the north and south shores easily accessible.

For Northern Californians who are venturing outside of the state, flights from SMF can get you to some of the country's best ski resorts in no time.

The Rocky Mountains stretch from British Columbia south to New Mexico, with dramatic mountain vistas, breathtaking ski terrain and as much as 33-feet of snow per year. Western Canada's renowned Whistler Blackcomb Resort can be accessed via several nonstop flights to Seattle (SEA) on Alaska Airlines, Southwest and Delta. Once you land, drive into beautiful British Columbia to one of the largest ski resorts in North America with a lift that can take you to an elevation of 7,350 feet.

Don't Fall for Holiday Scams

BUTTE COUNTY, CA (MPG) - In light of the rapidly approaching holidays, it is important for everyone to be prepared for an increase in scam calls. While there are many different types of scams, the Butte County District Attorney wants to remind everyone of ways to identity such scams and avoid becoming a victim. During the holidays, scammers use the increase in online sales to represent themselves as being from Amazon, Walmart, or other large retail or credit companies.

Scammers often have background information about the person receiving the call. This information is readily found on the internet and can include phone numbers, dates of birth, and addresses. Simply having this information does not make the caller legitimate. On the contrary, protected personal information is never provided over the phone from a legitimate company. You should never provide or confirm any information when receiving an unsolicited phone call.

The following are ways to help identify if the call is a scam:

Any unsolicited calls regarding a problem with an account or other problem.

Companies do not make phone calls to resolve problems, they send letters or emails with contact information for the customers to respond. Any unsolicited calls from companies should be considered a scam. If you do not recognize the number, do not answer, and let the caller leave a message. Avoid having any conversations with unsolicited callers.

The problem requires immediate attention. Scammers thrive on creating stress and use words like urgent or immediate attention required to prevent you from being able to think clearly. If the caller makes you feel rushed and/ or stressed, it is most likely a scammer. No legitimate company uses stress to address a business issue.

Cash is required and it needs to be sent immediately.

Large companies have financial departments that send notices of billing problems. They do not make unsolicited calls to the customer. Any unsolicited phone call that requires the transfer of

money is a scam.

Caller asks for pre-paid credit cards to cover the problem. Pre-paid credit cards are difficult to trace and do not require a name to be used. Most often scammers simply ask for the numbers on the cards, which can then be used to take the money off the cards without ever being in possession of the actual card. No legitimate business operates in this way. If someone asks for money, especially in the form of a pre- paid credit card, it is a scam.

Becoming hostile.

If you do not do what scammers want, they become aggressive and hostile. The more you prevent scammers from taking your money, the more they will verbally assault you. In many cases the scammers will claim legal action if you fail to do what they say. Do not fall for this tactic.

In the event you feel you are being scammed, tell them you want to research the issue and will contact the company directly; that you do not handle business over the phone. Ask for the caller's name, their supervisor, the name of the company and a call back number. Do not provide any personal or account information. Most likely the caller will become more aggressive and try to use scare tactics involving threats of jail or civil action. This is all part of their script. Do not give any information. If needed, hang up and notify your local law enforcement agency.

If you receive an unsolicited email, even if it looks as though it is from a legitimate company, DO NOT CLICK ON ANY PROVIDED LINK! A legitimate notice will provide directions for you to contact the company through secondary channels, never through a link in an unsolicited notice. If you have a question about authenticity, use contact information from the involved company website, or any correspondence you have previously received, not solely from the information provided on the

It is important to remember, legitimate notices do not require much on your part, the more the notice requires of you, the more the likelihood it is a scam.



Annie was vacationing with her parents and son Kai


in Maine when she was killed by a motorist while on a morning walk December 7, 2021.

Chico State Faculty and Staff **Charged in Grand Theft Schemes**

CHICO, CA (MPG) - Three former employees of the Chico State University School of Business, Department of Accounting were charged earlier this week in a criminal complaint that alleges they expensed fraudulent time, money, travel and other items to the University and the University Foundation.

Butte County District Attorney Mike Ramsey said the felony case against accounting professors Timothy Kizirian, 53, and Jeffrey Decker, 59, and the Accounting Department secretary Ronda McGrath, 55, began when a new Dean of the College of Business alerted the University in March 2019. The University administration began an of approximately \$24,517 investigation into financial irregularities in the dent placement" activities Department of Accounting. That investigation determined some \$1.12 million dollars had been spent over a period of several years on items such as duplicate compensation, gift card purchases, fraudulent mileage claims, improper travel and personal expenses including meals, hospitality and gifts and unreported absences. At the conclusion of the University's administrative inquiry, the matter was turned over to the Chico State University Police Department who launched their own criminal investigation. The Chico State University Police Department's investigation subsequently revealed the University and its founpatterns of alleged criminal fraud and manipulation investigators to be either that extended back to at least 2013. These included fraudulent travel claims, theft of time related to outside employment, improper never received them, and use of gift cards and meal reimbursements for student and mileage claims; as well meetings that the students

Count 2 of the felony complaint alleges Kizirian defrauded Chico State University and its Foundation in expenses for travel, "stuand other expenses between December 1, 2013, and November 30, 2018, which either did not exist, or were expenses for participants who were either not present, or not connected with university business. This included include a "Spring Social" at a Sacramento accounting firm on April 12, 2017, that never

took place. Count 3 of the felony complaint alleges that Kizirian and McGrath engaged in a pattern of fraudulent activity concerning Accounting Department expense reports between May 2014 and December 2018, wherein some \$9,219 in expenses submitted to dation were determined by false or personal in nature. Some expenses included gift cards reportedly given to students who reportedly as the manipulation of class themselves did not attend.

Email discussions between Kizirian and Decker demonstrated their belief the trip would be a "blast from the past" and contained discussions about their efforts to conceal the true nature of the trip.

Ramsey said the balance of the activities discovered in the civil and criminal investigations represented situations resulting from lax oversight by the University, including insufficient management and accounting controls and inadequate policy safeguards, but were not by themselves criminal, or were cases where evidence was insufficient to obtain a conviction.


Ramsey said he was informed the University suspended Kizirian, Decker and McGrath shortly after the administrative investigation was concluded in December of 2020. McGrath voluntarily resigned then retired in January 2021. Decker resigned in August 2021. Kizirian was dismissed in June 2021 but is contesting that dismissal through an arbitration board. The board held a hearing on the dismissal and is expected to issue a ruling next month to determine whether to uphold the dismissal or not.

Ramsey said if criminally convicted, Kizirian, Decker and McGrath face between three and five years, eight months in county jail. Ramsey said the case is set for initial arraignment in Butte County Superior Court







Proven to Decrease DUI Crashes. **ACCESS Launches Nationwide Program**

SACRAMENTO, CA (MPG) -

The Honorable Richard A. Vlavianos, in front of the California state capitol and surrounded by other Public Safety and Law Enforcement Officials. announced the launch of a new, nationwide non-profit organization designed to treat high risk and repeat DUI offenders. The new non-profit, ACCESS, launches with a foundation of learnings and track record of saving lives as proven through a pilot that's been active in California since 2008.

"After nearly 15 years and more than 5,000 participants, we've seen firsthand the difference this approach can make in changing behaviors and saving lives," said Chair of ACCESS and California Superior Court Judge Richard A. Vlavianos. "Each day, roughly 28 people die in drunk driving related car crashes and it's only fitting we make this announcement today as we kick off National Impaired Driving Prevention Month."

Current DUI and Drug Courts make an undeniable impact treating a smaller, more targeted population in need of

more significant support. ACCESS extends a similar approach to the remaining 70% of repeat DUI offenders that don't qualify for traditional DUI court. A recent study of the 5,200 participants indicates the concept is significantly changing behaviors with an 80% completion rate and most encouraging, a 19% decrease in DUI crashes. The six-year longitudinal study also found that participants did not revert to the norm upon completion of the program, indicating signs of long-term behavioral change.

"Existing special courts work with high-risk offenders who have high treatment needs, while ACCESS fills the gap by

focusing on offenders who may be high risk, but don't require the same level of treatment," said Judge Vlavianos. "To make an impact, we needed to ensure the ACCESS program was scalable and affordable. I'm excited that we can provide monitoring, education and training to repeat DUI offenders at a fraction of the cost of typical treatment programs, at about \$10,000 less per participant."

Discussions with multiple state law enforcement and judicial officials interested in launching ACCESS are currently underway. Those with questions or interested in learning more are encouraged to visit chooseaccess.org.

Communism and Christmas

ORLANDO, FL (MPG) - This Christmas season when the Biden administration is desperately trying to control Americans by denying their religious beliefs and forcing them to inject experimental shots into their bodies, it is important to examine how communism can quickly eradicate the Christian faith in a nation.

Before Ronald Reagan became president in 1981, he gave more than 1,000 daily radio broadcasts from 1975 to 1979, including one in which he shared a story about the history of Christmas in the Ukraine before and after communism.

In an effort to resist Christians, communist leaders secularized a favorite Ukrainian Christmas carol, "Nova Radist Stala" (Joyous News Has Come to Us). The original song began with these words: "The joyous news has come which never was before. Over a cave above a manger a bright star has lit the world, where Jesus was born from a virgin maiden" Communists feared the public outcry that would follow a complete ban on Christmas, so they began to slowly secularize the holiday. The first rewrite of the song began: "The joyous news has come which never was before, a red star with five tails has brightly lit the world." The second rewrite went further: "The joyous news has come which never was before. Long-awaited star of freedom lit the skies in October [the month of the Revolution]. Where formerly lived the kings and had the roots their nobles, there today with simple folks, Lenin's glory hovers."

The former Soviet Union eventually began banning Christmas commemorations. St. Nicholas was replaced with "Did Moroz," or Grandfather Frost. This Stalinist creation wears a red cap and long white beard of Santa Claus, but he delivers gifts to children on New Year's Eve. Christmas trees were also banned, but people continued to trim their New Year's trees. Communism folded all Christmas celebrations into a New Year's celebration.

Christians in the former Soviet Union exhibited bravery and courage in confronting communism's anti-Christmas campaign. One person recalled how the young people would go out in the streets and sing Christmas carols, knowing that if police heard them, they would be arrested. In communist Romania, Rev. Geza Palffy, a Roman Catholic priest, delivered a sermon

in 1983 protesting that December 25 had been declared a workday instead of a holiday. The next day he was arrested by secret police, beaten, imprisoned, and died. Inside and outside the Iron Curtain, Ukrainians never stopped singing: "We beg you our Lord, we pray to you today. Grant us freedom, return glory to our Mother Ukraine." Reagan ended his broadcast: "I guess we all hope their prayer is answered." Indeed

The secularization of Christmas is nothing new. Christianity Today in 2002 reported that in the Vietnamese province of Dak Lak, children's choirs were forbidden to sing "Silent Night." From 1969 to 1997, Christmas was banned in Cuba.

Legal challenges to Christmas and holiday displays have been ongoing for decades. The challenges to Nativity displays expanded to the public schools and even to nursing homes and assisted living centers. In some schools, students were told that Christmas cards, Merry Christmas greetings, singing religious Christmas carols, and even the colors red and green were not permissible. Some senior living centers prohibited residents from placing Christian or religious symbols on Christmas trees or decorating with any religious imagery. Around 2003, the censorship of Christmas entered the retail market. Christmas trees was renamed "Holiday Trees," Christmas decorations were referred to as "Holiday Decorations" or "Holiday Lights." In response to this trend. Liberty Counsel launched the annual Friend or Foe Christmas Campaign, which is designed to educate and, if necessary, litigate, to ensure that the religious and Christian viewpoints of Christmas are not censored.



In America, the First Amendment is a guard against censorship and religious hostility. In the retail market, the consumer can decide to patronize stores that recognize Christmas and avoid those that profit from Christmas while pretending it does not exist."



CORNER Calling 911

- 1. Do not panic. This is easier said than done. Panic does not help. Instead, begin to plan what you will say to the dispatcher.

 - · Location. Give the dispatcher your address or a detailed description of your location. The emergency is not always located where you are calling from. Always be aware of your surroundings and where you are. Try to keep a watch out for the road signs, business names and intersections whenever you may travel.

 Nature of the emergency: Do you require assistance from law enforcement, medical professionals, and/ or fire fighters? Have a detailed, yet concise, description of the emergency. In general, the most important thing is why you need assistance (a traffic accident, for example).







New Home Sales in Region Continue to Increase

North State Building Industry Association Press Release

SACRAMENTO, CA (MPG)

- New home sales in the Sacramento region are expected to continue rising for the next couple of years peaking at around 8,000 in 2023 before dropping off slightly in 2024. But while those sales totals are higher than most years since 2007, annual sales will remain far below they were before the Great Recession and well below the amount of new housing needed to meet current and expected demand, a panel of economists and builders said at the North State Building Industry Association's annual Regional Housing Forecast presentation.

Dr. Sanjay Varshney with Goldenstone Wealth Management, Dr. Dean Wehrli with John Burns Real Estate Consulting and Denton Kelley with LDK Ventures, told nearly 300 participants in-person and virtual that despite inflationary pressures, mortgage rates are expected to remain at historic lows, which will help counterbalance rising housing prices and keep the market for new homes strong.

Wehrli said his firm projects sales of 7,200 in 2022 (14.3% above this year), 7,800 in 2023 (8.3% higher than 2022), and 7,400 in 2024 (a 5.1% decline from the prior year.)

We are projecting over the next four years for the Sacramento MSA to

do pretty well. My biggest worry is, do we have the land to do it? We do in some places, not so much in others. Do we have the labor to do it? Do we have the supplies to do it? You hope the supplies will shake out some time next year, but labor is going to be constrained for the foreseeable future," he said.

He noted that builders have ramped up production, with permits up 41% in the region year over year, the fourth highest rate in the country behind San Francisco, Jacksonville, Fla., and

San Antonio, but that still isn't enough to meet demand.

We have ratcheted up supply, but I'd argue in the long-term perspective that new-home sales in the 7,000s is at or below the organic demand," he said.

Wehrli said a major demand driver has been the revolution in working from home caused by the COVID-19 pandemic. Varshney noted that Sacramento gained about 20,000 households from the Bay Area once tech workers didn't have to live close to their offices. Many people have moved to Sacramento, along with places like Austin, Tex., Boise, Ida., Reno and Phoenix, where housing was more affordable.

He added that the region remains well-positioned even if companies adopt a hybrid schedule, where workers are in the office two or three days a week and work from home the rest of the time.

"People who moved to Phoenix or Reno or Boise would have to be closer to the Bay if that happens, and our competitors are Tracy,

Lathrop and Manteca – and Sacramento has a lot more (amenities) than they do," he said.

If Bay Area companies do implement hybrid schedules, he said Elk Grove would benefit due to being closer to Silicon Valley than South Placer County or Folsom, but he said those submarkets have more land available and will likely be major growth centers for the next 10- to 20 years.

Kelley, who is developing The Railyards and focuses more on multifamily than single-family

housing, said about 3,000 units of market-rate apartments are in the pipeline, which he said was more than usual but because relatively few apartments have been built in the urban core during this cycle leads him to believe we're not overbuilding.

Lots of people still want to live in an urban environment, so my general feeling is if the city improves the environment downtown it should all work out as long as we continue to invest in amenities people want, he said.


