Mark Rober Presents World's Tallest Elephant's Toothpaste

GRIDLEY, CA (MPG) - Gridley was once again honored to help YouTube sensation and former NASA engineer, Mark Rober, create another one of his epic videos and surprise a well deserving young man with a party beyond his wildest dreams.

Rober first came to Gridley in the summer of 2020, bent on breaking world records and throwing cancer survivor Fletcher Rollinson, the biggest and best birthday party of his life.

Rober's team of engineers and scientists, along with locals, constructed a giant Erlenmeyer flask from hurricane glass and heavy timbers, which took the Guinness Book of World Records for biggest (or tallest) Elephant's Toothpaste by funneling Continued on page 3

Farmers, **Ranchers Have** Time to Replace Livestock

IRS Media Relations News Release

WASHINGTON, D.C. (MPG) -Farmers and ranchers who were forced to sell livestock due to drought may have an additional year to replace the livestock and defer tax on any gains from the forced sales, according to the Internal Revenue Service.

To qualify for relief, farmers or ranchers must have sold livestock on account of drought conditions in an applicable region. This is a county or other jurisdiction designated as eligible for federal assistance plus counties contiguous to it. Notice 2021-55, posted today on IRS.gov, lists applicable regions in 36 states and one U.S. territory.

The relief generally applies to capital gains realized by eligible farmers and ranchers on sales of livestock held for draft, dairy or breeding purposes. Sales of other livestock, such as those raised for slaughter or held for sporting purposes, or poultry, are not eligible.

The sales must be solely due to drought, causing an area to be designated as eligible for federal assistance. Livestock generally must be replaced within a four-year period, instead of the usual two-year period. The IRS is authorized to further extend this replacement period if the drought continues.

The one-year extension, announced in the notice, gives eligible farmers and ranchers until the end of their first tax year after the first drought-free year to replace the sold livestock. Details, including an example of how this provision works, can be found in Notice 2006-82, available on IRS.gov.

The IRS provides this extension to eligible farmers and ranchers who sold livestock on account of drought conditions in an applicable region that qualified for the fouryear replacement period, if the applicable region is listed as suffering exceptional, extreme or severe drought conditions during any week between Sept. 1, 2020, and Aug. 31, 2021. Investigation Conducted for Wound Botulism from Injected Black Tar Heroin

BCPH Press Release

BUTTE COUNTY, CA (MPG) - Butte County Public Health (BCPH) is investigating a case of wound botulism in a Butte County resident who injected drugs, including black tar heroin. Laboratory test results to confirm the diagnosis are pending. The source of the heroin is unknown at this time. Black tar heroin has been linked to other wound botulism cases and outbreaks in injection drug users, so there is concern that locally available black tar heroin may be contaminated.

California has the highest rate of wound botulism in the United States. This is the third case reported in Butte County this year.

Since 2016, there have been 22 to 59 cases of wound botulism annually in California. Wound botulism occurs when a wound becomes infected with Clostridium botulinum (the cause of foodborne botulism) or a closely related Clostridium bacterium. The bacteria multiply in the wound and create a toxin that acts on the nerves. Most, but not all, people with wound botulism will have a visibly infected wound. Persons injecting black tar heroin into their muscles

("muscling") or under their skin ("skin popping") are at highest risk of wound botulism. Persons with wound botulism cannot transmit the illness to others.

Symptoms of wound botulism occur within days or weeks of injecting contaminated drug and may be mistaken for drug overdose. Symptoms can include weak or drooping eyelids, blurred or double vision,

dry mouth, sore throat, slurred speech, trouble swallowing, difficulty breathing, and a progressive symmetric paralysis that begins at the face and head and travels down the body. If left untreated, symptoms may progress to paralysis of the respiratory muscles, arms, legs, and trunk with subsequent death. Prompt diagnosis and treatment is critical to decreasing the severity and duration of illness. Any injection drug users with symptoms of wound botulism should seek medical attention immediately at the nearest emergency


Healthcare providers should immediately report any suspected cases of botulism to BCPH. BCPH will facilitate testing and the acquisition of antitoxin treatment.

To Reduce Risk of Wound Botulism:

(1) Stop injecting drugs and seek treatment for opioid addiction: www.buttecounty.net/behavioralhealth/substanceuse. aspx (2) Do not use black tar heroin. Use of black tar heroin is the drug that most often results in wound botulism; (3) "Cooking" the drug and safe injection practices will prevent other blood borne infections, but will NOT prevent wound botulism.

Butte County Public Health Department Actions: (1) Issued a health advisory to area providers to promote rapid diagnosis and reporting; (2) Conducted outreach and provided information to homeless shelters, drug treatment facilities, and other locations that serve persons who may be at risk of wound botulism; (3) Alerted the public through a media release.

Continued from page 1 a blast of searing-hot red foam made from hydrogen peroxide, sodium iodide, soap, and food coloring, 60 feet into the air before the base of the flask failed. Regardless of the ruptured base, a new world record was set and gifted to Fletcher.

Rober, of course, saw the failure of the flask as an invitation to try a second time, and a year later, returned with his crew to Gridley and Dale Leishman's walnut dryer and huller. It also meant throwing another truly massive surprise party for an incredibly special young man, Brody.

During a grueling 3-year battle with blood cancer, Brody gave away his one and only "Make a Wish" chance he intended on using for a Quad, to another teen battling cancer after he had his "wish", also a Quad, stolen. Brody's selfless act of kindness drew the attention of not only Rober, but his friend, Mr. Beast, a YouTuber and philanthropist. But more on that later.

Like Rober says in the latest Elephant's Toothpaste YouTube video, "As word got out about Brody's story, the good people of Gridley came out in droves." Preparations for an out-ofthis-world surprise party and series of epic foamlocals out to help with the builds, from carpenters, heavy equipment opera-

Leishman's home, fully equipped with a giant skateboard ramp slip-n-slide into a pool, a pit filled with 26 million Orbeez balls (water gel balls) to swim in and jump into, a Devil Toothpaste experiment 2 ½ times larger than before, and a shot at crushing the world record with the largest Elephant Toothpaste experiment ever. But first, Brody would be flown to Sacramento for a meeting with a "new Doctor" so that Rober could reveal himself and then whisk the teen away, via private jet, to Gridley where this event of a lifetime would all take

To correct last year's 2021 Elephant Toothpaste's flask would have a custom poured concrete foundaflask. As for the Devil's Toothpaste experiment, troughs 2.5 times larger made for a huge explosion of foam that nearly engrossed an unoccupied ranch-house that served as the experiment site.

As the time came for the grand finale, guests gathered at the Leishman's walnut dryer and huller for the show of a lifetime! The experiment went off without a hitch, blasting glowing green foam skyhigh. Rober reports in his video: "When you do a side-by-side comparison of the max height from last year to this year, I'm happy to report, we absolutely destroyed the previous ing explosions brought problem with the base, the record by nearly a factor of 5, rising to the height of a 25-story building, at 250 feet. And so, with a new Guinness World Record under his belt, I still had one grand final surprise for Brody."

After Rober's friend Mr. Beast heard of Brody's good deed, Rober and Mr. Beast arranged for Brody to be the recipient of a new Quad. Brody, distracted by a video call with Mr. Beast, was delighted when Dale Leishman drove the sparkling new Quad up to the teen, surprising him with his original "wish."

Rober sums it all up perfectly in his video saying, "What's cool here, is this (quad) is the exact model he wanted to get for himself before he gave it away to someone else. And he didn't do that expecting to get something back in return - just like those who worked so hard to put this party together for him, didn't expect anything either. Which is why I believe, when you try to be a good person, it may not always come back to you immediately, but somehow, it always comes back."

COVID-19 Pfizer Booster Dose Available for Certain Groups

BUTTE COUNTY, CA (MPG) - Effective immediately, the CDC has authorized a COVID-19 Pfizer booster dose for certain groups of people, to be administered at least 6 months after their Pfizer-BioNTech primary series (after the second dose).

(Should get a booster) Persons 65 years and older; (Should get a booster) Residents of long term care settings; (Should get a booster) Persons aged 50-64 years with underlying medical conditions; (May get a booster) Persons aged 18-49 years with underlying medical conditions; (May get a booster) Persons aged 18-64 at increased risk because of occupational or institutional setting; Click to learn more about qualifying medical conditions: tinyurl.com/jt8cebmw

Butte County Public Health supports these recommendations made by CDPH

and the CDC and encourages residents who are at highest risk for COVID-19 to receive a Pfizer COVID-19 booster shot to help increase their protection.

Those who qualify may get a Pfizer booster dose in Butte County anywhere the COVID-19 Pfizer vaccine is currently available, including local pharmacies and community vaccination clinics. No documentation will be required.

The bulbs ordered in the spring have arrived. I was so happy to see that box. This helps my goal of yards covered in daffodils. This is an ambitious goal. Daffodils have not thrived in this yard. They grow and look great but they don't seem to spread. I check

have to buy more, but not many are ready for dividing. I feed them and I work at letting some of the leaves be present after blooming so the bulbs get lots of sun food. I think part of the problem is me. When I divide the bulbs, I don't want to leave only one. I want clumps of flowers so I leave clumps of bulbs. I auger a hole for the bulb and grind up an already existing bulb. I know the solution to this

to divide bulbs so I don't problem. This is why it is recommended that you map your flower beds. If I tracked where bulbs are already planted, I would know to move over a bit to plant so I don't destroy mature older bulbs. Maybe this is the year to map the bulbs I plant, we'll see. I have to do some prep work before planting the bulbs this year. Plus, I'm waiting until my shade tree is worked on by the tree service. I'm so happy for the blessing of not worrying about my beloved in a tree anymore. Tree guys will be risking their necks instead of him. I'm willing to pay for that alone. To get a well pruned tree on top of that is a bonus.

As a result, eligible farmers and ranchers whose drought-sale replacement period was scheduled to expire on Dec. 31, 2021, in most cases now have until the end of their next tax year to replace the sold livestock. Because the normal drought-sale replacement period is four years, this extension

impacts drought sales that occurred during 2017. The replacement periods for some drought sales before 2017 are also affected due to previous drought-related extensions affecting some of these localities.

More information on reporting drought sales and other farm-related tax issues can be found in Publication 225, Farmer's Tax Guide, available on IRS.gov.

IRS announces tax relief for victims of wildfires in California

Special IRS Notice

NORTHERN CALIFORNIA (MPG) - Victims of wildfires that began July 14, 2021 now have until Nov. 15, 2021, to file various individual and business tax returns and make tax payments, the Internal Revenue Service announced today.

Following the recent disaster declaration issued by the Federal Emergency Management Agency, the IRS announced today that affected taxpayers in certain areas will receive tax relief.

Individuals and households affected by wildfires that reside or have a business in Lassen, Nevada, Placer, and Plumas counties qualify for tax relief. The declaration permits the IRS to postpone certain tax-filing and tax-payment deadlines for taxpayers who reside or have a business in the disaster area. For instance, certain deadlines falling on or after July 14, 2021, and before Nov. 15, 2021, are postponed through Nov. 15, 2021

This means that individuals who had a valid extension to file their 2020 returns, due to run out on Oct. 15, will now have until Nov. 15, 2021 to file.

The Nov. 15, 2021, deadline applies to the quarterly estimated tax payment, normally due on Sept. 15. It also applies to the quarterly payroll and excise tax returns normally due on Aug. 2, 2021. Also penalties on deposits due on or after July 14, 2021, and before July 29, 2021, will be abated as long as the tax deposits were made by July 29, 2021

If an affected taxpayer receives a late filing or late payment penalty notice from the IRS that has an original or extended filing, payment or deposit due date that falls within the postponement period, the taxpayer should call the telephone number on the notice to have the IRS abate the penalty. For information on services currently available, visit the IRS operations and services page at IRS.gov/Coronavirus.

The IRS automatically identifies taxpayers located in the covered disaster area and applies filing and payment relief. But affected taxpayers who reside or have a business located outside the covered disaster area should call the IRS disaster hotline at 866-562-5227 to request this tax relief.

The IRS will waive the usual fees and requests for copies of previously filed tax returns for affected taxpayers. Taxpayers should put the assigned Disaster Designation "California Wildfires" in bold letters at the top of Form 4506, Request for Copy of Tax Return, or Form 4506-T, Request for Transcript of Tax Return, as appropriate, and submit it to the IRS.

Affected taxpayers who are contacted by the IRS on a collection or examination matter should explain how the disaster impacts them so that the IRS can provide appropriate consideration to their case. Taxpayers may download forms and publications from the official IRS website, IRS.

Food Allergies

Dear Readers,

Food allergies are on the rise in the United States, and it is estimated that as many as 8% of children suffer from at least one food allergy. A food allergy occurs when your body's immune system responds to a particular food as harmful and has a reaction. These reactions can range from itchy skin, vomiting, diarrhea, trouble breathing, wheezing, or life-threatening anaphylaxis.

Although it is uncertain why food allergies have increased, one theory is the hygiene hypothesis. Our immune system's job is to fight germs and stave off infections. However, our homes have been sanitized with bleach and antibacterial soap. In our efforts to provide clean homes for our families, our immune systems may have encountered an identity crisis, so they are looking for a new job. In this scenario, the body responds to a particular food as harmful and takes measures to protect itself.

Another contributor to food allergies may be food processing. For instance, China's peanut allergies are far less common than in the United States. While peanuts are roasted in the US, they are boiled in China. Boiling does not alter the protein in peanuts as does roasting, and typically, it is the protein in foods that acts as the allergen.

There are eight foods that account for 90% of all food allergies. They are: Peanuts, Cow's milk, Eggs, Fish, Wheat, Shellfish, Tree Nuts, Soy

Peanuts, milk, and eggs are the most common food allergies in children. While many children outgrow these allergies, some will have them their entire lives.

In the past, physicians have advised parents not to introduce potential allergic foods to children until age 3. However, recent studies have shown that introducing these foods earlier in infancy may help prevent allergies from developing. The LEAP study (Learning Early About Peanuts) was the first randomized trial to study early allergen introduction as a preventive strategy. It found that the introduction of infant-safe peanut-containing foods at 4–11 months of age significantly reduced the risk of developing peanut allergy in high-risk infants (1). High-risk infants were defined as those who had severe eczema or an egg allergy, or both. The LEAP study results were published in the New England Journal of Medicine.

Similar studies have been conducted on the early introduction of eggs to prevent allergies, but the results have been mixed or inconclusive. More research needs to be performed on food allergies to provide safe recommendations.

If you are concerned about food allergies for your child, talk to your pediatrician. Refrain from providing any of the foods mentioned above to your child until approved by your doctor.

Your written response must be in proper legal form if you want the court to hear your case. There may be a court form that you can use for your response. You can find these court forms and more information at the California Courts Online Self-Help Center (www.courtinfo.ca.gov/selfhelp), your county law library, or the courthouse nearest you. If you cannot pay the filing fee, ask the court clerk for a fee waiver form. If you do not file your response on time, you may lose the case by default, and your wages, money, and property may be taken without further warning from the court.

There are other legal requirements. You may want to call an attorney right away. If you do not know an attorney, you may want to call an attorney referral service. If you cannot afford an attorney, you may be eligible for free legal services from a nonprofit legal services program. You can locate these nonprofit groups at the California Legal Services Web site (www. lawhelpcalifornia.org), the California Courts Online Self-Help Center (www. courtinfo.ca.gov/selfhelp), or by contacting your local court or county bar association. NOTE: The court has a statutory lien for waived fees and costs on any settlement or arbitration award of \$10,000 or more in a civil case. 


No Doubt: Seniors are Tough Old Birds

WASHINGTON, DC (MPG) - It's not easy getting old. When times are bad they're worse for the elderly and no better example is there than the times in which we've been living for the past twelve months or so - in the year of the COVID-19 pandemic. There's no doubt that the older you are the more physically vulnerable you can be to the coronavirus, but there's evidence that aging can also turn us into mentally tougher "old birds," as the saying goes, according to Rebecca Weber, CEO of the Association of Mature American Citizens [AMAC].

There was concern across the board when the pandemic got started that there would be a "mental health crisis" among the older population due to COVID based restrictions on contact with friends and family. But according to an article in JAMA, the Journal of the American Medical Association, there is "evidence suggesting that, counter to expectation, older adults as a group may be more resilient to the anxiety, depression, and stress-related mental health disorders characteristic of younger populations during the initial phase of the COVID-19 pandemic."

The article cites a study by the Centers for Disease Control that showed "933 participants aged 65 years or older reported significantly lower percentages of anxiety disorder (6.2%). depressive disorder (5.8%),
