**GRIDLEY, CA (MPG)** - A milestone has been reached for the Orchard Hospital Patients Services Pathways (PSP) Program and its partner, Gridley High School: Its first graduate has officially been employed by the hospital.

The PSP Program, believed to have gotten off to a quiet start in 2018, facilitates students interested in healthcare careers by allowing them a closer look and firsthand experience in the industry through a partnership with Orchard Hospital. Orchard Hospital Emergency Room

Manager, Beth Brown, says that the PSP Program was designed to help students discover "all of the modalities within healthcare that you can go into" and "interest them and excite them to be a part of healthcare when they get through school."

## Gridley to Benefit from Climate Change Credit

**GRIDLEY, CA (MPG)** - As part of an 11-item agenda list, Gridley City Council approved a resolution at their August 16th meeting, authorizing the issuance of a California Climate Credit to City of Gridley Residential Electric Customers.

Under the California Legislature act Assembly Bill 32, "The Global Warming Solutions Act of 2006" to reduce greenhouse gases, public owned utilities like those of the City of Gridley are subject to rules, regulations and are issued "allowances" from the State and under the California Cap and Trade Program. Those allowances can be allocated to the Cap-and-Trade Auctions, the funds generated from their sale to be used to advance policy objectives under the AB 32 act. Item 9 on the City's Agenda was a recommendation to adopt a resolution approving the City Administrator to issue a "Climate Change Credit" to existing Gridley utilities customers, in accordance with the intent of AB 32.

Gridley City Administrator, Cliff Wagner, addressed the council saying about the resolution, "As you are all aware, this past year with COVID-19, has placed a range of very real stresses on city residents, including our residential electric utility customers." He went on to explain that, under the Cap-and-Trade program, the City had the opportunity to distribute some of the accumulated funds from the sales of allocated allowances, to "provide direct utility relief in the form of a climate change credit." If passed, the proposed credit of \$200 would be reflected as a climate change credit on the invoices of 2,430 residential utility customers currently in the City of Gridley. The resolution was met with approval and passed unanimously.

City Administrator Wagner believes that the credit is the first of its kind that the City of Gridley has extended to its customers and that it is allegedly one of the larger credits to be applied to residential utilities accounts in comparison to other municipalities in the area. Residential utility customers in the City of Gridley can expect to see the Climate Change Credit of \$200 on their accounts regardless of whether they are or are not in arrears. ★

# COVID Surge Leads to Increase in Deaths for Butte County

BUTTE COUNTY, CA (MPG) - Butte County Public Health announces that four additional community members have died due to their COVID-19 illness. BCPH expresses its sincere condolences to the family and friends of those who have passed. These recent deaths include persons from the following age groups: 55-64, 65-75, and 75+.

Sadly, BCPH will likely have more deaths to announce

this week but is awaiting the review of medical records and death certificate confirmation before confirming and announcing those losses. Unfortunately, BCPH had anticipated an increase in deaths due to a surge of COVID-19 hospitalizations since August.

"Typically, hospitalizations increase 1-2 weeks after an increase in the number of cases, and lives lost increases 1-2 weeks after the increase in hospitalizations. Then there is an additional

delay in reporting deaths as we gather the needed information to determine that the death was due to COVID-19," explained Linda Lewis, Health Scientist and Epidemiologist for BCPH. "Tragically, many of these deaths could have been avoided if more people had been vaccinated."

Since this latest surge started in late July, the death toll due to COVID-19 in Butte County has increased by 19. Sixteen of those deaths have been reported in the past seven days. Since

the start of the pandemic, Butte County has endured the loss of 221 residents, with an additional 56 probably deaths. Probable deaths are those that have been reported from the result of a positive "rapid" antigen test in comparison to a viral PCR test.

Since April 15th, of the 25 deaths in persons below the age of 80, 4% were fully vaccinated.

BCPH urges those who have not yet gotten vaccinated to do so as soon as possible and for those who have missed their second

dose of a two-dose vaccine, to reschedule as soon as possible, even if it is outside the recommended timeframe. Getting fully vaccinated against COVID-19 is the safest choice everyone can make to prevent severe illness, hospitalization and death.

The Pathways Program is two-partite - the educational foundation occurring on campus at GHS, through instruction from certified instructors with medical backgrounds, college level educational materials and training using state of the art equipment, such as mannequins to practice blood draws and a new lab facility for running basic diagnostic tests - all of which is funded through grants procured by Gridley Unified School District. Students then leave the classroom for clinicals or live training and observation at Orchard Hospital, shadowing healthcare professionals in the Emergency Room, or specialists as they treat patients.

Currently, the PSP Program offers two health occupation classes, one medical terminology and nursing course. Students commit to a 3-year course at GHS when joining the PSP Program, in which they are exposed to multiple fields of practice within the realm of healthcare, helping them weed-out and narrow down their interests. The instruction, certifications, and college level course credits they receive during the PSP Program give them a head start when they graduate and move on to college level training. Lyndi Little-Wallace, Director of Marketing and Community Outreach says Orchard's program is "really advanced. I feel like we have amazing pathways to help kids decide right away "What do you want to do?" and get your feet wet. Try it and if you don't like it, you learned in high school" and have the opportunity to move forward with less time spent determining the course of your future.

A recent graduate of GHS and part of the PSP program, Madison Tull is a testament to the PSP programs success and echoes Little-Wallace's sentiments. Tull, who currently attends Oregon Tech and is majoring in Respiratory Care, attributes her positive transition and advanced placement in her college program, to the PSP Program. She shares that when first investigating careers in the medical field, she felt she would be limited to nursing. While participating in the PSP Program, she shadowed a Respiratory Therapist and immediately recognized it as her calling. Her training in the PSP program shaved almost a year off her college

programs pre-requisite courses, putting her on the fast track to her degree in Respiratory Care and giving her solid confidence in her career choice. In addition, she has already benefitted from her training through the program as it allowed Tull to work at Orchard Hospital as an Emergency Room Clerk during the summer before returning to Oregon Tech in the fall.

Being able to experience first-hand, what it is like to work in a rural hospital's Emergency Room, Tull says she has gained a perspective only made possible through the PSP Program and Orchard Hospital. Working in a smaller hospital has allowed her to see how intimately the healthcare team operates together for ultimate patient care. "I really enjoy getting to hear them come in with their cases and bounce ideas off each other," she says about conversations had between specialists, nurses, and doctors in the E.R. "It's like a whole new type of environment that I never knew really existed," she says compared to some of the larger hospitals she has had attended for clinicals. It has made her reconsider working for a large hospital and opened her eyes to the benefits of working in a smaller hospital, such as Orchard.

As one, if not the largest, employers in Gridley, Orchard Hospital understands the connection between the community it serves, the people it employs and how it all fits into the small-town dynamic. People grow up here and if they stay, will eventually need employment. What better way to support the community other than providing quality healthcare, than to offer training and education to our youth that gives them a leg-up on the competition, shortens college level training, and promotes jobs within our own community, all the while illustrating the benefit and necessity of rural hospitals.

While Orchard is not officially considered a teaching hospital, Brown says that it now has college level students attending and observing the clinical side of the program from Cambridge College, Butte and Yuba Colleges, along with GHS students as the PSP Program gains more momentum. "I love this program" says Brown, with Tull agreeing and standing as a true testament of the successful nature of the PSP Program. ★

# Gridley Thumbs and Roots

We had our shade tree in front evaluated by a tree service. It is a decorative pear tree. We knew it had fire blight. I kept engaging in wishful thinking that it is not fire blight. It is. We are having the tree fully pruned and whatever blighted branches are left after that will be trimmed out. When

dealing with fire blight each cut requires cleaning the tool being used by dipping in a bleach solution. This tree is worth putting some money into to make it healthy. It is a great passive solar barrier to the west sun. Once the pruning is done in October, we will need to spray it right before blooming. This is to give resistance to the blight so it does not return. If it does return then we are looking at more cutting next fall. We'll see how it goes.

Due to the pruning process I have to remove the garden gee-gaws. The potted plants are easy to move with the hand truck. The larger cement items are more difficult. I'll be cutting some plants back a bit

sooner so they can survive some trampling. Needless to say, the pruning will cause some changes in how light comes into the area under the tree. This might cause me to move some plants. My biggest fear is that my "magic" planter in the front will be changed with additional light. I'm hoping the fuchsias will handle it. I'm not prepared to simply allow them to die. I am holding out hopes for the Iron Cross begonia, may it live through it all. Life is full of changes whether we want them or not. Gardens are a type of system that when disturbed change and are disrupted. No choice, change will happen and adaptations will happen. ★

Other ways to develop a positive attitude in life are just as easy, but must be made on step at a time, one foot in front of the other.



Farm Bureau President Jamie Johansson said, "There has been a concerted effort ... to consider our members' health because what we've experienced in the last three years has brought a tremendous amount of uncertainty."

### Healthy Composting Helps Winegrape Growers go Organic

Winegrape growers in Napa County are crediting healthy composting measures for helping transition vineyards to organic production. Napa County ranks second to Mendocino County in total organic winegrape acreage. Organics still account for less than 10 percent of winegrape production in Napa and about one-fourth of production in Mendocino. But improvements in fertilizers are convincing more growers to transition to organics.

### Cdfa Announces Grant Program for California Specialty Crops

The California Department of Food and Agriculture is accepting proposals for a 2022 grant program to improve research, quality and production of California specialty crops and promote related collaborative agricultural projects. Awards up to \$500,000 are available for projects promoting better practices for fruits and vegetables, tree nuts and nursery crops as well as supporting research enhancing food safety and prevention of plant disease and pest infestation.

### USDA Allocates \$700 Million in Pandemic Relief for food, Farm Employees

The U.S. Department of Agriculture is allocating \$700 million to help farm and food employees impacted by COVID-19. The money is intended to help front-line grocery workers, meatpacking and farm employees recover personal and family expenses resulting from the pandemic. Those costs may include protective equipment, dependent care and expenses for quarantine or testing. ★

# Dear Dietitian

## Irritable Bowel Syndrome

Dear Dietitian,

I was recently hospitalized overnight for irritable bowel syndrome. The abdominal pain was treated, then I was released the following day. I was not given any information on what diet I should follow. Can you help?

Julie

Dear Julie,

A flare-up of irritable bowel syndrome (IBS) can be very painful, but the good news is it can be well-managed with diet and lifestyle changes. IBS is a common intestinal disorder that affects 25-45 million Americans. It requires a diagnosis by a physician or another qualified clinician. The cause of IBS is unclear; it is usually diagnosed based on symptoms. This condition can cause abdominal pain, gas, bloating, constipation, and diarrhea.

During a flare-up of IBS, avoid high fiber foods – fresh fruits and vegetables and whole grains. When the flare subsides, you may slowly add these foods back into your diet. Many research studies point to a high fiber diet to help prevent obesity, heart disease, diabetes, and possibly some types of cancer. It is essential to add these foods to your diet. Most Americans get about half the recommended amount of fiber each day, so if your body is not accustomed to high fiber foods, increase intake slowly. Start with 5 grams of fiber each day, increase by 5 grams each week until you reach

a goal of 25-35 grams per day. Drink plenty of water and noncaffeinated beverages while increasing fiber intake.

In today's busy world, sometimes we don't find enough time to slow down and eat at regular times. As we have routines throughout the day, mealtimes should also be a part of that routine. In this way, food will be moving through your system at regular times. In addition, planned meals tend to be healthier, and you will be less likely to grab fast food on the run, which is often high in fat.

Stress is a part of everyday life, and it's important to manage stress when managing IBS. Increasing physical activity, yoga, stretching, breathing exercises, and meditation are all avenues to alleviate pressure brought on by life's twists and turns.

It's essential to know what foods your body can comfortably digest when managing IBS. Many people have trouble tolerating sugar alcohols. These are found in some sugar-free products and are commonly known as xylitol, sorbitol, and mannitol. The amount of these artificial sweeteners found in sugar-free gum probably won't have negative consequences, but avoid large amounts since they can cause excessive gas and abdominal discomfort.

Finally, while certain foods do not cause IBS, some find that specific foods irritate the condition. Keep a record of these foods so that you remember to avoid them next time. Just carry a pocket-size notebook, and record problem foods as you go about your week.





**CHILD CAR SEAT SAFETY**

One of the most important jobs you have as a parent is keeping your child safe when riding in a vehicle. Each year, thousands of young children are killed or injured in car crashes. Proper use of car seats helps keep children safe. But with so many different seats on the market, many parents find this overwhelming.

If you are expectant parents, give yourself enough time to learn how to properly install the car seat in your car before your baby is born to ensure a safe ride home from the hospital. The type of seat your child needs depends on several things, including your child's age and size and the type of vehicle you have. For more information, check the Butte County Department of Public Health website at [www.buttecounty.net/publichealth](http://www.buttecounty.net/publichealth) or call (530) 895-4035.

Here are some car seat safety tips:

**Rear Facing Seat (birth to two years)**

- Best seat for child to use has a harness that moves with your child in an accident to cradle your child's head and neck
- All children must ride in rear facing seat until child reaches size or age requirements set by seat manufacturer.
- Switch to convertible rear-facing seat for larger infants when rear-facing infant seat is outgrown.

**Forward Facing Seat (Two years and older)**

- Has harness and tether that limits forward movement during an accident
- Keep child in forward-facing seat with a harness until age and size limits set by manufacturer are exceeded.

**Booster Seat (Five years and older)**

- A booster seat positions seat belt so it fits properly over the stronger parts of the child's body.
- Use forward-facing belt positioning booster seat until child reaches 4'9" tall, typically at age 12.

**Seat Belt (Older Children and Adults)**

- Keep your child in a booster seat until he or she is big enough to fit in a seat belt properly.
- The seat belt should lie across the upper thighs and be snug across the shoulder and chest to restrain the child safely in a crash.
- It should not rest on the stomach area or across the neck or face.

# Chico Bike Path Shooter to be Tried as an Adult

## Butte County District Attorney Release

**BUTTE COUNTY, CA (MPG)** - A now 18-year-old youth will be tried as an adult after a finding by the Butte County Juvenile Court that he is unfit to be tried as a juvenile. Deshawn Kelley, 18, of Chico, was charged as an adult today in Butte County Superior Court with attempted murder with great bodily injury and possession of an illegal assault weapon.

District Attorney Mike Ramsey said the charges stem from a May 13, 2020 shooting on a bike path near Rio Lindo Avenue in Chico. At approximately 5:30 p.m. that day, Chico Police dispatchers received numerous 911 calls regarding gunshots in the area. A nearby officer arrived in under one minute and found a 23-year-old male severely wounded on the bike path with numerous gunshot wounds.

The male victim was transported to Enloe Hospital with life-threatening injuries involving no less than seven gunshot wounds. The victim survived

the shooting despite the extensive injuries he suffered. After a month in the ICU and multiple surgeries, the victim was discharged from the hospital and began a lengthy recovery process that continues to today.

Ramsey said an extensive investigation ensued and through surveillance videos, witness statements, and phone records, officers identified Deshawn Kelley, who was 17 at the time, as the shooter. Chico police detectives determined that Kelley went to the bike path with a semi-auto pistol that day to confront a high school classmate. However as Kelley was walking down the bike path, he heard a bicyclist coming from behind. Kelley hid in bushes at the side of the path and waited until the 23-year-old male was approximately three to five feet away. Kelley then jumped out of the bushes and unloaded the entire magazine of his gun at the victim. The victim told detectives that Kelley did not say anything to him before the unprovoked shooting. The investigation determined Kelley and the victim did not know

each other and there was no motive for the shooting.

Detectives later learned that Kelley fled to Southern California after the shooting. On June 17, 2020, Chico Police located and arrested Deshawn Kelley, who had an AR-15 assault rifle in his possession.

Ramsey said his office filed charges in the juvenile court and petitioned that court to have Kelley tried as an adult due to the egregiousness of the crime. After an extensive review over several months of the evidence in the case as well as Kelley's criminal and social background and psychologists' reports, the juvenile court judge agreed last Wednesday that Kelley should be tried as an adult. The judge ordered Kelley to be transferred from the Butte County Juvenile Hall, where he had been detained since his arrest, to the Butte County Jail.

Kelley was arraigned in court this afternoon. Further arraignment and entry of plea are scheduled for September 15. Kelley will remain in custody with bail set at \$1,565,000. ★

# Fatality on Dry Creek Road

**YUBA COUNTY, CA (MPG)** - On 09-10-2021, at approximately 2335 hours, a 2016 Ford Fusion was traveling southbound on SR-65 north of Dry Creek Levee Road, north of the City of Wheatland. For unknown reasons, a male pedestrian wearing dark clothing was walking in the roadway in a dark, unlit portion of SR-65 south of the Ford. The Ford struck the pedestrian, and the driver of the Ford immediately pulled to the right-hand shoulder of SR-65 and called 9-1-1.

First responders arrived and attempted life-saving measures, but the pedestrian succumbed to his injuries and was pronounced deceased at the scene.

The driver of the Ford remained at the scene and cooperated with the investigation by California Highway Patrol officers. The driver was determined not to be impaired by drugs or alcohol.

SR-65 was closed to all traffic for approximately two hours during the crash investigation.

The above information is preliminary, and this crash is currently under investigation by the California Highway Patrol - Yuba Sutter Area office. 

## California Wildfires Ignite an Insurance Crisis

As if California needed another crisis, the state's seemingly perpetual wildfires are forcing millions of homeowners in fire-prone areas to pay skyrocketing premiums for insurance coverage – if, indeed, they can buy it at all.

As the number and severity of wildfires increase, insurers are increasingly reluctant to renew policies and even if they do, premiums often double or triple.

Insurance is required for most homeowners since their mortgage lenders demand it. And if they cannot obtain regular coverage, they are forced into the insurer of last resort, FAIR, that has very high premiums and limits on coverage.

Insurance Commissioner Ricardo Lara has repeatedly invoked a law he authored three years ago as a state legislator, imposing one-year moratoriums on policy cancellations for property in or immediately adjacent to the sites of major fires.

In 2020, Lara's moratoriums covered 2.4 million policyholders after fires scorched more than 4 million acres and consumed hundreds of homes and other buildings. When this year's fires are finally extinguished, including the immense Dixie fire and the Caldor fire that nearly wiped out South Lake Tahoe, Lara will extend the

moratoriums to their burn zones.

At best, however, such moratoriums are merely stop-gaps. So what, one might ask, are politicians doing about the crisis?

There is some scapegoating. This month, Assemblyman Marc Levine, a Democrat from fire-prone Marin County, fired off a letter to insurance trade groups, telling them, "I do not believe that the costs of utility mismanagement, or the impacts of climate change should be arbitrarily and capriciously passed through to my constituents in the form of homeowners' insurance being declined, non-renewed, or their insurance premiums being raised exorbitantly. Particularly when there has been no change of conditions or circumstances."

Circumstances are also beyond insurers' control as they assess potential losses and calculate whether to offer coverage and if so, what to charge. They cannot, as Levine seems to suggest, ignore the perils regardless of their causes.

Levine later introduced legislation that would have the state become an insurer for those unable to buy coverage elsewhere.

John Norwood, a veteran insurance industry lobbyist, set forth the dilemma in a recent article for an industry publication:

"The availability and affordability of property insurance in California are not likely to change until the worldwide reinsurance market believes California is serious about addressing its wildfire risks and there are demonstrable results in reducing the number and severity of wildfires in the state.

"Without the reinsurance

market backing California property/casualty insurance companies, there will continue to be an availability crisis in the state for property insurance and prices for such coverage will continue to increase substantially to the detriment of California's homeowners and businesses."

The initial state budget signed by Gov. Gavin Newsom appropriated \$2 billion for making the state more fire-resilient, but was criticized for spending many billions more on problems of lesser import. Last week, with big fires still burning, the wildfire budget was sharply increased before the Legislature adjourned for the year.

Reducing the likelihood of destructive fires is a good step in the right direction, but the insurance crisis demands more – perhaps, even, an entirely new approach.

The state could, for instance, purchase basic disaster insurance for every California property owner – covering earthquakes and floods, as well as fires – and pay for it through some sort of property-based assessment. Property owners could tap the private market for coverage beyond the basic policy's limits.

Through reinsurance, the risk would be spread worldwide and Californians wouldn't have to worry about scrounging for coverage. The state's voluntary earthquake insurance program already embodies that concept.

There may be other workable approaches, but without new thinking, the insurance crisis will, as Norwood warns, continue to worsen.



# You Are Out of Time

*California legislators won't extend housing eviction ban*

California's eviction protections will almost certainly not be extended once they expire after Sept. 30, the state Assembly Housing chairperson said today.

The legislative session ends Friday, so that's the last day that lawmakers could push off that deadline. But the political appetite just isn't there to act, according to David Chiu, a San Francisco Democrat who spearheaded the previous efforts to stall the displacement of tenants amid the pandemic.

"I believed our eviction protections for tenants should be extended beyond September 30. The delta variant and the end of many unemployment benefits make that even more urgent," Chiu told CalMatters. "Unfortunately, some of my colleagues feel differently, and there's not enough consensus for that."

The current round of eviction protections were extended on June 25, just days before they were set to expire. At that point, Assembly Speaker Anthony Rendon said he hoped the economy would be in full swing so that another moratorium would not be necessary. Rendon's office declined to comment on the absence of another extension.

"The Legislature has kind of set a trap for itself because it won't be in session when that expires," said Brian Augusta, legislative advocate for the California Rural Legal Assistance Foundation, who has been lobbying for stronger protections throughout the pandemic. "So, that means, what we see is what we get."

Augusta said the governor could still call a special legislative session to extend protections before the end of the month, or issue an executive order as he did at the beginning of the pandemic to pause court proceedings relating to evictions. But he said that's unlikely.

The governor's office also declined to comment.

The California Rental Housing Association, which represents more than 20,000 landlords and has sued the state over the last round of protections, was pleased by the decision, but not surprised.

"Our lobbyists did not come to us and say, 'Hey, you know,

we're going to have to compromise somewhere or anything like that,'" said Sid Lakireddy, a board member for CalRHA. "So, I think the legislators are starting to get it as well. This can't go on at infinity."

The eviction protections in place state that tenants will have a defense in court should their landlord evict them over non-payment of rent through Sept. 30. They still have to submit a declaration saying they are unable to make full rent, and pay at least 25% of their monthly rent since Sept. 1, 2020, in installments or in bulk, by Sept. 30.

The protections are tied to \$5.2 billion in federal aid for

rent relief. People making less than 80% of their area median income who were financially affected by COVID-19 can still apply for the full amount of missed rent and stave off eviction. They can also now apply for three months of forward rent.

But distribution of those dollars remains a problem. While the state has received applications for about \$1.9 billion in rental aid, it has distributed only about \$491 million. Still, that's about a 500% increase since the current moratorium passed at the end of June, according to Russ Heimerich, spokesperson for the state's Business, Consumer Services

and Housing Agency.

According to a recent analysis of California's rental debt by Policy Link, an Oakland-based research group, about 753,000 families are behind on rent, and owe a cumulative \$2.8 billion.

"I think everybody's hope was that more families would have received the funds by now, and that the people who didn't apply or were denied were a minority, as opposed to an overwhelming majority," said Francisco Dueñas, executive director of Housing Now!, a tenant advocacy group.

Existing law has some stopgaps that, in theory, should prevent the tsunami of evictions tenant advocates and researchers have predicted. Heimerich said tenants will be shielded from an eviction procedure by the courts for 15 more days to apply for their missed rent — a provision that extends through March 2022.

To take advantage of those protections, tenants will have to show evidence they applied for the rental assistance program in court, Heimerich said. He said the state agency is working closely with the Judicial Council to inform judges of the procedure.

While the stopgap might seem promising on paper, tenant advocates are leery of its application.

"The problem with relying on the courts is it requires people to go to court," Dueñas said. "And a lot of people don't respond to a court notice. They just move."
