Gridley Plans for Growth

GRIDLEY, CA (MPG) - The City of Gridley has been busy over the last month with the Gridley City Council hearing and voting to proceed on multiple housing developments within the city—some that had stalled in the past—and has moved forward with the annexation of those that were not currently within the city limits in keeping with their General Plan.

Among those is a project that has lain dormant since 2005, when the initial push for development annexed the property located on the corner of Little Avenue and Richins Avenue into the Gridley City Limits with a proposed subdivision map of 20 residences. Sixteen years later, the project now called Steffen Estates, has been revived. The Planning Commission held a public hearing on August 18th, 2021, proposing the rezoning of that 8.66-acre plot from Residential Suburban (RS) to Single Family Residential (R1), then on September 7th, brought the resolution to the City Council for a general plan amendment from low density to medium and for a mitigated negative declaration - 2021-R-029 (Yes: Sanchez, Calderon, Farr, Johnson. No: Torres), to approve a Tentative Subdivision Map of a 46-lot subdivision -2021-R-030 (Yes: Torres, Calderone, Farr, Johnson. No: Sanchez), Ordinance to rezone - 843-2021 (Yes: Torres, Calderone, Farr, Johnson. No: Sanchez) and for the first reading of the Ordinance. The resolutions passed. The second reading of Ordinance 843-2021 occurred at the Monday, September 20th City Council meeting as part of the consent agenda, it passing as well, making the Ordinance effective 30 days thereafter on October 20, 2021.

Further developments considered by council include another subdivision, Parkland Estates, which also stalled after 2005. That project concerns the development of a 1.48-acre property located directly across from Manuel Vierra Park on the east side of Haskell Street. With the majority of the development's infrastructure already constructed (street, water, sewer, drainage, etc.) the application, brought to the Planning Commission on July 28th, 2021, required Council approval of the Tentative Subdivision Map No. 1-21 and for Council to declare the project "categorically exempt as an in-fill project." Resolution 2021-R-017 would approve a Tentative Subdivision Map to develop said parcel into

Daniel Lee Soares, 87, passed away at his home in Gridley on September 3, 2021, surrounded by his beloved family, following a lengthy struggle with multiple health issues. Through it all, he kept his sense of humor, his joy in his family, and an indomitable spirit.

Dan was born in Gridley on March 16, 1934, to Anthony and Illa Soares. He attended Gridley schools, graduating Gridley High in 1952. He briefly attended Yuba College prior to enlisting in the U.S. Army Infantry. Upon completion of basic training, Dan's unit was being readied for Korea. When he returned from mandated family leave, he discovered his name had been withdrawn and his unit had left. He was subsequently assigned to the 22nd Army Band at Fort Mason, San Francisco, as a brass instrumentalist. He attended Chico State College earning a B.A. Degree and Credentials in Music and Secondary Education. It was there in the college band that he met his future wife.

In July 1959, Dan married Donna Desoza in Yreka, California, where he began his music teaching career and coached high school sports. Dan taught music in Weed CA, and in the Yuba City Unified School District. In 1973 he was asked to serve as Assistant Director of Chico High School's "On to Berlin" Symphonic Band and accompanied them to the International Music competition in Germany. At Gridley High he taught history and social studies as well as music and was renowned for his classroom musical Fridays, ukulele in hand, teaching songs relevant to the historical era.

Dan retired from teaching in 1997, but not from music. He continued to play in the Yuba Sutter Symphony, was Musical Director for a number of live theatre productions, played tuba and string bass with King Cotton Jazz Band, and banjo with St. Andrews Dixieland Band. During Dan's teaching career he served in leadership positions with music educators' associations and organized numerous Honor Bands and Music Festivals at Chico State College. He directed the choir at the First Presbyterian Church in Gridley and, following



retirement, served as interim music instructor at Biggs Unified School District. Dan was active in the U.S. Power Squadron, a safe boating organization. In 2009 he was honored to be the recipient of Kaleidoscope's Artist of the Year Award.

Dan was a lifelong learner, an avid reader, a conversationalist who carried a pocket notebook to jot down information and highlights of the many conversations he had along life's journeys - he never met a stranger. His interests were many: sailing (especially ocean waters with his DHD buddies), gardening, cultivating Japanese Maple trees, bonsai, live theatre, building birdhouses, old western movies, the 49ers, cruising abroad, and traveling with Donna and his family.

Dan formed lifelong friendships and treasured the times spent with them. He will be remembered for his love for family and friends, his kindness, humor, and gentle nature, quick smile, friendly manner, humility and hearty laugh - the laugh that once brought recognition to a fellow Gridleyan who had also traveled to the Normandy beaches who shouted from a distance "That's Dan Soares of Gridley - I'd know that laugh anywhere."

Dan was preceded in death by his parents, a sister and his son, Mark.

He is survived and greatly missed by his wife of 62 years, Donna; his daughter Melinda (Michael) Tuft, Grandchildren Alex Tuft and Aubrey Hernandez, Great-Granddaughter Cassandra, brother, A.L. "Brud" (Martha) Soares, and sister-in-law Jan (Gary) Anderson, as well as numerous nieces, nephews and cousins.

A private family service with military honors will be held at the Gridley Biggs Cemetery with Vicar Jeff Tuft of the Calvary Evangelical Lutheran Church, Oroville, officiating. A celebration of life will be held at a later date.


Robert J. Almo

After a year and a half of remote learning and social distancing, kids are once again socializing after school and between classes, and are being confronted with one of the biggest dangers on school campuses — vaping.

As smoking cigarettes became less popular with younger generations, tobacco companies have adapted — changing their products to appeal directly to kids. They use misleading advertising to push colorful vapes and fruity flavors that make tobacco use look trendy, fun and empowering. This kind of advertising is why e-cigarettes are now the most commonly used type of tobacco product among California high school students.

The tobacco industry tries to hook young people, whose developing brains are more vulnerable to addiction, with candy-flavored vapes and youth-targeted social media marketing. Youth who live in rural areas are even more vulnerable, because the tobacco industry takes advantage of weaker tobacco retail laws in smaller communities.

Because of these practices, rural counties have some of the highest smoking rates in California, and rural residents start smoking at an earlier age, often after becoming addicted to nicotine through vaping.

Kid-friendly flavors like Blue Razz, Banana Ice and Pegasus Milk mask the harsh taste of tobacco, making it easy to start vaping and harder to quit. The tobacco industry also continues to lie and say that vaping and flavors are harmless, even though it's been proven that tobacco products lead to poor health and behavioral outcomes for teens.

Nicotine rewires the brain to crave more of it, creating nicotine withdrawal symptoms like headaches, shaky hands, mood swings and the inability to concentrate, ultimately holding them back developmentally and impacting kids' relationships, academic performance and ability to have happy, successful futures as adults.

"Parents, school officials, and community leaders need to be more aware of the how, where, and why our children are accessing and using tobacco products," said Larry Olson, Chair of the Mendocino County Tobacco Prevention

Coalition. "By knowing more about these products and the tobacco companies' tactics to hook our youth, we can be effective advocates to push for local policies that curb tobacco use and save our children from a lifetime of addiction."

The good news is that kids are starting to get the message. In California, data from the California Student Tobacco Survey shows that 8.2% of high school students vape, a significant drop from 2019, and half that of the US high

school vaping rate (19.6%). Yet the majority of youth who vape want to quit, and reported making multiple attempts to quit in the past year.

This is a critical moment in the fight against tobacco. We cannot let the tobacco industry steal the free will of another generation by convincing them that vapes are empowering. We can help our children keep their free will intact by choosing not to fall prey to the false advertising of the tobacco industry. We have the power to create a better, tobacco-free future in California—and we must start by protecting our kids.



Gridley Thumbs and Roots

I have a large variegated leaf Lantana with bright yellow blooms in a large pot in the backyard. It is a shining bit of light in an already sunny backyard. I love it. It tricks me every spring. I cut it back and it looks like dead sticks. I start looking for life in April, I become convinced it has died. It is a

late grower. It rarely starts new leaves until the end of May. It takes its own sweet time getting bigger. Then, it cannot be stopped except by cutting it back. This year I let it sprawl and it is glorious.

Lantanas come in a variety of colors and are hardy plants on long hot summer days. They need some water but not that often, about once a week. I've seen them in places where they get almost no water and they bloom away. Hot colors of red, orange and yellow and cool colors of blues to purples and a white. They will get powdery mildew if watered incorrectly. It is recommended that they be deadheaded. I do not deadhead mine and it blooms a

lot for a long time.

I don't think that much about the Lantana very often. What attracted me this year is the abundance of small brown moths that have been covering the blooms sipping nectar. There is some disagreement as to whether these Skippers are moths or butterflies. They do have a proboscis for sipping nectar, they are out in full sunlight. There's something about an unmoth-like connector in the wing. I only found information about them when using a search word of moth but then the arguing starts and many declare them butterflies. Whichever they are they are a wonderful dance of sipping and flying on the Lantana. ★

first. Baby Step 1 is saving \$1,000 for a starter emergency fund. Baby Step 2 is where you pay off all debt, except for your home, using the debt snowball method.

A fully-funded emergency fund should cover three to six months of expenses. You start the emergency fund with \$1,000, but a full emergency fund can range from \$5,000 to \$25,000 or more. A family that can make it on \$3,000 per month might have a \$10,000 emergency fund as a minimum.

What is an emergency? An emergency is something you had no way of knowing was coming – an event that has a major, negative financial impact if you can't cover it. Emergencies include things like paying the deductible on medical, homeowners or car insurance after an accident, a job loss, a blown automobile transmission or your home's heating and air unit suddenly biting the dust.

Something on sale you "need" is not an emergency. Fixing the boat, unless you live on it, is not an emergency. Want to buy a car, a leather couch or go to Cancun? Not emergencies. Prom dresses and college tuition are not emergencies, either.

Never rationalize the use of your emergency fund for something you should save for. On the other hand, don't make payments on medical

bills after an accident while your emergency fund sits there fully loaded. If you've gone to the trouble of creating an emergency fund, make sure you are crystal clear on what is and isn't an emergency.

Also, keep your emergency fund in something that is liquid. Liquid is a money term that basically means easy to access with no penalties. I use growth-stock mutual funds for long-term investing, but I would never put my emergency fund there. I suggest a money market account with no penalties and full check writing privileges for your emergency fund.

Your emergency fund account is not for building wealth. It's an insurance policy against rainy days!

Dear Leslee,

When bad, unexpected things happen, like a job layoff or a blown car engine, you shouldn't depend on credit cards. If you use debt to cover emergencies, you're digging a financial hole for yourself. My plan will walk you out of debt forever, and a strong foundation of any financial house includes an emergency fund.

Putting together a fully funded emergency fund is Baby Step 3 of my plan for getting out of debt and gaining control of your money. Before you reach this point, however, steps one and two should be completed

19 single family lots for a zero-lot line development zoned as multi-family residential (R-3), high density. It appeared on the consent agenda of the August 16th, City Council Meeting, which passed (Votes: Yes: Johnson, Farr, Sanchez. Not present: Calderon, Torres).

Also on the August 16th, 2021, agenda was that of the Kiwi Vineyard Estates subdivision, which would annex approximately 19.95 acres on the west side of W. Biggs-Gridley Road (at the end of Spruce Street) into the "incorporated boundary of the City of Gridley." The project was approved by the Planning Commission at the July 28th meeting and was brought before council to pass Resolutions 2021-R-018: Annexation of approximately 19.95 acres from Butte County into the Incorporated Boundary of the City of Gridley (Votes: Yes -Johnson, Farr, Sanchez, Calderon. Not present: Torres), Resolution 2021-R-019: Amend the General Plan of approximately 16.4 acres of the total 19.95 from residential, very low, to residential low density and adopt a mitigated negative declaration (Votes: Yes – Calderon, Sanchez, Farr, Johnson. Not present: Torres), Resolution 2021- R- 020: Approve the Tentative Subdivision Map No. 1-20, to divide the 19.95 acres into 60 parcels (Votes: Yes: Sanchez, Calderon, Farr, Johnson. Not present: Torres),

and Ordinance No. 833-2021: Pre-zone approximately 19.95 acres; 3.55 acres to Residential Suburban (RS) and 16.4 acres to Single Family Residential (R1) (Votes: Sanchez, Johnson, Farr, Calderon. Not present: Torres). This subdivision would develop the property from W. Biggs-Gridley Road back to the eastern edge of the current Eagle Meadows subdivision, with 58 new homes including 2 existing homes, for a total of 60, and potentially provide an additional entry and exit point for residents in Eagle Meadows if Spruce Street is extended through the subdivision. With those motions approved (Votes: the second reading of the Ordinance 833-2021 appeared on the September 7th consent agenda and was approved by Council vote. Next step for this project is for the application for development to go to LAFCO, due to the boundary change from Butte County into the City of Gridley limits.

Those three developments alone propose to add a potential of 125 new homes to the Gridley area, not including the Villages at Eagle Meadows subdivision, south of the Eagle Meadows, which proposes to bring 20+ homes, or the Chandler Estates Subdivision north of Heron Landing, expected to bring 201 new homes to the area. These and other potential developments in the planning stages are in keeping with the City of Gridley's General Plan. ★

Dear Dietitian

Whole Grains

Dear Dietitian,

I am confused about whole grains. Some information tells me to eat lots of whole grains, but others say fiber is important in a healthy diet. Which is it?

Ray

Dear Ray,

You ask a good question. I recently bought a loaf of bread that advertised “20 grams of whole grains per serving” and “a good source of fiber.” What does this mean? According to the Food and Drug Administration (FDA), a whole grain must contain all the components of a grain kernel: the bran, germ, and endosperm.

Whole grains include, but are not limited to whole wheat, barley, rye, oatmeal, popcorn, brown rice, and wild rice. These foods are rich in nutrients, including B vitamins and fiber. Refined grains, such as white bread and white rice, do not include all of the grain kernels. In the refinement of these grains, nutrients and fiber are removed. Nutrients are added back in the enrichment process, but fiber is not.

Enrichment of refined grains is required in the United States to prevent nutrient deficiencies. Centuries ago, people in the Far East who relied on white rice for 80% of their energy intake, developed a neurological disorder known as beriberi, which literally means “I can’t; I can’t.” This disorder left many paralyzed, weak, and with mental confusion. Extensive research uncovered the root of beriberi to be a lack of thiamin (vitamin

B1) due to the refinement process.

There is very little government regulation for whole grain food labeling. However, the Whole Grains Council, a nonprofit group, has developed guidelines to aid in truth in advertising. For example, a product with the “100% Whole Grain” stamp must have at least 16 grams of whole grains per serving.

In contrast, there are regulations for fiber claims. A “high in fiber” claim must contain 5 grams or more fiber per serving. A claim that a food is “a good source of fiber” must contain at least 2.5 grams of fiber per serving.

Remember, the main focus is on fiber. Scientific studies have shown a positive link between high fiber diets and the prevention of chronic diseases, such as diabetes, heart disease, and high blood pressure. These studies do not isolate one particular type of fiber or whole grain, but rather, all sources of fiber are included. These food sources include grains, fruits, vegetables, and even manufactured sources known as functional fiber. The bottom line is food that contains whole grains is not necessarily high in fiber.

While whole grains are your best choice in the grain food group, many plant products are rich in fiber and nutrition, including nuts, seeds, fruits, and vegetables. Set your goal of fiber intake to at least 20 grams per day. If you’re not used to eating a high-fiber diet, begin with 10 grams a day and work up to a goal of 20- 35 grams each day. Remember to drink plenty of water when increasing fiber intake to ease the digestive process.



BUTTE COUNTY, CA (MPG) - Caltrans is alerting motorists about intermittent, overnight one-way traffic control this weekend on State Highway 99 about 10 miles north of Gridley.

Crews plan to conduct one-way traffic control at various times between 8 p.m. and 6 a.m. Friday through Sunday in the Cottonwood Creek area of Butte County. Caltrans advises motorists to use alternate routes to avoid traffic delays.

Flaggers will be stationed at each end of the construction zone and a pilot vehicle will be used for traffic control. Motorists are reminded that pilot vehicles are to be followed at all times within the project zone for the safety of construction crews and travelers. Failure to follow pilot vehicles may result in a \$220 citation with traffic fees doubled in construction zones. The California Highway Patrol will be

on site, monitoring traffic safety during construction.

At the same time, construction activities will block access to Nelson Avenue at Highway 99 from 8 p.m. Friday to 6 a.m. Monday, September 27. Nelson Avenue residents will be detoured to Highway 162 then to Wilbur Road to connect with Nelson Avenue.

The weekend closures will allow crews to continue constructing a new highway alignment leading to the newly built Cottonwood Creek Bridge. Teichert Construction of Sacramento is the contractor on the \$8 million bridge project.

Five Individuals Arrested During Death Investigation

OROVILLE, CA (MPG) - On September 11, 2021, Butte County Sheriff's Office (BCSO) deputies located a sport utility vehicle without license plates parked in a rural area on the side of Forbestown Road, Oroville. Deputies approached the vehicle and located a deceased individual concealed in the rear of the vehicle. The scene was processed by detectives and the vehicle was towed to a secure location to be processed by detectives and personnel from the California Department of Justice. During the subsequent investigation, detectives identified the deceased individual as Melvin Garcia-Vargas, age 33, of Sacramento. Detectives located evidence that gave them cause to believe Melvin had been shot in his lower body.

On September 12, detectives contacted Melvin's father, who was identified as Carlos Garcia-Hernandez, age 66, at a residence in the 7000 block of Lindale Drive, Sacramento. Detectives determined evidence was located at Carlos' residence. Detectives obtained a search warrant for Carlos' residence.

During the investigation, detectives determined Melvin died at an illegal marijuana grow controlled by Carlos in the area of Squaw Flat Road, Forbestown. Detectives also located evidence that Carlos and his two other children, identified as

Juan Garcia-Vargas, age 27, and Ronald Garcia-Vargas, age 28, moved and concealed Melvin's body after his death.

On the evening of September 12, detectives, personnel from the Butte Interagency Narcotics Task Force, BCSO Marine Unit, and BCSO Special Enforcement Unit served a search warrant at the marijuana grow on Squaw Flat Road. During the service of the search warrant detectives located the area where they believe Melvin was shot. Detectives also located a firearm and over 600 marijuana plants. The scene was processed by the California Department of Justice.

On September 13, detectives determined Carlos, Juan, and Ronald had additional marijuana grows located in the area of Knob Hill Avenue, Oroville. On the afternoon of September 13, the BCSO SWAT Team served search warrants at seven parcels on Knob Hill Avenue. During the service of the search warrants five firearms and over 1400 marijuana plants were located.

This investigation is ongoing and detectives are actively reviewing evidence. To date, detectives have located evidence that gave them cause to believe Melvin likely accidentally shot himself while working at the illegal marijuana grow in Forbestown. Detectives also located evidence that Carlos and his two sons, with the assistance of Juan

Cruzcupido, then moved and attempted to conceal Melvin's body to prevent law enforcement from discovering their illegal marijuana grows.

To date, the following individuals have been arrested:

Carlos Garcia-Hernandez was arrested for misdemeanor counts of illegal cultivation of marijuana, possession of marijuana for sale, and unlawfully moving and disposing of human remains.

Juan Garcia-Vargas was arrested for misdemeanor counts of illegal cultivation of marijuana, possession of marijuana for sale, and unlawfully moving and disposing of human remains.

Ronald Garcia-Vargas was arrested for misdemeanor counts of illegal cultivation of marijuana, possession of marijuana for sale, and unlawfully moving and disposing of human remains.




