

Ethnic Studies Now Required for All High School Students

SACRAMENTO, CA (MPG) - On September 8, 2021, the Legislature passed Assembly Bill 101 (Medina) to mandate that

every high school student take a course in ethnic studies in order to graduate. Vice Chair of the Assembly Education Committee Kevin Kiley (R-Rocklin) responded to the passage of this bill with the following

"The first version of the Ethnic Studies model curriculum was universally condemned by Jewish leaders across the state. But instead of scrapping the bill, the Legislature accepted some minor tweaks and has decided to impose Critical Race Theory on every high school student in California.

"The purpose of education is to prepare students for citizenship and civic engagement. As our state has lost sight of that purpose, CRT has filled the void as the anti-civics. In essence, a failure to teach students how to build their communities up has created an opening for those who would have them tear their communities down.

"I urge Governor Newsom to stand by his word and reject this harmful bill."

Earlier this year, Assemblyman Kiley gave a speech in opposition to the bill on the Assembly Floor.

The model curriculum on which AB 101 is based has been embroiled in controversy for many years, prompting Governor Gavin Newsom to veto a similar graduation requirement in 2020 citing concerns that it did not go far enough to eliminate bias and discrimination. Jewish-American groups remain strongly opposed to the bill, with one even calling it "tantamount to putting an even larger target on the back of every Jewish student." 70 organizations sent an opposition letter to the State Senate last week urging legislators to reject this harmful attack on the Jewish community.

Bequette's "Lookin' Good"

GRIDLEY, CA (MPG) -Gridley's own Todd Bequette, now practicing as a Criminal Defense Attorney in Oakland, Calif., has recently put pen to paper and written a different document: A novel.

Bequette's debut novel, "Good Lookin': A Joe Turner Mystery" is set on the gang-ravaged streets of Oakland and follows attorney Joe Turner as he defends hardened criminals and attempts to "unravel a decade-old murder and a tangled web of family loyalty and devotion. Viewed through the prism of the unique bond of twins, Good Lookin' asks how far each of us will go to protect the ones we love."

Bequette, who was born and raised in Gridley, now resides in Lafayette, CA and holds degrees

Pacific and Georgetown Law School. Much of the inspiration for his novel comes from his extensive experience as a criminal defense attorney saying, "I've observed the culture first-hand. Most of my law practice involves defending Oakland youths accused of murder, so I've seen how the snitch culture can roadblock the path to justice." Combining his knowledge with a passion for creativity, Bequettes latest project has been exciting for the attorney. "I've always loved to write creatively," he says, "but legal writing is much different. It's sort of the opposite of creative." When he finally decided to take the leap and begin his first book, he says "It was liberating."



A Morning Like No Other - Ground Zero at 20 Years

After a long night of late work well into the morning, I was in a deep sleep. The repeating ring of the telephone wakened me. I received an alarming telephone call from a close friend frantically trying to get my attention. She said "just get up and turn on the TV. You won't believe what is happening". She was absolutely right.

As I sat there on my

white leather couch in my small rental home in Roseville, tuned in as the world was tuned it, to the disaster in New York as it unfolded live for everyone to see. We were all New Yorkers that day.

I had previously lived in Manhattan. After returning to California, I traveled to New York City often to teach classes at The Learning Exchange and spiritual training centers as a part of my ministry. I also met with many clients as a spiritual life coach each visit. Through these visits I became friends with so many great people who lived in The City. I stayed at their homes, got to know their families, learned about their lives, loves, and fears. Many of them worked in the immediate area of the Twin Towers.

As I sat there watching the towers fall along with the rest of the world, I had no idea if any of those friends or members of their families were weight of that destruction. It was a personal anguish and horror felt by millions simultaneously. It was a grief embedded forever. And we as a nation vowed to never forget.

Everything changed for everyone during those hours. Terrorism had come to our shores, and those whom we had charged to protect us failed miserably. We have been paying for their failures ever since.

And for those who paid the ultimate price, giving their lives to save others inside and around the Twin Towers? And for all the First Responders who witnessed the death and destruction at the end of

their fingertips and right before their own eyes? What did they get from so many after only 20 years? Many forgot.

Upgrades To Critical Canals Farmers and ranchers are working with lawmakers in hopes of passing legislation to fund repairs and upgrades to California's water conveyance system. Senate Bill 559, from Democratic Sen. Melissa Hurtado of Sanger, would pay for more than \$300 million in repairs on the Friant-Kern Canal, the California Aqueduct and the Delta-Mendota Canal in the Central Valley. The California Farm Bureau supports the improvements.

Raging Timberland Fires Renew Calls For Better Forest Management

Calls for improved forest management approaches are echoing again as devastating fires rage in California timberlands, even burning into the Tahoe Valley. Licensed timber operator Mike Albrecht in Tuolumne County encourages forest thinning efforts that won't repeat mistakes of the past. For years, rather than thinning forests, California thinned out sawmills and biomass plants - removing useful forestry infrastructure.

California Plums Get Improved Market Access to Japan

Export rules have been streamlined to help more California plums reach buyers in Japan. Caroline Stringer of the California Fresh Fruit Association says multiple rounds of negotiations have refined protocols for fruit entering the Japanese market. While she doesn't expect an export spike this year, she said the new rules will expand market opportunities over time. The California plum harvest wraps up in October.

Agricultural Exports Surging in 2021 and 2022 Looks Bright

U.S. agricultural exports for 2021 are running nearly one-fourth higher than last year, based on forecasts through August. And an even better export economy is forecast for 2022. According to the U.S. Department of Agriculture, 2021 farm exports are expected to total \$173.5 billion for the fiscal year. That figure is expected to increase by another 4 billion in 2022. Rising soybean and corn shipments to China are a key factor.

The Day of Atonement is also known as the Jewish New Year. Jews throughout the world will soon celebrate Yom Kippur, the Day of Atonement, the holiest day on the Jewish Calendar.

The solemnity of the occasion is evident in the English name itself, to be at, or one with God. Rather than a time to party and get drunk as is its secular counterpart, the Jewish New Year and Yom Kippur is a period of intense soulsearching, a time when all Jews, regardless of the level of their devotion during the rest of the year, come together in synagogues around the world to take stock of their lives and behavior, and seek to be better

It is a collective soulsearching as well as individual, each item in the long list of human errors

The Yom Kippur service ends as the Rosh recited during the day Hashannah service begins, long Yom Kippur service with the sounding of the Haskell Streets.

Herbal Supplement

Dear Readers.

Chances are, many of you are taking some type of herbal supplement. People are turning to natural remedies for their health, such as ginseng for better energy, saw palmetto for prostate health, or echinacea to boost the immune system.

In 2019 Americans spent about \$9.6 billion on herbal remedies. Consumers report a preference for natural products, heightened awareness of preventive healthcare, and increased spending on health and wellness as contributing factors for herbal purchases.

It is important to realize that just because something is natural does not mean it is safe. Many herbal supplements interact with other medications, so it is essential to talk to your health care provider before taking an herbal remedy.

A man in Texas needed a liver transplant after taking green tea extract for a few months. It is unclear if he was taking the extract as directed. Drinking green tea is considered safe, and some studies show positive results in preventing heart disease, although these studies are limited. Green tea extracts often contain high levels of epigallocatechin gallate (EGCG), an antioxidant that has been linked to liver damage

when taken in high doses. The European Food Safety Assessment (EFSA) warns against taking EGCG in amounts greater than 800 mg/day but has not established a safe dosage.

Supplements, vitamins, minerals, and herbal remedies are not regulated by the Food and Drug Administration in the same way medicine is. While the United States Pharmacopeia (USP) tests herbal supplements for potency, absorption, and validity, this testing is voluntary. There have been tests performed on herbal supplements that have found contamination or that the product did not contain what it claimed. Look for the 'USP verified' symbol on the bottle to ensure a wise purchase.

We live in a "Let the buyer beware" society, so as with all products, be an informed consumer when it comes to herbal remedies. ConsumerLab. com is a private company that independently tests herbal supplements and publishes the results. There is an annual fee to join. 

CORNER **Hoarding and Fire:**

Do you have a person in your life who may be a hoarder? Hoarding is a condition where a person has persistent difficulty discarding personal possessions. The large amount of possessions fills the home and prevents the normal use of the space. Living space becomes cluttered. It may be unusable. Hoarding brings distress and emotional Health concerns.

Why Hoarding Increases Fire Risks

- Cooking is unsafe if flammable items are close to the stove or oven.
- Heating units may be too close to things that can burn. They might also be placed on unstable surfaces. If a heater tips over into a pile, it can cause a fire.
- Electrical wiring may be old or worn from the weight of piles. Pests could chew on wires. Damaged wires can start fires.
- Open flames from smoking materials or candles in a home with excess clutter are very dangerous.
- Blocked pathways and exits may hinder escape from a fire.

How Hoarding Impacts First Responders

- · Hoarding puts first responders in harm's way.
- Firefighters cannot move swiftly through a home filled with clutter.
- Responders can be trapped in a home when exits are blocked. They can be injured by objects falling from piles.
- The weight of the stored items, especially if water is added to put out a fire, can lead to building collapse.
- Fighting fires is very risky in a hoarding home. It is hard to enter the home to provide medical care. The clutter impedes the search and rescue of people and pets.




When talking to a person who hoards, focus on safety rather than the clutter. Be empathetic. Match the person's language. If they call it hoarding, then you can call it hoarding.

Help the residents make a home safety and escape plan. Stress the importance of clear pathways and exits. Practice the plan often. Exit routes may change as new items are brought into the home. Install working smoke alarms in the home. Test

them at least once a month. Reach out to community resources. Talk to members of the fire department to alert them of your concerns. They may be able to connect you with members of a hoarding task force for additional help.

My Thoughts on Afghanistan

Throughout the last few weeks, I have watched Afghanistan descend into disarray with sadness, embarrassment, and anger. It truly did not have to turn U.S. service members and out like this. As the last of our troops were flown out of Afghanistan, I felt the need to share my thoughts with you all on this tragic situation and stain on our international reputation.

Since early July, the United States has been pulling troops out from various posts throughout Afghanistan in an attempt to meet an August 31st deadline. By early August, the Taliban was making rapid gains across the country, culminating in their uncontested capture of Kabul on August 15th. The very next day, President Biden, our Commander in Chief, claimed he had made the right decision and solely blamed the Afghan military and government for the chaos.

Although the Biden Administration had intelligence indicating a strong possibility that the Taliban could quickly regain significant portions of the country, it continued to pull American troops and failed to create a plan to assist Americans or our Afghan allies in evacuating out of Afghanistan safely and efficiently. The Biden Administration inexplicably decided to abandon our major air to the airport in hopes

base, Bagram, leaving Kabul as our only point of departure. As a result, many American troops had to be brought back to Kabul to secure the Hamid Karzai International Airport and begin evacuations.

Under Taliban control, Kabul has already become a breeding ground for terrorism - many terrorists escaped prison during the chaos that has engulfed the city over the past two weeks. Tragically, on August 26, 2021, ISIS Khorasan (ISIS-K) attacked and killed 13 up to 170 Afghans at the Abbey Gate, one of the entrances to Hamid Karzai Airport.

This week, I cosponsored a bill to award those 13 service members the Congressional Gold Medal, the highest expression of appreciation given by Congress, in tribute to the families of those 13 brave young men and women. We pray for their peace and comfort in this tragic time.

The withdrawal from

Afghanistan was not a simplistic choice between pulling out or continuing our presence as is. We could have, in an orderly and more sensible fashion, withdrawn personnel that kept the most vulnerable secure. While providing close air support to our Afghan allies, we could have shown them that we would continue to support them in their effort to hold off the Taliban. A sane plan would have evacuated all American civilians and identified Afghan allies before we pulled back militarily. Instead, American citizens, women and children included, were beaten by the Taliban at checkpoints as they attempted sneak



of being rescued. Many never made it out.

The way the Biden Administration left the country was disrespectful, dangerous, and un-American. Instead of prioritizing the protection of Americans, the Biden Administration buckled to the Taliban and incredibly, even gave them a list of every American and Afghan ally we were trying to evacuate, including their last known location. Up to 200 Americans and thousands of Afghans, who we promised to protect, have been left in Afghanistan. Their fate now lies in the hands of the Taliban. Already, many of our allies and their families have been brutally beaten and killed.

The chaos of the past month has now left military equipment worth many billions of dollars in the hands of the Taliban. They have begun using this equipment to publish and disseminate propaganda, including a particularly troubling recreation of the U.S. Marines raising the flag

is the white Taliban flag raised aloft. This is a brazen disrespect to U.S. taxpayers, after losing 2,372 American lives, putting 800,000 individual U.S. troops in harm's way while rotating through Afghanistan over the past two decades, and spending \$2.3 trillion in taxpayer

After abandoning our partners in Afghanistan, who will continue to stand with America? Who will trust our word or commitments? Already, many of our NATO partners are questioning our resolve and commitment to them. The British are openly rebuking our leadership. Parliament has officially held Biden in contempt over this fiasco.

Our hurried withdrawal disregarded our allies and security partners and serves as a striking example of our Commander in Chief not keeping his promises to those who risk their lives to help the United States. In the future, potential foreign partners may on Iwo Jima in 1945 well think twice before every American to rally tudes around the globe. ★

withdrawal puts our international reputation and national security at risk. It pains me to think that our brave service men and women fought and sacrificed for 20 years just to have a Commander in Chief completely disregard their work and allow the Taliban back to where they were before 2001.

Although my frustrations are plentiful, I am grateful for the skill, service, and grace our service men and women have shown over the last 20 years in Afghanistan. They have prevented terrorism from reaching our shores because of their effort and sacrifice during that time. That is success. We all thank our military service members, those who were wounded both physically and mentally, as well as our Gold Star Families for your loss that will resonate in your family for generations. We honor and cherish the memory of your loved one and ultimate sacrifice they gave us in the name of freedom. Now is the time for

- however, this time it taking us at our word. The around our service members and veterans. The failures in Afghanistan lie with Washington, not those who have served and sacrificed more than many of us can fathom. We must support those serving now and our veterans more than ever.

I will continue working with the State Department to evacuate our remaining Americans and allies as quickly as possible. I pray for the Afghan people, especially women and girls who can no longer go to school under Sharia law. Our great Nation has had many ups and downs, and mistakes we have lived through and learned from. Let this be one, as we rally and refocus on what makes America and our ideals the greatest hope of liberty throughout the world. I pray the President and his administration will change the current course of action and that our countrymen and allies left behind will be rescued. Let's restore our standing in the world and strive to be that shining city on a hill, an inspiration of freedom to the multi-

Local Athletes Hit the Volleyball Courts



California Housing Plans Need an Overhaul

For more than a half-century, California has been trying to nudge county and city governments into generating enough new housing to handle an ever-

increasing demand. The state's chief tool has been a legal requirement that local government "general plans" include an adequate "housing element." Every eight years, the state Department of Housing and Community Development issues regional quotas of housing needs which then are divvied up into specific city-by-city goals for zoning enough land to meet projected needs.

The allocations are very controversial, especially in suburban communities, because they run counter to the not-in-mybackyard sentiments of local residents. As housing production falls chronically short of the state's goals, the cyclic quotas steadily increase and in recent years the state has added penalties for failure.

Obviously, the quota system hasn't been working very well and researchers at UCLA's Lewis Center for Regional Policy Studies have concluded that it has a "fundamental flaw" because vacant land

"The median Bay Area city is on track to approve housing projects on less than 10% of the sites listed in its housing plan," the study found. "On average, however, cities are achieving a substantial portion of their (too low) housing targets – nearly 60% for the median city – just not on the sites they had selected and presented to the state as likely or apt for development. Across the Bay Area as whole, nearly 70% of housing built during this period was on sites not listed in housing plans."

While cities zone specific sites to meet quotas, "housing development occurs in a way that is hard to anticipate. In spite of planners' efforts to select imminently viable sites, they do not."

The solution, they say, is to create a more realistic set of requirements that identifies all potential sites for housing, a "change (that) may require cities to their housing plan."

While a more realistic inventory might require more work – and possibly increase local angst – the UCLA team also proposes that "cities receive preemptive credit for housing

they expect to be built on sites not listed in their plan.

"The credit would be tied to production on noninventory sites during the previous period, giving cities an incentive to accommodate much-The study focused on needed development when can't anticipate exactly where or what developers will want to build."

"The Legislature should stop proliferating ever more detailed requirements for a site to be included in the inventory, and instead require cities to consider every parcel on which residential use is allowed," the UCLA team suggests. "Since cities aren't very good at picking the sites where developers want to build, the focus should shift to estimating how much housing is likely to be built during the planning period on the entire stock of residentially zoned land in a city.

This is wonky stuff, but important because of the state's worsening housing shortage. The proposals would shift the housing quotas from an exercise in paper-shuffling into something more likely to produce real results. But implementing it would require an official admission that the current system isn't working and a willingness to correct its "fundamental flaw."










9/11 Day of Service Gallagher Relentlessly Pursues and Remembrance

Wildfire Solutions

Revives Cancelled Legislative Hearing on the Capitol Steps

SACRAMENTO, CA (MPG) - In response to the cancellation of the only scheduled legislative hearing on wildfires, Assemblyman James Gallagher (R-Yuba City) joined other lawmakers in fire prone districts to host their own wildfire forum on the steps of the State Capitol. The event, titled Wildfires & Climate: Finding A Better Path Forward, was intended to identify barriers and solutions to preventing catastrophic wildfires.

"The political establishment in Sacramento has put this off for far too long," said Gallagher. "Committees have refused to even hear bills on wildfire and most recently, oversight hearings on the topic have been cancelled. We should not and cannot wait any longer.

Gallagher was joined by Senator Jim Nielsen (R-Tehama) and members of the Assembly Republican Wildfire Working Group. The forum featured testimony from eight expert witnesses, including five panelists from the North State.

The lawmakers highlighted several solutions they are pushing for, including:

Allocating \$500 million from the General Fund for Fire Prevention and Forest Health Grants; Exempting wildfire mitigation projects from the California Environmental Quality Act (CEQA); Extending the Greenhouse Gas Reduction Fund commitment in SB 901 through 2028-29 with a \$200 million a continuous appropriation.

"I'm not the type to give up or give in. Clearly the status quo on wildfires is not working," said Gallagher. "These cataclysmic fires are burning down communities, taking lives and livelihoods, obliterating California's climate reduction goals, and destroying critical habitats. I will not allow the Legislature to bury their heads in the sand in denial. We will keep pushing until we get results."
