Orchard Hospital Mandates Vaccines for Healthcare **Workers**

GRIDLEY, CA (MPG) - Orchard Hospital will require all employees to be vaccinated by September 30, 2021, following a state-wide public health order.

A state-wide public health order was issued August 5, 2021, by Gov. Newsom requiring all healthcare workers in California to be vaccinated for COVID-19 by September 30, 2021. "As COVID-19 positivity rates continue to increase, a public health order from the Governor's Office is not surprising", says Steve Stark, Orchard Hospital's chief executive officer. "While many of employees have voluntarily received the COVID-19 vaccine, this new mandate ties our hands on allowing unvaccinated employees to report to work, absent a medical or religious exemption", Stark explains.

Another Public Health Order issued on the same day will require unvaccinated visitors to show proof of a negative COVID-19 test within 72-hours of visiting a patient. Orchard Hospital plans to set up virtual visits for its patients for unvaccinated visitors that cannot show proof of a negative COVID-19 result.

COVID-19 Vaccines Are Safe

"In the past three months, nearly all hospitalizations related to COVID-19 are in unvaccinated populations of people", says Dr. Natalie Ladine, Orchard's chief medical officer. "The evidence is clear; the vaccination is safe, and vaccinated people have much better outcomes if they contract COVID-19," Dr. Ladine concludes.

CSEA Confronts GUSD Board

GRIDLEY, CA (MPG) - At the last Gridley Unified School District Board Meeting, the California Schools Employee Association (CSEA) addressed board members on the issue of a pay increase and fixed salary.

Before the Wednesday, August 18th GUSD board meeting, district classified employees, which includes instructional aids, office clerks, custodians, cafeteria workers, translators, media clerks, librarians, health office aides, maintenance/ grounds workers, IT technicians and more, protested outside the district office. Holding signs saying, "WE ARE ESSENTIAL", "Tell the Truth" and "Fix Our Salary," staffers vented their frustrations regarding current negotiations, or lack of, with the GUSD Superintendent, Jordan

Reeves, and his negotiating team of Heather Naylor, GUSD Chief Business Officer and Julie Vang, GUSD Personnel Manager. Earlier this month, GUSD Superintendent declared Impasse between the two negotiating bodies.

Antionette Hudson took to the podium first to address the board and circulated handouts to those in attendance containing both CSEA's proposal and the last proposal from the district. She said, "It seems


Profile of a Legend: Brian Bassett and Legend Soundworks

He has also softened the atmosphere at the Courtyard Stage by adding cafe style seating, string-lighting and arranged live musical acts so families are encouraged to sit and enjoy themselves. 



Unemployment Insurance Fund Debt Undermines Safety Net Programs

SACRAMENTO, CA (MPG) -

The California Legislature has rejected efforts to begin to pay down even the smallest fraction of an estimated \$22 billion Unemployment undermining the long-term integrity of the program and guaranteeing that businesses of every size will be forced to pay higher taxes in an effort to pay off the debt.

"The UI Fund has been critically important during the recession, helping provide support for workers who lost their jobs due to government-mandated closures. But now the Legislature is refusing to provide the program critically needed funding that will help alleviate the \$22 billion – and growing - debt the fund has accumulated after the fifth-largest economy shut down for 15 months," said Rob Lapsley, president of the California Business Roundtable.

Employers are paying higher taxes now and

While the state rates were on course to go down prior to the pandemic, the rapid deterioration of the state fund's viability means these higher rates are now likely locked in for another decade

In addition, federal taxes on employment will go Insurance (UI) Fund debt, higher as well. As a participant in the federal unemployment fund program, the state cannot carry a UI Fund debt for more than 34 months. If the state continues carrying the debt, businesses will automatically incur an annual payroll tax increase until the fund debt is paid off. Because of the size of the current UI Fund debt, it is unlikely that the debt will be paid off before the next recession hits, creating a permanent tax increase on all businesses while ensuring this critical safety net will not be there to help workers in the next economic downturn

"California businesses already pay the highest unemployment fund tax rate, plus a 15 percent surcharge. Without a significant investment from the state to address the massive UI Fund debt, businesses are now on the hook to pay for debt that they didn't create and cannot afford to pay back.

"There is no time to delay. This tax increase is hurting employment now, and even higher taxes will go into effect when the federal increases kick in as well. The troubling reality is that businesses will likely never be able to pay off this debt. The debt is so large that we will likely experience another recession before the current debt is paid, creating debt in the fund and erasing any progress businesses have made to pay off existing debt. Nielsen Comments on Hearings on EDD Reform Postponed Indefinitely

SACRAMENTO, CA (MPG) - Sen. Nielsen issued the following statement regarding the indefinite postponement of a joint legislative hearing on the mismanagement of the Employment Development Department (EDD) scheduled for Aug. 24:

"There are hundreds of thousands of Californians struggling to put food on the table and keep a roof over their heads because of Governor Newsom's gross mismanagement of the EDD.

"Most of these folks lost their jobs because of the governor's mandated shutdowns, and can't get through to the EDD to get their unemployment benefits, but the EDD has paid out an estimated \$31 billion in fraudulent claims.

"As the LA Times recently reported, 'As of July 31, there was a backlog of 216,000 claims that had not been approved within 21 days. The week ending on that date saw the EDD receive 3.4 million calls – it was able to answer only 248,000 of them.'

"Clearly, the governor is trying to dodge the massive negative news coverage this important informational hearing would have generated ahead of the recall election.

"This is outrageous political gamesmanship.'

In July 2021 alone, Nielsen's office worked with 479 constituents in Senate District 4 who are having problems with EDD. For six months in a row, the office has had recordbreaking numbers of EDD cases:

February – 274; March – 275; April – 306; May – 447; June – 475; July – 479.

SACRAMENTO. CA (MPG) - The California gubernatorial recall election is underway and voters across the state are eager to make their voices heard. This special election is being held to answer two important questions: Should Gavin Newsom be recalled from the office of Governor? If so, who should replace him? How voters answer these two questions could transform the political landscape of both California and the U.S. for years.

For Debbie Wuthnow, president of iVoterGuide, this recall election provides a unique opportunity. "An opportunity like this hasn't occurred in California in years. Recent polls indicate that the state is evenly split over the effort to recall Governor Newsom, with the majority of California voters still undecided. Will Legislature Confront **California Housing Crisis?**

California had a huge and growing housing problem before COVID-19 reared its ugly head 18 months ago, falling well short each year of state construction goals.

The pandemic, which continues to flare up, "exacerbated a long-standing housing shortage, intensified a statewide affordability crisis, and provoked housing instability," the new state budget declares.

While suddenly unemployed workers struggled, and often failed, to make their monthly payments, the prices for homes soared, freezing out many who aspired to ownership.

The budget projects that California will add, at best, about 100,000 housing units this year, which is scarcely half of the 180,000 units state housing authorities say are needed to meet current demand and reduce the backlog. And that projection did not take into account the current COVID-19 surge.

The Legislature has reconvened after its summer vacation and is sprinting toward adjournment in mid-September. Housing is, or should be, at the top of its

While many factors affect the housing shortage,

the most important is the of the law's efficacy. reluctance of suburban communities to embrace multi-family housing projects, particularly those for low- and moderate-income renters.

Dubbed "not-in-my-backyard," or NIMBY, it is by no means a recent phenomenon. One could trace it back to the anti-Asian exclusion laws of the 19th century, and 20th century anti-okie laws and whites- and Christiansonly deed covenants.

As California's population exploded after World War II, some rural communities attempted to avoid becoming commuter suburbs. When Petaluma adopted a strict growth control law in the early 1970s, developers sued and the case went all the way to the U.S. Supreme Court, which allowed Petaluma's law to remain in effect.

The state has made multiple attempts to overcome NIMBYism, such as imposing residential zoning quotas on regions and cities. Recent versions contain some penalties for cities that ignore their quotas and the state sued one city, Huntington Beach, for ignoring its quota.

One of the state's many anti-NIMBY actions is the Housing Accountability Act, first enacted in 1982 and later tightened up. It essentially bars local governments from arbitrarily blocking housing projects that are "consistent with objective local development standards."

Citing the law, pro-housing organizations have been challenging local governments when they reject low- and moderateincome projects and two cases are looming as tests

One is in Huntington Beach, which rejected a 48-unit project. The California Renters Legal Advocacy and Education Fund (CaRLA) sued but a local judge ruled for the city, declaring that it had valid reasons, such as increased traffic, to deny a permit for

CaRLA is also suing San Mateo, which imposed stringent design requirements on a 10-unit project that its developers said were onerous. Once again, a local judge ruled for the city and even questioned whether the Housing Accountability Act can be constitutionally applied to a charter city under the home rule doctrine.

Both cases are headed up the legal appeals chain and state Attorney General Rob Bonta is intervening in the San Mateo case to defend the law's application.

That brings us back to the final weeks of the legislative session and two highly controversial anti-NIMBY measures. Senate Bill 9 is the latest effort by Senate President Pro Tem Toni Atkins to allow small multifamily projects on lots zoned for single-family homes, while SB 10 would allow local governments to approve up to 10 units of housing on any lot, regardless of current zoning, near transit.

Whether they pass or fail will tell us much about the direction of housing policy as California's crisis continues.

Scrambling to Keep the Lights On

Water projects in the West stand to benefit from the Senate's recent passage of a bipartisan infrastructure bill. The bill, still to be passed in the House, would provide more than \$8 billion for new water storage facilities, upgrades to aging dams and canals and other infrastructure. Western states face severe drought impacting farmers and water providers. A national coalition, led by the California Farm Bureau, backed the legislation.

Drought Curbs Tomato Harvest, Stokes Fears of Harder Times

California tomato farmers are expecting only a modest decline in output this year. But growers fear exceptional drought conditions could lead to a far greater drop in tomato production next year. The California Tomato Growers Association said this year's very hot growing season will impact Central Valley yields. The state's tomato forecast of 12 million tons has been revised downward by 400,000 tons and may fall some more.

Tariffs From China Still Impact California Farm Products

Tariffs as a result of trade disputes with China are continuing to impact a range of California farm products. In particular, tree nuts and wine still face increased duties, despite last year's implementation of the Phase One U.S.-China trade agreement. Meanwhile, tariffs on farm products have been suspended for exports to Europe under an interim agreement between the U.S. and the European Union.

USDA Provides Healthy Food Grants to California Communities

The U.S. Department of Food and Agriculture is funding \$69 million in grants to provide nutritious foods to low-income communities enduring the pandemic. The money includes more than \$6 million in nutrition grants to increase fresh fruit and vegetable offerings for shoppers in underserved California areas. Funds also will support the VeggieRX nutrition program at Fresh Approach in Concord and provide produce to Los Angeles County residents with diabetes.

Antioxidants

Dear Readers,

Most of you have probably heard of antioxidants. They're good for you, right? But what are they, exactly? "Antioxidant" is a chemistry term that simply means preventing oxidation, which is the transfer of tiny, electrically charged particles known as electrons.

Antioxidants protect us from free radicals, which damage our cells and may lead to cancer, heart disease, and Alzheimer's. Free radicals are unstable molecules that wish to become stable. In doing so, they rob another cell of an electron needed for stability. The cell that has been robbed is now susceptible to damage. Free radicals result from food digestion, everyday cellular activity, and outside sources like smoking and air pollution.

Studies on the role of antioxidants and disease prevention have produced mixed results. In the Women's Health Study, over 39,000 women took 600 IU of vitamin E or placebo every other day for ten years. At the end of the study, the rates of stroke, heart attack, and cancer were not lower among those taking vitamin E. However, there was a significant twenty-four percent reduction in death from stroke and heart attack

There was another large study of beta-carotene supplementation in men who were heavy smokers. The study was aborted because there was a significant increase in lung cancer among those taking the supplement than those given the placebo (2).

Antioxidants in their natural food state may have health benefits that are not found when taking them in supplement form. A possible explanation of this is the x-factor. When consuming foods that contain antioxidants, one also gets fiber and other nutrients in that food that cannot be found in a supplement. The x-factor could be a combination of nutrients that have a health benefit or even be a factor that has not yet been identified. Remember, the science of nutrition is still in its infancy, and there is still much to be revealed.

Listed below are particular antioxidants and their food sources:

Vitamin C - oranges, grapefruit, lemons, cantaloupe, kohlrabi, broccoli

Vitamin E - nuts & seeds

Beta-Carotene - carrots, sweet potatoes, spinach, broccoli, winter squash, cantaloupe

Polyphenols - red grapes, red wine, coffee, chocolate, legumes

Lutein - spinach, kale, egg yolk Selenium - beef, pork, turkey, fish, chicken, shellfish, nuts, seeds, soy products

Manganese - pineapple, nuts, beans, spinach

Remember, a diet rich in fruits and vegetables, whole grains, legumes, nuts, seeds, and lean proteins, along with a healthy body weight, is the best bet for keeping us healthy.

"To Newsom or Not to Newsom"

Governor Newsom's recall election concludes September 14, and the rhetoric is heating up, so it's important to carefully evaluate what's being said! We will see more political advertisements bombarding us!

The first ad I saw was the rapid-paced Newsom's "Roaring Back" blitzkrieg. It starts with, "Newsom is delivering money to your pocket!" It continues ... \$1,100 in your pocket, plus \$500 if you have children (Covid relief). It then proclaims he delivered \$4 billion in small business grants (again million cost of the recall, Covid). A couple projects by Newsom are mentioned and it ends with "Free Pre-K" for every child!!

Honestly, my first reaction was that Newsom is paying us to vote for him. Money for everyone! However, most of that money is federal money and all of that money is

taxpayer money. The other ad I viewed was US Senator Elizabeth Warren (D-Massachusetts) "Here's the Deal" declaration. "Republicans across the country are attacking the election results and the right to vote." And, she asserts, these same evil forces are attacking California in a power grab. This "Partisan Recall" is "abusing the recall process," Warren declares!

How so, I wonder? How is the process being abused? The process was laid out in state law for anyone to use since 1911.

Since 1913, eleven recalls have qualified for the ballot (of 179 attempts) and six were successful per the Secretary of republicans and three democrats were recalled. That doesn't seem too partisan. And, if this is such a partisan power play, why is Warren from Massachusetts doing the ad and not one of our two US California Senators (both democrats)? Other Newsom ads speak of "anti-science republicans" and other guilt by association smears.

And, by the way, if you ask who is funding the Warren ad, it's Reed Hastings (Netflix founder/ CEO) who was also on the board of Facebook; the Service Employees International Union #215 (state employees union); and the California Democratic Party.

Newsom blasts the \$276 which is a lot of money. However, that pales with other state expenditures, such as the proposed \$1 billion being foisted by the legislature to tear down and rebuild the Capitol annex so legislators can have new luxury offices! The recall is a legitimate expense of citizens exercising ownership over their government. The Annex is just the legislators padding their own chairs!

There are approximately 22 million registered voters in California. About 24.2% are republicans, 46.1% are democrats, and 24% have no party preference. when Newsom touted the 30 day period when people could retract their signatures ... less than 50 did so. How embarrassing!

In an August 2-4, 2021 statewide poll for the San Diego Union, 51% favored State. Of those six, three recalling Newsom (up from 36% in May). Only 40% wanted to keep him (down from 47% in May).

Now, you may like or dislike Newsom, and I'll keep my opinion to myself, but I can confidently predict the recall is not about partisanship, but perceived performance by the voters.

Just be glad we don't have the 135 candidates as we did in 2003 with the Gray Davis recall.

Be skeptical of advertisements. Beware of what is promised but unproven! Come to events, such as our SacTax (Sacramento Taxpayers Association) interviews with Governor candidates this year. Be informed and intelligent. Exercise ownership over our governments. These recommendations will make each of us better citizens!

Watch out for Airfare Scams When Booking Flights

SACRAMENTO, CA (MPG) - With the availability of COVID-19 vaccines, travel is coming back! That's great news for summer vacation plans... and scammers. BBB Scam Tracker is receiving reports of con artists creating fake airline ticket booking sites or customer service numbers. If you are buying airfare, use caution and double-check the URL or phone number before providing your credit card information.

How the Scam Works

While doing an online search for cheap flights, you come across what seems like a great deal with a major airline. You book the flight – either through the website or by calling a customer support number - and receive a confirmation message. However, when you look more closely at the email, you notice that you never actually received

In another version of this scam, you book a flight on a travel website offering deals on airfare. You pay with your credit card like normal. But shortly after making the payment, you receive a call from the company saying that there's been a sudden price increase or an extra charge to finalize your booking. This is something a legitimate company would never do!

In either case, you call the airline to follow up about your flight. After talking to an agent, you find that they have no record of your booking. It turns out you accidentally purchased tickets through a scam website or a phony customer service number. One victim told BBB Scam Tracker: "I received a phone call right after [I booked the flight] stating that they wanted \$100 per passenger to finalize my flight." Then, after calling the airline to complain, the victim discovered that "the flight wasn't available to begin with. The flight was never booked... this company just charged my card."

How to Avoid Travel Scams

Do your research. If you come across a company you haven't dealt with before, research it before making any purchases. Look on BBB.org for reviews and feedback from previous customers;

Double-check the URL before you enter personal and payment information. It can be easy to click on a sponsored ad or imposter website without noticing. Before you enter any sensitive information, double-check that you are on the right website and that the link is secure. Secure links start with "https://" and include a lock icon on the purchase page. Learn more at BBB.org/BBBSecure;

Be wary of third-party websites. Some websites appear to offer a legitimate service but are only fronts for a scam. Be suspicious of websites with no working customer service number and no physical address. Typos and grammatical errors can be indications of a scammer's handiwork, too;

Make online purchases with your credit card. Fraudulent charges made on a credit card can usually be disputed, whereas that might not be the case with other payment methods. Unfortunately, there is no way to get back the personal information you may have shared.

Warning to Remote Workers: Out of Sight Could Mean Out of Job

Although debate continues about whether the business world will return to normal even after most people have the COVID-19 vaccine, the expectation is that many companies will soon call employees back to the office.

Some workers may still get to work part-time from home, and some businesses will make remote work permanent. But tension between owners and workers is building as it becomes evident many employees are resistant to giving up working from home. In a survey, 65% said they want to work remotely full-time after the pandemic. And in a poll conducted by LiveCareer, 29% of working professionals said they would quit if they couldn't continue working remotely.

But those who push back against ownership's preference to return to the office might paint themselves into a corner, especially if they stand out. says Rod Robertson, Managing from employees. And those commean out of mind, or out of job, when it's time to trim the roster," he says. "Working from a distance all the time is going to lower your skill level, your engagement, and your productivity. Employees need to make the time to have facetime in the office and stay in the groove with ownership and management. You can't do technology."

> Show the human touch. "When we achieve herd immunity, faceto-face meetings with co-workers, managers and clients should be 20 to 25% of someone's portfolio of time," Robertson says. "Zoom meetings are a pain because you

have to set them up. Remote employees should prioritize live voice communication with colleagues, managers, and clients in order to stay in the game. Picking up the phone to talk with someone keeps the relationship alive and brings more clarity than constantly texting or emailing."

Push your boss to measure that as well at home relying on you quantitatively. "Woe to the remote employees who believe they are not under increasing scrutiny – downsizing is on the way," Robertson says. "The good employees working at home will have more reporting mechanisms in place. Show your boss your genuine enthusiasm by

being proactive and coming up with more measurables for your performance."

Do extracurricular work. "The question is, how can you be front-and-center with the boss?" Robertson says. "One way is to do extracurricular work by bringing relevant and helpful articles to ownership. Develop a thesis for those articles to show that you're a thought leader. Executives and managers are flooded with emails, so the smart employees send a synthesis of an article that's to the point.

"Businesses can't afford slippage," Robertson says. "Once there is herd immunity, the remote work issue shouldn't be just about where employees feel they are most comfortable, but how they can be the most valuable and effective."

Detection of Invasive Aedes Mosquitoes in Gridley

Butte County Mosquito and Vector Press Release

BUTTE COUNTY, CA (MPG) - The Butte County Mosquito and Vector Control District (District) detected an invasive (non-native) species of mosquito on Tuesday, August 2, 2021. The Aedes aegypti, commonly known as the yellow fever mosquito, was found in Gridley in the area of Highway 99 and East Gridley Road. The California Department of Public Health confirmed the invasive species detection. The District has identified this invasive mosquito in Chico, Thermalito, Oroville, and now Gridley.

"The District is working to evaluate the extent of the infestation and we plan to do everything we can to eradicate this mosquito and to protect our residents from the potential disease risk of these invasive mosquitoes," said Matt Ball, District Manager. "Our goal is to control and eliminate this species of mosquito so that it does not become established in our community.'

The District utilizes a science-based, data-driven approach to mosquito control. This Integrated Vector Management approach will include immature surveillance and control that includes door to door inspections, as well as adult surveillance and control, which will include ultra-low volume spraying, barrier treatments and a variety of live mosquito trapping. "The District is enhancing and expanding the District's comprehensive surveillance system to track this mosquito" said Amanda Bradford, the District's Entomologist.

The Aedes aegypti mosquito was detected earlier this year in Butte County. For the Chico and Oroville detections, this

is the 2nd consecutive year in a row this species has been discovered. This is the first time this mosquito has been found in Thermalito and now Gridley. Aedes aegypti have the potential to transmit viruses such as chikungunya, dengue, yellow fever, and Zika, that are not known to be transmitted by Butte County's native

The public plays a critical role in helping to control the spread of this mosquito population. "Aedes aegypti love to breed in small water-holding containers and prefer being in and around our homes. A breeding ground for this mosquito can

be as small as a water bottle cap. Eliminating all standing water regardless of size is essential to effective control," says Matt Ball.

Prevent Aedes aegypti development in your yard: (1) Inspect your yard for standing water sources and drain water that may have collected under potted plants, in bird baths, discarded tires, and any other items that could collect water; (2) Check your rain gutters and lawn drains to make sure they aren't holding water and debris; (3) Check and clean any new containers that you bring home that may contain water. Aedes aegypti eggs can remain viable under dry conditions for months.

As with all mosquito issues, native and non-native, the Butte County Mosquito and Vector Control District staff urges residents to take precautions to avoid mosquito bites by implementing the 7 Ds of

(1) Drain any standing water that may produce mosquitoes, this includes flowerpots, old tires, and buckets. Some species of mosquitoes can lay their eggs in very small sources of water, like a bottle cap; (2) Defend yourself and your home by using an effective insect repellent and making sure screens on doors and windows are in good condition; (3, 4) Dusk or Dawn, avoid outside activities; (5) Dress in long sleeves and pants when mosquitoes are active; (6) Door and window screens should be in good working condition and free of holes and tears. This will prevent mosquitoes from entering your home; (7) District personnel are available to address any mosquito problem you may be experiencing, to report water that may be breeding mosquitoes, and to answer any questions you may have.

Sheriff's and DA's Office **Investigating in Custody Death**

BCSO Press Release

OROVILLE, CA (MPG) - On August 12, 2021, around 1:00 a.m., Erin Conway, age 43, of Chico was arrested by Butte County Sheriff's Office (BCSO) deputies for trespassing at a local convenience store located in Oroville. Conway was subsequently booked at the Butte County Jail.

During the booking process, an evaluation was conducted by BCSO Jail medical staff which determined Conway was under the influence of drugs. Based on the aforementioned, Conway was housed in a sobering cell located within the Butte County Jail booking area. While housed in the sobering cell, deputies and jail medical staff conducted frequent checks

Around 5:00 p.m., a deputy and jail nurse were conducting a routine health and safety check on Conway. While conducting the check, the deputy and nurse determined Conway was not breathing and appeared to be having a medical issue. Deputies and jail medical staff immediately began providing Conway with emergency medical treatment. Paramedics responded and provided additional emergency medical treatment. Despite the life-saving measures that were administered, jail medical staff and paramedics were not able to revive Conway.

Butte County District Attorney's Office Investigators and Butte County Sheriff's Office Detectives responded to the jail and began investigating the circumstances surrounding Conway's death. During the investigation, personnel interviewed deputies, medical staff, and inmates housed in cells adjacent to the cell occupied by Conway. To date, detectives and investigators have not located any evidence to suggest Conway committed suicide or was involved in any type of criminal violence prior to being found unresponsive. Additionally, there were no

use of force incidents involving Conway and BCSO staff.

Investigators and detectives determined Conway was housed in a cell by herself for several hours prior to her death, and at the time of her death. Investigators and detectives determined other inmates did not have access to the cell housing Conway. Investigators and detectives did not locate any evidence Conway summoned help or activated the emergency alert button the safety cell was equipped with. Investigators and detectives did not locate any signs of trauma or injuries on Conway's person. An autopsy will be conducted by the Sacramento County Coroner's Office in an attempt to determine Conway's cause

During the investigation, investigators and detectives reviewed the circumstances surrounding Conway's arrest. Investigators and detectives located surveillance video from the local convenience store where Conway was arrested. The video depicted Conway entering a patron's vehicle and rummaging through the vehicle's contents. The video also depicted Conway entering and exiting the convenience store multiple times prior to Conway's arrest.

Staff at the convenience store eventually called BCSO for assistance. BCSO deputies arrived at the store, used de-escalation tactics, and were able to convince Conway to leave the store. Several minutes later Conway returned to the store. When Conway returned to the store, store employees completed a private person arrest form and told BCSO deputies they wanted Conway placed under arrest for trespassing. Conway was subsequently placed under arrest without incident and transported to the Butte County Jail.

Butte County District Attorney's Office Investigators and Sheriff's Office Detectives are actively investigating this incident.

truly negotiate in good faith." Allegedly, no board members have been allowed at the negotiation table.

Hudson was followed by negotiation team member, Colleen Haymond, who stated, "The current Gridley Unified checks and balances system seems to have a problem: The school board has not been given accurate information regarding the negotiation meetings. The transportation department has not been given accurate information regarding the mediation process. The classified staff negotiating team has not been given accurate information regarding the district's finances or the feasibility of our proposed pay increase."

CSEA Vice President and member of the negotiating team, Angelina Hopoate, read the GUSD mission statement aloud and said, "GUSD cannot put its students first if they put their classified employees last." Numerous staff members and parents addressed the board, including students from Gridley High School, Ella Hughes, Audrey Johnson and Kirsten Muzzy, who spoke out in support of classified staffers and the important roles they had played in each girl's lives. A frustrated veteran with GUSD, Melinda Carr, from Wilson School read aloud a letter to the board, "With a heavy heart.... I'm handing in my letter of resignation after 20 years, because I do not feel valued, or appreciated in this district."

The board heard the comments and concerns, adjourning to closed session at 7:30 to review items from the meeting's agenda. They allegedly did not adjourn from closed session until nearly 10:00 that evening with no notable reportable action.

Construction Starts on Major Butte County Highway Project

- In a major milestone, Caltrans is beginning consafety and passing lanes projsouthern Butte County.

Starting today, crews plan to begin placing temporary concrete barriers, or K-rail, along a four-mile stretch of roadway from East Gridley Road to the Honcut Creek bridge.

Governments (BCAG) are partnering on this \$50 million Amarjeet S. project to create continuous passing lanes with a two-way left-turn lane and build a new bridge over Honcut Creek. Other improvements include widening the shoulders to 8 feet, upgrading drainage systems and establishing an area for vehicles veering off the roadway to return to the main highway.

The work represents the





