## Dixie Fire, **One of Largest** in State History

NORTH STATE COUNTIES, CA (MPG) - The Dixie Fire is now the 14th largest wildfire in California history, according to CALFIRE.

According to the **CALFIRE** Incident Report dated July 28th, as of 7:00 am the Dixie Fire is 217, 581 acres and at 23 percent containment. At this point, 35 structures have been destroyed along with 19 other minor structures, with damage to 7.

The Fly Fire that popped up to the east has merged with the Dixie Fire and CALFIRE is currently using the Hwy 70 corridor to divide the whole of the burn into the Dixie Fire West Zone and the Dixie Fire East Zone.

CALFIRE reports that activity in the west zone was minimal overnight and that the fire is burning in a remote area with heavy terrain making access difficult. Dozer lines are being used to protect the community of Jonesville and Butte Meadows and control the progress of the fire.

CALFIRE reports no change from the Humboldt Summit over to Lake Almanor, parallel to Hwy 89 to Canyon Dam - the fire line is holding. A crew of 5,000 firefighters are constantly patrolling the perimeters to identify any breakout areas. Work is being done to protect historical landmarks like the Swiss Cabin and Caribou Powerhouse in the Caribou drainage area.

Moving further east, crews are using dozers, tactical firing operations and pretreating areas around the dozer lines with ground application fire retardant, using water tenders when aerial deployment is not optimal to decrease the risk of embers lighting and fire spread.

The CALFIRE incident report says, "Fire behaviorists predict robust fire activity day and night this week, based on expected weather and fuel conditions."

There are currently 420 engines, 90 water tenders, 34 helicopters, 90 handcrews, 192 dozers, 1,157 additional personnel and numerous air tankers from throughout the state working to control the blaze. An estimated date for containment is still unknown.



## **Building Demolished as Part of Sycamore School Field Renovation**

GRIDLEY, CA (MPG) - A long-standing part of the Sycamore Middle School campus has come down.

The large building on the Magnolia Street side of Sycamore School's campus, which functioned as the music room and Ag/ shop facilities for Gridley's High School that was once located on the site, was torn down last week. It has been used for storage for many years until its failing roof made it unfeasible to keep anything of significance in it. As the building continued to age, it was boarded up to keep students and other curious minds out of the structure.

Superintendent Jordan Reeves says, "It was time. It (the building) was abandoned...no roof, safety issues, an eye-sore ... " and construction personnel on site added that the materials the building was made of aren't produced anymore,

like square re-barb. It is believed to have been nearly 100 years old.

As the remains of the dilapidated building are removed, crews will prepare the area in its former footprint to be incorporated into the main field area of the campus. "So basically, what we are doing is a complete renovation of the field here," says Reeves. We will "put new irrigation in, new piping, and once the contractors are done, we will

put a sprinkler system as well. Then we're going to hydroseed it." The field is plagued by holes created by gophers, which poses a problem to athletes and students using the fields for *Continued on page 3*

## PG&E Initiates New Electric Infrastructure to Protect from Wildfire Threat

#### PG&E Press Release

**CHICO, CA (MPG)** - Pacific Gas and Electric Company (PG&E) announced a major new initiative to expand the undergrounding of electric distribution power lines in High Fire Threat Districts (HFTD) to further harden its system and help prevent wildfires. The new infrastructure safety initiative, announced today in Butte County by PG&E Corporation CEO Patti Poppe, is a multi-year effort to underground approximately 10,000 miles of power lines.

PG&E's commitment represents the largest effort in the U.S. to underground power lines as a wildfire risk reduction measure.

"We want what all of our customers want: a safe and resilient energy system. We have taken a stand that catastrophic wildfires shall stop. We will partner with the best and the brightest to bring that stand to life. We will demand excellence of ourselves. We will gladly partner with policymakers and state and local leaders to map a path we can all believe in," Poppe said.

In addition to significantly reducing wildfire risk, undergrounding also benefits customers by lessening the need for Public Safety Power Shutoffs, which are called as a last resort during dry, windy conditions to reduce the risk of vegetation contacting live power lines and sparking a wildfire. Undergrounding also eases the need for vegetation management efforts, leaving more of California's trees untouched.

PG&E maintains more than 25,000 miles of overhead distribution power lines in the highest fire-threat areas (Tier 2, Tier 3 and Zone 1) – which is more than 30% of its total distribution overhead system.

10,000 miles of PG&E lines represents approximately the distance of 11 round trips from Chico to Los Angeles or almost half way around the world. The exact number of projects or miles undergrounded each year through PG&E's new expanded undergrounding program will evolve as PG&E performs further project scoping and inspections, estimating and engineering review.

PG&E will engage customers and stakeholders as it develops a plan and reviews potential additional undergrounding sites based on a variety of factors, including local municipal planning and safety considerations. Engineering an underground electric system requires designing the system around existing water, natural gas and drainage systems, as well as planning for future road widening. PG&E intends to work closely with customers and local, state, federal, tribal and regulatory officials throughout this new safety initiative.

In the past, undergrounding has been done on a select, case-by-case basis, and largely for reasons other than wildfire risk reduction. Thanks to breakthroughs PG&E has achieved on undergrounding projects in recent years, undergrounding can now play a much more prominent role in PG&E's ongoing efforts to harden the electric grid. Following the devastating October 2017 Northern California wildfires and the 2018 Camp Fire, PG&E began to evaluate placing overhead power lines underground as a wildfire safety measure, and to better understand the construction and cost requirements associated with undergrounding for system hardening purposes. These demonstration projects were part of PG&E's Community Wildfire Safety Program (CWSP) and included the following: From 2018-2020, PG&E completed multiple demonstration projects aimed at converting overhead power lines to underground in high fire-threat areas of Alameda, Contra Costa, Nevada, and Sonoma counties; As a part of the rebuild efforts following the October 2017 Northern California wildfires, PG&E completed undergrounding eight miles of power lines in the Larkfield Estates and Mark West Estates communities in Sonoma County in 2018;

In 2019, PG&E announced it would rebuild all its power lines underground in the Town of Paradise as it helps the community recover from the Camp Fire. The company is also rebuilding power lines underground within the 2020 North Complex Fire footprint in Butte County.

Through these demonstration projects and rebuild efforts, PG&E has been able to refine the construction and cost requirements associated with targeted undergrounding, enabling the acceleration and expansion of undergrounding projects. Learnings include:

Implementing new planning systems and strategies and using new materials and new equipment to make undergrounding more cost effective;

Building strong partnerships with material suppliers and contractors to accelerate undergrounding efforts;

Partnering with natural gas projects as well as phone and internet providers to joint trench and share costs, where possible;

Using new technology and construction methods to increase trench production;

Bundling work into larger blocks to take advantage of economies of scale;

Testing new cable and conduit materials to accelerate undergrounding work processes.

Installing stronger poles and covered power lines; Deploying remote grids and community microgrids; Targeted sectionalizing and grid reconfiguration; Investing in centralized data analytics to reduce risk; Conducting enhanced vegetation management; Scaling the deployment of emerging technologies to proactively mitigate wildfire risk

## **GUSD** Superintendent Declares Impasse Farewell to Wildfire Distribution Center

On May 6, 2021, California School Employees Association (CSEA) negotiations team held their first negotiation meeting for the 2021-22 Gridley Unified School District (GUSD) School Year with Jordan Reeves, GUSD Superintendent, Heather Naylor, GUSD Chief Business Officer, and Julie Vang, GUSD Personnel Manager.

CSEA classified members consist of school secretaries, office clerks, clerical aides, custodians, cafeteria workers, yard duty supervisors, campus supervisors, instructional aides, translators, media clerks, librarians, health office aides, maintenance/grounds workers, and IT technicians.

The negotiating team is asking for the classified staff salary schedule to be updated to meet the current minimum wage, as the schedule currently starts at \$12.33, and employee pay has not been increased incrementally as minimum wage has increased. With the higher minimum wage, a newly hired employee would earn as much as an employee who has worked for the district for four years. The increase between pay steps is less than a dollar for five years of service, and only increases every five years after the first four years of employment. Because employee pay has not been increased, Mr. Reeves and Mrs. Naylor have repeatedly told the CSEA negotiating team that the increase we are requesting is too much for the district to afford, and that employees would have to be laid off if the requested raises were approved, which is not true.

GUSD received over eight million dollars in COVID relief money to combat the pandemic and the recession, and to help reopen schools. Each group of employees from the district has received a one time off schedule payment from this fund as part of negotiations. Based on percentages of salary, the superintendent received \$8000, the teachers received \$3000, and CSEA asked that our percentage be based on our

group's top paid full time employee, as many of our employees are not full time. That amount would be based on full time employment. Mr. Reeves and Mrs. Naylor instead offered an amount based on the average paid Classified employee, significantly lowering the proposed amount.

After negotiating nine times, and having several CSEA proposals rejected without offering to seek authorization for the increase from the GUSD board, Mr. Reeves declared impasse, with the added insult of showing a printed definition of the word to the negotiating team. At that point, Mr. Reeves and Mrs. Navlor were asked if they really wanted to go to impasse over a three percent pay difference, and Mrs. Naylor stated that the district was prepared. She further stated that when the Yuba City teachers association went on strike several years ago, it did not improve the outcome of their negotiations, insinuating that the district is not willing to budge on our increase.

GUSD Classified members recently attended a board meeting to show Mr. Reeves that we are a cohesive unit, and that we do not intend to accept their offer or their excuses for an unfair wage. CSEA members have been quietly trying to persuade Mr. Reeves and Mrs. Naylor that what we are requesting is fair, but now feel that the board members and community need to be informed of our insulting treatment.

We are Essential. We were on campus throughout the COVID lockdown. We remain the main points of contact. We are the first ones on campus and the last to leave. We are the school's core personnel, and should not be treated any differently than other district employees.

## **Joint Investigation Results** in Murder Arrest

#### **BCSO** Press Release

**OROVILLE, CA (MPG)** - On December 25, 2017, Butte County Sheriff's Office (BCSO) deputies and detectives responded to a shooting in the 2900 block of Clark Road, Oroville. Upon arrival, deputies located a deceased male who was identified as Salvador Fuentes, age 27, of Oroville. During the subsequent investigation, it was determined Fuentes died as a result of a gunshot wound. Detectives located evidence that gave them cause to believe Fuentes was murdered.

During the investigation, detectives identified Johnny Cabrera, age 34, of Chico as a suspect. Detectives located evidence that gave them cause to believe Cabrera was associated with a local criminal street gang and the murder was gang-related.

In 2018, the Chico Police Department (CPD) Violence Suppression Unit and the FBI Chico Office began assisting BCSO detectives with the murder investigation. BCSO and CPD detectives spent the past three years investigating the murder. In April of 2021, Butte County District Attorney's Office Investigators began assisting with the investigation.

Over the past four months, detectives conducted additional interviews and served search warrants at two locations in Chico. Detectives located additional evidence that gave them cause to believe that Cabrera murdered Fuentes.

In May of 2021, detectives worked with the Butte County District Attorney's Office and obtained an arrest warrant for Cabrera for an open count of murder. Cabrera is currently incarcerated at the California Department of Corrections Corcoran State Prison for an unrelated criminal conviction. On July 16, 2021, detectives interviewed Cabrera at Corcoran State Prison. Detectives and the Butte County District Attorney's Office are working on having Cabrera transported to the Butte County Jail. ## **Could Crime Surge Push Newsom Recall?**

Those who want voters to recall Gov. Gavin Newsom joined crime victim advocates at the state Capitol last Tuesday to accuse the governor of being too lenient on lawbreakers as the state experiences a new wave of crime.

They castigated him for unilaterally suspending executions of murderers and making it easier for felons to win release from state prisons.

'The thing that really alarms me about what the governor did, is that it's a continuation of policies to undermine the criminal justice system, and to put dangerous people back out onto the streets," said Marc Klaas, whose daughter, Polly, was murdered 25 years ago by a recently released felon. The killer, Richard Allen Davis, is one of 737 murderers benefiting from Newsom's death penalty suspension.

A few hours later, Newsom's office announced that he would hold a press conference in Los Angeles Wednesday "on state action to address crime and reduce retail theft in communities more violent crime, seemacross California."

Newsom devoted much of the event to signing

extends an effort to crack down on organized shoplifting that has plagued California retailers in recent months. But he attributed the sharp increase in violent crime, particularly murders, to "a proliferation of guns on our streets" and noted that "There is not a state that's been spared."

The back-to-back events imply that crime may be a new front in the recall campaign and that Newsom feels the need to defend himself.

"In 2020, California saw a troubling rise of more than 500 homicides, the largest jump in state history since record-keeping began in 1960," the Public Policy Institute of California says in a recent report. "Victims were predominantly Black and Latino, male, and killed by guns on our streets, parking lots, or in vehicles."

Newsom's comments about "a proliferation of guns on our streets" echoes declarations by gun control advocates that California's surge of homicides results from a big jump in gun ownership. Californians legally bought a record 686,435 handguns in 2020 a nearly 66% increase from the year before – and sales of rifles and shotguns also shot upward.

However, Newsom and other gun control advocates offer no proof of the connection. In fact, a new study by University of California-Davis researchers found no evidence that increases in legal gun sales resulted in ingly refuting Newsom's assertion.

Assembly Bill 331, which purchasing and firearm violence increased substantially during the first months of the coronavirus pandemic," the study by UCD's Violence Prevention Research Program, concluded. "At the state level, the magnitude of the increase in purchasing was not associated with the magnitude of the increase in firearm violence."

> "Results suggest much of the rise in firearm violence during our study period was attributable to other factors, indicating a need for additional research," the researchers added.

A more likely scenario is that Californians are buying more guns because their fears of becoming violent crime victims have increased. In recent weeks, the residents of three Northern California homes, one in Solano County and two in Stanislaus County, have shot and killed violent home invaders.

The surge in crime, both violent assaults and thefts, is real. The videos of brazen daylight raids on pharmacies and other stores, particularly in San Francisco, by thieves unafraid of either arrest or prosecution, have become cable television and YouTube staples.

While rising crime might not sink Newsom in the recall election a few weeks hence, if it continues to rise, he could feel the backlash when he runs for re-election in 2022.

#### Farmers Markets Slowly Rebound in **Uncertain Comeback**

California's farmers markets are facing challenges, even as produce shoppers are returning after easing of pandemic restrictions. Foot traffic remains light at many urban markets as the flow of office workers remains down due to employees still working from home. Some markets remain closed and others - like the Ferry Plaza Farmers Market in San Francisco are climbing back toward near-normal traffic levels.

#### Drought, Winds Yield Smaller Avocados

Avocados from California are smaller this year and the seasonal harvest is expected to be down by as much as 30 percent in total pounds. According to the California Avocado Commission, that's the result of low rainfall totals over the last few years. Another factor is Santa Ana winds that struck avocado-growing regions in January. This year, growers are more likely to fill cartons with 60 smaller avocados rather than 48 larger ones.

#### November Temperature Swings Damage Walnut Groves

Wild temperature swings last fall are believed to be the cause of widespread freeze damage in California's walnut groves. In early November, temperatures dropped from 80 degrees to below freezing in several areas. Freeze damage, observed this spring, is most severe in Butte, Glenn and Tehama counties and is also reported in Lake, San Joaquin, Stanislaus, Yolo and Yuba counties. Before the freeze, walnut production had been steadily increasing.

#### Agriculture Coalition Seeks Federal Water System Upgrades

A coalition of western farmers, ranchers, water providers and farm communities is urging the U.S. Senate to pass legislation to upgrade aging water infrastructure. The California Farm Bureau joined with more than 200 organizations in seeking more than \$14 billion in water storage and conveyance projects and related construction as part of President Biden's jobs and economic recovery plan.

## Dear Dietitian

## Insulin

#### Dear Readers,

Chances are you know someone who has diabetes. According to the Centers for Disease Control, nearly 30 million Americans have the disease. With type 1 diabetes, the pancreas no longer secretes insulin, so the patient must take insulin shots. In type 2 diabetes, the pancreas secretes insulin, but not enough to keep blood sugars under control, or the body cannot use it efficiently. People with type 2 diabetes sometimes take insulin in addition to oral medication.

As with any chronic illness, there are costs associated with management, and many people who have diabetes must take insulin to maintain a healthy lifestyle. Rapid-acting insulins, such as insulin aspart, are commonly prescribed, and their cost has nearly tripled in the last decade.

Due to the rising cost of insulin, some people with diabetes are rationing their insulin, which is dangerous. If a person knew his heart would stop beating if he didn't take his medication as prescribed, he would certainly understand the seriousness of his condition. However, with diabetes, the damage to the body from high blood sugars is not readily apparent. Related complications include kidney disease, blindness, loss of limbs, and nerve damage. Even more disastrous, if someone has type I diabetes and does not take the right amount of insulin, elevated blood sugars may lead to diabetic ketoacidosis (DKA).

DKA occurs when there is not enough insulin in the body. The body, in turn, will burn fat for energy, but this process is inefficient, causing a buildup of ketones. Ketones cause the blood pH to be acidic, a condition in which the body cannot survive. If left untreated, DKA may lead to coma and death.

There is a solution. Other types of insulin, like human regular or NPH, are much less expensive but still effective in controlling blood sugar levels. When using regular or NPH, it is important to be consistent in your carbohydrate intake and to eat at regular mealtimes. You may also need planned snacks to avoid low blood sugars.

There are less expensive ways to obtain medical treatment for diabetes. According to the American Diabetes Association, there are local community health clinics and pharmacies in your area. These clinics are generally free to patients or require a small fee. Go to https://findahealthcenter.hrsa.gov/ or http://www.nafcclinics.org/find-clinic to find a clinic in your area. These clinics often have a Registered Dietitian Nutritionist on staff to help you with meal planning.

There is also help available to pay for insulin. Most pharmaceutical companies offer financial assistance programs if you can't afford your medication. There are programs to assist those who do not have insurance to obtain their medications at little or no cost. One such program is Medical Assistance Tool (medicineassistancetool.org). The American Diabetes Association also offers information on medication assistance. Visit diabetes.org or call them at 1-800-342-2383.





## School Safety Tips

In 2007-2011, U.S. fire departments responded to an estimated average of 5.690 structure fires in educational properties, annually. These fires caused an annual average of 85 civilian fire injuries and \$92 million in direct property damage.

- · Fire drills must be held at least once a month while school is in session. (Schools located in climates where weather is severe have the option of deferring monthly drills).
- · Principals, teachers or other school staff must inspect all exits daily to ensure that stairways, doors and other exits are working properly and are unblocked.
- · On the day of the drill, the emergency drill alarm should be sounded on the school fire alarm system. Make sure that everyone can recognize the sound of the alarm and knows what to do when it sounds.
- · Teachers, officials and staff should be familiar with the school's fire protection system, including the location of fire alarm pull stations and sprinklers.
- Every room in the school should have a map posted identifying two ways out. In schools with open floor plans, exit paths should be obvious and kept free of obstruction.
- · On the day of the fire drill, everyone in the school should participate.
- · Students with specific needs should be assigned an adult or a student buddy to assist them. Fire drills are a good opportunity to identify who among the student population requires extra assistance.
- While it's important to make sure that students leave the building as quickly as possible, order is more important than speed when it comes to conducting a safe fire drill.
- Once everyone has safely exited the building, they should remain outside at a predetermined location until the 'all clear' has been given to reenter the school.
- Use rosters to ensure that every student is accounted for.
- Fire drills should be held both at expected and at unexpected times, and under varying conditions in order to simulate the conditions that can occur in an actual emergency.
- School fire drills are a model for students to use in their homes. Encourage students to practice their escape plans at home - just as they do at school.

#### **Butte County Mosquito** and Vector Control District

BUTTE COUNTY, CA (MPG) - For the second year in a row, the Butte County Mosquito and Vector Control District (District) detected an invasive (non-native) species of mosquito on Tuesday, July 6, 2021. The Aedes aegypti, commonly known as the yellow fever mosquito, was found in northwest Chico-in the area of Eaton Road and Esplanade. The California Department of Public Health confirmed the invasive species detection.

"The District is working to evaluate the extent of the infestation and we plan to do everything we can to eradicate this mosquito and to protect our residents from the potential disease risk of these invasive mosquitoes," said Matt Ball, District Manager. "Our goal is to control and eliminate this species of mosquito so that it does not become established in our community."

The District utilizes a science-based, data-driven approach to mosquito control. This Integrated Vector Management approach will include immature surveillance and control, that include door to door inspections, as well as adult surveillance and control, which will include ultra-low volume spraying, barrier treatments and a variety of live mosquito trapping.

The District's first ever detection of Aedes aegypti was last September in Chico and in October in Oroville. To date, Aedes aegypti have not been rediscovered in the areas where detections were made last year.

Aedes aegypti have the potential to transmit viruses such as chikungunya, dengue, yellow fever, and Zika, that are not known to be transmitted by Butte County's native mosquitoes, and to date, have not been detected in Aedes aegypti in California.

The public plays a critical role in helping to control the spread of this mosquito population. "Aedes aegypti love to breed in small water-holding containers and prefer being in and around our homes. A breeding ground for this mosquito can be as small as a water bottle cap. Eliminating all standing water regardless of size is essential to effective control,"

Prevent Aedes aegypti development in your yard:

Inspect your yard for standing water sources and drain water that may have collected under potted plants, in bird baths, discarded tires, and any other items that could collect water;

Check your rain gutters and lawn drains to make sure they aren't holding water and debris;

Check and clean any new containers that you bring home that may have contained water. Aedes aegypti eggs can remain viable under dry conditions for months.

As with all mosquito issues, native and non-native, the Butte County Mosquito and Vector Control District staff urges residents to take precautions to avoid mosquito bites by implementing the 7 Ds of protection:

Drain any standing water that may produce mosquitoes, this includes flowerpots, old tires, and buckets. Some species of mosquitoes can lay their eggs in very small sources of water, like a bottle cap;

Defend yourself and your home by using an effective insect repellent and making sure screens on doors and windows are in good condition;

Dusk or Dawn, avoid outside activities:

Door and window screens should be in good working condition and free of holes and tears. This prevents mosquitoes from entering your home;

Dress in long sleeves and pants when mosquitoes are active.

District personnel are available to address and mosquito problem you may be experiencing, to report water that may be breeding mosquitoes, and to answer any questions you may have.




