The location has remained dark and somewhat austere, curtains studded with black bears and Lysol cans left forgotten in place, collecting dust for over a year after covid forcibly closed its doors forever.

But you know the saying - when one door closes, another opens, and in this instance, Huckleberry's Restaurant is walking right

Huckleberry's Restaurant describes itself as "southern cookin' with a California twist" and features a breakfast and lunch menu. The nearest Huckleberry's is located in Yuba City on W. Son Admits Killing Mother with Dumbbell

Butte County Superior Court

BUTTE COUNTY, CA (MPG)

- A Chico man, charged with killing his mother with a dumbbell last year, appeared in Butte County Superior Court where he entered a plea of no contest to first degree murder.

Aaron Neil Patrick Connors, 46, of Chico was in court to set a date for a jury trial when he changed his not guilty plea to one of no contest.

District Attorney Mike Ramsey said the case began on March 5, 2020, when Connors went to visit his 68-year-old estranged mother, Susan Robb, at her home in north Chico during the early morning hours. Connors' mother invited him inside and the two visited with each other for a few hours. When Connors went to leave his mother's home, he went outside to his van, grabbed a 10-pound dumbbell, and went back inside his mother's home. The unsuspecting Robb was sitting on the couch with her back to her son when he approached her from behind and hit her on the head with the dumbbell. Connors proceeded to strike his mother multiple times on the head using the dumbbell causing her death. Ramsey noted this is the sixth matricide case in Butte County in the last 12 years.

Robb's roommate returned home from work that afternoon and found her body. The roommate called 911.

After the murder, Connors made his way to Gold Country Casino in Oroville where he was later arrested by Butte County Sheriff's deputies. Connors was interviewed at the Butte County Sheriff's Office where he provided a full confession. Connors told detectives he had been thinking about killing his mother for years but began thinking about it more seriously in the days leading up to the crime. Ramsey said Connors has no known mental health

The judge scheduled Connors' sentencing for August 4, 2021. Ramsey said Connors is facing a statutory term of 25 years to life in prison. However, due to recent changes in how the state department of corrections calculates credits given to prisoners, Connors could have a parole hearing in as soon as 16 years. Ramsey said he and 40 other elected district attorneys around the state are suing the department of corrections for giving too much time off to violent criminals.

Connors remains in custody at the Butte County Jail pending sentencing. ★

Dear Gridley community,

I am writing this letter to you on behalf of the Gridley community that tends to get forgot about. I am one of the individuals that live outside the city limits, but we are still as much part of the City as the rest of the community. I'm coming forward to advocate for the public safety of my neighbors that encircle the small town of Gridley. In these areas, many parents whom have small children, and elderly family members, have noticed the extreme speed violations that occur on our streets. As you drive on the outside, rural streets of Gridley, we can almost all agree, these two-lane roads become a lot smaller in width and in turn require more people to share the roadway. Many motorists take advantage of the "Back Roads" to speed at extremely high rates causing detrimental safety issues for themselves and the people of Gridley who call these roads our home. Data Undercut Newsom's 'Roaring Back' Claim

Virtually any utterance from Gavin Newsom's mouth these days, as well as those from his press office and other outposts of his administration, contains the phrase "roaring back."

Legislature passed a state budget to meet the June 15 constitutional deadline, Newsom issued a statement declaring that "California's economy is coming roaring back."

Not surprisingly, it's also the key slogan in his resistance to a campaign to recall him, something voters will decide later this year.

has California roaring declares. "Newsom is delivering money to your pocket. Plus an extra \$500 bucks for families with kids – \$4 billion straight to small businesses through the nation's largest grant program cleaning up our streets and getting 65,000 homeless Californians into housing and free pre-K for every of income."

To some, it might appear somewhat unseemly that Newsom so obviously merges his official actions – and taxpayers' money – with Mexico.

his political campaign, but the once-discernible line between politics and policy vanished long ago.

That said, do the facts support Newsom's repetitive "roaring back" claim?

To be sure, some Californians have prospered in the 15 months since Newsom declared a public health emergency due to COVID-19 and imposed restrictions on personal and economic activities.

Those who could continue to work at home maintained their incomes and those on the top rungs of the economic ladder were enriched When, for example, the as the values of their investments such as stocks expanded, thanks largely to the Federal Reserve's cheap money policies.

However, broader eco-"Gov. Gavin Newsom nomic data offer scant support for the "roaring back," the announcer in back" mantra the governor one of his campaign spots is chanting these days. It's more like creeping back slowly.

The state's monthly report on employment, issued on June 18, frames the glacial pace of improvement. The state lost nearly 3 million jobs after Newsom ordered widespread business closures in March 2020, and since then we've recovered California child, regardless roughly half of them. Our 7.9% unemployment rate is still twice what it was before the shutdown and is the third highest of any state, slightly under Hawaii and New

In addition to the official unemployment rate, the federal Bureau of Labor Statistics makes other calculations, including an important one on underemployment, called U-6, which includes not only workers without jobs but those who are only marginally attached to the labor force and those working part-time.

California's U-6 rate through the first quarter, 18.4%, was four percentage points above the national figure and the third highest of any state, behind Hawaii and Nevada. Even more disturbingly, the U-6 rate in Los Angeles County, 24.1%, is higher than that of any state.

The federal Bureau of Economic Analysis reported this month that during the first quarter of this year, California's economic output increased by 6.3%, slightly lower than the national rate and in the lowest third of the states.

The federal bureau also reported that California's personal income grew by 42.8% during the first quarter, which sounds impressive until one looks at the nation as a whole and learns that California's growth was the second lowest of any state. The bureau notes that nationwide, "transfer payments" - mostly federal aid programs rather than earned income - accounted for virtually all of personal income growth.

California's economy is recovering, to be sure. But "roaring back?" Hardly.

Forest Ranch and Butte County Fire Safe **Councils Receive Grants from PG&E**

CHICO, CA (MPG) - This wildfire season, mobilizing Californians to protect their homes, businesses, communities, and the environment from wildfire is more important than ever. The work of local California Fire Safe Councils (FSCs) is critical to strengthening the safety and preparedness of local communities during the 2021 wildfire season.

Pacific Gas and Electric Company (PG&E) continues its strong support of local FSCs and non-profit organizations that are focused on reducing the threat of wildfires in its communities, with \$2 million in grants for projects scheduled in 2021. Of that, \$100,000 of that will go to the Forest Ranch Fire Safe Council and \$50,000 to the Butte County Fire Safe Council.

"With our Community Wildfire Safety Program, we focus on reducing wildfire risk by meeting and exceeding state vegetation safety standards, continuing to harden our electric grid with stronger power lines and poles and by integrating new tools and technologies. But we can't do it all alone. We need to work together and enable each other to prepare for this wildfire season, which is why the work of the local Fire Safe Councils is so essential," said Peter Kenny, PG&E Interim Vice President of Vegetation Management.

Since 2014, PG&E has provided \$17 million in grant funding to support local FSCs in their efforts to improve fire safety in communities. Typical FSC projects include reducing fuel, creating fuel breaks, and improving fire evacuation routes and emergency access roads.

The Forest Ranch FSC will use the funds to expand evacuation safety along primary roads by thinning brush and small trees near the roadside along Garland and

Doe Mill roads, so that wildfire would not threaten vehicles evacuating or fire equipment coming into the community.





The proposal was similar to Assembly Bill Paradise and the area devastated by the 297 (Gallagher) which Assembly Democrats prevented from even getting a committee hearing earlier this year.







What Happens to the Home and Economy when Women Leave the Workforce?

Commentary by Andi Simon

The pandemic-induced recession forced many women to drop out of the workforce, with research showing they were much more likely than men to give up jobs so they could take care of children when schools went online.

The consequences of these decisions may go beyond each individual, though.

"They could have large repercussions for the economy, the home, and society as a whole, says Andi Simon (www.andisimon.com), a corporate anthropologist, founder of Simon Associates Management Consultants, and author of the upcoming book Rethink: Smashing the Myths of Women in Business.

Some ramifications of this 2020 exodus from the workforce for women could include:

A drop in consumer **spending.** When one spouse loses a job, whatever the reason might be, it means an immediate and sudden drop in income for that household. "The impact on household earnings will lead to reduced spending," Simon says. "That will have ripple effects throughout the economy."

An impact on women's careers and advancement. Eventually, many of these women will no doubt go back to work, but how

just pick up their careers where they left off could be another matter, Simon says. "Will they have lost ground in the line for promotions to men who didn't take any time away from work?" she asks. "Also, depending on how slow the recovery is, rejoining the workforce might not be that quick and easy."

A reduction in demand for familyrelated industries. When both spouses work outside the home, couples often need to make use of services that developed or grew because one adult

Dear Dave,

I'm on Baby Step 2. I've paid off almost all my debt, and I'm living on a monthly budget. Recently, I got a call from a debt collection company about an old medical bill. They threatened to garnish my wages, and from the way they talked I'm afraid they may actually do it. How should I handle this situation?

First of all, they won't garnish your wages. They can't. For that to happen, they would have to go through all the formal, legal steps of suing you, and then they'd have to win the case. Debt collectors like to play with people's emotions

Let her know, too, that she's will give in and do whatever they want – whether they can afford it or not.

> The worst thing you can do in these situations is react with panic or fear. Talk to them calmly and rationally, and explain your financial situation. You may be able to reach a compromise that works for both of you. If they get nasty, or continue to lie to you, let them know you'll file a complaint with the FTC (Federal Trade Commission). Pushy debt collectors have a habit of getting polite and reasonable in a hurry when faced with the possibility of the federal

government stepping in. Do everything you reasonably can to pay your debts, Gwen. You owe the money, and that means you have a legal and moral obligation to pay them. But you don't have to put up with a collector's lies and harassment!

Ewanless was transported to the Butte County Jail where he is being held in lieu of \$50,000 bail.



Drought Brings New Focus on Water Facilities

Canals that stay dry due to drought may be more prone to cracking, intensifying calls for federal and state investment in water facilities. Water district officials say the drought and resulting water shortages have further exposed weaknesses in water systems. A national coalition has urged U.S. Senate leaders to boost funding for water facilities in any infrastructure package, while the state Legislature also considers water investments.

Dry Pastures, Wage Rule Threaten Sheep Ranchers

Pastures have dried out much earlier than usual, leaving California sheep ranchers having to decide how to sustain their operations. Many have thinned flocks by selling lambs early. Ranchers who offer targetedgrazing services to reduce wildfire fuel say demand for their services has surged. But all ranchers say an impending state overtime rule for sheepherders threatens to undermine the entire sheep business.

Analysts Expect Strong Beef Demand This Summer

The economic reopening of the country appears to be contributing to strong demand for beef. An American Farm Bureau economist says restaurants and other food-service establishments have been trying to secure beef supplies in anticipation of pent-up demand. Grocery stores are also competing for beef supplies, because as more people cooked at home during the pandemic, they may have become more comfortable in preparing different cuts of meat.

Almond Sales Establish New Record

Despite disruptions caused by the pandemic, trade disputes and port slowdowns, sales of California almonds have reached record levels. The Almond Board of California reports annual sales establishing new highs with two months remaining in the crop's marketing year. The board attributes the increase to people's interest in plant proteins and the almond's versatility in a range of products and cuisines.



Sheriff's and District Attorney's Offices Investigating in Custody Death

OROVILLE, CA (MPG) - On the evening of July 4, 2021, Butte County Sheriff's Office Correctional Deputies were conducting routine safety checks on inmates housed at the Butte County Jail. Around 6:30 p.m., a correctional deputy discovered Inmate Madison Sall, age 45, of Chico unconscious on the bed within his cell. Upon closer examination, the deputies determined that Sall was not breathing and appeared to be having a medical issue.

Correctional deputies and jail medical staff immediately began providing Sall with emergency medical treatment. Paramedics responded and provided additional emergency medical treatment. Despite the life-saving measures that were administered, jail medical staff and paramedics were not able to revive Sall.

Butte County District Attorney's Office Investigators and Butte County Sheriff's Office Detectives responded to the jail and began conducting an investigation. During the investigation, personnel interviewed correctional deputies, medical staff, and inmates housed in cells adjacent to the cell occupied by Sall. To date, detectives and investigators have not located any evidence to suggest Sall committed suicide or was involved in any type of criminal violence prior to being found unresponsive. Additionally, there were no use of force incidents involving Sall and BCSO staff.

Investigators and detectives determined Sall was housed in a cell by himself and other inmates did not have access to Sall's cell. Investigators and detectives did not locate any signs of trauma or injuries on Sall's person. An autopsy will be conducted by the Sacramento County Coroner's Office to determine Sall's cause of death.

Investigators and detectives determined Sall had been housed at the Butte County Jail for several months. Sall has received extensive medical treatment since being housed at the Butte County Jail. At the time of his death, Sall was housed in the medical unit at the Butte County Jail as a result of health-related conditions. The medical unit is located next to the medical offices in the Butte County Jail which allows inmates to have immediate access to medical staff. Butte County District Attorney's Office Investigators and Sheriff's Office Detectives are actively investigating this incident.




