GRIDLEY, CA (MPG) - Getting one last big one in the books before summer, Biggs 4-H Club set the bar high with their latest service project.

Brian Harrison, Community Club Leader for Biggs 4-H says that "In July, even though COVID was keeping most of the world down, our officers met and planned out a full year of activities, fundraisers and community service. At that time our president, Mason Kaelin had the idea to get involved in an effort called "Crosses Across America". Due to COVID-19 that didn't work out."

Blood in the Water

Recall backers raise more money, but Newsom's side has more cash in the bank

The campaign to eject Gov. Gavin Newsom got off to an early financial head start, raising gobs of money from high-profile Republican luminaries, SoCal millionaires and irate voters, according to new campaign finance reports.

But like the world's most lucratively sponsored tortoise, the anti-recall campaign is planning to take back the lead in the money race – and soon.

So far, political fundraisers have set up six campaign committees to spend on either side of the still-unofficial recall election. The pro-recall side came out ahead, with \$5.45 million raised, state reports show, while the committees spending in Newsom's defense brought in \$4.56 million.

Recall opponents also boasted a higher share of contributions from

small-dollar donors, which political strategists sometimes take as a proxy for regular-folks enthusiasm that translates into votes.

And while Newsom's opponents have burned through most of their cash, the governor's defenders have roughly \$2.5 million socked away.

GRIDLEY, CA (MPG) - The Gridley high school Ag Department and their Ag Fabrication Team recently participated in the Construction Industry Education Foundation (CIEF) Design Build Program, which promotes awareness of the construction industry and careers available in the field to high school students. This year, they brought

back their Design and Build Competition, but things looked a little different. Ag instructor Nick Dreesmann says that typically, the design and build challenge is held at American River College and students from various high schools are provided with the same stack of materials and asked to build the same project. "They set it up like a real construction site, there's a foreman, there's a safety monitor, they go through all proper PPE's, and what to do.... all that stuff." Says Dreesmann. 

Housing Authority of the County of Butte Opens Section 8 Housing Choice Voucher Wait List May 9, 2021 - May 22, 2021

Butte/Glenn County residents will be able to apply for rental assistance in securing safe, decent and affordable housing through the Housing Authority of the County of Butte (HACB) Section 8 Housing Choice Voucher Program. Commonly known as "Section 8", the program provides rental assistance so that tenant-paid rent is limited to between 30 and 40 percent of the household's monthly adjusted income.

Eligibility for the program is based on household income. Households must qualify as "Very Low Income," defined by the U.S. Department of Housing and Urban Development as 50 percent of the Area Median Income. Applicants are screened for criminal background history. The Section 8 Wait List opens from Sunday, May 9 through Saturday, May 22. While all applicants will have an equal opportunity for placement on the Wait List, due to limited funding availability, a one-year pool of applicants will be selected. The one-year pool of applicants will be selected and ordered by means of a random lottery. One application per household will be considered.

Applications will be available online at www.butte-housing.com and can be completed and submitted online starting Sunday, May 9 and no later than Saturday, May 22. For more information, call the HACB Office at 530-717-2121, TDD (800) 735-2929.

Wildland Fire Safety

Every year, wildfires burn across the U.S., and more and more people are living where wildfires are a real risk. But by working together, residents can make their own property - and their neighborhood – much safer from wildfire.

ACTION STEPS FOR AROUND YOUR HOME:

- CLEAR leaves and other vegetative debris from roofs, gutters, porches and decks. This helps prevent embers from igniting your home.
- **REMOVE** dead vegetation and other items from under your deck or porch, and within 10 feet of the house.
- **SCREEN** in areas below patios and decks with wire mesh to prevent debris and combustible materials from accumulating.
- **REMOVE** flammable materials (wood piles, propane tanks) within 30 feet of your home's foundation and outbuildings, including garages and sheds. If it can catch fire, don't let it touch your house, deck or porch.
- Wildfire can spread to tree tops. **PRUNE** trees so the lowest branches are 6 to 10 feet from the ground.
- KEEP your lawn hydrated and maintained. If it is brown, cut it down to reduce fire intensity. Dry grass and shrubs are fuel for wildfire.
- Don't let debris and lawn cuttings linger. DISPOSE of these items quickly to reduce fuel for fire.
- **INSPECT** shingles or roof tiles. Replace or repair the shingles that are loose or missing to prevent ember penetration. COVER exterior attic vents with metal wire mesh no
- larger than 1/8 inch to prevent sparks from entering the home.
- ENCLOSE eaves and screen soffit vents using 1/8 mesh metal screening to prevent ember entry.

You talk a lot about budgeting, and how important it is in getting control of your money. Alleged Serial Sex Assailant Nabbed through Familial DNA Search

Butte County District Attorney's Office

BUTTE COUNTY, CA (MPG)

- An alleged serial sex assailant was arrested this morning as a result of a cross match DNA "hit" on a member of the suspect's family. The assailant is suspected of multiple sexual assaults that occurred in Chico and Red Bluff between 2014-2019.

Butte County District Attorney Mike Ramsey and Tehama County District Attorney Matt Rogers announced that officers from the Chico Police Department, the Red Bluff Police Department, and the California Department of Justice (DOJ) arrested Steven Craig Michael Haskins, 36, of Chico, this morning.

"In what would otherwise have remained cold case sexual assaults in Northern California, the use of familial DNA search not only led to the suspect's arrest, but ensured a dangerous sexual assailant is off the streets and unable to victimize another woman today. The identification of Haskins would not have been possible without the familial DNA search by DOJ," Ramsey and Rogers

"This was a joint effort with dedicated detectives from Chico, Red Bluff, and the expert forensics team at the Department of Justice," the District Attorneys added.

New California Attorney General Rob Bonta said, "There is absolutely no place for rape or sexual assault anywhere in our society. Today's arrest is a clear reminder of the good work that can be done when we collaborate across jurisdictions to stand up for the people of our state. I am proud of the efforts of the California Department of Justice's forensic experts, special agent investigators, and crime analysts who work tirelessly to help keep our streets safe. I also commend our law enforcement partners in Butte and Tehama on their commitment to securing justice. My office stands ready to continue to provide assistance on this critical case and to use our technological know-how to support our

partners across the state." The familial search process involves searching the assailant's DNA against the state's convicted offender database to identify potential relatives in the database. Haskins' DNA had been previously recovered from two sexual assaults in Chico and one sexual assault in Red Bluff, between 2014-2019. Although his DNA was recovered in each case, he remained unidentified because the sexual assault DNA samples were not known to be associated with him as he had no known DNA sample in the state's system.

However, the DNA of one of Haskins' family members, who had been convicted of a felony, was in the state's DNA databank. A familial search was conducted, and DOJ established a possible familial connection between the family member and the DNA collected from the three sexual assaults. That connection was used to identify and arrest Haskins after his DNA was obtained by DOJ agents who had been surveilling him.

Familial DNA searches are only used in limited situations where a violent crime has been committed, there is a serious risk to public safety, and all other investigative leads have been exhausted.

District Attorneys Ramsey and Rogers noted they have agreed to combine the cases to be tried in Butte County. Ramsey says his office plans to charge Haskins with a count of rape, a count of kidnapping, and a count of assault with intent to com-


Haskins is currently being held on \$450,000 bail and will appear in Butte County Superior Court to face charges on Wednesday afternoon, April 28, 2021.



A Showdown Over Crime and Punishment Looms

Should California continue to reduce punishment for crimes large and small, or has it gone too far and implicitly allowed criminals to prey upon Californians without fear of imprisonment?

The question has reverberated throughout the state over former Gov. Jerry Brown lunched a personal crusade to scale back the lock-'em-up laws that California enacted – including some that he signed – in the 1980s and 1990s.

California voters will answer it next year by either giving newly appointed Attorney General Rob Bonta, a fervent believer in the softer approach to crime, a full term or replacing him with someone with a tougher attitude toward lawbreakers.

The conflict jelled on Monday when Sacramento County District Attorney Anne Marie Schubert declared her candidacy, saying, "The California criminal justice system is in chaos" value rehabilitation over punishment.

Schubert devoted much of her announcement to denouncing Los Angeles District Attorney George Gascón and San Francisco District movement that has been Attorney Chesa Boudin as "rogue prosecutors,"

ignoring crime victims in their rush to soften punishments, and tying Bonta to them.

"Rob Bonta has no regard for crime victims," Schubert told the Sacramento Bee in a pre-anouncement interview. "I think Rob Bonta is similar, if not identical, to the district attorney in San Francisco and Los Angeles."

In Schubert, the state's criminal justice traditionalists probably have their strongest challenger to Bonta, a state legislator who was selected by Gov. Gavin Newsom as a successor to Xavier Becerra after the latter joined the Biden administration in Washington.

While moderate Republican the last half-decade, ever since Nathan Hochman, former assistant U.S. attorney in the Bush administration, also is running, he is little known while Schubert, a former Republican who is not registered with a political party, achieved statewide and even national attention for recently prosecuting serial rapist and murderer Joseph James DeAngelo Jr. Dubbed the Golden State Killer, DeAngelo, a former policeman, was tied to the decades-old crime spree by a novel use of DNA evidence.

Schubert can expect support from all but a handful of the state's other local prosecutors and police organizations which have opposed efforts by Brown and like-minded legdue to laws and policies that islators to soften punishment. She surrounded herself with families of crime victims as she announced her candidacy.

Bonta, on the other hand, will be backed by the national criminal justice reform working state-by-state and county-by-county to replace

criticizing state legislators for traditionalist prosecutors with those favoring rehabilitation over incarceration. Billionaire investor George Soros has been one of the major drivers behind the movement.

> Schubert, in fact, had overcome such a challenge in winning re-election three years ago. When Gascón, who had been San Francisco's district attorney, moved to Los Angeles and unseated District Attorney Jackie Lacey in 2020, it marked a new intensity in the philosophical clash.

> He, Boudin and two other like-minded district attorneys have battled with the California District Attorneys Association over policy issues and formed their own group, the Prosecutors Alliance of California, to push for criminal justice reforms.

The next big California battle for the contending factions was to have been in Orange County, where District Attorney Todd Spitzer, a former Republican legislator, will be facing Peter Hardin, a Democrat and former prosecutor, next year.

However, Becerra's resignation, Bonta's appointment and Schubert's declaration of candidacy create an even more intense showdown over crime and punishment in the nation's most populous state.

Should Schubert prevail next year, it would not only be a big win for criminal justice traditionalists, but also make her a potential candidate for governor or U.S. Senate thereafter.

Dear Dietitian

Iron Deficienc

Dear Dietitian,

My teenage daughter was recently diagnosed with iron deficiency anemia. She follows a vegan diet and has been taking a vegan supplement. Are these as good as regular iron pills?

Dear Mom,

It is not uncommon for women of childbearing age to become iron deficient, especially if they have heavy menstrual periods. According to the US Department of Health and Human Services, iron deficiency is the most common nutritional deficiency and the leading cause of anemia in the United States. (1) The RDA of iron is 15 mg per day for women 14-18 years of age, 18 mg for women 19-50 years old, and 8 mg for men 19 years and older. Furthermore, the RDA of iron for vegans (those who abstain from all animal products) is 1.8 times more than for those who eat meat.

Iron is needed to produce red blood cells, which carry oxygen to our organs and tissues. If there is not enough iron in our bodies, there is insufficient oxygen flowing throughout, and we may become tired and weak.

Iron is plentiful in our food supply, and it is found in two forms. Heme iron comes from animal products, such as beef, poultry, and fish. Nonheme sources are found both in animal products and plant foods. Examples of non-heme iron are beans, spinach, and dried fruits such as apricots, raisins, and prunes. Breakfast cereals, as well as flour and bread, are fortified with iron. It is estimated that our bodies absorb heme iron two to three times more efficiently than non-heme. The amount of iron absorption is dependent on how much the body needs, and vitamin C aids in this process. Citrus fruits and juices, strawberries, and kiwi are good sources of vitamin C. If excessive amounts of iron are consumed, it will be excreted in the

Most iron supplements are made in a laboratory and consist of an iron salt, such as iron gluconate or iron sulfate. These are absorbable, nonheme sources and are acceptable on a vegan diet. There are iron supplements derived from the curry tree, but studies on absorption rates are limited.

Absorption of iron supplements is best when taken on an empty stomach one to two hours before a meal. If stomach upset occurs, drink water or a cup of orange juice with the iron pill. If nausea or vomiting persists, take iron with a meal.

One last tip: when purchasing any supplement, be sure USP is on the label. The United States Pharmacopeia (USP) tests dietary supplements for quality, safety, and benefit.

Father on Trial for Killing His Children in Crash

BUTTE COUNTY, CA (MPG) - A Sacramento man, who drove his truck into a local canal killing his children and a brother-in-law last Easter, was in Butte County Superior Court where a judge found sufficient evidence to send his case to a jury trial.

Colby Allen Brookman, 28, was held to answer after a prelimi-

with gross vehicular manslaughter while intoxicated and felony DUI. Brookman is facing life in prison.

Butte County District Attorney Mike Ramsey said on April 12, 2020, Brookman drove his truck into the canal at the end of Grand Avenue in Oroville. Brookman's wife, J'lynne Stothers, was a passenger in front seat and their two infants – Arianna, 17 months; Ava, nary hearing before Judge Kristen 7 months; and J'lynne's brother,

Butte County Superior Court Lucena. Brookman is charged Matthew Stothers, age 32 - were passengers in the rear of the quad cab truck.

> Ramsey said the evidence at the hearing showed Brookman was drinking numerous beers throughout the day and had been told not to drive. A blood test taken two hours after the crash showed his blood alcohol level to be 0.12 percent. California Highway Patrol's Multidisciplinary Accident Investigation Team (MAIT)

investigated the incident and testified at the hearing. The MAIT team was able to determine through the truck's "black box" that Brookman was driving at over 80 mph just prior to the road ending at the canal. The truck launched over the levee into the canal's deep waters. The children were strapped into baby car seats in the rear seat with Matthew Stothers between them.

Ramsey said a witness testified he saw Brookman and J'lynne swim out of the water. He saw Matthew come to the surface of the water briefly, struggle and then sink below the surface. Butte County Search and Rescue later recovered the bodies of Matthew, Arianna, and Ava from the canal's water.

The judge scheduled Brookman's case for arraignment and jury trial setting on April 14, 2021. Brookman remains in custody at the Butte County Jail and is being held without bail.







Gridley Bulldogs Varsity Baseball Win 7 Straight, Start League 3-0





Safety Project for Highway 99 near Lomo Railroad Crossing

SUTTER COUNTY, CA (MPG) - Caltrans is alerting motorists about the upcoming construction of a safety project at the intersection of State Highway 99 and Live Oak Boulevard/Encinal Road near the Lomo Railroad Crossing.

During the week of May 24, crews are scheduled to replace the left turn lanes in the center median with flexible delineators, rumble strips and double-yellow striping. These features will prohibit motorists from making a left turn from southbound Highway 99 to Live Oak Boulevard and a left turn from northbound Highway 99 to Encinal Road. Motorists should use alternate routes to access Live Oak Boulevard or Encinal Road.

In addition, painted splitter islands will be placed at Live Oak and Highway 99 and Encinal and Highway 99. These islands will allow only right turns from Live Oak to northbound Highway 99 and from Encinal to southbound Highway 99.

Motorists also will be unable to cross the highway between Live Oak and Encinal.

The \$100,000 safety project is aimed at improving safety and traffic operations and reducing the number and severity of collisions at the intersection. Chrisp Co. of Fremont is the contractor. The roadwork is expected to take about a week to complete.

Now it's on to the next phase of the campaign. And because the Newsom camp will be fending off attacks not just from the pro-recall campaign itself, but from every candidate hoping to replace the governor, "they're gonna have to spend a whole lot more to win than we're gonna have to spend to beat him," Dunsmore said. "Everybody's gonna have over a million bucks worth of potshots."

By April 30, committees on both sides of the recall fight were required to file semi-annual reports with the secretary of state disclosing all of their fundraising activity to date. That included a list of larger donors – those who gave at least \$200 – as well as the total contributions from smaller anonymous donors. Except for the occasional poll on the governor's favorability ratings, these campaign finance reports provide one of the first hard metrics of the state of the race.

Walsh, Sean Republican strategist who advised Arnold Schwarzenegger in his successful 2003 recall race against Gov. Gray Davis, said that recall supporters are all but certain to get outraised and outspent
