

## **Bring Us Your Drugs!**

GRIDLEY, CA (MPG) - Gridley Police Department, in cooperation with the Drug Enforcement Administration (DEA), is participating in the 2021 National Take Back Initiative! And what is that?

The National Take Back Initiative is a program that offers safe outlets and ways to dispose of prescription medications in an ecofriendly manner. The DEA says, "National Prescription Drug Take Back Day addresses a crucial public safety and public health issue. According to the 2019 National Survey on Drug Use and Health, 9.7 million people misused prescription pain relievers, 4.9 million people misused prescription stimulants and 5.9 million people misused prescription tranquilizers or sedatives. The survey also showed that a majority of misused prescription drugs were obtained from family and friends, often from the home medicine cabinet."

Medications collected at various Take-Back Day locations are weighed, labeled, and delivered to the area DEA offices, in our case, Sacramento, to be destroyed.

GPD Officer Ruth Hennessey will be leading the Gridley collection efforts at the 2021 National Prescription Take Back Day, which will be held Saturday, April 24th. GPD asks that you be mindful of the following instructions: There is no need to separate the pills from their storage containers; Liquids are accepted - please seal tightly and bag if possible; NO SHARPS under any circumstances.

If you have medications that you no longer take, are expired, or are just in need of disposal, please consider disposing of them at a secure location, such as the Take Back event or either of the two secure drop boxes in Gridley. They are available 24/7 and are located at Orchard Hospital and out front between Gridley City Hall and Gridley Police Department.

Dispose of your drugs at Gridley's National Take Back Day Saturday, April 24th from 12:00-2:00 pm at the Gridley Animal Control Shelter parking lot located at 895 Sycamore Street, Gridley.

GRIDLEY, CA (MPG) - Do not miss the Gridley High School Graduating Class of 2021, athletes and royal court as they make their way through town this Friday.



## **Breakaway Roping Comes** to the Stonyford Rodeo

STONYFORD. CA (MPG) - Women's Professional Rodeo Association (WPRA) Breakaway Roping will be added to this year's Stonyford Rodeo, which will be a three-day outing on April 30, May 1, and

Breakaway Roping is similar to regular calf roping, except that the calf is not thrown and tied. In this event, the contestant's rope-end is tied to the saddle horn with light string. Once the calf is roped and the horse has made a quick stop, the calf continues until the rope breaks away and signals the end of the run. A white flag is affixed to the end of the rope tied to the rider's saddle horn, which lets the timer easily see and record the breakaway time. The roper with the quickest time is the winner.

WPRA Breakaway Roping has become very popular and lucrative: The top contestant exceeded \$17,000 in winnings, with the next five exceeding \$15,000, as of 04/02/2021. If our fans like this new event, which will be on Friday and Saturday, it will likely become a permanent add to our rodeo.

Pre-rodeo ticket prices are \$10 for adults and \$6 for children, ages 7-12. At the rodeo gate, ticket prices are \$15 for adults and \$7 for children, ages 7-12. Tickets for the May 2, 2021, amateur events can only be purchased at the rodeo gate on that Sunday. Ticket prices are \$5 for persons aged 13 and older; children 12 and younger are free. ★

## State Issues Pause on the COVID J and J Vaccine, Butte County to Follow

BUTTE COUNTY, CA. (MPG) - The California Department of Public Health (CDPH) announced that California will follow the FDA and CDC recommendations to pause the use of the Johnson and Johnson COVID-19 vaccine after several cases of blood clotting were reported in the U.S. This pause will remain while the safety of the vaccine is being reviewed by federal authorities. Butte County Public Health will follow this determination made by CDPH. All previously scheduled vaccination clinics in Butte County that were offering the Johnson and Johnson vaccine will be replaced with Moderna.

Residents who booked a vaccination appointment at the Chico Community Vaccination Clinic for Wednesday, April 15th will be rescheduled for Saturday, April 17th to receive the Moderna vaccine.

Residents who booked a vaccine through a local pharmacy that was offering the Johnson and Johnson vaccine will need to coordinate directly with the pharmacy where the appointment was booked.

As of April 12, more than 6.8 million doses of the Johnson & Johnson (Janssen) vaccine have been administered in the U.S. CDC and FDA are reviewing data involving six reported U.S. cases of a rare and severe type of blood clot in individuals after receiving the J&J vaccine. All six cases occurred among women between the ages of 18 and 48, and symptoms occurred 6 to 13 days after vaccination.

Right now, these adverse events appear to be extremely rare. COVID-19 vaccine safety is a top priority for the federal government and CDPH, and we take all reports of health problems following COVID-19 vaccination very seriously.

Butte County residents who recently received the Johnson and Johnson vaccine who develop severe headache, abdominal pain, leg pain, or shortness of breath within three weeks after vaccination should contact their health care provider.

YUBA - SUTTER REGION, CA (MPG) - The Feather River Tea Party Patriots, in cooperation with Stephanie Ruscigno, U.S. Army veteran, hosted a unique and informative event - the Veterans PTSD Town Hall.

Open to anyone suffering from Post-Traumatic Stress Disorder (PTSD), the event was mostly attended by veterans who wanted to know more about cutting edge science and treatments for the disorder from a pair of doctors out of Maine, that call themselves The Integrative Docs.

Doctors Richard Matthews, a Board-Certified Chiropractic Neurologist and Dr. Ruth Moore, an Integrative Health Practitioner and Cognitive Behaviorist, make up The Integrative Docs duo, who specialize in reducing the effects of stress responses in the body and promoting health and wellness through complementary and alternative medicines and treatments. Dr. Matthews and Dr. Moore collaborate and travel or present via zoom, scientific data, research, and treatments that can help those suffering from

to be a slave to your stress. You don't have to be a slave to your condition. It's understanding that you have hope, or creating hope, or embracing hope, [it] means that you are seeing things from a different perspective. Ultimately, our happiness, our stress levels - it all depends on the mindset or the perception we have." A pivotal concept in her practice, she continues, "in mind-body medicine, our minds have the power to heal our bodies."

Many veterans suffering from mental health issues, MST (military sexual trauma) or PTSD express frustration with the "pop-a-pill, cure an ill" or traditional pharmaceutical approach of treating the sometimes severe physical and mental conditions manifest by those disorders. The Integrative Docs believe that "Medication is never a 1st choice," saying that "it removes responsibility, accountability, and some of our constitutional freedoms." Dr. Matthews and Dr. Moore educate that although PTSD cannot be cured, it can be mitigated through neurolinguistic reprogramming, behavioral therapy, autonomic nervous system balancing therapy and coaching. They

PTSD understand the disease.

As stated in the Integrative Doc's power point presentation to the veterans that evening, "PTSD is not a mental health condition, but a neurobiological injury, much like Traumatic Brain Injury (TBI)." The presentation went on to illustrate how PTSD appears on and can be diagnosed by functional Magnetic Resonance Imaging (fMRI) and Positron Emissions Tomography (PET) scans. Dr. Matthews and Dr. Moore discussed allostatic load, adrenal fatigue and provided those in attendance with a foundation for self-care and tools for creating H.O.P.E for wellness: Honoring yourself; Organizing needs; Prioritizing your schedule; Empowering your life.

Dr. Moore who practices at Downeast Wellness Holistic Health Services and treats many struggling with disorders besides PTSD says that "You don't have

promote healthy diet, physical exercise, stretching and breathing exercises, along with holistic practices of using essential oils, acupuncture, mindfulness and more to treat PTSD.

Ruscigno, who helped bring the Integrative Docs to the forum, has benefitted personally from the resources and information that is shared nationwide by Dr. Moore and Dr. Matthews. It has become a passion for her to spread this life-changing information to veterans and anyone struggling with mental or physical health issues that could benefit from it. "I believe the Integrative Docs message needs to get out. How many suicides prevented and lives-lived more fully?" she questioned. Ruscigno secured the Integrative Docs' expert advice with a personal financial donation, so that the nearly 60 veterans and the Feather River Tea Party Patriots in attendance at the PTSD Town Hall could benefit from the

The feedback from those in attendance was profound. Ruscigno shares that a woman, who asked to remain anonymous said, "the affirmation she got was both comforting and encouraging. Tears welled." Others in attendance reported they planned to get MRI's for diagnostic purposes as soon as possible. U.S. Navy Vet, Jonathan Bibbins said, "Awesome presentation. Bringing a conscience to the needs of veterans warriors is necessary." He ended with "I look forward to your next presentation."

## **National Crime Victims' Rights** Week Celebration

**BUTTE COUNTY, CA (MPG)** 

- In commemoration of National Crime Victims' Rights Week, April 18 those victims traumatized by violent crime, Butte County District Attorney Mike Ramsey dedicated this week to raise awareness about crime victims' issues and rights. Ramsey noted a substantial increase in victims of violent crime in Butte County in 2020 during the COVID-19 pandemic.

Ramsey said, "We must always remember that the faces of crime victims are those of our family, friends, neighbors, and community members. The Butte County District Attorney's Victim Assistance Bureau reached out to 4,145 new victims of violent crime in 2020. In 2019, that number was 3,435 – an increase of 21%. This, despite the COVID-19 lockdowns and the best efforts of our law enforcement and justice partners throughout Butte County."

Ramsey said, "Now is the time to redouble our efforts so that victimization declines and fewer Butte County residents suffer the trauma of violent crime."

Ramsey noted that the federal Office for Victims of Crime (OVC) leads communities throughout the nation in their annual

observances of the Crime Victims' Rights Week by promoting victims' rights and honoring crime victims and those who advocate on their behalf.

"This year's theme Support Victims. 24, 2021, and in honor of Build Trust. Engage Communities. – celebrates the contributions we all can make toward building trust in our community's capacity to support the healing journeys of crime victims. Trust is collective as well as individual, so we honor both the individual victims in our community and the groups engaged in building networks of understanding and support.'

The DA's Victim Assistance Bureau is in its tenth year of operations with the District Attorney's Office. In the nine calendar years of operation under the District Attorney, victim services have been offered to 35,168 victims of violent crime.

The Bureau's victim advocates work closely with prosecutors and investigators to provide information to victims of the progress of their case through the criminal justice system. Advocates assess and refer for services, provide court escorts, education, and support, and offer California Victim Compensation program access to victims of violent crime. In addition to medical and counseling expenses, this program offers reimbursement for

funeral and burial expenses in homicide cases and relocation expenses for victims who must move for their

Last year in 2020, the Bureau assisted in gaining \$407,789.65 for Butte County crime victims. In the nine fiscal years of operation under the District Attorney, over \$7,744,448 has been paid on behalf of crime victims.

Bureau staff are members of county-wide multidisciplinary teams including Butte County's Sexual Assault Response Team, Child Abuse Response Team, and Commercially Sexually Exploited Children Team. Victim Assistance Bureau continues to work closely under the Memorandum of Understanding with the Butte County Superior Court, Butte County Treasurer-Tax Collector and Auditor-Controller to enhance the collection and disbursement of restitution to crime victims.

LIVE OAK, CA (MPG) - The Live Oak Hwy 99 Streetscape Project has been tearing the highway in Live Oak up for over a year now; You cannot drive through Live Oak without noticing the construction everywhere you look, but new curbing, parking spaces, sidewalks and more are beginning to tease residents and motorists that the end may be in sight. But, not yet.

Residents and motorists can expect continued heavy construction activity that will once again re-route their course through town. Beginning May 1, 2021, Caltrans and the City of Live Oak want residents, drivers, and pedestrians to know that the traffic flow on Hwy 99 through town will be shifted to the west side of the existing roadway between Archer Ave and Pennington Road. Officials expect this shift to be temporary, ending July 30th or as work completes.

An additional traffic shift is planned for the area between Myrtle Street continuing past Ramsdell Drive to the north. Traffic will be shifted to the west through that stretch of town between May 1 and June 1 for construction crews to rehabilitate the existing roadways.

Motorists should be aware of temporary concrete barriers placed or other construction materials throughout the work zones, reduced speeds, and expect narrowed lanes. Although some of the construction may hinder the entrance and egress from your favorite local shops, highway access will remain open to business and residents (unless otherwise posted).

## Did You Feel It?

**GRIDLEY, CA (MPG)** - Something has been shaking up Gridley recently and it seems to be happening more often!

Tuesday evening, at approximately 7:39 pm according to earthquake.usgs.gov, a 3.8 magnitude earthquake occurred near Chico, about 9 miles from Willows. The epicenter of the quake was reported to be 23 km deep. It was followed by a second, slightly smaller 2.8 magnitude quake later that evening at 9:25 pm 14 km from Willows.

According to EarthquakeTrack.com, Gridley has had 4 quakes in the past 24 hours, 6 in the last 7 days, and 9 in the past 30. Over the past 3 months, Willows has had 3 earthquakes (not counting the latest two) with magnitudes of 3.8 (12-12-20) 2.5 (12-27-20), and 2.6 (1-31-21) reported. Chico was hit with a magnitude 2.1 in February of this year, Loma Rica with a magnitude 2.3 (2-13-21), Oroville with a 1.8 magnitude (2-3-21), and Durham with a 1.9 magnitude (12-11-20). All were 26 km down or closer to the surface.

Many in Gridley, Biggs and surrounding areas felt heavy shaking while others were oblivious to the rocking and rolling underground. For the latest earthquakes, facts and other information, visit earthquake. usgs.gov.

## Wanda Williams Hodges

A graveside service will be held Friday, April 23, 2021 at 11:00am at the Gridley-Biggs Cemetery for Wanda Williams Hodges, 96, who at the time of her death resided in Emmitt, Idaho with family members. She was born on Oct. 8, 1924 in Gridley, CA, the daughter of Joseph Leo Williams and Mima Durfee.

Wanda graduated from Gridley High School, class of 1942. After graduation, she moved to San Francisco, CA

where her older sister Leola lived and got a job in an insurance company. During this time, she met and married a young serviceman named Movell Martell and had a son, Charles William. Through the pains of separation and WWII the marriage did not last.

In 1948, while living with her parents in Hydesville, CA, she met the love of her life Weston K. Hodges at a church service. ## **Raw Milk**

Dear Dietitian,

I have a friend who drinks raw, unpasteurized milk. She claims it has many health benefits and that pasteurization of milk is unnecessary. What do you think?  $\sim$  Jim

Dear Jim,

The consumption of raw milk has gained popularity in recent years, and many people believe it is a healthier alternative to pasteurized milk. Let's take a look at what science says.

Most of us are familiar with the term pasteurization, which is the process of heating food products like milk to a temperature high enough to kill harmful bacteria. The process was named for its inventor, Louis Pasteur, a French scientist. Pasteurization was created to "kill the diseases" of wine in France (1). Commercial pasteurization of milk began in the US in the early 1900s due to widespread milk-borne illnesses.

A review of studies on the safety of raw milk was performed at Johns Hopkins University in Maryland in 2014 and concluded the "relative risk of individual illness is almost 150 times greater per unit of unpasteurized dairy product, compared to pasteurized." (2) The most common disease-causing bacteria in unpasteurized milk are E. Coli, Salmonella, Listeria, and Brucella. According to Dr. Pritish Tosh, an infectious disease specialist at the Mayo Clinic, Brucella is a drug-resistant bacterium that can cause brucellosis, an infection that can be severe and affects many areas of the body, including the bloodstream, bones, and joints (3).

Contrary to what can be found on the internet, milk's nutrient composition is not changed by pasteurization. Milk is a significant source of calcium, protein, and vitamin B12. Vitamins A and D are added to pasteurized milk that is sold commercially. While there are some losses of B12 (<10%), vitamins A and D and calcium are heat stable and maintain their value during pasteurization. Denaturing of protein indeed occurs, but it still retains its nutritional purpose (4).

Are good bacteria lost in pasteurized milk? These studies are conflicting. At any rate, healthy bacteria can be obtained in pasteurized foods like yogurt with live and active cultures and kefir. You may also purchase probiotics but remember, research only supports improvement in digestive problems with probiotics, not overall health.

Finally, it is essential to note that most health organizations recommend infants under the age of one not consume cow's milk, raw or pasteurized. Their digestive tracts cannot handle the ash in cow's milk, and if they contract an illness from bacteria in raw milk, their immune systems are not yet fully developed to fight the infection effectively. Babies should consume human breastmilk or formula.


## Fire Alarms in Apartment Buildings

Large apartment buildings are built to keep people safe from fire by utilizing alarm systems that detect smoke and fire that will warn residents of danger.

- In a fire, smoke detectors sense smoke and activate the fire alarm. Manual fire alarm boxes allow people to sound the alarm. When the fire alarm system activates it will warn residents of danger.
- Everyone in the building should know where to find the manual fire alarm boxes (alarm boxes on the wall with a pull bar). Most are found within five feet of an exit door.
- If there is a fire, pull the manual fire alarm box handle on your way out of the building.
- When the system senses smoke or fire, a loud horn or tone will sound. Everyone must know what this sound means and how to react.
- Leave the building right away if you hear the sound of a fire alarm. Stay outside at your meeting place until you are told the building is safe.

 Treat every fire alarm as an emergency. When the alarms sounds, get outside.

Only use a manual fire alarm box if there is smoke or fire.
 Frequent false alarms are a problem. People might ignore the sound if they hear too many false alarms.



## Kiley and Gallagher Issue Joint Statement in Case against Newsom

SACRAMENTO, CA (MPG) Assemblymembers Kevin Kiley (R-Rocklin) and James Gallagher (R-Yuba City) released the following statement after oral arguments in Gallagher and Kiley v. Newsom that took place in front of the Third District Court of Appeal:

"We appreciated the opportunity to appear before the Appeals Court and are hopeful that the Superior Court's ruling will be affirmed. The notion that one person can centralize all state power in his hands is utterly incompatible

with our Constitution and form of government. This case can assure the extraordinary abuses of the past year are never repeated."

Gallagher and Kiley won their case in the Superior Court where the judge restrained the Governor from "exercising any further legislative powers in violation of the California Constitution and applicable statute" and barred him "specifically from unilaterally amending, altering, or changing existing statutory law or making new statutory law."

This will be the first precedent-setting decision in California history on the limits of a governor's emergency powers. ★

## **Bills would Hamstring Future California Recalls**

As signatures on petitions to force Gov. Gavin Newsom into a recall election are being tallied, the Legislature is considering bills that would, if enacted, make future recalls of California's elected officials less likely.

Two Democratic state senators, Ben Allen of Redondo Beach and Josh Newman of Fullerton, are carrying measures they say are needed to reform the recall process.

Newman's Senate Bill 663 would allow targets of recall campaigns to access the lists of recall petition signers and try to persuade them to remove their signatures. Current law allows only election officials to access their names to validate signatures.

Currently, signers have 30 days after the recall to change their minds. SB 663 would extend that to 45 days.

Critics say that revealing the names of petition signers would subject them to harassment by recall targets and their supporters.

Newman, who went through a recall election himself in 2018, told the Senate's election committee this week that "this bill has no impact whatsoever on the recall effort against Governor Newsom" because, as now written, it would not take effect until next January.

The Senate elections committee approved SB 663 and another Newman measure, Senate Bill 660, that would ban the now-common practice of paying professional petition circulators by the signature, not only for recalls but also for initiative measures and for referenda to invalidate laws passed by the Legislature.

A prohibition on per-signature payments has been floated for years. Advocates contend that paying signature-gatherers by the name encourages them to mislead potential petition signers about the issues before them.

However, every recent governor has vetoed at least one version of the proposal. When he vetoed a 2019 ban on per-signature payments, Newsom said, "While I appreciate the intent of this legislation to incentivize grassroots support for the initiative process, I believe this measure could make the qualification of many initiatives cost-prohibitive, thereby having the opposite effect."

Allen, meanwhile, is offering a constitutional amendment and a conventional bill that would affect the recall process.

Senate Constitutional Amendment 3 would make successful recalls more difficult by placing the name of the targeted official on the ballot as a successor candidate.

That, Allen argues, is unfair because with multiple candidates, someone could win with relatively few votes. Under his measure, voters would simply decide whether to retain the incumbent with a plurality of votes or opt for one of the other contenders.

SCA 3 also would cancel a recall election if the incumbent resigns after the recall qualifies which, in the case of governors, would mean an automatic takeover by the lieutenant governor. If another statewide official facing recall resigned, the governor would name a successor.

Allen's second measure, Senate Bill 752, would require that before voters signed petitions for a recall, an initiative or a referendum, they would have to certify that they had read a list of the proposed measure's top financial contributors. As with Newman's SB 660, its declared aim is to prevent signature gatherers from misrepresenting the issues involved.

It's debatable whether these measures would, as Newman and Allen contend, improve the recall and other forms of direct democracy. They certainly would make them more cumbersome and expensive and therefore less likely to succeed.




