# Sen. Dahle **Helps Bring** Transparency to Parents

SACRAMENTO, CA (MPG) - Senator Brian Dahle (R-Bieber) appealed to the California State Senate Committee on Education to pass legislation that would bring transparency to school curriculum on sexual health.

As one of the most sensitive subjects taught in our schools, parents are intensely interested in what and when the topic of sexual health is presented to their children.

Senate Bill 217 will simply add transparency to school instruction by requiring the school's curriculum on this subject be made available online.

Over the past year, parents were plunged into a much more active role in their children's education and online resources became invaluable to filling-in any gaps created by distance learning.

"The education of our students can only be improved when teachers and parents can work collaboratively, especially on difficult or sensitive subjects," said Senator Brian Dahle.

Encouraging transparency should not be partisan, especially when the education of California's students are involved.

"Having these resources available online will provide parents valuable information to follow-up with their children so there's a better understanding of the material," Dahle continued.

SB 217 passed the Education Committee on a vote of 4-1, and will now go to the Senate Appropriations Committee for consideration.

SB 229, a measure that would offer up to \$500 million in Pupil Mental Health Grants has also passed the Senate Committee on Education, on consent.

You do need to sign up, and there are prizes, including best engine, best interior, best paint job, best of show, and the people's choice. If you are too cool for the internet, call 846-3142. Some people with vintage cars still use the phone for communicating, so the Chamber maintains a landline number. Red Suspenders Day happens on Hazel and Sycamore Street and most of downtown Gridley with vendors, food, refreshments, games, entertainment, and some odd ritual in which service clubs arrest people - and their friends have to bail them out to raise money for community service events.

We loaded up in the family van and went to Lassen Volcanic National Park. The road was still closed, but they allowed us to hike



# Medium or Low, Heron Landing Says "No"

GRIDLEY, CA (MPG) - It was full capacity at City Hall chambers last Wednesday, April 21st as the Gridley Planning Commission considered amendments to the general plan of an incoming development and opened the meeting to the public for input.

The site in question is approximately 40 acres located on the eastern side of West Biggs Gridley Rd and running contiguous along the northern border of the Heron Landing development. It has been within the city sphere of influence since 2010 and according to the Planning Commission agenda, is "the next logical area of growth to the City."

Property owners Darryl and Sue Bernard requested annexation of the property into the City and an amendment to the proposed General Plan land use designation of residential, low density to General Plan medium density and pre-zoned for Single Family Residential District (R-1). The development was originally intended to have both low and medium densities (and even considered a high-density area) to diversify residents in the attempt to attract single family occupants, empty nesters/seniors and families just getting

The agenda packet for this meeting states that "The proposed project removes the high density residential and the residential low-density designations from the plan; this removed the multi-family component of the current General Plan. The density of the existing General Plan.... reflects an average of 5.3-9.9 du/ ac (development unit/acre). The first alternative proposed 212 units resulting in a density of 5.6 du/ac. This is the lowest density of the Residential Medium

Density designation." Another alternate would propose 202 units with the 5.3 du/ ac, the lowest average for compliance with the General Plan.

Prior to this meeting, concerned residents in Heron Landing circulated flyers seemingly against the new development and submitted emails to the commission questioning a variety of issues with the new development slotted to go in north of Heron Landing.


Among the chief complaints of neighbors in Heron Landing were the number and proximity of the homes to each other (density), increases in neighborhood traffic, more neighborhood crime, or nuisances, including fears for the safety of

A large turnout at Wednesday's meeting allowed many the opportunity to add to those concerns and voice others, but due to COVID-19 safety precautions, not all were allowed into council chambers. Allegedly, many residents gathered on the landing outside chambers waiting for entrance but were turned away and told to dial-in to participate in the discussions. Allegedly, there were somewhere around 60 people attempting to participate in the public hearing either in person or by teleconference.

The planning commission heard public comment and responded directly to the concerns listed in the emails and circulated on the flyers. After the close of the public hearing, the commission considered the next steps forward. The issue is slated to appear on a future Planning Commission agenda. 

# **Biggs Preps for Annexation Phases**

BIGGS, CA (MPG) - The City of Biggs Planning Department is preparing to hold a public informational meeting next week, May 4th, 2021 at 5:00 pm. This is open to the public and residents may attend at the City of Biggs City Council Chambers located at 3016 Sixth Street or via zoom if social distancing.

The purpose of the meeting is to inform the public on a series of annexation phases. The information packet available on the City of Biggs website says, "Following its award of a Senate Bill (SB) 2 Planning Grant, the City of Biggs

proposes to increase the inventory of land zoned for residential growth within the city by annexing and pre-zoning approximately 577.6 acres adjacent to the eastern city limits." It continues, "The proposed annexation plan could lead to the addition of approximately 992 acres to the City of Biggs and the potential development of 2,635 new housing units."

The annexation process would occur in Phase 1 and Phase 2, with each phase encompassing sub-phases. The proposed annexation area is bounded by Rio Bonito road to the north, Dakota Ave on the south, Highway 99 on the east and the existing City limits on the west. The Passcode: 071001.

# Sosa Arrested and Booked into Suter County Jail

**SUTTER COUNTY, CA (MPG)** - On April 17th, 2021 the Sutter County Sheriff's Office was dispatched to an orchard behind 1560 Greenwich Circle for a suspicious vehicle. Deputies arrived on scene to locate a female (victim) covered in blood and a male subject, identified as 25-year-old Luis Amado Sosa.

After further investigation it was determined that the female victim had ended a relationship with Sosa the night prior. Sosa then allegedly took the female by force, took her phone, begun to beat her up as well as stabbed her several times.

Sosa allegedly would beat and stab the victim in a location then would move to another location and continue the beating and stabbing. This occurred in multiple locations. The female was taken to the hospital and treated for major injuries.

Sosa was arrested and booked into the Sutter County Jail for numerous charges including, attempted homicide, kidnapping, assault with a deadly weapon, and felony domestic violence.






# Life Jackets

CAL FIRE/ Gridley Fire Department would like to remind everyone of the importance of using life jackets when having fun in the water this year. With the record rain fall and snow pack the local rivers, streams and lakes will be high most of the summer. With high water, dangerous conditions are highly likely. Fast moving water and lots of debris will be common. Use extreme caution when enjoying the local water ways. Wear life vests and keep a close eye on children.

Nine out of ten drownings occur in inland waters, most within a few feet of safety and involving boats under 20 feet long. 70% of all boating fatality accidents result from drowning. Almost 85% of those who drown were not wearing a life jacket! Having life jackets aboard does not save lives - WEARING them does!



 Have children wearing a life jacket that fits properly (unable to slide past chin or ears)

 Small children must have a crotch strap that promotes a snug fit and keeps the jacket in place

 Have enough life jackets that are easily accessible for everyone on the boat or in the water

With the number of perennial plants reduced, sorta, I'm using annuals for more color in the yards. This is fairly common for many flower gardeners but I always had perennials that held the color throughout the year in the yards. I still have swaths of perennial color but it's somewhat reduced. The annuals I'm using are very

common. Petunias, violas, pansies, snapdragons and at some time marigolds will enter the picture. I'm putting all of them in containers. For some reason I don't feel as responsible for the lives of the annuals as I do for perennials. After all annuals are exactly that...they grow they make seeds and they die in one season. Each year is started anew with plants from the seeds of the previous year.

Many annuals are either sort term perennial of rebels of survival in our area. For example, snap dragons are treated like annuals but I have some in a container that have come back for the last three years. It comes from a stump of stems when it regrows. Another plant that keeps



# **Fad Diets**

Dear Readers,

When it comes to weight loss, we'd all like an instant solution. Many of us have tried a fad diet, myself included. Many years ago, I was on a diet where you followed a strict meal plan for three days, then ate whatever you wanted within reason (whatever that means) for the following three days. The problem was I couldn't make it through the first three days!

Wikipedia defines a fad diet as "one that is popular for a time, similar to fads in fashion. These diets usually promise rapid weight loss or other health advantages, such as longer life. They are often promoted as requiring little effort and producing a quick fix (1)."

Why do we fall prey to these diets? There are many reasons, the first and most obvious is we want to lose weight fast! Many fad diets produce a rapid, initial weight loss of up to five pounds in one week. This is achieved by depleting the body's glycogen stores, an intermediate form of carbohydrate energy. When glycogen stores are depleted, water is lost with them. Hence, the rapid weight loss.

Another reason we choose a fad diet is it sounds reasonable. Sometimes, they are created by physicians, so they must be healthy, right? Often, these diets proclaim to have discovered a secret to losing weight or, even better, a way to trick your body into shedding those unwanted pounds. There are no tricks or secrets to weight loss. You simply create a caloric deficit over time. Simple, but not easy.

According to the Cleveland Clinic, the following guidelines will help you spot a fad diet. (2) These diets tend to have:

- Recommendations that promise a quick fix
- Claims that sound too good to be
- Recommendations based on a single study
- Dramatic statements that are refuted by reputable scientific organizations
- Lists of "good" and "bad" foods
- · Elimination of one or more of the five food groups (fruits, vegetables, grains, protein, and dairy)

Will there ever be an end to fad diets? Not in my lifetime, but as public nutrition education expands, one day, the fad diet will quietly disappear. Just as it is now accepted that smoking increases your risk of cancer, the consumer will realize that a fad diet is not suitable for good health. A healthy diet consists of moderate portions of lean proteins, whole grains, lots of fruits and vegetables, low-fat dairy, and mono- or polyunsaturated fats. Keep it simple.



# California Reverses, **Now Shutting Prisons**

As signatures on petitions It was 1981 and then-Gov. Jerry Brown had a problem. California's 12 prisons were bulging at the seams with more than 28,000 inmates, thanks largely to tougher sentencing laws he signed, and he was told to expect another 20,000 more inmates within a few years.

The state hadn't built a new prison in two decades, stretching back to when Brown's father, Pat Brown, was governor. The Department of Corrections, as the prison system was then called, wanted Brown to launch a major prison construction program to handle its rapidly growing inmate load.

The young governor, nearing the end of his second and final term, was reluctant to ask voters for billions of dollars in bond money to build new prisons. His state architect, Sim Van der Ryn, had even refused to endorse plans for new prisons, reflecting opposition by those on Brown's left flank.

Finally, after months of negotiations and debate within his administration, Brown took a minimalist approach, asking the Legislature to place a \$495 million prison bond issue fraction of the projected need.

Voters approved the measure, and over the next two decades the number of prisons tripled. However, the state sidestepped the need for voter approval with a clever, if deceptive, system of financing that borrowed many billions of construction dollars. Under the "lease-revenue" system, a state agency legally separate from the prison system issued bonds to build prisons, then leased them to the corrections department.

Even though most inmates came from urban counties, particularly Los Angeles, their politicians resisted having new prisons. The single Los Angeles County prison was built in the remote Antelope Valley.

Therefore, most new prisons were located in rural communities eager for the payrolls that the human warehouses generated, with the first in Avenal, a tiny Kings County community that had once been an oil boom town.

Despite the frantic pace of prison construction, the inmate population still outpaced the number of new cells and eventually grew to six times what it had been in 1981, declining only when, during Brown's second governorship, federal judges intervened and declared that the overcrowded conditions were illegal.

Over the last halfdecade, thanks to more lenient sentencing laws (some sponsored by Brown

on the 1982 ballot, enough 2.0), diversion of felons to build space for about into local jails and early 10,000 more inmates, a releases due to COVID-19, inmate numbers have declined sharply to 94,000, scarcely half of the 173,000 peak and very close to the system's original design capacity.

It's now time, Gov. Gavin Newsom says, to start shutting down some of the state's three dozen prisons, citing the inmate decline and billions of dollars in looming costs to rehabilitate older facilities.

The first to go will be the 68-year-old Deuel Vocational Institution near Tracy. This month, it was announced that the second will be the California Correctional Center in Lassen County.

The Legislature's budget office projects that three more could be shuttered by 2025 and the local economic impacts could be heavy, particularly in rural areas. However, just as with the closure of unneeded military installations in the 1990s, that must be a secondary consideration. It's unfair to taxpayers to keep obsolete facilities open just because of their jobs.

That said, rural communities accepted prisons that politicians from urban areas refused and the state should foster the redevelopment of its prison sites for positive purposes, rather than leaving them as decaying eyesores of a previous era.

Newly filed disclosure forms from the first quarter of 2021 show that over 100 lobbyists have been mobilized to contact lawmakers and members of the Biden administration, urging them to oppose a proposed temporary waiver on intellectual property rights by the World Trade Organization that would allow generic vaccines to be produced globally. Pharmaceutical lobbyists working against the proposal include Mike McKay, a key fundraiser for House Democrats, now working on retainer for Pfizer, as well as several former staff members to the U.S. Office of Trade Representative, which oversees negotiations with the WTO. Several trade groups funded by pharmaceutical firms have also focused closely on defeating the generic proposal, new disclosures

California National Guard put fighter jet on alert in March 2020 for 'possible domestic mission' - report - An F-15C fighter was put on alert, sources told the Los Angeles Times | 24 April 2021 | California National Guard members say a fighter jet was put on standby for a "possible domestic mission" last year, raising concerns that the military could be used to disperse protesters in the early days of the coronavirus pandemic, according to a report. Four National Guard sources spoke to the Los Angeles Times about the matter, revealing that commanders were concerned about resistance to stay-at-home orders or chaos due to panic-buying. According to the sources, an F-15C fighter was put on alert, which raised concerns among Guard members that the jet could be used to "buzz" crowds -- a tactic often used in combat zones to disperse the enemy. The orders were allegedly handed down orally or through text messages rather than formally in writing, which made them highly unusual, the sources told the Times. The Guard members described such a tactic as an "inappropriate" use of military force against U.S. citizens."It would have been a completely illegal order that disgraced the military," one source told the Times. "It could look like we're threatening civilians."

FTC takes censorship to a whole new level, charges and fines St. Louis man for questioning vaccines, promoting zinc and vitamin D | 22 April 2021 | The FTC recently charged a St. Louis man for making fraudulent claims about covid-19. The FTC is charging Eric Nepute and Quickwork LLC in a federal court for the heinous crime of advertising zinc and vitamin D to combat covid-19. Nepute is charged with ten counts of violating the Covid-19 Consumer Protection Act and the Federal Trade Commission Act. The FTC alleges that Nepute falsely advertised his products, which contain vitamin D and zinc - two important supplements that are scientifically proven to block viral replication and prevent hospitalization. In 2020, the U.S. Congress quietly installed a new censorship clause in a coronavirus emergency response and relief package. In HR 133, Congress gave the FTC supreme authority to target, arrest and fine anyone who doesn't follow the government's narrative on lock downs, masks, quarantines and vaccines. Anyone who promotes a healthy immune system can now be charged and fined for the "criminal" act of helping people treat and overcome respiratory infection.

The U.S. Postal Service is running a 'covert operations program' that monitors **Americans' social media posts** | 21 April 2021 | The law enforcement arm of the U.S. Postal Service has been quietly running a program that tracks and collects Americans' social media posts, including those about planned protests, according to a document obtained by Yahoo News. The details of the surveillance effort, known as iCOP, or Internet Covert Operations Program, have not previously been made public. The work involves having analysts trawl through social media sites to look for what the document describes as "inflammatory" postings and then sharing that information across government agencies.

# Tax Day 2021: California Ranked #5 for Tax Procrastinators

SACRAMENTO, CA (MPG) - The IRS recently extended the federal tax deadline from April 15th to May 17th, giving many American's more time to procrastinate filing their taxes.

IPX 1031 recently surveyed 1,000 Americans to learn more about their fax filing habits. They also analyzed Google search data from all 50 states and the 30 largest American cities during last year's tax season to determine which cities and states have the biggest tax filing procrastinators.

Here's what they found: California ranked 5th for the biggest tax day filing procrastinators by state with an average of 487 searches related to the tax filing deadline per every 100,000 residents. California ranked 1st in the same analysis in 2020, jumping 4 spots from last year! 33% of American's wait until the last minute to file their taxes.

Top reasons why Americans procrastinate on their taxes: Too time consuming (40%). Too complicated (22%). Want to make sure it's correct (22%). Not getting a refund/no rush (10%). Worried I'll owe money (6%). This year Americans expect to receive an average tax refund of \$2,059. The average federal tax refund for individuals for the 2020 filing season was \$2,707, so many Americans expect a smaller refund this year. 32% of surveyed respondents didn't know that Tax Day was extended until May 17th.★

# **Jury Finds Man Guilty of Six Counts of Child Molestation**

**Butte County District** Attorney Press Release

**BUTTE COUNTY, CA (MPG)** - After an eleven-day trial, a Butte County jury this morning found a man, who was on federal parole for child pornography, guilty of molesting two young sisters last year, when they were ages 10 and 7.

Joshua Chadwick, 40, of Oroville, was convicted of six individual counts of lewd and lascivious conduct involving the girls, along with a special enhancement for multiple victims. Butte County District Attorney Mike Ramsey

court and testified against him.

The trial prosecutor, Deputy District Attorney JJ Stark-Modlin, said, "Despite their tender years, the girls showed more bravery and resilience on the witness stand than most adults." Stark-Modlin gave special recognition to a pair of specialized comfort dogs, Micah and Reuben, who sat at the girls' feet while they testified in court. The Lutheran Churches of Yuba City and Elk Grove provided the dogs.

Ramsey said the girls, their older siblings and their parents moved into Chadwick's home last year after moving out of the home of said the girls, now ages 11 and age David Acuff, 38, of Oroville. Acuff 8, bravely faced their molester in is Chadwick's cousin and he is

currently pending trial for his earlier molest of the same girls when they lived with Acuff. Ramsey said the evidence presented at trial showed Chadwick targeted the girls as easy prey based on their previous molests at the hands of

Chadwick remains in custody with no bail. Chadwick faces up to 43 years to life in state prison at his pending sentencing hearing on May 5, 2021.

Ramsey said Chadwick was previously convicted of federal charges of possession of child pornography and sentenced to five years in federal prison in 2012. Evidence produced at this trial

included child pornography depicting the two sisters, which was found in Chadwick's possession. Federal prosecutors are preparing to prosecute Chadwick for this child porn, which could bring an additional 50 years of federal

Summer Carver, 36, the children's mother, last week plead guilty to four counts of Procuring a Child to Engage in a Lewd Act, and four counts of felony Child Abuse as a result of knowingly making her children available to Chadwick and Acuff. She is facing 19 years 4 months in state prison and is scheduled to be sentenced on April 28, 2021.

Ramsey praised the twelve deliberating jurors and three alternate juror for sitting through an emotional jury trial that was spread over 5 weeks. Noting that the jurors had to listen to and watch difficult evidence related to sexual acts with children, including the child pornography videos of the girls. Ramsey also noted, "Justice is never easy and is rarely swift, yet despite the length of the trial and the complications of the COVID-19 pandemic, Butte County residents are taking their job as jurors seriously and rendered a guilty verdict after deliberating for nearly three







Jayden Punzo paved the way for a 19-yard rushing touchdown by junior Ryan Smith and a 21-0 Bulldog lead at halftime.






