# City of Gridley Sued

GRIDLEY, CA (MPG) - On the first day of March 2021, a lawsuit was filed by McNeil Law Offices with the Butte County Superior Court against the City of Gridley.

The Walter P. McNeil, McNeil Law Offices are representing plaintiffs, Scott McMillan, Michael McMillan, Allison Woolbert and Tyrell Ford, all four of whom are, and have been, residents of Gridley throughout the time in question and are behind the initial filing of the complaint.

The language of the lawsuit lists 4 main complaints, which are outlined as follows:

- 1. PETITION FOR WRIT OF MANDATE Adoption and Imposition of Taxes in Violation of California Constitution Article XIIIZ 1 and 2 (b)(d), and Government Code 50076, 53722 and 53723 (CCP 1085).
- 2. COMPLAINT FORDAMAGES Unconstitutional "Taking" and Confiscation of Money/Property For Public Use Without Just Compensation in Violation of the 5th and 14th Amendments to the U.S. Constitution and Art I 19 of the Ca. Constitution.
- 3. COMPLAINT FOR UNJUST ENRICHMENT AND REFUNDS, With Ancillary Equitable Remedies.
- 4. COMPLAINT FOR DECLARATORY AND INJUNCTIVE RELIEF (Code Civ. Pro. 1060, 526).

The complaint attempts to establish as fact the following information in paragraphs 1-21. The language of the complaint states that City of Gridley, as electric utility provider, is constrained by the state of California Constitution Article XIII C to set rates that shall "not exceed the reasonable costs to the local government of providing the service." (paragraph 13). Following paragraph 13, the complaint attempts to establish the City's electric rate is "designed and levied in whole or in part 'for general revenue purposes" and not strictly electric services, causing the complaint to "have found unequivocally that fees "levied for general revenue purposes" are "taxes" (paragraph

14). With that, the complaint reminds that "In California a 'tax' must be approved by a vote of the electorate," continuing, "The imposition of an illegal tax that hasn't been approved by the voters, through excessive electric rates greater than the reasonable cost of electric service, or designed merely to extract funds for unrelated general revenue purposes, is an illegal tax and an unconstitutional condition placed on the receipt of electric services that residential customers simply can't do without."

Included as supporting evidence are minutes from past City Council Meetings, slides from a power point presentation made at a City Council Meeting in December 2 of 2019, and confirmation of transfer amounts from City Budget and financial records from the last 5 fiscal years.

Paragraph 19 alleges that "Plaintiffs estimate (without the benefit of discovery that will make the numbers more precise) that at a minimum the residential customers are paying what amounts to a "General Fund Tax" that is in a range of 15% to 20% of the electric rates charged in their monthly bills." The complaint goes on to allege that percentage could be higher, with, "data from the City would indicate the Electric Program is over-collecting beyond the Total Electric Program Costs in amount that roughly average at 30%" plus or minus.

The complaint reads "the persons in the class are so numerous, consisting of approximately 2,250 household accounts, that the joinder of all such persons is impracticable and that the disposition of their claims in a class action rather than in individual actions will benefit the parties and the court." "Plaintiffs are informed and believe that the damage to each Plaintiff is relatively small [ annualized damages to individual Plaintiffs estimates to be in a range of \$500 to \$1,000 per household account] making it economically unfeasible to pursue remedies other than a class action."

Mayor Bruce Johnson has said that he and his fellow Councilmembers cannot comment on the suit now due to that it has been officially filed with the Butte County Superior Court. At the time of this article, a hearing date had not been set.

# **Butte County Moves to Less** Restrictive **Red Tier 2**

**Butte County** Department of Public Health

**BUTTE COUNTY, CA (MPG) -**Butte County has qualified to move from Tier 1 (purple) to a less-restrictive Tier 2 (red) of the State's COVID-19 Blueprint for a Safer Economy, a shift that allows more businesses to reopen at reduced capacity and allows certain youth and adult recreational sports to resume with modifications. This change in tiers is effective as of 12:00 am on Wednesday, March

The data requirements to qualify for Tier 2 include a case rate of 4-7 cases per 100,000 residents with a test positivity rate of 5-8%. The current Butte County COVID-19 case rate is 7.3 cases per 100,000 residents with a 3.6% test positivity

While this is an encouraging move in the right direction, the more contagious B117 variant of the Coronavirus has been identified in Butte County There is evidence that this variant may be more severe. It is vital that we all continue to follow guidance to prevent the spread of COVID-19 and all its variants, including: wearing a mask, washing your hands, keeping distance from others, staying home if you are sick, and getting vaccinated when it is your turn.

BIGGS, CA (MPG) - On March 3rd, Biggs Unified School District Superintendent Doug Kaelin announced the re-opening of all BUSD schools and a return to full time in-person instruction by next week, March 15th.

Biggs Unified School District has been very diligent in adhering to Butte County Department of Public Health and Board of Education guidelines and has taken a cautious approach to re-opening classrooms. BUSD has slowly been bringing back various grades of instruction since it reopened, using hybrid schedules of distance learning and classroom instruction. Biggs Elementary is the last of the schools to complete the move to full-time in-person instruction.

Superintendent Kaelin says in a written notice to the public, families and students, "Although it is very exciting to think about students being on campus full-time, it also comes with a caution that we need to be very deliberate about returning students

to full-time in-person learning. Your child's safety remains the primary objective of the Biggs Board of Trustee's and Administrations of Biggs Unified School District. The number one priority for me is returning everyone to school safely so that we do not have to close again. I know that school closure can happen, but I'm going to do everything in my power to make sure that there will be very little disruption to the school day once we get going!'

He continues, "The district will provide transportation, but we encourage as many families as possible to bring students to school. Students from the same families may sit together, while others will need to be separated. All students will be temperature checked before being allowed on the bus and will be required to wear face

As of next week, Biggs Unified School District will join the ranks of the few districts in California that are open for inperson instruction. Students may finally feel a sense of normalcy as they return to their pre-COVID education schedules. ★

Ava Lee was the last living sibling, having all eight of her brothers and sisters already passing away along with both parents and her only son



Delgado crossed the finish 1st for the Varsity Girls' team and 4th overall. "Just keep up with the boys," was the encouragement by Coach Steve Allard. And she did just that.

Overall, the first-place finisher for the boys' varsity was Damian Mendoza Jr (12) at 20:47, 2nd was Gordon LaBuff (11) with 21:39, and Oroville's Wyatt Stanhope (10). All three had Janessa at their heels for most of the race. Her time of 21:55 was 36 seconds faster than her previous run at home against Sutter. Office of Assemblymember Frank Bigelow

SACRAMENTO, CA (MPG) - Assemblymember Frank Bigelow introduced two wildfire related bills, AB 910 and AB 912, to help prevent future catastrophic

"Last year, California faced its most destructive wildfire season," says Assemblymember Bigelow, "The Creek fire in my district alone burned over 300,000 acres. California cannot keep putting off the wildfire problem, it is time to start taking a wildfire prevention approach to legislation."

AB 910 would increase the Small Landowner Exemption from 100 acres to 300 and remove the restriction for usage while also authorizing the construction for temporary roads when needed. AB 912 would expand the Working Forest Management Plan from 10,000 acres to

its original 15,000.

AB 910 and AB 912 would create more accessibility to the programs and provide a better opportunity to conduct wildfire prevention efforts. Assemblymember Bigelow states, "These programs have existed for a few years now, but they are rarely used because of all of the restrictions on them. With all of the restrictions, people aren't able to conduct the necessary wildfire prevention efforts that they need to, making them more susceptible to catastrophic wildfires. These two bills are the solution as they provide a gateway for people to use them to the full extent the programs were created for."

#### Survey Confirms Erosion of Sierra Snowpack

Recording a fifth straight dry month, state surveyors report the Sierra snowpack has slipped further below average. Survey results released Tuesday showed the statewide snowpack at 61% of average, compared to 70% at the time of last month's survey. Farmers have been warned to expect low water supplies, and say they will have to leave land idle as one response to the dry conditions.

#### Farmers Look To Accelerate Wood-Disposal Alternatives

With a final decision having been made to phase out agricultural burning in the San Joaquin Valley by 2025, farmers seek alternatives for disposing of vineyard and orchard prunings. The state Air Resources Board voted last week to end the practice. Farmers can grind discarded wood and incorporate it into the soil, but that's not now possible in all cases. Farmers asked the board for help in developing alternatives for wood disposal.

### Pandemic Takes Toll On County Fairs

County fairgrounds face a cash crunch, as the pandemic forces ongoing cancellations of events. A number of county fair boards have already voted to cancel their 2021 fairs. Some fairs have made accommodations for junior livestock sales, so students can still market their animals. In other locations, fairs have pushed back their traditional start dates. in hope pandemic restrictions will ease in time.


#### U.S. Capitol Christmas Tree Will Come From North Coast

# **Another Chance to Act on Housing**

When he was running for governor three years ago, Gavin Newsom promised, rather absurdly, that he would spearhead a drive to build 3.5 million new housing units by 2025.

It was absurd because it would require California to escalate new construction from about 100,000 units a year to 500,000, which would be financially and physically impossible.

Once elected, Newsom backed away from that pledge, calling it "aspirational," but he did attempt, a year ago, to once again focus attention on the state's housing crisis by devoting nearly all of his State of the State address to it and the closely related homelessness issue.

Within weeks, however, his attention shifted to the COVID-19 pandemic and housing went on the Capitol's back burner.

Meanwhile, California's housing shortage has gotten significantly worse. This month, Newsom's Department of Finance revealed that just 102,800 residential building permits were issued in 2020, down 8.8% from 2019's total, which itself was a 3.8% drop from 2018.

Not only is overall construction headed the wrong

way, but all of last year's decline was in apartments and other forms of multifamily housing where shortages are the worst. Moreover, when housing lost to fires, old age and other causes is included in the equation, the net gain last year was only about 75,000 units, under half of the state's official yearly goal.

The cold fact that housing construction is headed the wrong way, and that housing shortages and high housing costs are feeding a high poverty rate and pushing employers and workers out of the state doesn't seem to be having much effect on the Capitol.

Newsom and other politicians talk a good game, but don't back up their words with action. What happened, or didn't happen, to last year's major housing bill is a telling example.

The measure, carried by Senate President Pro Tem Toni Atkins, was a modest stab at the housing issue's biggest roadblock - the notin-my-backyard attitudes in local communities. The bill would have made it easier to build duplexes and other low-impact multi-family projects on lots zoned for single-family homes.

Atkins' measure cleared the Senate easily and had enough votes to pass the Assembly. However, due to conflict between Atkins and Assembly Speaker Anthony Rendon over legislative procedures, it was held in the Assembly on the last night of the session until just minutes before the midnight deadline, leaving too little time for a final Senate vote.

Newsom could have intervened in the petty squabble to get the bill to his desk, but didn't, for reasons best known to himself.

The Legislature is back in session and its leaders and Newsom have another opportunity to match their words on the housing shortage with action – or not.

Atkins has introduced a new version of her failed bill, now known as Senate Bill 9, and others have proposed measures to speed up construction, most notably a four-bill package by Sen. Scott Wiener. The San Francisco Democrat has emerged as the Legislature's leading housing advocate with a willingness to challenge the reluctance of many cities to build their fare share of low- and moderate-income housing.

The most important of the four is Senate Bill 478. which would neutralize local ordinances that effectively prevent construction of multi-family projects on land zoned for them by imposing unworkable landto-building ratios.

The Atkins and Wiener bills challenge local governments' much-cherished powers over land use. which is the most contentious but most important piece of the housing conundrum. They also will test the willingness of California's political leadership to do something more than talk about the



Let me give you three times my Lord had a hand in saving me from death itself.





# Dear Dietitian

# Plateau

Dear Dietitian,

I've been doing a very clean keto/ Mediterranean diet for a year and have lost 105 lbs. I'm 11 pounds away from my goal and cannot seem to get there. I do intermittent fasting five days a week and cardio workouts 45-60 minutes a day. My carbs stay at 23 grams or less a day, 90 grams of protein, and I drink 65-80 oz of water. Any suggestions?

Dear Rita,

Wow! That's a fantastic weight loss! Congratulations! Just about everyone on a weight loss journey has experienced the frustration of a plateau. It's so hard to be patient, but you've come this far, so hang on a little longer. You will see results.

Although it sounds like you keep track of your food intake, write down everything you eat. You may find places where food is creeping in or times when you haven't made the best food choices. Also, take the time to calculate your caloric intake for at least three days. Aim for about 1400 calories a day. Of course, a caloric deficit is needed to produce weight loss, but being too restrictive can also result in muscle loss.

While cardiovascular exercise is a vital part of weight loss, consider replacing some cardio with strength training. Lifting free weights offers the most muscle-building potential, but using weight machines is fine, too. Muscle burns more calories than fat, so when muscle mass increases, the body burns more calories, even at rest. Muscle weighs more than fat but takes up less space, so your clothes fit better. Building muscle won't produce instant results in overcoming a plateau, so try to be patient.

Get plenty of sleep. Experts recommend getting at least seven to eight hours of continuous sleep each night. One theory is that ghrelin levels rise with inadequate sleep. Ghrelin has been dubbed the "hunger hormone" because it stimulates appetite and promotes fat storage. Hence, higher ghrelin levels may hamper weight loss efforts.

Finally, weigh yourself less frequently. Try not to focus so much on the scale. Being healthy isn't dictated by a certain number. It's about feeling better, reducing the risks of weightrelated diseases, and feeling good about your appearance. Be proud of yourself! Yours is already a success

Hrenko had been previously acquitted by an Alameda County jury for lewd acts on a different victim in 2014. Ramsey said that victim bravely testified before the Butte County jury to convince the jury of Hrenko's predatory nature.

Ramsey said under the current state of the law, Hrenko will not be eligible for release until he is 58 years old, at which time he may be evaluated as a sexually violent predator requiring indefinite commitment in a state

**BUTTE COUNTY, CA (MPG) -**Jail Inmate Found Guilty of Assaulting Another Inmate After a three day trial, a Butte County jury on Friday found a jail inmate guilty of seriously injuring a fellow inmate at the Butte County Jail in an August 2020 attack.

Cornelius Eugene McCauley, 28, of Chico was found guilty of assault with force likely to produce great bodily injury along with a special enhancement for great bodily injury.

McCauley was accused of an unprovoked attack in a housing pod at the jail, which resulted in the victim suffering

a fractured skull and repeated loss of consciousness. The victim was transported from the jail to Oroville Hospital for treatment and recovery.

Prosecutors presented evidence to the jury in the form of a jail surveillance video and testimony of a tower guard who witnessed the attack. The video showed McCauley "square off" in front of the victim inmate, a 49 year-old Oroville man in jail on a parole violation, then suddenly launch a vicious physical attack on the older inmate, beating him about the head.

No motive for the attack was ever definitively established.

McCauley was being held

in the jail pending sentencing for a series of car breakin burglaries in the Chico area between July 2019 and February 2020.

McCauley faces up to 16 years in state prison at his pending sentencing hearing on April 7, 2021, which includes an enhancement for a strike offense of robbery in 2014 in Sacramento.

District Attorney Mike Ramsey said Butte County is seeing increases of jail assaults due to recent reforms under AB-109 legislation and COVID-19 pandemic restrictions, both of which have contributed to jail over-crowding by limiting the transport of inmates who would otherwise serve time in state prison. ★

# Sheriff's Office Investigating in Custody Death

Office Press Release OROVILLE, CA (MPG) - On the evening of March 6, Michael Borgman, age 23, of Chico was arrested by the California Highway Patrol (CHP) for misdemeanor DUI charges. On the evening of March 6, Sherman Silva, age 43, of Oroville was arrested Department (CPD) for a felony arrest warrant. CHP and CPD subsequently Silva at the Butte County the influence of alcohol

Correctional deputies immediately responded and observed Silva and Borgman involved in an alterby the Chico Police cation. Correctional deputies immediately separated Borgman and Silva. Correctional deputies and booked Borgman and jail medical staff noted Silva was not responsive. Jail. Borgman was under and they immediately began providing Silva

with emergency medical treatment. Paramedics responded and provided additional emergency medical treatment. Despite the life-saving measures that were administered, jail medical staff and paramedics were not able to revive Silva.

Butte County District Attorney's Office Investigators and Butte County Sheriff's Office detectives responded to the jail and began conducting an investigation. During the investigation personnel located evidence indicating Borgman and Silva were involved in a brief altercation and Silva expired during the altercation. Based on the evidence obtained during the initial investigation, Borgman was placed under arrest for a felony count of murder. This is an ongoing investigation. Butte County District Attorney's Office Investigators and Sheriff's Office detectives are actively investigating this incident.

# **CAL FIRE Officers Arrest Multiple Suspects for Arson**

**BUTTE COUNTY, CA (MPG)** - In the early hours on January 11th, 2020, an occupied residence in Oroville, CA was set on fire in an intentional act of arson. During the same time frame, approximately 9 miles away in Gridley, CA, a vehicle was set on fire in another intentional act of arson.

Over the course of a year-long investigation CAL FIRE Law Enforcement Officers learned that Ember Lee Bert, Levy Dylan Williams, and Andrew Joseph Tune were allegedly responsible for the planning and commission of the crimes.

Arrest warrants were issued out of Butte County for Bert, Williams, and Tune for one count of Penal Code 451(b) arson to an inhabited structure and one count of 451(d) arson to property. Over the course of the last week all three have been taken into custody by CAL FIRE law enforcement officers. Tune and Williams have been booked into Butte County Jail and are being held on \$300,000.00 bail. Bert has been released pending future charges.
