

LOS ANGELES, CA (MPG) - Bobcats On heard reports of a Three, directed by Alison Taupier, is a fire nearby at around powerful documentary following the 8:00 a.m. A remote Paradise High School girls' basketball town on the crest of team after the most devastating fire in a hill, Paradise had California history destroys their entire town. ing to where she could see the fire, she quickly returned to the nursing home and began to help evacuate the 91 elderly residents, despite officials advising people to stay put.

By 8:30 a.m. the skies were dark, the whole town was on fire, and Sheila was stuck in traffic with three elderly residents in her car. After suffering a a borrowed gym with the remnants Sheila Craft was at her job at an flat tire and believing that she wasn't

going to make it, she started calling her family to say goodbye. They all managed to somehow miraculously escape when a man (an "angel") drove up and loaded all of them into his car.

This was the start of the Camp Fire and it burned for 17 days straight.

Community Calls for Council Leadership during COVID

GRIDLEY, CA (MPG) - As Gridley's new councilmembers acclimate themselves to service on the city council and learn the ropes of their positions, the opportunity has arrived for them to "make good" on some of their campaign promises.

At the Tuesday, February 16th meeting, council considered two agenda items that played a pivotal part of councilmember Angel Calderone's campaign. Recently, Gridley was invited to join the Butte County Behavioral Health Advisory Board (BCBHAB) meetings, a first. Although Councilman Calderon, who works with Butte County Behavioral Health, is required to abstain from any actions that could be considered a conflict of interest between his position at BCBH and the council, he urged council to take advantage of this "excellent opportunity." Acting City Administrator and Chief of Police Rodney Harr told council, "One of the goals of this board is to find the funding to set up an MCT, which is a mobile crisis team, for every one of our cities and towns in Butte County." Chief Harr explains throughout his service at GPD, previous requests to BCBH have met with little to no response.

Both Chief Harr and Councilman Calderon agreed that participating in these meetings, having a voice at the table, would go far towards breaking the cycle of mental illness related incidents and arrests.

Council voted unanimously to place Vice Mayor Mike Farr on the BCBHAB board and Councilmember Catalina Sanchez alternate.

Next, Councilmember Calderone addressed the council about item 3, his request that Gridley initiate a COVID-19 local intervention program to address COVID-19 concerns and education to our local community. Calderone proposed a program that would help support COVID education and training in Gridley and motivate local businesses to make a pledge to our community to strictly follow the CDC guidelines of masking, social distancing etc. Calderone cited Gridley's continued high case numbers, at one time in the highest case numbers in the county, and the huge impact COVID has had on our farm workers and migrant community. There would be no sanctions for businesses that chose not to participate. This item drew multiple

Paradise on Mars

GRIDLEY, CA (MPG) - Many watched around the nation as the Mars rover Perseverance landed on the rocky, red surface of our neighbor, the planet Mars last Thursday around 1:00 pm PST.

Unbeknownst to many, the Perseverance, NASA's largest, most advanced rover, carried with it an incredibly special homage to the town of Paradise. Onboard the car-sized rover destined for the Jezero Crater, the words "Paradise Strong" and "Town of Paradise, California" along with the names of the 85 souls lost to the 2018 Camp Fire were etched on two small chips embedded on the Rovers specimen retrieval arm.

A former NASA employee, Jerry Stoces, who influenced the inclusion of the town of Paradise



on this mission, says he and others at NASA and the Jet Propulsion Laboratory (JPL) were inspired by the sheer strength of Paradise and the perseverance to rebuild. In an interview with KRCR, Stoces says, "The NASA Team was very touched by how many lives were affected by this fire.... We felt terrible for the lives lost and wanted to do something special."

As a representative of NASA, Stoces visited Paradise in early 2020 to speak with the town and students about the mission to Mars set to depart that July and what the residents could expect. Students allegedly watched from their classrooms as the Perseverance set down on Mars, carrying its solemn cargo. As yet another tribute to Paradise, the Paradise Strong emblem for all time."

Pharmacists have always ranked as being the most trusted and loved professionals - even surpassing doctors and clergy (televangelist scandals of the '80s put pharmacists over the top). We soon found that as we took our animals into the ring to show off their superior muscle tone, enhanced genetic composition, and our excellent showmanship we would be thrown out, or given odd colored ribbons we didn't even know existedlike green and yellow. Amanda Gallardo the FFA Chapter Treasurer - always resourceful - came up with an FFA jacket that had been modified to no longer say Gridley on the back - it was emblazoned with "San Jose" (why San Jose we never knew - and Amanda told us to never ask.) We all took turns wearing it to the final rounds of competitions and soon we were back to our winning ways. Lisa and I laughed. and then I told Lisa how much I loved and admired her Dad - and that a day does not go by that I do not use some skill that he taught me when I was a young man. Gridley Couple Loves to Serve the Hungry

GRIDLEY, CA (MPG) - When Bob and Ione Cunningham began their missionary service, they walked into the intensity of Camp Fire recovery efforts. Little did they know that, a year later, COVID-19 would bring another layer of food insecurity to the communities they help serve.

The Cunninghams accepted the assignment to serve in the Bishops Storehouse of The Church of Jesus Christ of Latter-day Saints, located in the Chico Municipal Airport industrial complex. This Storehouse serves those experiencing food insecurity from Yuba City to Redding.

Their work began in March 2019, a few short months after the Camp Fire. Previously never open to the public, the Storehouse began serving the public five days a week. Walk-ins could fill out a food order and leave with a two-week's supply of groceries for their household. They served Camp Fire survivors, homeless, and others in need.

Three senior missionary couples constitute the staff at the Storehouse. The Cunninghams have served with couples from Orland, Willows, Oroville, and Yuba City, each couple serving two years.

When the economic effects of the pandemic began to hit families, the Storehouse saw an increase in need. In the beginning, the senior missionaries, any over age 60, were sent home. Younger Latter-day Saints filled in for a few months, including Libby Tolman and Kathy Sannar, both of Gridley.

Finally, in August of 2020, senior missionaries were allowed to return if they felt comfortable. Ione recalls, "Nobody didn't want to go back." The Cunninghams resumed their service, adhering to Covid precautions.

Along the way, the Storehouse turned their focus to commodities grants to area food closets and pantries. Storehouse commodities are now distributed to the Jesus

Hope Center in Oroville, and, locally in Gridley, St. Vincent de Paul (Sacred Heart Catholic Church), and the Butte Wildfires Distribution Center.

the work of individual household orders, for Latter-day Saints families and for other families. For such food orders, a family contacts the local Bishop, who authorizes the order, and the local Relief Society President completes and submits the order to the Storehouse. Cunninghams' son, Bobby Cunningham, is a bishop in Weaverville, CA. Ione noted that one day, she looked at an order, and there was her son's name and signature. "Oh, I know him," she thought.

Storehouse work includes receiving commodities, shelving, inventory, and filling orders. Computer work is required, and Ione shared, "The computer and I hated each other." She always hopes for the "perfect day," when the food deliveries perfeetly match the original food orders. "We've had two or three perfect days," she said.

The Cunninghams share the story of Rachel, who lost her home and place of employment, a dental office, in the Camp Fire. The first time she came to the Storehouse, she needed food for her and her husband. She felt so grateful for the help that she began volunteering each Tuesday, when the Storehouse fills most orders.

One week, Rachel didn't The Storehouse still does come. They learned from a mutual friend that she was in treatment for cancer. The Storehouse missionaries created a gift basket to let her know how much she was appreciated and missed. Rachel passed a few weeks later. In her memory, her husband requested donations for the Storehouse and was happy to deliver the resulting funds to the missionaries.

The Cunninghams recommend the Bishops Storehouse mission to anyone who wants to serve. "You can live at home and attend family events. I was able to help my niece after my sister had a stroke. And you're helping someone that really needs help."

The Cunninghams' service ends in March. Bob shares that the best part has been "The friends we make and the opportunity to serve. Seeing the people we serve, it makes me feel really good." He reports that they will continue volunteering, just not in an official missionary capacity. Ione shares, "It's a lot of fun, and we get to know the people we serve."

Determined, Sheila felt a drive to maintain some hope and normalcy for all of the kids, through all the trauma and chaos and disruption. The team had dwindled to just 14 players as the season began, therefore fielding just one Varsity team with only two seniors playing.

Through perseverance and personality, Coach united in their ambition to survive. As young athletes, as a team, they came together to create a bond to support each other on and off the court.

This triumphant season, through some of the most difficult moments, is a legacy that will never be forgotten. It is the story of triumph of will over adversity, of positivity over loss, of strength over pity. It is an inspiring story of resilience, courage and basketball.

The documentary is

produced by Flat-Out Films and Diamond Docs, directed and written by Alison Taupier, and produced by Michael Shevloff and Jeff Taupier. Executive producers are Paul Crowder Sheila created a team and Dashiell Hopper. Co-producers are Emily Kretzer and Ira Flowers. The film was edited by Sierra Neal, and the music was composed by Matter Music.

The film premiered at Big Sky Documentary Film Festival. Senator Dahle Questions State Contract Linked to Biden Campaign

SACRAMENTO, CA (MPG) - During a public hearing, Senator Brian Dahle (R-Bieber) forced the Administration and Legislative Leaders to admit that a contract the California Controller refused to pay for was included in a bill passed by the Budget Committee. Essentially, backdating the check for something Dahle believes was an illegal contract.

Last year, rather than providing budget dollars directly to counties, as legally required, for voter outreach efforts during the pandemic, the Secretary of State took it upon himself to contract with a political consulting firm with close ties to then presidential candidate Joseph Biden. The \$35 million contract is currently the subject of a legal battle with taxpayer groups for using funds without legislative authority for a new state-wide program, instead of assisting counties

Assembly Bill 85 is a budget bill that includes a \$35 million payment that the State Controller refused to pay because the Secretary of State authorized a voter information scheme instead of sending those funds directly to counties.

"For the Secretary of State to take dollars away from counties for his own voter outreach is underhanded and wrong," said Senator Brian Dahle (R-Bieber). "Besides, this \$35 million use of taxpayer dollars went to an obviously partisan contractor, which doesn't instill trust in the independence of the information or their focus on all voters."

AB 85 passed the Senate Budget Committee on a 12-3 vote, and was sent to the Senate Floor for a final vote.

public comments, most in support of the program, but one comment made by Orchard Hospital CEO, Steve Stark stood out. "I do support more of a community leadership role. We've definitely seen a somewhat dismal response to the vaccine..." He continues, "I think just a statement from the city that supports the initiation of the CDC and those of the Hospital would go a long way to support eradicating COVID for the City of Gridley."

Mayor Bruce Johnson questioned whether a COVID Intervention Program was really in the scope of practice for the City of Gridley and was concerned with attaching the intervention program to the city, especially when so much money has been spent at the state and federal levels to educate. Councilmembers agreed that the program was a good idea but would not officially get behind the project. With Mayor Johnson and Vice Mayor Farr voting "no" and Councilmembers Calderone and Sanchez voting "yes", the motion failed.

In other business, council voted 4-0 to


pause the interest accrual and granted a loan forbearance for the Community Housing Improvement Program (CHIP) loan from the City of Gridley that helps maintain and operate the Hazel Hotel. The Hazel Hotel is home to a senior apartment complex on its second story with retail lots on the floor level. Decreased business in downtown Gridley and COVID-19 impacts have strained CHIP's resources. Council granted a 2-year in the total of \$23,847.52 forbearance will allow CHIP and the Hazel Hotel to remain in operation.

Finally, Council considered the addition of a livestream/Zoom style platform to broadcast future City Council meetings to the public, a topic that has been brought to the Council multiple times by concerned community members. The current dial-in system is limited to one telephone device, making it difficult to clearly hear meetings. Chief Harr reports that in his research, costs can range between \$3,000-and \$25,000 depending on the system. The agenda item was postponed until later meetings due to the absence of Councilmember Zach Torres and for more study into the software.

Rising Interest in Home Gardening Boosts Seed Sales

As Americans have renewed their interest in gardening during the COVID-19 pandemic, farmers who grow seeds for home gardeners have seen demand increase. Farmers and seed companies say the more-popular seeds include specialty vegetables and herbs, pollinator-friendly plants and crops that grow well in small spaces. Farmers who grow seed for commercial-scale farms say that side of the business has been less stable because of pandemic-related uncertainties.

A new report says the value of most California-grown vegetable crops declined in 2020, as pandemic impacts echoed through markets. In an annual report, the U.S. Department of Agriculture says farmers of a number of vegetables found themselves unable to sell some of their crops, when sales to restaurants or other customers abruptly changed or ended. California remains the leader in U.S. vegetable production.

UCPublishes Food-Safety Guide for Urban Farms

Urban farms and community gardens that sell or donate food need to know about how food-safety laws apply to their operations, and the University of California has produced a guide intended to help. The free publication includes information on rules that pertain to urban agriculture in California. Along with explaining regulations, UC says the guide lists best practices to assure food safety for produce grown in urban settings.

Analysis Points to Farms' Role in Reaching Climate Goals

Forestland and farmland already contribute to carbon sequestration, and the American Farm Bureau says those contributions can rise as climate-smart farming practices increase. A Farm Bureau analysis of federal data shows reductions in agricultural emissions and the importance of finding new ways to capture more carbon in cropland and pastureland. Farm Bureau says climate goals need to be achieved without harming agricultural production.

What would Rush say? How will he interpret the events? And most importantly, what will Rush say we need to do next?


It wasn't even so much that Rush would tell us what to do. Instead, he would put the political

Prosecutors Feud over Criminal Sentencing Laws

The starkest aspect to California's evolution from has been an evolving attitude toward crime and punishment.

In the 1980s and 1990s, California became a national leader in increasing penalties for crimes large and small, symbolized by a three-strikes-and-vou're-out law calling for life imprisonment of repeat offenders. Not surprisingly, despite construction of many new prisons, they became horrendously overcrowded with inmates.

However, as California made its almost 180-degree political turn to the left over the last couple of decades, attitudes about crime also evolved, culminating in legislative acts, ballot measoftened the state's sentencing laws. The number of felons locked up in state prisons has dropped by at least one-third in recent years.

That said, what supporters call "criminal justice reform" is not universally accepted. Some law enforcement officials believe it's gone too far and has contributed to recent upticks in violent crime - a conflict now rippling through the state's local district attorneys.

who had been district attorney of San Francisco, challenged and defeated Los Angeles District Attorney Jackie Lacey and immediately issued new operational rules that downplayed punishment.

He prohibited his deputies from seeking the death penalty, prosecuting juveniles as adults, attending parole hearings or seeking "enhancements" that increase a defendant's a relatively conservative prison term. The union repstate into a blue bastion resenting those deputies sued, alleging that Gascón was ordering them to violate criminal laws, and won an initial judgement.

What really blew up the conflict politically was support from the California District Attorneys Association (CDAA) for the union position. In its supporting brief, the District Attorneys said Gascón's orders meant that "the voices of victims fall silent and the might of the state has failed its most vulnerable."

Last week, Gascón resigned from the organization with a two-page letter that he posted on Twitter, accusing the association of being racially insensitive, sures and administrative closed-minded about crimipolicies that repealed or nal justice reform and even corrupt.

"CDAA continues to be a member organization solely for those willing to toe the 'tough on crime' line," Gascón wrote. "For the rest of us, it is a place that fails to support us, our communities, or the pursuit of justice."

Gascón and several other like-minded district attorneys have founded their own group, the Prosecutors Alliance of California, to push for criminal justice reforms. It includes Gascón, In 2020, George Gascón, San Joaquin County's Tori newspapers.

Salazar, Chesa Boudin of San Francisco and Contra Costa County's Diana Becton.

Gascón's election and the burgeoning conflict with more traditional prosecutors is part of a larger phenomenon – a nationwide effort by left-of-center organizations to change criminal justice policies one election at a

Billionaire businessman George Soros is a major figure in the campaign, having donated millions of dollars to reform-minded candidates. The movement has scored some victories, such as Gascón's election, and also suffered some losses, such as a failed challenge to Sacramento County District Attorney Anne Marie Schubert.

The conflict also colors Gov. Gavin Newsom's selection of a replacement for Attorney General Xavier Becerra if he is confirmed as the federal health and human services secretary.

Newsom seemingly supports the criminal justice reform movement. He sponsored a ballot measure to make marijuana legal, has sped up reductions in prison populations and declared a moratorium on executions.

He could appoint a new Attorney General sympathetic to the Gascón-led faction, such as Oakland Assemblyman Rob Bonta, but such a move would carry some political risk. Were Newsom to face a recall election this year, as seems likely, opposition from police and prosecutors could be a critical factor.








OVEN STORAGE HAZARD

Cold and Flu

Dear Readers:

As we await our vaccination date for COVID-19, the thought of coming down with a cold almost seems harmless. Yet, the common cold is responsible for 150 million missed workdays each year in the United States. Many of us will head to the nutrition supplement aisle in an attempt to ward off these nasty viruses, but do these supplements really work? We investigated four of them, and this is what we found:

- 1. Elderberry In a study of 312 air travelers, those using elderberry had an average of a 2-day shorter duration of the cold and experienced fewer symptoms (1). More extensive studies are needed to confirm these results. Remember, several studies are needed before scientific value can be determined.
- 2. Vitamin C- In a meta-analysis involving more than 11,000 participants, 200 mg of vitamin C daily did not reduce the risk of getting a cold for the general population. However, the same dosage did reduce the length of the illness by about one day (2). The supplement must be taken every day to obtain this benefit, not only when you realize you are getting a
- 3. Zinc In a review on zinc and the common cold, researchers found that when taken within 24 hours of symptom onset, zinc reduced a cold by about one day, and the severity of symptoms was also reduced (3). It is important to note that excessive

amounts of zinc can cause copper deficiency, anemia, and damage to the nervous system. Furthermore, in 2014 the FDA warned against the use of zinc nasal sprays due to permanent loss of smell in more than one hundred people. For Adeline everyday collided into another, "I get distracted by everyday things like my pets and cars driving outside. It was harder to focus on online school because every single day was the same and with events never happening, it made distractions much more exciting. I would sit there blankly staring at my chromebook, daydreams going through my head." With possible television noises and beeps of gadgets around her, going to school may have felt like a day off. Days felt long and drawn out to her and other kids.. Without the routine of going to school everyday, and being social there was no reason to be excited. Adeline's description was the experience many kids in our country had. According to expert Carci Decandia, "Top distractions for students include social media, texting, television, and family, which can pull one's attention away from the task at hand and diminish productivity." These distractions happened even in homes that strongly valued education. Some with parents able to work from home, or others with kids trying to balance learning and babysitting younger siblings while parents were at their jobs.

It was another school day at home, a student sitting in "class", trying to understand the lesson being taught but in utter confusion. Days were filled with anxiety for a student who chose to remain unnamed. "Everyday was worrisome and I was scared for my grade," said the anonymous student, "The resources that were normally available to me were no longer there. Everyday I would try to get as many assignments done as possible so I would have less the next day, but I soon realized that made it harder to learn." During normal school if a student needed help they could easily go in to get help, there were After School Programs and you could work with other students, but being isolated at home made that impossible. Sometimes submitting an assignment felt like opening Pandora's box. Luckily for Anonymous the wifi worked, this allowed her to go to group interventions to get help, but this wasn't the case for everyone. With school being online and with limited ways to get help, information was hard to retain for many.

As a pandemic was raging school had to be online. Schools were making the best of it, but could never avoid issues like distractions, connection, and learning issues. 



PG&E to Release **Higher Flows Below Rock Creek and Cresta**

QUINCY, CA (MPG) - Pacific Gas and Electric Company (PG&E) will increase flows on portions of the North Fork Feather River on Sunday, Feb. 28, by releasing more water from the Rock Creek and Cresta dams. Those recreating in or near the on this part of the river are advised to be aware of the higher flows and to

The higher flows, known as "pulse flows," are done to mimic higher flows that would normally occur during typical winters and flush out sediment.

PG&E will gradually increase water flows to 1,000 cubic feet per second (cfs) out of the Rock Creek Dam, holding the higher flows for 12 hours, between 1 a.m. on Sunday, Feb. 28, and continuing until about 1 p.m. that day before gradually reducing flows to 150 cfs.

PG&E will also increase flows below the Cresta Dam, starting by gradually increasing flows before dawn on Sunday, Feb. 28 and release 1,000 cfs between 6 a.m. and 6 p.m. that day before gradually reducing flows that night to 100 cfs.

The two higher flows will be present along 15 miles of river between the Rock Creek Dam and the Cresta Powerhouse along Highway 70 in the Plumas National Forest in western Plumas County. Despite recent wet weather, the higher releases will still be necessary.

PG&E offers the following water safety tips:

Stay out of cold water. Sudden immersion in cold water can stimulate the "gasp reflex," causing an involuntary inhalation of air or water. It can even trigger cardiac arrest, temporary paralysis, hypothermia and drowning. When faced with swift water, even the strongest swimmers may be easily overwhelmed.

Many unseen obstacles can be lurking below the water's surface. Swift water can make these obstacles even more treacherous. Guided trips for inexperienced paddlers are strongly recommended.

Recreating in PG&E canals and flumes is strictly prohibited. Stay out of canals and flumes, which are very dangerous due to slippery sides, sub-surface obstacles, fast moving water, and transitions to full tunnels and pipes. For more water safety tips visit: www.pge.com/hydrosafety
