GRIDLEY, CA (MPG) - Depending on when you grew up in Gridley will determine what you call it, but the old building on has met its match. Literally. The building was burned down Monday, February 8th 2021 after serving as a training site for CALFIRE crews for the past two weeks. Inclement weather prevented it from being demolished Thursday, February 4th when the "Live Fire" evolutions began at the site. The Live Fire Training Exercise, organized by Battalion Chief Sean Norman, invited CALFIRE crews from all over the area to participate. CALFIRE was incredibly grateful to have the building for training. The word "invaluable" was used by many to describe the gravity of being able to train in a non-emergency situation. Chief Norman says "We have some training props that are great for us, but you cannot replace training on a real building and we're really appreciative of Gridley Country Ford, they own the building, for letting us come in and use it." FEMA: Can't Stay if You Can't Pay

GRIDLEY, CA (MPG) - The Gridley Relief Group held a meeting in order to determine their course of action in regard to the FEMA camp at the Gridley Industrial Park.

According to FEMA Voluntary Agency Liaison Bruce Yerman, the scheduled end of program for the FEMA park is May 12, 2021. There are currently 112 households at the park, which Yerman says is changing "almost daily at this point." Disaster Case Managers (DCM) and recertification advisors are working hard to help the remaining survivors currently living at the park find alternative housing prior to the May 12 deadline.

The contract with FEMA and the City of Gridley has already been extended multiple times. "What is unique about this disaster amongst all disasters in the nation is how long it has been extended," says Yerman. "This just isn't seen elsewhere in the United States. In part, that is because of the nature of the disaster."

The extensions buy survivors more time to find housing, but at a certain point, they start doing more harm than good.

The stark reality is that money is a huge motivating factor and as urgency grows, FEMA intends to use fines as incentive to straggling survivors that have not found housing yet. As of May 13th, anyone remaining at the FEMA park will be subject to fines and penalties that could cost \$2,000 and up, depending on their unit size. The fees would cover the cost of the pad the mobile units are on, their maintenance, utilities costs, etc. and would be a monthly incurrence on anyone still inhabiting a FEMA unit. Cost is based on the Housing and Urban Development rates for the number of bedrooms in the domicile.

According to Gridley Police Chief and Acting City Administrator Rodney Harr, on January 14th, the city entered into a 6-month contractual agreement to extend the FEMA lease until July 1st. That looks to be the final contract date, but the City of Gridley seems to be open to considering a potential extension past July 1st, 2021.

In the meantime, this information has left the community concerned about the survivors and their options come May 13th. Yerman says, "the park won't disappear overnight" but will survivors take to the streets due to their inability to pay fines? What about the Gridley Continued on page 2

Eckert Still Working for City of Gridley

GRIDLEY, CA (MPG) - Four months after his arrest for allegedly driving under the influence of drugs, Paul Eckert has been cleared of any charges after a blood test confirms the lack of any illegal drugs in his system.

Community uproar and calls for his removal in the wake of the incident with the California Highway Patrol and social media posts regarding a separate investigation into Eckert by Gridley Police Department caused Eckert to resign from his position as City Administrator and City Finance Director while Gridley City Councilmembers considered their course of action. The last information circulating in the public by way of the Council before

his resignation was that still under contract with the Mr. Eckert would be working from home for the City of Gridley until November 30th. After Eckert's resignation, the community assumed that Eckert and the City of Gridley had parted ways.

On Sunday, February 7th, City Councilmember Catalina Sanchez put a community update on Facebook, surprising the community with some information from the January 19th City Council Meeting. Councilmember Sanchez has been assigned to the Norther California Power Agency Committee, which requires the involvement of a voting Councilmember, City Attorney and City Administrators. During that discussion, it came to light that Paul Eckert was indeed

We have not been able to obtain a copy of the contract at this time, but from our conversation with relations with the NCPA Mayor Johnson, Eckert is to work approximately 20 hours a week, remotely and not at City Hall, not to exceed \$3,300.00 of compensation with no benefits, to facilitate work and business relationships between Gridley and the NCPA until a new City Administrator is hired, or other action is taken. Eckert's current contract can be severed at any time for any reason, according to Mayor Johnson.

Gallagher Co-Authors Bill to Eliminate Hurdles for Military Spouses/Veterans Seeking Employment

SACRAMENTO, CA (MPG) Assemblyman James Gallagher (R-Yuba City) has co-authored bi-partisan



Flavio R. Alfaro, 59, of Sacramento CA, a local chestnut farmer, former Marine and U.S. Olympic baseball player passed away January 27, 2021 at home with his wife after a short battle with pancreatic cancer.

"Flav" attacked life with uncompromising zeal, humor and generosity. For Flav, each day was a celebration to be enjoyed with his wife, family and numerous friends from across his life's journey.



That journey began in the Pacoima area of Los Angeles, where

his baseball speed and glove skills began to emerge at Polytechnic High School. After service in the United States Marine Corps, he returned to playing baseball at College of the Canyons and then for San Diego State University Aztecs.

He was then given the honor of a lifetime when he was selected as a member of the United States' first national Olympic baseball team in 1984. Flav played middle infield and travelled the country with many future Major League Baseball All Stars. The team played in the Olympics' demonstration baseball tournament during the 1984 Summer Olympics in Flav's hometown of Los Angeles, earning silver medals.

Flav was the 99th overall pick in the 1984 Major League Baseball First-Year Draft and played for several minor league teams, including the Durham Bulls. He was extremely humble about his baseball career, joking that it was over "once they put a wooden bat in my hand." When asked about his time plaving baseball, he preferred to tell stories of the fun he had, the friends he made and the lessons he learned -- never about any personal achievements.

After his baseball career, Flav worked in the recycling business and moved to Sacramento, where he met the love of his life, Suzanne. "Suz" would be at his side for nearly 30 years. Along the way, Flav recommitted to earning his college degree and received a Bachelor of Science in Business Information Management Systems from California State University Sacramento.

Flav's passion was spending time with friends and

family. The home he and Suz made was full of warmth, laughter, great food and wine. Their door was always open. He loved exercise, movies, music, books and sports. He loved to travel with his wife to wine country. He loved playing golf, poker and fantasy sports with his friends.

Flav was an accomplished storyteller. During countless leisurely times with friends and family, his tales and his long list of Flav-isms to describe everyday life would leave anyone crying in laughter. He enriched many young lives who all knew him for his "power hugs." He cherished the title of "uncle" and "tio." And he had a deep love for animals. He spent much of his time caring for his cats and dog, Lily "The Hammer".

Most recently, Flav managed Harrison's California Chestnut Farm in Gridley, owned by his mother-in-law Sandy and late father-in-law Paul Harrison. There too, Flav, Suz, Sandy, his sister-in-law Anastasia and brotherin-law Kevin ensured



State Lifts Suspensions of Half a Million Driver's Licenses

More than 400,000 Californians had their driver's licenses reinstated last month after an appeals court ruled that the state was illegally penalizing people who failed to appear in court on costly traffic tickets.

The lawsuit was part of a broader, ongoing effort by legal advocacy organizations to roll back California's traffic fines and court fees, which they contend disproportionately impact low-income residents and communities of color.

More than three million traffic infraction citations are issued in California every year, averaging between \$600 and \$700 each.

California has among the highest traffic ticket penalties in the country due to a litany of state and county add-on fees. A ticket for running a red light – which has a base fine of \$100 actually costs nearly \$500 because of state and local fees, and more than \$800 if the driver misses a deadline to pay or appear in court.

The ruling "limits this blunt instrument of punishing people for not taking care of traffic tickets when in reality, for many Californians, traffic tickets are simply too expensive to take care of," said Rebecca Miller, senior attorney at the Western Center on Law and Poverty, one of the organizations that sued the Department of Motor Vehicles.

"Like any state in the country, we have overpolicing of lower-income and black and brown communities in California."

Several Bay Area residents sued the DMV in 2016 when their licenses were suspended after they failed to pay a traffic ticket or appear in court. Last June, a three-judge panel in the First Appellate District ruled in their favor, deciding that the state inappropriately suspended the licenses of drivers without formal notices from traffic courts that their failure to appear was willful. As a result, the DMV lifted suspensions on 555,000 driver's licenses. Because some had additional suspensions for other reasons, about 426,000 motorists were eligible to have their licenses reinstated, according to the DMV. Legal aid groups - the Western Center on Law and Poverty, Bay Area Legal Aid, the Lawyers' Committee for Civil Rights of the San Francisco Bay Area and the East Bay Community Law Center represented the plaintiffs. The lead plaintiff, Guillermo Hernandez, local governments have of Richmond, had been ticketed in 2013 for not updating his driver's license information and driving without a valid registration, court records show. Hernandez said he tried to go to court to take care of the ticket but was told twice that clerks couldn't find it in the system. "Fifty percent is not necessarily meaningful to many of my clients who are homeless or completely destitute," said Waite-Jones, the East Bay Community Law Center attorney.

The court system administrator, Hoshino, recommends more substantial changes from lawmakers.

But he also worries about how California will make up the revenue for vital services if the fees are slashed. The state collected \$1.4 billion in court fines and fees - all cases, not just traffic-related - in 2018-19.

"If you're going to remove \$1.4 billion for state and local programs, you're either going to end up abolishing those programs or you're going to have to find alternatives,"

Fees Tacked onto **Traffic Fines**

Economic justice advocates and some government officials are examining court fines and fees as part of a national reckoning over racial disparities in the justice system. A growing body of data suggests black and brown drivers are more likely to be pulled over than white motorists, and they often face staggering bills for traffic tickets.

Records and interviews show fees in criminal court, including for traffic violations, have funded an array of services and projects in California, including court construction, DNA collection, emergency medical on her citation, her license was suspended. Kmetz ultimately went to court and got a \$78-a-month payment plan, records show. But the court did not notify the DMV to lift the suspension.

"I pleaded to have that license so I could pay my bills and look for work," she said. "I was working with two temp agencies who wanted nothing to do with me when I explained the situation."

Legal Aid attorneys stepped in and got the court to recall the failure-toappear notification. Kmetz was able to get her license back in October after six months without it.

"It was terrible. The anxiety of the whole dilemma...it was awful," she said, adding that she's since used her license to work as a driver for some delivery apps.

Pilot Program To Avoid **Court Appearances**

Lawmakers and court officials have taken some recent steps: They have eliminated license suspensions for failing to pay traffic tickets and developed payment plans.

The court system also developed a pilot project that makes it easier for low-income motorists to request a traffic ticket fee reduction. A website called MyCitations allows motorists to request a reduction online. The courts can consider a driver's income and other information on their ability to pay before deciding whether to lower a penalty.

The virtual ticket system was created so that motorists wouldn't have to appear in person at a courthouse if they wanted to get

How Long Will California Economy Languish?

As COVID-19 began surging through California a year ago, Gov. Gavin Newsom declared a state of emergency and ordered widespread restrictions on personal and economic activity to curb infection rates.

His actions immediately triggered a severe economic recession. California had been enjoying record-low unemployment just before the shutdown, 3.9% of the labor force, but within weeks the jobless rate quickly shot up to a recordhigh 16.4% as employers laid off workers.

Initially, there was a fingers-crossed hope that the recession would be what economists call a "V" - a two unpredictable factors deep plunge followed by an equally rapid recovery. However, as the public health crisis and the recession continued, it became apparent that it would be a "U" – a steep decline that reaches bottom, eventually followed by a gradual recovery.

Employment actually rebounded somewhat during summer and autumn months as Newsom loosened economic controls, although certain sectors such as tourism and travel continued to lag.

However, when infection rates, hospitalizations again late in the year - many holiday gatherings - Newsom clamped down again, businesses closed and joblessness again increased.

The state's official unemployment rate - the percentage of the labor force not working edged upward in December to 9% but when those who dropped out of the labor force or were involuntarily working part-time are included, the real rate is more like 15%.

Even without that adjustment, 9% is still very high and, according to the federal Bureau of Labor Statistics, the third highest of any state. Only tourismdependent Nevada and Hawaii are higher, with South Dakota and Nebraska at other end of the scale at

Overall, California has lost 1.5 million jobs in the last year of pandemic and economic turmoil, leaving a salient question hanging in the air: How long will California's pandemicinduced recession continue?

The answer depends on when and if vaccinations can tame COVID-19 and whether President Joe Biden and Congress pump additional billions, or even trillions, of borrowed dollars into the nation's economy.

Newsom's proposed 2021-22 budget projects, "Businesses are expected to continue to operate at limited capacity into 2021. Increased automation and a shift to online retailing will lead to permanent job declines in leisure and hospitality, retail, and other services."

The budget also implies and deaths shot upward that the bottom of the "U" will continue for some working for California thanks, probably, to too time, saying, "Nonfarm newspapers.

employment for California is projected to recover to pre-pandemic levels in 2025."

The millions of Californians affected by the pandemic's economic fallout are understandably worried about their futures and their angst is one of the drivers of a petition campaign aimed at recalling Newsom.

Whether from concern for his constituents or worries about a recall, Newsom is proposing "a broad-based recovery package to support businesses, individuals and job creation both during the pandemic and as the state recovers. It totals \$14 billion, including \$3.5 billion in immediate relief for individuals and small businesses disproportionately impacted by the pandemic."

While Newsom wants fast action from the Legislature, its fiscal advisor, Gabe Petek, wants a more deliberate and skeptical approach, noting that "unlike the federal government - which can run a deficit to pay for fiscal stimulus - the state must balance fiscal stimulus with other one-time and ongoing spending priorities."

In other words, a dollar spent on Newsom's economic recovery plan is a dollar that can't be spent on something else – unless, of course, the governor and legislators are also willing to raise taxes. As the pandemic, the recession and the recall campaign evolve, big state stimulus expenditures will be one of the year's more interesting issues.

Farm Employees Begin to Receive Covid-19 Vaccine

The work is just beginning to bring COVID-19 vaccinations to California farm employees, but inoculation clinics have been held on a number of farms. County Farm Bureaus around the state have been coordinating with local public-health agencies to arrange for farm employees to receive vaccines. Local task forces are working to reach farm employees in their native languages with information, so more can receive vaccines as supplies improve. Storms Add To Water Supply, Snowpack

The atmospheric-river storms that reached California last week brought mostly positive news for California farmers and ranchers. Farmers along the Central Coast, for example, say heavy rains slowed their work for a few days, but brought significant benefits to water supplies. The Sierra Nevada snowpack remains low, but the storms boosted the statewide average snowpack from 45% of average up to 68% in a week's time.

Number Of Organic Operations Grows

California retains its national lead in the number of organic farms and ranches, according to the U.S. Department of Agriculture. In an annual report from its Organic Integrity Database, the USDA says the number of certified organic farms and ranches in the state exceeds 5.000. California has more than two-and-a-half times the number of organic operations as the No. 2 state, Wisconsin.

Food Waste Could be Reused as Plant Food

Fermented food waste could be used to deliver beneficial bacteria to food plants. Research from the University of California, Riverside, found that beneficial microbes on crops "increased dramatically" when the food waste was added to plant-growing systems in a greenhouse. The researchers say the fermented food waste appears to help plants resist pathogens and could reduce carbon emissions from farming. *

Planning to Travel Internationally?

SACRAMENTO, CA (MPG) - If you are planning to travel internationally please be aware beginning Jan. 26 changes will be made to the Centers for Disease Control and Prevention (CDC) (CDC) travel mandates.

Effective January 26, 2021 the CDC will require all international air passengers entering the United States (including U.S. citizens and Legal Permanent Residents) to present a negative COVID-19 test, taken within three calendar days of departure, or proof of recovery from the virus within the last 90 days. Airlines must confirm the negative test result or proof of recent recovery for all passengers prior to boarding. Airlines must deny boarding of passengers who do not provide documentation of a negative test or recovery.

Supreme Court to Consider 2020 Election Challenge Lawsuits in February Conference 06 Feb 2021 | The U.S. Supreme Court on Friday scheduled several high-profile contest-ofelection lawsuits, including ones brought by attorneys Sidney Powell and Lin Wood, and the Trump campaign, for consideration at its Feb. 19 conference. According to a case listing, the lawsuits include Sidney Powell's Michigan case (20-815), the Trump campaign's Pennsylvania lawsuit (20-845) and Wisconsin lawsuit (20-882), the Pennsylvania lawsuit brought by Rep. Mike Kelly (R-Pa.) (20-810), and Lin Wood's Georgia case (20-799). All cases allege some form of unlawful election-related conduct affecting the result of the election, including expansion of mail-in balloting by elections officials changing rules in contravention of state election laws, lack of adequate security measures around mail ballots, issues with machine vote tabulation, and denial of meaningful access to poll watchers.

Biden administration's CBP revives 'catch and release' policy at border amid COVID concerns | 05 Feb 2021 | A perfect storm of events has the Biden administration's Customs and Border Protection on its heels in parts of Texas, forcing the agency to begin releasing newly arrived illegal immigrants back into U.S. cities as part of a policy known as "catch and release." This is the first time since the surge of 2019 that CBP has been compelled to revive the controversial policy. It raises concerns the Biden administration's softer, more welcoming approach will trigger a wave of migrants from Central America that could overwhelm the agency's limited detention capacity. The bill calls for the U.S. Attorney General to establish a licensing and registration system through the Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF), which would increase the federal government's ability to monitor gun owners' purchases and the location of their firearms by requiring them to inform the government of the "make, model, and serial number" of the firearms that they own and adds that the firearm owner must tell the government "where the firearm is or will be stored."

Dryer Safety

Doing laundry is most likely part of your everyday routine. But did you know how important taking care of your clothes dryer is to the safety of your home? With a few simple safety tips you can help prevent a clothes dryer fire.

Dryers should be properly grounded.


Check the outdoor vent flap to make sure it is not covered by debris.

Keep the area around your dryer clear of things that can burn, like boxes, cleaning supplies and clothing, etc.

Clothes that have come in contact with flammable substances, like gasoline, paint thinner, or similar solvents should be laid outside to dry, then can be washed and dried as usual.

FACT

- The leading cause of home clothes dryer fires is failure to clean them.
- Have your dryer installed and serviced by a professional.
- · Do not use the dryer without a lint filter.
- Make sure you clean the lint filter before or after each load of laundry. Remove lint that has collected around the drum.
- Rigid or flexible metal venting material should be used to sustain proper air flow and drying time.
- Make sure the air exhaust vent pipe is not restricted and the outdoor vent flap will open when the dryer is operating. Once a year, or more often if you notice that it is taking longer than normal for your clothes to dry, clean lint out of the vent pipe or have a dryer lint removal service do it for you.
- Keep dryers in good working order. Gas dryers should be inspected by a qualified professional to make sure that the gas line and connection are intact and free of leaks.
- Make sure the right plug and outlet are used and that the machine is connected properly.
- Follow the manufacturer's operating instructions and don't overload your dryer.
- Turn the dryer off if you leave home or when you go to bed.



Dear Dietitian

Internet Influencer

Dear Dietitian:

I suffer from binge eating. I hired an internet influencer who claimed to be a nutrition coach for people with eating disorders. He gave me a strict meal plan and exercise routine. I asked what I should do when I have cravings to binge. He said not to worry, just follow the meal plan. I told him I thought I needed more to eat, but he wouldn't adjust my calorie level. This whole plan ended in disaster for me. What can I do? He refuses to give me a refund!

Dear Cassy,

First of all, I want to say I'm sorry this happened to you. Unfortunately, these things happen with nutrition because there are so many "magic bullets" marketed by charlatans that people don't know what to believe.

Another reason for the confusion is many people do not realize who the nutrition expert is. A Registered Dietitian Nutritionist (RDN) is a protected title that ensures the professional is qualified. That said, other professionals are legitimate, but you may have to ask a few questions to determine authenticity. Ask about their education. They should have at least a bachelor's degree in nutrition or another related field. Ask about their credentials and state licensure. There should be no hesitation or defensiveness on the part of the nutrition professional. If there is, be warv.

Licensure is required to practice

nutrition in 47 states, Puerto Rico, and the District of Columbia. If your state requires dietitian licensure, you can report this incident to the state licensure board for dietitians. You may also report your experience to your state's Attorney General. The Better Business Bureau also receives complaints of this nature.

The good news is there is help. Binge eating is now recognized as an eating disorder. It is listed in the Diagnostic Statistical Manual (DSM) along with other eating disorders, such as bulimia and anorexia nervosa. This means you can receive treatment, and insurance will cover part of the cost.

Optimal treatment results are achieved through a team approach, and outpatient programs are available. Your team may consist of a physician, a dietitian, a psychologist, and an exercise physiologist. Each team member brings his or her expertise to deal with all aspects of the illness.

I recommend checking into Overeaters Anonymous (OA), a 12-step recovery group that uses the same steps as Alcoholics Anonymous (AA). In OA, it is suggested that you find a sponsor to help guide you through the steps. You will also decide on a food plan that works for you.

Equally important, you will find that you are not alone. There will be people with the same problem, and you may develop friendships on your road to recovery. Search the internet for meetings or call (505) 891. 2664. During the COVID-19 pandemic, there are numerous meetings online.

BUTTE COUNTY, CA (MPG) - Paul Eckert, 58, was stopped at 12:05 a.m. on October 3, 2020 by the California Highway Patrol in the city of Gridley for having no tailights. During the initial interaction with Eckert the officer noticed the physiological indicators that suggested he might be under the influence of a controlled substance, not alcohol.

A number of field sobriety tests were given to Eckert, which were not performed satisfactorily. This, combined with the physical manifestations, led the officer to conclude Eckert's ability to safely operate a motor vehicle was impaired. As a result Eckert was arrested for driving under the influence of a drug. A blood sample was collected and later analyzed, which revealed that Eckert had ingested a prescribed medication. No alcohol was detected in the blood sample.

Upon further investigation it was discovered that some of the rare and unexpected side effects of that medication (e.g. racing heartbeat) were the same as those observed by the officer and mimicked the symptoms of commonly abused drugs. Furthermore, there was an absence of other evidence of impairment, such as poor driving. The district attorney's office has therefore declined to charge Eckert with driving under the influence, which requires a knowing ingestion of drugs known to cause impairment in a driver's ability to control a vehicle.



City Administrator Paul Eckert Found Innocent

GRIDLEY, CA (MPG) - Test results have proven that former City Administrator Paul Eckert did not have any alcohol or drugs in his system in October when pulled over in Gridley by the Highway Patrol. Charges have been dismissed. Court proceedings had been repeatedly delayed due to COVID19.

Mr. Eckert is now considering legal action against the Highway Patrol for the botched process and his family's long-term loss of employment income. Eckert said that he's worked very closely with law enforcement for 30 years and had never heard of such terrible performance.

Eckert was making the 5-minute drive from his home in Gridley to I told the officer he was his office at Gridley City Hall to collect some necessary items required to work on City business at home. It's well known that Eckert worked 50 to 60 hours weekly, including weekends and late nights. Eckert was pulled over going east bound on Sycamore Street, near City Hall.

Eckert assumed it was Gridley PD. He introduced himself, thinking it was a GPD Officer. Eckert said that "he and others consider it unusual for the Highway Patrol to be working in the middle in baseless and highly of Gridley". Within two minutes he was asked to take a field sobriety test.

Eckert has said that "they were trying hard to find something wrong when there was clearly nothing wrong". The field testing showed zero alcohol. "It was bizarre that they then wanted to assume I was on meth.

Looming Tax Tsunami Requires Immediate

SACRAMENTO, CA (MPG)

- A massive change to property tax law is coming soon that could cost families thousands of dollars a year and affect how parents and grandparents pass down properties through generations.

Proposition 19, passed California voters by last November, makes major adjustments to the "parent-child" and "grandparent-grandchild" exclusions, all to the harm of taxpayers. Prior to Prop. 19, parents and grandparents could transfer their principal residence to a child or grandchild with no value limit and without adjusting the property tax base-year value, meaning that the child or grandchild would not be saddled with a huge new property tax assessment when they became owner. The person receiving the property could live there, rent it out, use it as a second home, or let it sit empty there were no restrictions on property use to qualify for the exemption.

Prop. 19 changes all of that. Once the new law goes into effect on February 16, 2021, the unlimited value provision disappears. The new formula will be the current taxable value of the property plus one-million hit many coastal property

Californians. Under Prop. 19, a person receiving property under one of these exclusions must now use the property as their primary residence to qualify. That means if you have moved to a different city, you would have to move back and occupy the home to receive the exemption. It means that if you are happy with your current home, you would have to give it up and move to qualify for the exemption.

The date these changes go into effect is right around the corner. If you are planning on transferring property to a child or grandchild, please be aware of the very different landscape that awaits you and them after February 16.

There are a thousand unanswered questions regarding these changes that are not clarified in the proposition language. What happens if multiple children receive a property but only one makes it a primary residence, for example? What happens if someone qualifies for the exclusion, then moves out of the primary residence for a time, then moves back in? Does the exemption kick back in or is it lost forever? It was an initiative written with little concern for detail.

Proposition 19 does dollars. This change will provide some new and welcome benefits for California

year transfers. Taxpayers can now also use that transfer provision three times instead of the one-time, geographically limited use in prior law.

Although I favor the baseyear transfer provisions, I oppose this new tax increase, which will take hundreds of millions of dollars a year from Californians inheriting their family's biggest asset. But it's now the law, and as a Board of Equalization Member and taxpayer advocate, I will be seeking to identify every area where Prop. 19 is unclear and am committed to working with the legislature, county assessors, tax professionals and taxpayers to ensure effective administration of this new law

SACRAMENTO, CA (MPG) California Senate Republicans are concerned about the looming tax tsunami facing unsuspecting and unemployed Californians stemming from mismanagement and fraud in the state's Unemployment Insurance program. Senate Republicans delivered a letter to Governor Newsom urging him to take immediate action to help those innocent victims.

receiving 1099-G tax forms summarizing their taxable earnings from unemployment benefits. Not only will the tax bill come as a shock to recipients, there is a distinct possibility many victims of fraud will be left on the hook for taxes on money never received. The Employment Development Department (EDD) has struggled to do even the slightest thing right during the pandemic and to think this agency could straighten this out on its own prior to tax day is unfathomable.

By the end of 2020, EDD had paid out \$10.4 billion in benefits to claimants whose identities were unverified and that figure could climb as high as \$30 billion. This resulted in frozen bank accounts, stalled benefit payments and a variety of other problems each of our offices has been tirelessly working to help these individuals with over the last ten months. The Auditor's report last week

underscored Californians' worst nightmare by pointing out the potential problems with regard to tax liability. Without immediate action by the Governor and our federal representatives, innocent people will be left to fight the IRS over tax liabilities for benefits they never received.

Senate Republicans share the auditor's concerns, and want to ensure the Newsom Administration is taking every action possible to enact the auditor's recommendation to promptly assist victims of identity theft and help them avoid Californians will begin tax liabilities for unreceived benefits. April 15 is just a few months away and Republicans are rightfully concerned the agency will be unable to effectively address this new challenge.

... As we enter the tax filing season, many Californians will be surprised to learn that they have tax liabilities for UI benefits that were fraudulently claimed in their name. This is because 1099-G forms will soon be arriving in the mailboxes of taxpayers who were victims of identity fraud. Even more concerning is that there will be victims of identity fraud who will have no idea why they even received one of these forms until after they file taxes. This is because EDD is generally going to mail the 1099-G to the most recent addresses of record, which


are the ones the bad actors used to obtain UI benefits.

The State Auditor shares our concern for the tax liabilities for victims of this identity theft and recommends that EDD should prepare to assist victims of identity theft to ensure that they receive prompt assistance and avoid tax liabilities for benefits they never received. Specifically, the auditor recommends that EDD must prepare to respond to victims of identity theft who receive incorrect tax forms, and should, by mid-February 2021, provide information on its website and set up a separate email box for such individuals to contact EDD and receive prompt resolution. We wholeheartedly agree with this recommendation, but remain skeptical about the agency's ability to do it effectively, if at all. Our offices are currently hearing from the same amount of constituents as we did last spring, who are seeking help from EDD because of problems with identity verification, backlogged claims, and frozen accounts. ...

Last week, Senate Republicans requested legislative leadership for an immediate oversight hearing to discuss ways to implement the State Auditor's recommendations. An oversight hearing was held on Wednesday, February 3 with the Joint Legislative Audit Committee (JLAC) and the Assembly Insurance Committee. **★**
