**GRIDLEY, CA (MPG)** - Animal Control Officer Sam Stopplemore says that Gridley's Animal Shelter is in need of supplies year-round, but that they are taking advantage of the lull in traffic caused by the recent drop in temperature to prepare for a busy spring

# **Proposition 19 Puts** Family Legacies at Risk

### SACRAMENTO, CA (MPG)

- A massive change to property tax law is coming soon that could cost families thousands of dollars a year and affect how parents and grandparents pass down properties through generations.

Proposition 19, passed by California voters last November, makes major adjustments to the "parent-child" and "grandparent-grandchild" exclusions, all to the harm of taxpayers. Prior to Prop. 19, parents and grandparents could transfer their principal residence to a child or grandchild with no value limit and without

Continued from page 1 16, 2021, the unlimited value provision disappears. The new formula will be the current taxable value of the property plus one-million dollars. This change will hit many coastal property owners in the pocketbook as they inherit or receive property that appreciated wildly in California's multi-decade housing boom. Modest homes in Silicon Valley neighborhoods owned and transferred by middle-class families will face stratospheric tax bills under the new regime.

As bad as that will be, it is another provision that is more likely to cause havoc and financial loss for many Californians. Under Prop. 19, a person receiving property under one of these exclusions must now use the property as their primary resif you have moved to a dif- homeowners who want home to receive the exemption. The date these changes go into effect is right around the corner. If you are planning on transferring property to a child or grandchild, please be aware of the very different landscape that awaits you and them after February 16.

There are a thousand unanswered questions regarding these changes that are not clarified in the proposition language. What happens if multiple children receive a property but only one makes it a primary residence, for example? What happens if someone qualifies for the exclusion, then moves out of the primary residence for a time, then moves back in? Does the exemption kick back in or is it lost forever? It was an initiative written with little concern for detail.

Proposition 19 does provide some new and welcome benefits for California taxpayers, most notably that it allows certain property owners to transfer their base-year tax assessment to idence to qualify. That means all 58 counties. This allows

### **Auditor Exposes Governor's Funding Inequities**

SACRAMENTO, CA (MPG) - The California State Auditor published a report investigating the state's disbursement of the \$9.5 billion provided in the federal CARES Act's Coronavirus Relief Fund (CRF) to counties. The report uncovered that large counties with more than 500,000 residents received nearly double the CRF dollars per person than did small counties.

Assemblywoman Megan Dahle (R-Bieber) issued the following statement regarding this report:

"The State Audit released today confirmed the sentiment of distrust and unequal treatment many of my rural counties have felt for years, as the state continuously favors large counties at the expense of rural Californians. The disbursement of COVID-19 relief funds is only further proof of this systemic problem.

"While large counties got their funds expeditiously and nearly double the amount per person than did small counties, the 42 counties with fewer than 500,000 residents were forced to beg and plead with the Governor to get their entitled funds. Rural counties were financially bleeding trying to keep up with the demands of COVID-19 response, but the Governor held their CRF dollars hostage in order to extort compliance with his COVID-19 guidelines. This further delayed funds to the point that some rural counties received this money just two months before the December 31, 2020 expenditure date.

"It is unconscionable that some Californians received nearly double the CRF funds than others, depending on their zip code. While COVID-19 did not discriminate in the communities it ravaged throughout California, our Governor did. The 42 counties that were grossly underfunded must be immediately reimbursed for the funds they were denied, and the state must correct this unequal funding formula that discriminates against small counties for any future disbursement of federal relief."

In May of 2020, Assemblywoman Dahle co-signed a bipartisan letter to Governor Newsom calling for him to release the CRF funds to counties with populations under 500,000.

Assemblywoman Megan Dahle represents the 1st Assembly District in the California Legislature, which includes portions of Butte and Placer counties, along with Lassen, Modoc, Nevada, Plumas, Shasta, Sierra, and Siskiyou counties.

Last night, a resident in the 10000 block of N Street heard what they believed to be a mountain lion on their property. Both occurrences were during the night. Fish and Game has been contacted and made aware of the occurrences.

A little information on mountain lions: As the mountain lion population increases there is a potential for increased sightings. Sub-adult lions will branch out and try to

establish their own territory.

This lion is probably trying to find a new territory and will eventually settle somewhere in the river bottoms or the Buttes. Sightings during the night time hours tell you it's typical nocturnal lion behavior. It's a lion being a lion at this

Day time sightings in residential neighborhoods could be concerning, as lions are not typically active during the day and there is obviously potential for more human/wildlife interaction during the day.





### **Five Arrested During Storage Unit Burglary Investigation**

**Butte County Sheriff's Office** Press Release

CHICO, CA (MPG) - Over the past several months, Butte County Sheriff's Office (BCSO) deputies have been investigating storage unit burglaries that have occurred in the Chico area. On January 2, 2021 Deputy Voris contacted Chad Parras, age 49, of Chico, at a storage unit facility located on Highway 32. Deputy Voris determined Parras was on Post Release Community Supervision (PRCS). After conducting a search of Parras' vehicle, Deputy Voris located evidence showing Parras had committed burglaries at a storage unit facility located on Highway 32. Deputy Voris placed Parras under arrest for violating the terms and conditions of his Post Release Community Supervision, and for a felony count of burglary.

After the arrest of Parras, Deputy Voris and Detective Mollath determined Parras was storing additional stolen property at a storage unit in the Chico area. Detectives obtained a search warrant for the aforementioned storage unit. During the execution of the search warrant, property taken during two additional storage unit burglaries was located. Based on the investigation, Parras was arrested for an additional two felony counts of burglary.

During the follow-up investigation, deputies located evidence indicating Matthew Myers, age 35, of Chico, was involved in the aforementioned storage unit burglaries. On January 11, 2021 deputies served a search warrant at Matthew Myers' residence, which is located in the 10,000 block of Lone Pine Avenue, Chico. Myers was in custody at the Butte County Jail on a separate criminal case during the service of the search warrant. During the service of the search warrant deputies located numerous items of stolen property.

In December of 2020, deputies and detectives obtained evidence indicating Myers was responsible for forging checks from a local Oroville business. During this investigation additional evidence indicating Myers was responsible for the aforementioned check forgery was located.

During the investigation, deputies obtained evidence indicating additional stolen property was being stored at two additional storage units in the Chico area. On January 12, deputies served search warrants at the aforementioned storage units. During searches of the storage units additional stolen property was located. To date, deputies have located over \$25,000 of stolen property and have identified approximately ten different victims.

As a result of this investigation the following individuals have been arrested:

### **Escaped Inmate Back in Custody**

Berry's original charge was for felony burglary, to which he had added a felony charge of escaping from a custodial facility. Margetts was booked into the Butte County Jail for a felony count of conspiracy and a misdemeanor count of possession of narcotic paraphernalia.

### After Covid-19, Drought Threat Still Looms

California is enveloped in balmy weather that's more like spring than midwinter – and that's not a good thing.

We have seen only scant rain and snow this winter, indicating that the state may be experiencing one of its periodic droughts and adding another layer of crisis to the COVID-19 pandemic and economic recession.

The all-important Sierra snowpack, California's reminder that although Pass. A San Luis-like projprimary source of water, pandemic and recession is scarcely half of what is deemed a normal depth.

"The snow survey results reflect California's dry start to the water year and provide an important reminder that our state's variable weather conditions are made more extreme by climate change," the state director of water resources, Karla Nemeth, said after the disappointing Dec. 30 snowpack survey. State Water Project customers have been told to expect only 10% of their requested allotments in 2021.

The state is so dry that this week Southern California Edison and Pacific Gas and Electric temporarily interrupted power to thousands of customers, fearing that high winds could down power lines and spark devastating fires.

Gov. Gavin Newsom's this month, warns that California, already hit by devastating wildfires in recent years, is in grave danger.

"In 2020, 9,000 wildfires burned over 4 million acres across the state, more than the 2017 and 2018 fire seasons combined and significantly higher than the most recent five-year average of acres burned," the budget says in proposing new firefighting expenditures. "Hotter, drier conditions in the state's forests, driven by climate change and the consequences of a century-old legacy of fire suppression, have generated unparalleled fuel conditions that result in significant wildfire risk."

The situation is a dominate Californians' consciousness now, with good reason, older threats still must be confronted.

Clearing fuel, "hardening" communities against wildfires and expanding firefighting capabilities are all expensive necessities, as the budget proposes. At the same time, we must also build more resilience into a water supply dangerously dependent on an assumption that winter storms will always refill the natural reservoirs of mountain snowpacks.

With climate change, even normal levels of precipitation will be more in the form of rain and less in the form of snow, thus reducing that natural reservoir. Therefore, we must, in addition to pursuing water-saving and reuse strategies, create more storage.







### **Are You Prepared** to Evacuate in an Emergency?

When stuff hits the fan and you need to flee your home, being organized is the best way to protect your home and family.

If there comes a time when you have to abandon your house, an emergency probably won't give you enough time to gather essentials and take steps to limit property damage. Getting all of your ducks in a row before disaster strikes is the best

Evacuations in the U.S. are more common than most people realize, according to FEMA. Natural disasters aside, people are forced to leave their homes hundreds of time a year because of transportation and industrial accidents.

Here's a list of things you can prepare now in case your home is ever in

Have a grab-and-go kit. Include essential supplies, such as water, food, and first-aid supplies.

#### What to Put In Your Emergency Preparedness Kit

• Your driver's license. • The deed to your house. • Proof of insurance. • Medical records. • Passports. • Social security cards. • A list of personal contacts.

Safeguard pets. Make sure they're micro-chipped and have I.D. collars. Create pet grab-and-go kits that include leashes, medications, meal bowls, and three days worth of food and water. Know your utility shutoffs. Learn now how to safely shut off all utility services in your home. FEMA has tips for shutting off electricity, water, and gas. Note: To turn off gas you may need a special

Stock pile sand bag materials. If you live in a flood prone area, keep sandbags on hand or the materials to make them. It takes 100 sandbags to create a 1-foot-tall wall that's 20 feet long. If you're filling bags on the fly, two adults can create the wall in about an hour.

#### When it's Time to Evacuate

Before you pick up and go (and if you have enough time) follow these steps - they're designed to protect your pets and help prevent property damage:

Shut off utilities. Turn off electricity, water, and gas. Doing so will help prevent additional dangers including flooding, fire, and explosions. Keep in mind, you're going to need the utility company to turn your gas back on when you return home.

Protect indoor stuff. Move valuables to higher levels in your home to prevent water damage. As an extra measure, wrap electronics and furniture in sheets, blankets, or plastic drop cloths.

Gather up pets. If it's not safe for you to stay, it's not safe for Fido. Make plans to stay with friends or at a pet-friendly hotel - most emergency shelters will only accept service animals that assist people with disabilities.

Lock your house. Because crooks and looters take advantage of evacuations, lock all doors and windows and don't leave house keys in an obvious place, such as a mailbox.

#### Important Stuff to Remember

Whether the order is voluntary or mandatory, if officials in your area tell you to evacuate, you should do so before things get worse. Although laws vary from area to area, you may receive a hefty fine or face a jail sentence if you don't follow a mandatory evacuation order.

Failure to follow an evacuation order can place your life in danger by leaving you stranded in an area with no basic services or food and water.

When you return home after an emergency, don't use matches, lighters, or any sources of flame or spark until you're 100% certain that you don't have a natural gas leak inside your home - you'll need a gas company service technician to confirm that it's safe.

#### Stay Informed with Emergency Alerts



Smartphone technology has made it easier to receive disaster alerts free of charge. You'll automatically receive alerts if you have a phone capable of receiving Wireless Emergency Alerts (WEA) and your wireless carrier participates in the program. To find out if your mobile device is capable of receiving WEA alerts, contact your mobile device carrier or visit CTIA - The Wireless Association.

### Dear Dietitian

### **Detox Diet**

Dear Dietitian:

I made a New Year's resolution to eat healthier. A friend told me to try a detox diet, but that seems rather extreme to me. What do you think?

Thank you, Brad

Dear Brad,

You are among the 51% of Americans who have resolved to eat healthier in 2021. Congratulations on your new endeavor! Some will choose a detoxification (detox) diet to get started on a healthier road. Traditionally, the term detox was used in reference to a medical process of ridding the body of dangerous levels of drugs or alcohol. Today detoxing, or cleansing, is used in a broader sense and refers to ridding the body of

A typical detox diet requires fasting, followed by a diet of fruit and vegetable juices, tea, smoothies, water, and juices. Some cleansing diets use herbs and supplements. These diets claim to eliminate toxins, boost energy, improve sleep, improve health, and support the immune system. A quick internet search found commercial detox diets in the \$100-\$200 range. You could probably find an internet guide to cleansing at no cost.

The practice of detoxing dates back thousands of years. Many place its origin in India as a part of Ayurveda, an ancient form of medicine. Some Native Americans still use aromatic rituals with food and herbs to help cleanse the body.

Let's define toxin in terms of the human body. A toxin is a harmful substance produced within living cells or organisms. Anything, even water, can be a toxin in high enough levels. The body is continually releasing toxins through sweat, urine, and feces. Toxins can come from outside the body as well. Examples are smoking, alcoholic beverages, and toxins that cause foodborne illness.

There have been some studies that found certain cleansing agents helpful. A commercial detox product was studied to determine if it released higher levels of caffeine compared to no treatment. It did release a higher amount of caffeine, but it was not a significant amount (1). To my knowledge, there are no randomized controlled studies (RCTs), the gold standard of research, on detox diets.

Our bodies have an amazing detoxification system in place. Two of its major players are the liver and the kidneys. The liver neutralizes harmful metals like mercury so the body can eliminate them in the urine. The liver also produces enzymes that metabolize drugs and protect against dangerous levels. The kidneys act as filters to eliminate harmful substances in the urine.

If you choose a detox plan, consider limiting it to three days and definitely no more than five days, as nutrient deficiencies can occur. As for me, I'm sticking to whole foods from every food group.

# Inspiration for Revitalization

BIGGS, CA (MPG) - The main drag through the town of Biggs is incredibly charming but not all areas are aesthetically pleasing. That is why local business owner, Marci Shadd, has thrown out a line of inspiration to her community and is hoping to get a few bites.

The ambitious owner of the Hotel Colonia has spent the last 5 years renovating the crumbling historical site just because she says, "we were hoping to save this small landmark from just being another demolished building." Her experience has generated an intense passion for restoration, especially the revival of Biggs, and thus she found herself taking a class called "Rural Revival Challenge" alongside others that share her interests. Her classmates hail from about 18 different states and all are involved in the leadership of a small town, a group project like "Project Biggs" or own their own historical properties. Shadd shares, "We all face unique and similar problems... most of us all struggle with downtown empty buildings and how to utilize them in the best possible manner so that the community is flourishing and not crumbling."

Shadd says she personally has been working on the perception of visitors coming into Biggs, "We love our town and want our people to be proud of it! .... The drive from the highway to downtown Biggs is so pretty, but once you get past the hotel building, it is very apparent that we have crumbling infrastructures and a serious lack of downtown businesses."

A quick, colorful, and easy way to beautify an area, tried by one of Shadd's classmates, was to paint murals in dilapidated areas. The effort is part community donation and part talent; Businesses and people can contribute to paint and supply costs, while local artists volunteer their time and skills to create visually appealing

works of art on the sides of business buildings (with owners' permission of course).

Shadd thought a little visual would help and used her photoshop skills to create some inspiring "before" and "after" images of downtown Biggs with murals in unsightly areas. She is looking for property and business owners

She says, "Other communities revitalize their downtown areas and flourish and who's to say it can't be done here? I'm going to take the optimistic road here and say it could happen!"
