Recognition of our Vietnam **Era Veterans**

GRIDLEY. CA (MPG) - Feather River Chapter Daughters of the American Revolution (Oroville) are proud partners with the 50th Anniversary United States of America Vietnam War Commemoration.

The intent of this Commemoration is to offer the thanks of our nation to as many as possible of the 7 million living Vietnam veterans and the 9 million families of those who served from November 1, 1955 to May 15, 1975.

Across the country, thousands of local, state and federal organizations, along with non-profit organizations just like ours have become Commemorative Partners. Since this Commemoration began, more than 1.4 million have been welcomed home in ceremonies.

In November 2019, with assistance from Owen Stiles, Commander of American Legion Post #210 in Gridley, plans were formulated to honor our Butte County Vietnam War veterans. Invitation letters were distributed by Commanders of the American Legion and VFW Posts throughout the county. The date of March 29, 2020 (Vietnam Veterans Day) was set and the Gridley Veterans Memorial Hall was secured for the presentation. There were to be 61 veterans in attendance along with 41 family members. After months of preparation, our event had to be canceled due to COVID-19. COVID Outbreak at Orchard Hospital

GRIDLEY, CA (MPG) - Orchard Hospital is currently responding to an outbreak of COVID-19 cases in both staff and patients. On November 25th, 2020, regular weekly testing of staff began showing higher than normal positivity rates. The number of positive results warranted the testing of all patients admitted in Orchard Hospital as well as its skilled nursing facility, also known as Hovlid Community Care Center (HCCC). In total, 16 staff, including some agency staffing, and 32 patients, tested positive for COVID-19.

"Just like every hospital in the country right now, we are caring for COVID-19 patients within our hospital. We were successful for many months of maintaining an almost zero infection rate, but despite our best efforts, COVID-19 has found its way into our hospital," Steve Stark, Orchard Hospital's CEO, says.

Orchard Hospital is a 24-bed general acute critical access hospital with

an 82-bed distinct part skilled nursing facility. Orchard Hospital provides emergency, inpatient, and outpatient services to many communities in and around Butte County.

"We are praying for quick recoveries for our staff and patients," Stark concludes.





Area Evacuated after Propane Truck Crashes

GRIDLEY, CA (MPG) - On the morning of November 30th, sirens wailed through Gridley as emergency personnel responded to an accident involving a propane tanker truck.

The tanker truck carrying 2,000 gallons of propane was in flames and actively leaking propane when CAL FIRE crews arrived on scene shortly after 10:00 am. The truck crashed west of Pennington Rd on Colusa Highway near Hatch Rd. The fire spread from the truck to a nearby rice field while firefighters worked to prevent the breach of the tank and evacuated residents in a mile-radius. To complicate

things, reports say that along with the blaze, several power lines were down, creating a level 3 hazard for emergency responders.

Resources from CAL FIRE, Gridley Fire Department, Gridley Police Department, Chico Fire Department, Butte County Sheriff's Office, California Highway Patrol and more responded to the scene. The blaze was contained and what could have been a large explosion prevented. The driver of the truck escaped the burning truck and was taken to the hospital for treatment.

CAL FIRE expects to be on scene for hours for containment and HAZMAT crews will follow to verify the area is safe to re-enter.





Recent Yuba City Homicide

YUBA CITY, CA (MPG) - On 11-25-2020 at approximately 10:20 pm, Yuba City Police Officers responded to the 700 block of Orange Street for a report of a fight involving several people in the street and one subject with a knife. When Officer's arrived, they located one victim in the street with suspected stab wounds. Medical attention was immediately provided; however, the individual was pronounced dead at the scene. The victim is a 26-year-old male from Yuba City. His identity is not being released pending notification of next of kin. The Sutter County Corner will release this information when this is completed.

During the initial investigation, a second victim who was also suspected of being stabbed was transported to Adventist/Rideout Hospital by some unknown subjects. This victim is a 24 year old male from Yuba City who received non-life threatening injuries. This victim's identity is being withheld due to the sensitive nature of the investigation and his safety.

The Yuba City Police Investigation Unit responded to the scene and took over the investigation. It was determined there was a fight between several people, and a single suspect pulled out a knife and stabbed the two victim's. The suspect was identified as Anthony Teglia, a 27-year-old male

from Sparks, Nevada. Mr. Teglia fled the scene prior to officer's arriving. Detectives, with the assistance of the Sacramento Police Department were able to locate Mr. Teglia, on 11/26/2020 at approximately 3:00am in the Sacramento area. Mr. Teglia was arrested and transported to the Sutter County Jail where he was booked for murder and assault with a deadly weapon.

This is considered an isolated incident between individuals who were considered acquittances. This investigation is ongoing and anyone who might have witnessed this incident is strong urged to contact the Yuba City Police Investigation Unit at 530-822-4660.

Two Arrested for Infant Endangerment

Deputies responded and located an infant child alone inside a vehicle, while the vehicle was still running and the heater was running. The child was sweating and crying, but appeared to be unharmed. Deputies located the mother of the child, who

was identified as 34 year old Amanda Nicole Lookingbill. Also located, was 29 year old Nicolaus Wentworth Voter. Lookingbill and Voter were sleeping inside a trailer near where the infant was located. Lookingbill and Voter were both arrested on charges of child endangerment. Voter is on parole and was booked into the Sutter County Jail with a \$50,000 bail and a court date of 11/24/2020. Due to medical issues. Lookingbill was cited and released with a future court date. Child Protective Services was called out and took possession of the infant.

School Closures May be Killing our Kids

Throughout California, academic grades for children forced into makeshift learn-at-home arrangements rather than receiving classroom instruction have plummeted – and that's among kids who are struck, those children were actually signing on via already, as a group, falling computer.

Too many public school students still lack the necessary equipment and internet access, but even when they have them, they may be left on their own as parents, unable to work from home, go to their service ing more children to lives jobs. Thus, what used to be called truancy, just not participating, is also rampant.

What's been happening, or not happening, in the huge Los Angeles Unified School District typifies a statewide syndrome.

"The drop in grades, which also is affecting other school systems, was disclosed Monday when LA Unified released a chart long run. based on 10-week interim assessments," the Los Angeles Times reported. "Poor grades surged in the district's lower-income communities, which also is where student attendance rates are lower and where the COVID-19 pandemic has hit especially hard."

don't reflect the desire or capability of students,"

District Superintendent Austin Beutner said in broadcast remarks. "They're eager to learn and every bit as capable as they were before school facilities closed. But the struggle to cope with COVID-19 and online learning for children and their families is very real."

As the Los Angeles experience underscores, this catastrophe mostly affects children in low-income families, just as COVID-19 has a disproportionately heavy health impact on those same families. And even before the pandemic behind their more privileged peers - a syndrome dubbed the "achievement gap."

The long-term effects of truncated educations are obvious. The achievement gap, already yawning, will widen even further, doomof economic struggle, and the state will be deprived of the well-educated workforce it needs for 21st century prosperity.

It may be even worse. An academic team examined the potential effects of interrupting classroom learning and reported last week that it will mean a greater loss of life in the

The study, published in the Journal of the American Medical Association, estimates that 24.2 million children aged 5 to 11 each lost a median of 54 days in school last spring. That, the researchers said, translates into 5.53 million fewer years of life due to lower "The attendance figures educational achievement, and interim assessments nearly four times the estimated 1.47 million years of life that would be lost had

schools remained open.

"In this ... model of years of life potentially lost under differing conditions of school closure, the analysis favored schools remaining open," the study concluded. "Future decisions regarding school closures during the pandemic should consider the association between educational disruption and decreased expected lifespan and give greater weight to the potential outcomes of school closure on children's health."

Most schools remain closed because local education officials and their unions are at odds on the conditions of reopening. The latter are seeking virtually impossible guarantees of protection before returning to the classroom.

It's nothing short of educational apartheid, not fundamentally different from the separatebut-unequal segregation in the South during the precivil rights era.



GOP Poll Observer: Hundreds of Thousands of Votes Counted With No 'Oversight' in Pennsylvania | 26 Nov 2020 | Several witnesses who spoke during a Republican state Senateheld event in Pennsylvania said that hundreds of thousands of votes were allegedly counted with no "civilian oversight." Justin C. Kweder, a certified canvass observer and lawyer, said he served as an observer at the Philadelphia Convention Center. GOP observers, he said Wednesday, were kept between 10 and 200 feet away from the vote-tabulating process. Because of the distance, "it was impossible for me or any observer to see what the workers were doing with any type of specificity." "The observers were not able to challenge any decision or determination being made about the processing of these mail-in ballots," Kweder also said.

Ballot Count Upload Error in Arizona - Over 6,000 False Biden Votes Discovered | 24 Nov 2020 | Joe Biden's lead in Arizona dropped from 10,377 votes to 4,202 after a machine error was discovered on Tuesday. The error was from a faulty upload from Greenlee County, which showed 22,110 votes – but should have been 3,723. State officials say that it was temporary and has now been corrected. Biden's lead is now back to being listed as 10,377.

'One kind of fraud': Biden won thousands of illegal votes by non-citizens, study shows 22-Nov 2020 | A new study estimates that presumptive President-elect Joseph R. Biden benefited from thousands of illegal votes by non-citizens, providing President Trump's backers with another potential argument for a fraud-tainted election. The study comes from the nonprofit research institute Just Facts, and its president, James D. Agresti, who looked at election returns from seven battleground states: Arizona, Georgia, Michigan, Nevada, North Carolina, Pennsylvania and Wisconsin. He compared U.S. Census numbers on noncitizens (a total of 21.7 million) with each battleground state's demographics and election results. He then applied previous election polling of non-citizens.

Group files emergency petition in Wisconsin after finding 150,000 potentially fraudulent ballots | 24 Nov 2020 | The national conservative group Amistad Project filed an emergency petition Tuesday with the Wisconsin Supreme Court challenging the state's unofficial results in the 2020 presidential election, saying it has identified over 150,000 potentially fraudulent ballots. Results from the Nov. 3 balloting in the state show Democratic candidate Joe Biden defeated President Trump by a roughly 20,000-vote margin. Phill Kline, director of the Amistad Project of the Thomas More Society, said the number of potentially fraudulent ballots identified are "more than enough to call into question the validity of the state's reported election results." "Moreover, these discrepancies were a direct result of Wisconsin election officials' willful violation of state law," he also said.

Thousands in Georgia Registered at Postal, Commercial Addresses, Portraying Them as Residences, Researcher Says | 24 Nov 2020 | Thousands of people registered and voted in Georgia using addresses of postal facilities or businesses, but making it look like they were residential addresses, according to a former Trump campaign official whose team analyzed the states' voter data. The addresses listed on the voter rolls included information that didn't make sense for the actual locations, but on paper made the addresses look like residential ones, according to information published by Matt Braynard, former data and strategy director for President Donald Trump's 2016 election campaign. "Georgia: We have identified over a thousand early/abs votes cast by individuals whose registered addresses are in fact at post offices, UPS, and FedEx locations, willfully disguising the box numbers as 'Apt,' 'Unit,' etc.,' he said in a Nov. 22 tweet. He published a sample of 15 such address entries in a Nov. 24 tweet... Nearly all those "who disguised a postal facility as their residential address" used an absentee ballot to vote, he said.

\$2 Million Now Available in Sutter County COVID-19 Relief Grants

SUTER COUNTY, CA (MPG) - Sutter County's community support program has resulted in grants totaling almost \$2 million to 104 small businesses and 31 non-profit agencies impacted by COVID-19.

The Sutter County Board of Supervisors authorized the Small **Business Economic Resiliency Grant** program in response to the financial losses encountered by businesses during the pandemic. The program was possible because of federal funding authorized in the Coronavirus Aid, Relief, and Economic Recovery Act signed by President Trump in the summer after bi-partisan approval in Congress. The Yuba-Sutter Economic Development Corporation administered the program.

"We're very proud of this program and our partnership with Yuba Sutter to school closures.

Economic Development Corporation to get money into the hands of our local businesses and nonprofits who were impacted as a result of COVID-19." said Ron Sullenger, chair, Sutter County Board of Supervisors.

Altogether, Sutter County has authorized up to \$4 million to go toward community support programs to help our County recover. In addition to the small business and nonprofit programs, Sutter County has given \$145,875 to the Yuba Sutter Food Bank to help with home food delivery for vulnerable people and to respond the greater need for food distribution due to COVID-19's impact on the local economy. The Sutter County Superintendent of Schools is administering an \$800,000 program to provide support to families who have increased child care costs due

9 Volt Battery Safety

9-volt batteries power our smoke alarms, household items, and toys. They can be found in most homes, but these batteries can be a fire hazard if not stored safely or disposed of with care.

THE PROBLEM:

- 9-volt batteries can be dangerous. The positive and negative posts are close together. If a metal object touches the two posts of a 9-volt battery, it can cause a short circuit. This can make enough heat to start a fire.
- It is unsafe to store 9-volt batteries in a drawer near paper clips, coins, pens, or other batteries. Do not store common household items such as steel wool, aluminum foil, and keys near 9-volt batteries. If these items touch the two posts, there is a greater risk of a fire starting.
- Weak batteries may have enough charge to cause a fire. Some fires have started in trash when 9-volt batteries were thrown away with other metal items.

STORING 9-VOLT BATTERIES:

- Keep batteries in original packaging until you are ready to use them. If loose, keep the posts covered with masking, duct, or electrical tape. Prevent the posts from coming in contact with metal objects.
- · Keep them someplace safe where they won't be tossed around.
- · Store batteries standing up:
- 9-volt batteries should not be stored loose in a drawer.
- Do not store them in containers with other batteries.

DISPOSAL:

- 9-volt batteries should not be thrown away with trash. They can come in contact with other batteries or pieces of metal.
- 9-volt batteries can be taken to a collection site for household hazardous waste.
- To be safe, cover the positive and negative posts with masking, duct, or electrical tape before getting rid of batteries.
- Some states do not allow any type of battery to be disposed of with trash. Check with your city or town for the best way to get rid of batteries.

So, when you are preparing to stock up on batteries for the holidays, remember these simple safety tips to keep your holidays a safe and memorable one.

Coffee

Dear Readers:

Many of us start our day with a hot cup of coffee. In my opinion, the best part of the day is over when the alarm clock goes off, so coffee is needed to come alive. Coffee is a good source of caffeine, which increases alertness, and antioxidants, which may help prevent several diseases.

Finland tops the world in coffee consumption, where they consume 23 pounds of the brew per person each year. In the US, 64% of adult Americans drink java, with the average coffee drinker taking in about 10 pounds of coffee every year (1).

What does your cup of java say about you? While these findings may not be strictly scientific, they are interesting and fun.

People who order black coffee are no-nonsense. They are the ones who get to a meeting five minutes early and leave promptly when it's over. There's no time to socialize. 

Tier 1 Broad Review Program Title: Gridley Owner-Occupied Rehabilitation Program

On or about December 14, 2020 the City of Gridley will submit a request to the Department of Housing and Community Development (HCD) for the release of HOME Investment Partnerships Program (HOME) funds under Title II of the Cranston-Gonzales National Affordable Housing Act of 1990 as amended, to undertake a program known as Owner-Occupied Rehabilitation Program (OOR Program) for the purpose of providing financing for income-eligible singlefamily households to rehabilitate homes, within the city limits of Gridley, CA. During the program period of December, 2020 through November, 2025 the OOR Program will utilize HOME grant funds, HOME Program Income and Recaptured Funds, and any other source of federal, State and local funds as they may become available during the program term. The approximate amount of these funds may potentially reach \$850,000 of which the amount of HOME funds may be an estimated maximum of \$700,000 to provide loans of up to \$100,000 per unit to rehabilitate a maximum of fifteen homes/units. The Area of Consideration for this program is the city limits of Gridley, CA and excludes Special Flood Hazard Areas and reconstruction projects.

The activities proposed are categorically excluded from the National Environmental Policy Act requirements under U.S. Department of Housing and Urban Development regulations at 24 CFR Part 58.35(a)(3)(i). An Environmental Review Record (ERR) for the area of consideration that documents the environmental determinations for this program is on file at the City of Gridley, 685 Kentucky Street, Gridley, CA 95948 and may be examined or copied weekdays 9:00 A.M. to 4:00 P.M. The City of Gridley will perform Tier 2 site-specific reviews, which will cover the following laws and authorities not addressed in the Tier 1 broad review: Flood Insurance, Contamination and Toxic Substances, Floodplain Management and Historic Preservation.

PUBLIC COMMENTS

Any individual, group, or agency may submit written comments on the ERR to City of Gridley, Attn: Rodney Harr, Interim City Administrator, 685 Kentucky Street, Gridley, CA 95948. All comments received by December 13, 2020 will be considered by the City of Gridley prior to authorizing submission of a request for release of funds.

ENVIRONMENTAL CERTIFICATION

The City of Gridley certifies to HCD that Rodney Harr in his capacity as Certifying Officer consents to accept the jurisdiction of the Federal Courts if an action is brought to enforce responsibilities in relation to the environmental review process and that these responsibilities have been satisfied. HCD's approval of the certification satisfies its responsibilities under NEPA and related laws and authorities and allows the City of Gridley to use Program funds.

OBJECTIONS TO RELEASE OF FUNDS

HCD will accept objections to the City of Gridley's Request for Release of Funds and Environmental Certification for a period of fifteen days following the anticipated submission date or its actual receipt of the request (whichever is later) only if it is on one of the following bases: (a) the certification was not executed by the Certifying Officer of the City of Gridley; (b) the City of Gridley has omitted a step or failed to make a decision or finding required by HUD regulations at 24 CFR Part 58; (c) the grant recipient or other participants in the project have committed funds or incurred costs not authorized by 24 CFR Part 58 before approval of a release of funds by HCD; or (d) another Federal agency acting pursuant to 40 CFR Part 1504 has submitted a written finding that the project is unsatisfactory from the standpoint of environmental quality. Objections must be prepared and submitted in accordance with the required procedures (24 CFR Part 58 Sec. 58.76) and for the HOME Program shall be addressed to the California Department of Housing and Community Development, Grants Management Section, HOME Program, P.O. Box 952054, Sacramento, CA 94252-2054. Potential objectors should contact HCD to verify the actual last day of the objection period.

EDD Unemployment Scandal

SACRAMENTO, CA (MPG) -California may have paid up to \$1 billion in fraudulent unemployment claims filed on behalf of prison and jail inmates in ment changes at the state what prosecutors are calling "the most significant fraud on taxpayer funds in cross-check prison and jail California history."

The state paid more than 35,000 claims under state prisoners' names, with one inmate collecting nearly \$49,000, a group of district attorneys and a federal prosecutor said at a Tuesday press conference. California also paid more than \$421,000 to of serial killers, rapists and 133 Death Row inmates including Scott Peterson, a San Quentin prisoner convicted of killing his wife and unborn child. Some of the claimants used pseudonyms like "Poopy Britches" or "John Doe,"

and most targeted federal support investigations by benefits distributed by the state.

In a sharply worded letter, the district attorneys asked Gov.
