Let the Replacement **Process Begin**

GRIDLEY, CA (MPG) - Two weeks after formally announcing that the Gridley City Council had accepted the resignation of former City Administrator and City Finance Director, Paul Eckert, Council held a special meeting to begin the process of filling the position.

Gridley City Attorney Tony Galyean brought to the council's consideration a professional services contract agreement with Bob Murray and Associates for the recruitment of a new City Administrator. The City of Gridley has contracted with the firm numerous times in the past for employee recruitment, including the last two City Administrator positions.

According to Galyean, the last recruitment process took almost 6 months. Murray and Associates conducts a nation-wide search for talent and Galyean says, from his understanding, that the initial openperiod for application can take between 4-6 weeks. Murray and Associates will submit candidates to a screening process, presenting a portfolio of applicants that satisfy recommendations and hold experience specific to Gridley's needs to council for consideration.

The City of Gridley was able to retain previous contract rates established when partnering with the firm to replace Eckert after his first exit from the position to pursue a place in Hollister. Sitting council members approved the measure to begin the recruitment process, but newly elected City Council Members Catalina Sanchez, J. Angel Calderone and Mike Farr will ultimately

help decide Gridley's pick. When asked if the Council will use this opportunity to establish a lower rate of compensation for the City Administrator position, they assured that any opportunity to save the city money would be considered but within reason. Council reminded that "you get what you pay for" and that although saving money would be fantastic, they intend to find a dedicated candidate that will work hard for Gridley and not break the bank in the process.

In the meantime, Gridley Police Chief Rodney Harr will assume the responsibilities of city management as Interim City Clerk and Acting City Administrator.

It is November, the month of Thanksgiving, and it would serve us well to elucidate gratitude. Gratitude is an uplifting and exalting attitude. People who feel and express gratefulness are happier. We cannot be bitter, resentful, or mean-spirited when at the same time, we are grateful. A mindful person is thankful for the wonderful blessings and the tremendous opportunities that await them. We can be thankful for our parents, family, friends, and teachers. During November, we should make an extended effort to express appreciation to every person who has assisted us in any way. Let me give you a few of mine: I appreciate Gwen Dundas, who, when I was in First Grade at Wilson School, taught me to read. Leticia Quist Stewart taught me how to sit still in church meetings. Donna Tibbits signed me up for Butte College, got me a job on campus, got me several scholarships, and elected Student Body President. The list of people who have back to me every day is long. Take a moment this week to think of some of the people who gave you a life skill you use every day and be grateful for them, tell their story, share your thoughts about them with someone this week.

So what is it that keeps us from acknowledging those people, from appreciating the good things in our lives? Two joy killers come to mind: The first is comparison. For some reason, almost all of the research is indicating that people who have lots of things, lots of wealth, and lots of comforts are much less happy than people who don't. We are saturated with media that tells us if we simply buy more stuff, we will be happier. This will go down in history as one of the biggest lies ever perpetrated on literate people. When your focus shifts from what you have to what you don't have, the spiral of unhappiness begins. Indeed one of the best ways to block good things from coming into your life – is to not appreciate the things that you have already. Being grateful takes effort and attention. The second thing that draws us away from happiness is a lack of perspective. If you're reading this paper, you're in the top 1% socioeconomically of all the people in the world. Take a moment and think about that. For every you, there are 99 other people who live in some form of poverty (not American poverty but the looking for enough calories to live povthose people would say if they were to observe a group of 100 angry people protesting about how lousy life is on a street that is paved? If you are protesting on a paved surface, you're in the 1% of the world. Do you have running water that is heated, you're in the 1%. Suppose I were to take you into a classroom and explain to you that you are one of the most blessed, healthiest, most educated, comfortable people in the world; you would probably feel a sense of satisfaction. If I took you into a classroom and told you all the ways someone else got ahead of you and never mentioned to you the 99 other people - who are behind you in the line of life - you would probably be dissatisfied and unhappy. Perspective and truth matter.

Why does gratitude matter more now? Even before our current pandemic, alcohol abuse rates, drug abuse, suicide, depression, and other measurable mental health benchmarks were at a record high in the United States of America and other developed nations. Thanksgiving month creates an opportunity for us to share with people around us the importance of perspective, and the damage done to us by comparing everything in our lives to things we don't have.

The Wrong Kind of Take-Out

GRIDLEY, CA (MPG) - As if throughout the restaurant operating a restaurant in the year of COVID hasn't been enough of a challenge, a local favorite can add another hardship to their 2020 survival list.

Last week, owners of Gridley's Rail House Pub and Grill, Tim and Kari Trusheim, got quite a shock the morning of November 6th when they arrived to find that their restaurant had been broken into.

Surveillance footage shows two suspects,

presumably males, entering and rummaging throughout the restaurant in the morning. They are believed to have gained access to Rail House by breaking a lower window panel of the large floor to ceiling and crawling through. Reportedly the thieves caused a lot of damage to the building, were able to get away with a very large amount of cash, products and the businesses checkbook.

The Trusheims have shared images of the

suspects on their Facebook page and have asked for the public's help in identifying them, noting unique sneakers. They also said that no one should accept checks from the business unless they are expressly being written from and by Tim or Kari. If anyone has any information on the burglary, please contact the Gridley Police Department.

Officer Jared Cooley says the incident is currently under investigation but that there is no additional information at the time of this article.

again our community stepping out and helping to meet the needs of those around us. This Christmas season we again have an opportunity to helps those in need.


The Gridley Emergency Relief

OROVILLE, CA (MPG) - The Butte County Sheriff's Office is announcing an additional victim has been identified from the North Complex West Zone/Bear Fire. On September 8, 2020, Win Naing, age 54 of Berry Creek, sustained burns as a result of the fire. Naing was injured but was still able to drive. Naing drove from his home on Sandy Springs Lane and located a firefighter. The firefighter was then able to have Naing transported

to Enloe Medical Center.

On September 9, 2020, Naing was transferred to UC Davis Medical Center for further treatment. Naing was put into a medically induced coma and passed away on October 21, 2020.

If Trump concedes election, Republicans will 'never' elect another president | 08 Nov 2020 | Sen. Lindsey Graham (R-S.C.) warned that President Trump should not concede defeat in the 2020 presidential election in part because Republicans will "never" be able to elect another president from their party again. "If Republicans don't challenge and change the U.S. election system, there will never be another Republican president elected again," Graham said Sunday on Fox News. "President Trump should not concede. We're down to less – 10,000 votes in Georgia. He's going to win North Carolina. We have gone from 93,000 votes to less than 20,000 votes in Arizona, where more -more votes to be counted." Every major news network and The Associated Press on Saturday projected Joe Biden as the winner of the 2020 race for the White House. Trump has said he will not concede, alleging widespread voter fraud led to tens of thousands of illegal ballots being cast against him. Rep. Doug Collins to lead Trump campaign's Georgia recount effort | 08 Nov 2020 | Georgia Rep. Doug Collins – who just lost his bid for a Senate seat – will lead the Trump campaign's recount effort in the state that was too close to call. The move was announced Sunday night and the recount in The Peach State will begin when "the canvassing has concluded," according to President Trump's campaign. "Republicans stand by the ideal that every eligible voter should be able to vote legally and have it be counted," Collins said in a statement. Collins and the Trump campaign both claimed that ballots were "improperly harvested" in Georgia.

Trump Campaign to Name David Bossie to Lead Legal Election Fight - Report | 06 Nov 2020 | President Donald Trump's re-election campaign is expected to name seasoned conservative operative David Bossie to lead its post-2020 presidential election legal efforts, according to reports. The New York Times, CBS News, and ABC News all reported the development Friday afternoon as the Trump campaign continues to wage legal battles in key battleground states over concerns of voter fraud and inadequate observation of ballot counting in the November 3rd election.

Candace Owens targets Facebook 3rd-party fact-checkers with lawsuit | 06 Nov 2020 Conservative activist Candace Owens said Thursday that she plans to sue Facebook's third-party fact-checkers over perceived censorship of her social media posts. "It is time to fact-check the fact-checkers," Owens said in a video posted to her Twitter account. "I'm going to put these suckers through discovery and figure out what the relationship is that they have with Facebook." Owens gave an example of an instance that she alleged crossed the line. "Quite literally a doctor gave his opinion about COVID-19, which I shared, and Facebook issued a strike on my account because they said only information that they agree with about COVID-19...was acceptable," she said.

Supreme Court Orders Pennsylvania to Separate Late-Arriving Ballots – Alito orders that 'all such ballots, if counted, be counted separately' | 07 Nov 2020 | U.S. Supreme Court Justice Samuel Alito late Friday ordered Pennsylvania election officials to segregate and separately count ballots that arrived after Election Day. Alito granted a request by the state's Republican party to separate mail-in ballots received between 8 p.m. Nov. 3 and 5 p.m. Nov. 6 from those that arrived by 8p.m. Nov. 3, in accordance with state guidance. He ordered that those segregated ballots must be kept "in a secure, safe and sealed container separate from other voted ballots." The justice, however, did not order the counties to stop counting but instead ordered "all such ballots, if counted, be counted separately." Alito also directed any responses to the application by 2 p.m. Nov. 7. The Republican Party of Pennsylvania had filed a request earlier on Friday asking the court for an order to log, segregate, and not take any actions over mail-in ballots received after Election Day.

Two 'Bomb Threats' Force Trump Supporters to Move Locations of Detroit Rally; **Detroit Police Arrest Trump Unity Bridge Driver, Falsely Accuse Him of Having Two** Outstanding Warrants | 06 Nov 2020 | WalkAway founder Brandon Straka and other local Michigan grassroots groups organized a rally to show their support for President Trump in front of the TCF Center in Detroit, where the process of 'counting' absentee ballots took place for the past 3 days. Shortly after Trump supporters arrived, they were told by Detroit Police that they had to leave because there was a bomb threat at the TCF Center. The group moved to the Detroit City Hall, where they reorganized and began to show their support for President Trump when they were told to move AGAIN because there was another bomb threat... Avid Trump supporter Scott Hagerstrom was with Rob Cortis, when he arrested. Hagerstrom told us that although the police told them there was a bomb threat at Detroit City Hall, none of the workers inside City Hall were being evacuated.

Fixed 'computer glitch' turns losing Republican into a winner in Oakland County 06 Nov 2020 | (MI) A 'computer error' led election officials in Oakland County to hand an upset victory Wednesday to a Democrat, only to switch the win back to an incumbent Republican a day later. In Oakland County's 15th County Commission District - representing Rochester and Rochester Hills – the initial count gave a 104-vote margin to the Democrat, Melanie Hartman, amounting to a razor-thin majority of 50.08%. That stunned the incumbent, Adam Kochenderfer, giving him a sure sense that he'd lost in a district long deemed a Republican stronghold. "Apparently, there was a technical glitch in Rochester Hills. And so I actually ended up winning by a little over 1,100 votes," said a chuckling Kochenderfer. The margin was 1,127 votes, to be exact. That gave him a 51.67% share of the total (with 48.23% going to his opponent, Hartman).

GOP Claims Software Error Switched 6,000 Republican Votes to Democratic, Used in 47 Michigan Counties | 06 Nov 2020 | Republican National Committee Chairwoman Ronna McDaniel and other GOP officials said the fight over the presidential election isn't over, saying that 47 counties in Michigan may have used software that was detected to have allocated votes to Democrat Joe Biden instead of President Donald Trump in one county. "In Antrim County, ballots were counted for Democrats that were meant for Republicans causing a 6,000-vote swing against our candidates," Michigan GOP Chairwoman Laura Cox said in a news conference Friday. "The county clerk came forward and said tabulating software glitched and caused a miscalculation of the votes." Cox added: "Since then, we have now discovered that 47 counties use this same software in the same capacity. Antrim County had to hand count all of the ballots, and these counties that use this software needs to closely examine their results for similar discrepancies."

On the website's landing page, it urges urges that "[w]e must never forget those who helped further the Trump agenda," The site is a self-described "permanent record" of those who elected the president, including Trump campaign staffers, Republican National Committee members, and affiliated PACs in 2016 or 2020.

Nevada Republican Party sends criminal referral to DOJ alleging thousands of cases of voter fraud | 05 Nov 2020 | The Nevada Republican Party announced Thursday evening that it has sent a criminal referral to U.S. Attorney General William Barr with allegations that the state had 3,602 cases of voter fraud. The criminal complaint comes as news outlets have yet to announce a projected winner in the race between President Trump and Democratic nominee Joe Biden, with the Trump campaign and the GOP having already filed multiple unsuccessful legal challenges in the Southwestern state. "Our lawyers just sent a criminal referral to AG Barr regarding at least 3,062 instances of voter fraud," the Nevada Republican Party wrote in a tweet. "We expect that number to grow substantially. Thousands of individuals have been identified who appear to have violated the law by casting ballots after they moved from NV."

Large Amount of Illegal Drugs Found At The Butte County Jail

Butte County Sheriff's Office

OROVILLE CA (MPG) - On October 23, 2020 at approximately 9:15 a.m., Butte County Sheriff's Office (BCSO) correctional deputies conducted a random search of an inmate housing unit within the Butte County Jail. Deputies routinely conduct random searches of inmate housing units to locate contraband and inmate made weapons. This is necessary to ensure the safety and security of the inmates, civilian contractors and correctional staff who work in the jail. As part of those searches, correctional deputies conduct cursory pat-searches of the inmates housed in the unit to make sure they are not in possession of weapons or contraband.

During a cursory pat-search of inmate David Weston, age 39, approximately 9.7 grams of black tar heroin, 12 packages of Suboxone strips and multiple unknown crushed pills were found to be concealed on his person. Weston was recently remanded into custody during a court appearance. He knew he was likely to be remanded into custody ahead of time and it's believed that he smuggled the narcotics into the jail by hiding the contraband inside his body.

Weston was arrested by deputies and booked for the illegal transportation for sale of a controlled substance, in violation of Penal Code section 11352. Weston was also booked for illegal sales of narcotics in violation of Penal Code section 4573.9, when it was determined that he was furnishing the narcotics to other inmates in exchange for money being deposited upon his inmate

During the search of the housing unit, deputies located approximately 3 gallons of "pruno," which is an alcoholic beverage commonly made by inmates using food items they obtain from the meals they are served. Additionally a three inch bolt with a sharpened paperclip affixed to the end was located. It is likely this item was being used to apply tattoos. Deputies are conducting further investigation in an effort to determine which inmates were responsible for those items.

Butte County COVID-19 Data Trending Towards Tier 2 (Red — More Restrictive)

BUTTE COUNTY. CA (MPG) - Butte County Public Health urges residents to take action to prevent COVID-19 as current case and test positivity rates, as monitored by the State's Blueprint for a Safer Economy, are trending higher. If this trend continues, Butte County will likely move back to Tier 2 (red) by November 17,2020.

Moving back to Tier 2 would place more restriction on businesses and activities that have been able to increase indoor operations since being in Tier 3 (orange) on October 20, 2020. This move would also require some business to close all indoor operations.

This week, BCPH also announced the first death in a person in their 20's with no underlying health conditions. This is a sad and stark reminder that COVID-19 can affect anyone, no matter their age. BCPH also reported the biggest increase in cases among people ages 0-17, with 12 cases reported over the weekend. An additional 21 cases were reported among people ages 18-24. This increase in cases among school age children and young adults comes just nine days after the Halloween holiday. BCPH learned through case investigation that cases are connected to in-person education and through small-medium sized gatherings including, but not limited to weddings, funerals and Halloween celebrations.

"I am very concerned to see an increase in cases among some of our youngest residents as we head into colder weather, flu season and holiday celebrations. This is a critical time in the pandemic, please do your part to stop the spread of COVID-19," stated Dr. Robert Bernstein, Butte County Health Officer. "Until there is a safe, effective, FDA approved and available vaccine, the only defense we have against COVID-19 is proper use of non-pharmaceutical interventions (of "NPIs") – cover your mouth and nose with a mask when in public places, wash your hands with soap and water, maintain six feet of distance from others, stay home if you are sick and only attend gatherings that are in compliance with State guidance."

How will moving tiers impact businesses? Gridley Thumbs and Roots



By Barbara Ott

There is a new nemesis in our vegetable garden, nematodes. As far as we knew we did not have nematodes and now we do. While my beloved pulled up tomato plants that were not producing much, he noticed nodules on the roots. Lots of nodules. He had never seen the like before. So, he wandered in and described them to me and I having read books, said "Oh no, we have nematodes!" It was time to find out more about nematodes.

It turns out there are good and bad nematodes. They are multicellular insects with smooth, unsegmented bodies, worm-like. The good ones distribute bacteria and fungi through the soil and along roots by carrying live and dormant microbes on their surfaces and in their digestive systems. They are also eaten by higher level predators, including predatory nematodes, and soil insects.

The bad nematodes that feed on plants are so tiny that you need a microscope to see them. They get into the roots of plants making nodules and causing problems by stunting the plants, yellowing the leaves and making the plants resistant to fertilizers.

There are several

important things to do to reduce or eliminate nematodes in the soil.

- 1. Crop rotation is one of the oldest and most economical methods of controlling nematodes.
- 2. Plant nematode-resistant plants all year long to limit damage.
- 3. Clean up old plant debris and roots from the soil.
- 4. Bring up the soil temperature by putting down plastic sheeting.
- 5. Bring up the soil temperature by spreading out raw manure. Research shows the best manure treatments were #1. turkey manure #2. horse manure #3. cow manure.

If you have nematodes start now to control them. Turns out they don't like cold weather so we are in

BCSO Detectives Arrest Three Individuals for Two Murders in the Oroville Area

OROVILLE, CA (MPG) - On the evening of October 21, 2020, the Butte County Sheriff's Office (BCSO) was contacted by family members of Jerry Bonds, age 39 and Randy Bonds, age 33, of Florida. The family members reported Jerry and Randy had County area. The family members were concerned because they lost contact with Jerry and Randy after they arrived in the Butte County area. BCSO deputies and detectives immediately began conducting an investigation.

During the investigation that followed, BCSO detectives, Butte Interagency Narcotics Task Force detectives, BCSO Special Enforcement Unit detectives, Designated Area deputies, and Agents from the Chico FBI Office worked together and devel-

tioned area, detectives located the bodies of Jerry and Randy in a wooded area. Detectives determined Jerry and Randy had both been shot.

Detectives worked with the Reno Police Department and located the vehicle Jerry and Randy had rented in the area of Boomtown, Nevada. flown from Florida to Los Detectives traveled to Angeles, rented a vehicle, Reno, worked with the and traveled to the Butte Reno Police Department, and executed a search warrant at a residence in Reno. Detectives located additional evidence related to the murders of Jerry and Randy in the Reno area. Based on informa-

tion obtained during the investigation, detectives identified Michael Griff, age 21, Austin Hogan, age 21, and Kyle Smith, age 24, as the individuals who murdered Jerry and Randy. Detectives determined Griff, Hogan, and Smith were residing at a residence on Coho Court, Oroville.

On October 22, deputies oped information that led and detectives contacted them to believe Jerry and Hogan and Smith dur-Randy were last in the ing a traffic enforcement area of Pondersoa Way, stop in the Kelly Ridge

search of the aforemen- obtained a search warrant for the Coho Court address, and an arrest warrant for Griff. On the afternoon of October 22, deputies with the BCSO SWAT team executed the search warrant. During the execution of the search warrant, Griff was contacted and placed under arrest. During a search of the Coho Court residence, detectives located additional evidence showing Griff, Hogan, and Smith were the individuals responsible for the murders of Randy and Jerry. Detectives are currently following-up on additional information regarding the circumstances of the murders.

On October 22, Griff, Hogan, and Smith were booked into the Butte County Jail. Griff, Hogan, and Smith were each booked for two counts of first degree murder. Griff, Hogan, and Smith are scheduled to be arraigned at the Butte County Superior Court on Monday, October 26, at 3 PM. FEMA's Committed to Butte County's Long-Term Camp Fire Recovery

OAKLAND, CA (MPG) - As we recognize the second anniversary of the Camp Fire on Nov. 8, the Federal Emergency Management Agency (FEMA) remains committed to Butte County's recovery.

Two years ago, the Camp Fire - California's deadliest and most destructive wildfire in history – swept through 153,336 acres over 16 days. It destroyed 18,804 structures, prompted the evacuation of more than 30,000 residents and took the lives of 85 individuals.

Such wide-spread damage required a coordinated effort between local, state and federal government, nongovernmental organizations, the private sector and volunteers to support Butte County in its response and long-term recovery efforts. Since 2018, FEMA has provided more than \$238 million in assistance to local and state government agencies, and residents to support recovery from the Camp Fire.

Individuals and households received \$84 million to manage rental expenses, home repair and home replacement costs, in addition to grants to replace personal property and cover other disaster-related expenses. As part of an extensive direct housing mission, FEMA also developed the 72-acre Gridley Industrial Park, with 289 manufactured housing units and mobile homes for thousands of displaced Butte County residents.

Costs of disaster-related debris removal, emergency protective measures to protect life and property, and permanent repair work to damaged or destroyed infrastructure have totaled more than \$129 million. Funds have gone to repair and replace large portions of the Paradise Irrigation District's water system, repair and restore nine damaged or destroyed Paradise Unified School District facilities, remove debris on public and private property, repair damaged roads and rebuild the Honey Run Bridge.

More than \$25 million in hazard mitigation grants to Butte County and the Town of Paradise will reduce or eliminate the long-term risk to life and property from a future hazard. Some of the projects approved or under review will develop emergency notification systems, fuels reduction initiatives, administer code enforcement, install ignition-resistant materials in homes and create a defensible space program.

Due to the size and severity of the Camp Fire, FEMA established a long-term community recovery office in Paradise to take a holistic, long-term view of critical recovery needs and coordinate the mobilization of resources at the federal, state and community levels. Collectively, we are vested in and committed to the area's long-term recovery plan to restore a functioning, healthy economy, improve infrastructure, expand housing, address environmental considerations, and make Butte County and the Town of Paradise more resistant to future disasters.

Careless cooking is the number one cause of residential fires. Never leave anything unattended while cooking! Don't let an unfortunate grease fire ruin your holiday meal. With the holiday season fast approaching; here are some helpful tips and safety information to make this holiday season a memorable one, brought to you by CAL FIRE/Gridley Fire Department.

- Stay Away from the House Set up the turkey fryer more than 10 feet away from your home and keep children and pets away. Never leave it unattended.
- Find Flat Ground The oil must be even and steady at all times to ensure safety. Place the fryer on a flat, level surface and carefully gauge the amount of oil needed.

• Use a Thawed and Dry Turkey – Make sure your Thanksgiving turkey is completely thawed and dry. Extra water will cause the oil to bubble furiously and spill over. If oil spills from the fryer onto the burner, it can cause a fire.

• Monitor the Temp – Use caution when touching the turkey fryer. The lid and handle can could cause burns. Also be sure to keep track of the oil's temperature as many fryers do not have their own thermostats.

• Be Prepared – Have a fire extinguisher (multipurpose, drypowder) ready at all times in the event that the oil ignites.

Dear Dietitian

Cholesterol Supplement

Dear Readers,

Last week, we discussed diets to combat high cholesterol. Another avenue to improve your lipid panel is the use of supplements. Patients sometimes choose supplements because they are less expensive than medication, or they cannot tolerate a particular drug's side effects.

Citrus bergamia, the bergamot orange, is a fragrant citrus fruit. It is yellow or orange, depending on its ripeness. The fruit originated in Southeast Asia but was named for Bergamo, Italy, where it first gained popularity.

In a review of twelve studies, bergamot was associated with a significant decrease in total cholesterol (TC) and low-density lipoprotein (LDL), or bad cholesterol. The reduction in TC varied from 12%-31%, and the decline in LDL was as much as 41%. The authors pointed out that the studies had limited scientific quality (1).

Niacin, or vitamin B3, has been used to increase HDL, or good cholesterol. Since HDL transports some LDL back to the liver for disposal, LDL levels diminish, and total cholesterol is lowered. However, recent studies have discovered the niacin method is not associated with lower rates of heart attack, stroke, or death. For this reason, many practitioners have stopped using the vitamin to treat high cholesterol.

Garlic is an inexpensive way to treat high cholesterol, but is it effective? Studies are mixed. A study using a mixture of fresh garlic and lemon juice showed an impressive 41-point decline in TC and a 30-point decrease in LDL. The study consisted of 112 volunteers and lasted eight weeks (2).

In another well-designed study conducted at Stanford University, garlic did not have any effect on cholesterol levels. The results were published in the Archives of Internal Medicine. In this six-month study, 192 patients who had elevated LDL levels were given a sandwich or supplements with the equivalent of 4 grams of garlic per day. Participants were closely monitored to make sure they didn't gain or lose weight, affecting cholesterol levels. At the end of six months, LDL levels were unchanged. Senior author Christopher Gardner, PhD, assistant professor of medicine at the Stanford Research Center, said, "If garlic was going to work, in one form or another, then it would have worked in our study. The lack of effect was compelling and clear."(3)

If you have high cholesterol, talk to your doctor before adding a supplement to your medicine cabinet. Supplements may produce side effects and can interact with other medications.














How Long will Newsom have One-Man Rule?

California has been a one-party state for the last decade, with Democratic governors and supermajorities in both legislative houses doing pretty much as they pleased without paying any attention to the relative handful of Republican legislators.

However, one-party rule gave way to one-man rule eight months ago when Gov. Gavin Newsom declared an emergency due to the COVID-19 pandemic, thus empowering himself to govern by decree and suspend any laws that stood in his way.

Democratic legislators were fully complicit, even suspending their proceedings and abandoning Sacramento for months. Eventually, however, even they chafed a bit at Newsom's seeming endless string of emergency orders.

In effect, some of those orders essentially made new law and while Democratic lawmakers stood by, two Republican legislators, Kevin Kiley and James Gallagher, filed suit, alleging that Newsom had gone too far.

Last week, Sutter County Superior Court Judge Sarah Heckman sided with the Republicans, declaring that Newsom's order changing procedures for the

ing a mandate that every voter be sent a mail ballot, crossed the line.

later ratified the election changes, Heckman wrote that it was still important to place limits on a governor's powers under the California Emergency Services Act. Heckman indicated that in her final ruling, she would permanently enjoin Newsom from issuing any order "which amends, alters, or changes existing statutory law or makes new statutory law or legislative policy."

"The doctrine of the separation of powers prohibits any of the three branches of government exercising the complete power constitutionally vested in another or exercising power in a way which undermines the authority and independence of another," Heckman, who was elected in 2012, wrote.

The law empowering a governor to declare an emergency and suspend laws that impeded a rapid response was clearly aimed at some immediate catastrophe such as a flood, an earthquake or a riot. It envisioned something like then-Gov. Pete Wilson's suspension of contract bidding laws to quickly rebuild a major freeway after the 1994 Northridge Earthquake.

COVID-19 required a rapid response, but it's also something that could last, in one form or another, for years. Conceivably, Newsom could continue governing under his emergency decree for the remainder of his first four-year term.

Newsom claims moral imperative as justification for his acts, but if elected officials ignore laws they don't happen to like or find inconvenient, they undermine the concept of governance under law and encourage disrespect for legal authority. Ironically, this is the same governor who demands that 40 million Californians obey his pandemic decrees, such as shutting down small businesses

Judge Heckman's order will certainly be appealed and the issue will probably wind up in the state Supreme Court. Newsom press secretary Jesse Melgar said Newsom and his advisers "strongly disagree" with "specific limitations" on the governor's emergency authority.

Meanwhile, it's time for the entire Legislature, not just Kiley and Gallagher, to reassert its co-equal authority rather than allowing Newsom to operate indefinitely as a one-man band.

The law that gives Newsom the authority to declare an emergency also allows the Legislature, on its own, to end such an order.
