Volunteers Assemble Humanitarian Food Boxes for Hope Center

OROVILLE, CA (MPG) - Keith Stutznegger, retired Oroville dentist, and his wife, Susan, are becoming experienced humanitarians. After the 2018 Camp Fire in Paradise, Keith and Susan were tasked with organizing a community work project to assemble 5.000 food boxes for fire survivors. A few weeks later, when greater need became apparent, the Stutzneggers organized an additional project to assemble 2,500

GRIDLEY, CA (MPG) - The Gridley Parks and Recreation Department has the opportunity to take advantage of a minimum \$200,000 in grants for park improvement projects city wide under the umbrella of Proposition 68.

Grant writer Lucy Cardenas, who has partnered with Gridley Parks and Recreation Director Trina Leishman, is holding a series of Zoom meetings in order to poll the community on what further improvements residents and parents would like to see at Gridley's parks. Vierra Park has already received an \$180,000 upgrade

to the playground equipment, which Gridley families have been incredibly grateful for. Future suggested improvements to Vierra Park funded by this new grant are not limited to: creating ADA compliant walkways and bathrooms, adding more ball fields, soccer fields, expanding and centralizing the snack-bar, resurfacing the tennis courts, more picnic tables, solar lighting and more.

The first meeting, held Tuesday, October 13th at 9:30 a.m., dealt with the removal of the historic trees at the park to make room for some of the new additions. Leishman assures that she is "equally concerned about

the trees and will be working around existing, healthy trees" when considering park improvements. Gridley Parks and Rec is encouraging more community input to voice concerns such as these, pose questions, and make suggestions in order to shape the future layout of park so as to best serve the Gridley community.

The grant application is due December 14th and Cardenas is hoping to get it submitted early. "We're competing with all of California and we want Gridley to be one of the grantees for this grant process," says Cardenas. "We want to make sure that everybody enjoys

this park. This is such a beautiful city and we want to get as much funding as possible so that we can make the

needed improvements." The next scheduled meeting is for Thursday, October 15th at 6:30 pm and a meeting broadcasted in Spanish will be held Sunday, October 18th at 2:00 pm. Restrictions Set on **Oversize** Loads on Highway 99 in Live Oak

LIVE OAK, CA (MPG) -Caltrans is reminding trucking companies about temporary restrictions for hauling oversize wide loads on State Highway 99 through Live Oak.

The Caltrans Transportation Permit Office in Sacramento has set a maximum width of 10 feet for oversize loads such as mobile homes and heavy

The restrictions cover a stretch of Highway 99 between Bishop Avenue and Nevada Street North and will remain in effect through October 31, 2021. Violators are subject to a traffic ticket and fine.

In July, Caltrans and the City of Live Oak started construction on a two-year \$36 million pavement. safety and streetscape project to replace the old pavement, flatten the roadway, construct new sidewalks, curbs and gutters, upgrade drainage systems, and improve traffic signals, bicycle and pedestrian signals between Pennington Road and Elm

Since the start of construction, roadside message boards have alerted motorists that the roadway narrows ahead. The width of the traffic lanes has been reduced by a foot to 11 feet. In some cases, the shoulders have been narrowed down as well to accommodate roadway construction behind a protective concrete barrier, or K-rail.

The temporary permit restrictions are aimed at keeping extra wide loads from hanging over the center line and creating a potential safety hazard to approaching vehicles in the construction area.

Caltrans advises motorists to "Be Work Zone Alert." The department will issue construction updates on Twitter @CaltransDist3 and on Facebook at CaltransDistrict3. For realtime traffic, go to Caltrans' QuickMap quickmap.dot. ca.gov/ or download the QuickMap app from the App Store or Google Play.

Interested in what the going rate for public service is? You can go to Transparent California at www.transparentcalifornia. com. State Law requires government agencies to post salaries of public sector workers. Just a few data points for conversation; In 2017, Live Oak Unified had 105 certificated employees, and the average salary for people with a teaching credential was \$73,654 - add-in benefits and other compensation, and the number comes to \$101,985. That was in 2017, the new numbers from the district have not come in. In the Gridley Unified District, the average salary for people with a teaching certificate was \$67,214, and total compensation was \$89,071, which was reported for 2018 activities. Manzanita district had 14 teachers in 2018 with an average salary of \$67,576. If you think working at College may pay better, you are right. Butte College's average pay for a "Philosophy Instructor" was \$115,662 in 2019. For the record, I would be willing to teach you Philosophy for \$99,999; I am a bargain.

If those salary figures seem high to you, and you were shocked, the real shocker is they are not enough to afford a home

in California. The median (that means average) price of a home in California is now \$706,900. That price is mind-boggling and a real public policy problem.

I am in receipt of a letter from Gridley High School principal Justin Kern. In his letter, he expresses his frustration and professional opinion that locking down schools and not allowing children to participate in their traditional educational activities is bad policy. Says he: "I cannot think of a decision causing more harm than shutting down our schools. Our collective approach has been the most punitive to school-age children - the data, the science, and relative common sense simply does not support the severity of the path chosen. Program - Separate from responders allow customers to return home PG&E recommends the following safety tips for homes and business in impacted areas.

Returning Home Safety Tips:

If you see downed power lines, treat them as if they are "live" or energized. Keep yourself and others away and call 911, then notify PG&E at 1-800-743-5000;

If you smell the distinctive "rotten egg" odor of natural gas, leave the area and call 911 immediately, and then call PG&E at 1-800-743-5000;

If you or someone else shut off gas service, DO NOT turn it on yourself. Contact PG&E or a qualified professional to perform a safety inspection before restoring gas service and relighting pilot lights;

Check for damaged household electrical wiring. Turn off the power at the main electric switch if you suspect damage and consult an electrician:

Make sure generators are properly installed by a licensed electrician. Improperly installed generators pose a significant danger.

Biggs Students Are Going Back to the Classrooms!



BIGGS, CA (MPG) - Biggs Unified School District (BUSD) Superintendent Doug Kaelin has officially announced that the BUSD is the first public school district in Butte County to have its application for opening approved by the Butte County Department of Public Health.

The Superintendent received the approval notice dated October 2nd, outlining that Biggs has been granted a "Conditional waiver approval for in-person

instruction in alignment with State guidance and standards" for grade K-6 at the Biggs and Richvale Elementary school sites beginning October 7th, 2020.

Superintendent Kaelin plans to reopen both Elementary and High School campuses for In-person instruction beginning Monday, October 19th adhering to strict social-distancing guidelines. The district plans to mail out letters to parents and guardians outlining what the process will look like and the requirements for students to return to their classrooms.

Another Vague Decree from Newsom

Gavin Newsom is fond overly so – of declaring "big hairy, audacious goals" and doing something that implies he's striving to achieve them.

However, he's been compelled to devote virtually all of his time to managing crises this year: the COVID-19 pandemic, followed by a recession as he shut down businesses to battle infection, a state budget deficit caused by the recession, record heat waves that overwhelmed the state's power supply, and wildfires of historic proportions.

Managing crises is essentially a reactive process while Newsom fancies himself a proactive striver and doer, not unlike, it should be noted, Jerry Brown in his first stint as governor four decades ago.

Newsom began the year in characteristic form, devoting virtually his entire State of the State address to homelessness and a chronic shortage of housing.

"After decades of neglect and inadequate responses, we are putting our entire state government on notice to respond with urgency," Newsom declared. "We need a new approach. In the budget I just submitted, I proposed a new California and, with it, a whole new way of investing in homeless solutions."

He also declared "a commitment - right now, this year – to major reform that will eliminate red tape, and delays for building critically needed housing – like affordable, multifamily homes - especially near transit and downtowns."

Never mind. Within days of delivering that speech, Newsom issued his first emergency order on COVID-19.

Newsom is now trying to return to a proactive mode by issuing sweeping executive orders on climate change that make headlines, but really are no more than declarations of lofty intent.

The first declared that California will ban the sale of vehicles powered by internal combustion engines by 2035, but the order only directed the Air Resources Board to explore how that might be done.

The second, issued last week, directed state agencies to devise ways to "protect" 30% of California's land and coastal waters by 2030 to reduce greenhouse gases and promote biodiversity, boasting that California would be the first state to adopt the "30-by-30" program being advocated globally.

"Once again, California is taking on the mantle of global climate leadership and advancing bold strategies to fight climate change," Newsom said. "The science is clear that, in our existential fight against climate change, we must build on our historic efforts in energy

Access to Housing Fund, and emissions and focus on our lands as well."

> But what does "protect" actually mean?

Newsom's order basically enacts a piece of legislation, aptly named Assembly Bill 3030, that passed the Assembly this year but died in the Senate Appropriations Committee without a vote.

It had an extensive airing in the Senate Natural Resources and Water Committee, whose staff raised the definition question, to wit:

"It is a complicated task to determine how much of the state's land, water, and ocean resources are already protected, in part because there is no one uniform definition of 'protection' in state law. These and similar terms can represent a sliding scale depending on the types of restrictions and allowable uses, including the degree of human access."

In fact, the meaning of "protect" varies greatly even among its advocates, as the staff report detailed.

That lack of specificity is why those who catch fish, farmers, hunters, housing developers and others opposed the bill. They saw it as carte blanche for state agencies to issue restrictive land use rules.

So Newsom gets another headline attesting to his "bold strategies," but as with his decree on cars, we won't know, perhaps for years, whether it has any concrete meaning.

Man Pleads as Charged to South Oroville Shooting

Butte County District Attorney's Office

- Butte County District Attorney Mike Ramsey announced a Berry Creek man admitted to an August 28, 2020 shooting in Oroville and unlawful possession of a firearm. He also pled to separate charges stemming from a 12-mile vehicle pursuit on September 6, 2020.

Jesse Dean Sweeney Jr., 22, plead as charged in Butte County Superior Court to Discharge of a Firearm with Gross Negligence, Possession of a Firearm by Vehicle while Driving Recklessly, and Driving Under the Influence of Alcohol.

Ramsey said on August 28, 2020, shots were reported to have been heard in the area of Spencer and Mesa Avenue in south Oroville. More shots were later reported on D Street. When officers arrived at these locations, they spotted a speeding black sedan believed to be involved with the shooting. When officers attempted to stop the sedan,

2.2-mile long pursuit through the residential streets of Oroville. The pursuing officers briefly lost sight of the sedan before finding it abandoned at the intersection of Bird and 6th Street. Witnesses in the area reported seeing a female exit the driver's seat.

The female driver was located and arrested on Bird Street. She presently faces charges of Fleeing a Pursuing Peace Officer's Motor Vehicle and Accessory After the Fact. Sweeney and another male were found hiding in the same area of Bird a Felon, Fleeing a Pursuing Street. Near Sweeney in Peace Officer's Motor yard, officers located a 9 mm semi-automatic handgun. Back at the scene of the shooting, officers found several 9 mm spent casings.

Oroville Police officers released Sweeney and the other man pending further investigation. Luckily, Ramsey said, no one was injured in the shooting. However a neighborhood vehicle was found to have a bullet hole in it. Officers then sought the advice of the District Attorney's Office. Ramsey said his

it failed to yield resulting in a office listened to the officers and directed them to seek a warrant for Sweeney's arrest, which was signed by a local judge.

> On September 6, 2020, a State Parks officer saw Sweeney driving a vehicle in the Oroville area on Olive Highway near Medley Lane. When the officer tried to stop the vehicle, Sweeney failed to yield resulting in a 12-mile pursuit. The pursuit ended when the vehicle collided into a tree at the intersection of Pam R Lane and Bald Rock Road. When officers made contact with Sweeney, they determined Sweeney was under the influence of alcohol.

Sweeney faces up to 4 years and 4 months state prison when he is sentenced on November 4, 2020. He remains in custody. His male co-defendant also faces charges of Discharge of a Firearm with Gross Negligence and Possession of a Firearm by a Felon. A preliminary hearing for him is set for October 21, 2020. Discharge of a Firearm with Gross Negligence is a "strike" in California.

Felon Convicted for "Pretend" **Bank Robbery and Criminal Threats**

Butte County District Attorney's Office

BUTTE COUNTY, CA (MPG) A 47-year-old Oroville man was convicted of two counts of robbery and four counts of criminal threats by a Butte County Superior Court jury for a 2018 Oroville bank robbery which occurred just days prior to the devastating Camp Fire. The jury unanimously found Joshua Daniel Newens guilty despite a point before he could escape. defense "mental" claim that the robbery was only a "pretend" robbery. Newens' jury trial had been delayed many months as his attorney tried to get his case diverted to a mental health court.

Butte County District Attorney Mike Ramsey said the evidence presented to the jury included November 5, 2018 surveillance footage from the Oroville Bank of the West showing Newens entering the bank and ordering everybody to the ground. Newens claimed to have a bomb and threatened to kill everyone in the bank unless they followed his demands. Newens could be seen on the surveillance tape going down the teller line, gesturing violently as he took money from the tellers. Ramsey said the victims testified Newens put them in fear for their lives and they

were scared of what would happen if they did not comply with his demands.

After taking the money, Newens launched into a short profanity-laden rant, yelling at the victims to remember his name and remember his face. Thankfully, Ramsey said, the Oroville Police Department responded quickly, arriving less than three minutes after the initial 911 call and immediately detaining Newens at gun-

At the trial, Newens' defense counsel presented evidence that approximately an hour before the robbery; Newens was contacted at another Oroville bank creating a disturbance in the parking lot. He made statements to a responding officer that he was going to "pretend" to do a bank robbery. It was determined he was unarmed and he was

sent on this way. However, Ramsey said his trial prosecutor DJ Lee showed that after the Bank of the West robbery, Newens told arresting officers that he "came to "rob this mother f-ing bank and to show this mother f-ing place what's up." And, even though no bomb was ever located, Newens was found in possession of a water bottle that he later admitted to using as if it were a bomb.

Witnesses from inside the bank also testified Newens seemed like he "meant business" and Newens absolutely knew where he was and what he was doing when he took several thousand dollars from them.

Newens made additional statements to officers on the way to the Butte County Jail, saying that he had needed some quick money to get out of town so he decided to rob the Bank of the West. However Ramsey said this statement was excluded from evidence by the judge on a claimed Miranda violation. Despite this ruling, Ramsey said his prosecutor DJ Lee persevered and convinced the jury of the true nature of Newens' intent to rob.

Ramsey said the trial judge is scheduled to determine next week whether Newens' two prior "strike" convictions are valid and true. Newens has previously been convicted in Butte County of First Degree Residential Burglary and Discharging A Firearm With Gross Negligence, as well as other felony convictions. Due to these prior "strike" convictions, Newens would be designated a "Third Striker" if the judge finds them to be true and faces a possible 25-to-life prison sentence.

If the collector agrees to settle the debt, get it in writing and keep the document as proof in case they "forget" they made the offer.

Also, be completely up to speed on your accounts. Know what you owe, who you owe, and have a record of all the payments you've made. Knowing the facts gives you the upper hand in any situation. Dear Dietitian

Dairy and Heart Disease

Dear Dietitian,

I typically drink skim milk, but I love the rich taste of whole milk. A friend recently said dairy fat is good for us and doesn't clog the arteries like the fat in meat. Is this true?

Thank you, Laura

Dear Laura,

A rich, creamy glass of milk is soothing, satisfying, and nutritious. Dairy products, such as milk, cheese, and yogurt, are excellent sources of calcium, which we need for healthy teeth and bones. Around the age of twenty-five, our bodies no longer build bone, where most of our calcium is stored. To preserve bone mass, it is vital to consume calcium in our diets. It is especially important for post-menopausal women to consume a consistent source of calcium, since estrogen levels are lower. In women, estrogen plays an essential role in preventing bone loss.

Of course, there are vegetarian sources of calcium, such as fortified soy milk and broccoli. Surprisingly, shrimp is a good source of calcium. However, the majority of Americans get their calcium from dairy products. According to the USDA, in 2019, the average American consumed 20 pounds of ice cream, 148 pounds of fluid milk, and 40 pounds of cheese (1).

As part of a heart healthy diet, the Dietary Guidelines for Americans recommend low-fat dairy over whole-fat. Recent studies have challenged this position, with some research revealing that dairy fat may have a protective effect against heart disease.

In the Prospective Urban Rural Epidemiology (PURE) study, over 136,000 people documented dairy intake using food frequency questionnaires. Dairy products recorded were milk, yogurt, and cheese. After fifteen years, those with a higher intake of dairy (more than two servings per day) compared with no intake had fewer deaths from heart disease, as well as fewer major heart attacks and strokes (2).

Other studies have associated dairy intake with decreased rates of Type 2 diabetes. Randomized, controlled trials (RCTs) are considered the gold standard of research, and few exist on this topic. The RCTs available suggest no effect or a moderate positive relationship between dairy intake and type 2 diabetes.

It is important to note that the vast majority of studies on dairy consumption do not show an advantage of whole-fat over low-fat when it comes to preventing heart disease. Furthermore, many studies (excluding the PURE study) that tout the health benefits of dairy fat are funded by the dairy industry. When an industry finances research on its own product, there is a risk of bias in favor of the product.

What is one to do? We mustn't look at just one nutrient or one food when deciding on a healthy diet. We need to have an overall attitude towards healthy eating. Research has consistently shown that replacing saturated fat with unsaturated fat lowers cholesterol and the risk of heart disease. That said, a healthy diet has to be livable. You will find low-fat yogurt and 1% milk in my refrigerator but not low-fat cheese because, well, it just isn't cheese.



Oakland Man Pleads Guilty to Evading Arrest Causing Death

BUTTE COUNTY, CA (MPG) -Butte County District Attorney Mike Ramsey announced an

Oakland man pleaded guilty today for a deadly high-speed 15-mile chase that happened on July 30, 2020. David Lee Survine Jr.,

31, pleaded guilty in Butte County Superior Court this morning to Evading the Police Causing Death.

Ramsey said the chase started when the California Highway Patrol attempted to stop Survine for speeding on eastbound Highway 162 near the intersection with Aguas Frias Road in southern Butte County. A CHP Sergeant on patrol clocked Survine's vehicle at 85 mph in a 55 mph zone. When the Sergeant activated his emergency lighting to initiate a traffic stop Survine accelerated to over 100 mph. Survine continued eastbound on Highway 162 to its intersection with Highway 99. Survine failed to stop at the stop sign at the intersection, turned northbound onto Highway 99, and further accelerated to

over 130 mph. Ramsey said while driving ejected from the vehicle

northbound on Highway 99, Survine used both the southbound lane and the shoulder to pass slower northbound vehicles, forcing multiple vehicles to take evasive action Survine's extremely dangerous driving, CHP positioned an officer with a spike strip near the intersection of Highway 99 and Nelson Rd. As Survine approached the officer's location, the officer's radar clocked Survine at 131 mph. As the officer deployed the spike strip Survine swerved to the right in an apparent attempt to avoid the spike strip. Despite the swerve, the front driver's side tire of Survine's vehicle hit the spike strip.

Ramsey said approximately a quarter mile after hitting the spike strip, Survine lost control of the vehicle and flipped several times. The vehicle came to rest off the southbound shoulder of Highway 99. The wreck caused a dust cloud that obscured vision of the wreckage for several minutes. When CHP officers arrived at the wreck, they found the body of Kristen Jones, 39, of Rialto near the wreckage. Jones had been

during the crash. Jones was pronounced dead at the scene. Survine was not immediately located anyway around the crash scene.

Approximately two and to avoid collision. Because of half-hours later, a motorist contacted CHP to report an injured male laying on Nelson Rd approximately a half mile east of Highway 99. CHP officers responded and found Survine. Survine had visible injuries, which identified him as the driver of the vehicle. He was arrested and transported to Enloe Hospital.

While at Enloe Hospital, Survine admitted to driving the vehicle and identified Jones as his girlfriend. Survine told CHP officers he and Jones had left Oakland earlier in the day and were in route to stay with family in Oroville. Survine admitted knowing that the vehicle he was driving was stolen. Survine also admitted he knew he was being pursued by CHP. Survine stated he believed if he drove fast enough, CHP could no longer pursue him.

Ramsey said Survine will be sentenced on November 5, 2020. Survine faces up to 10 years in state prison based upon his plea.



Eckert Facing DUI Charges, Subject of Investigation

GRIDLEY, CA (MPG) - In the early hours of Saturday, October 3rd, Gridley's City Administrator and Finance Director, Paul Eckert, was arrested by California Highway Patrol.

Officer Draper at Oroville CHP shares that the arresting officer stopped Eckert shortly after midnight due to a mechanical violation - no taillights during the hours of darkness. Subsequently, Eckert was arrested under suspicion of DUI and booked into Butte County Jail at approximately 2:38 am under the charge of driving under the influence of alcohol or drugs, or California vehicle code 23152 (f). This charge, 23152 section f, includes both street and/or prescription drugs under its definition of "driving under the influence".

According to Officer Draper, the results of a toxicology report that will either confirm or clear Eckert of said charge, will be provided to the legal team processing the charges once it is completed. At this point

the court system has taken over and will decide the outcome.

In addition to the DUI charge, Eckert has been the subject of a Gridley Police Department investigation. Holding with GPD policy on active investigations, information is not released until the investigation comes to completion. The following is a statement provided to the Gridley Herald by Police Chief Rodney

"On September 25th, 2020 at approximately 1600 hours, the Gridley Police handled a call for service, reporting two female juveniles were contacted by a male alleging he had taken photos and asked inappropriate questions. During the course of the investigation the male involved was identified as Paul Eckert. An extensive investigation was conducted with all involved parties.

Upon completion of the investigation, it was determined Paul Eckert had not committed any criminal violations, nor any violation of misconduct."

· Be aware of possible tripping hazards in your kids costumes


- · Plan a safe route for trick-or-treating



Out-of-Work Californians Urge Governor to Expedite Unemployment Benefits

SACRAMENTO, CA (MPG)

- Standing in front of California's Employment Development Department (EDD) headquarters, seven residents of Northern California urged Governor Newsom to be more handson with helping those in need. Like millions of Californians, these residents lost their jobs after the Governor triggered a shutdown of businesses and for all Californians.

"The experiences of outof-work Californians and EDD's lack of action are shameful," said Senator Jim Nielsen (R-Tehama). "The Governor and his Administration must do better to serve the people who elected him. Californians deserve better."

Waiting for unemployment benefits has been a

shared frustrating, infuriating and devastating experience.

Phone calls are cut off after hours of waiting on hold. Mails and emails gone unanswered. Endless requests for legal documents that are not always related to the applicant's claims, has resulted in a nerve-racking game of waiting.

With the support Senator Jim Nielsen, Sacramento area residents spoke up for the 1.6 million Californians who are still waiting for their benefits.

"Action must be taken ordered a shelter-in-place now to help those who are waiting for their benefits," said La Toya Horne of Sacramento. "I don't want anyone else to deal with the humiliation and bureaucratic obstacles I had to endure. I lost my home. No one should have to lose their home while waiting for a benefit they have earned and deserved."

> Ms. Horne owned a thriving salon in an upscale

part of town. She applied etc. to work out payment we need help. We are lawfor unemployment in March when salons were forced to close. Months later, a stranger contacted Ms. Horne through social media to inform her that mail from EDD arrived at his house. She had lived at that address 10 years ago. When she amended her application and updated her identification, EDD told her she needed a judge to resolve the issue. They later reversed their decision.

Resolved in her passion to help others, Ms. Megan Williams drove nearly 100 miles to urge the Newsom Administration to act swiftly to get benefits to applicants.

"It is very disheartening to see the lack of urgency. I feel bad for the people who are not as lucky to have others to lean on financially, or who have landlords that are not as understanding as mine. The stress of having to call phone companies, credit cards companies, plans or shifting debt from one credit card to another, just to maintain on time payments, or keep things turned on, is unnecessary," Ms. Williams stated.

EDD just emerged from a two weeks closure that left an estimated 100,000 people unable to apply for benefits. The hiatus was supposed to "reset" its operations and implement a new system. However, Senator Nielsen's office was informed Tuesday that the backlog to review weeks to 11 weeks.

Understanding the financial and mental toll of waiting for EDD's slothlike movements, Mr. Rick Walters of Yuba City joined the call to ask the Governor to immediately take action to help those who have lost their jobs due to the government-imposed lock-down.

"Government is supposed to work for us when them, I would not have

abiding taxpayers. This experience was beyond stressful. As Governor, you need to act now to protect our citizens of this state," Mr. Walters appealed.

Like the 1.6 million residents still waiting for their benefits, Ms. April Carlton of Citrus Heights has been able to meet most of her financial obligations thanks to her close-knit family.

As an office manager and bookkeeper at a small business, Ms. Carlton's hours were reduced and she was claims went from eight later furloughed. EDD denied her claim based on a name change in 2018. Ms. Carlton provided EDD with judgment orders for the name change, immigration papers and proof of residence. Despite providing all legal documents, Ms. Carlton is still waiting for her backdated benefits.

"Thank God for the sup-

been able to handle this financially straining and emotionally infuriating process," said Ms. Carlton.

Sherri Bailey of Rancho Cordova, along with her 82-year-old mother, joined the group to remind EDD officials of their commitment during the Great Recession to the public and lawmakers.

"They are not keeping the promise they made in 2008. They owe it to Californians to tell us what they did do to serve the public. Clearly, their system is still broken."

Sutter County Will Buy Motel with CARES Act Funding

- Just six weeks after the Sutter County Board of Supervisors applied for emergency funding to purchase a motel for affordable housing and wrap around services for individuals and families, California Governor Gavin Newsom today announced approval of a \$6.7 million grant to buy the 62-room Baymont Motel, self-storage yard, and restaurant on Highway 99 near Oswald Road south of Yuba City.

cess is complete, the County intends to immediately quitclaim the property at 4228 Sawtelle Avenue (Highway 99) to Habitat for Humanity Yuba-Sutter to be operated as permanent housing for Sutter County residents who are currently, or become, homeless, according to County Administrative Officer Steven M. Smith.

Habitat for Humanity of Yuba-Sutter will work with Hands of Hope in Yuba City to administer the permanent housing solution and provide a variety of services to assist homeless individuals in retreating from the insecurity of the river bottoms and the streets into the security of four walls and a locked door. The agencies will work closely with Sutter County Health and Human Services Department, but the operation will be entirely under the umbrella of Habitat for Humanity.

"This is not a homeless 'shelter'," CAO Smith pointed out when the Board of Supervisors voted 5-0 on August 11 to submit the grant application to the California Department of Housing. "This will be affordable housing targeting those with a history of homelessness operated by an agency whose mission is to house people."

Governor Newsom announced the Homekey project in June. The state offered a total of \$600 million in grants to jurisdictions throughout the state for

creative solutions to get homeless individuals off the streets during the pandemic. Most of the funds used to purchase the motel were allocated to California when Congress passed, and the President signed, the Coronavirus Aid, Relief. and Economic Security (CARES) Act in late March. He announced 19 new projects today, bringing the total funded to date to 49. (For a full list of projects, visit https://www.bcsh.ca.gov/ homekey/)

Homeless individuals housed at the Habitat for Humanity will pay a capped percentage of their to live on the property. While the rental amounts will be small, it will help pay for some of the services to be provided, Habitat for Humanity Yuba-Sutter Chief Executive Officer Joseph Hale told the Board of Supervisors.

The operation of the selfstorage business will help Habitat for Humanity fund maintenance and services at the property. And the agency operates a Re-Sale store out of a former department store in Marysville that raises additional funds that can be used in supporting the motel project. Hale said Habitat for Humanity intends to work with Hands of Hope, which has more than a quarter century of experience serving the homeless population.

"This is an outstanding opportunity to provide a safe, secure, sanitary place for individuals, rather than the streets and the rivers," said Board Chairman Ron Sullenger. "By using available grant funds to purchase a property to provide housing, and transferring the property to a non-profit agency to operate it and provide services, the County is improving opportunities for housing without becoming a

landlord. "At this property, residents can feel safe, get any help they need, and begin anew. Combined with our Better Way emergency housing shelter and 13 other programs for the homeless in Sutter County, this will provide people with necessary alternatives to camping in public places. This will allow Sutter County to enforce the no camping ordinance it adopted last year."

"Habitat for Humanity's mission is to end homelessness and substandard housing," Hale said. "For a long time the focus has been on prevention through the construction of low income housing and home repairs for seniors. With this Permanent Housing project, we hope to be a hand up to those actively experiencing the struggles of living without a place to call home." The Board of Supervisors considered a number of properties before making an offer on the Baymont Hotel, which is owned by Ray Patel. The property went into escrow last week. The purchase price is \$7.2 million. Sutter County will commit \$500,000 in CARES Act funds it previously allocated to make up the difference between the Homekey grant and the purchase price.

"This project has many benefits," said CAO Smith. "It will move people out of homelessness, off the streets and into a secure, supportive environment, yet charge a percentage of their income as rent so each resident will have skin in the game so to speak. The County already puts some individuals in motel rooms at the daily rate if they are experiencing chronic medical problemsthis will reduce those costs. It will allow us to engage in enforcement of the ordinance that prohibits camping on county property, including county road right of way, and our precious rivers."

Smith praised County staff and leadership at Habitat for Humanity for putting a complicated application together in a short period of time. Alternatives to the street and the river bottoms have been a priority of the Board of Supervisors since 2017
