Cancels Classes

CHICO, CA (MPG) - Days into the start of Chico State University's Fall Semester, reports of positive reports of COVID19 among students began to surface. Students had returned to the university on August 24th, some lodging in campus dorms and attending the few in-person instruction classes being held on campus, while others attended virtual courses.

On Wednesday, August 26th, the Butte County Department of Public Health warned of a spike in COVID19 infections associated with college age persons, and that over 15 new COVID cases among people the ages of 18-24 had been identified in an apartment complex near the Chico State University Campus.

Then, Sunday, August 20th, just a week after instruction began, University President Gayle Hutchinson ordered the closure of campus dorms and the cancellation of inperson instruction due to the "alarming" increase in cases and concern for student safety. Hutchinson stated that "Nearly every on-campus residence hall has been impacted by at least one positive case and there's concern that numbers will only increase." An update released by the University the following day states that they had learned of an additional nine new COVID cases involving students who spent time in Tehama Hall, Mechoopda Hall, Wildcat Recreation Center, and the Sim Center. These recent incidents bring the total number of cases on campus since the beginning of August to 36 (not all currently active).

Students currently living in residence halls have been given until Sunday, September 6th to find alternate housing. Hutchinson has been quoted to write, "Simply put, we need students out of the residence halls as quickly as possible for their own safety... Unfortunately, with COVID-19, exposure to even a small number of individuals has serious consequences in terms of community spread...". The limited number of inperson classes being held will continue virtually for the remainder of the fall semester.

Chico State has been and will continue to work closely with the Butte County Department of Health and with infected individuals to enact contact-tracing procedures. Individuals that believe they may have been Continued on page 3

Gridley Thumbs and Roots

Mealy bugs are the current bane of my container plants. Along with aphids, mealybugs are common garden sap sucking insects. Mealybugs are a scale-like insect. They cause damage to plants similar to aphids. Mealybugs are covered in a whitish 'mealy' wax, which helps lower the loss of water from their soft bodies. The adults are slow-moving insects.

in survival tactics. They prefer warm, humid, sheltered sites. I know they like mild sheltered places so I've always been puzzled when they show up at one hundred degrees outside. Then I realized that the places where they live are micro-climates on the plants. That wee space where the leaf meets the stem is shaded and protected for the plant's sake. This micro-climate stays within the 77°F-80°F temperature range and holds the humidity that helps mealybugs thrive.


Mealybug populations can build up quickly. They have a number of overlapping generations per year. Eggs can be laid singly or in clusters. Egg clusters are usually embedded in a still have an cocoon of waxy filaments. Newly hatched "crawlers" look for sheltered These pests are versatile feeding sites. They can be

blown to new sites by the wind. While going through 5 molts before becoming adult females there is one point when they are in the last stage of molt, a silk cocoon develops winged males. Adult males have no mouthparts - their sole purpose is to mate with females.

Due to rapid breeding mealybugs become resistant to sprays quickly. Getting rid of them is a practice in patience and creativity. Sprays with horticultural soap desiccate and suffocate the insects, as does 70% rubbing alcohol. Diatomaceous earth can work by getting trapped in their joints. If any of the newly hatched "crawlers" are missed you

Dear Dietitian

Weight Gain

Dear Dietitian.

I recently lost forty pounds to get my cholesterol level down. My LDL went from 150 to 117, and I'd like to get it down to 100. I am 70 years old, and the doctor wants me to gain a few pounds! He says if I were to get sick, I would need some extra weight as a safeguard. How am I supposed to gain weight AND get my LDL down at the same time? I am 5 feet 7 inches tall and weigh 135 pounds.

Sincerely, Paula

Dear Paula.

First, I want to congratulate you on your success! You are a dietitian's dream! You have identified two goals that, at first glance, appear to be opposites. We generally associate high cholesterol with being overweight or with an unhealthy diet. Your doctor is correct in saying that if you encounter an extended illness, you will possibly lose weight and become malnourished. Malnourishment puts everyone at a disadvantage in recovery, especially those 65 years and older.

In case some readers need a review of cholesterol terms, low-density lipoprotein (LDL) is often called "bad" cholesterol, while high-density lipoprotein (HDL) is referred to as "good" cholesterol. The best way to achieve weight gain while lowering your LDL is simply to eat more healthy food. You will need to take in at least 300 extra calories every day. You may choose more fruit, more lean proteins, and more whole grains. Continue to eat healthy fats, those that are monounsaturated or polyunsaturated, and consume less saturated fats (animal fats). Limit refined carbohydrates and sugar.

Monounsaturated fats include olive oil, canola oil, nuts, avocados, nut butters, olives, and peanut oil. Polyunsaturated fats are found in corn oil, safflower oil, and sunflower oil. Omega-3 fatty acids are also included in this category, and these are found in walnuts and fatty fish, like salmon, mackerel, trout, and sardines.

The next strategy is to raise your HDL level. Increasing your HDL will help lower your LDL-cholesterol. Health experts believe that HDL acts as a house cleaner by "sweeping up" some LDL particles and carrying them back to the liver for disposal. The best way to increase good cholesterol is through exercise - just 20 minutes of moderate exercise at least four times a week.

It is also essential to avoid trans fats. While trans fats have been banned in the US, a food manufacturer is allowed to claim zero trans fat on the nutrition label even when there are 0.5 grams of trans fat per serving. If you consume only one serving once in a while, there is no problem. Look out for partially hydrogenated oils (PHOs) on the ingredients list, as these are a source of trans fats. PHOs are found in non-dairy whipped topping and non-dairy coffee creamer, to name two commonly used products.

Finally, consider seeing a Registered Dietitian Nutritionist (RDN), who will work closely with you to help you reach your goals. Most insurance plans pay for an RDN consult, and your doctor will provide a referral for you.

I get what you're saying. It might help speed up the process a tiny bit, but the habits that got you into debt in the first place won't change just because you've switched you're talking about is an easy way to lower the interkeep you from taking on more debt.

Many people think they've really done something to solve their debt problems when they do this. But you've got to remember that getting out of debt, and gaining control of your finances, is all about changing the person you see in the mirror. You've got to make a commitment to getting out of debt, staying out of debt, and sticking to a written, monthly budget - that means keeping track of every, single dollar and living on less than you make.

In many cases, when people have problems with debt it's the result of unwise lifestyle and financial choices. But guess what? When you change, interest rates don't matter nearly as much. And when you shift your mindset about money, that will make a difference in a way that changing credit card companies and chasing lower interest rates can't!

Newsom's Plan Imposes Risk-based Restrictions; Expands on Times



Office of Governor Gavin Newsom

SACRAMENTO, CA (MPG) - Governor Gavin Newsom unveiled the Blueprint for a Safer Economy, a statewide, stringent and slow plan for living with COVID-19 for the long haul. The plan imposes risk-based criteria on tightening and loosening COVID-19 allowable activities and expands the length of time between changes to assess how any movement affects the trajectory of the disease.

Like every aspect of California's response, data and science are the North Star, and as a result, this new framework makes a number of changes to the state's previous resilience roadmap.

Californians can go to covid19. ca.gov to find out where their county falls and what activities are allowable in each county.

"This Blueprint is statewide, stringent and slow," said Governor Newsom. "We have made notable progress over recent weeks, but the disease is still too widespread across the state. COVID-19 will be with us for a long time and we all need to adapt. We need to live differently. And we need to minimize exposure for our health, for our families and for our communities."

The Blueprint builds on lessons learned from the first six months of the disease – and the new scientific understanding that has been collected – to create a new system for regulating movement and COVID-19 transmissions. It includes:

(1) At least 21 days to expand activities beyond the initial tier to ensure California better limits the spread of the virus; (2) Mandatory metrics – case rates and test positivity – to measure how widespread COVID-19 is in each county and guide what is allowed; (3) A uniform state framework, with four categories instead of 58 different sets of rules; (4) A more nuanced way of allowing activity: Instead of open vs. closed, sectors can be partially opened and progressively add to their operations as disease transmission decreases; and (5) A new process for tightening back up again quickly when conditions worsen.

Based on recent data, each county will fall into one of four colored tiers - Purple (Widespread), Red (Substantial), Orange (Moderate) and Yellow (Minimal) - based on how prevalent COVID-19 is in each county

and the extent of community spread. That color will indicate how sectors can operate.

For example, in the Purple (Widespread) tier where the disease is widespread, restaurants can only operate outdoors. But once a county has achieved a lower level of disease transmission and moved into the Red (Substantial) tier, restaurants can operate with 25 percent capacity indoors or 100 patrons, whichever is fewer.

It relies on two leading health metrics: number of cases per 100,000 residents and percentage of COVID-19 tests that come back positive. In addition, counties will also be required to show they are targeting resources and making the greatest efforts to prevent and fight COVID in communities and with individuals with the highest risk, and demonstrate improvements in outcomes.

Counties must remain in every tier but purple for a minimum of 21 days before being eligible to move into the next tier. Each Tuesday, California will update each county's data for the previous week and make corresponding changes to tiers. In order to move into a less restrictive tier, a county must meet that tier's criteria for two straight

Conversely, counties that fail to meet the metrics for their current tier for two consecutive weeks must move to the next most restrictive tier. The plan also includes an "emergency brake" where the state can intervene more immediately for concerning factors like hospitalizations.

Purple (Widespread) is substituted for the previous County Data Monitoring List (which has equivalent criteria to Purple). Schools in the (Purple) Widespread tier aren't permitted to reopen for in-person instruction, unless they receive a waiver from their local health department for TK-6 grades. Schools can reopen for in-person instruction once their county has been in the Red (Substantial) tier for at least two weeks.

The plan also emphasizes that no matter what restrictions the state puts in place, COVID-19 will get the upper hand if Californians don't adapt their behaviors for the duration of the

That means, until an effective vaccine is distributed, Californians must wear a mask every time they're with people outside their household. Residents must take activities outside and maintain distance even with loved ones who do not live with them. Californians must realize that the safest place to be is still at home. And the elderly and those with medical conditions should still stay away from others as much as possible.

The Governor also announced new PSAs highlighting the dangers of social gatherings during the pandemic and partnerships with Yelp, Facebook, Google and OpenTable, which will now encourage businesses to share COVID-19 safety precautions through new features so that customers can make informed decisions to protect their health and safety.

 Never stick hands, arms, or head out of the window, and never throw things out of the windows or on the bus.







Attempted Axe-Murderer in Court

BUTTE COUNTY, CA (MPG) - A Chico man, accused of attempting to murder another man with an axe blow to the chest, was in **Butte County Superior Court** where a judge found sufficient evidence to send his case to jury trial.

District Attorney Mike Ramsey said Matthew Dorenzo, 37, of Chico, was held to answer after a preliminary hearing before Judge Stephen Benson. Dorenzo had been charged with Attempted Murder with

an Axe Causing Great Bodily Injury and Criminal Threats. Additionally, Dorenzo is charged with having a prior Assault with a Deadly Weapon as a prior strike offense for which he served prison time. Dorenzo is facing life in prison on the new attempted murder charge.

Ramsey said on May 22, 2020 the 39-year-old victim of Dorenzo's attack was camping with several members of his family in the Butte Meadows area of Butte County, when another group of individuals (approximately 15 with multiple unrelated families) including Dorenzo, asked if they could camp nearby, across a creek. As the night progressed, Dorenzo's group began partying and was loud enough that the victim and a friend approached the group and asked them to be quiet.

Ramsey said Dorenzo, who had been drinking, grabbed an axe and yelled that he was a gang member and had been previously convicted of assault. Dorenzo also threatened to kill the victim. Dorenzo then crossed the creek and hit the victim in the chest with the axe blade. The victim fell back with the axe still in his chest. The victim removed the axe from his chest and Dorenzo helped the victim up, but then threw the victim into the creek. A melee between the two camping groups then ensued, which was only stopped when the victim's grandmother fired a .22 caliber rifle into the air.

Ramsey said the victim's wife rushed him to Enloe Hospital for treatment of his wound. The wound was over four inches in length and two inches in width, and deep enough that it struck bone. As the surgeon aptly stated, she was surprised the victim was still alive.

The judge scheduled Dorenzo for further arraignment and jury trial setting on his charges on October 14, 2020. Dorenzo in the meantime remains free on a \$1,000,000 bail bond he posted approximately a month after his arrest.

Caltrans Rescheduled around the Clock **Traffic Control on Highway 20**

SUTTER COUNTY, CA (MPG) - Caltrans announced a contractor has postponed plans to start around the clock one-way traffic control on State Highway 20 west of Yuba City.

Construction crews are now tentatively scheduled to conduct one-way traffic control between Acacia Avenue and Humphrey Road from 9 p.m. Friday, September 11 through 6 a.m. Friday, September 18. Motorists are advised to seek alternative routes to avoid congestion in the area.

The schedule change is due to recent lightning strikes that caused damage to an asphalt plant used by the contractor.

Next month's lane restrictions will allow crews to realign the roadway to connect to a newly constructed bridge spanning the Wadsworth Canal.

The highway work is part of a \$37.7 million project funded in part by Senate Bill 1 (SB 1), the Road Repair and Accountability Act of 2017, to restore nearly 12 lane miles of pavement between Lytle Road and the Sutter Bypass, widen the shoulders and replace the Wadsworth Canal Bridge.

Weather or unexpected events may delay or prolong the work. Caltrans advises motorists to "Be Work Zone Alert." The department will issue construction updates on Twitter @CaltransDist3 and on Facebook at CaltransDistrict3. 

Magalia Resident Arrested For Sexual Abuse

California's Mixed Messages on COVID-19 Create Confusion

SACRAMENTO, CA (MPG) -There have been too many conflicting messages to the public surrounding the COVID-19 pandemic. There has been a loss of focus on the people of California's overall health and wellbeing, and the guiding values of this administration have

been misplaced. Since a public health emergency was declared in March, my office has received thousands of calls from people and local governments confused by conflicting guidance. This confusion stems directly from the administration and state health authorities. Local health officials have had little to no direction; instead, they watch the governor at his noon briefings talking about his dimmer-switch approach to his health orders, while onstrated and rioted across Californians hope and pray for real answers.

"Localism is determinative," Gov. Gavin Newsom said during one briefing. When counties started opening, they were told to stop and wait for state approval, acting like more of an on-off switch than a dimmer.

At first, local variances were allowed, counties were told that an "attestation" required the health officer's signature. Later, after some counties announced openings, they were told the state would review and approve them. A defiant county risks losing state relief money. When Modoc, Yuba and Sutter counties were cleared to open by their health officers, as instructed by the state, the administration sent agents from the Bureau of Alcohol Beverage Control to shut down businesses complying with local guidance.

Things have become so bad on the local level that county health officers and other officials are caught between an irate citizenry, including death threats, and a state bureaucracy drunk with

Unsurprisingly, more than 10 county health officials have resigned rather than face the reality of having no control over the residents they took an oath to protect. And, now the California Department of Public Health director has resigned after reports of major inconsistencies in the testing data.

We were told to go for walks to get fresh air and maintain good health, but then they closed state parks and beaches while leaving others open in high infection

When protesters dem-California, the governor's response was, "God bless you. Keep doing it." Why is it that the Constitution gives us the freedom to protest, and the same amendment gives us the freedom of religion, yet we can't go to church? The governor obviously deemed church non-essential even though it's protected by the Constitution.

Since March, consolidation of political power under the guise of public health has given Newsom sole authority to freely spend tax dollars and dictate public policy at will. Our constitutional freedoms have been trampled, and we must take them back. Currently, there is one branch of government making all of the decisions, decisions aligning with one party's agenda.

The executive branch has taken the emergency declaration as a license to unilaterally govern, spend money, make policy and enforce laws without including other branches of government. History shows us that human rights given away during an emergency are rarely given back.

Perhaps most discouraging has been the abdication of the Legislature's role. Legislative leaders closed the Capitol, returning to their districts. Leaders are supposed to face fear head-on and continue to represent the people they were elected to protect.

At this time of year, parents are preparing their children to return to the classroom. Instead, counties that are on the state watchlist are required to distance-learn for now, and local school districts not on the watchlist are grappling with fears and liability that can be solved by legislative action and bold leadership. Both in short supply right now.

Californians are suffering under the confusing and ever-changing messages from the top-down rather than being guided by their local circumstances. It's time we look at individual areas of the state and implement sensible, safe policies that make sense based on the situation as they see fit by the local county health officers.

AB 3262 Amendments Made Suing Small Businesses Easier

SACRAMENTO, CA (MPG) - August 24 amendments proposed for Assembly Bill 3262 would only exacerbate an already bad idea, the state's largest and leading small-business association charge.

NFIB testified earlier before the Senate Judiciary Committee on its opposition to AB 3262, stating that (ERM) and whether their the bill increases liability on all online marketplaces, including the small online marketplaces relied upon by many small businesses. NFIB's concern is that the bill erodes the ability of small- and medium-sized businesses from using their

digital platforms.

But subsequent amendments revealed on August 24 make the bill worse by expanding the scope to cover businesses 'facilitating the placement of products into the stream of commerce.'

"Given the vague language in the bill, it is unclear which business owners will be covered under the definition of 'electronic retail marketplace' activities constitute 'facilitating' the placement of products into the stream of commerce leading to liability," said John Kabateck, California state director for NFIB.

In an NFIB survey of its members this week, 68% identified 'increased liability'

as a significant concern for them right now. "This bill will compound their existing fears, frustrations and inability to stay afloat during the COVID crisis," said Kabateck. "AB 3262 should be rejected. The policy is harmful, the last-minute amendments are flawed, and the timing could not
