## New Recipe for Salmon

California Rice Pilot Salmon Project Yields Great Results

**SACRAMENTO, CA (MPG)** - The second year of our Pilot Salmon Project fieldwork has yielded some exciting results and should pave the way for the Rice Commission and our fish conservation partners to develop methods to utilize winter-flooded rice fields to help struggling salmon populations.

In late-March, we released nearly 350 baby salmon that were raised in rice fields. Later, we released a set of control groups that were reared and released using more traditional approaches. Fish in both of these groups were fitted with a very sophisticated tag, allowing us to

track their travels through the watershed and out to the ocean. Our hope was to demonstrate rice field-reared fish might survive their journey out to the ocean better than those that are raised in hatcheries. We hypothesized this possible outcome based on previous studies showing that salmon grow very fast in rice fields because of the abundance of their natural food sources in these fields. I'm happy to say that our 2020 graduating class of our young salmon did not let us down!

Before getting to the results, it's

probably best to understand what reasonably expected salmon survival rates are from year-to-year. In extremely high-water years, it is possible to get to as high as 15 to 20 percent survival. However, those years are quite rare. In drought years, similar to the 2019/20 season, expected survival is typically around zero to 3 percent and is often close to zero.

## DA Warns of Mail Local Fraud Scam

Butte County District Attorney Press Release

**BUTTE COUNTY, CA (MPG)** - "If it sounds too good to be true, it probably is," Butte County District Attorney Mike Ramsey said as his office learned of a new financial scam attempt that has appeared in Butte County. The scam consists of attempting to have a person cash a bogus check they receive in the mail and forward a portion of it in cash back to the sender/scammer.

Ramsey said an Oroville resident recently received an official and expensive looking two-day priority United States Postal Service envelope containing a typed letter and a business check. The sender's address was listed as "Bridge City, Texas." The check was made payable to the resident for the amount of \$2,450 from a health insurance company in Michigan. The alert resident recognized it was probably a scam and turned it over to the District Attorney's Consumer Protection Division.

Ramsey said the letter instructed the recipient to provide his/her full name, the check number on the check and dollar amount to a phone number with an area code of "(219)." Ramsey said the letter further instructed the recipient to "deposit the check via ATM or electronically."

Ramsey said the final instructions indicated the recipient was to send a photo of the deposit receipt to three phone numbers with different area codes and an email address listed in the letter. The letter ended with the handwritten name "Isabel" from the "Payment Secure Department."

Ramsey said his investigators determined the account holder listed on the check, "Beaumont Health," in Michigan was not aware of this scam and did not authorize this check. Investigators determined "Comerica Bank and Trust," listed on the check, did not have any affiliation with Beaumont Health. The check was a fake.

Ramsey said investigators were able to contact the scammers by calling one of the phone numbers provided in the letter. Investigators pretended to be the recipient of the check and letter. The scammer sounded to be a male with a heavy foreign accent, most likely from Africa. The scammer instructed investigators to send a photo of a deposit receipt, proving the check that had been sent had been deposited.

Ramsey said investigators

## Speaker is Sent Letter for Oversight Hearing and Investigation of COVID-19 "Data Glitch"

**SACRAMENTO, CA (MPG)** - Assemblyman Kevin Kiley (R-Rocklin) submitted a letter to Assembly Speaker Anthony Rendon calling for an immediate joint oversight hearing and investigation of the recent COVID-19 "data glitch."

The letter requests that a hearing include testimony from Governor Gavin Newsom himself, as well as former Public Health Director Sonia Angell, who resigned from her position Sunday evening.

"Oversight is a vital role of the Legislature, never more so than in the

wake of a failure by the Executive branch that could impact the lives and livelihoods of 40 million Californians," Kiley said. "To restore public confidence, it is critical that the Legislature determine the full extent of the state's COVID-19 'data glitch' and receive a full account of the steps taken to assure we now have accurate data to guide decision-making."

# Fire Destroys Home on French Ave

GRIDLEY, CA (MPG) - In the early afternoon hours of Friday afternoon, August 7th, a two-story home located on French Avenue

in Gridley was overrun by flames. The blaze looked to have begun on the second floor of the home – black smoke and flames clearly visible from multiple windows. Firefighters arrived on scene at the single-family residency and requested further units as they identified a need for water access and began a search of the home for residents that may have been trapped inside. Due to the fact the home was in the country and no fire hydrants were located in the area, four water tenders were requested to provide water to the engines. Overall, 8 trucks/engines, 4 water tenders, and 33 personnel responded to the blaze including: CAL FIRE/ Butte County Fire Department, Sutter County Fire, Volunteer Companies 31,42,45, 64, 74. Butte County Sheriff's Office, and PG&E were also present. Firefighters were able to knock down the flames and begin overhaul operations relatively quickly. The residents were not home at the time of the fire and no one was injured. Unfortunately, the home was considered destroyed and the cause of the fire is still under investigation at this time. ★

GRIDLEY, CA (MPG) - On Saturday, August 8th, a young-man from Gridley, Randy Miller, was severely injured in a car accident. Miller was life-flighted to Enloe Hospital in Chico for treatment and then transferred to U.C. Davis in Sacramento. He sustained a broken neck, broken jaw, severe tendon damage to his right leg and has been on a ventilator while awaiting surgery. Reports from friends and family have noted daily progress. A fundraiser has been set up to pay for his medical bills, aftercare, therapy and to help his mother, Sarah, with lodging and travel expenses while she stays close to her son. Diane Wilkerson, who set up the online fundraiser writes, "For those of you that don't know Randy, you need ... to know that he is an amazing young man. Despite

being thrown a few curveballs in his life, Randy has always excelled at academics and sports. He is currently a student at Chico State and studying to be a CHP officer. He was an outstanding student and athlete while at Gridley High School and was a huge part of championship teams in both basketball and baseball. He lives at home in Gridley and commutes to school and work." The community has been quick to show support. The fundraiser reached it's goal of \$20,000 but donations are still accepted. Unfortunately, scammers have been posing as Wilkerson, asking through Facebook Messenger for those participating to purchase Amazon gift cards. 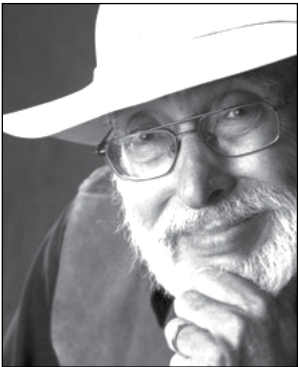

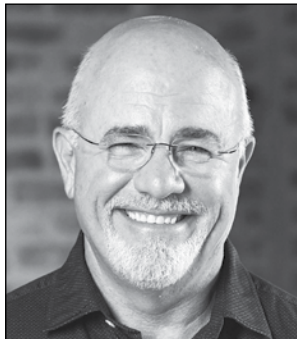

## Dave Ramsey Says



### Might be Money Well Spent ... at the Proper Time

Dear Dave,

My wife and I are on Baby Step 2 of your plan. About eight months ago she gave birth to our second child, and now she would like to have a mommy makeover. I want her to be comfortable and feel good about herself, but those procedures can be really expensive. I don’t know how to fit that in with trying to pay off debt and get control of our money. What do you think?

Dear Greg

Basically, this kind of cosmetic surgery isn’t an emergency. It’s a desire.

It can, in many cases, be a valid and reasonable desire. But if you guys are serious about getting out of debt and gaining control of your finances, I’d advise waiting until after Baby Step 3 to make this happen. At that point, you’ll have paid off all your debt – except for your home – and you’ll have a fully funded emergency fund of three to six months of expenses in the bank.

Going on vacation isn’t a need, it’s a want. Buying a new couch isn’t a need, it’s a want. I know you love your wife, and you want her to be happy and feel good about herself. But right now, this is a want. If it were a medical procedure required to save her life, it would be an emergency – a need. In a case like that, you’d stop what you’re doing right now and address the issue.

This may be something you both agree is a valid expense. If it’s something you’ve talked through

together, and something you both want, that’s fine. It’s a reasonable goal under the circumstances. But I would wait until after you’re out of debt and you have your emergency fund in place. Being out of debt will make it so much easier to save up and take care of any out-of-pocket expenses you might have to pay.

All in all, it’s money well spent to help your wife look and feel like herself again. Just do it at the proper time where your finances are concerned!

## Dear Dietitian

## Aluminum

Dear Dietitian,

My step-daughter told me not to cook with aluminum foil, as it can cause health problems. Is this true? Is it safe to use plastic containers when heating food in the microwave oven?

Thank you, Jesse

Dear Jesse,

We use aluminum in our everyday lives. Sources include medication, aluminum foil, aluminum cans, and cookware. In fact, it is the most abundant metal on the planet, and aluminum is even found in the air we breathe. But is it safe? Symptoms of aluminum toxicity include confusion, dementia, anemia, and osteomalacia (soft bones).

In the US, aluminum toxicity is rare, and no outbreaks have been reported since 2007. In a small study of 10 patients receiving dialysis, increased blood levels of aluminum were found. The problem was related to the dialysis machine and was corrected. Of note, none of the patients showed any symptoms of aluminum toxicity (1).

Toxic levels of aluminum have been discovered in people with kidney problems, in which case, the kidney cannot adequately filter any excess amount of the metal. High levels have also appeared in patients receiving long-term IV nutrition. In this case, one should be closely monitored by a Registered Dietitian Nutritionist so that any imbalance in nutrients can be prevented or quickly corrected.

In the 1960s, aluminum became a suspect in Alzheimer’s disease. Since then, much research has been conducted, and no link has been found between aluminum and the cause of Alzheimer’s.

It is safe to use aluminum in cooking. It may slightly increase the level of aluminum in your body, but it is not harmful. The human body does not easily absorb aluminum, and a healthy

kidney will excrete any excess amount in your urine. Talk to your doctor if you are concerned about your aluminum level. A simple blood test will determine if it is too high.

Another common and convenient item found in our cupboards is plastic. When using plastic containers to heat food in the microwave oven, it is important to know a few things. Plastics can release bisphenol-A (BPA) and phthalates into your food. These chemicals are known as endocrine disrupters, which means they mimic human hormones. In doing so, they disrupt the body’s natural hormonal process. Hormone disruptors cause problems in animals, but there is little scientific information on the potential health problems in humans (2).

The FDA regulates the labeling of plastic containers that are “microwave safe.” These containers must be tested to determine if chemicals from the plastic will migrate into the food, if so, how much, the likelihood that someone will eat directly from the container, and how hot the food will get during microwaving. The amount of chemical release allowed is 100-1,000 times less than the amount found to be harmful to animals (2).

Do not use plastic storage bags, plastic wrap, brown paper, or plastic grocery bags in the microwave. If you choose to be extra cautious, use only microwave-safe glass or ceramic when heating food in the microwave.

they select supplies. The GRG has investigated avenues and funding to replace or repair the current HVAC system, but the \$25,000 price tag has been a hurdle that was unable to be cleared. Then along came Kate.

Spencer, who continuous to organize donations and schedule supply pick-ups for survivors, even though COVID19 has closed center doors, crossed paths with Kate Wilson in early 2020. Wilson was working to help Camp Fire survivors after witnessing the devastation of fire that touched someone close to her and found an ally in Manou Sinoncelli. Together, yet in contrasting ways, these two huge-hearted ladies have been working alongside each other to provide relief to survivors.

While Sinoncelli tirelessly searches for donations, mostly of second-hand nature, Wilson is quick to open her pocketbook to fund the humanitarian efforts. Over the course of her work, Wilson has bought and received donations of new, high-quality goods, purchased a truck for relief workers and a Mercedes van the size of a small bus for herself and Sinoncelli to transport donations from all over the north state. Endless hours of time have been spent organizing, traveling and delivering goods, and now Wilson has procured a new HVAC system for the Distribution Center. Wilson funded the replacement system through a \$25,000 grant from the Marin Community Foundation, which she created.

Ultimately, it all goes back to the size of Wilson's heart and desire to do good. Of Wilson's generosity Sinoncelli says, "You have never seen a kid so happy in a Christmas shop like Kate Wilson" giving out donations. "She was like a kid in Toys 'R' Us. And that's here (she clutches her fist to her heart); it's not here (she motions to her purse)."

Whatever the course, much thanks goes to Wilson for her charitable donation to the center and the generous work of all three amazing women. ★



## Butte County Sheriff's Office Press Release

**BANGOR, CA (MPG)** - On June 12, 2020, Butte County Sheriff's Office (BCSO) deputies responded to a burglary at the Bangor Post Office. Deputies and detectives conducted an investigation and located video surveillance of the individuals who committed the burglary. Deputies and detectives also located additional physical evidence.

Detectives reviewed the video surveillance and physical evidence and identified the two individuals responsible for the burglary as

Mayra Jimenez of Tracy, 25, and Jonathan Dew of Vacaville, 26. During the investigation detectives determined Jimenez and Dew drove to the Hard Rock Casino located in Wheatland after the burglary. Detectives worked with the Yuba County Sheriff's Office and obtained additional video surveillance and physical evidence related to the burglary.

In June of 2020, detectives obtained arrest warrants for Jimenez and Dew for one felony count of burglary. On August 4, officers from the Sacramento Police Department contacted and placed Jimenez and Dew

under arrest. Jimenez and Dew were both booked into the Sacramento County Jail. Dew later posted bail. Jimenez was later transferred to the Butte County Jail. After arriving at the Butte County Jail, Jimenez posted bail.

Jimenez is scheduled to be arraigned at the Butte County Superior Court on October 23, at 8:30 AM. Dew is scheduled to be arraigned at the Butte County Superior Court on September 11, at 8:30 AM. The Sheriff's Office is asking anyone with additional information about Jimenez or Dew to contact Detective Zach Price at 530538-7671. ★

# Woman's Body Found by Railroad Tracks Identified

**GRIDLEY, CA (MPG)** - On July 6th, an unknown caller reported finding a redheaded "young girl face down fully clothed in the dirt" to law enforcement. Gridley Police Department responded to secure the scene until Butte County Sheriff's Department could arrive.

The body was found close to the railroad tracks near W. Evans Reimer and Township Roads. According to Gridley's Lieutenant Quihuiz, the body was located close to the area housing the business Gridley Gravel & Nursery.

The body was identified by the Butte County Coroner's Office as 54 year-old Marie Anzalone of Biggs. She was petite in stature, lending to the initial confusion regarding reports of a body of a "young girl". Her children did share that they felt her death was the result of foul play and organized a fundraiser to help cover funeral costs. Son Devin Underwood said online, "My mom was someone everybody loved; she had an amazing laugh and a loving personality. I hate to ask for help."

The investigation into Anzalone's death is still open, pending the results of the autopsy report. Butte County Coroner's Office has not received those results as of Monday, August 10th. ★

learned through their conversation with the scammer that recipients of the checks and letters were told they are being “paid” to have an advertising decal installed or “wrapped” on their vehicle. The scammer told investigators that recipients would be paid \$600 of the total dollar amount listed on the check to simply drive around with the decal on their vehicles. The scammer told investigators a “decal installer” would arrive soon to install the decal on the recipient’s vehicle.

Ramsey said the scammer would not provide additional information to investigators upon being

asked and was repetitive in his instructions. The scammer also instructed investigators to download the “Cash App” application on a cellular phone and send the remaining money (\$1850) from the check to a username provided by the scammer. The “Cash App” application is a mobile payment service used to transfer money to others with the use of a cellular phone.

Ramsey said he wanted to remind the citizens of Butte County of how important it is to safeguard their financial and identifying information. Ramsey said scammers are continuously looking for new ways to obtain the identifying

and financial information of others for the purpose of financial gain. He said never provide one’s personal information to an unknown third party.

Ramsey said the scam tactic of leading people to believe they are receiving payment with the agreement to cash a check and return funds is nothing new. But he said unfortunately some still fall victim to these scams and lose money as well as compromise their identities.

# BCSO Exhumes Body and Identifies 1969 Missing Person

## Butte County Sheriff’s Office Press Release

**BUTTE COUNTY, CA (MPG)** - In November of 2019, a citizen began communicating with the Butte County Sheriff’s Office (BCSO) regarding a 1969 missing person case. The citizen had received information from the Doe Network about the missing person case. The Doe Network is a 100% volunteer organization devoted to assisting investigating agencies in bringing closure to national and international cold cases concerning Missing & Unidentified Persons. Detectives researched the 1969 case and determined an unidentified male died in Butte County in 1969 as the result of an accident involving a train. Detectives were not able to identify the male in 1969.

Detectives conducted research and determined there was a high probability the male was Marvin Price McMullen, of Florida. Mr. McMullen was born in 1931 and was believed to have been traveling in California in 1969. Detectives began communicating with Mr. McMullen’s family

and ultimately obtained DNA samples from a relative of Mr. McMullen.

On April 22, 2020, BCSO received a permit from Butte County Public Health to exhume the body of the unidentified male. On Saturday, May 2, 2020, BCSO detectives, Chico State Forensic Anthropology Professors and Butte County Public Works personnel exhumed the body. The body was transported to a local funeral home where DNA samples were collected for testing and comparison, in an attempt to confirm the identity of the male.

BCSO transported DNA from Mr. McMullen’s family members and DNA from the unidentified male to the California Department of Justice DNA lab in Richmond for processing. In July of 2020, BCSO obtained the results of the DOJ DNA analysis. Based on the DOJ DNA analysis, BCSO positively identified the male as Marvin Price McMullen. Mr. McMullen’s remains have been released to his family. The Butte County Public Guardian’s Office assisted Mr. McMullen’s family members with burial expenses. ★

## Gas Safety Tips

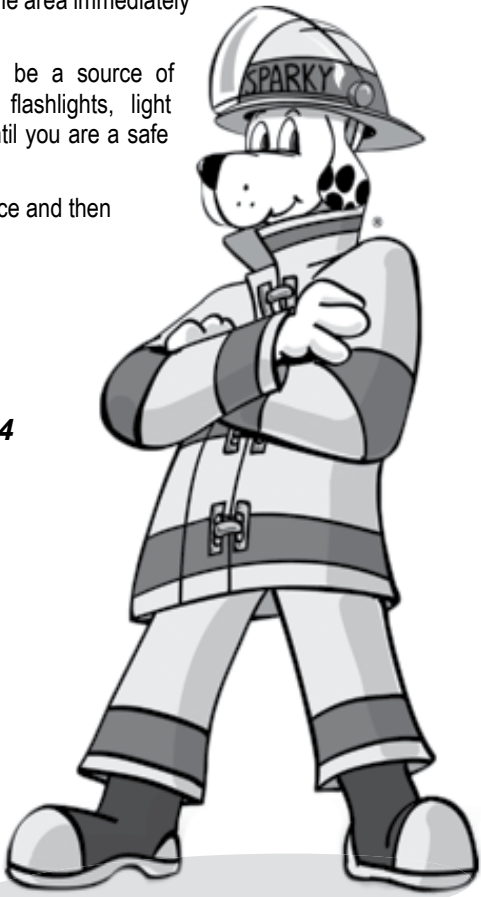
Safety is our highest priority. Follow these safety tips to keep yourself and your family safe.

- Never use a flashlight, match or candle to look for gas leaks, and never turn electric switches on or off if you suspect a gas leak.

- If a pilot light is out, shut off the gas at the appliance gas shutoff valve. Wait five minutes to let gas disperse before trying to relight the appliance pilot light.

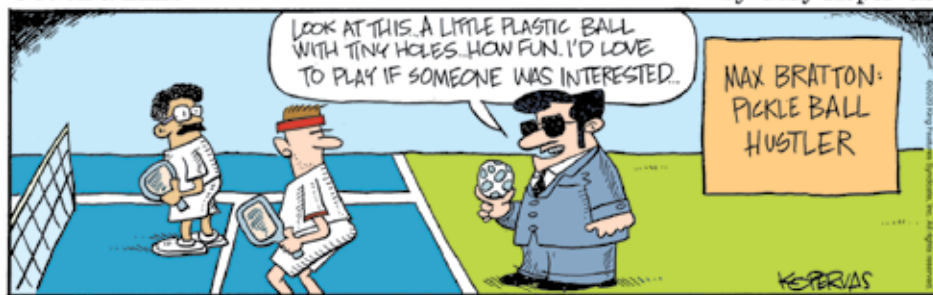

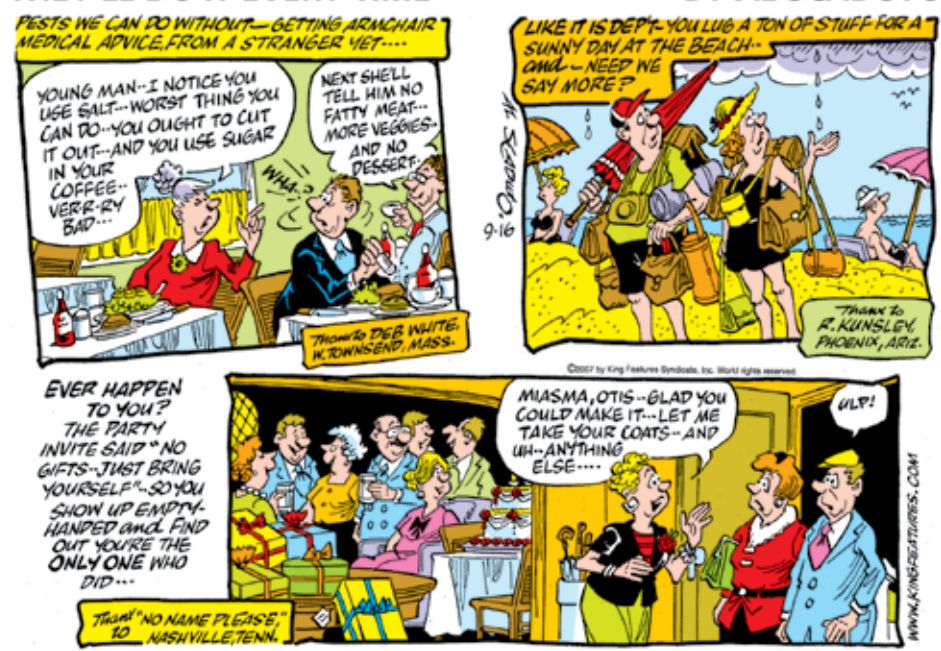

The outmigration survival rate of our 2020 rice field-reared salmon was nearly 4.5 percent. This was nearly 4.5 times higher than our control groups and substantially higher than other similar tagging study during this period. We could not be happier with these results and they will now serve as the basis for further work by CRC and its fish conservation partners to continue efforts to develop a larger-scale strategy to use our fields to help salmon just as we have used them to help birds for decades now.

We want to thank UC Davis and CalTrout for their extraordinary work in the field over these past two years. And, of course, this project could not be possible

without the help of our funding partners and participating growers. Special thanks to the Natural Resources Conservation Service and Syngenta for their major contributions and our long list of supporting partners including S.D. Bechtel Jr. Foundation, GrowWest, Corteva, Valent, Almond Board of California, NovaSource, Conaway Ranch and River Garden Farms. We also want to specially recognize both U.S. Fish and Wildlife Service and California Department of Fish and Wildlife for supplying us with hatchery fish to support this important work and for technical expertise on key aspects of the work.

A year ago, the California Department of Education released a draft of guidelines for implementing “ethnic studies” in public high schools.

It unleashed a torrent of controversy – for good reason.

The 303-page document was ersatz Marxist agitprop that, if adopted, would have drummed into young minds the notion that in America, anyone not a white male is virtually enslaved.

“At its core,” the draft declared, “the field of ethnic studies is the interdisciplinary study of race, ethnicity, and indigeneity with an emphasis on experiences of people of color in the United States,” adding, “The field critically grapples with the various power structures and forms of oppression, including, but not limited to, white supremacy, race and racism, sexism, classism, homophobia, islamophobia, transphobia, and xenophobia, that continue to impact the social, emotional, cultural, economic, and political experiences of Native People(s) and people of color.”

In critiquing “systems of power,” it advised, “These are structures that have the capacity to control circumstances within economic, political, and/or social-cultural contexts. These systems are often controlled by

those in power and go on to determine how society is organized and functions,” adding, “some examples of systems of power are: white supremacy, capitalism, and patriarchy.”

Some of most pointed criticism came from Jewish legislators who said in a letter, “we cannot support a curriculum that erases the American Jewish experience, fails to discuss anti-semitism, reinforces negative stereotypes about Jews, singles out Israel for criticism and would institutionalize the teaching of anti-semitic stereotypes in our public schools.”

Hurriedly, state education officials, including Superintendent Tony Thurmond, promised a makeover. The new version is definitely toned down – less a call for social revolution and more a conventional academic outline.

There's some irony in that transformation. The new draft was released as the fundamental change advocated in the first version was gaining currency in response to the suffocation death of a Black man, George Floyd, with the knee of a Minneapolis policeman on his neck.

Nevertheless, the new draft still contains echoes of the previous proposal, to wit:

“Ethnic studies should help students become more engaged locally and develop into effective civic participants and stronger social justice advocates, better able to contribute to constructive social change. It can also help students connect current resistance movements to those of the past, and to

imagine new possibilities for a true democracy.”

There's another bit of irony in the declaration that ethnic studies “can help students learn to present their ideas in strong, compelling, jargon-free language.”

The draft itself is loaded with undecipherable jargon, such as saying ethnic studies help students “conceptualize, imagine, and build new possibilities for post-imperial life that promotes collective narratives of transformative resistance, critical hope, and radical healing.” Can anyone translate that?

When the Legislature required an ethnic studies curriculum to be created, its expressed rationale was that since Californians are a complex matrix of ethnicities and cultures, students should become more aware of who we are and how we got here.

No argument there. And there's absolutely nothing wrong with taking a warts-and-all approach, including slavery, genocidal treatment of native peoples and immigration patterns. Facts are facts and we shouldn't shy away from them.

But ideological indoctrination, which the first draft clearly embraced and still colors the second, is not knowledge. The histories of America and California are not only tales of conflict, including a very bloody civil war, but also narratives of overcoming adversity and achievement, and well-balanced ethnic studies should include them as well.

The Legislature is weighing whether to make ethnic studies mandatory. If so, we'd better get it right.
