### Licenses for **Drivers 70** and Older are **Extended**

#### California Department of Motor Vehicles

SACRAMENTO, CA (MPG) -The California Department of Motor Vehicles is providing an automatic one-year extension to Californians age 70 and older with a noncommercial driver license with an expiration date between March 1 and December 31, 2020. This action delays the requirement for this population to visit a DMV office during the COVID-19 pandemic.

The DMV previously provided 120-day extensions to senior drivers with noncommercial licenses expiring in March through July. While the new extensions are automatic. drivers will not receive a new card or paper extension in the mail. As an option, drivers can request a free temporary paper extension online beginning July 15 through DMV's Virtual Field Office to document the extension, though it is not needed to drive. 

> after the expiration date. Commercial licenses, including those for drivers 70 and older, expiring between March and September are extended through September 30, 2020, to align with federal guidelines.

> The one-year extension for senior drivers is the latest action to help Californians avoid or delay a DMV office visit during the COVID-19 pandemic. The DMV has issued extensions for expiring driver licenses and permits, expanded eligibility to renew a driver license or identification card online or by mail, and created new digital options for transactions that previously required an in-person office visit. The DMV continues to streamline its processes to limit the time customers spend at an office. Customers are encouraged to fill out the online application and upload their documents before they come to the office. The DMV is also contemplating other ways to safely serve seniors.

There are some human rights that are simply fundamental to a life of meaning and joy. Concepts so crucial that women and men, some of the best women and men in history, have fought and died to maintain theses principles or values. They are referred to as human rights or human dignities; like freedom from forced labor (or having the wealth you have earned taken from you by force), the freedom to own property, speak your thoughts, go where you want to go, and in my opinion the first freedom, doing the things you want to - because of your powerful gaming induspersonal religious feelings and identity. These ideas are all found written into The Constitution. Yet increasingly, we see an open hostility toward these traditional and fundamental human rights. This animosity toward individual rights has, in recent months, been very much on display as we have observed the United States Supreme Court issued several rulings which redefine how we will be allowed to be "who we are" and live as we believe. Indeed Dr. Douglas Laycock of the University of Virginia ence to the now superior School in 1988

the following: "For the first time in nearly 300 years, important forces in American society are questioning the free exercise of religion *in principle – suggesting* that free exercise of religion may be a bad idea, or at least, a right to be min*imized*, " which brings us to the recent action of the US Supreme Court in the case of the congregants of the Christian Calvary Chapel of Dayton Valley Nevada vs. their Governor. The State has issued rules by which human gathering, or doing business, will be "allowed" during an Emergency, and in which order public activities are permitted. These Dayton Valley Religionists are finding themselves at the back of the line, so they went to the Supreme Court for relief - and were rejected on a 5 to 4 vote. I paste below some of the arguments made by the Justices who were correct - but outvoted. "That Nevada would discriminate in favor of the try, and its employees may not come as a surprise, but this Cour's willingness to allow such discrimination is disappointing ... We have a duty to defend the Constitution, and even a public health emergency does not absolve us of that responsibility... The Constitution guarantees the free exercise of religion. It says nothing about the freedom to play craps or blackjack, to feed tokens into a slot machine, or to engage in any other game of chance." Alitos's refer-

"right" - to gamble which Nevada has allowed while threatening to send the Calvary Chapel people to jail for doing something in the Constitution expressly allows - freedom to be religious. Justice Neil Gorsuch wrote, "today's world with a pandemic upon us. poses unusual challenges. But there is no world in which the Constitution permits Nevada to favor Caesars Palace over Calvary Chapel." Pause for a moment and mentally process this - Casinos can open, Churches cannot. Will, any of us be surprised when the same value set held by the Governor allows the "sex workers" in the State sanctioned brothels to open while the Dayton Valley Jesus lovers are still locked out, unable to sing, or worship - even with masks on standing six feet apart? Those of you philosophical or religious type Pi Line readers - who care about human rights, human dignity, and freedom - can have a very clear apprehension of which way these rights are now ordered. Likewise, a clearer percipience that the order of importance can change on any given day during an "Emergency." Unwittingly, the Governor of Nevada has misapplied the New Testament teaching of Jesus and has decided to "render unto Caesars" more civil rights of the Dayton Valley Christians. \*\*\*

# **Extreme Number of BC Inmates** Infected with COVID

#### Butte County Sheriff's **Office Press Release**

OROVILLE, CA (MPG) - Within the past two weeks there has been a rapid increase in the number of lab confirmed COVID-19 cases within the Butte County Jail. This increase coincides with an increase in the number of confirmed cases throughout Butte County and in many parts of California. The Butte County Sheriff's Office (BCSO) is working cooperatively with the Butte County Public Health Department and Wellpath, the jail's medical services provider, to mitigate the spread of COVID-19 within the jail and provide appropriate care for those inmates currently infected with the illness.

To date approximately 500 COVID-19 tests have been administered to both inmates and staff members. None of the BCSO staff members tested to date were positive for COVID-19. Currently, among the inmate population, there are 71 lab confirmed COVID-19 cases within the jail. An additional 18 tests are pending lab results.

The overwhelming majority of cases involve asymptomatic individuals or individuals with mild symptoms. One individual was admitted to an area hospital for observation over the weekend. That individual is in stable condition and is likely to be returned to the jail in the coming days. (When there is a need for an enhanced lize previously adopted community.

level of care, inmates are screening and detection transported to local hospitals, but kept under observation by jail staff.) The jail's medical staff is currently able to provide the necessary medical care within the facility for the rest of the inmates who tested positive. Inmates with confirmed cases of COVID-19 are being isolated from the remainder of the population. There is currently sufficient capacity within the jail to accommodate these individuals. Inmates who have tested positive are isolated for ten to fourteen days. in accordance with best practices as defined by the U.S. Centers for Disease Control and Prevention (CDC), the Butte County Public Health Department and Wellpath.

The jail staff closely monitors the jail's population on a daily basis and utilizes statutory and court ordered authority to maintain sufficient capacity within the jail to manage this regularly changing situation. Inmate, staff and public safety interests are continually being balanced during this process. As a general rule, inmates with confirmed cases of COVID-19, who have not yet recovered, will not be released unless it is required by law or is medically necessary. In those cases, the jail will coordinate the release with Public Health to ensure proper post-incarceration housing, monitoring and care The jail continues to uti-

protocols in an effort to mitigate the spread.

Those protocols include: Screening of all intakes for symptomatic individuals; Weekly temperature and symptom checks of all inmates; Use of Personal Protective Equipment, i.e. masks and gloves, by inmates and staff; Increased access to hand sanitizer and cleaning supplies for inmates and staff; Aggressive testing and monitoring in cooperation with the Butte County Public Health Department to detect asymptomatic individuals.

In addition to the protocols noted above, the jail has suspended public visiting and is actively working with the Butte County Superior Court, the Butte **County Public Defenders** and the Butte County District Attorney's Office to limit in-person court appearances for inmates during the next 14 days.

Firms reduced employment by 0.28 workers per firm over the past month, weaker than the decrease of 0.17 workers per firm in May. 

On the day California hit motorists with its annual increase in the gas tax and on the eve its state Senate is looking to pass a greatly expanded family leave law socking smallbusiness owners with new costs, NFIB's month Jobs Report showed, to little surprise, a worsening economy.

"You have to ask if California's policymakers think the whole COVID-19 crisis is just a minor, ephemeral distraction that shouldn't stop their regulatory agenda from proceeding at its breakneck pace," said John Kabateck, California state director for NFIB, the nation's leading small-business association. "As our Jobs Report cries out, every effort should be made to make re-opening small businesses and fostering their ability to stay open Priority No. 1, but instead we get things like Senate Bill 1383, which expands leave time for employees who may never get it if they don't have jobs to return to. State leaders talk a good game about the need to help small business, but then pass bills like SB 1383, which is opposed by more than 100 business organizations. Just

# **Caltrans to Begin Construction** on State Route 99 Live Oak Project

#### SUTTER COUNTY, CA (MPG)

- Construction crews are scheduled to start work Monday, July 27, on a major pavement and streetscape project on State Route 99 in Live Oak.

Roadwork will take place in various stages from south of Pennington Road to north of Ramsdell Drive. Caltrans reminds residents that local businesses will be open during construction.

The \$36 million project is funded in part by a \$10 million federal Transportation Investment Generating Economic Recovery (TIGER) grant and \$2.3 million from Senate Bill 1 (SB 1), the Road Repair and Accountability Act of 2017.

"This is a very exciting project that benefits residents, visitors and regional commuters. The federal funding will go toward improving the streetscape to create a 'main

street' environment," said Caltrans Director Toks Omishakin.

"Without funding from SB 1, the pavement would continue to deteriorate, which would have a direct impact on travelers and result in costly maintenance repairs in the future," Omishakin said. "This project allows crews to make long-term repairs, providing a smoother, safer ride for motorists and the region's commercial operators."

DeSilva Gates Construction is the contractor for this project, which calls for:

Upgrading the drainage systems; Rehabilitating the roadway to achieve a 40-year design life; Flattening the roadway cross slopes; Constructing new continuous sidewalks; Making traffic signal improvements at three intersections of Highway 99 at Pennington Road, Elm Street and Kola Street; Creating a pedestrian-focused downtown environment by enhancing

parking and building access, wayfinding and signage, landscaping and facilities for bicyclists and pedestrians.

Motorists should expect travel-interfering work and pedestrian detours during construction. Completion is expected in fall 2021. For the latest updates and more information about this project, please visit www. LiveOak99.com

The construction schedule is subject to change due to traffic incidents, weather, availability of equipment and/or materials, and/or construction-related issues. # **CDFW Now Hiring Wildlife Officers**

#### **CDFW Law Enforcement Press Release**

SACRAMENTO, CA (MPG) - The California Department of Fish and Wildlife (CDFW) Law Enforcement Division is beginning the next cycle of recruitment for wildlife officers. If you want to make a positive difference in California as a member of a professional, effective, responsive law enforcement organization dedicated to ensuring public safety and protecting of our natural resources, this may be the career for you. Applications must be submitted by July 31, 2020. Apply for a "Warden Cadet" position if you are not currently a peace officer. Apply for a "Warden" (lateral) position if you have your Peace Officer Standards of Training (POST) Basic certificate and are currently employed as a peace officer within the State of California.

CDFW wildlife officers are fully sworn California peace officers with a fundamental duty to serve and protect the public. They have the authority to enforce all California laws. Wildlife officers patrol the mountains, valleys, deserts, creeks, streams, rivers and ocean. They frequently work alone and cover both rural and urban areas. California's diverse ecosystem spans 159,000 square miles divided into 58 counties, with a human population more than 39 million. The state has 1,100 miles of coastline, 30,000 miles of rivers and streams, 4,800 lakes and reservoirs and 80 major rivers. Wildlife officers patrol with trucks, off road utility vehicles, personal watercraft, large patrol vessels, snowmobiles and aircraft. They work undercover, conduct surveillances and complete in-depth investigations, including writing and serving search warrants. CDFW's Law Enforcement Division has numerous specialized teams and assignments including K-9, wildlife trafficking, cannabis enforcement, marine patrol, and oil spill prevention and response. Successful applicants for warden cadet will attend a POST-certified law enforcement training academy, conducted by CDFW at Butte College in Oroville. Following the academy, probationary wildlife officers will work with seasoned field training officers for several months, where they will learn to apply their training in practical circumstances

### 2020-2025 Dietary **Guidelines for Americans**

#### Dear Dietitian.

The Scientific Report of the 2020 Dietary Guidelines Advisory Committee has been

released. The report is based on scientific evidence in nutrition and is issued by a team of experts, including Registered Dietitians, Medical Doctors, and Doctorates of Nutrition. The information will be used by the Departments of Agriculture and Health and Human Services to develop the 2020-2025 Dietary Guidelines for Americans. These recommendations are made every five years as a road map to help people make healthier food choices and prevent diet-related diseases,

such as heart disease and diabetes.

will likely remain the same as those released in 2015. Choose a variety of foods from every food group. Select more plant foods. Replace saturated fats (found in animal products) with unsaturated fats (found in plant oils). Choose whole grains instead of refined grains.

For the first time, the guidelines will address the nutrition of children from birth to 2 years of age. The Advisory Committee has recommended breastfeeding infants for at least six months.

### Parent's Safety Tips Young Fire Setters

Children playing with fire cause hundreds of deaths and injuries each year. Preschoolers and kindergartners are most likely to start these fires, typically by playing with matches and lighters, and are most likely to die in them.

Young children and fire are a deadly combination. Some children play with fire out of curiosity, not realizing its danger. Troubled children may set a fire as a way of acting out their anger, disappointment or frustration.

Important! If you suspect your child is intentionally setting fires or unusually fascinated with fire, get help. Your local fire department, school, or community counseling agency can put you in touch with trained experts who know how to teach children about fire in an appropriate way.

- Children experience fire interest. They may ask questions such as how hot is fire or show an interest in fire through playing with fire trucks or cooking on a play stove. This is healthy, and it is time to begin educating about fire.
- Fire starting happens when children begin to experiment with fire using matches and lighters. Many fires happen when young children are left alone, even for a short period of time, and have access to matches and lighters. Parents must have clear rules and consequences about fire misuse.
- · Grown-ups can help keep fire out of the hands of children.
- Store matches and lighters out of children's reach and sight, up high, preferably in a locked cabinet or container.
- Never leave matches or lighters in a bedroom or any place where children may go without supervision.
- Teach young children and school-age children to tell a grownup if they see matches or lighters. Children need to understand that fire is difficult to control; it is fast and can hurt as soon as it touches you.
- A child with an interest in fire can lead to fire starting and result in repeated fire setting behavior.
- It is important for grown-ups to discourage unsupervised fire starts.
- Never use lighters or matches as a source of amusement for children; they may imitate you.
- Never assign a young child any tasks that involve the use of a lighter or matches (lighting candles, bringing a lighter to an adult to light a cigarette or the fireplace, etc.)
- If your child expresses curiosity about fire or has been playing with fire, calmly but firmly explain that matches and lighters are tools for adults only.
- Use only lighters designed with child-resistant features. Remember, child-resistant does not mean child-proof.



# **Human Trafficking Victims Qualify for Income Loss**

SACRAMENTO, CA (MPG) -Human trafficking victims in California can now qualify for up to \$20,000 in income loss paid through the California Victim Compensation Board.

Signed by Governor Gavin Newsom, Assembly Bill 629 (Smith and Gonzalez) went into effect on January 1, 2020, making human trafficking victims eligible for up to \$10,000 of income loss per year, for up to two years. The bill required the Board, on or before July 1, 2020, to adopt regulations that allow it to rely on evidence other than official employment documentation in considering and approving applications for compensation. The Board adopted the Office of Administrative Law approved the final regulations, ahead of the July 1 deadline.

"It's clear the trauma of human trafficking extends far beyond the time having been trafficked -survivors often have faced homelessness, addiction and mental health issues stemming from

their exploitation," Assemblywoman Christy Smith said. "My bill with Assemblywoman Gonzalez removes a loophole in the victim compensation system that required survivors to obtain a note from their employer - often times this was their trafficker. The regulations adopted remove these barriers to justice and provide critical support for victims rebuilding their lives."

"Survivors of human trafficking face unimaginable obstacles when they work to put their lives back on track. They are typically on their own and have to figure out how they will pay for housing and food, apply for work, and get treatment for medical and mental health," Assemblywoman Lorena Gonzalez said. "Most regulations in May. The human trafficking survivors don't have the formal documentation CalVCB had previously required to collect lost income, such as a W-2 form. CalVCB's new rules, now in effect thanks to our legislation AB 629, are a just and fair way to help survivors get back on their feet and get the help they need.

"CalVCB recognizes the challenges human trafficking victims face as they work to rebuild their lives," said Executive Officer Lynda Gledhill. "By providing financial support, along with options for medical and mental health treatment and other compensation, CalVCB is able to play a small part in victims' recovery."

As with all claims, victims will need to provide CalVCB with evidence of a crime, including, but not limited to, a statement under penalty of perjury from the applicant, a caseworker, a licensed attorney or a witness, or a law enforcement report. Victims brought from other countries and trafficked in California may also qualify. Before AB 629 became law, victims could only prove income loss with formal employment documentation or voluntary cooperation from their traffickers, meaning most could not qualify.

AB 629 became law on January 1, 2020, allowing victims to submit income loss applications, even as CalVCB drafted the required regulations. In the months
