Gridley and people from as far away as Yuba City and Williams turned out this Independence Day weekend to stand in support of our local law enforcement agencies and others'

Veterans, community members, retired law enforcement and the families of law enforcement gathered at the Heritage Oak shopping center

and lined Hwy 99 in Gridley. Young and old, they waved Old Glory, black & blue striped flags, handmade signs and many wore patriotic garb. Passing traffic made their support known through loud horn blasts

or screams from windows. Of course, the group was also the target of some not-so-nice comments from passersby. At one point someone from a passing car yelled "Black lives Matter" to which, and not disagreeing with, one of the pro-blue retorted "So do the blue."

That was one aspect of the "Back

the Blue" rally that could be misconstrued, especially during our nation's current social climate and current cries to "de-fund" police departments across the country. Many participants at Sunday's rally felt that actively supporting law enforcement was crucial during these times and in the same turn, was not meant to downplay the importance of "Black Lives Matter" or other people of color's battle for equal and civil treatment. Taxpayers Should File by July 15

WASHINGTON, DC (MPG) - The Department of

the Treasury and IRS announced the tax filing and payment deadline of July 15 will not be postponed. Individual taxpayers unable to meet the July 15 due date can request an automatic extension of time to file until Oct. 15.

The IRS reminds taxpayers filing Form 1040 series returns that they must file Form 4868 by July 15 to obtain the automatic extension to Oct. 15. The extension provides additional time to file the tax return - it is not an extension to pay any taxes due.

The IRS urges people who owe taxes, even if they have a filing extension, to carefully review their situation and pay what they can by July 15 to avoid penalties and interest. For people facing hardships, including those affected by COVID-19, who cannot pay in full, the IRS has several options available to help. To avoid interest and penalties, the IRS encourages them to pay what they can and consider a variety of payment options available for the remaining balance.

Individual taxpayers have several easy ways to file Form 4868, Application for Automatic Extension of Time to File U.S. Individual Income Tax Return, by the July 15 deadline. The IRS also reminds taxpayers to check their state filing and payment deadlines, which may differ from the federal July 15 deadline.

IRS Direct Pay allows payment directly from a checking or savings account. This service is free; Electronic Federal Tax Payment System, or EFTPS. Pay by phone or online. This service is free; Debit or credit card payment. This service is free, but the processing company may charge a fee. Fees vary by company; Check or money order made payable to the United States Treasury (or U.S. Treasury) through the mail.

Several payment options are available on IRS.gov/ payments to help taxpayers who can't pay in full and some can offer taxpayers smaller penalties. Though interest and late-payment penalties continue to accrue on any unpaid taxes after July 15, the failure to pay tax penalty rate is cut in half while an installment agreement is in effect. The usual penalty rate of 0.5% per month is reduced to 0.25% For the calendar quarter beginning July 1, 2020, the interest rate for underpayment is 3%. For more info see IRS.gov. ★

From the March 4th, 1998 Original Burleson Pi Line: The Post Office opens according to its own time, that big electric clock you see as you go into the counter area, the clock is sensitive to power fluctuations and power outages. SACRAMENTO, CA (MPG) - After much advocacy from Senator Jim Nielsen (R-Tehama), Assemblyman James Gallagher (R-Yuba City), community and business leaders and Paradise residents, the Governor signed the \$202 billion budget Monday evening that continues the promised \$7.3 Million to Paradise Irrigation District. This funding is critical to bringing clean water to residents for rebuilding efforts.

The Governor took the money out of his May revise budget proposal, but the funding was affirmed by the final budget.

'Camp Fire survivors spoke up loud and clear. I thank the people of Paradise for their strength and courage to continue the fight to rebuild their Town," said Senator Jim Nielsen (R-Tehama). "I also want to thank my legislative colleagues for their continued support of Paradise."

Assemblyman Gallagher stated, "It's ridiculous that this was such a budget battle to begin with. The Town of Paradise has already suffered through so much; there was no reason for the Governor to threaten their ability to rebuild. That being said, I'm pleased with the outcome and will continue to protect and defend our ability to recover from this devastating fire."

In November 2018, PG&E's faulty electrical lines sparked a raging fire that decimated the Town of Paradise and killed 84 residents. Since this deadly fire, citizens have combed through rubbles of their destroyed homes and businesses for precious keepsakes, cleared their properties and began rebuilding their lives.

Without water, the rebuilding of the Town of Paradise would have come to a screeching halt.

Butte County Supervisor and Camp Fire Survivor Doug Teeter previously said, "No water = no town."







YUBA CITY, CA (MPG) - The Church of Jesus Christ of Latter-day Saints has recently announced that the ground breaking ceremony for its first temple in California north of Sacramento will be held July 18th,

Plans for the 8th LDS temple in California were announced in October of 2018 by church President, Russel M. Nelson, but the exact location was not made known until fall of 2019. The 38,000 square foot temple will be located at 1470 Butte House Road in Yuba City, the site of the former Stake Center.

Demolition of the Stake Center and the clearing of the 9.4 acre area has already begun. The parcel that housed the Stake Center, along with a neighboring parcel acquired from the City will be the home to the new temple, a new Stake Center/ meeting house and also, a distribution

center. The temple itself will be quite large - nearly double the size Sacramento's 19,500 sq. ft total floor area.

Church members are ecstatic over the news of the coming Feather River California temple. Previously, members were required to travel to either Sacramento or Oakland to visit and work. Other LDS temples are located even further south: Fresno, Redlands, Los Angeles, San Diego, Newport Beach. With a strong LDS population in the North State and multiple stakes north of Sacramento area, it will no doubt be highly utilized. Sacramento currently serves 22 "stakes", composed of multiple congregations, in Northern California.

The groundbreaking will be by invitation only due to the current COVID19 crisis. Elder Scott D. Whiting of the North America West Presidency will preside. Further details about the groundbreaking will be announced as the date nears.



Chico Woman Sentenced to Prison in Vehicular Manslaughter

BUTTE COUNTY, CA (MPG) -The Chico woman recently convicted of vehicular manslaughter in a deadly 2019 crash on East Avenue in Chico, appeared in Butte County Superior Court to face the wife and daughter of the man she killed and was sentenced to the maximum term of six years eight months in state prison.

Amery May Sweany, 24, of Chico stood before Judge Michael Deems and apologized to the family of Virgil Santos, 64, of Chico for her actions leading to Mr. Santos' death. However Mr. Santos' wife and daughter told the judge how devastating the death of Mr. Santos has been on their lives and asked the maximum punishment be handed down. Noting that one, and spitting on the the daughter will be married this fall without her father to walk with her, and that the wife had to move from the family home to a cheaper apartment because of Sweany's grossly reckless actions, the judge sentenced Sweany to the

maximum. In April 2019, Sweany careened down East Avenue at speeds over 70 mph. Multiple witnesses reported seeing Sweany swerving around other cars on the road and weaving in and out of traffic as she approached the intersection at Marigold Avenue. Sweany ignored the red light and ran her car into a vehicle driven by Virgil Santos, 64, of Chico. Virgil's wife, Shelly Santos, 52, was a passenger in the vehicle.

Mr. Santos succumbed to injuries sustained from the collision, and died at Enloe Hospital. Ms. Santos sustained major injuries and underwent multiple surgeries in the months following the collision.

While in custody at the Butte County Jail, Sweany assaulted two correctional officers, punching other. Sweany had previously pled to one count of Resisting an Officer and one count of Battery upon an Officer, both misdemeanors.

District Attorney Mike Ramsey noted Sweany's case was delayed as her defense attorney sought to have her declared mentally incompetent to stand trial. A court-appointed psychologist finally opined she was competent to stand trial. Her attorney then attempted to place her into a mental health diversion program, but the Butte County Behavioral Health Department found she was unsuitable. Once she was finally set for jury trial, Sweany changed her plea to no contest.

Gov. Newsom Claims Right to Withhold Federal Grants to Fund California Deficits

YUBA CITY, CA (MPG) -California Gov. Gavin Newsom responded to a New California State press release regarding illegal borrowing of federal grant monies to fund budget deficits by claiming the right to seize federal grant funds from counties not requiring

press release issued early on June 24, 2020 highlighted the State of California intending to fund its \$85 billion budget shortfall through June 30, 2021 by accessing "Borrowable Resources" of over \$59.6 billion, including the over \$27 billion in federal health and financial stimulus dollars to address the COVID-19 pandemic.

Later the same day, Gov. Newsom told reporters, the State of California has the sovereign right to indefinitely hold billions of targeted federal grant monies from counties that are not in full compliance with the "new rules and regulations" in his recent COVID-19 Executive

oing what he referred to New California State as a "budget deal" with stimulus as a source of the California Legislature, "We're going to attach some considerations and consequences" for withholding federal funds from non-compliant counties.



Low Sodium Diet

Dear Dietitian,

My husband was recently in the hospital and was diagnosed with congestive heart failure. He has been instructed to follow a 1500 mg sodium diet. He's trying to follow the diet, but it's tough. I'm afraid he will get frustrated and give up. Any words of wisdom?

Elsie

Dear Elsie,

A low sodium diet is a major adjustment for just about any person, and a 1,500 mg sodium diet is not easy to follow. To put that in perspective, Americans consume more than 3,400 mg of salt each day. For readers who are not familiar with congestive heart failure (CHF), it's a chronic condition where fluid builds up around the heart, causing it to pump inefficiently. Salt draws water, so it is restricted in the CHF patient's diet to decrease fluid retention.

Behavior change is a process that takes time; it is not an event. Following are the stages of change as described by Prochaska and DiClemente:

- 1. Precontemplation The person does not have any plans to change in the near future. The positives of using salt outweigh any negatives associated with not using it.
- 2. Contemplation. People in this stage may consider the cutting down on salt, but may be indecisive about taking the first step.
- 3. Preparation The person sees the 'cons' of continuing behavior as outweighing the 'pros' and are more

willing to take the first step.

4. Action – People have changed their behavior and plan to move forward. There is still ambivalence about change, and relapse is possible.

5. Maintenance – The patient is able to avoid temptations to return to using salt. He may have slips, but doesn't see this as failure.

There are several things you can do to support your husband in his lifestyle change. First, you can educate yourself on a low salt diet. Most hospitals offer Cardiac Rehabilitation classes where diet and exercise are taught. You may have already attended these classes with your husband.

Although patients are educated on their diet while in the hospital, it is a lot of information to process when you are not well. I strongly recommend an outpatient appointment with a Registered Dietitian Nutritionist (RDN) and attend the session with your husband. The environment is much more relaxed than in the hospital, and at this time, the patient usually feels better, so it's easier to learn. Most insurances will cover the cost. Also, interview the dietitian over the phone to see if it's a good fit before making an appointment. Any dietitian will have the information to teach you, but styles and attitudes vary.

If you are the cook, prepare tasty meals that use herbs for seasoning instead of salt. There are numerous recipes on the internet.

Finally, compliance is a choice that the patient has to make. No one else can make it for them.

Don't expect to see significant changes for at least six weeks. Try to be patient; it's a virtue.







REQUEST FOR RELEASE OF FUNDS

On or about July 27, 2020, the California Department of Housing and Community Development (HCD) will submit a request to the U.S. Department of Housing and Urban Development (HUD) for the release of Home Investment Partnerships Program (HOME) funds, under Title II of the Cranston-Gonzalez National Affordable Housing Act of 1990 as amended, to undertake a project known as North Biggs Estates Phase 2, for the purpose of construction of an affordable 10-unit new construction single-family homeownership project. The project will be located on a vacant 1.71-acre parcel (APN# 001-220-057). The project is located on J Street between 2nd Street and 4th Street in the City of Biggs, Butte County, $California. \ \ All\ ten\ lots\ will\ face\ J\ Street\ and\ utilize\ the\ existing\ public\ road.\ The\ lots\ will\ range\ from\ 7099\ to\ 8027\ square$ feet, with the average lot at 7265 square feet. The project will include ten (10) single-story single-family units, ranging from 3 to 5 bedrooms. Each home will have two bathrooms and an attached 2-car garage. The homes will range from 1,394 square feet for the 3-bedroom unit to 1,575 square feet for the 5-bedroom unit.

The residences will be available for purchase by low-income households via a Mutual Self-Help Housing Program. Homebuyers must be at or below 80% Area Median Income (AMI) for Butte County and be first-time homeowners. The Project will include utility tie-in with the existing buried facilities (lot trenching for water service, electrical, and telecommunications lines between the individual residential units and stubbed-out facilities), trenching and grading associated with foundation construction, general home construction activities and final front-yard landscaping. Construction will consist of "traditional" wood-framed residences with asphalt composition roofs and solar panels.

The total development cost of the project is estimated \$2,600,000, up to \$875,000 of which would be funded by the federal HOME Investment Partnerships Program administered by HCD. Additional funding source is UDA 502 Direct.

FINDING OF NO SIGNIFICANT IMPACT

HCD has determined that the project will have no significant impact on the human environment. Therefore, an Environmental Impact Statement under the National Environmental Policy Act of 1969 (NEPA) is not required. MITIGATION MEASURES

Mitigation Measure 1: Prior to approval of project improvement plans, the project applicant shall submit for the City Engineer's review and approval a soils report prepared by a qualified soils specialist or certified engineering geologist. The report shall evaluate any potential constraints on developing the project site, including, but not limited to expansive soils, and shall include recommendations for development in areas where potential constraints exist, including design and engineering changes. The project applicant shall incorporate all feasible recommendations into the final site plan.

PUBLIC COMMENTS

Any individual, group, or agency may submit written comments on the ERR to Janice L. Waddell at NEPAComments@hcd.ca.gov State Department of Housing and Community Development, HOME Program. All comments received by July 26, 2020, will be considered by HCD prior to authorizing submission of a request for release of funds. Comments should specify which Notice they are addressing.

ENVIRONMENTAL CERTIFICATION

HCD certifies to HUD that Janice L. Waddell, in her capacity as Federal Programs Branch Chief consents to accept the jurisdiction of the Federal Courts if an action is brought to enforce responsibilities and in relation to the environmental review process and that these responsibilities have been satisfied. HCD's approval of the certification satisfies its responsibilities under NEPA and related laws and authorities and allows HCD to use Program funds.

OBJECTIONS TO RELEASE OF FUNDS

HUD will accept objections to HCD's Request for Release of Funds Certification for a period of fifteen days following the anticipated submission date specified or its actual receipt of the request (whichever is later) only if they are on one of the following bases: (a) the certification was not executed by the Certifying Officer of HCD; (b) HCD has omitted a step or failed to make a decision or finding required by HUD regulations at 24 CFR part 58; (c) the grant recipient or other participants in the development process have committed funds, incurred costs or undertaken activities not authorized by 24 CFR Part 58 before approval of a release of funds by HUD; or (d) another Federal agency acting pursuant to 40 CFR Part 1504 has submitted a written finding that the project is unsatisfactory from the standpoint of environmental quality. Objections must be prepared and submitted in accordance with the required procedures (24 CFR Part 58, Sec. 58.76) and shall be addressed to Ms. Kimberly Y. Suspected Arsonist Arrested by CAL FIRE Investigators

scene of the "Swedes Fire" in Bangor, fire personnel saw an unknown female leaving the area on foot.

As firefighters were controlling the fire and holding it to a 3/4 of an acre, investigators arrived and began a search for the female subject. She was quickly found by fire personnel in the back of a department crew bus, dressed in a CAL FIRE uniform and gathering personal belongings of firefighters.

While being questioned vegetation fire was reported and placed under arrest, the female gave officers several false names. She was transported to Butte County Jail, where corrections officers positively identified the first engine arrived at her as Nicole Carol Bunch,

who was previously wanted for two felony warrants in Butte County.

Bunch, age 33, of Bangor, was booked into the jail on one count of Penal Code 451 (c), arson to forest land; one count of Penal Code 538, impersonating a firefighter; one count of Penal Code 148, resisting or delaying arrest; as well as the outstanding warrants; one count of Penal Code 273, child cruelty with possibility of injury or death; and Failure To Appear for PC 273.

Bunch is being held at the Butte County Jail in Lieu of \$90,000 bail.

Further charges may be forthcoming pending the result of a full investigation.

Man Sentenced to Prison for Sex Trafficking and Distribution of Methamphetamine to a Minor

SACRAMENTO, CA (MPG) - On Monday, July 6th 2020, Christopher Ramonaguilar Lawrence, 25, of Chico, was sentenced to 14 years in prison for sex trafficking of a minor and distribution of methamphetamine to a person under 21, U.S. Attorney McGregor W. Scott announced.

According to court documents and evidence presented at trial, July and August 2017, Lawrence recruited a then 17-yearold girl to engage in prostitution for his financial benefit. Lawrence used social media to communicate with the victim, and on two occasions, he lured the victim to Chico motel rooms where he gave the victim methamphetamine, explained the methods of his prostitution business, including how to detect and evade lawenforcement, and continued to recruit the victim to work for him as a prostitute. After a seven-day trial, a federal jury found Lawrence guilty on August 29, 2019.

"Sex trafficking can occur in any community, and it is an exploitive, abusive crime that treats human beings as mere commodities to be bought and sold," said Special Agent in Charge Sean Ragan of and federal partners to identify individuals education.

who are trafficking minors and adults for financial gain to disrupt this activity in the communities we serve. Today, as a result of our partnership with the Chico Police Department and Butte County Sherriff's Office, an exploiter who entrapped his victim in a cycle of abuse and addiction will pay the penalty for his crimes, and those he exploited can take another step towards healing."

This case was the product of an investigation by the Federal Bureau of Investigation, the Chico Police Department, and the Butte County Sheriff's Office. Assistant U.S. Attorneys Brian A. Fogerty and Quinn Hochhalter prosecuted the case.

This case was brought as part of Project Safe Childhood, a nationwide initiative launched in May 2006 by the Department of Justice to combat the growing epidemic of child sexual exploitation and abuse. Led by the United States Attorney's Offices and the Criminal Division's Child Exploitation and Obscenity Section, Project Safe Childhood marshals federal, state, and local resources to locate, apprehend, and prosecute those who sexually exploit children, and to identify and rescue victims. Food Insecurity Rising

Feeding America Study Projects Yuba-Sutter Community Shortfall

YUBA CITY, CA (MPG) -The novel coronavirus (COVID-19) pandemic will have a devastating impact on people facing hunger across the country and Yuba & Sutter Counties according to a new study by Feeding America, the nation's largest hunger-relief organization. This study is the first of its kind to explore how food insecurity rates at the local level may increase in 2020 due to

COVID-19. The Impact of the Coronavirus on Local Food Insecurity analyzes food insecurity rates for the overall population and children by state, county and congressional district. Pre-pandemic, here in Sutter County, 13,250 people, including 5,230 children, did not have adequate access to nutritious food to live a means approximately healthy life. However, this 15,190 people (1 in 151 new study demonstrates that this number is likely to grow by 5,370, including 2,520 children. That means approximately 18,620 people (1 in 186 people) may experience food insecurity in 2020, including 7,750 children (1 in 77 children).

In Yuba County, 10,870 people, including 4,450 children, did not have adequate access to nutritious food to live a healthy life. However, this new study demonstrates

Key findings for Yuba-Sutter from this report regarding food insecurity

Yuba-Sutter had relatively high rates of food insecurity before COVID-19 and the study shows Yuba-Sutter will continue to see an increase in the rate of food insecurity; As closures caused by the coronavirus lead to a rise in unemployment and poverty, more people will experience food insecurity; Households with children are more likely to be food insecure. In 2018, across Yuba and Sutter county, 9,680 children (1 in 96), lived in a food-insecure household.

The Yuba-Sutter Food Bank has responded to COVID-19 with increasing food distribution by working with schools and agencies, such as local food pantries and soup kitchens, and implemented a Homebound Delivery program, which food is delivered twice a week to the doorsteps of individuals who are at highest risk for serious illness associated with COVID-19 - including seniors, and people with chronic illness.
