GRIDLEY, CA (MPG) - Beginning this week, the hospitable community of Gridley will be welcoming new neighbors to southern Butte County as FEMA Eligible Camp Fire Survivors start making Gridley their home. The arrival of the new residents follows three highly attended Public Hearings last December and January, including several public votes by the Gridley City Council. During the course of those three public meetings FEMA eligibility, traffic, crime, impacts to schools, impacts to Police and Fire, and the possibility of the FEMA lease being dragged out over years were priority issues discussed at great length.

GRIDLEY, CA (MPG) - Over the last week, many Gridley residents may have noticed that the road home has become a one-lane passage and extremely uneven because of missing sections of pavement, and at times impassable due to temporary closure. Not to worry, it is all a part of an aggressive project initiated by the City of Gridley to attack, repair and improve some of Gridley's most damaged and pot-hole ridden streets.

Gallagher **Unites Community Behind Bruce Road Funding** Request

CHICO, CA (MPG) Assemblyman James Gallagher (R-Yuba City) announced a wide range of support for a new effort to secure \$15 million in infrastructure to spur housing in Chico. Gallagher's funding request has gained official support from stakeholder groups in a variety of fields including education, housing, medical, business, service providers, realtors, and others.

"It is refreshing to see this new proposal being met with a wide range of support from a variety of local stakeholders," said Gallagher. "The consequences of doing nothing are severe. That is why I will continue to push the urgency of finding solutions to the housing crisis."

Gallagher is working with the City of Chico to secure \$10 million to widen Bruce Road and another \$5 million for the Bruce Road bridge widening project over Little Chico Creek. Funding for the Bruce Road bridge widening project will trigger construction of 350 single family homes and up to 200 affordable housing units.

The \$10 million Bruce Road widening project would complete a four-lane route with a center median from Skyway to State Route 32. Construction of diverse housing options located within the footprint of the Meriam Park project would be expedited under this plan.

"The benefits of this investment include more than increasing desperately needed housing," said Bill Webb, President of the Chico Builders Association. "This infill infrastructure will reduce vehicle miles traveled, expand public transportation, provide safer routes for schools and improve our Camp Fire damaged economy.'

Earlier this month, the Legislature approved a \$90 million budget allocation to fund infrastructure projects in rural counties that will stimulate the development of new housing. Gallagher is seeking to secure the \$15 million from this new funding mechanism.

In a support letter on behalf of the Sierra North Valley Realtors, President Brandi Laffins wrote, "The only way we are going to get people of out hotels, rentals, trailers and multi-family housing situations is to build more housing. We need more new construction as quickly as possible."

variety of additional services and staffing related to the Camp Fire Community including onsite healthcare for residents of the Gridley Camp Fire Community. In addition, dozens of highly dedicated and generous leaders have worked tirelessly over the past six months as members of the Gridley Camp Fire Relief material items they need in between.

The project will pay for Electric, Water, and Sewer utilities of Camp Fire Survivors which will benefit existing local rate payers by reducing future rate increase. The City will also receive lease revenues that will go to the City's General Fund that will in turn help fund Streets, Recreation, Police and Fire, creating an even more attractive, fun and safe Gridley Community for all to enjoy.

God Loves Gridley!

We live in a small world where everyone is interconnected in some degree. When we ask God to help us in our lives, He does not personally come down and help us. He uses this interconnection to help us more than we may

People who live or have lived in the Gridley area just seem to be more closely interconnected and influenced by God than others. What is the evidence?

Every town is supported by a basic industry. Gold discovery and mining was the basic industry God used to cause men and their families to settle the Wild West to expand His new nation created to provide freedom of religion under an inspired and unique Constitution.

When gold miners filed their claims along rivers and streams they were told by government agents that only the land along the river banks had value, so they could add as much land off the river to their claim as they were able to homestead.

Gold miners along the Feather River in East Gridley who were farmers back home recognized the farm value of the "worthless" land so they extended their mining claims for long distances off the river creating farms of 720 acres of fertile soil in a better climate than they were from. Many "gold miners" were soon making more money on their claims as farmers raising food for other miners.

Agriculture is now the basic industry that supports all the people, businesses and services in the Gridley area. Agriculture is God's favorite industry.

Note how many times Christ referred to agriculture in his parables and teaching. Faith grows like a mustard seed which is the smallest of seeds but grows into a large bush... The same seeds are sown but they prosper differently based on a variety of conditions, the best being when they are watered and nourished in good soil... The wheat and the tares... Good fruit comes only from good trees and bad fruit from bad trees... Olive trees are pruned and grafted with new branches... The vineyard parables, etc.

An Ag sheepman named Gridley owned a lot of land. He felt inspired to donate some of his land to the Railroad if they would create a station to stop in the town, which was then named Gridley after him.

Other men felt inspired to create a system of canals to irrigate farm lands. This created a need for farmers who knew how to take turns using water from canals to irrigate their crops and orchards. So, the canal creators went to Utah to recruit farmers who knew how to use the canals to settle in Gridley. Thus, many farmers from Utah settled in the Gridley area at the beginning of the 1900s and their children learned to swim in the canals.

There are a lot of churches in the Gridley area. More residents are church members than in big cities. November 4, 1934 was a very big day in Gridley. On that day there were so many members of the Church of Jesus Christ of Latter-day Saints in the densely populated Sacramento-Roseville area and down the valley through Stockton, Manteca, Tracy, Modesto, Turlock, and Merced, enough to create a stake (diocese) of about 3000 members.

On that same day, there were a comparable number of members in this valley area north of Sacramento to create another large stake centered in rural Gridley. John C. Todd was the first stake president while being the manager of the local Bank of America. 1934 was exactly 100 years since the very first stake of this church was created in Kirtland, Ohio.

Crews could accomplish some of the work, normally outsourced to contractors, in order to help with cost of maintenance. According to Dye, "the crews did such a good job; we decided to purchase a used paver last year. This is the first year we have used it - the results have been good!"

The paving project will no-doubt be a long-term project as crews work their way through streets in the city limits, smoothing and sealing our rougher patches while saving the city quite a deal of money. Dye asks the community to "Please be patient with us during the construction and do not drive on the new asphalt for 24 hours." The City and its crews are working hard to improve our daily driving experience and road aesthetic. ★

Summer-Blooming Native Plants Fall-River Big Valley

BUTTE COUNTY, CA (MPG) - By this time of year the lush growth and colorful flowers of spring are just a memory. Many California native plants go dormant in the summer, waiting for the fall and winter rains before they grow again. Some plants, like California buckeye, are already losing their leaves. But luckily for the native garden, there are still plenty of plants that thrive and bloom during the hot weather.

Eriogonum, or wild buckwheat, is a large genus with many species native to California. These perennials are available in a variety of sizes, growth habits and flower colors, and some species also have named cultivars. Individual flowers are small but are born in clusters containing many flowers, providing a visual impact. Wild buckwheats are very attractive to native pollinators, especially butterflies, and also provide food and habitat for birds. The flowers are long-lasting, fading to a rusty color in late summer. The plants are evergreen, grow in full sun, and require little to no supplemental water once established.

One buckwheat native to dry slopes in the mountains of Butte County is sulfur-flowered buckwheat (scientific name Eriogonum umbellatum). It grows one to two feet tall and three feet wide. The flowers are a bright yellow. The leaves are gray-green with whitish undersides.

California buckwheat (Eriogonum fasciculatum) is native to the foothills of southern California and is quite drought-tolerant. It grows one to three feet tall and up to four feet wide. Its needle-like leaves grow in clusters along the stem. The white or pink flowers grow in flat-topped clusters.

St. Catherine's lace (*Eriogonum giganteum*) is native to the Channel Islands and Baja California. It grows to be a large, rounded woody shrub four to five feet tall and six or more feet wide. Its creamy flowers grow in large flat clusters held above the plant. The leaves are gray-green and felty.

Coyote mint (Monardella villosa) is another summerblooming perennial that does well in sunny and dry garden settings. It has fragrant dark green foliage; Native Americans used the leaves to make tea. Its showy heads of light purple flowers attract butterflies. With deadheading, coyote mint will continue to bloom for most of the summer. It grows 1-2 feet tall and wide. Cut back the branches in the fall to reduce legginess and to promote denser growth in the spring.





Western columbine (Aquilegia Formosa) is a reliable perennial for partly shaded gardens. It will grow in full shade, but its flowering will be reduced. The stunning yellow and red flowers nod from thin stems which rise above delicately divided leaves. The flowers are very attractive to hummingbirds. If the flowers are allowed to go to seed, small seed-eating birds will visit, and volunteer plants will appear the following spring. The plants tend to be short lived, lasting about three to four years. Native to moist woods and streams in northern California, western columbine needs regular water through the summer.

Remember to include summer-bloomers when planting your native garden this fall.

- When waiting for the school bus, stay back and away from the street until the bus comes to a complete stop, and the door opens.


 Hold the handrail while going up or down the steps. Do not stand up in a moving bus.


Never stick hands, arms, or head out of the window, and never throw things out of the windows or on the bus.

Dear Readers,

Eggs have made headlines again with a study recently published in the Journal of the American

Medical Association (JAMA). Is it the incredible, edible egg or a food you should limit in your diet? As with many nutrition studies, the results go back and forth, which can be confusing and even frustrating for consumers.

This study set out to find if egg consumption or dietary cholesterol increased the risk of cardiovascular disease (CVD) and death. Nearly 30,000 people reported their dietary intake and were followed up after 18 years. The study discovered that for each 300 mg increase of cholesterol in the diet, the risk of CVD (heart attack, stroke) increased by 17% and death from all causes increased by 18%. An additional half an egg per

day increased the risk of CVD and all- cause death by 6% and 8%, respectively. (1)

The study was praised for its large size and study design; however, it was criticized for only collecting information on dietary intake at the beginning. Some people will change their eating habits if they believe a change will benefit their health, and this study could not account for that. In addition, many nutrition studies use questionnaires to gather information, and when participants self-report, there is room for error. How accurately could you report what you ate yesterday, for example, or how many ounces of meat you usually eat in a week? Finally, the study was observational, which means it doesn't prove that the cholesterol-containing foods caused the increase in CVD and death. Nonetheless, it still holds strong merit.

We all know about the cholesterol in eggs, but let's take a look at its overall nutrition. Eggs are a tasty, inexpensive source of protein, as well as an important source of vitamin D. They contain the carotenoids lutein and zeaxantin, which are believed to help prevent macular degeneration, the

leading cause of blindness in older adults. Eggs are also a healthy source of choline, which aids in brain development of babies.

The bottom line is one egg a day is nutritious for someone who is generally healthy. If you are at risk for heart disease, consider limiting eggs to three per week. If you have a history of heart disease or stroke, allow two eggs per week. And no matter who you are, eat more plant foods, including fruits and vegetables, beans and legumes, bran cereals and other whole grains.


