**BUTTE COUNTY, CA (MPG)** - In recent months there has been disturbing news about the decline of the Western Monarch population. The North American Monarch Butterfly (*Danaus plexippus*) is a familiar and charismatic insect. It is known for its amazing migration and its reliance on one plant in particular: milkweed.

The monarch spends the winter along the California and Mexico coastline. When early spring arrives these butterflies begin a long distance, multi-generational migration. They travel as far as Arizona, Nevada, Idaho, Utah, Oregon, and Washington.

There are many hazards along the way.

The monarchs that start their migration in the spring will not live long, so in order to lay their eggs

they must locate a stand of milkweed. Once laid, it takes three to five days for the eggs to hatch into caterpillars. Monarch caterpillars feed exclusively on milkweed. They grow and molt through five developmental stages over a span of 14 to 18 days. Each caterpillar then spins silk attaching itself to a milkweed leaf or stem and forms a chrysalis (hardened outer protector). After about 10 days it emerges from the chrysalis as an adult butterfly.

The lifespan of this adult butterfly is very short – just two to six weeks. In that time it feeds on nectar and continues the migration journey. It might take three or four generations to reach the end of the migration. The last generation (which has a lifespan of months rather than weeks) flies back to its ancestral start where it overwinters in large trees. In Pacific Grove, California they overwinter in a large grove of eucalyptus trees.

As of February 2, 2018, according to the Xerces Society for Invertebrate Conservation, monarch populations in western North America were at their lowest point ever. There used to be millions of monarchs that overwintered along the Pacific Coast of California and Mexico. There were an estimated 4.5 million in the 1980s. In 2018 the annual Xerces Western Monarch Thanksgiving Count totaled only 28,429. The population is now 0.6% of what it was in the 1980s.

The reasons for Monarch decline are varied, and include habitat loss,

## Gridley Little League Parks Get an Upgrade

**GRIDLEY, CA (MPG)** - Gridley's Manuel Vierra Park, has long been the heart of spring and summer recreational activities, with its playgrounds, water park and Gridley's Little League Baseball and Softball diamonds.

As part of an on-going effort to enhance the park, the City of Gridley Public Works Department has been steadily making renovations over the past 3 years, including upgrades to the restroom facilities at the park, the installation of a shade structure for those attending Little League Games and upgrades to field lighting controls.

The primary focus of the park rehab has been the little league fields.

This year the City of

Gridley Public Works Department started work in mid-February, repairing the backstop, the fencing surrounding the baseball diamonds and installing LED lighting in some areas.

The department is also adding four new tables with garbage containers to a newly poured cement patio in the snack bar area. So far the crews at the department have dedicated 500 man hours to

the project and \$30,000 in materials and supplies.

At the end of the season, as time permits, the department's focus will turn to Kawasaki Field, home to

## Live Oak Hires New Interim City Manager

**LIVE OAK, CA (MPG)** - After months of vacancy, Live Oak City Council temporarily filled the position of City Manager with the new Interim City Manager, Aaron Palmer. Palmer will serve as the Interim City Manager for the next 3 months, whereas his contract with the City of Live Oak, effective April 1st, 2019 will terminate unless he is officially installed as permanent City Manager.

In additional news, City Council members considered recent communications between the Sacramento Area Council of Governments (SACOG) and itself regarding the submission of the Annual Transportation Development Act Claim to SACOG and the amendment of the previous FY2018-2019 budget for projects funded by the Local Transportation Funds.

SACOG requested the city to detail the components of \$403,656.00 requested for funding of the street projects currently underway. The City of Live Oak intends \$120,000 to be used for the Hwy 99 Project easements related to undergrounding, \$125,000 for the Hwy 99 Project engineering work for the Streetscape portion of the widening project, and \$125,000 for overall engineering management of the Hwy 99 Project from 2018-2019.

The City of Live Oak also expects to contribute to the project through budgeted LTF funds and possibly the city's General Fund.

The council addressed the Pennington Water Main project, which began in 2012 and due to a series of scope changes and bid-advertising that produced unsatisfactory estimates, has been delayed until now.

The revised project will replace the water main in Pennington Road from O Street to Larkin Road with a 12-inch diameter main which will better transmit the output capacity of the Memorial Park booster pump station to the east side of Highway 99.

All-American Construction came in with the lowest bid for the project at \$777,565.

Also on the docket was the proposition 218 which would increase water rates to \$1.91 to be in compliance with the State Water Board. The increase would cause the Water Fund to bring in enough cash to pay for annual operations, which it has failed to do in previous years.

Even with that increase, the Water Fund will deplete cash reserves to make its annual State Water Board loan payment of \$85,000. City staff estimates a further increase to \$2.63 will need to be made to get the city within the correct rate compliance as set by the State Water Board.

Such a rate increase depends on the State Water Board's willingness to allow the city to gradually correct the problem of if it will require immediate repairs. ★

the softball teams. The Department has plans to install LED lighting, pour cement around the backstop and seating areas, establish ADA parking and access from Haskell Street to the seating area and potentially place tables in the vicinity. What work doesn't get completed this year will be

re-scheduled for spring of 2020 before the sporting season begins. disease and predation, use of herbicides and pesticides, and climate change.

What can be done to help these beautiful pollinators? Backyard gardeners can help restore breeding and migratory habitat here in Butte County by planting native milkweed and nectar-producing flowers that bloom from spring to fall. This can be as simple as planting annuals like zinnias, sunflowers, and asters in your garden. Even if your garden is small you can dedicate a small area or container to pollinator-friendly flowers.

Milkweed is a perennial plant. It is named for its milky, latex sap. Milkweed is drought tolerant and deer resistant. The native species are not invasive.

Milkweed plants develop large fleshy seed pods. When the seeds are mature, the pods pop open, freeing the seeds. Attached to the seeds are fine tufts of hairs (called pappus) which aid dispersal of the seeds: as the wind blows, it catches the silky hairs, carrying the seeds away from the plant. The seeds can be collected from the pods for later propagation or left alone to re-seed themselves.

Milkweed belongs to the genus *Asclepias*. The California native milkweed species that are most commonly available commercially and grow well in this area are narrow-leaved milkweed (*A. fascicularis*) and showy milkweed (*A. speciosa*).

Other native milkweed species that are not commonly available include California milkweed (*A. californica*), wooly

milkweed (*A. vestita*), woolypod milkweed (*A. eriocarpa*) and heartleaf milkweed (*A. cordifolia*), which is suited to the Sierra foothills.

Home gardeners can aid the Monarch population by adding milkweed to their landscape, pollinator garden, herb garden, or even a patio container. If you own a larger plot of land you might consider letting some of it remain wild, so that the wild nectar producing flowers are available not only for butterflies, but for other pollinators as well.

Hedgerows that include milkweed and nectar flowers are a wonderful way of attracting wildlife and pollinators. Creating a monarch way station (a garden that includes milkweed, nectar flowers and a water source) is a nice addition to a community or school garden.

Once the monarch lays its eggs and the caterpillars hatch, they will devour most of the leaves on the milkweed plant. By the time the caterpillars are ready to morph into chrysalis, the plant will look dead, but don't despair - the leaves will grow back.

Milkweed is also a great host plant for many other beneficial insects including bees, beetles, and lady beetles (ladybugs). It will also attract a yellow aphid known as Oleander aphid. This aphid will not destroy the plant and it will not infest nearby roses or vegetable gardens. It is plant specific: think of the Oleander aphid as food for the lady beetles.

Avoid using pesticides or herbicides that might damage these breeding and feeding areas. Use caution

where you plant the seeds, as milkweed can be toxic to livestock.

Area specific milkweed seeds can be purchased online. You can also find milkweed plants at our upcoming Master Gardener plant sale on Saturday, April 20th, from 10 a.m. to 2 p.m. at our Demonstration Garden at Patrick Ranch, located at 10381 Midway, Durham. **SACRAMENTO, CA (MPG)** - Director Tanya N. Garfield of the U.S. Small Business Administration's Disaster Field Operations Center-West today reminded California small businesses of the May 6, 2019, deadline to apply for an SBA federal disaster loan for economic injury caused by wild-fires and high winds that occurred July 23 - Sept. 19, 2018.

According to Garfield, small nonfarm businesses, small agricultural cooperatives, small businesses engaged in aquaculture and most private non-profit organizations of any size may apply for Economic Injury Disaster Loans of up to \$2 million to help meet working

capital needs caused by the disaster.

"Economic Injury Disaster Loans may be used to pay fixed debts, payroll, accounts payable and other bills that cannot be paid because of the disaster's impact. Economic injury assistance is available regardless of whether the applicant suffered any property damage," Garfield said.

These low-interest federal disaster loans are available in Colusa, Glenn, Lake, Lassen, Mendocino, Modoc, Napa, Plumas, Shasta, Siskiyou, Sonoma, Tehama, Trinity and Yolo counties.

The interest rate is 3.61 percent for businesses and 2.5 percent for private nonprofit organizations with terms up to 30 years.

Loan amounts and terms are set by SBA and are based on each applicant's financial condition.

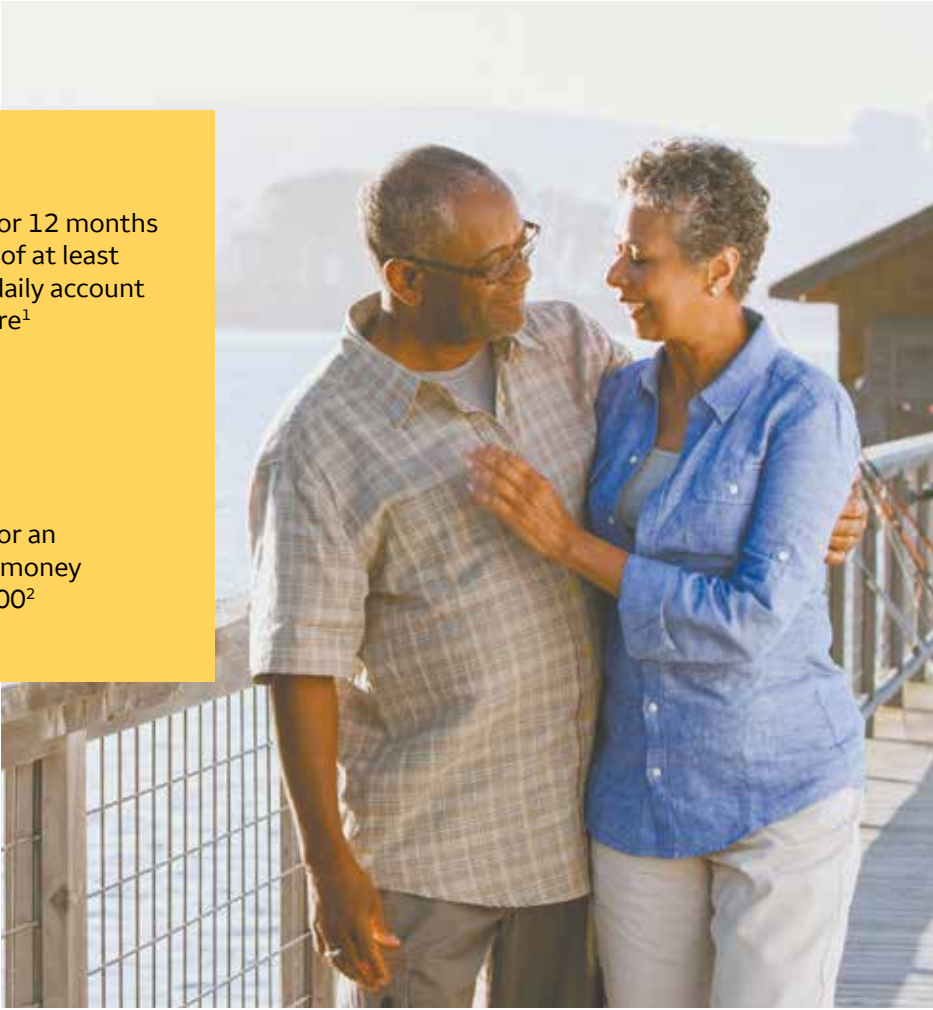

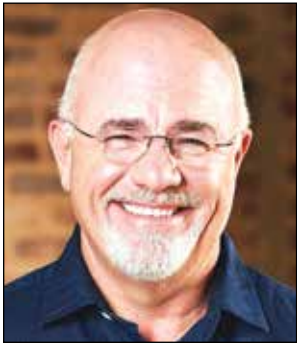

Preparing for the Real World

Dear Dave,  
I'm getting married this summer and about to become a stepfather, but my fiancé's daughter from a previous marriage seems very irresponsible. She's 20 and lives at home, has trouble holding a job, and she doesn't really want to work. When she doesn't have money to make her car payment, she seems to expect her mom to pay it for her. My fiancé and I both agree that she's been too lenient with her in the past, but she doesn't want to suddenly pull the rug out from under her. How do you think we should approach this situation?  
— Kendall

Dear Kendall,  
Marriage counselors say you have a good chance of having a successful marriage if you're in agreement on four things—religion, money, children, and in-laws. So, first things first. I'd strongly suggest you and your fiancé go

through pre-marital counseling to make sure you're on the same page when it comes to handling this and other issues.

If you and her mom really want to show her you love her, you'll make sure she starts learning some character and discipline. And it's very important that both of you are on the same page and in agreement every step of the way. You might also want to read a book together by Dr. Henry Cloud called "Boundaries." This is a great book, and it will give you both several ideas for creating a reasonable timeline aimed at teaching her more responsibility.

I would advise letting her mom present any changes to her initially. Neither of you wants to create a scenario where you're viewed as the bad guy. Let her mom start the process by explaining that she made a few mistakes in terms of teaching her more about personal responsibility and self-reliance when she was younger. Then, she can begin to lay out the first few rules and expectations.

In my mind, there's nothing wrong with requiring her to get a job within 30 days if she doesn't already have one. If she needs to go job hunting, make sure

she's out of bed and on the road no later than 8:00 a.m. every morning. During this first phase, looking for work every day should be her job. It wouldn't be a bad idea to start teaching her about budgeting, saving, and everything else that goes into handling money responsibly during this time, too.

Next, phase two might consist of requiring her to help around the house doing chores on her days off, or whenever mom needs a hand. Then, after a month or two of this, phase three might consist of her paying a small amount in rent.

Do you see what I'm doing? By stepping up the expectations gradually you're building a foundation so she'll have the tools and knowledge to where, in the sixth or seventh month, she's moving out and taking care of her own responsibilities.

Like an adult!

**25 Years Ago (1994)**  
“GHS Variety Show”  
This year's Gridley high school Variety Show, hosted by the Parents Club, will be held Thursday, Friday and Saturday nights April 14th, 15th and 16th at 7:00 PM at the newly renovated Butte Theater. Students will be performing the play “Around the World... By Accident” a politically incorrect satire that pokes fun at everything from “dumb jocks” to “old coots”. High school marching and jazz bands will perform selections from their recent Disneyland tour while other students showcase their talents in skits, dance productions, vocal numbers and musical reviews. Proceeds from the event will go to find various student activities.

**50 Years Ago (1969)**  
“School Board Elections”  
None of the candidates for Gridley area school boards are a “shoe-in” for the positions, as there are more running than there are vacancies to be filled. The race that appears to be drawing the most interest is the one for the Gridley High School Board of Trustees, with six candidates running. Candidates are as follows for the high school Board: M.J. Dear Dietitian  
Listeria

**Dear Readers,**  
If you have been listening to the news lately, you may have heard about more food recalls. This time almond butter and avocados were recalled for concerns of listeria contamination. Listeria monocytogenes is type of bacteria found in soil and water and in some animals, including poultry and cattle. It can also be found unpasteurized cheese and milk. Listeria can live in processing plants and contaminate a variety of processed meats. When someone consumes food contaminated with listeria, it may cause a foodborne illness known as listeriosis.

Listeria is named after Joseph Lister, the British pioneer of sterile surgery. According to the Centers for Disease Control (CDC), an estimated 1,600 people get listeriosis each year, and about 260 will die from it. Symptoms of listeriosis include fever, muscle aches, nausea, vomiting, and diarrhea.

Those who are most vulnerable to food poisoning are people who immunocompromised, like those undergoing chemotherapy

for cancer. These patients often do not have the ability to fight off the infection. Young children, pregnant women, and elderly adults are also more vulnerable to foodborne illness.

It is important to note that foodborne illness can be passed from one person to another. It is generally passed via the fecal-oral route. Someone has diarrhea and doesn't thoroughly wash her hands after using the bathroom. She then touches a light switch, leaving a trace of bacteria. Someone else flips on the light switch two minutes later and comes into contact with the bacteria. She then pops a piece of gum into her mouth, and the bacteria has entered her system.

Why do we seem to be hearing more about food poisoning? No one knows for sure, but there are theories. In an article that appeared in the Business Insider (Taylor, 2018), foodborne illness attorney Bill Marler gave three possibilities:

1. Early detection. In both cases of the avocados and almond butter, no illnesses were reported. The possibility of contamination was detected, and both companies took their products off the shelves voluntarily.
2. More than half of fruit and a third of vegetables purchased in the US are now imported from other countries. While imported food isn't necessarily less safe, it can allow for more opportunities for contamination

along the way.  
3. Convenience foods. The demand for pre-chopped fruits and vegetables allows more opportunities for these foods to be contaminated simply because they are handled by more people.

Oftentimes, foodborne illness is preventable. The following tips were taken from the Academy of Nutrition and Dietetics:

- Keep raw meat, poultry, seafood, and eggs separate from ready-to-eat foods.
- Wash your hands thoroughly with soap and warm water. Wash them after using the bathroom, before eating, before preparing food, and after petting an animal, even if it's your own pet.
- Wash raw fruits and vegetables before eating them.
- Use a food thermometer to make sure foods are cooked to the appropriate internal temperature.
- Store perishable foods at or below 40°F.
- Do not consume unpasteurized milk or cheese.

They all looked over at the tall cowboy, Steve.

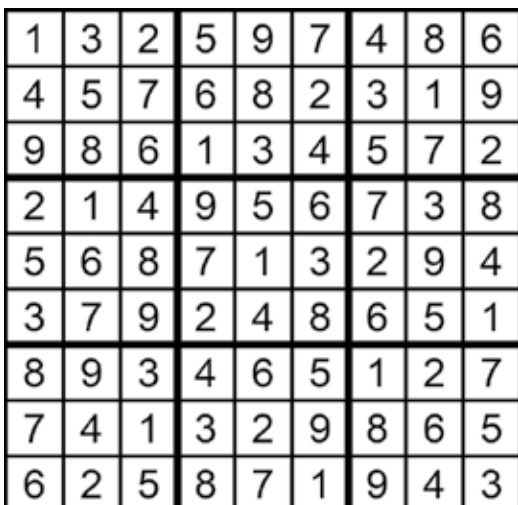

## Hunter Roles Throws No-Hitter for Wolverines against Quincy

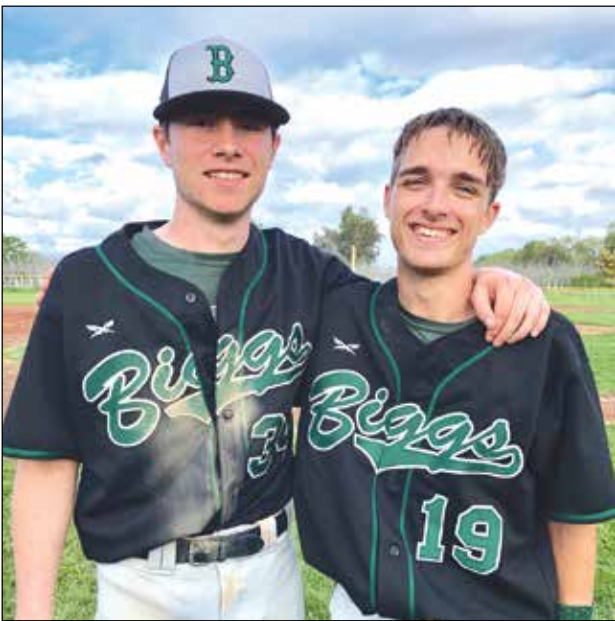

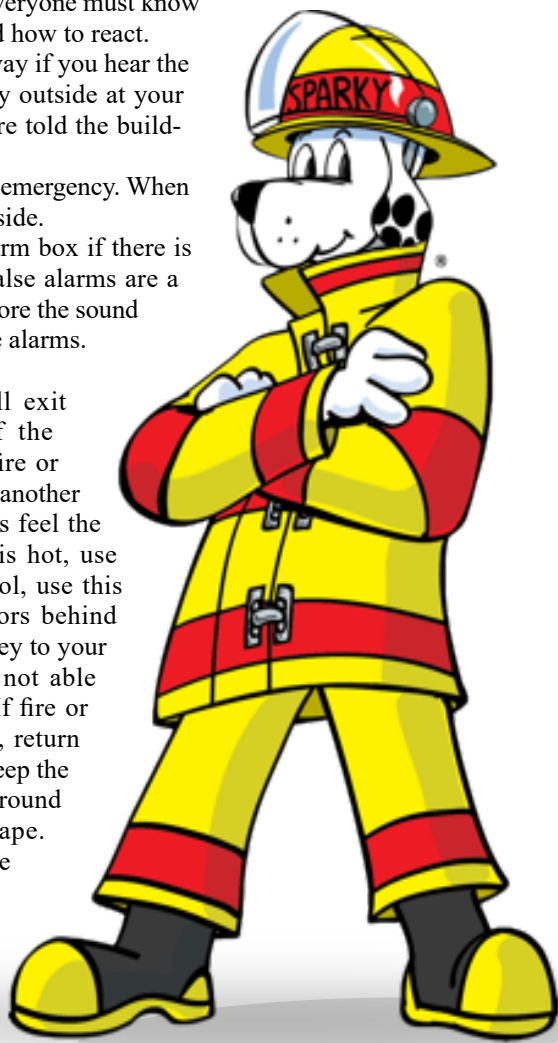
# SPARKY'S CORNER

## FIRE ALARMS IN APARTMENT BUILDINGS

Large apartment buildings are built to keep people safe from fire by utilizing alarm systems that detect smoke and fire that will warn residents of danger.

- In a fire, smoke detectors sense smoke and activate the fire alarm. Manual fire alarm boxes allow people to sound the alarm. When the fire alarm system activates it will warn residents of danger.
- Everyone in the building should know where to find the manual fire alarm boxes (alarm boxes on the wall with a pull bar). Most are found within five feet of an exit door.
- If there is a fire, pull the manual fire alarm box handle on your way out of the building.
- When the system senses smoke or fire, a loud horn or tone will sound. Everyone must know what this sound means and how to react.
- Leave the building right away if you hear the sound of a fire alarm. Stay outside at your meeting place until you are told the building is safe.
- Treat every fire alarm as an emergency. When the alarms sounds, get outside.
- Only use a manual fire alarm box if there is smoke or fire. Frequent false alarms are a problem. People might ignore the sound if they hear too many false alarms.

Know the locations of all exit stairs from your floor. If the nearest one is blocked by fire or smoke, you may have to use another exit. If the fire alarm sounds feel the door before opening. If it is hot, use another way out. If it is cool, use this exit to leave. Close all doors behind you as you leave. Take the key to your apartment in case you are not able to get out of the building. If fire or smoke is blocking all exits, return or stay in your apartment. Keep the door closed. Cover cracks around the door with towels or tape. Call 9-1-1 and let the fire department know you are trapped. Signal from the window by waving a flashlight or light-colored cloth. ★
