# Cleaning Up Blood Alley

OROVILLE, CA (MPG) - The section of Hwy 70 that stretches between the northern city limits of Marysville to Oroville has been knick-named "Blood Alley" by some and is known as one of the deadliest roadways in northern California. Over the recent years, the increase in hazardous diving along the mostly two-laned highway has resulted in over 30 fatal CHP offices, Butte and California Highway Patrol and local of safety measures at a press conference held Wednesday, March 6th.

These upcoming roadway improvements and measures are part of a multi-agency campaign to increase public safety and reduce traffic collisions along the highway 70 corridor and will precede the start of a series of construction projects along the route planned to begin later this spring. Among those projects will be the addition of passing lanes from Ophir Road to Palermo Road. Caltrans District 3 Director Amarjeet

S. Benipal said during the conference that "We echo the public concerns about traffic safety along this corridor and stand committed to ensure the roadway stays safe for travel. Safety is our top 1 priority."

safer driving conditions, Caltrans, the announcing the establishment of a Daylight Headlight Section on elected officials announced a series a 22-miles stretch of highway 70. Motorists will now be required to turn on their headlights while driving on Hwy 70 anywhere between Laurellen Rd north of Marysville and Ophir Rd, just south of Oroville. Benipal states that "From our experience, daylight headlight sections have been effective in increasing motorist safety on heavily traveled rural roadways." Statistics from National and International studies support the director's comment, showing that the use of daytime

Other safety measures that can be expected in the near future are the installation of 5 solar-powered RADAR speed feedback signs in along the route in Yuba and Butte counties and 3 signs alerting motorists that passing lanes are ahead between Cox Lane and Central House Rd. The installation of additional rumbles strips along the corridor, alerting motorists that they are crossing the center divide or leaving the roadway, is expected to cut fatal accidents by 44 percent and use of headlights reduce daylight head-on collisions by 42 percent. ★

## **CA Has Some** of the Worst **Drivers**

If you're constantly frustrated with the drivers you share the streets with, you're not alone. And there may be some truth to your road rage. Car crashes are a leading cause of death in the US and were expected to cause around 40,000 deaths by the end of 2018.

To put it plainly, America's roads are dangerous. Texting behind the wheel is a major reason for many traffic fatalities, and it's only getting worse. In 2016, 3,450 people were killed by distracted driving. Plus, cheap gas and a strong economy means America's 222 million licensed drivers are driving more than ever. More people on the road leads to more accidents and citations.

Every state has their share of bad drivers, but some are worse than others. We ranked all states from worst to best based on the methodology outlined at the end of the article. These states have the worst drivers, in order; Maine, South Carolina, Nebraska, California, and North Dakota.

The US has been politically polarized for a long time. But after the 2016 presidential elections and the 2018 midterms, there's a rising divide between Democrats and Republicans. We took it upon ourselves to settle the score by determining which political party is better behind the wheel.

So, which is it- red or blue? The final score is a bit of a tossup. Considering two-thirds of the best driving states are historically red, and the worst driving state is blue, it looks like red takes the lead. But, the second and third worst driving states are conservative strongholds. So, we're calling it a tie.

Whether you live among the best or the worst drivers in the country, you still need a strong auto insurance policy. Especially if you live in Maine, South Carolina, Nebraska, California, North Dakota, or one of America's worst driving states.

Your rates depend in part on how well the people around you can drive. Why? Because the more bad drivers there are on the road, the higher the chance of a collision. Even if you're a fantastic driver, living in a state full of speed demons or reckless traffic weavers can cause your rates to skyrocket. Car insurance companies look at your zip code to determine your prices. And if your zip code has a propensity for poor driving, you'll pay more for coverage.

The rankings are a sum of weighted means calculated from these incidents: Accidents; Speeding tickets; DUIs; Citations; Fatalities.

## The New Pi-Line: Thank You for Your Service Vere

United States Navy SKD1c (his rank) Vere Gardner, one of the last remaining military survivors of the Japanese Empire's attack on Pearl Harbor, passed away listening to grandchildren singing at his bedside on March 2, 2019. Born on December 20, 1922, he was 96. His wife Artie Mae Sutton preceded him in death, they were married 71 plus years.

Today, (Friday, when you get this paper) at 11:00 AM at the Liberty Ward Building of the Church of Jesus Christ of Latter-day Saints, he will be honored with a funeral service. He believed in Jesus and he expects to be resurrected into a state of eternal happiness along with his wife and family. This is good to

Vere is one of the last of the greatest generation of Americans. After graduating from Gridley High School he joined the Navy - and his story would make a great script for a 3 hour true to life historic adventure movie.

He was at Pearl Harbor Hawaii when the attack occurred, away from his ship at a Marine mess hall.

and Marines literally shot down a Japanese airplane with rifles (they were not officially credited with the kill until 1981, but it is now official military history).

That is just the opening trailer for the movie - from 1941-1945 Vere cruised the Pacific as a storekeeper, clerk, radi-oman, paymaster and sight setter for anti-aircraft guns, he also stood watch quite often. In a twist of comedic pro-portions he was one of seven members of the Church of Jesus Christ of Latter Day Saints - assigned to a boat named the USS Salt Lake City. The Pensacola Class Cruiser Salt Lake City had more combat engagements than any other ship in the Pacific Fleet with 38 major sea battles, invasions and/or bombardment of 30 islands, the sinking 4 Japanese Heavy Cruisers and 11 merchant ships, while shooting down 12 enemy aircraft.

Every year there have been fewer and fewer survivors of Pearl Harbor. There is a military association of Pearl Har-bor Survivors, but a couple of years ago because so many had passed away, and the health of the others had so deteriorated, they stopped having their annual meetings.

I last met Vere at the Memorial Day Ceremony in 2016, at the Gridley-Biggs Cemetery. I asked Vere if he would take a picture with me, and he did. He also took a photo with my daughter RileighAnne and many other people who understand what a big deal meeting a Pearl Harbor Survivor is.

Can you even contemplate what courage is required to take on a fighter plane with a rifle? Can He and his group of Sailors you imagine what it would

be like to be on the open sea taking bombs and bullets while you stay at your post and planes are crashing down on you? This is not an abstract concept, he literally shot at an enemy that was steaming toward California to kill us. The selfless commitment to duty, honor and country is something that should be reflected upon as we part company with one of the truly great heroes of our community. Their generation's sacrifices have given us decades of freedom from oppression and tyranny. There are no words to describe the level of respect I have for Vere Gard-ner, his volunteer service to our country, his life of humble

goodness, and his bravery. Mr. Gardner's daughter Sharon Gardner Miller, collected his history and interviewed him. Below are excerpts from those interviews in his own words:

"I went into the Navy in November, 1940 after graduating from High School. I volunteered to go. I was inducted at Goat Island (San Francisco, California). "

"I got to see a lot of the island (Hawaii). Whenever I got to go on liberty, I went to different wards (LDS congrega-tions) all over the island. I usually went ashore by myself, because I didn't drink and that was the main attraction for the servicemen. I ran across a cousin of mine (Lyle Merritt) from Utah in the Army at Fort Rucker. He lived off the base, so I ended up there on a long weekend. Sometimes we went to a dance. What little I know about dancing, I learned from his friends and their girlfriends."

"While I was with the boat crew, I had to take my turn at mess cooking, I was peeling potatoes when the Jap planes came over on the first run at the battle wagons alongside of Ford Island. I witnessed the Marine 1st Sgt. shoot Island." off the lock on the armory to set up a machine gun to was a report of parachutes in the sky, so everyone was issued a rifle and ammo and loaded into trucks and taken in a perimeter around Pearl Harbor. I was unloaded along with a

marine corporal in a housbase, where an off-duty officer was taking moving pictures. Our position was on a rise and could see everything that was happening in the harbor. When the planes made their runs on the ships they had to make a wide turn to go back to attack again, and they flew right over where we stood. Both of us, corporal and I, would fire our rifles at the planes, soon one of the planes exploded. So we shot down a plane. We never got credit for it because they never found the wreckage. It was found in the 1980's and our names are on a plaque in Pearl Harbor. It didn't make any difference to me. I knew that I had done what I could."

'We had the privilege of the first offensive attack against the Japs, 1 February 1942. We bombarded the island of Wotje in the Marshall Islands group. It was the first of 9 times that we hit it, but the first time we didn't know what to expect? Planes or support ships? We was at G.Q. (general quartersstanding at battle stations) for 72 hours, dur-ing which time my hair showed grey. We lived, ate, and slept on our battle stations, rain or shine, night or day. 24th of February we hit Wake Island. 2nd to 12th August 1942 we hit Kiska Island, 4th of March 1942 Marcus

"Battle of the Coral Sea where the Carrier fire on planes, shortly there Lexington was sunk, the torpedo that sunk her passed right underneath the U.S.S. Salt Lake City. When we seen the wakes, we thought we had had it, but they was too deep for

"When we was hit by ing out of the submarine shrapnel off Kwajalein, a dive bomber crashed alongside of the ship and blew up, which sent shrapnel which hit our (observation) airplane. So we had to go down to push the damaged aircraft off the ship. I was the third one down the ladder and 4th one down was hit in the head as he started down (and died). It was just 4 feet from my head. He was one of the twins that was aboard ship."

> "I was at Iwo Jima when Uncle Rusty Ford was wounded. Also I was on duty up in the foremast, with the gunnery officer and I watched the Marines put out the flags on Mt. Surabatchi. We had to get as close as we could be to the beach to cover the Marines in their advance positions. There were so many caves in the rocky formation that the only way to reach them was to blast them out or use flame throwers, if you could get close enough. SLC covered the whole battle of Iwo Jima without relief (from another ship)."

"Okinawa was much the same except we had to watch out for kamikaze airplanes as well as do all of our other bombardment duties. We never were hit by a kamikaze but I have seen other ships all around us that were not so fortunate. "

"We covered the landings of the following islands and beaches in the Pacific: Guadalcanal, Kiska, Kwajalein, Ma-juro, Saipan, Leyte Gulf, Iwo Jima, Okinawa, Philippine Islands. At this time I left the ship to come home to marry Artie - 30 days before the war was over."

GRIDLEY, CA (MPG) - The Camp Fire that leveled Paradise last November left hundreds of displaced students traumatized by their loss. Paradise Elementary School was totally destroyed by the fire, and students needed to relocate. 



police report immediately, and if possible, have this guy arrested. He has committed criminal fraud, and it's not something you should take lightly. Also, put a fraud victim alert on your credit bureau reports today.

Don't stop with just alerting the credit card companies about this situation. You should be speaking with and communicating via email—plus snail mail, if necessary—directly with the fraud victim division at every credit card company involved. Make sure they understand this is a denial of responsibility and not simply a dispute.

Let them know you're sorry this happened, but explain that all these charges in your names are the result of a criminal act perpetrated against you. You may have to stand your ground with the credit card companies, because some of them might try to get you to pay it, anyway. Don't do it!

## **Dear Dietician**

#### **Cancer and Nutrition**

#### Dear Readers,

Today I am writing about a topic near to my heart: nutrition and cancer, or more pointedly, nutrition myths and cancer. My clinical experience included twelve years of oncology nutrition, in both inpatient and outpatient settings. Good nutrition can help prevent some types of cancer, and not surprisingly, it is the same diet that helps prevent other diseases, such as heart disease and stroke. You've heard it before and read it in this column: Eat lots of fruits and vegetables, whole grains, and lean proteins. Eat more plant foods.

Conversely, there is a lot of misinformation on nutrition, especially when it comes to cancer. Cancer patients are sometimes afraid and vulnerable, which may make them susceptible to quack nutrition. Remember we live in a "let the buyer beware" society, and there is nothing in the First Amendment that requires free speech to include the truth.

#### These are just a few myths involving nutrition and cancer:

- 1. Sugar feeds cancer. This is misleading. The real question is "Does sugar make your cancer worse?" The answer is no.
- 2. A ketogenic diet does not involve glucose (sugar) and so starves the cancer tumor. The truth is our bodies must have glucose in order to survive. If we don't consume it in our diet, our bodies will make glucose from fat and/ or protein in a process known as gluconeogenesis -- a fancy name for making new glucose.
- 3. Alkaline water/diet similar to the baking soda myth. Supposedly, alkaline foods (including baking soda) and water neutralize a cancer-friendly acidic environment. The truth is the pH of our blood is slightly alkaline. Mechanisms are in place to keep this in place; otherwise, the human body cannot survive. It doesn't matter what the pH of your food or drinking water is, your body will always maintain a blood pH balance of
- 4. Vitamin D. According to Memorial Sloan-Kettering Cancer Center, an internationally renowned facility in New York: "Intake of vitamin D through diet may protect against breast or colorectal cancers or affect markers

for prostate cancer. However, vitamin D by itself does not prevent or treat cancer. Other large studies show that high vitamin D levels do not reduce the risk of many other cancers, and may increase risk for pancreatic or aggressive prostate cancers."

5. An-all vegetable diet. There was a patient in the hospital that revealed she had followed an all-veggie diet for cancer, and exclaimed, "I lost 30 pounds, and it was all muscle!" A vegetablesonly diet will leave you malnourished and dissatisfied, and on no uncertain terms, will not improve a cancer diagnosis.

While nutrition is a very important aspect of cancer treatment, there is no nutritional cure for cancer. It is important to stay well-nourished in order to help maximize the outcome of cancer

treatment. Registered Dietitians (R.D.s) are available wherever you receive cancer care to help you maintain a healthy nutritional status. My goal is to help you make informed decisions when nutrition is concerned.

#### 25 Years Ago (1994)

"Protest Petition" A petition has been circulating and now has 29 names of residents opposed to the establishment of what they claim will be an auto-dismantling business on Obermeyer Avenue opposite of Ayers Avenue. A firm named "A-1 Used Auto Parts and Tires" that also advertises "24 hour towing" on its business identification sign has been established at 39 Obermeyer Ave. The property is in a C-2 zone (commercial zoning district) but neighbors are strongly against the business's location and presented the City Council with a petition stating, "We, the residents of Obermeyer Ave and adjacent Ayers Ave sign this petition in protest of the recent occupancy of 35 Obermeyer Ave by 'Coast Dismantlers'." Unless there is evidence that the operators are failing to comply with zoning regulations, there is nothing that Planning Director Jo Sherman or the council can do.

#### 50 Years Ago (1969) "Local Soldier Receives

Honors" Army Sergeant Clifford S. Coats, son of Mrs. Madie Hughes of Biggs, received the Bronze Star Medal, presented by Brigadier General Darrie Richards. Sgt. Coats is squad leader in the 88th Transportation Company of the Army and received the award for heroism in action against the enemy forces in Vietnam, January 3rd. During the same ceremonies, he was also present the Purple Heart for wounds he received during combat action. #### **DWR Gives Lake Oroville Operations Update**

#### SACRAMENTO, CA (MPG)

With recent storms increasing runoff into Lake Oroville, the Department of Water Resources (DWR) is monitoring lake levels and taking steps to prepare in the event the newly reconstructed main spillway needs to be used. However, at this time DWR does not anticipate using the main spillway to manage lake levels and inflows in the immediate

Oroville's elevation is currently 773 feet. At this elevation, the reservoir is a little over 40 feet below the entrance to the main spillway. The following scheduled steps are being taken, as construction

activities are ongoing at the Oroville spillways:

• Based on current 10-day projections, reservoir levels could reach an elevation of 780 - 785 feet by the end of the month. At elevation 780 feet, DWR and its construction contractor Kiewit will take steps to remove equipment from the main spillway. To prepare for rising lake levels, DWR will also plan to shut and seal the gates before the lake reaches an elevation of 805 feet.

Once water reaches the gates at 813 feet, the lowest elevation at which the spillways can be used, it will not necessarily be activated. Releases are based on available flood storage, environmental needs, and water

deliveries.

If DWR needs to use the main spillway for flood control releases at any point during the season it will follow the 2018/2019 Lake Oroville Flood Operations

As of November 1, 2018, the Oroville main spillway is fully reconstructed and is capable of handling flood control releases. DWR is closely coordinating with our state and federal partners, including the National Weather Service, to monitor and stay aware of minute to minute forecast changes.

The recent precipitation and forecasted reservoir inflows mean Oroville is likely to reach average levels for this time of year.

# FIRE EXTINGUISH

BY PUTTING OUT A SMALL FIRE OR CONTAINING IT UNTIL THE FIRE DEPARTMENT ARRIVES; BUT PORTABLE EXTINGUISHERS HAVE LIMITATIONS. BECAUSE FIRE GROWS AND SPREADS SO RAPIDLY, THE #1 PRIORITY FOR RESIDENTS IS TO GET OUT SAFELY.

Fire extinguishers are one element of a fire response plan, but the primary element is safe escape. Every household should have a home fire escape plan and working smoke alarms.

#### **SAFETY TIPS**

- Use a portable fire extinguisher when the fire is confined to a small area, such as a wastebasket, and is not growing; everyone has exited the building; the fire department has been called or is being called; and the room is not filled with
- To operate a fire extinguisher, remember the word PASS:
- Pull the pin. Hold the extinguisher with the nozzle pointing away from you, and release the locking mechanism.
- Aim low. Point the extinguisher at the base of the fire.
- Squeeze the lever slowly and evenly.
- Sweep the nozzle from side-to-side.

• For the home, select a multi-purpose extinguisher (can be used on all types of home fires) that is large enough to put out a small fire, but not so heavy as to be difficult to handle.

Choose a fire extinguisher that carries the label of an independent testing laboratory.

Read the instructions that come with the fire extinguisher and become familiar with its parts and operation before a fire breaks out. Local fire departments or fire equipment distributors often offer hands-on fire extinguisher trainings.

Install fire extinguishers close to an exit and keep your back to a clear exit when you use the device so you can make an easy escape if the fire cannot be controlled. If the room fills with smoke, leave immediately.

Know when to go. Fire extinguishers are one element of a fire response plan, but the primary element is safe escape. Every household should have a home fire escape plan and working smoke alarms.



# Having a Disability Doesn't Mean Life Stops

Laura Monaco; Independent Living Skills and Assistive Technology

SACRAMENTO REGION, CA (MPG) - Laura Monaco spent her whole life trying to fit in. It wasn't until she came to Society for the Blind in her mid-30s that she finally found what she was looking for – and she's never been happier.

Born with albinism, Laura grew up in Chico with white hair, fair skin and pink eyes. She was legally blind from birth. Teased her whole childhood until she could finally dye her hair and wear makeup at age 12, Laura struggled through school all the way through receiving her associate's degree at Butte College in Chico. No matter what activity she participated in, she always felt different.

"I struggled my whole life to be the same," Laura said. "I didn't want to be that albino girl or that blind girl. I was a good cheerleader, but I would burn in the sun at cheerleading camp and couldn't see well, so I'd get discouraged."

She became a daycare provider and ran her own business for 12 years, but sometimes faced discrimination from parents because of her vision. Married for 11 years with three children, Laura hit rock bottom in her struggle for acceptance when she got divorced at age 34. She started doing drugs, her children went to live with her parents, and she was homeless for a year and a half until the summer

Carmichael and was connected to a transitional and she learned how to use housing program.

"I came from a good home, but I struggled with depression from feeling life," Laura said.

In January 2018, Laura housing program and started classes at Society for the Blind. Here, for the first time in her life, she found a group of employees and students who understood how it felt to be blind. She began learn-

of 2017 when she checked skills like how to cook and into a treatment center in how to get around town using public transportation, assistive technology to her advantage. She began to feel like she had a family.

"I realized how much like an outsider my whole I lived in fear and I was ready to face it," Laura said. "Society for the Blind finished the transitional made me finally feel at peace with myself. I have friends who all have the same struggles and understand me."

When she had the opportunity to apply for a job working in the North State Assistive Technology Store ing independent living at Society for the Blind, Communications

she jumped at the chance and was hired. A year later, she can't say enough positive things about her job and her daily opportunities to help people discover the same assistive technology tools that have changed her life. She plans to go back to school for her bachelor's degree and wants to stay working at the store as long as possible - and she's seen the effect her new life has had on her kids, now ages 21,16 and

"My kids are really proud of me," Laura said through tears. "There was a lot that had been broken during those years. Now they love me walking in the mall with my cane and helped me celebrate my first anniversary of sobriety. They're glad to have their mom back, and I've shown them that you can pick yourself up from these things. Having a disability doesn't mean life stops."

Laura's number one recommendation to people who feel different in any way is to get connected. Laura now lives in Carmichael.

"Find a support group, a friend, someone you have something in common with," Laura said. "There's a lot out there now because of the Internet and Facebook, and it makes a huge difference. If I had done that when I was younger, my life and my kids' lives would have been a lot different."
