



GRIDLEY, CA (MPG) - The main item on the agenda for Monday night's Gridley City Council meeting was the possible termination of Gridley-Biggs Police Chief Dean Price.

But hours before the meeting drew a rare standing-room only crowd to the council chambers, Price made the agenda item moot by submitting his resignation.

In a letter to both the cities he's served as chief of police for the past four years, Price said his retirement/resignation would be effective at the end of October.

"I am grateful to the Gridley City Council for their confidence in me and for allowing me the privilege to serve as chief for the past four years," Price said.

Price also thanked the community of Biggs for contracting with Gridley for its police services.

"Thank you to the citizens of both Gridley and Biggs for your support, love, friendship and trust in allowing me to lead your police department the past several years," Price added in the letter. "I will cherish the many relationships I have made."

Mayor Frank Hall became emotional as he addressed the issue.



### 2019 Highway **Safety Plan** Funds \$82 **Million in Traffic Safety Grants**

OTS Awards 287 Grants to Agencies Statewide

CALIFORNIA (MPG) - The California Office of Traffic Safety (OTS) announced plans to fund more than \$80 million in traffic safety grants to hundreds of local and state agencies for the 2019 federal fiscal year, which started October 1.

The 287 grants awarded are part of the annual OTS Highway Safety Plan, which outlines traffic safety priority areas, and programs aimed at strengthening and expanding our efforts to save lives on California roads.

"This funding is vital in our efforts to reduce traffic deaths and bring about behavior changes needed to make roadways safer for everyone," OTS Director Rhonda Craft said. "Our goal is zero deaths, and we will continue to do everything we can to reach this goal."


### The grants will help fund multiple traffic safety efforts:

•Enforcement operations: Addressing primary collision factors with special emphasis on alcohol, drug-impaired and distracted driving. Provide drug-recognition training for officers and prosecutor training for handling DUI cases.

"I don't understand why this is happening," Hall said, his voice breaking.

Meanwhile, the three remaining council members - Chris Williams, who requested that Price's employment status be placed on Monday night's agenda, Ray Borges and Vice Mayor Bruce Johnson - spent most of the 45-minute meeting sitting in stone-faced silence as speaker after speaker praised Price and berated the council for its apparent desire to force Price out of his post.

Some of the speakers included some of Gridley's most prominent citizens and civic leaders, including Gridley School Board President Eric Waterbury and board member Art Cota.

"You're making a big mistake," both Cota and Waterbury told the council.

It was a statement repeated often during the more than 30-minute public comment period, especially by Biggs council members



Butte County Sheriff Kory Honea was also on hand to offer his support to Price, reading a letter from Butte County District Attorney Mike Ramsey in addition to addressing his own comments to Price.

"Your shoes will be hard to fill," Honea

said. "You're a class act, and I'm glad you're my friend."

Council members declined to comment after the meeting, as did City Administrator Paul Eckert.

- •Motorcyclist, Bicyclist and Pedestrian Safety: Youth and adult education, traffic violation enforcement.
- •Occupant Protection: Increasing seat belt use, child passenger safety seat training and education.
- •Traffic engineering/records: Improving state and local data systems, identify areas with high concentration of collisions, and countermeasures to create safe environments for all modes of transportation.
- •Emergency Medical Services: Upgraded extrication equipment, improve response times and survivability rates in crashes.

In addition, OTS actively partners with private sector, non-profits, advocates and community-based organizations who share the same goals of making roadway safety a priority.

The federal grant awards can only be used for traffic safety activities during the federal fiscal year, which is October 1 to September 30. Grants are awarded based on data-driven traffic safety problem(s) identified by the organizations applying for funding, as well as a demonstrated ability to show effectiveness in reducing traffic deaths and injuries.

### LOOKINGBACK BY SETI LONG

#### GRIDLEY, CA (MPG) - The following are stories that appeared in the Gridley Herald 25, 50, 75, 100 and 125 years ago:

#### 25 Years Ago (1993) "Live Oak Info Center Acquisition"

The Live Oak City Council is asking to establish a Travelers Information Center on Hwy 99, which would allow them to apply for grant funds to purchase the site. The property, located on the west side of Hwy 99, is owned by Southern Pacific Railroad, which is willing to sell the site for \$225,000. The acquisition of this property would assure the preservation of the historic California and Oregon Railroad depot building and the city's huge namesake oak tree.

#### 50 Years Ago (1968) "Freeway Delayed."

It will be at least six to ten years before Gridleyans can expect updates to the freeway to reach completion. Boyd Peterson, design engineer from District 3 Division of Highways told the Gridley District Chamber of Commerce members that the state has not begun purchasing properties for the rights-of-ways and will not

do so for another 3 years. Peterson explained that the bulk of present spending is on the Interstate System and the state is focusing on meeting the 1974 deadline set for those repairs before turning its' attention to new projects. He continued to inform the chamber that over 14,000 miles of freeway is being planned for California, 7,000 of which has been routed and 3,000 miles has been completed. He forecasted that transitions of Hwy 99 to freeway routes starting south of Yuba City and going north to Hamilton Road near the Afterbay would begin in the coming year. It is the hope of the division that changes will be completed and that section be ready for use by 1970, but other areas of freeway will have to wait.

### 75 Years Ago (1943) Flash and Sound Bombs for War on Ducks

A supply of cases of flash and sound bombs has been shipped to Butte county rice growers for use in herding ducks and blackbirds. according to George L. Cosart, county war board chairman. Cosart has appointed a county wide committee to assist rice growers and farmers to

obtain the ammunition and bombs. Ricemen claim that the waterfowl are much more numerous this year and congregating earlier than usual, causing issues with harvest. Many growers have been unable to obtain ammunition of any kind due to the war. Crop production is crucial to the war effort and the success of the troops.

#### 100 Years Ago (1918) **Angry Bull**

Walter Johnson, of Live Oak, narrowly escaped death Thursday evening when he was attacked by a bull which got out of the corral it was kept in. The bull got Johnson down and worried him ten minutes before help could come and drive the animal away. Johnson suffered severe bruises and a gored face.

#### 125 Years Ago (1893) **Business Changes in** Gridlev

The Gridley livery stables have again changed hands. C.H. Block is the new proprietor. The Pacific Hotel is in new hand. It is owned by P. Charles, of Galt. Andy Ellison has opened a harness repair shop next door to the livery stable.

### **2017 Butte County Crop Report**

BUTTE COUNTY, CA (MPG) - Butte County's gross value for agricultural production in 2017 was \$696,563,214 - representing an increase of nearly \$776,000 from the previous year (\$695,787,317).

Walnuts (English), rice, almonds and prunes led the way for 2017 crop values. Walnuts continued to be the number one crop that generated close to \$255 million in gross value. Rice became the number two crop in the county at \$145.5 million. Almonds dropped to the number three crop at just over \$138 million. Prune growers had a bounce back year in 2017 and remained number four at \$35 million.

"Butte County farmers realized similar overall prices for their crops in 2017 compared to previous year's values. It's the

main reason why our agriculture industry was able to have a slight overall increase in crop value. Agriculture is still the number one industry in Butte County and contributes to our economy in the form of employment, labor income and value added," said Butte County Agriculture Commissioner Louie Mendoza. "About one in five jobs in our area is attributed to agriculture." Butte County's Agricultural

impacts go far beyond the orchards, fields, farmers and farm workers. Each dollar earned within agriculture fuels a more vigorous economy by stimulating additional activity in the form of jobs, labor income and value added such as generating business in banking, marketing, transportation, and other services. The contrifor nearly 1.7 million jobs in California.

Butte County agricultural exports to other countries did experience a slight decrease in 2017. Export destinations range from Algeria to Vietnam, with 63 countries and 10 states importing Butte County agricultural products. Indications at this point are that the number of agricultural exports will continue to stay resilient as products remain in demand.

The figures presented in this report are estimated gross values with no consideration of production costs and do not reflect net income to producers.

GRIDLEY, CA (MPG) - On the happy occasion of our class reunion this summer, one of my dearest friends from the Bulldog Class Of 1988 mentioned to me that he had recently been in a business meeting and there was a guy there from Corning and that he instantly did not like him. I pointed out that we graduated from high school 30 years ago and we shouldn't judge all people from Corning based on our football, baseball, and basketball experiences when we were kids.

He responded by asking me "have you forgotten what they did to us?" Oddly, I had to tell him I don't remember what Corning did to us. I remember that most Championship games in Baseball, Football and Volleyball were always between us and them. But a lot of high school is a bit fuzzy now. I shared this funny

exchange with several people and I found out that many of my friends still hold High School sports grudges; for decades. I am the statistical outlier. I found that people from Biggs really don't like people from East Nicolaus and Esparto too. One summer Southern Pacific was so desperate kids were used on the section gang to tamp ties. That was where we learned to cuss in basic Mexican but never learned to hit the hammer on the spike. Tamping the ties with the square ended shovel was our speed

Even Tri Vallev Cannerv, then Libby. then McNeill and Libby, used young help.

**Kavanaugh Assault** Validates Trump

The attempted political assassination of Brett Kavanaugh is bad for the country, but good for a Trumpian attitude toward American politics.

The last-minute ambush validates key assumptions of Donald Trump's supporters that fueled his rise and buttress him in office, no matter how rocky the ride has been or will become. At least three premises have been underlined by tawdry events of the past weeks.

First, that good character is no defense. If you are John McCain, who genuinely tried to do the right thing and carefully cultivated a relationship with the media over

decades, they will still call you a racist when you run against Barack Obama.

If you are Mitt Romney, an exceptionally earnest and decent man, they will make you into a heartless and despicable vulture capitalist, also for the offense of campaigning against Obama.

If you are Brett Kavanaugh, a respected member of the legal establishment who doesn't have a flyspeck on his record across decades of public service in Washington, they will come up with dubious accusations of wrongdoing from decades ago when you were a teenager.

Second, that the media is an unremitting political and cultural adversary. In the Kavanaugh controversy, the press has been wholly on the other side, presuming his guilt and valorizing his accusers and their supporters, including Hawaii Sen. Mazie Hirono, whose most famous contribution to the debate was telling men to "shut up.'

Third, that politics isn't just

rough-and-tumble; it's red in tooth and claw. Process and norms are nice, but they go out the window as soon as something important is at stake, like a potential fifth vote on the Supreme Court to overturn Roe v. Wade.

Senate Democrats may delicately talk about the importance of norms and civility on Sunday shows, but watch how they act. They sat on an accusation throughout an extensive process of vetting and questioning a nominee, then declared it dispositive evidence against his confirmation when it leaked at the 11th hour. They delayed a hearing with Christine Blasey Ford long enough to allow time for the second accuser to be persuaded to come forward.

All of this plays into Trump's support. Surely, a reason that the president appealed to many Republicans in the first place, despite his extravagant personal failings, was that they had decided that virtuous men would get smeared and chewed up by the opposition's meat grinder, so why

be a stickler for standards?

If Trump's attacks against the media are over-the-top and sometimes disgraceful, at least he understands the score.

He may not be a constitutionalist, but he will be faithful to his own side, and fiercely battle it out with his political opponents.

The logic of this dynamic is risky. It can be self-defeating, and lead down the road of supporting, say, a Roy Moore, a kooky candidate doomed even in red Alabama. It can be corrupting, if character and standards are no longer considered important. But the dark view of our politics that has driven the Trump phenomenon for three years now is impossible to gainsay. Who can watch the frenzied assault on Brett Kavanaugh and say that it's wrong?



\*If you are a Gleaner: a completed Gleaner Certificate While the commodity is in your possession, while being transported, and until sold.
