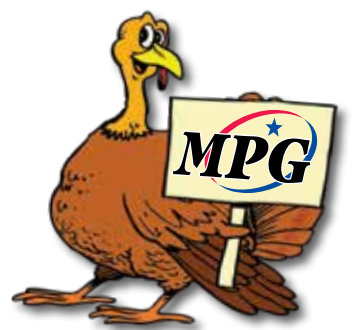

Eagle on Deck

CARMICHAEL, CA (MPG) - Eagle Scout candidate Zaven Gee has nailed much-needed renovations to an Effie Yeaw Nature Center deck.

Over two weekends, he led work that topped the Carmichael facility's must-do list. Zaven's assignment included replacing 500 square feet of dry-rotted wood. The Orangevale Scout and supporters then sanded and stained new boards and positioned metal ramps for ADA access. "Our renovation will allow staff to add enclosures and cabinets to use the deck

for outdoor classes," he explained.

The 17-year-old Casa Roble High senior has enjoyed the center since childhood and previously helped build its aviary. Fellow Troop 144 members and parents bolstered deck restoration.

At a cost of \$1500 - for lumber and other materials - funding was met by Zaven's community outreach. "People gave \$1000 in my first week of fundraising," he reported. "That shows they think the Nature Center is a good cause."

Eagle status is a final step in many Scouting careers. To achieve the rank, candidates must complete a project beneficial to community

- incorporating skills learned as Scouts. "My project would have been hard without my dad," admitted Zaven. "As a machinist, dad (Ricky Gee) was the backbone of the process. He knows his way around tools and motivates me to get things done."

The completed deck crowns Zaven's eight years as a Scout. "I like how the organization encourages young people to give back," he considered. "I'll feel good when I see my project helping education at Effie Yeaw. Learning about nature is good for the whole world."

California Faces \$25 Billion Budget Shortfall

When I last wrote about California's state budget picture, Gov. Newsom was warning in his September veto messages about the state facing lower-than-expected tax revenues in the first months of the new fiscal year, and urging lawmakers to "remain discipline when it comes to spending."

With ongoing inflation and economic problems, the state's budget problem is growing worse by the day. The Department of Finance's most recent Finance Bulletin, released in October, pegged the current deficit at \$6.967 billion through September.

Personal income tax cash receipts in September came in 22.9 percent lower than projected for the month, while estimated tax payments for the month were 42.3 percent lower. The Department notes that "September is a significant month of personal income tax receipts as many taxpayers pay their third quarter estimated payments."

While the Governor's budget won't be released until January 10, we get a sneak preview of the budget debate every November when the non-partisan Legislative Analyst's office releases their annual fiscal outlook for the year ahead. This year's outlook, which was released on Wednesday, is pretty dire.

According to the LAO report, the state faces a \$25 billion budget shortfall in the 2023-24 fiscal year, which is primarily the result of lower revenue estimates than projected in the 2022-23 state budget. Over the three year budget period (2021-22 through 2023-24), the LAO estimates \$41 billion in lower revenue than projected in the enacted state budget. If the state enters a recession, which many economists believe is nearly upon us, the LAO says "revenues could be \$30 billion to \$50 billion below" their current estimates. The LAO also forecasts multi-billion-dollar deficits each year through the 2026-27 fiscal year.

Rising inflation makes the state's budget problem even worse. The LAO estimates that the Legislature can meet the requirements of the voter-approved Proposition 98 minimum funding guarantee for education and provide an 8.38 percent cost-of-living adjustment. However, inflation adjustment isn't built into the rest of the budget. As a result the LAO notes that, "our

Sacramento-area Giving Machines Are the Only Ones in California

SACRAMENTO REGION, CA (MPG) - This holiday season, Sacramento-area residents can go to vending machines and purchase clothing for a local refugee family, meals for a needy family, a blanket for a homeless person, essentials for a battered woman, and even chickens for a family in Africa.

It is part of a global effort to promote the true spirit of the holidays by giving gifts to those in need. The Light the World Giving Machines, organized by The Church of Jesus Christ of Latter-day Saints, will be located on the first floor of the Westfield Roseville Galleria and stocked with items that are needed by four regional and three international charities.

The Sacramento-area Giving Machines will be available Nov. 22, 2022, to Jan. 2, 2023. The items available to donate range from \$7 socks to a \$250 children's bedding kit that includes a mattress, blanket, sheets and pillows.

"The Giving Machines will help Catholic Charities of the Diocese of Sacramento in our mission to assist women, children and families in our region who are struggling during these very tough economic times," said Miriam Sammartino, director of Catholic Charities and Social Concerns for the Diocese of Sacramento. "This wonderful program will enrich and transform the lives of those who both give and receive."

The other local charities with items available for donation are Al-Misbaah, Homeless Assistance Resource Team (or HART) and Placer Food Bank.

The initiative has proven to be popular throughout the United States since 2017, and this year has been expanded to reach 28 cities worldwide. The three Giving Machines inside the Roseville mall will be the only ones this holiday season in California. Those unable to visit a machine in person can still participate by making an online donation at www.LightTheWorld.org/give.

"We are excited that the Church has chosen the Sacramento region for this year's Light the World

Giving Machines," said Bruce Anderson, the director of the local effort. "Our region has proven to be very charitable, and we expect there to be an outpouring of support from the public. These giving-focused vending machines offer a unique and memorable way to light the world with love by serving and caring for others both locally and globally."

Since the first Giving Machine appeared in 2017, total contributions have reached \$15 million. As part of its ongoing global humanitarian efforts, The Church of Jesus Christ of Latter-day Saints covers all operational costs, ensuring that 100% of every donation goes to the charitable cause of your choice. A team of

volunteers will be staffed at the Roseville location to assist individuals and families with their donations and to answer questions. Due to the influx in the past couple of years of refugees from Afghanistan and Ukraine, several of the items from the charities will benefit these families.

"The gifts that the public can purchase from these charitable vending machines will help refugees from Afghanistan and the Ukraine get settled here in their new hometown," said Helena Madera-Silmi, resource director at Al-Misbaah, a local Islamic nonprofit organization that assists refugees and others in need of all faiths. "They include clothing, kitchen

utensils and even bicycles for the breadwinner of the family to get to and from work. This is a fun and exciting way to really light the world with true charitable love."

Other Giving Machine charities also are assisting refugee families, as well as those experiencing hunger and homelessness.

"The holiday season is all about bringing joy to others. The Light the World Giving Machines will not only bring joy to families and individuals in our area but also healthy food," said Dave Martinez, executive director of Placer Food Bank, which provides hunger relief to El Dorado, Nevada and Placer counties. "By using these charitable

vending machines, you can really bring the 'merry' into this season, and beyond, through your gift of purchasing food and meals for people of all ages, genders, race and ethnicities - many of whom experience chronic food insecurity or for those who need food assistance during this economic challenging time."

HART has 10 groups throughout the Sacramento region that provide services to those experiencing homelessness and assist them in their efforts to become self-sufficient.

"During this season, Christians celebrate the day when a baby was born to parents who had no room in an inn. This winter, and every winter, there are many of our friends and neighbors who find themselves with no place to live, and that is why our Homeless Assistance Resource Teams exist," said Travis Kimball, who represents the Rancho Cordova HART. "We provide food, shelter and supplies to the unhoused in the greater Sacramento area, and we are so happy to be part of the inaugural Light the World Giving Machines here. We hope area residents will find the true spirit of this season by purchasing something for the needy and find joy in doing so."

\$23 Million for Homeless Shelter

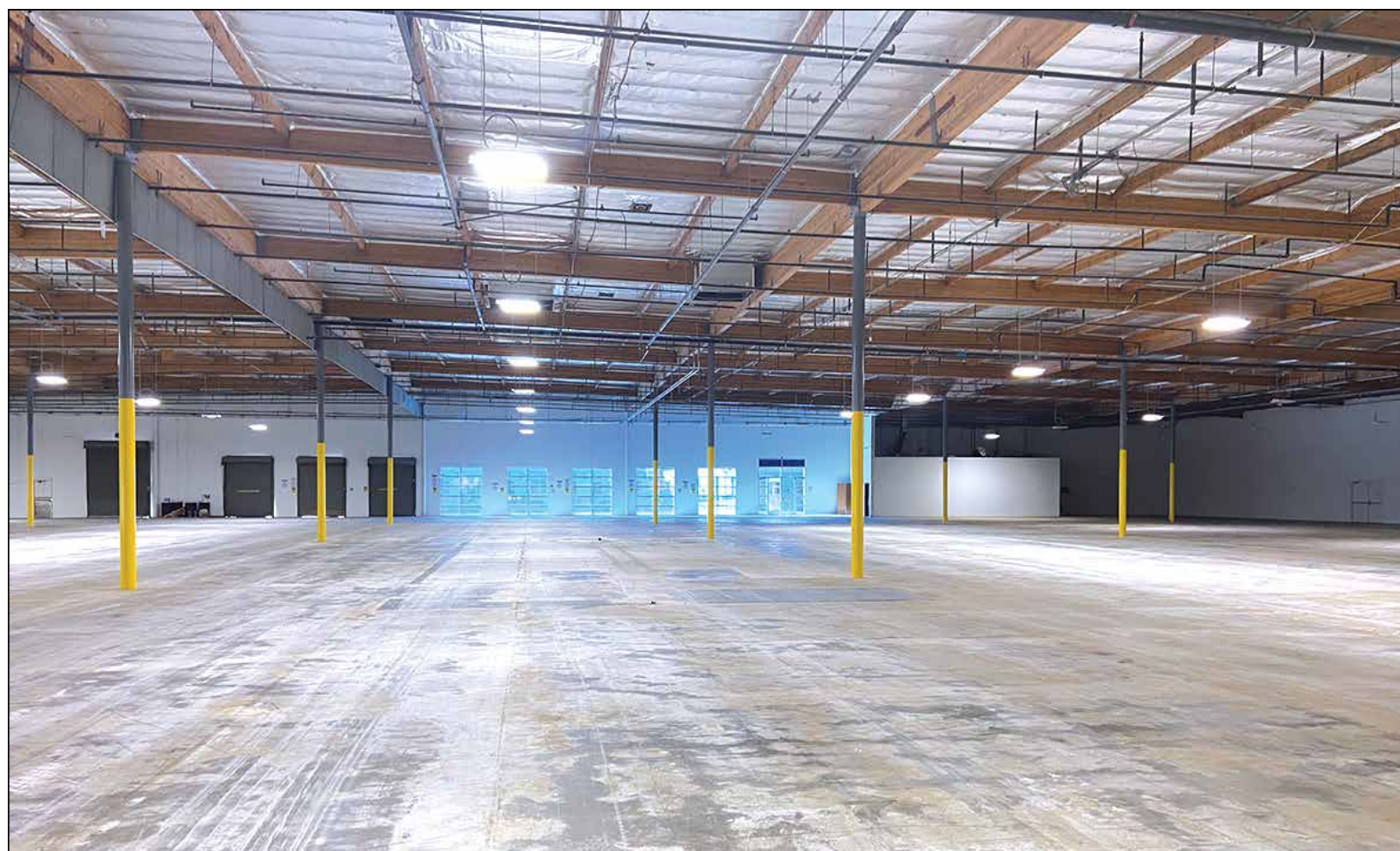

SACRAMENTO COUNTY, CA (MPG) - On Nov. 15, the Sacramento County Board of Supervisors unanimously approved the historic purchase of a \$23 million piece of real estate that will ultimately serve as the county's third and largest, to date, Safe Stay Community.

The property, located at 4837 Watt Ave, is near several large encampments – both tent encampments and vehicle parking encampments. The space is initially expected to shelter up to 140 cabins for 160 people inside the building, with additional space for 50 cars/RVs in the parking lot for those wishing to transition from homelessness while remaining in their vehicles.

After county staff and supervisors conducted a series of community meetings with both business owners and residents in proximity to the site and received valuable community feedback on the use and plan for the site, staff returned to the board with a preliminary plan for use, capacity and logistics, as well as an estimate of \$17 million for capital improvement costs.

The property consists of approximately 13.05 acres improved with a 129,491 square foot industrial building and parking lot. This site is recommended as the third Safe Stay Community site due to its size, access to infrastructure, and proximity to existing unsanctioned encampments – as well as the current owner's willingness to sell the property

to the County.

The total purchase price of \$22,825,679, which reflects the property cost of \$22,800,000, plus \$25,679 in closing costs, will be funded from the county's available ARPA allocation. Of the total \$22,825,679, \$18,825,679 will be funded from the Housing and Homelessness Strategic Investment and the remaining \$4,000,000 will be funded from the District Allocations. Supervisors Serna, Kennedy, Frost and Desmond have each allocated \$1,000,000 from their district APRA funds toward the purchase.

Safe Stay Communities are low-barrier,



full-service shelters located proximate to where unsheltered encampments exist in the community. Stay Safe Communities provide spaces where

people living unsheltered can safely stay while engaging in necessary supportive services to aid them in exiting homelessness.

Safe Stay Communities intentionally offer non-congregate sheltering, which has emerged as best practice after the Covid-19 pandemic and allow access

to diverse populations that may not be able to be successful in a congregate setting. As with all Safe Stay Communities, there will be accommodations for pets, places to store possessions and the ability to shelter with partners.

In developing Safe Stay Communities, the county is providing solutions, not only to address the health and safety of those living unsheltered, but the safety and rights of small business owners and residents to have clean and sanitary properties and neighborhoods.

Big Sky Champs! Sac State Finishes Regular Season 11-0 with Win in Causeway Classic

SACRAMENTO, CA (MPG) - Sacramento State finished the regular season with a 27-21 win over No. 24 UC Davis to cap the first undefeated regular season in school history on Saturday in front of a school record 23,073 fans at Hornet Stadium in the 68th Causeway Classic.

The second-ranked Hornets earned their third consecutive Big Sky Conference title, completing the year with an 8-0 league record while winning their 19th consecutive conference game. The team earned the Big Sky's automatic berth into the NCAA FCS Playoffs and will find out its seed during the selection show on Sunday at 9:30 a.m. PT on ESPN.

Asher O'Hara rushed for two scores and threw another during the game to lead the offense. Sacramento State never trailed in the contest but saw its lead trimmed to 24-21 with 4:41 remaining following a 75-yard touchdown pass from Miles Hastings to Josh Gale.

Following the score, Sacramento State was able to drain nearly four minutes off the clock before Kyle Sentkowski made a 44-yard field goal. Needing a touchdown with only 32 seconds remaining and no timeouts, UC Davis quickly moved down the field with three completions to C.J. Hutton to move the ball the Hornet 45. Hastings then found

Trent Tompkins who was kept in bounds at the 33 as time expired.

Sacramento State scored the game's first points by driving 75 yards on a 10-play opening drive which was capped by a 2-yard shovel pass from O'Hara to Marcus Fulcher. UC Davis immediately answered with a 37-yard field goal from Isaiah Gomez and the Hornets closed the first quarter scoring with a 23-yard field goal from Sentkowski.

After both defenses dug in to start the second quarter, O'Hara scored his first touchdown of the game with a 19-yard rush up the middle. The Hornets needed only three plays during the series to cover 50 yards and move ahead 17-3. However, UC Davis had an answer with Ulonzo Gilliam finding the end zone on a 1-yard rush with just 18 seconds left in the half.

Both defenses came up with interceptions in the third quarter but neither offense could convert the turnovers into points. The only points in the period came from Gomez who made a 37-yard field goal with 9:39 showing.

Sacramento State again turned to O'Hara for a touchdown early in the fourth quarter. The quarterback cartwheeled his way into the end zone on an 8-yard rush to make the score 24-13. The drive was kept alive by a 20-yard run on a fake punt from Cal McGough.

The final stats were

nearly identical as the Hornets finished with 426 yards of total offense and the Aggies compiling 420. Sacramento State had 190 yards on the ground and 236 through the air. Cameron Skattebo had a game-high 97 rushing yards while O'Hara added 50.

Jake Duniway completed 14-of-22 pass attempts for 169 yards while O'Hara was 7-of-8 for 67 yards. Running back Marcus Fulcher led the team with six receptions for 50 yards while Parker Clayton had a team-high 73 yards on three receptions.

Marte Mapu, Jeremy Harris and Armon Bailey tied for the team lead with seven tackles each. Mapu had a pair of tackles-for-loss among his total and added three pass breakups. ★

SACRAMENTO, CA (MPG) — After an undefeated regular season, the Sacramento State football team earned the No. 2 seed in the NCAA Football

Championship Subdivision Playoffs, it was announced today. The Hornets will receive a first-round bye and then welcome the winner of Davidson-Richmond on Saturday, Dec. 3, at Hornet Stadium at 2 p.m. Sacramento State

finished the regular season with a perfect 11-0 record with a 27-21 win over UC Davis in the Causeway Classic on Saturday. The Hornets won their third Big Sky title in as many seasons played and have now won 19 straight conference games which is the second longest in league history.

Tickets for the playoff game went on sale this past Monday, November 21. Tickets start at \$10 for east and west general admission. Reserved chairback seats in section 214 can be purchased for \$20 while admission to the end zone can be bought for \$60. Current Sacramento State students will be admitted free with details to be announced soon. ★

California Faces \$25 Billion Budget Shortfall

estimate of a \$25 billion budget problem understates the actual budget problem in inflation-adjusted terms.”

In one bit of good news, the state has amassed a significant rainy day fund reserve in recent year. The rainy day fund reserve, which became law in 2014 thanks to the efforts of then-Assembly Republican Leader Connie Conway, has required the state to save money in good times to blunt the impact of a massive budget shortfall like the state is facing this year. But the amount saved in the reserve – about \$22 billion – is roughly the same as the state’s current shortfall.

Now that incoming lawmakers and the Governor have received the bad news, it’s up to them to figure out how to respond. You can expect Newsom will propose a January budget that sounds fiscally conservative – suspending new programs, making cuts where they won’t conflict with liberal priorities, and focusing on addressing the state’s unfunded obligations, and cautioning lawmakers to focus on one-time spending.

What is unclear is how the Legislature

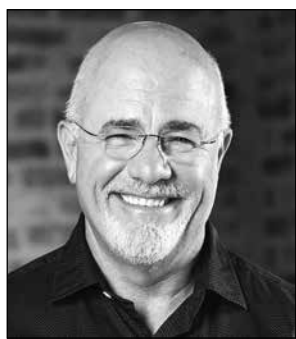
will respond. Keep in mind that one-third of the Legislature is newly elected, and the new Democratic members are generally more liberal than the members they are replacing by any objective measure.

How will they respond if Newsom wants to suspend or repeal some of the new ongoing spending they have enacted in recent years? The LAO notes that recently enacted ongoing spending will grow to \$12 billion in new annual spending by the 2025-26 budget year and is a prime target for being suspended or cut.

Signaling a potential budget fight with Newsom, Senate President Pro Tem Toni Atkins, D-San Diego, said in a statement that, “we are prepared to hold onto the gains we’ve made and continue where we left off once our economy and revenues rebound.”

Consider that the opening salvo in what will surely be one of the most challenging budget debates in Sacramento in more than a decade.

Being Hounded Isn't the Issue

When it comes to these guys, reach out and get an agreement in writing detailing exactly how much you owe and the monthly payment amounts. Remember, do not give any of these folks direct access to your bank accounts.

There’s no upside to not paying what you owe. It’s an integrity issue, it’s a legal issue, and it’s a credit

issue. Did I mention it’s an integrity issue, Mike?

You want this stuff out of your life. If you don’t take care of it, I guarantee it’ll come back to haunt you somewhere down the road!

DWR Symposium Highlights the Need to Prepare for Flooding

DWR News Release

SACRAMENTO, CA (MPG) - With California in extreme drought and facing ongoing extreme climate events, the Department of Water Resources (DWR) gathered scientists, water policy experts, and members of communities impacted by drought and floods for a conversation about building climate resiliency, including in the state's water and flood management systems.

More than 500 people from around the world attended the symposium, which was conducted virtually and in person. As highlighted in Governor Newsom's "Water Supply Strategy for a Hotter, Drier Future," California is experiencing large swings between drought and flood, and due to climate change those swings could become more severe, which will require new strategies and partnerships represented by panelists and speaker.

"Being prepared has always been a core goal of DWR, and

our need to meet that goal has never been more important," said DWR Director Karla Nemeth. "We must take action to reduce both the risk and the consequences of flooding by using nature-based solutions, sophisticated weather forecasting and reservoir operations, and other innovative strategies."

After a keynote address and presentation from F. Martin Ralph, Ph.D., Director, Center for Western Weather and Water Extremes, and Daniel Swain, Ph.D., Climate Scientist, Institute of the Environment and Sustainability, University of California, Los Angeles, DWR led three panel discussions on the challenges of extreme climate events and how California is responding.

Bianca Sievers, DWR Deputy Director for Special Initiatives, moderated a panel on the impacts that climate extremes are having on California communities and was joined by:

Rey Leon, Mayor of the

City of Huron; Justine Massey, Policy Manager and Attorney, Community Water Center; Ivan Senock, Tribal Historic Preservation Officer and Cultural Resources Director, Buena Vista Rancheria of Me-Wuk Indians; Mark Strudley, Ph.D., Executive Director, Pajaro Regional Flood Management Agency.

Communities impacted by severe drought and flooding are key partners to make sure assistance for climate resilience reaches Californians who need it the most. DWR has recently awarded \$50.4 million in flood risk protection funding for communities who are at high risk of severe flooding. DWR's Small Community Drought Relief Program has also awarded \$190 million for small communities facing water supply challenges because of the current drought.

State Climatologist Dr. Mike Anderson also discussed current efforts to use the latest scientific tools and research to adapt water management tools to our hotter

and drier climate using Forecast Informed Reservoir Operations (FIRO), and was joined by:

Michael Dettinger, Ph.D., Center for Western Weather and Water Extremes, Scripps Institution of Oceanography; Joe Forbis, Chief, Water Management, Sacramento District, U.S. Army Corps of Engineers; John James, Director of Natural Resource Planning, Yuba Water Agency; Adam Hutchinson, Recharge Planning Manager, Orange County Water District.

As climate extremes continue to impact the state, DWR has prioritized projects and partnerships between public and private sector organizations that can simultaneously address water supply, habitat and ecosystem restoration and flood protection. DWR Deputy Director of Integrated Watershed Management Kris Tjernell discussed these efforts with:

Jane Dolan, President, Central Valley Flood Protection Board;

Chris Elias, Executive Director, San Joaquin Area Flood Control Agency; Alicia Kirchner, Chief of the Sacramento District Planning Division, U.S. Army Corps of Engineers; John Cain, Senior Director of Conservation, River Partners; Gary Lippner, DWR Deputy Director of Flood Management and Dam Safety.

The Central Valley Flood Protection Board will soon adopt the 2022 Update to the Central Valley Flood Protection Plan (CVFPP), California's strategic blueprint to improve flood risk management in the Central Valley. This year's update to the plan, which is updated every 5 years, has utilized recent climate research discussed in today's event for its flood risk projections. California Flood Preparedness Week is October 22 through October 29, and it is crucial for all Californians to prepare for flooding, even during drought conditions, as extreme climate conditions mean flooding can happen at any time. ★

Another Step Toward Agreement on California's Water

For at least a decade, off and on, state water managers and local water agencies have pursued the holy grail of a master agreement to improve the environmental health of the Sacramento-San Joaquin Delta by increasing its water flows.

At any given moment, California's water supply is a zero sum game. Therefore, increasing flows through the Delta to improve habitat for salmon and other species would require local water agencies, particularly those serving farmers, to take less from the Sacramento and San Joaquin rivers and their tributaries.

That's not only a hard sell, but also could interfere with water rights, some of which stretch back to the 19th century. State officials have hoped that so-called "voluntary agreements" would forestall direct action that could touch off a legal donnybrook over those rights.

However, many environmental groups have pushed for direct and mandatory restrictions on water diversions, saying they don't trust agreements that lack the force of law and believe that water rights need to be reconfigured to match 21st century conditions, including the likelihood of semi-perpetual drought.

The pressure for

agreements ramped up in 2018 when the state Water Resources Control Board published its draft of new regulations to protect the Delta, indicating that roughly 40% of natural river flows should make it to the Delta, and most into San Francisco Bay and the Pacific Ocean.

Reaching that figure would require steep reductions in water diversions from rivers for farms and municipal users.

A few months later, newly inaugurated Gov. Gavin Newsom stressed the urgency of the situation in his first State of the State address, saying, "Our first task is to cross the finish line on real agreements to save the Sacramento-San Joaquin Bay Delta. We must get this done — for the resilience of our mighty rivers, the stability of our agriculture sector, and the millions who depend on this water every day."

Later that year, he vetoed a bill that would have adopted, wholesale, all of the environmental laws that existed in the federal government prior to Donald Trump's election as president because the Trump administration had loosened up on water diversions. Had the bill become law, Newsom was warned, it would have short-circuited the drive for voluntary water agreements.

In 2020, Newsom's Resources Agency released a framework for such agreements and earlier this year announced initial agreements with some major water interests that would forestall a legal clash.

However, there were holdouts, particularly agencies that draw water from the Tuolumne River, including

the City and County of San Francisco, which owns Hetch Hetchy Dam on the Tuolumne and transports its water to the city via pipelines. Tuolumne water diverters filed a lawsuit challenging the water board's right to impose diversion restriction and their offers for voluntary cutbacks were rejected as insufficient.

Last week, there was a breakthrough. San Francisco and two agricultural water agencies, the Modesto and Turlock irrigation districts, forged an agreement with the state to increase Tuolumne flows and enhance habitat.

"This collaborative approach holds the promise to do that (work) more quickly and holistically, while improving water reliability to communities, farms and businesses," the state resources secretary, Wade Crowfoot, said in a statement.

Does that mean that the Delta water war is over? Not necessarily.

Environmentalists still don't like the voluntary agreement approach and there still is another unresolved Delta issue: A Newsom-backed tunnel beneath the Delta to carry Sacramento River water to the head of the California Aqueduct near Tracy. Tunnel opponents believe the flow-enhancing agreements are being sought merely to make the project, which would divert water from the Delta, more environmentally acceptable.

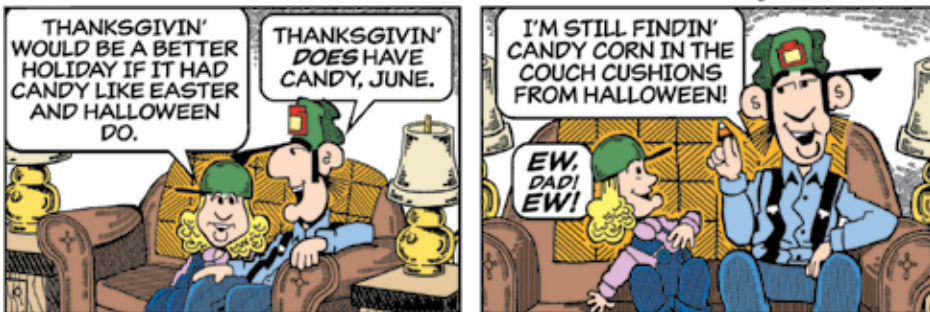

Jesuit 5-star Recruit Andrej Stojaković Commits to Stanford

SAN JOSE, CA (MPG) - Jesuit five-star recruit Andrej Stojaković recently verbally committed on November 7 to play basketball collegiately at Stanford University, beginning next year.

Stojaković, a 6-foot-7 small forward, is the eldest child of former NBA All-Star Peja Stojaković. Peja played in the NBA for 16 seasons and was selected to the All-Star team in three

consecutive years from 2002-04. He was drafted by the Sacramento Kings where he played from 1998-2006.

"I am excited to announce that next year I will be attending Stanford University," Stojaković said Monday afternoon live from the Zoom headquarters in San Jose. "I chose Stanford because for me it was the best basketball decision but also the best academic and long-term decision."

"I believe that Stanford is the place

that will allow me to achieve my dreams on and off the court."

Stojaković chose Stanford over other powerhouse programs like Kentucky, UCLA, Texas, Indiana, Florida, Louisville, Tennessee, Oregon, UConn and Georgia Tech. His final four schools came down to Stanford, UCLA, Oregon and Texas.

According to 247Sports, Stojaković is the 21st overall ranked prospect in the Class of 2023. With the beginning of the name, image and likeness (NIL) policy in the NCAA, Stojaković recently signed with U'u Sports Management.

As a junior at Jesuit in Carmichael, Stojaković averaged 25.3 points, 9.3 rebounds and 1.4 steals per game in 26 contests. In the high school offseason, Stojaković played for the Compton Magic, which has had over 40 players go on to play professionally in the NBA and its affiliates since 1993.

Stojaković is Stanford's second five-star commitment from the Class of 2023, joining combo guard Kanaan Carlyle, who is the fourth highest ranked recruit in program history. He will also be rejoining a familiar face, as his former Jesuit teammate, Isa Silva, committed to Stanford in 2020 and is currently a sophomore for the Cardinal. ★

Feeding a Country During War

SACRAMENTO REGION, CA (MPG) -

We all see on TV news about the war in the Ukraine. Most of us feel compassion towards what the citizens in that country are going through, but we really have very little idea of what it's really like. One local man, who is a baker by trade (specializing in making bread) decided that he wanted to do something to help them. For safety purposes, we will use only his first name – Shawn.

“Sometimes charity takes more than writing a check or waving a flag,” said Shawn. He joined a group out of Washington DC called World Central Kitchen. This organization is strictly a humanitarian organization with no political influence or agenda. They simply go where they are needed to help get food to those who need it. In fact, neither the organization nor the government supplied any support, of any kind, in the mission.

Shawn explained that even though the Ukraine usually has a good wheat production, other countries are sending them wheat now, but they didn't really know what to do with it. Businesses like bakeries are shut down or bombed. Those that aren't cannot follow their regular baking schedule because they are under martial law. No one is allowed outside from 10pm to 6am, except for military. Shawn knew he could help.

Shawn and three others went to the war-ravaged Ukraine this summer to do what they could to feed the Ukrainian people. Told ahead of time to bring a flak jacket and a Kevlar helmet, Shawn wasn't sure what he was getting into. He just knew that they needed help and this was something he could do. He didn't bring a jacket and helmet

because he thought it would raise questions in both our airports and theirs. Once he was there, he wished he would have.

“You can't go into a war zone armed unless you are part of the local militant system,” Shawn said, “I just went in looking like a normal American tourist.” Shawn and his friends arrived in the Ukraine with only their carry-on luggage. They were questioned why they were there. Any electronic devices were gone through thoroughly, including all text messages, photos, etc. Burner phones were purchased for the minimal communication that would be used. Russian spies and Pro-Russian Ukrainians had devices that lifted cell phone numbers when they crossed into the country. Those numbers were closely monitored while they were there. Photos were not permitted.

They traveled in different

modes while there, but no matter how they were traveling, they were regularly stopped (about every kilometer) and questioned by Ukrainian Security about why they were there and what they were doing. They especially focused on Americans. Men would board trains, buses, etc. armed with machine guns and AK47's to question passengers on their purpose of travel. Every time they focused a lot of attention on Shawn, often being the only American.

Ukrainian soldiers don't have many supplies on the frontline, so it was standard practice for people to take an SUV or some other vehicle and fill it with gasoline, food, socks and other supplies. They would then take these vehicles to the frontline and just leave them there. One of these vehicles was one of the modes of transportation that Shawn's group used to get to the next area.

Shawn and his group would arrive in a city and pull together whatever they could to set up. They would gather supplies from grocery stores that had been bombed, or restaurants that had been destroyed and occasionally they might get some food from suppliers. They would use whatever they could, often an oil drum to cook on. In one city they even used a burnt out tank to turn into a stove. They would gather big pots and set them on their make shift stoves to make soup or stew. Sometimes they made sandwiches. Occasionally they had bags of groceries to hand out.

When the air raid sirens go off, they go off across the country so you never know where the missiles were headed. Many people began to ignore them. Others would run for cover, taking safety in the underground bunkers that are

under most public buildings there (left over from WWII). There were missile strikes all around them, the closest being just a few blocks away. It was so close they could feel the rumble of the ground as the bomb exploded. In one town there was a missile that had hit the ground and was sticking out of the ground but had not detonated.

In the more rural areas, such as villages, people hid in their root cellars (a cellar that is designed for storage of potatoes and other produce). They would come out sheepishly at first, until they got to know them, then more people would come out. Sometimes the same people would make multiple trips to the same bunker. This was especially true in areas that were under heavy bombardment.

As people got to know the group, more people would come out to help. There was even a 15-year-old girl in a flak jacket and Kevlar helmet delivering bread. The group would come across schools being taught in bunkers because their school had been bombed. Shawn and his friends did what they could to get these kids school supplies.

“The hardest thing was the language barrier,” Shawn said, “But we brought a bunch of little hot wheels cars and John Deere tractors and handed those out. It was a great ice breaker, as many of them were farmers.” Shawn and his group spent three and a half weeks there and he spent around \$5000 out of his own pocket to fund the trip and supplies. They fed roughly 1500 people a day from their mobile kitchens, mostly women and children.

“It was an amazing experience. They were very grateful that we were there, and I would love to go back” Shawn said. ★

President Robert S. Nelsen Announces His Retirement

SACRAMENTO, CA (MPG) -

President Robert S. Nelsen, who for the past seven years has overseen Sacramento State's historic student achievement and shepherded the University through unprecedented challenges, will retire in July, he announced Wednesday, November 2.

Nelsen will be remembered for his dedication to student success, his efforts to raise the University's profile in the region, his commitment to diversity and inclusion, and a deep love for what he warmly called the Hornet Family, among other notable accomplishments.

Whether delivering a speech, shoveling dirt to break ground for a new campus building, or attending an athletic event, Nelsen has been widely admired for performing his duties with unbridled enthusiasm and a gentle sense of humor. His declaration “Sac State is No. 1! Stingers Up!” – often made with his wife, Jody, by his side – has become his signature valediction.

“Sacramento State will always be in my heart,” Nelsen said, adding some flavor from his Texas roots. “I wish I could be

president forever, but I know the time is right for me to hang 'em up.”

Nelsen, 70, became Sacramento State's eighth permanent president on July 1, 2015, succeeding Alexander Gonzalez, who retired after 12 years of leading the University. Prior to arriving in Sacramento, Nelsen spent the better part of three decades in the University of Texas system.

He was president of UT-Pan American from 2010 to 2014 and served as special advisor to UT's executive vice chancellor for academic affairs. His career also includes service as a professor of English, a vice provost, and a director of creative writing.

Nelsen earned his bachelor's and master's degrees in political science from Brigham Young University, and his doctorate from the University of Chicago's Committee on Social Thought.

Arriving at Sac State, he said a primary goal was to improve graduation and retention rates, and success followed. Under his leadership, the University has seen a 187% increase in the number of students who graduate within four years. Sac State's performance in the CSU's Graduation 2025 initiative is among the best in the system.

With Nelsen's oversight, the University surpassed its On The Rise fundraising goals, raising \$239 million in its first comprehensive campaign. He celebrated completion of major campus projects, including the funding, construction and 2019 opening

of the Ernest E. Tschannen Science Complex, and the Planetarium next to it. Nelsen also was instrumental in the creation of Sac State's Antiracism and Inclusive Campus Plan, which is guiding the University toward its goal of creating a campus culture that is fair and welcoming to all.

The gains have occurred even as Sac State was forced to adjust to the devastating impacts of a global pandemic, which in March 2020 sent students, faculty, and staff members home to study, teach, and work. The campus quickly pivoted to online learning, and notably, the University's enrollment and graduation rates held steady. About 31,000 students returned to campus in the fall, and the University maintains a COVID-19 positivity rate of less than 1%.

CSU Interim Chancellor Jolene Koester called Nelsen “a brilliant, compassionate and student-focused leader who has successfully guided Sacramento State through a period of remarkable growth and transformation.”

“Sac State's student body is larger and more dynamically diverse than ever before,” Koester said. “Most important, the University has made extraordinary progress in helping that talented and diverse group of students reach their academic goals.”

“These accomplishments would have been impossible without the faculty, staff, students, and community members who have poured their hearts into this work,” he said. ★

Newsom Provoked, Relents

Newsom released \$1 billion despite lackluster local homeless plans

Two weeks after withholding \$1 billion in homelessness funding over lackluster local plans, Gov. Gavin Newsom announced Friday that most cities and counties would get the funds as early as next week anyway — as long as in the next round, they commit to more aggressive plans to reduce street homelessness.

But it's been a whiplash-inducing couple of weeks, triggered by a funding process that frustrated both the governor and the locals. Newsom dissed local applicants for seeming too complacent about a dire California problem, while the applicants retorted that the Newsom administration sent conflicting signals — and that in any case, state lawmakers had inadvertently given them a financial motive to lowball their goals.

More than 100 local mayors and county officials gathered virtually and in-person in a sleek downtown Sacramento government building Friday afternoon to broadly discuss how to better tackle the state's most pernicious crisis.

"It was nice to hear their progress, and it was nice to hear their recognition that we have to get to another level," Newsom told reporters following the over two-hour-long private meeting.

It was a quick reversal some local leaders and advocates saw as a political stunt: The episode gave everyone a chance to air their grievances, but landed on no specific targets, while briefly risking the continuity of services for people experiencing homelessness.

"If you asked me what emerged from the meeting, I don't know. I did not hear any specific policy changes," said Sam Liccardo, mayor of San Jose. But, he added, "Nobody's going to criticize the state or the governor at a time when it's critical to get resources to bring people out of the cold. Lives depend on this."

Other local leaders said they welcomed the prodding.

"Sometimes, you have to provoke," said Darrel Steinberg, mayor of Sacramento. "And then gather around a table like we did today, and actually talk about what it's going to take to provide a further jolt to this problem."

The governor sent shockwaves through the state two weeks ago, just days before Election Day, when he summarily rejected every local homeless action

plan. On the line: nearly \$1 billion in homelessness funding. The plans, altogether, promised to reduce visible street homelessness by 2% between 2020 and 2024, or 2,000 fewer people statewide — which Newsom had called "simply unacceptable."

His move triggered chaos among many of the 13 largest cities, 58 counties and 44 homeless service providers who went through the process. Many of them thought they had been approved after workshoping the plans with Newsom's own homelessness agency, only to learn of their rejection en masse.

But local governments didn't have much of an incentive to shoot for the stars in their plans, either, because of the way the governor and Legislature wrote the grant. In the name of accountability, they tied nearly a fifth of the \$1 billion to local governments meeting their own unsheltered targets. With more people falling into homelessness than they can catch, many felt ambition might set them up for failure.

That criticism came up during the meeting, Newsom told reporters, holding up yellow pages ripped from a notepad.

"We worked with 120 members of the Legislature to put this forward," he chuckled. "And now we're working with 75 jurisdictions on these plans... In fact, literally right here, the recommendations: 'What specifically do you want to change in terms of these metrics and plans?' And that's exactly what this conversation was about going forward."

As soon as applicants sign a pledge to submit more ambitious unsheltered targets and try harder

in their plans for the next \$1 billion grant — the final round of flexible local homelessness funding approved in the 2021 budget — the state will start cutting checks for this round, according to Jason Elliott, Newsom's deputy chief of staff. Those new plans are due Nov. 29. A handful of local governments will have to work with the state to adjust their current plans before seeing the funding, although Elliott declined to name which ones.

During the pandemic, homelessness only spiked, and experts expect to continue to see its fallout on the streets in the coming years as rental assistance and eviction bans end. Between 2019 and 2022, homelessness increased by at least 22,500, to 173,800 people statewide, according to a CalMatters analysis of local point-in-time counts. Nearly 70% of those people were sleeping outdoors or in vehicles, while the rest stayed in shelters and transitional housing. (These biennial visual headcounts on a given night often are criticized for their inaccuracies.)

Yet the state asked cities and counties to calculate their 2024 goals based on their lower pre-pandemic counts of homeless people. At the time the application was due this summer, most localities simply figured they couldn't promise to make homelessness that much better when it had already grown so much worse, and was on track to keep worsening. And being too ambitious risked failure to meet their targets and losing any shot at the bonus money.

Newsom saw what they did and cried foul. He called out the Sacramento region in particular

— though not by name — for its lack of ambition: Instead of promising a reduction, the local governments and service providers foresaw a 71% hike in homelessness in their report. Why? That's exactly how much homelessness had already risen in the capital city this year, and the latest data that would be available by the time communities were evaluated on their progress to qualify for \$180 million in bonus funding statewide.

Comparing the relatively current 2022 numbers with the 2024 goals, communities had really signed up for a 4% or 5,000 person reduction, according to a CalMatters analysis — which if achieved would be better than the state has done in years. Since 2015, homelessness has only increased in California, by an average of 7% a year, or about 8,300 people.

After the turmoil of the past couple of weeks, Steinberg said Sacramento has now put forth a new goal, promising a reduction of 15%, or 1,000 fewer unsheltered people, by 2024. How progress might be measured differently remains unclear.

The U.S. Department of Housing and Urban Development — which mandates the homeless count — has often advised against tying it to funding because shooting for a certain number could influence its accuracy. Still, the point-in-time count remains the only uniform way to measure the number of people sleeping on the streets.

"It's imperfect at the moment and over the years... I hope we can evolve and consider different strategies," Newsom said,

suggesting the count can miss homeless people who are less visible. "Now what I see is what I see on the streets. And that's a challenge."

The federal department instead advises measuring success using the count in conjunction with other outcomes, like higher placements into permanent housing or fewer returns to homelessness.

"If I see positive trends in those other areas, and either stagnation or maybe just a slight downturn in the (count) that's actually probably a positive thing," a HUD spokesperson who would only speak anonymously told CalMatters.

California, like many other states, has seen a massive jump in homelessness since 2015, "way beyond the great work that many communities are doing to house people," the spokesperson added. The driver: a housing shortage propelling skyrocketing rents.

Newsom himself promised to abate that shortage when he first ran for governor, vowing to oversee the building of 3.5 million homes. He's fallen dramatically short of his goals.

Local service providers felt unfairly stung by Newsom's criticism because they have no control over housing unaffordability and the other system failures that cause homelessness. And while they are getting more state funds than ever before, their resources don't match demand. Funding the current affordable housing need alone would require nearly \$18 billion a year, according to an analysis from Housing California and California Housing Partnership, two affordable housing policy advocacy groups.

When Newsom withheld the funds earlier this month, service providers were aghast.

"We were all feeling pretty blindsided and you know, sort of reeling," she said.

The state had approved none of the applications before requesting additional information, according to Lourdes Castro Ramirez, secretary of the Business, Consumer Services and Housing Agency, which directly oversees the council. She told CalMatters "there was no conflicting communication" from her agency and the governor's office. ★
