## Sacramento Locals Prepare For Baseball's Biggest Stage

SACRAMENTO REGION, CA (MPG) - Despite the San Francisco Giants and Oakland Athletics missing the playoffs this season, Sacramentans still have a lot to look forward to with the 2022 World Series beginning this Friday, October 28.

Three Sacramento-area locals will be participating in this year's Fall Classic, with two on the field and one in the dugout. Philadelphia Phillies first baseman Rhys Hoskins stands on one side representing the 916. On the other side stands utility player Mauricio Dubón and manager Dusty Baker for the Houston Astros.

Hoskins has played for the Phillies his entire career since being drafted in the fifth round of the 2014 Major League Baseball (MLB) Draft out of Sacramento State. Before becoming a Hornet, Hoskins played locally at Jesuit High School in Carmichael. This is Hoskins' first playoffs and World Series appearances as Philadelphia snapped an 11-year postseason drought this year.

Baker is back for more after reaching the World Series with Houston last year. After playing 19 years in the big leagues, Baker is in his 25th year as an MLB manager. He led the Giants to the World Series in 2002 and now the Astros to back-to-back appearances in 2021 and 2022.

Baker holds the record for most wins among managers who have yet to win a World Series. He went to Del Campo High School in Fair Oaks and still has a Sacramento residence to this day. His son, Darren, played at Jesuit until 2017 and was drafted by the Washington Nationals in the 10th round of the 2021 MLB Draft.

Dubón has had two stints in Sacramento, both as an amateur and as a professional. After growing up in Honduras, Dubón moved to Sacramento as a 15-year-old to play baseball at Capital Christian High School in

## Mural Makes Door to Adore

CARMICHAEL, CA (MPG) - When is a door not a door?

When it's a flora and fauna-festooned frieze, brightening a Carmichael neighborhood.

Janet Jimenez went on a Midtown Sacramento mural walk in June. Captivated by walls transformed, the former Aerojet employee told daughter Kim Hanagan: "I know what you can get me for my 82nd birthday - a mural."

Replied Kim: "That would be a lifetime of birthday presents, mom." In the end, she and mom agreed to share the expense of beautifying their street-facing garage.

Many weeks and a birthday later, artist Jesse Melanson (35) arrived from Truckee. The professional muralist had previously daubed city walls from Boston to Austin and San Francisco. Kim and Janet first saw his nature-inspired work

on a Fair Oaks Pizza restaurant wall and asked the artist to design for their project.

Octogenarian Janet has fond memories of Hawaiian vacations. She also loves birds and flowers. She and State worker Kim settled on hummingbirds and tropical blooms. Their double garage was a small project compared to some of Melanson's

massive commissions. But its ridged surface was a two-day challenge. "I'm used to bricks, concrete and some really gnarly walls," he noted. "But I'll paint on anything. I feel privileged when people ask me to share my art."

Mom left town during the mural's creation and returned to a fait accompli. "I got home at midnight, so I didn't see it

till the morning," she says. "Our garage door turned out even more beautiful than I'd imagined - it's still fun to come home to. Our neighbors have made nice comments.

"The man across the street has a better view than we have. He says he feels like he's in Hawaii."

# All Aboard: Caltrans Has New Passenger Trains

#### SACRAMENTO, CA (MPG) -

Rail passengers in Northern California and the Central Valley will start enjoying a more comfortable and modern ride after Caltrans accepted into its fleet the first of seven Siemens Mobility single-level intercity trainsets at the San Joaquin Regional Rail Commission facility in Stockton.

“With train ridership recovering from the pandemic drop, these new trainsets will provide Californians with enhanced comfort and convenience as they move around the state,” said Caltrans Director Tony Tavares.

The new trainsets will operate on the San Joaquin

rail corridor between Sacramento/Oakland and Bakersfield, connecting riders to jobs, education and leisure along the way. Passengers can expect spacious and modern interiors with amenities that include enhanced onboard Wi-Fi with power and USB ports at all seats as well as enlarged windows. The passenger cars also feature wider aisles and more comfortable seats, additional leg room, larger tray tables and expanded luggage storage options, with oversized baggage and bike racks. The trains are ADA accessible, including weatherproof gangways between cars, wider aisles, retractable steps, and state-of-the-art touchless and much larger restrooms. Each coach car

seats up to 70 passengers.

“These trainsets were designed with Californians in mind, both in terms of job creation here in Sacramento and next-generation passenger rail throughout the state,” said Michael Cahill, president of Siemens Mobility Rolling Stock in North America. “Together with Caltrans, we’ve created a trainset that is both safe and modern to keep passengers connected and on the move.”

With Caltrans officially taking ownership, the department anticipates the trainsets soon will enter service. These additional trains will help restore service to pre-pandemic levels, resulting in schedule improvements throughout the state’s rail service.

The Venture Trainsets for Caltrans were ordered from Sumitomo Corporation of Americas and are being designed and manufactured by Siemens. They are Buy America-compliant and built at the Siemens Mobility rail manufacturing facility in Sacramento. Powered by the California sun with two megawatts of solar energy and 2,400 employees, the facility has been in operation for more than 30 years. ★

# Who Let the Dogs Out? We Did.

**SACRAMENTO COUNTY, CA (MPG)** - It was all fun and games for the dogs at Sacramento County's Bradshaw Animal Shelter last month.

The shelter was chosen to participate in three intensive, all-day training workshops with Dogs Playing for Life (DPFL), a 501c3 nonprofit organization rooted in a dog's natural instinct to play. The sessions, which taught staff how to conduct successful large-scale playgroups to increase dogs' adoption prospects as well as provide efficient and effective socialization and exercise, took place from Sept. 28 - 30, 2022. Over three days and a series of playgroups, more than 100 dogs ran, wrestled and rolled around together.

The play model is part of an innovative approach to animal sheltering: one that aims to make a stay at the shelter more like a fun trip to summer camp and less like time behind bars. DPFL furthered staff's expertise of dog behavior by teaching them how to assess nuances of play styles and body language in order to create dog playgroups that bring out the best in animals while minimizing the risk of injury or spread of infection.

"A big misconception is that it's too risky to let dogs play or that shelter dogs have to be carefully taught how to socialize," said Lauren Revier, Program and Research Administrator for DPFL. "It's natural for dogs to interact and play, and when playgroups are approached thoughtfully, most dogs can participate and enjoy them."

Dogs that have the most difficult time getting adopted stay in shelters the longest

and are most at risk of developing behavioral issues due to prolonged shelter stress are generally those that aren't social with other dogs. Most adopters and rescue groups seek out dogs that play well with others since the majority of homes interested in fostering or adoption already have at least one dog at home. These playgroups can help the less social dogs develop the dog-to-dog skills they need to adopt and succeed in their new homes.

"When you focus on meeting a dog's needs—their needs for mental enrichment, physical exercise and socialization—you see that many behavioral issues tend to disappear or are greatly reduced," said Annette Bedsworth, Director of Bradshaw Animal Shelter. "Oftentimes, we can meet those needs through one simple thing: play. We're not only going to see major quality of life increases for our dogs by implementing more playgroups, but by making our shelter a place that prioritizes the opportunity for dogs to safely have fun and just be dogs, we're going to be able to save even more lives."

Shelter staff plan to carry out what they learned from DPFL in ongoing future playgroups. In large municipal shelters like Bradshaw Animal Shelter, where the numbers often tip past 300 pets on site, it is a daily endeavor for shelter staff and volunteers to ensure every animal gets quality time outside of their kennels each day. Not only will the playgroups give dogs more time to run free, but they will enable staff and volunteers to spend individualized time with dogs that need it most, such as the ones that are extremely scared and shut down in the shelter environment. ★

# UC Davis Health Nurse Honored for 'Rocking' Nursing World

**SACRAMENTO, CA (MPG)** - The National Black Nurses Association (NBNA) has named Aron King a 2022 Under 40 Awardee. King, an assistant nurse manager at UC Davis Medical Center and a 2021 graduate from the Betty Irene Moore School of Nursing at UC Davis, is one of only 16 nurses in the nation to receive the honor.

"These nurses are our present and our future. They are the next generation of nurse leaders," said Martha A. Dawson, NBNA president. "We look forward to honoring these NBNA young notables under the age of 40 who are rocking the nursing world through professional and educational achievement, leadership and civic involvement in their NBNA chapters and in the communities they serve."

After caring for patients as a bedside nurse for 8 years, King entered the master's-degree leadership program at the School of Nursing in 2019. He said through that educational experience he began to see the bigger picture of how he could serve the Black community and inspire future Black nurses. He joined the Capitol City Black Nurses Association, founded by School of Nursing alumni, to advocate for the needs of nurses and optimize health outcomes in communities where health disparities persist.

"Health care is in a battle to undo decades of valid mistrust in communities of color. From unjust medical trials to the treatment of undocumented people and those battling drug addiction," said King, the organization's former secretary who now serves as an executive board member. "Winning the trust of these communities means having a workforce that has representation. We have work to do."

In July, King served as the keynote speaker for the School of Nursing 2022 Commencement. In July, he joined Piri Ackerman-Barger, School of Nursing associate dean for Health Equity, Diversity and Inclusion, to present to an international audience of nursing researchers understanding how microaggressions in health professions schools can poise students for inclusion. She

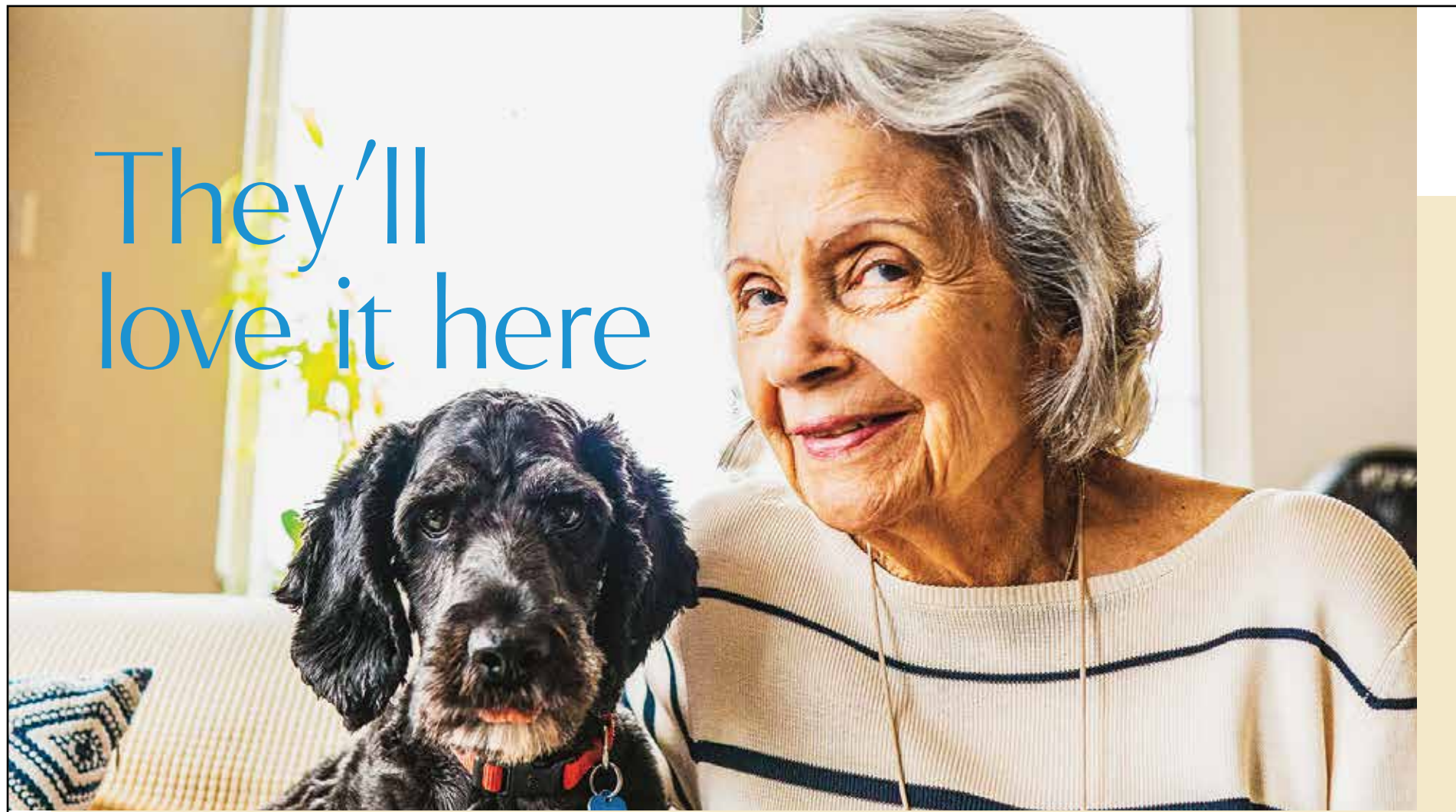
said King is deeply deserving of this honor.

"Aron is being recognized for his commitment to high quality practice, his accomplishments as a leader and his work as a scholar," Ackerman-Barger explained. "It is an honor to have him join us once again as he pursues his Doctor of Philosophy (PhD) at the School of Nursing."

Next month, King enters the school's PhD program. He expects with the rigorous research program and the demands of his nursing career, the lift to continue the drive to end disparities will be heavier.

"The role of a nurse is not limited to the bedside and we as nurses shouldn't measure our worth by looking at technical skills," he said. "We are advocates and leaders in patient care. We need to be proactive in our approach by investing our energy in preventive interventions."

NBNA honored this year's winners at its 50th Annual Institute and Conference in Chicago. NBNA is comprised of nurses at all levels and serves as the voice for Black nurses and diverse populations to ensure equal access to professional development, promote educational opportunities and improve health. ★

## Spooky, Creepy and Tasty Too

Halloween straddles fall and winter...life and death. It's thought to have originated with the ancient Celtic festival of Samhain. People would light bonfires and wear costumes to ward off roaming ghosts. The Celts, who lived some 2,000 years ago in the area that is now Ireland, the United Kingdom, and Northern France celebrated the New Year on November 1. This day marked the end of summer and the harvest, and the beginning of the dark and cold winter, a time of year that was often associated with human death. Celts believed that on the night before the New Year, the boundary between the worlds of the living and the dead became blurred. That's why on October 31, they celebrated Samhain. They thought these roaming ghosts would cause trouble and damage crops. Since this was a culture entirely dependent upon the volatile natural world, prophecies were an important source of comfort and direction during the long, dark winter.



Then Halloween came to America, but extremely limited in colonial England because of the rigid Protestants. It was much more common in Maryland and the southern colonies. Today's tradition probably dates back to the early All Soul's Day parades in England. During the festivities, poor citizens would beg for food and families would give them pastries called "soul cakes" in return for their promise to pray for the family's dead relatives. The soul cake was encouraged by the church as a way to replace the ancient practice of leaving wine and food for roaming spirits. Merging different ethnic groups and Native American Indians gave America its own Halloween. The first ones were party-driven and public events to celebrate the harvest. Neighbors would share stories of the dead and tell fortunes. Colonial Halloween festivals added ghost stories and America began dressing in costumes and going house

to house asking for money for food. That's when "trick or treat" was born. Young women believed they could divine the name or appearance of their future husband by doing tricks with yarn, apple parings and mirrors. By the late 1800s, there was a move to mold Halloween into a holiday more about community and neighborly get-togethers than about ghosts, pranks and witchcraft.

4. **Brush Before Bedtime.** It ensures the remnants of candy don't stay on our teeth to cause damage while you sleep.
5. **Chew Sugarless Gum.** Chewing gum causes increased saliva flow which helps wash out food and naturally cleans teeth. But enjoy the fun and tasty treats. ★

## CHP Receives Grant to Increase Safety for Motorcyclists

**SACRAMENTO, CA (MPG)** - The California Highway Patrol (CHP) will implement a yearlong federal grant to help save lives and reduce the risk associated with riding a motorcycle.

The goal of the Get Educated and Ride Safe (GEARS) V grant is to decrease the number of motorcycle-involved crashes and victims through education and enforcement efforts across California through September 30, 2023.

From October 1, 2020, to September 30, 2021, there were 7,078 motorcycle-involved crashes resulting in 354 deaths and 6,400 injuries within CHP jurisdiction, an increase of 3 percent over the previous 12 months.

"Motorcycle riders are statistically more likely to be injured or killed when involved in a crash," said CHP Commissioner Amanda Ray. "In an effort to ensure every motorist reaches their destination safely, the CHP will continue to use enforcement and

non-enforcement strategies, including education and community engagement, to target the leading causes of traffic deaths."

During the grant period, the CHP will participate in traffic safety education efforts, such as

"May is Motorcycle Safety Awareness Month." These campaigns will promote the use of U.S. Department of Transportation-compliant helmets for all riders and raise driver awareness of sharing the road with motorcyclists. The CHP will also increase enforcement in areas with a high number of motorcycle-involved crashes, which resulted from speed, improper turns, and driving under the influence of alcohol and/or drugs.

Funding for this program was provided by a grant from the California Office of Traffic Safety, through the National Highway Traffic Safety Administration.

The mission of the CHP is to provide the highest level of Safety, Service, and Security. ★

## Social Security Matters

### About Applying for Social Security Benefits

**Dear Rusty:** I will be turning 65 this December and will most likely continue working until July of 2024 at my current job. It is possible I could leave a year earlier. With that being said, when should I submit paperwork to start collecting Social Security benefits? Is there anything I should know previous to applying that will make sure the process is relatively seamless?

**Signed: Ready to Retire**

**Dear Ready to Retire:** Social Security recommends you apply for benefits 2 to 3 months before you wish your benefit payments to begin, but you can apply up to 4 months prior. When you apply, you will specify your desired benefit-start-month on the application, and that is when your benefits will start. Be aware that Social Security pays benefits "in arrears," meaning your benefit is paid in the month following the month earned. So, for example, if you apply for your benefits to start in January your January benefit will be paid in February.

The exact date of your payment depends on the day of the month you were

born – born between the 1st and 10th of the month, you get your payment on the 2nd Wednesday; born between the 11th and 20th of the month, payment is made on the 3rd Wednesday; born after the 20th of the month your payment will be received in your bank account on the 4th Wednesday of every month.

You can apply in person, either over the phone or by visiting your local Social Security office, or you can apply for your benefits online at [www.ssa.gov/retire](http://www.ssa.gov/retire). Applying online is, by far, the most efficient method. To apply online, you will first need to set up your personal "my Social Security" online account which is easy to do at [www.ssa.gov/myaccount](http://www.ssa.gov/myaccount). I suggest you create your online account now, even if you don't plan to claim your SS for a while yet. Once you have your online account set up, you can see your estimated benefit amounts at different ages, which can help you decide when to claim.

Since you are still working, you should be aware that if you claim at any time prior to reaching your full retirement age (FRA) you will be subject to Social Security's earnings test. If you will be 65 in December 2022 your FRA is 67, and that is the point at which you will get 100% of the SS benefit you've earned from a lifetime of working. If you claim any earlier, your benefit will be permanently reduced, and the Social Security "earnings test" will apply. The earnings limit for

2023 will be a bit more than the 2022 limit of \$19,560. If you are collecting SS and exceed the earnings limit, they will take away benefits equal to \$1 for every \$2 you are over the limit. In the year you reach your FRA (2024) your earnings limit will be about 2 ½ times more than the normal annual limit and the penalty is less, and once you have reached your FRA there is no longer a limit to how much you can earn. For clarity, you can also wait and claim after your FRA and gain a higher benefit (your benefit will grow up to age 70).

So, how can you make the process "relatively seamless?" Create your online "my Social Security" account in advance and verify that your lifetime earnings as recorded by Social Security are accurate. Then, when you're ready to claim, simply go to [www.ssa.gov/retire](http://www.ssa.gov/retire) and follow the instructions. The online application process is quite intuitive, and you should have no trouble even if you have limited computer skills. Social Security will contact you if they need more information after you apply online. Of course, you can also apply whenever you're ready by calling Social Security to make an appointment to apply over the phone but applying online is much more efficient.

## California May Reallocate Shrinking Water Supply

While it's not yet formal policy, those who manage California's vast water system are edging toward a historic reallocation of the state's shrinking supply that could have a life-altering impact on its largest-in-the-nation agricultural industry.

For many years, farmers have used about 80% of the water diverted from rivers for human use, with the rest going to urban areas for drinking, watering lawns, maintaining swimming pools, taking showers, cooking and commercial or industrial use.

Prolonged drought has compelled all users to make do with less. However, the biggest loser has been the environment — free flows to maintain habitat for fish and other aquatic species — which generally gets about 50% of the total flow.

In recent years, federal judges have ordered cuts in agricultural water diversions to enforce the Endangered Species Act and the state Water Resources Control Board has moved in the same direction on an emergency basis due to drought. However, environmental groups want permanent habitat-enhancing reductions.

Former Gov. Jerry Brown and his successor, Gavin Newsom, have sought "voluntary agreements" by

which agricultural water agencies would curtail diversions to maintain river flows, but results have been scanty at best.

Without such agreements, the water board could implement mandatory reductions, but they would be viewed by farmers as an assault on their historic water rights and probably trigger massive legal battles. The key principle in these conflicts is that water belongs to the public as a whole and must be put to "beneficial use," as defined in a 1943 law that implemented a constitutional declaration passed by voters in 1928. The law commands authorities to prevent "waste or unreasonable use or unreasonable method of use of water..."

Environmentalists believe the constitution thus authorizes the state water board to curtail agricultural diversions for the protection of habitat, but the 1943 law also declares, "In the enactment of this code the Legislature does not intend thereby to effect any change in the law relating to water rights."

That obvious legal dichotomy is the crux of the situation. Whether, indeed, the state water board is gearing up for a showdown over water rights, some of which stretch back to the 19th century, is the subject of much speculation in water circles.

Early this year, water board chairman Joaquin Esquivel told a gathering of water officials, "We know we have to change the system. Water rights can be there as a tool to be able to manage supplies through not just a drought but when

there is water again. Our water rights system can be there to facilitate decisions on projects and help us make decisions, or they can be a hindrance."

While the water rights issue percolates in Northern California, there's a similar conflict underway in Southern California over how much water the state diverts from a severely threatened Colorado River.

California is legally entitled to 4.4 million acre-feet per year, with the vast majority of that going to the Imperial Irrigation District and other agricultural users, but the Colorado's flow has dropped dramatically.

The federal government demands that California and other states that draw from the river, principally Nevada and Arizona, reduce diversions by 2-to-4 million acre-feet per year, and threatens to mandate cuts under the "beneficial use" doctrine if they cannot agree.

California has offered a 400,000 acre-foot reduction, only 9%, but that's not enough to satisfy the other states and the outcome is very much in doubt. Meanwhile, the feds are offering Colorado water users \$400 for every acre-foot of water they don't take.

Farmers' water rights are clearly not as sacrosanct as they once seemed to be, and as drought persists the stage is being set for a monumental reckoning of some kind.

## Veterans and Suicide

Veterans Day, November 11th, is an important day for every American and is intended to honor America's veterans for their patriotism, love for their country, and willingness to serve and sacrifice for the common good. This day of remembrance celebrates the service of all U.S. military veterans. Communities across the country plan events to honor those who have served and are currently serving. As we celebrate and recognize these brave men and women, we should also consider the struggles that they go through with mental illness.

Suicide is a national problem in the U.S. and a major concern for active-duty service members and military veterans. Members of the military may experience a variety of difficult and traumatic events including combat, natural disasters, and physical assault. According to the 2022 National Veteran Suicide Prevention Annual Report, there were 6,146 Veteran suicide deaths in 2020. That is 31.7 deaths per 100,000. During that year, suicide was the second leading cause of death among Veterans under age 45. The suicide rate for Veterans was 57.3% greater than for non-Veteran U.S. adults.

Veterans can come home from service carrying a weight they did not go in with. Without the right help, that weight can seem like too much, leading some Veterans to consider, or carry out, suicide. Some of the warning signs that Veterans exhibit include feelings of hopelessness, acting agitated, struggling with anxiety, insomnia, outburst of

anger or rage, an increase in substance use or abuse, and isolating themselves from the people close to them. Other factors related to the higher risk of suicide among Veterans are related to undiagnosed or untreated conditions, such as PTSD or mood disorders, which can increase a person's overall risk of suicide.

The VA offers a wide range of treatment programs for Veterans and their families. Also, "Vets for Warriors" is a peer support network with Veterans answering the phone for those in need. The number is 1-855-838-8255. Veterans may also use the Veterans Crisis Line Number where there is 24/7 crisis support. Dial 988, then press 1.

The Jason Foundation is another valuable resource for those struggling with suicidal ideation. Many times, a Veteran will exhibit clear warning signs prior to an attempt. By knowing the warning signs, and knowing how to help, you could save a life. 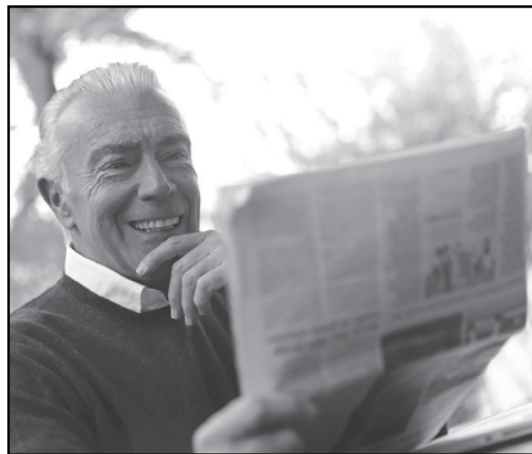

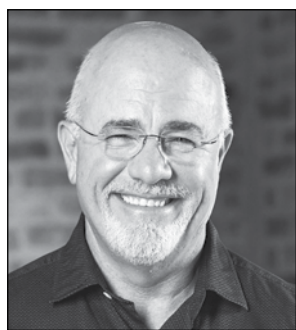

Dear Dave,

I need help. I am way behind on my basic utilities and my taxes. I have tried to start the Baby Steps, but everything is so overwhelming right now that it is easy to get discouraged. I am 33, I live in Los Angeles, and I average around \$30,000 a year doing behind-the-scenes work in the entertainment industry. My total debt is about \$10,000. Can you give me some advice?

Dear Cameron,

I know you're in a scary place right now, brother. But I'm glad you're getting on board and that you want to move in the right direction with your finances.

# Low-Cost Clinic Keeps Pets Healthy and Home

**SACRAMENTO COUNTY, CA (MPG)** - Pet owners whose animals venture outdoors can be keenly aware of the possible dangers to their animals, such as rabies and other illnesses as well as pets becoming lost. However, indoor animals may occasionally get out and face the same risks. In partnership with VIP Pet Care, the Sacramento County Bradshaw Animal Shelter offers low-cost vaccination and microchip clinics every third Thursday of the month, 3 - 5 p.m. at 3839 Bradshaw Road, Sacramento, CA 95827.

In addition to keeping pets healthy, the clinic focuses on making sure pets can safely find their way home. Most pets who get lost and find their way to the shelter have no identification tags and no microchip, making reunification difficult.

For only \$30, pet owners

can buy the extra security that has proven to reunite many owners and their pets. Though visible tags are the first line of identification for animals, they may wear off, fall off or get lost. Unlike traditional ID tags, permanent microchips can contain owner contact information, pet information and Bradshaw Animal Shelter's contact information, and most vets and shelters can easily scan them.

"A microchip greatly increases the chances your pet will be returned to you when lost," said Annette Bedsworth, Director of the Bradshaw Animal Shelter. "It just takes a moment to scan, and then we can quickly reunite pets with their families. Sadly, most pets who enter our shelter are not microchipped, and we have seen many beloved pets stay for several months before their owners finally tracked down where they were. It's heartbreaking."

Pet owners can take advantage of the

clinic's affordable microchipping services on the third Thursday of every month, as well as prevent illness. Pets with up-to-date vaccinations and preventive care are protected from illnesses including heartworm, kennel cough, Bordetella, parvo and Lyme disease. If unvaccinated animals contract illnesses, an owner may face costly treatments and surgeries for these preventable diseases. And when pets receive rabies vaccinations, it not only helps to prevent them from contracting the disease from bats, skunks, and raccoons, but it also protects residents from contracting the virus if bitten by an infected animal.

Licensing can be done at the same time as vaccinations and microchips for as little as \$15. Owners may also conveniently purchase a license online. This inexpensive service proves a pet's ownership and home address, and animals found by County animal officers can be returned immediately to the home, saving the stress of a shelter stay for the animal and the owners.

Vaccinations, microchipping and licensing cost a small fee that proves priceless when owners have safe, healthy pets at home where they belong.

Don't have a pet? The Bradshaw Animal Shelter has many available pets for adoption looking for loving homes. Adoptions include spay/neuter surgery, vaccines and microchipping. Visit the Bradshaw Animal Shelter's website to view a list of adoptable pets. ★

# California Gets Green Light for EV Charging Network

**SACRAMENTO, CA (MPG)** - California has the green light to start using federal infrastructure funding to expand electric vehicle (EV) charging stations along the state's interstates and highways following the recent federal approval of a joint plan by Caltrans and California Energy Commission.

The U.S. Joint Office of Energy and Transportation's signoff on the California Deployment Plan for the National Electric Vehicle Infrastructure (NEVI) Program makes an initial \$56 million in funding available to the state. Funded by the federal Infrastructure Investment and Jobs Act of 2021 (IIJA), California expects to receive a total of \$384 million for the program over the next five years. The federal funding will build on California's historic \$10 billion, multiyear investment to accelerate the transition to zero-emission vehicles by improving affordability and expanding charging infrastructure.

"Thanks to the Biden-Harris Administration's approval of California's NEVI plan, we can start putting historic levels of federal infrastructure funding to work to close gaps in our state highway system's evolving EV charging network and improve availability and reliability for low-income and rural residents," said California Transportation Secretary Toks Omishakin. "Coupled with unprecedented levels of state investments in zero-emission vehicles, this funding will help supercharge California's nation-leading efforts to drastically cut climate-changing pollution from the transportation sector."

The IIJA funds will add to efforts to complete a 6,600-mile statewide charging network and deploy 1.2 million chargers by 2030 to

meet the anticipated charging needs of the state's EV fleet.

"With this unprecedented federal investment, California can advance our vision of a unified network of charging stations along the state's busiest corridors," said California Energy Commission Commissioner Patty Monahan. "This new network will increase charging access, particularly in the rural areas of our state, and help EV drivers charge up on long trips."

The state's NEVI plan focuses on construction of fast-charging stations near interstates, U.S. routes and state routes throughout California. These charging stations will increase the availability of charging options, improve the reliability of the charging network and remove barriers to accessing EVs. NEVI funding will also support upgrades to existing infrastructure, charging stations' operation and maintenance costs, community and stakeholder engagement, workforce development, and related mapping and signage.

California surpassed one million zero-emission vehicles (ZEV) sold in 2021 and leads the country in all ZEV market metrics including the highest level of public funding, the largest EV market share percentage, and the most extensive public charging infrastructure. The success of the state's programs has led to ZEVs becoming a top export and has spurred major advances in manufacturing and job creation.

# Hornets Rally for 31-24 Overtime Win Over Montana

**SACRAMENTO, CA (MPG)** - The Sacramento State football team scored the final 17 points of the game to defeat No. 7 Montana, 31-24, in overtime in front of 15,927 fans and a national television audience on Saturday night at Hornet Stadium.

The Hornets, who are ranked second in the FCS media poll and third in the coaches poll, are now 7-0 overall for the first time in school history and stand at 4-0 in the Big Sky Conference. Montana dropped to 5-2 overall and 2-2 in league play.

Sacramento State never led in regulation and took its first lead of the game in overtime when Asher O'Hara rushed for a 7-yard touchdown to punctuate a four-play series with all 25 yards coming on the ground.

Montana had an opportunity to match the score and began its series with a 2-yard rush up the middle. The Griz then attempted three consecutive passes, including a fourth-down pass into the end zone, but all three fell incomplete.

The Hornets forced overtime with two scores in the final six minutes. Kyle Sentkowski made a 27-yard field goal with 5:54 remaining to make it a one-possession game at 24-17. The Hornets then lined the ensuing kickoff off a Montana player and the loose ball was recovered by Sacramento State. The Hornets faced 4th-and-4 during the next series but kept the drive alive when Jared Gipson was able to get his toes down for a 26-yard reception before stepping out at the 4-yard line. One play later, O'Hara went around the right end for his first score of the night to tie the game, 24-24, with 3:39 showing.

The Griz picked up a first down on its next possession but were hurt by an offensive pass interference call on 3rd-and-7 which eventually forced the team to punt. Sacramento State drove

to the Montana 38 with one second remaining but opted against attempting a long field goal into the wind and instead threw a Hail Mary into the end zone which was intercepted.

Montana scored the game's first points with a 15-play, 88-yard drive which was capped by 2-yard rush from Marcus Knight. The Grizzlies converted all three of their third down attempts during the series and the score marked the first time the Hornets have trailed in the last 470 minutes; 31 seconds of regular season play.

Montana stretched its lead to 10-0 after recovering a Hornet fumble on their own side of the 50.

Sacramento State posted its first points of the game on the next drive as the team needed just three plays to cover 75 yards. Cameron Skattebo started the drive with a 39-yard run around the right end. Two plays later, Jake Dunniway stepped up in the pocket and connected with Marshel Martin for a 38-yard touchdown pass up the

middle of the field. Montana had one final chance to add points at the end of the half but Caleb Nelson blocked a 39-yard field goal attempt as time expired. That effort followed a block by Marte Mapu on a 45-yard attempt early in the second quarter.

The slugfest continued into the third quarter where the only points of the period came after a lengthy review. A pass from Kris Brown to Aaron Fontes was originally ruled incomplete plus a late hit was called against the Griz which set up a 3rd-and-25. However, the play went to replay review and Fontes was ruled to get his left foot inside the end zone for a 16-yard touchdown.

Sacramento State needed just six seconds to score in the fourth quarter. Dunniway found Pierre Williams in stride for a 45-yard touchdown. That drive was aided by the late hit on the previous touchdown which was enforced on the kickoff and helped the

Hornets return the ball to their own 45 yard line.

Montana immediately responded with a 13-play drive which ended with a 2-yard touchdown rush from Nick Ostmo with 8:42 left in the game. The Griz picked up three first downs on third-down plays, including drawing a pass interference flag which brought the ball to the 3-yard line.

The game was billed as strength against strength as Sacramento State came in ranked fourth in total offense while Montana was third in total defense. The Hornets finished the game with 479 offensive yards, including 180 on the ground. While those numbers were below Sacramento State's season average, both were high allowed by the Griz this season.

Cameron Skattebo rushed for 111 yards and averaged 8.5 yards per carry to post his third consecutive 100-yard game and his fifth of the season. Skattebo's total was also a season high against Montana which had not allowed

any player to rush for more than 88 yards in a game this season.

Jake Dunniway was 19-of-36 for 284 yards and three touchdowns but also threw three interceptions. Asher O'Hara was 2-of-4 passes for 15 yards and added 56 rushing yards with two scores.

Marshel Martin caught six passes for 75 yards and a score while Gipson provided five catches for 66 yards.

The Hornet defense saw career highs by Brock Mather and Jett Stanley who tallied 13 and 10 tackles, respectively. Prince Washington, Marte Mapu, Armon Bailey and Killian Rosko each had nine stops.

Montana ran 24 more plays than Sacramento State (95-71) and dominated time of possession, holding the ball for 37:51.

Sacramento State will next host Idaho on Saturday, Oct. 29, at 6 p.m. for Homecoming. The Vandals improved to 5-2 overall and 4-0 in the Big Sky with a 56-21 win over Portland State. ★
