Super Women Offer Wisdom 311 Connect New and Improved Links to **Services**

SACRAMENTO COUNTY, CA (MPG) - In 2013, Sacramento County launched 311 to handle all municipal County service requests. By now, everyone knows to call 311 to report an abandoned vehicle or a broken streetlight in unincorporated Sacramento County. Sacramento County 311 handles these and hundreds of other questions covering a variety of County services every day, seven days a week and 24 hours a day.

What you may not know is that the County has been working hard to improve the 311 service and in February 2020 completed a project that integrates all County municipal service departments with 311 for seamless transfer of service request directly to the department that will handle the request. 311 encouraged public user and internal department participation in each phase of the project. They included citizen and departmental suggestions throughout the project and the new system features many elements provided by user feedback. 311 is delighted to announce the following new self-service customer features: **Request Services Online** by completing virtual interviews that route your request to the appropriate department for handling (a) Interview questions were specifically developed by the responsible departments (b) Interview answers enable departments to quickly resolve the request; Instantly receive a case number with an estimated time of completion; Use the Interactive Map to pinpoint the exact location for your request; View Nearby Requests of reported issues in your area; Track and update your Service Requests Online; Quickly access information online for County services using our newly created self-service Knowledge Base; Search the Public Knowledgebase to learn about countywide services and find answers to frequently asked questions (FAQs); Submit requests online or by use of a mobile device; Provide feedback, letting 311 know if the information was helpful or not, our dedicated team will review and revise as necessary. 311 is excited to provide this new and improved service for the citizens of Sacramento County. SACRAMENTO REGION, CA (MPG) - Because women have led Sacramento's District 3 for almost 50 years, its three living Supervisors laughingly call their board position the 'girl's seat.' Susan Peters' 2021 retirement will end that matriarchal dynasty. A guy – either Rich Desmond or Gregg Fishman – will take over.

When Sandy Smoley, Muriel Johnson and Susan Peters recently convened, conversation was not so much memory lane as memorable potholes. "But road deterioration will always be with us."

New Neonatal Intensive Care Unit Opens

CARMICHAEL, CA (MPG) -Dignity Health announced the completion of construction of the new 'Robert S. and Star Pepper Neonatal Intensive Care Unit' at Mercy San Juan Medical Center. The NICU spans 17,889 square feet and is a huge increase over the previous 1,200-square-foot space originally built it 1989. Mercy San Juan's original NICU was among the first of its kind in Northern California. Over the past three decades, the practice of neonatology has progressed significantly and the Sacramento region has grown exponentially and therefore so have the community's needs for the NICU. Since its inception, the hospital has always grown with its community, and the development of the

Dispose of Furniture, Appliances and Bulky Waste

SACRAMENTO COUNTY, CA (MPG) - Do you have big stuff at home that you need to get rid of? Old furniture, a worn-out mattress, a washer, dryer, tree branches or just junk?

Residential customers who receive curbside garbage and recycling service from Sacramento County's Department of Waste Management and Recycling have many options:

Schedule a Bulky Waste Pick Up. Once per calendar year, residential curbside customers are provided a bulky waste pick up at no

additional cost. On the day before your pick up, put acceptable items at the curb. Pile size is limited to 8' x 4' x 4', or about as much as the cab of a pickup truck piled to the top. To schedule this service, call 311, download the free SacGreenTeam app, or complete the online form;

Already had your annual Bulky Waste Pick Up? Additional pickups are only \$25 each!

Donate gently used furniture, appliances hold goods store, churches, Salvation Army or Habitat for Humanity of Greater Sacramento;

Take large appliances like refrigerators, washers, dryers, stoves, ovens and dishwashers to the North Area Recovery Station or Kiefer Landfill. County residents may drop off up to two large appliances per day for no charge;

Hire a county licensed rubbish hauler to dispose of old furniture, appliances, etc. It's important to use a licensed rubbish hauler so that your junk doesn't end up dumped illegally. If anything in the pile points back to you, you could be financially responsible for cleanup costs! If in doubt of a business license, contact the Business License Unit at 916-874-6644 or send us an email. ★

Counseling is Available for Medicare Open Enrollment Period Oct. 15-Dec. 7

SACRAMENTO COUNTY, CA (MPG) - Medicare's Open Enrollment period begins Oct. 15 and ends Dec. 7. During that period, Medicare recipients may:

Switch from Original Medicare to Medicare phone and video-confer-Advantage; Switch from encing to answer questions Medicare Advantage and help seniors and other to Original Medicare; eligible recipients under-Switch from one Medicare Advantage plan to another; Switch from one Medicare Part D prescription drug plan to another; Enroll in a Medicare Part D plan if you didn't enroll when you first were eligible for Medicare.

To help you understand your options, you can schedule a free

counselor.

HICAP (the Health Insurance Counseling & Advocacy Program) is administered by the California Department of Aging. Its trained volunteer counselors are available by stand their Medicare rights and benefits.

HICAP counselors can provide information about Medicare supplemental insurance (Medigap policies); Medicare Advantage plans; employee and retiree coverage; long-term-care insurance and how to appeal coverage denials.

Voting Has Officially Begun for Presidential General Election

SACRAMENTO COUNTY, CA (MPG) - Voter Registration and Elections (VRE) has delivered Vote by Mail (VBM) ballots to the U.S. Postal Service for distribution to all currently registered voters in the County for the November 3, 2020, Presidential General Election.

Voters may use any Ballot Drop Box throughout the County to return their ballot. VRE has a drive-through Ballot Drop Box in the Election's Office parking lot at 7000 65th Street, Sacramento. This Ballot Drop Box is open 24 hours a day, 7 days a week and until 8:00 p.m. on Election Night.

Voters are encouraged to return their ballots early and sign their pink VBM envelope in order for their ballot to be counted. No postage is necessary for

Continued from page 1 its ongoing program to involve community volunteers in government. The lone female endured disproportionate workplace scrutiny: she survived breast cancer and other health issue in a fishbowl; even her divorce was public property. "The Sacramento Bee ran a he-said-she-said report of the court proceedings," she winces. "They wouldn't have done that to a man. That's why at 84, nothing can get to me. I've heard it all."

After 20 years, leaving the Board was not a retirement. Governor Pete Wilson grabbed Smoley for State and Consumer Services Secretary; she later became his Secretary of Health and Human Services. "I went to bigger arenas with greater influence," she says. "But County government was always my favorite. I saw results for every decision I made on the Board. I can still drive down streets and see bike lanes I put in, or a day care center I started." She relished Board members' diversity of service: "One day, I had to change my outfit five times. I started in the morning in jeans, riding on a buckboard for a parade. I ended up in evening dress, at a Crocker Art Museum gala."

Community activist and fundraiser Muriel Johnson won the District in 1993. She pushed to begin costly revamps for Fulton Avenue and for the widening of the Watt Avenue bridge. "We added bike lanes, benches and art," she enthuses. "We gave Watt Avenue the bestlooking bridge in town." During 1990s efforts to save McClellan Air Base, she



met President Bill Clinton in Sacramento and later sat beside him for Washington DC negotiations. "He was charming and easy to talk to," she recalls. "He let us down gently. He understood what McClellan meant to the community but he was straight with us. We gave it our all, but we just couldn't save the base."

Smoley was her chief mentor. "She appointed me to the Arts Commission and other committees," recalls Johnson. "She persuaded me I could run for District 3. You only had to watch Sandy's energy in office, and seeing was believing." Cracking the whip for 12 years at Johnson's side was Chief of Staff Mary Anne

Dann. "If I got off track, Mary Anne quickly got me back," approves her boss. "In 1986, my husband and I went to New York for a vacation. After two days, Mary Anne called me and commanded: get back - your District's flooding! I came straight back to work on saving the levies." Evening meetings sentenced the Supervisor and her husband (ENT surgeon Ernie Johnson) to years of takeout food. "He never complained," says his spouse. "One night I found him peeling potatoes. He'd decided to teach himself to cook."

Before retiring, she recruited banker Susan Peters to run for her seat. "In Susan, I felt I'd found

the golden ring," says Johnson. "She's been so capable and wonderful for the District. After I stepped everywhere. "

Her January farewell to arms promises nostalgia. "I'll miss so many people," she considers. "But I'll sleep better. Years of waking up - worrying about the parkway's flooding or another deputy's been injured on the job - it all takes its toll."

Veterans Smoley, Johnson and Peters agree their successor will agonize for the County's homeless problem and the economic recovery from COVID 19. But they each have buoying advice:

Suggests pioneer Sandy Smoley: "Enjoy your service. It's a tough job, but it's rewarding."

Offers Muriel Johnson: "Don't sit downtown. Get out to the District and listen to people."

Adds Susan Peters: "Problems aren't solved quickly. The job's not a sprint. It's a marathon." \star

Taxpayer Funded Campaign Outreach Contract Tied with Democrat Candidates

SACRAMENTO, CA (MPG) - Without legal authority and bypassing the state's open bid contracting procedures, the California Secretary of State entered a \$35 million agreement with a partisan public relations firm to conduct "voter outreach." These state funds were intended to help with the administration of local county elections.

"We write to you to express significant concerns with the Secretary of State's (SOS) recently reported contract to spend \$35 million, ostensibly to provide voter outreach, through a firm widely known for its partisan history," said Senator Patricia Bates (R-Laguna Niguel), the Vice Chair of the Senate Appropriations Committee, and Senator Jim Nielsen (R-Tehama), the Vice Chair of the Senate Budget and Fiscal Review Committee, in their letter to decision makers. "This creates an obvious conflict of interest in the administration of

these public funds, no matter the protestations from the SOS and the contracting firm that the money would be used in a nonpartisan manner."

In a September 29 article from the Sacramento Bee, the Secretary of State's office asserts that he is spending money "on the counties' behalf."

The letter from Senators Bates and Nielsen continues, "This explanation raises significant legal questions as to how the SOS can unilaterally decide it will spend money on behalf of all 58 counties. Thus far, we have seen no indication from counties that any of them in fact did ask the SOS to engage in the contract on their behalf."

Continued from page 1 new Level III NICU will now be able to accommodate 40 infants in 16 private rooms and eight three-bed pods. The private rooms are available for multiple birth family sets, isolation for infants whose circumstances require it, and a private place for families to say a loving goodbye to NICU babies who, despite every effort, will be unable to survive. The new space also offers parents the opportunity to stay at the bedside of their baby at all times.

"For over 30 years, Mercy San Juan Medical Center's NICU has been a life-saving resource for families throughout the Sacramento region," said Mercy San Juan Medical Center president, Michael Korpiel. "The new unit will house the remarkable neonatologists and nurses who have made the NICU what it is today and continue to offer this urgently needed, excellent care to our region's most vulnerable babies.'

Despite caring for many of the sickest and most-fragile infants in the Sacramento region, Mercy San Juan Medical

Center's NICU had a mortality rate of 1.1 percent in 2015 - among the lowest in the nation.

"Thanks to Bob and Star Pepper and numerous other donors and supporters of this project, the department now has the facilities and equipment it needs to continue carrying out its extraordinary life-saving work," said Kevin Duggan, President and CEO of Mercy Foundation. "It is through this thoughtful generosity of many that the NICU can continue to be a source of comfort, hope and advanced medical care for fragile infants in our to come."

With Dignity Health's commitment of \$35 million to make the new NICU a reality, Mercy Foundation led the efforts to raise community support and donations for the additional \$3,080,000 needed to expand and update the NICU at Mercy San Juan.

As most premature babies are in the NICU until they reach what would have been 36 to 40 weeks gestation, they may be in the care of NICU staff for months, with parents who are trying to balance work, caring for family at home, and being at the hospital for their new baby. Central to this initiative was the desire to offer families the opportunity to stay with their infants. Research has shown that these tiny patients have the best chance at survival when they are able to bond with their parents or guardians. The new NICU offers families a comfortable space with enough room in which to nurture their new babies and get to know them. An important element for people like Scott and Cary Boese, who know very well the difficult journey that can come with being parents to babies who need high-level care.

"When we heard news that the new NICU would be built, we were overcome with joy and emotion, because the unit represents more than just additional bed space. It gives our community access to a

community for generations modern facility, new technology, and room for privacy, so that parents can bond with their fragile children," said Cary.

> The NICU will be up and running to receive its first patient sometime in late October to early November.



Out-of-Work Californians Urge Governor to Expedite Unemployment Benefits

SACRAMENTO, CA (MPG) - Standing in front of California's Employment Development Department (EDD) headquarters, seven residents of Northern California urged Governor Newsom to be more hands-on with helping those in need. Like millions of Californians, these residents lost their jobs after the Governor triggered a shutdown of businesses and ordered a shelter-in-place for all Californians.

"The experiences of out-of-work Californians and EDD's lack of action are shameful," said Senator Jim Nielsen (R-Tehama). "The Governor and his Administration must do better to serve the people who elected him. Californians deserve better."

Waiting for unemployment benefits has been a shared frustrating, infuriating and devastating experience.

Phone calls are cut off after hours of waiting on hold. Mails and emails gone unanswered. Endless requests for legal documents that are not always related to the applicant's claims, has resulted in a nerve-racking game of waiting.

With the support Senator Jim Nielsen, Sacramento area residents spoke up for the 1.6 million Californians who are still waiting for their benefits.

"Action must be taken now to help those who are waiting for their benefits," said La Toya Horne of Sacramento. "I don't want anyone else to deal with the humiliation and bureaucratic obstacles I had to endure. I lost my home. No one should have to lose their home while waiting for a benefit they have earned and deserved."

Ms. Horne owned a thriving salon in an upscale part of town. She applied for unemployment in March when salons were forced to close. Months later, a stranger contacted Ms. Horne through social media to inform her that mail from EDD arrived at his house. She had lived at that address 10 years ago. When she amended her application and updated her identification, EDD told her she needed a judge to resolve the issue. They later reversed their decision.

Resolved in her passion to help others, Ms. Megan Williams drove nearly 100 miles to urge the Newsom Administration to act swiftly to get benefits to applicants.

"It is very disheartening to see the lack of urgency. I feel bad for the people who are not as lucky to have others to lean on financially, or who have landlords that are not as understanding as mine. The stress of having to call

phone companies, credit cards companies, etc. to work out payment plans or shifting debt from one credit card to another, just to maintain on time payments, or keep things turned on, is unnecessary," Ms. Williams stated.

EDD just emerged from a two weeks closure that left an estimated 100,000 people unable to apply for benefits. The hiatus was supposed to "reset" its operations and implement a new system. However, Senator Nielsen's office was informed Tuesday that the backlog to review claims went from eight weeks to 11 weeks.

Understanding the financial and mental toll of waiting for EDD's sloth-like movements, Mr. Rick Walters of Yuba City joined the call to ask the Governor to immediately take action to help those who have lost their jobs due to the government-imposed lock-down.

"Government is supposed to work for us when we need help. We are law-abiding taxpayers. This experience was beyond stressful. As Governor, you need to act now to protect our citizens of this state," Mr. Walters appealed.

Like the 1.6 million residents still waiting for their benefits, Ms. April Carlton of Citrus Heights has been able to meet most of her financial obligations thanks to her close-knit family.

As an office manager and bookkeeper at a small business, Ms. Carlton's hours were reduced and she was later furloughed. EDD denied her claim based on a name change in 2018. Ms. Carlton provided EDD with judgment orders for the name change, immigration papers and proof of residence. Despite providing all legal documents, Ms. Carlton is still waiting for her backdated benefits.

"Thank God for the support of my family. Without them, I would not have been able to handle this financially straining and emotionally infuriating process," said Ms. Carlton.

Sherri Bailey of Rancho Cordova, along with her 82-year-old mother, joined the group to remind EDD officials of their commitment during the Great Recession to the public and lawmakers.

"They are not keeping the promise they made in 2008. They owe it to Californians to tell us what they did do to serve the public. Clearly, their system is still broken."

Elected to the State Senate in January 2013, Senator Nielsen represents the Fourth Senate District, which includes the counties of Butte, Colusa, Glenn, Placer, Sacramento, Sutter, Tehama and Yuba. Having worked through my quarantine backlog on my Playstation 4, I did the unthinkable: instead of booting up a game from recent years that I'd been itching to play, I turned to remastered version of last-generation games, and even pulled my Playstation 3 out of its dusty box to turn it on for the first time since 2014.

I explored a bevy of experiences that gained popularity about a decade ago. I hopped around the alien planet of Pandora in Borderlands 2 (three additional Borderlands games have been released since), punched my way through the streets of Hong Kong in Sleeping Dogs (an excellent Grand Theft Auto imitator that everyone seems to have forgotten) and started my journey through Heavenly Sword (a 2007 action game that has you fighting an evil CGI Andy Serkis with a magical blade).

The last game, in particular, is a time capsule for how far we've come. Heavenly Sword places undue emphasis on clunky motion controls (I had forgotten that the Playstation 3's controller even had motion-sensing capabilities) and exaggerated acting to

look and sound prettier.

show off the still-newto-games technology of motion capture. But it was also an indication of how much of a leap the Playstation 3 generation of games was over its predecessors. Playing most games on the Playstation 2 or on any older systems feels like driving a Model T: primitive and unwieldy by modern standards.

But interestingly, despite the leap from the Playstation 2 to the Playstation 3. revisiting Playstation 3 games reminds me how little the Playstation 4 (the most modern console in the Playstation lineup) has changed. If playing Playstation 4 games feels like driving a Tesla, playing Playstation 3 games feels like driving a '99 Camry: it's not as sleek nor as comfortable, but it's not a fundamentally different experience.

This makes me wonder about the upcoming Playstation 5, the fanciest, newest, and largest piece of gaming tech to grace televisions in recent years, releasing this November. The ads try to sell the machine as an immersive powerhouse, but the games themselves look fundamentally similar to those decade-old Playstation 3 titles. The controls are the same and the mechanics are the same, they just

Maybe this lack of evolution is a good thing, an indicator of video games reaching their "middle age" of artistic maturity. For comparison, arguably no technology has fundamentally changed the way movies have been made since the advent of digital cameras and CGI. But such a prospect still feels disappointing, as it seems that the lack of pushing the medium forward could just as easily be a result of missed potential than of artistic development. With each passing year games become more and more expensive to develop, making creators more and more riskaverse when it comes to generating a return-oninvestment. Why spend \$200 million or more over the course of four years for a product that isn't tried-and-true? It's yet to be seen whether a resurgence in activity among indie and midsize developers with smaller budgets and overhead can fill the gap and continue to innovate in ways we haven't seen for years. Until then, we can only hope that I'm proven wrong, and that the next generation of consoles will be the driver of artistic progress that this generation

wanted to be.

It will be simple for you to enroll in Original/Tradition Medicare and a new Medicare Supplement/ Medigap (without having to answer questions) only because this is your first year to be out of your Medicare Supplement/Medigap or your first year to pick a Medicare Advantage Plan. Medicare's Annual Enrollment Period starts on October 15 th and ends at midnight on December 7th.

For you to disenroll from a Medicare Advantage company simply enroll in a Medicare Prescription Drug plan that fits your needs. You will automatically be out of your old Medicare Advantage plan and back to "Original/Traditional Medicare with a Medicare Prescription Drug Plan; ers at www.tonisays.com.

apply for a Medicare Supplement/Medigap to pick up what Medicare does not pay for. What happens if you have health issues which can keep you from qualifying with a Medicare Supplement's application. See the Medicare rules concerning this issue in the Medicare and You Handbook, which states.

"If you join a Medicare Advantage Plan for the first time, and you aren't happy with the plan, you'll have special rights to buy a Medigap policy if you return to Original Medicare within 12 months of joining.'

Below are the changes that a Medicare beneficiary can make to their Medicare plans during Medicare Annual Enrollment Period:

- Enroll in a new Part D Medicare Prescription Drug Plan, which automatically disenrolls you from a Medicare Advantage plan.

Another Vague Decree from Newsom

Gavin Newsom is fond overly so – of declaring "big hairy, audacious goals" and doing something that implies he's striving to achieve them.

However, he's been compelled to devote virtually all of his time to managing crises this year: the COVID-19 pandemic, followed by a recession as he shut down businesses to battle infection, a state budget deficit caused by the recession, record heat waves that overwhelmed the state's power supply, and wildfires of historic proportions.

Managing crises is essentially a reactive process while Newsom fancies himself a proactive striver and doer, not unlike, it should be noted, Jerry Brown in his first stint as governor four decades ago.

Newsom began the year in characteristic form, devoting virtually his entire State of the State address to homelessness and a chronic shortage of housing.

and, with it, a whole new way of investing in homeless solutions.'

He also declared "a commitment – right now, this year – to major reform that will eliminate red tape, and delays for building critically needed housing - like affordable, multifamily homes - especially near transit and downtowns."

Never mind. Within days of delivering that speech, Newsom issued his first emergency order on COVID-19.

Newsom is now trying to return to a proactive mode by issuing sweeping executive orders on climate change that make headlines, but really are no more than declarations of lofty intent.

The first declared that California will ban the sale of vehicles powered by internal combustion engines by 2035, but the order only directed the Air Resources Board to explore how that might be done.

The second, issued last week, directed state agencies to devise ways to "protect" 30% of California's land and coastal waters by 2030 to reduce greenhouse gases and promote biodiversity, boasting that California would be the first state to adopt the "30-by-30" program being advocated globally.

"Once again, California "After decades of neglect is taking on the mantle of global climate leadership and advancing bold strategies to fight climate change," Newsom said. "The science change, we must build on our historic efforts in energy

Access to Housing Fund, and emissions and focus on our lands as well."

But what does "protect" actually mean?

Newsom's order basically enacts a piece of legislation, aptly named Assembly Bill 3030, that passed the Assembly this year but died in the Senate Appropriations Committee without a vote.

It had an extensive airing in the Senate Natural Resources and Water Committee, whose staff raised the definition question, to wit:


"It is a complicated task to determine how much of the state's land, water, and ocean resources are already protected, in part because there is no one uniform definition of 'protection' in state law. These and similar terms can represent a sliding scale depending on the types of restrictions and allowable uses, including the degree of human access."

In fact, the meaning of "protect" varies greatly even among its advocates, as the staff report detailed.

That lack of specificity is why those who catch fish, farmers, hunters, housing developers and others opposed the bill. They saw it as carte blanche for state agencies to issue restrictive land use rules.

So Newsom gets another headline attesting to his "bold strategies," but as with his decree on cars, we won't know, perhaps for years, whether it has any concrete meaning.

AN ORDINANCE OF THE RANCHO CORDOVA CITY COUNCIL AMENDING CHAPTER 6.84 OF THE RANCHO CORDOVA MUNICIPAL CODE **RELATED TO SMOKING IN AND** AROUND MULTIFAMILY **RESIDENTIAL PROPERTIES** WITH THE PURPOSE OF UPDATING THE CITY'S CLEAN INDOOR AND OUTDOOR AIR AND HEALTH PROTECTION **REGULATIONS TO BETTER** PROTECT INDIVIDUALS FROM THE NEGATIVE EFFECTS OF SECONDHAND SMOKE

The City is estimating that it will receive approximately \$600,000 in CDBG funds for the 2021 program year. The CDBG program is funded by the U.S. Department of Housing and Urban Development (HUD). The program provides funding for activities that benefit low-income persons, eliminate slum or blight, and/or serve an urgent need. Eligible activities include property acquisition, public improvements, housing rehabilitation, economic development, and public services.

The City has developed an Annual Action Plan that describes how the City will utilize program funds for eligible activities during the 2021 program year. The 2021 Annual Action Plan will be made available to the public for at least 30 days before adoption by the City Council. The documents were released on October 2, 2020, for public review and comment, and have been made available until November 2, 2020 at Citv Hall, 2729 Prospect Park Drive, Rancho Cordova, between the hours of 8:00 a.m. and 5:00 p.m. on weekdays and on the City's website: https://www.cityofranchocordova.org/departments/communitydevelopment/housing/community-development-block-grant.

The purpose of this public hearing will be to present the 2021 Annual Action Plan to City Council for their approval, as well as to give citizens an opportunity to make their comments known regarding community needs, goals, and potential activities to be funded under the CDBG Program. The 2021 CDBG program year will run from January 1, 2021 to December 31, 2021. The Annual Action Plan can be amended as needed to reallocate funds to housing and community development activities. 



United Way and City of Sacramento Offer Free Broadband, Computers and Training

SACRAMENTO, CA (MPG) - Up to 10,000 Sacramento households affected by the pandemic, particularly low-income households with children and seniors, will receive free broadband access this fall through a new pilot program launched by the City of Sacramento and United Wav California Capital Region. Funded through the federal CARES Act, the Digital Equity program also will provide free computers to up to 1,000 households as well as digital literacy training on how to use the technology. To qualify, an applicant must be a City of Sacramento resident and eligible for public assistance programs such as the National School Lunch Program, Medicaid or WIC. To apply and learn more, call 211 or visit sacramentocovidrelief.org/digital.

The Digital Equity program aims to address unequal access to technology, known as the digital divide, which has expanded during the pandemic.

"The Covid-19 pandemic has disproportionately affected our low-income communities and made it even more crucial that we close the digital divide," said Mayor Darrell Steinberg. "Providing reliable Internet access to families in Sacramento means more children can learn and more adults can work or take advantage of education and retraining that will help them succeed in today's job market."

Participating households will receive broadband at no cost through December and will be offered service through the Comcast Internet Essentials program at a discounted rate after that. Households receiving computers will be offered refurbished Dell Chromebooks. The program will contract with community-based nonprofits and school districts to provide outreach, identify households in need and house "digital champions" who will work on outreach, case management and training in targeted geographic areas. Digital champions are community residents with technology skill sets who are trained to

help households with broadband application and provide basic digital literacy education.

The pandemic has brought the digital inequities in our community to the forefront, and I am happy to see our city working to provide residents with access to Internet and computers to be able to learn, work and stay connected with others," said Mayor Pro Tem Angelique Ashby. "This program will help close these digital gaps by providing equipment, connection and digital literacy to those most in need."

Of the more than 24 million unconnected households nationwide, the digital divide disproportionately affects minority and low-income populations. According to the Federal Communications Commission, 35 percent of adults who do not use broadband at home are older, poorer, less educated, more likely to be a racial or ethnic minority, and more likely to have a disability than those with a home connection.

"We are honored to partner with the city to provide Sacramento residents in need with equal access to the technology necessary to succeed during the pandemic,' said Stephanie Bray, president and CEO, United Way California Capital Region. "This project is an important element of United Way's Square One Project that is working to make sure families have the tools and resources they need so kids can graduate from high school ready for success in college or career. There is no doubt that Internet access and technology will play an increasingly vital role in kids' success in school."

For nearly 100 years, United Way California Capital Region has brought local people together to make community change happen. Today, the nonprofit is bringing people together across Amador, El Dorado, Sacramento, Placer and Yolo counties for its Square One Project, a 20-year promise to significantly increase the number of students in our region who graduate from high school ready for success in college and beyond. SACRAMENTO COUNTY, CA (MPG) - Utility poles covered with signs and notices for political candidates, lost animals, yard sales and events present serious hazards for utility workers. This is a particular problem during election season.

Nails, staples, tacks, and screws used to post signs can cause serious injury to line workers who climb the wooden utility power poles every day. These items are especially hazardous when the poles are climbed during bad weather to restore power during storms and at night.

When the signs fall off or are removed, the fasteners often remain in the pole, causing line workers to get cut or injured. Nails and staples can obstruct climbing gear, which can cause workers to slip or fall as they climb. Even the tiniest puncture in line workers' rubber gloves can expose them to severe shock from power lines.

When advertising for a political candidate, lost pet, garage sale or other event, please do not post signs on utility poles. \star
