### **State Water** Allocations **Increase Due** to Winter Storms



#### SACRAMENTO, CA (MPG) -

Following several strong winter storms that brought snowpack and precipitation to above average levels, the California Department of Water Resources (DWR) has announced it will increase the 2019 State Water Project (SWP) allocation. Most SWP contractors will now receive 70 percent of their requests for the 2019 calendar year, an increase from the 35 percent allocation announced last month.

"Just ten weeks ago it looked like we may have been facing another dry year in California," said DWR Director Karla Nemeth. "Fortunately, we've turned a corner and now it's shaping up to be a great year for water supply. California's hydrology varies year to year, which is why all Californians must work together to use water wisely."

The allocation is assessed monthly and the final alloca-

As of March 7, the Northern Sierra 8-station index recorded above average precipitation for water year 2019. While the state has not reached record precipitation like that seen in 2017, February was the third wettest recorded in the Northern Sierra index since 1921 and the sixth wettest in the San Joaquin index since 1913. The statewide Sierra snowpack is 156 percent of average for this date.

Most of the state's major reservoirs are at or above their historical averages for this time of year. Lake Oroville, the SWP's largest reservoir, is currently at 76 percent of capacity and 103 percent of average for this time of year. Shasta Lake, the Central Valley Project's (CVP) largest reservoir, is at 83 percent of capacity and 106 percent of average.

Reservoir storage, snowpack, precipitation, and releases to meet water supply and environmental demands are among several factors used in determining allocations.

The 2019 allocation of 70 percent amounts to 2,942,158 acre-feet of water.

# **Reconciling a Rivalry**

Playmakers Brings Rival Players Together to Serve Underprivileged Kids

SACRAMENTO REGION. CA (MPG) - Last October, during the last game of their season, the football teams from local high schools Rio Americano and El Camino forfeited the game due to bad conduct – a bench-clearing brawl that ended the season with a lot of bad blood on both sides.

After hearing about the brawl, Greg Roeszler was inspired to find a way to turn the situation into a positive for both the players and the game itself. Roeszler — or Coach Roz, as he is affectionately called — has a long history with football: he played at Encina High School and at San Diego State University, went on to play for the NFL, and then eventually returned to Encina to coach the varsity football team. Coach Roz now runs a local nonprofit, The Playmakers Organization, that coaches character through leadership and provides free programs to underprivileged and at-risk youth.

Coach Roz saw an opportunity to heal the rift between Rio and El Camino through shared service to the community. He invited El Camino Head Coach JP Dolliver, Organization is bringing Rio Head Coach Sam Stroughter, and San Juan Unified School District Athletics Director Ron Barney to join him and Playmaker Director Phil

discuss a unique idea. Coach Roz suggested that the coaches and selected members from each team work together to serve at the upcoming Tim Brown Playmaker 9-1-1 Camp for Kids on April 12.

The Playmakers retired Oakland Raider and NFL Hall of Fame player Tim Brown to West Sacramento for a free oneday football camp for at-risk and special needs Dubois at a meeting to kids. Coach Roz suggested

that serving together at the camp could create a sense of camaraderie between rival players. He said, "There are so many good things that will come out of this. ... Players being led by the most powerful guys in the community in serving at-risk underprivileged kids — using the greatest game that God put on the face of the earth as the magnet."

Barney said the District fully supports the teams "doing something positive

Barney explained that a good rivalry motivates the players to perform at their best and is based on the result of a few bad mutual respect. Both coaches also expressed frustration with social media, which they believe escalated the rivalry to the point that some of their players were throwing punches on the field. Dolliver said the kids typed things to each other with a screen between them that they never would have said face to face. "These kids are missing out by not treating this rivalry as a positive. ... Without Rio, that last game of the season is just another game," said Dolliver.

Stroughter and Dolliver are both committed to coaching their players on character as well as football. As Coach Roz said, "This is about loving the game more than loving the fight. ... We can take this thing and turn it into something that's good for the game. ... We've all been in football a long time. Has anyone ever heard of reconciliation like this? ... What if Sacramento has figured out and is implementing how you take a bad rivalry and make it a good rivalry, how you take a bad situation and turn it into a good situation? This could be the model. ... We very well could be on to something here beyond just our community."

### **Fatal Hit and Run Collision in Arden Arcade**

SACRAMENTO COUNTY, CA (MPG) - On March 17, 2019 at approximately 1:35am, the California Highway Patrol (CHP) received reports of a traffic collision within the intersection of Marconi Avenue at Bell Street.

CHP Officers arrived on scene and discovered a twovehicle traffic collision had occurred. During the initial on scene investigation CHP Officers learned a 36-year-old male from Sacramento, who was travelling with a 9-yearold boy, was driving his 1998 Toyota Corolla westbound on Marconi Avenue approaching Bell Street.

Zaragoza Jr., (03/26/1991 of

Roseville) was driving his 2010 Infinity QX56 southbound on Bell Street. As the Toyota entered the intersection, Zaragoza Jr., failed to stop for a red light, entered the intersection, and collided with the Toyota. Zaragoza Jr., fled the collision scene.

Both occupants of the Toyota were transported to local area hospitals with major injuries. As CHP Officers continued their investigation, they were informed that the 9-year-old boy had died as a result of his injuries.

### Assemblyman Kiley Announces Resolution to **Censure Senators Kamala Harris and Dianne Feinstein**

SACRAMENTO, CA (MPG) - Presenting the only train ride experience behind an authentic, historic locomotive in the Sacramento area. California State Parks and the California State Railroad Museum & Foundation are proud to offer history-rich weekend excursion trains on the Sacramento Southern Railroad that begin on April 6 & 7, 2019. Each weekend through September 2019, guests can enjoy relaxing and memorable excursion train rides along the picturesque Sacramento River and Old Sacramento Waterfront pulled by either the vintage steam locomotive Granite Rock No. 10 or a historic diesel locomotive, depending on the weekend.

Diesel or steam, excursion train ride guests delight in the sights, smells and sounds of an authentic, historic locomotive as it rolls along the levees of the Sacramento River for a six-mile, 45-minute roundtrip excursion. Appealing to all ages, the experience offers guests the chance to enjoy train travel from an earlier era. The train features a combina-

comfortable seats, open-air "gondolas" with bench style seating or VIP train ride experiences onboard one of three of the California State Railroad Museum's first class cars (depending on the weekend): the El Dorado lounge observation car, the Audubon dining car or the French Quarter lounge car from the 1950s that served the famed Southern Pacific "Sunset Limited" service.

Weekend excursion train ride tickets are available and encouraged to book online in advance at www. californiarailroad.museum/visit/ excursion-train-rides or can be purchased in-person starting at 10:30 a.m. the day of the train ride (based on availability). Weekend excursion trains depart from the Central Pacific Railroad Freight Depot (on Front between J & K Streets) on-the-hour from 11 a.m. to 4 p.m. From July 6 through September 2, an adjusted summer schedule takes effect with trains running on-the-hour from 10 a.m. to 3 p.m. (if summer temperatures reach 100 degrees or higher, trains may be cancelled for the remainder of that day).

Regular excursion train tickets tion of vintage closed coaches with cost \$12 for adults, \$6 for youths

(ages 6-17), and ages five and under ride free. For passengers desiring a first-class train ride experience, tickets cost \$24 for adults, \$16 for vouths and are free for children five and under. First-class train tickets often sell out early so guests are encouraged to purchase tickets in advance. Groups interested in reserving the entire VIP car for a regularly scheduled ride need to do so in advance by calling 916-322-7112.

- It may be spring, but it is never too early to start thinking of how you can support those in need during the holiday season or throughout the year. While many celebrate the holidays surrounded by friends, family and gifts under the tree, it is important to remember those who may be without, including local foster children, dependent adults and seniors.

For the last 30 years, the lives of thousands are touched each holiday season by Sacramento County's Gifts from the Heart Program, an annual holiday gift-giving program that runs from mid-November until early December serving those within the Child Protective Services, and Senior and Adult Services of the Sacramento County Department of Child, Family and Adult Services.

Over 90 local community partners and individuals from businesses, government agencies, service groups and families donate gifts that allow the County to continue to provide gifts year after year.

"Coordinating this program has been truly fulfilling," said Tanja Edelman, Volunteer and Student Intern Services Coordinator. "The generous gifts and contributions from local community partners and the teamwork of volunteers have made the Gifts from the years and counting."

The success of the Gifts from the Heart program not only lies with the kind sponsors but also with the wonderful volunteers who dedicate hundreds of hours, helping to organize and disof over 50 volunteers manages the pick-up, distribution and delivery of gifts from community and private sponsors.

The volunteers, many of whom return year after year, spend weeks in the warehouse organizing toys and gifts to be delivered or picked up by social workers. In 2018, program and community partner volunteers donated over 12,370 hours at an estimated \$360,000 value.

Gifts from the Heart provided more than 3,300 gifts to children, teens and seniors in Sacramento County during the 2018 holiday season. The program welcomes all who are interested in participating by sponsoring gifts, becoming a community partner and volunteering time during the season.

However, the holiday season is not the only time you can donate or volunteer to support seniors in the community. Senior and Adult Services welcome yearround donations. In fact this week, Liberty Home Equity Solutions, Inc., a business located in Rancho Cordova, coordinated with the department to set up an office collection of basic necessities for seniors. The staff at Liberty Home Equity Solutions, Inc. put together gift bags that included lotion, toothbrushes, toothpaste, chopstick, crossword puzzles, fuzzy no-slip socks and more for social workers to bring to senior clients in need.

### The Green New Deal Plus Modern **Monetary Theory Equals Socialism**



#### Commentary by Dr. Mark Hendrickson

Thank you, Representative Alexandria Ocasio-Cortez. The Green New Deal (GND) she has . unveiled is most illuminating. It is now unmistakably clear that AOC, Bernie • "Guarantee a job with Sanders, and other democrat socialists in the Democratic Party don't want "socialism lite" but rather they want the federal government to take control of the "commanding heights" of the economy. Although they may settle for the variant of socialism in which businesses remain nominally private, even as the government dictates what they must do, they plainly want central economic planning, albeit with a 10-year rather than five-year plan.

This is no exaggeration. The GND essentially calls for conscripting the American workforce and putting us to work in accordance with what the elite government planners want instead of what "we, the people" want. They propose to replace our market economy, in which privately owned businesses compete to see who can best supply the needs and wants of the people, with a command economy in which government is the master and citizens build what the planners say must be built.

Here are some planks in AOC's GND:

• The elimination of fossil fuels in 10 years, which would entail the closing of all gas stawith electric-charging but are created out of thin stations; replacing or retooling tens of millions of vehicles that travel by land, sea, or air (with the alarming acknowledgment "we aren't sure that we'll be able to get rid of ... airplanes [in 10 years]"); replacing all power plants that use fossil fuels with wind and solar, and eliminating all jobs involved in the exploration, extraction, refining, and transportation of fossil fuels.

- "Retrofit every building in America."
- "Overhaul ... agriculture."
- "Provide job training and education to all."
- family-sustaining wages" "Provide high-quality health care [and] housing.'
- "Ensure universal access to healthy food ..." and much, much more.

What the GND proposes - essentially, rebuilding America's physical plant and infrastructure from top to bottom - is physically impossible to do in 10 years. In fact, it couldn't be done in 100 years. The economy would collapse long before then in the chaos that socialist economies always experience as the inevitable consequence of replacing market prices with government edicts.

The GND is economically impossible, too, although its proponents seem to think that they can bypass economic reality by implementing what is called MMT—Modern Monetary Theory, a new label for the old, failed practice of printing more money.

In everyday economic life, money acts like a claim on goods and services; if you have enough of it, you can obtain what you want. Under MMT, the governply. (Fiat currencies are not

air and rely on legal tender laws to compel people to accept them as payment for goods and services.) Using its monopoly power over money, MMT in practice would give the federal government unlimited purchasing power. That would enable the government to outbid all private interests for labor, materials, equipment, etc. In short, what the government wants, the government gets, and private individuals and businesses are correspondingly deprived.

What about inflationwouldn't printing all those additional fiat dollars cause prices to rise? According to MMT, the government can prevent inflation by draining purchasing power away from the private sector through higher taxes. Thus, while printing more money increases the government's purchasing power, inflationary pressures would be offset as government removes purchasing power from the private sector. MMT is a game rigged so that the government always wins and the private sector always loses. No wonder socialists love MMT!

There is a well-known word that describes overwhelming power that government wields over people: tyranny. MMT boils down to government using its monopoly over money to dictate and control production, obliterate free markets, suppress private enterprise, and impoverish the people-i.e., socialism. A more apt name for MMT is Money Monopoly Tyranny. Indeed, MMT is a destructive tool tailor-made to assist the implementation of the socialistic Green New Deal.

#### **Defendant Sentenced for** Foothill Farms Murder

DATE: March 19, 2019 CASE: Souksavanh Phetvongkham (Case #17FE005490) **PROSECUTOR:** Deputy District Attorney Matt Chisholm, Homicide Unit

The Honorable Gerrit Wood sentenced Souksavanh Phetvongkham to 56 years to life in prison. On February 5, 2019, a jury convicted Phetvongkham of the first-degree murder of Mario Benitez-Gallegos. The jury also found that Phetvongkham personally used a deadly weapon during the murder. An allegation that Phetvongkham suffered a prior strike conviction for aggravated felony assault was determined to be true at the sentencing hearing.

The victim and Souksavanh Phetvongkham had been friends until a recent falling-out. A mutual friend of the two gave a ride to Phetvongkham. During that ride, the two stopped and picked-up the victim. Phetvongkham and the victim agreed to fight and got out of the car. During the fight, Phetvongkham stabbed the victim multiple times, including a stab wound to the heart. The victim was taken to a hospital by his friend, but he died from blood loss.

#### **Defendant Sentenced for** Hotel Room Murder

DATE: March 15, 2019 CASE: Mario Michael Mayorga (Case #16FE022652) **PROSECUTOR:** Deputy District Attorney Caroline Park, Homicide

Unit The Honorable Eugene Balonon sentenced Mario Michael Mayorga

to 76 years to life in prison. On February 13, 2019, a jury convicted Mayorga of the first-degree murder of Tina Morales. The jury also

found true that Mayorga used a deadly weapon during the murder. Allegations that Mayorga suffered two prior strike convictions for assault with a firearm and assault with a deadly weapon were determined to be true at the sentencing hearing.

Mario Michael Mayorga and the victim were in a dating relationship. On November 24, 2016, Thanksgiving Day, the victim checked into a motel near Stockton Boulevard and Mack Road. The victim had Thanksgiving dinner with Mayorga and the two then walked to a friend's house. Another friend drove the two back to the victim's motel room at 1:30 a.m. At 11:30 a.m. that day, motel employees found the victim with multiple stab and puncture wounds

#### Child Sexually Violent Predator to Remain in Hospital Custody DATE: February 1, 2019 **CASE:** Michael Gillette (Case #96F07315) **PROSECUTOR:** Deputy District Attorney Stefanie Mahaffey, Mental Health Litigation Unit The Honorable James Arguelles

found true a petition of civil commitment against Michael Gillette as a Sexually Violent Predator (SVP), and ordered Gillette committed to Coalinga State Hospital for an indeterminate term.

On April 21, 1997, Gillette was convicted of lewd acts with a child under 14 years of age. He was sentenced to three years state prison. On January 18, 2013, Gillette was again convicted of lewd acts with a child under 14 years of age. Before he was released on parole for that offense, the People filed a petition to commit Gillette as an SVP. The petition alleged that Gillette had qualifying prior convictions and a mental disorder that caused him to be a substantial danger to the safety of others and likely to engage in violent predatory sexual acts in the future.




