# **Providing Shelter, Counseling, Housing**

#### From Carmichael HART

CARMICHAEL, CA (MPG) - For the second year, hundreds of volunteers from churches, nonprofit organizations, and local businesses are doing something about Carmichael's homeless people.

Carmichael HART's (Homeless Assistance Resource Team) Winter Sanctuary provides safe overnight shelter to dozens of people coming in from the cold for nine weeks -- Dec. 30 through March 2.

"It's more than a hot meal and a cot," Carmichael HART President Scott Young said at the charity's January meeting. "We offer housing leads, help with acquiring IDs, and assist with transportation to help people get to that point where housing is possible for them. Our long-term goal is to get as many people as we can off the streets and into housing. To do that, establishing trust with Winter Sanctuary guests is crucial."

## **California Driver Cell Phone Use Up in 2018**

More California drivers are using their cell phone behind the wheel, but less than previous years, a 2018 observational study by the California Office of Traffic Safety (OTS) and California State University, Fresno found.

The study, which was done between August and September of 2018, revealed fewer than five percent (4.52 percent) of California drivers were seen picking up and using their cellphones, compared to less than four percent (3.58 percent) in 2017. As part of the study, surveyors examined driver behavior at 204 locations across 17 counties statewide.

The 2018 numbers are three percent less than 2016 (7.6 percent), a year before the most recent cell phone law went into effect.

"Our goal is to end distracted driving, and there's still work to be done," OTS Director Rhonda Craft said. "This observational survey gives us an idea on where we stand getting drivers' attention away from their phones and where we still have work

Other key findings from the study include:

- Cell phone use was more than 8 times higher (5.55 percent) among drivers with no passengers versus with at least one passenger (less than one percent).
- · Cell phone use was higher on local roads than on freeways or highways.
- The most common cell phone use by drivers was to perform a function on the phone. This could be anything from texting, email, GPS, using an app or social media.
- Less than two percent of drivers were observed using their phone with a child passenger.

Under the 2017 hands-free cell phone law, drivers are not allowed to hold their phone for any reason. The phones must be mounted on the dashboard, windshield or center console.

The mounted phone can only be touched once with the swipe or tap of a finger to activate or deactivate a function. If cited, drivers face a \$162 fine for a first offense and at least \$285 for a second offense.

Since the first cell phone laws went into effect more than 10 years ago, the OTS has been urging people to put down their phones and focus on the road.

## **County Partnership with UC Davis Approved**

SACRAMENTO COUNTY, **CA (MPG)** - On Jan. 15, the Board of Supervisors approved a collaborative partnership between Sacramento County and UC Davis Health to deliver primary care, behavioral health, and some specialty services to 5,000 Medi-Cal enrollees at the County-run Federally Qualified Health Center at Broadway and Stockton Boulevard.

"Sacramento County is thrilled for this relationship with UC Davis Health," said Supervisor Patrick Kennedy. "Together we are committed to ensuring greater access to high-quality health care Hom Primary Care Facility

in our region. UC Davis Health already provides health care services at the Sacramento County Health Center and the expansion will allow for more access to primary care and high-quality health care to Medi-Cal patients."

Starting Feb. 1, the partnership will bring together a hospital system and Sacramento County health care providers to give coordinated, high-quality care to patients. The unique structure of the agreement is based on that of an Accountable Care Organization, where UC Davis Health provides all care for primary care and behavioral health services for enrollees at the Paul F.

in the Sacramento County Health Center as well as at UC Davis facilities.

"Patients will be phased in over a period of six months to the Paul F. Hom Primary Care Facility in the Sacramento County Health Center," said Peter Beilenson, Director of the Department of Health Services. "These enrollees will be provided with comprehensive primary care and behavioral health services, but will also have opportunities to connect with on-site social service organizations that provide housing assistance, job placement, legal services, Medi-Cal system navigation and eligibility, and care coordination."

## **Brundage to Return as River Cats** Manager for 2019

WEST SACRAMENTO, CA (MPG) - The Sacramento River Cats, in conjunction with the San Francisco Giants, are excited to welcome Dave Brundage back for his third season as manager of the River Cats for 1,477 (.502) in 21 seasons the 2019 season.

joined by Damon Minor, Triple-A level. who will return for his fourth season as the River Cats' hitting coach, and pitching coach Steve Kline, who will enter his second season in Sacramento. One of two newcomers for 2019 will be fundamentals coachJolbert Cabrera. The training staff will be made up of athletic trainer David Getsoff and strength and conditioning coach Andy King who are each returning for their second season. Lastly, the staff will welcome Hiro Sato, who will also serve as athletic trainer in Sacramento.

An Oregon native, Brundage joined the River was drafted by San Cats in 2017 and has compiled a 119-162 record in making his Major League his two seasons at the helm in Sacramento. Before coming to the River Cats, the veteran manager spent the previous four seasons with the International League's Lehigh Valley IronPigs. In 2016, Brundage led the IronPigs to an 85-58 record, the second best mark in all of Triple-A baseball.

Brundage, 53, made his managerial debut in 1995 with the Riverside Pilots across nine seasons.

Prior to his four seasons with Lehigh Valley, Brundage helmed the Richmond/Gwinnett Braves for six seasons from 2007 through 2012. He made his Triple-A debut in 2006 with the Pacific Coast League's Tacoma Rainiers. Brundage has a career record of 1,490as a manager including a Brundage will again be 912-943 (.492) mark at the 3.12 team ERA in 2015.

Minor, 43, returns to the River Cats for his fourth season as hitting coach. In his third year with the team, Minor worked closely with Triple-A newcomers and top Giants' prospects Steven Duggar, Chris Shaw, and Aramis Garcia as they prepared for their Major League debuts.

A former Giant, Minor Francisco in 1996 before debut in 2000. In 136 games over parts of four seasons, Minor hit .232 with 13 home runs. He set a career-high in 2002 when he played in 83 games and slugged 10 home runs, helping the Giants claim the National League pennant. While in the Giants farm system, he compiled a .277 batting average with 179 home runs and 648 RBI

Kline, 45, returns to the River Cats for his second season as pitching coach. Kline joined the Sacramento staff following three seasons with the Double-A **Richmond Flying Squirrels** and nine seasons overall with the organization. In 2018, Kline helped develop Giants' prospects Andrew Suarez, Dereck Rodriguez, and Ray Black before each were called up to the big club in San Francisco. Kline led the Giants Double-A affiliate to a league-leading

Kline completed his Drafted in the 4th 11-year Major League career as a lefty reliever with the Giants in 2007. All told, he appeared in 796 MLB games with five different organizations. The Pennsylvania native was an 8th round selection by the Cleveland Indians in the 2003 draft out of the University of West Virginia. He set the single-season record for appearances by a left-hander (89) in 2001 while with St. Louis, and led the National League in games played as a pitcher for three consecutive seasons (1999-2001).

> Cabrera, 46, comes to the River Cats coaching staff as fundamentals coach following managerial stints with the San Francisco Giants' Class-A Short Season affiliate Salem-Keizer Volcanoes in 2017, and Single-A affiliate Augusta GreenJackets in 2018.

Continued from page 1 It also pays for beautification projects, arranges litter cleanup, graffiti removal, and waste abatement. Gary Hursh, a Carmichael attorney, the district's past president and current chairman of its Security Committee, says HART and its Winter Sanctuary are good investments.

He said the program last winter took dozens of homeless people off the streets and away from store doorways and other sleeping spots on business property.

"Shuffling people around is not a solution," he said in an interview. "The next step, in my opinion, is for CID to partner with nonprofits that find and provide housing for the homeless. HART is providing a solution."

Deputy Kevin Hee of the Sheriff's Department Homeless Outreach Team (HOT), told HART meeting attendees: "We all agree that we can't jail and arrest everybody out there. We're looking at getting services to the homeless. There's an exponential explosion of homelessness in California. Every community is affected."

Besides churches, sheriff's deputies and business leaders, other HART partners are Sacramento Self Help Housing, ATLAS of Carmichael with its thrift store, the local Chamber of Commerce, the San Juan Unified School District, and Sacramento County.

County Supervisor Susan Peters offered this assessment: "Carmichael HART has a proven track record of success, and its Winter Sanctuary program reflects the dedication of the community's faith-based organizations to help those in need who find themselves homeless."

Paul Keefer, a trustee of the Sacramento County Board of Education who is working on a HART plan to help homeless students, stated "As a volunteer for the Carmichael HART Winter Sanctuary I was impressed by the training and guidance that our team received from Sacramento County."

"Wonderful people are coming with a willingness to help, saying, 'We want to be part of this," Farley said at the HART meeting. She reported that 78 different guests participated in last year's Winter Sanctuary, whereas more than 30 different homeless people have come in the first three weeks of the program this year. Young said volunteers are winning the trust of their guests and are seeing dramatic changes in attitudes and a willingness to accept assistance.

"We should all have the same goal," he said. "Whatever our reasons for getting people off the streets, our goal should be the same -- getting people housed. Ultimately, we all want our communities to thrive. As long as we have people camped on our sidewalks, next to our businesses and on our back lots - it remains a distant goal. The only way we'll see effective change is to get people housed. It's all about getting people housed."  $\star$



of those prom dresses and the dresses away before plan to have two giveaways with the first being conducted on February 9, 2019.







For me, the problem with this show (unlike *The Middle*, which always lived in its

shadow) is that the younger family members for the most part didn't develop into characters who are still fresh and funny. The traits that were amusing in the adults still by and large work after ten seasons, some weeks more effectively than others, but Modern Family is an example of how difficult it can be to sustain such a high degree of quality over the long haul, especially when so many of the situations are built on misunderstandings and farce. 


