CARMICHAEL, CA (MPG) - Franco Garcia sold his first house when he was 22. It was modest home on Hillcrest Way, Carmichael. Though he was simply following family footsteps, he remembers the thrill 30 years later. "There's always satisfaction in helping someone achieve the American dream," says

Recently elected the 100th president of the Sacramento Board of Realtors, Garcia is also the group's first Latino leader. "Considering the local demographic," he considers, "it's a huge honor. The organization opened many doors my family and me." Another recent victory was being named one of 250 top producers in the National Association of Hispanic Real Estate Professionals.

Selling real estate clearly runs in Garcia blood. In her 79th year, mom Eva is still a dynamo at the family's midtown office. Franco's sister Rosanna and both siblings' spouses are among the sales team. "My sister and I never planned to join the business," recalls the boss. "We were just used to it. We grew up thinking it normal to get picked up from school by a parent who had a stranger in the front seat. We did homework in the car. They looked at houses."

Champions of the Mexican community, his parents founded local, state and national Hispanic chambers of Commerce. "They met with President Jimmy Carter many times, advocating for their minority's representation," recalls the son. "With their business and the many charities they were involved with, it's amazing they found time to put home-cooked meals on the table and keep us kids moving forward."

Church and Catholic school education helped. Garcia's son Sebastian is currently an athletic star at dad's Carmichael alma mater, Jesuit High. After graduating from UC Berkley with a political economics degree, Franco set out to work in the mortgage

industry. When his father's health declined, he was called back to the family fold. "In 1964, my parents started one of the first Hispanicowned real estate companies in Northern California," attests their son. "Spanish is still is still spoken in our office; we've long tapped an underserved demographic. But we still pride ourselves in serving every client faithfully. We been around so long, we're now helping children and grandchildren of my parents' first clients."

Region Now Conserving Water at 25 Percent

SACRAMENTO REGION, CA (MPG)

Sacramento-area residents reduced water use by 25 percent in 2016 compared to 2013 even without a state mandate to conserve, according to an analysis of water use figures submitted to the State Water Resources Control Board (State Water Board) and the Regional Water Authority (RWA), which represents nearly two dozen water providers in the Sacramento region.

"The savings last year demonstrate that residents are continuing many of the water-wise behaviors adopted during the drought," said RWA Water Efficiency Program Manager Amy Talbot. "The conservation ethic did not go away with the mandates."

The State Water Board in May 2016 adopted a new Emergency Regulation that allowed water utilities to set their conservation standard based upon local water supply conditions and the utility's ability to pass a "stress test" (to meet customer demand in the next three years if drought continued). Local water providers certified that they have adequate supplies to meet customer needs. "However, this was not a signal to stop using water wisely," Talbot said. "Instead, it recognized that local water providers have planned and invested in building reliable supplies for decades."

The 25 percent savings in 2016 comes on top of significant water use reductions over the past decade. Overall, the region's water demands have decreased 9 percent from 2000-13, while population increased 17 percent. The region uses the same amount of water today as it did in 2000 while serving 400,000 more people. And, during the drought, the Sacramento region achieved some of the highest water use reductions in the state.

"Although the Sacramento region is no longer in a drought, we're encouraging everyone to continue using water wisely," Talbot said. "Droughts are a part of life in California and remind us that water is precious. Wasting water is foolish, especially when there are so many easy ways to conserve."

RWA and local water providers are asking residents to turn off sprinkler systems until spring, especially in light of the recent drenching by winter storms. In addition, now's a great time to consider how to save water indoors by, for example, replacing older fixtures with high-efficiency WaterSense-labeled ones. These include toilets, showerheads, faucets, aerators and weather-based sprinkler timers.

Attacking Carmichael's Homeless Problem: First, the Numbers

Past annual counts of Carmichael's homeless people suggest that as many as 150 may be on our streets, but many hundreds more are out of sight – most of them children.

No one knows the exact numbers, but every two years volunteers take an on-the-street count of homeless people across Sacramento County. Besides the informal government-directed census, they also conduct voluntary in-depth interviews

While volunteer counters fanned out on the evening of Jan. 25, Winter Sanctuaries involving Carmichael churches were offering overnight housing and meals. Christ Community Church was a host overnight site for up to 20 men and women who were bused in from Citrus Heights. The church and 10 others are participating in Carmichael HART (Homeless Assistance Resource Team), a collaboration also involving businesses, nonprofit charities and schools.

Since last August, as many as 40 people have attended HART's past six monthly organizing meetings to get information about the scope of Carmichael's situation and devise solutions ultimately aimed at helping people move off the street into transitional or permanent housing with resources and, later, job prospects.

Carmichael HART has pitched in to help its counterpart in Citrus Heights, which for the first year has been operating its own Winter Sanctuary program to offer homeless men and women safe haven from the season's cold and rain. Last year, Citrus Heights helped Rancho Cordova HART's shelter program. Other community-based shelters also have been operating in Davis and Elk Grove for several years.

Besides Carmichael's shelter,



the Greater Sacramento Winter Sanctuary, involving dozens of the county's churches, have offered overnight spaces for 100 or more people daily through March 31. Carmichael Presbyterian Church has been our community's intake center where "guests" are registered, then bused to a host church by 6 p.m. The program runs through March 31

Guests are given a dinner and loaned a cot and sleeping bag that they check back in before they return to the intake center by 7 a.m. the next morning. Many homeless people are repeat visitors.

Some nonprofits also operate other winter shelters around the county. Most exclude children under age 18 and pets. Organizers say the word gets out about the shelters although many people choose to stay on the street rather than accept restrictions related to hours, conduct and prohibitions of drugs and alcohol. Sometimes people are turned away once capacity has been reached.

County and school district figures show that many of Carmichael's residents who don't have a permanent address are children who have no say in where they spend their nights. They typically "couch surf" with friends or relatives, sleep in cars or move around to temporary day shelters and motels.

Regular school attendance is a

huge challenge.

Steve Young, a school community worker for homeless children and families for the San Juan Unified School District, says almost 3,000 of the 40,000 students in the district are "living in transition" - including about 790 in the Carmichael area.

"Truancy is a big issue when it comes to homelessness," Young said at a Carmichael HART meeting. "A lot of kids are missing school because of it. There's a lot of trauma where these kids are becoming homeless like a death in the family, a mental health issue or drug addiction. A divorce can lead to it, or the loss of a job. Right now, in Sacramento, you need to make at least \$20 an hour to rent a twobedroom apartment. We've got single mothers who are making \$10 an hour and they've got five

kids. They're not making it."

Shaun Dillon, a Carmichael community advocate, told HART that Sacramento County has a deficit of up to 60,000 affordable housing units.

Several plans are in the works to develop such units in the region, including a village of "tiny houses" grouped around common service facilities. Elk Grove HART operates four transitional houses to move people off the street and position them for the job market.

Ken Bennett of Sacramento Self-Help Housing says Carmichael HART may want to consider "shared housing" where four or more people pay about \$450 a month for space in a rented residence with house leaders and counseling. Transitional housing is another model being considered. However, Bennett says, "The long-term goal of transitional housing requires financing and extensive partnering."

Despite such challenges, Carmichael HART participants are upbeat about the strong turnout of community volunteers at planning meetings and winter shelters.

Scott Young of ATLAS, a nonprofit thrift shop operator and charity serving needy Carmichael people, said at a recent HART meeting:

"There's a lot of capital in this room. We've made a good head start. Our winter shelters are meeting a need and giving us experience. However, they're not getting us any closer to a permanent solution to homelessness. What we really need is more affordable housing. We're learning about the population that we're serving, about their needs and how they landed on the street. But until we see them in permanent housing and with better access to employment, we won't be nearly finished."

"In the Sacramento region, most household water use occurs outdoors, but people don't believe it," said Regional Water Authority Water Efficiency Program Manager. "Time and again, public opinion surveys show the residents incorrectly believe that more water is used indoors."

That's why RWA and local water providers are challenging kids to bust the myth and educate the public about a fundamental fact: Most of the water we use daily goes on lawns and outdoor landscaping. "There are lots of ways to save water, but reducing outdoor water use can make the biggest difference of all," Talbot said.

Water Spots Video Contest entries are due by Friday, March 3, 2017. Entries will be judged by a panel of water conservation experts and distinguished judges on creativity, entertainment value, accuracy, originality and incorporation of the 2017 water efficiency message. Finalist videos will be displayed on the Raley Field Jumbotron screen, and winners announced at a Sacramento River Cats game in April 2017. Videos may be used in RWA's 2017 advertising campaign. Winning students and their teachers will also get cash



Allergy Alert on Undeclared Cashew Allergen in Dry Roasted Almonds

U.S. FDA Special Report

SACRAMENTO REGION, CA (MPG)

- Specialty Commodities, Inc. (SCI), a subsidiary of Archer Daniels Midland Company (NYSE: ADM), is recalling a specific lot of dry roasted almonds because they may contain undeclared cashews. People who have an allergy or severe sensitivity to cashews run the risk of a serious or life-threatening allergic reaction if they consume these products.

The recall was initiated after it was discovered that the cashew-containing product

was distributed in packaging that did not reveal the presence of cashews. The recalled dry roasted almonds were distributed between December 22, 2016, and January 19, 2017, to three customers, one of whom redistributed them for sale in either bulk bins or clam shells to retail outlets in California, including Safeway and Nugget Markets.

Representatives of SCI are working with DSD Merchandisers Inc., the distribution customer, and these outlets to ensure the product is removed from shelves and returned. No illnesses have been reported

to date in connection with this issue.

Subsequent investigation indicates the problem was caused by a temporary process irregularity that occurred at the third-party contract manufacturer that processed and packaged the almonds for SCI. Then, an inventory processing irregularity resulted in the almonds being forwarded to the impacted customers.





My husband was recently laid off, and he has \$229,000 in a 401(k). He has been told that he should roll it into a hybrid annuity. Is this a good idea?

- Durnae

Dear Durnae,

Absolutely not! It sounds to me like he's been talking to an insurance agent instead of an investment advisor. There's no reason to put a 401(k) into an annuity. Annuities are there to protect money, as it grows, from taxes. Well, guess what? The 401(k) is already protecting it from taxes.

I would roll it into a traditional IRA in a series of growth stock mutual funds. You'll have half the fees, the advisor won't make anywhere near the commission he'd make on an annuity, and you'll get much better results in the end.

Yeah, I definitely wouldn't go the annuity route. I don't have a single annuity, and I've got a lot of investments. One of the reasons so many "advisors" push

Dave Says annuities is because they wind up with bigger commissions.

Annuities aren't evil or anything, but they're definitely not the proper product for you in this situation.

Get away from the guy who gave you this advice, and find a good financial advisor — not an insurance guy — with the heart of a teacher. You need to talk to someone who's interested in helping you two plan for your future, not theirs!







Police Officers Lawfully Acted in Self-Defense in Shooting of Dazion Flenaugh Woman Sentenced for Stealing Wallets, ID Theft Woman Convicted for Double Murder of Elderly Couple

DATE: January 13, 2017

The District Attorney's Office has determined that three Sacramento Police officers lawfully shot Dazion Flenaugh after he rushed at them in a threatening manner while holding two knives.

On April 8, 2016, Sacramento Police officers contacted Flenaugh in the South Sacramento area after receiving a report that Flenaugh had been acting suspicious in the neighborhood. Flenaugh ran from the officers and committed multiple crimes while seeking to avoid apprehension. After jumping over fences and escaping through backyards, Flenaugh stole a large pick axe from one yard and used it to smash another residence's front door window. He also broke the back door glass. Flenaugh then went to an occupied home, which he forcibly entered after threatening to harm the resident with the pick axe and knife he was holding. She retreated from her home and contacted a neighbor for help. After discarding the pick axe and now holding two knives, Flenaugh confronted and threatened the neighbor, then fled.

When officers finally caught up with Flenaugh, he refused to comply with repeated commands to drop the knives and get on the ground. Instead, he rushed directly at one of the officers with the two large kitchen knives still in his hands. Two other officers were also standing nearby. Fearing for their own safety and the safety of each other, the three officers discharged their weapons at Flenaugh. Flenaugh died as a result of his gunshot wounds.

Multiple witnesses reported Flenaugh acting in a manner consistent with being under the influence of a controlled substance. Laboratory testing confirmed the presence of amphetamine and methamphetamine in Flenaugh's blood.

The District Attorney's Office investigates all officer-involved shootings that result in death or bodily injury. By law, officers are allowed to use deadly force when they reasonably believe they are faced with imminent danger.

Based on a thorough review of the evidence, Flenaugh posed an imminent threat of death or serious bodily injury to the three officers, and they were justified in shooting Flenaugh to defend themselves

Our review only addresses whether the officers involved committed any violation of criminal law. We do not address issues of civil liability, police tactics, or department policies or procedures.

factual and legal findings is available to the public.

The Honorable Michael Bowman sentenced Jasmine Moore-Grant to 21 years county jail prison, of which she was ordered to serve 13 years in custody and 8 years on mandatory supervision. Moore-Grant previously pled to one felony count

of second-degree burglary, 24 felony counts of

identity theft, and admitted to two prison priors. In July and August of 2015, Moore-Grant entered office buildings during business hours and stole wallets from employees who were away from their desks. She then repeatedly used and attempted to use more than a dozen victims' credit cards to make purchases at local stores. She completed over 90 fraudulent transactions causing more than \$7,000 in loss.

Moore-Grant has a prior criminal history of multiple theft and identity theft offenses.

Thien Ho, Homicide Unit Shauna Burton was convicted by a jury of two counts of first-degree murder for beating Melvin Bain and Jean Bain to death. The jury also found true weapons and multiple murder special circumstance allegations. Burton was also convicted of robbing a store clerk.

On November 3, 2013, Shauna Burton went to a CVS Pharmacy on Zinfandel Drive, where she threatened a clerk with a gun and then robbed the store. Shortly afterwards, Burton went to Melvin and Jean Bain's residence. Burton had previously assisted in caring for 78-year-old Jean Bain. While at the Bains' residence, Burton demanded prescription pills and money. When Melvin Bain refused, Burton stabbed Melvin Bain in the face and beat the elderly couple to death with a large Maglite flashlight.

Burton faces a maximum sentence of life without the possibility of parole. Sentencing is set for February 24, 2017 at 9:30 a.m. in Department 13 before the Honorable Matthew Gary.

AHHH is as advertised. Staff is

They provide truly advanced wound care, infusion nursing, orthopedic, occupation and physical rehabilitation, speech and swallow function therapy, specialized medical social workers and a chaplaincy ministering to the patients and their loved ones. The tiniest staff member is a therapy dog.

AHHH is a Medicare Certified Home Health Provider. They are licensed by the by the California Department of Public Health. They have provided care for premature babies, pre-and post op patients, patients such as diabetics with wounds that can be nearly impossible to heal. Many of these

are patients the hospitals have given up on and AHHH has succeeded where others have failed, improving patient outcome in terms of health and healing. Sehr is intent that her teams utilize the latest technology to treat patients and makes available ultrasound and laser therapy, in addition to debridement if physician ordered.

The Low-Level Laser Therapy (LLLT) alone, per Sehr can be highly effective in treating, diabetic ulcers, venous stasis and arterial ulcers, and many other types of non-healing wounds.

The hospice care that Sehr's company provides is a growing service, based on industry best practices, but also on her own experiences as a nurse. Most hospice patients they see are given six months or less to live, but that isn't an outcome set in stone. "We don't give up," she says. "We're not God, but people do 'graduate' from hospice. They do get better."

Hospice care provides

comfort care to patients and family. "Advanced hospice nurses are registered nurses specifically dedicated to end-of-life care. Sehr credits hospice volunteers for the selfless work they do as part of the organization. "Our hospice volunteers spend time with patients and their loved ones. They run errands and provide caregiver relief, companionship, and supportive services. Volunteers are the backbone of our hospice team.". Volunteers form bonds with patients and family members. Patients and families often tell volunteers things they feel they can't tell their loved ones and help open the way for people to talk honestly. Volunteers work alongside paid staff in every area of hospice

AHHH truly treat the entire family, and that includes monthly bereavement support group meeting. "At Advanced Hospice, patients are nearing and passing the end of their life, leaving behind husbands, wives, sons, and daughters," according to the company website.

"When a patient is diagnosed with a serious illness or is recovering from an injury, our medical professionals, nurses, and therapists work hard to rejuvenate him/her to normal life. In addition to purely medical procedures, medications, and techniques, a huge part of a person's recovery depends on his/her psychosocial condition."



IRS Tax Filing Season Open

Revenue Service has said that it successfully started accepting and processing 2016 federal individual income tax returns on schedule. More than 153 million returns are expected to be filed

People have until Tuesday, April 18, 2017 to file their 2016 returns and pay any taxes due. The deadline is later this year due to several factors. The usual April 15 deadline falls on Saturday this year, which would normally give taxpayers until at least the following Monday. However, Emancipation Day, a D.C. holiday, is observed on Monday, April 17, giving taxpayers nationwide an additional day to file. By law, D.C. holidays impact tax deadlines for everyone in the same way federal holidays do. Taxpayers requesting an extension will have until Monday, Oct. 16, 2017 to file.

"Following months of hard work, we successfully opened our processing systems today to start this year's tax season," said IRS Commissioner John Koskinen. "Getting to this point is a year-round effort for the IRS and the nation's tax community. The dedicated employees of the IRS look forward to serving taxpayers this filing season, and I want to thank all of the tax and payroll community for their hard work that makes tax time smoother for the nation."

The IRS expects more than 70 percent of taxpayers to get tax refunds this year. Last year, 111 million refunds were issued, with an average refund of \$2,860.

Refund Delays

A law change now requires the IRS to hold refunds on tax returns claiming the Earned Income Tax Credit (EITC) or Additional Child Tax Credit (ACTC) until Feb. 15. Under this change required by the Protecting Americans from Tax Hikes (PATH) Act, the IRS must hold the entire refund — even the portion not associated with the EITC and ACTC. Even though the IRS will begin releasing EITC and ACTC refunds on Feb. 15, many early filers will still not have actual access to their refunds until the week of Feb. 27. The additional delay is due to several factors, including weekends, the Presidents Day holiday and the time banks often need to process direct deposits.

This law change gives the IRS more time to detect and prevent fraud. Beyond the EITC and ACTC refunds and the additional security safeguards, the IRS anticipates issuing more than nine out of 10 refunds in less than

21 days. However, it's possible tax-filing or payment obligations a particular return may require additional review and take longer. Taxpayers are reminded that state tax agencies have their own refund processing timeframes that vary, and some states may make additional reviews to ensure their refunds are being issued properly. Even so, taxpayers should file as usual, and tax return preparers should submit returns as they nor-

Use e-File and Free File

The IRS expects more than 80 percent of returns to be filed electronically. Choosing e-file and direct deposit remains the fastest and safest way to file an accurate income tax return and receive a refund.

The IRS Free File program, available at IRS.gov, gives eligible taxpayers a dozen options for brand-name products. Free File is a partnership with commercial partners offering free brand-name software to about 100 million individuals and families with incomes of \$64,000 or less. Seventy percent of the nation's taxpayers are eligible for IRS Free File. People who earned more than \$64,000 may use Free File Fillable Forms, the electronic version of IRS paper forms.

Protecting Taxpayers from Identity Theft-Related Refund Fraud

The IRS continues to work with state tax authorities and the tax industry to address tax-related identity theft and refund fraud. As part of the Security Summit effort, stronger protections for taxpayers and the nation's tax system are in effect for the 2017 tax filing season.

The new measures attack taxrelated identity theft from multiple sides. Many changes will be invisible to taxpayers but will help the IRS, states and the tax industry provide new protections. New security requirements will better protect tax software accounts and personal information.

Renew ITIN to Avoid Refund Delays

Many Individual Taxpayer Identification Numbers (ITINs) expired on Jan. 1, 2017. This includes any ITIN not used on a tax return at least once in the past three years. Also now expired is any ITIN with middle digits of either 78 or 79 (Example: 9NN-78-NNNN or 9NN-79-NNNN). Affected taxpayers should act soon to avoid refund delays and possible loss of eligibility for some key tax benefits until the ITIN is renewed. An ITIN is used by anyone who has

under U.S. tax law but is not eligible for a Social Security number.

It can take up to 11 weeks to process a complete and accurate ITIN renewal application. For that reason, the IRS urges anyone with an expired ITIN needing to file a return this tax season to submit their ITIN renewal application soon.

New AGI requirement for e-file

All taxpayers should keep a copy of their tax return. Beginning in 2017, taxpayers using a tax filing software product for the first time may need their Adjusted Gross Income (AGI) amount from their prioryear tax return to verify their identity. Taxpayers can learn more about how to verify their identity and electronically sign tax returns at Validating Your Electronically Filed Tax Return.

Free Tax Help

Low- and moderate-income taxpayers can get help filing their tax return for free. More than 90,000 volunteers around the country can help people correctly complete their return.

To get this filing help, taxpayers can visit one of the more than 12,000 community-based tax help sites that participate in the Volunteer Income Tax Assistance and Tax Counseling for the Elderly programs. To find the nearest site, use the VITA/ TCE Site Locator on IRS.gov or the IRS2Go mobile app.

Filing Assistance

The IRS reminds taxpayers that a trusted tax professional can provide helpful information about the tax laws. A number of tips about selecting a preparer and information about national tax professional groups are available on IRS.gov.

The IRS urges all taxpayers to make sure they have all their year-end statements in hand before filing. This includes Forms W-2 from employers and Forms 1099 from banks and other payers. Doing so will help avoid refund delays and the need to file an amended return.

Online tools

Many tax issues can now be resolved online or by phone from the convenience of a home or office. The IRS urges taxpayers to take advantage of the many tools and other resources available on IRS.gov. IRS phone lines will be busy again this year, so in order to save time, people should first visit the IRS website for tax assistance.

How to Build Better Drugs Faster

Breast cancer surgeon Dr. Laura Esserman sings to her patients as they go under anesthesia. She tackles any song request, whether it's a top 40 hit or a Broadway ballad. This same patient-centric attitude drove Dr. Esserman to participate in adaptive clinical trials, a game-changing way to test new medications.

It's past time that other researchers think beyond traditional clinical trials. Adaptive trials can make drug testing both more efficient and accurate. If regulators were to encourage greater use of adaptive trials and facilitate sharing of electronic health record data, researchers could deliver better drugs to patients, faster.

In a traditional clinical trial, researchers plan out every element of the trial -- from the number of participants to the type of data to be collected -- before they begin testing. They stick to this rigid master plan until the trial is complete.

But in an adaptive trial, researchers pre-plan certain modifications that they can make part-way through the trial, based on the results they've uncovered

Think of it in terms of mapping a run. A runner might look at a map and realize that at one point, the road will fork. Instead of deciding whether to go left or right before he ever begins jogging, he might choose to postpone the choice until actually reaches the fork. Perhaps he'd like to observe which path is muddier or which path has less traffic -and he'll only know when he gets

Similarly, researchers administering adaptive clinical trials can modify their tests as they make observations. Like the runner, they have to pre-plan what choices they'll make and when. But the more flexible trial formula enables them to alter the trial in response to real-world results. Dr. Esserman's trial, for exam-

ple, personalized testing by splitting breast cancer patients into different groups depending on various measurements of their health. She tested a combination of therapies on these patients -and only continued testing those that were found initially effective. By not having to run a dud treatment through the course of a standard clinical trial, the adaptive design reduced the cost, time, and number of patients needed for the

The FDA currently permits adaptive trials in limited instances. Letting researchers use this model more often would improve the drug development

Another way to improve the process is to enable doctors,

insurers, and drug companies to share data on patients' health outcomes after they take new FDA-approved medicines. By analyzing this data, they could uncover patterns that can't be detected even in the largest clini-

For instance, a clinical trial for a diabetes drug might include 1,000 participants, 10 of whom are Native American. Perhaps 60 percent of all patients respond well to the drug, but all 10 Native Americans get their blood sugar under control thanks to the medicine. It's impossible to tell from such a small sample size whether the medicine really is vastly more effective for Native Americans, or whether those 10 patients just got

Changing regulations to permit greater sharing of such data would help researchers unveil rare side effects, complications, or "miracle" results that crop up.

Adaptive trials and increased data sharing would deliver better medicines to patients faster and with greater safety. That's something to sing about.

Dare to Live

"For want of a nail the shoe was lost. For want of a shoe the horse was lost. For want of a horse the rider was lost. For want of a rider the message was lost. For want of a message the battle was lost. For want of a battle the kingdom was lost. And all for the want of a horseshoe nail."

As you have experienced, small problems have the ability to mushroom into larger ones with incredible speed. Yet, there is a tendency to ignore or put off addressing issues that warrant your attention.

There are numerous reasons for this; procrastination, avoidance, denial, lack of awareness, lack of time, or hoping things will either fix themselves or go away. Regardless of why you don't address them, unresolved problems grow quickly and even multiply.

No matter how many times a person is burned by growing problems, many still don't change their approach. If you want things to change, you have to change them. Remember, doing the same thing over and over and expecting a different result is one definition of insanity.

Bigger problems generate more stress than smaller ones. Constant stress creates its own secondary problems. Judgment is impaired. Patience is diminished. All types of physical problems can follow as

At some point you do have to address your problems. It makes so much more sense to handle them while they are still small and more easily rectified. As you have already learned, putting them off doesn't work. So you need to develop a more effective strategy.

Begin by differentiating problems from symptoms. Problems lead to symptoms which themselves cause additional secondary problems if the original problems are ignored. Not only do ignored problems grow in size, they also grow in number.

Treating only symptoms leaves roblems untouched For example, if a lost nail causes the horseshoe to shift, the horse would start limping. So, if you erroneously identify the limp as the problem, you would then allow the horse to rest. Unless and until you accurately recognize the problem as a missing nail, you won't be able to formulate a solution. For maximum effectiveness, the root problem must be rectified.

Once you identify the root problem, the exact cause must be determined and corrected. Otherwise, the problem will keep recurring. Since, the missing nail is the real problem, it should be replaced. But why did it fall out in the first place? Was it the wrong size, the wrong shape, the wrong type, worn out, or defective? Unless it was worn or defective,

the nail will continue to fall out unless a different type is used.

Problems that initially appear overwhelming should be broken down into smaller, manageable pieces. Each component can then be tackled individually. This approach enables you to expeditiously handle unwieldy issues.


Correcting problems as they arise prevents a problem backlog. Rather than being constantly bogged down by problems, you have the energy and freedom to stay on your desired course. You will be able to quickly identify and fix problems as they arise. Your stress level will drop while enthusiasm rises. What sets Smokey Oaks apart from other places is the

impressive fact that they do all their own smoking of meats and vegetables on site. They have a 110 gallon drum smoker that they utilize for everything from

chicken, to cuts of beef such as tri-tip, brisket and even peppers. 'We smoke all our protein in house," said Santos.

Lest diners think all that work will have a high ticket price, Santos and Glass strive to keep the prices affordable without sacrificing quality. "We want produce a good product at a reasonable price," Santos said.

They have working business arrangements with the nearby Waldorf School to provide them with local tomatoes and firewood, for instance. They buy all their wood for smoking from GBR Ranch in Lodi. That selection currently includes Applewood, Oak and Cherrywood, giving all their smoked goods a delicious and distinctive flavor. Almond wood is next on their list to add, a rare treat for the wood smoking connoisseur.

Smokey Oaks isn't all about the meat though. According to local regular "Dirty Don" Leek, the Caesar Salad is "off the hook." The restaurant is also well known for its Dirty Tots and other tantalizing treats such as wings, lettuce wraps, battered and fried green beans and mac and cheese. Seafood, surf and turf and vegetarian options, soups and sandwiches round out the menu offerings.

Not to be outdone, Smokey Oaks makes some mean cocktails. Santos says he knows how to make just about concoction behind the bar and knows he can wing and still mix a winner. 
